# E ective wave-equations for the dynam ics of cigar-shaped and disc-shaped B ose condensates

#### Abstract

Starting from the 3D G ross $P$ itaevskii equation and using a variational approach, we derive an e ective 1D wave-equation that describes the axial dynam ics of a Bose condensate con ned in an extemal potential $w$ ith cy lindrical sym $m$ etry. The trapping potential is harm on ic in the transverse direction and generic in the axial one. O ur equation, that is a tim e-dependent non-polynom ial non linear Schrodinger equation (1D NP SE ), can be used to m odel cigar-shaped condensates, whose dynam ics is essentially 1D.W e show that 1D NPSE gives $m$ uch $m$ ore accurate results than all other e ective equations recently proposed. By using 1D NP SE we nd analytical solutions for bright and dark solitons, which generalize the ones known in the literature. $W$ e deduce also an e ective 2D nonpolynom ial Schrodinger equation (2D NPSE) that m odels disc-shaped Bose condensates con ned in an extemal trap that is ham onic along the axial direction and generic in the transverse direction. In the lim iting cases of weak and strong interaction, our approach gives rise to Schrodinger-like equations $w$ ith di erent polynom ial non linearities.

## I. IN TRODUCTION

II. EFFECTIVE 1D EQUATION

B ose condensates are now adays routinely produced by $m$ any experim ental groups all over the world. The therm al and dynam ical properties of $B$ ose condensates have been investigated with di erent atom ic species and various trap geom etries. An interesting theoretical problem is the derivation of 1D and 2D equations, describing cigar-shaped and disc-shaped condensates, respectively. At zero tem perature, a good theoretical tool for the study of the dynam ics of dilute condensates is the tim e-dependent 3D G ross $P$ itaevskiiequation [1] 1 case of reduced dim ensionality, various approaches have been adopted to derive e ective equations from the 3D G ross $P$ itaevskiiequation $\left[\begin{array}{ll}{[-1 / 4} \\ {[4]}\end{array}\right]$.

In this paper we analyze both cigar-shaped and discshaped condensates. By using a variationalapproach, we obtain an e ective 1D tim e-dependent non-polynom ial nonlinear Schrodinger equation that describes the axial dynam ics of a Bose condensate con ned in an extemal potential with cylindrical sym $m$ etry. W e dem onstrate that our equation exactly reproduces previous ndings in the lim its of weak-coupling and strong-coupling. M oreover, we show that our variational approach is m ore accurate than all other recently proposed procedures in the evaluation of both static and dynam ical properties of the condensate. $W$ e also investigate the 2 D reduction of the 3 D G ross $P$ itaevskii equation. In this case it is not possible to analytically determ ine an single e ective 2D wave-equation which describes the dynam ics of discshaped condensates. N evertheless, analytical equations can be found in the weakly-interacting lim it and in the strongly-interacting lim it.

The 3D G rossP itaevskii equation (3D GPE), which describes the $m$ acroscopic wavefunction $(r ; t)$ of the B ose condensate, is given by

$w$ here $U(r)$ is the extemal trapping potential and $g=$ $4 h^{2} a_{s}=m$ is the scattering am plitude and $a_{s}$ the s-w ave scattering length [1] $]$. $N$ is the number of condensed bosons and the w ave-fiunction is norm alized to one. N ote that the 3D GPE is accurate to describe a condensate of dilute bosons only near zero tem perature, where therm al excitations can be neglected [']

The 3D GPE can be obtained by using the quantum least action principle, i.e. 3D GPE is the Euler-Lagrange equation of the follow ing action functional

W e consider an extemal potential with cylindrical sym $m$ etry. In particular we analyze a trapping potential that is harm onic in the transverse direction and generic in the axialdirection: $U(r)=\frac{1}{2} m!{ }_{?}^{2}\left(x^{2}+y^{2}\right)+V(z)$. W ew want to $m$ inim ize the action functional $S$ by choosing an appropriate trial wavefunction. A natural choioe [] $[$ d is the follow ing

$T$ he variationalfunctions $(z ; t)$ and $f(z ; t) w$ illbe deter－ $m$ ined by $m$ inim izing the action functional after integra－ tion in the $(x ; y)$ plane．The choice of a $G$ aussian shape for the condensate in the transverse direction is well jus－ ti ed in the lim it of weak interatom ic coupling，because the exact ground－state of the linear Schrodinger equation w ith harm on ic potential is a G aussian．M oreover，for the description of the collective dynam ics of Bose E instein condensates，it has already been show n that the varia－ tional technique based on $G$ aussian trial functions leads to reliable results even in the large condensate num ber $\lim$ 止 $\left[\operatorname{lon}_{16} 1\right.$

$T$ his equation is the $m$ ain result ofourpaper．It is a tim e－ dependent non－polynom ial nonlinear Schrodinger equa－ tion（1D NPSE）．

W e observe that from 1D NPSE in certain lim it－ ing cases one recovers fam iliar results．In the weakly－ interacting $\lim$ it $a_{s} N$ 让 $3 \ll 1$ one has ${ }^{2}=a_{?}^{2}$ and the previous equation reduces to

where the additive constant h ！？has been om itted be－ cause it does not a ect the dynam ics．This equation is a 1 D G ross $P$ itaevskii equation．The nonlinear $c 0-$ e cient $\mathrm{g}^{0}$ of this 1D GPE can be thus obtained from the nonlinear coe cient $g$ of the 3D GPE by setting $g^{0}=g=\left(\begin{array}{ll}2 & a_{?}^{2}\end{array}\right)$. This ansatz has been already used by various authors，for exam ple in Ref．［2］． 1 ．N ote that the lim it $a_{s} N$ 迁 $\} \ll 1$ is precisely the regim e where the healing length is larger than．In this regim e the cigar－ shaped condensate is quasi－1D，as show $n$ in a recent ex－ perim ent［ig］．It is well known that in 1D and at ultra－ low densities（ $a_{s} N$ ff $f<a_{s}^{2}=a_{?}^{2} \ll 1$ ）an interacting Bose gas becom es a Tonks gas，i．e．a gas of spinless Ferm ions $[\underline{[ }]$ ］．Such a transition cannot be described by the cubic 3D GPE equation and therefore by 1D NPSE because in the Tonks regim e the inter－atom ic interaction cannot sim ply be approxim ated by a zero－range pseudo－ potential in $m$ ean eld approxim ation $[1]$ Ond．Instead，in the strongly－interacting high density lim it $\mathrm{a}_{\mathrm{s}} \mathrm{N}$ 迁予 $\gg 1$ （but $\mathrm{N} j f \mathrm{f}_{\mathrm{s}} \ll_{\mathrm{p}} 1$ to satisfy the diluteness condition） one nds ${ }^{2}={ }^{p} \overline{2} a_{?}^{2} a_{s}^{1=2} N^{1=2}$ jf jand the 1D NPSE be－ com es

In this lim it，and in the stationary case，the kinetic term can be neglected（T hom as Ferm iapproxim ation）and one nds the follow ing analyticalform ula for the axialdensity pro le

where ${ }^{0}$ is the chem ical potential，xed by the norm al－ ization condition．It is im portant to stress that this 1D Thom asFerm idensity pro $l e$ is quadratic in the term $0 \mathrm{~V}(\mathrm{z})$ ．The sam e quadratic dependence is obtained starting from the $T$ hom asFerm iapproxim ation of the 3D stationary GPE，i．e．neglecting the spatial derivatives in Eq．（1），and then integrating along $x$ and $y$ variables．In this way one nds a formula that di ens from（11）only for the num erical factor which is $1=4$ instead of $2=9$ ．

To test the accuracy of the fill 1D NPSE，Eq．（8）， and com pare it w ith other procedures proposed in the last few years，we num erically investigate the sim ple case of ham onic trapping also in the axial direction： $V(z)=\frac{1}{2} m!{ }_{z}^{2} z^{2}$ ．In this case，the 1D NPSE can be written in scaled units：$z$ in units of $a_{z}=\frac{\frac{h}{m!}}{\frac{m}{z}}$ ，the oscillator length in the axial direction，and $t$ in units of $1=!{ }_{z}$ ．In order to assess the accuracy of the various 1D approxim ations we have also solved num erically the 3D G rossP itaevskii equation（3D GPE），given by Eq． （1） w th im aginary tim e $\left[11_{1}^{1}\right]$ ．N ote that the num erical solution of the 1D NPSE is not more time consum ing than the solution of the standard 1D GPE．In Fig． 1 we plot the norm alized density pro le $(z)=$ 价 $(z)$ 予 of the ground－state w ave－function of a cigar－shaped condensate con ned in a trap $w$ ith an aspect ratio $a_{z}=a_{?}=10$ ．

W e com pare the results of four di erent procedures． The rst procedure is the＂exact＂one，i．e．the solution of the 3D GPE．The second procedure is the num erical solution of the 1D G ross $P$ itaevskii equation（ $1 \mathrm{D} G \mathrm{PE}$ ） given by Eq．（9）with an im aginary time．The third procedure is that proposed by Chiofalo and Tosi［E］$\left.\underline{L}^{\prime}\right]$ ．In this case the nonlinear term of the 1D G ross $P$ itaevskii equation is found by im posing that the 1D wave－function has the sam e chem ical potential of the 3D one（CGPE）．

T he fourth and last procedure is the num ericalsolution of our non－polynom ial nonlinear Schrodinger equation（1D NPSE），i．e．Eq．（8）with im aginary time．A s shown in $F$ ig．1，the 1D NPSE results are always very close to the＂exact＂ones and $m$ uch better of the other approx－ im ations．M oreover，the CGPE procedure gives better results than the 1D GPE for large values of the scatter－ ing length where Eq．（9）is not reliable but in any case the 1D NPSE is superior．
$T$ he very good perform ance of Eq．（8）is not lim ited to the ground－state．W e have investigated the dynam－ ics of the condensate by taking the previously calculated ground－state wavefiunctions but changing the harm onic trap in the axial direction：from $V(z)=\frac{1}{2} m!{ }_{z}^{2} z^{2}$ to $V(z)=\frac{2}{5} m!{ }_{z}^{2} z^{2}$ ．In this $w$ ay the condensate show $s$ large collective shape oscillations along the z axis．

In $F$ ig． 2 we plot the tim e evolution of the squared am plitude $<z^{2}>$ of the gondensate in the axial direc－有ion，given by $<z^{2}>=d z z^{2}(z ; t)$ ，where $(z ; t)=$ dxdyj $(r ; t)$ f in the case of the 3D GPE and $(z ; t)=$ If $(z ; t) \rho$ in the other cases．A part the better evaluation of the am plitude that is a consequence of the better eval－ uation of the ground－state wave－fiunction，one sees that our1D NPSE reproduces quite wellalso the＂exact＂sinu－ soidalbehavior of the collective oscillation．For exam ple， after four oscillations the relative error in the determ ina－ tion of the instant tofm inim radius $\left\langle z^{2}\right\rangle$ is about 1\％．The other two procedures（CGPE and 1D GPE） clearly show a frequency delay w ith respect to the 3D

GPE and 1D NPSE results: after four oscillations their relative errors, w ith respect to the 3D GPE result, are about 5\% and 6\% respectively.

W e rem ind that the 1D NPSE has been obtained by using a factorization of the 3D wavefunction $w$ ith a variationalansatz for the transverse part of the w avefunction and neglecting the term $\frac{h^{2}}{2 m} \quad \frac{\Omega^{2}}{\mathrm{ez}^{2}}$. U nder the condition of the present com putations the last assum ption is fully justi ed because we have num erically veri ed that the ratio betw een the neglected term and the total energy ranges form $10^{3}$ in the weak-coupling lim it to $10^{7}$ in the strong-coupling lim it.

To test the accuracy of 1D NPSE in the description of the dynam ics of a cigar-shaped Bose condensate in $m$ ore com plex problem, we investigate the scattering and tunneling of the condensate on a G aussian barrier. T he initial wave function of the condensate is found by solving the equations $w$ ith im aginary tim $e$ and im posing a harm onic trapping potential also in the horizontal axial direction:

To have a cigar-shaped condensate we choose $!_{?}=!_{\mathrm{z}}=$ 10. W e set $z_{0}=20$, where $z_{0}$ is w ritten in units of the harm onic length $a_{z}=\left(h=m!_{z}\right)^{1=2}$. For $t>0$ the trap in the axialdirection is sw itched $\circ$ and a G aussian energy barrier is inserted at $\mathrm{z}=0 . \mathrm{T}$ he potentialbarrier is given by

$w$ here $V_{0}$ is the height of the potential barrier and its w idth. T he condensate is m oved tow ards the barrier by adding an initialm om entum $p_{0}$ in the axialdirection:

In the case of a non-interacting condensate, i.e. $a_{s}=0$, the total energy per particle is practically the start-up kinetic energy $\mathrm{E}_{0}=\mathrm{p}_{0}^{2}=(2 \mathrm{~m})$, and the transverse energy $h!$ ? does not a ect the dynam ics.

A s shown in $F$ ig. 3, where we plot the density pro le of the condensate along the sym $m$ etry axis at di erent instants, a fraction of the condensate tunnels the barrier while the rest is re ected. A s expected, one sees also the interference betw een the incident wave function and the re ected wave function. Fig. 3 show s that the "exact" axialdensity pro le obtained w ith the 3D GPE and that of the 1D NPSE are always quite close, also during the im pact and tunneling time. These results suggest that 1D NPSE is very adequate also in the description oftunneling phenom ena.

The cigar-shaped con guration of the condensate is usefiul to study topological ob jects, like bright and dark solitons. By using 1D NPSE one nds out solitonic solutions which generalize what has been previously found w ith 1D GPE [3] [1] 1 . D ark solitons ( $a_{s}>0$ ) of Bose condensed atom $s$ have been experim entally observed [13는, while bright solitons ( $a_{s}<0$ ) are m ore elusive due to the collapse of the condensate $w$ th a large num ber of atom $s$.

Let us rst consider bright solitons. Starting from our 1D NPSE, setting $V(z)=0$, scaling $z$ in units of $a$ ? and $t$ in units of $!{ }^{1}$, w ith the position

The norm alization relates the chem ical potential to the coupling constant, while the velocity $v$ of the bright soliton rem ains arbitrary. In the weak-coupling lim it ( ${ }^{2} \ll 1$ ), the nom alization condition gives

$T$ he above solution is the text-book bright soliton of the 1D non-linear cubic Schrodinger equation (1D GPE). As shown in $F$ igure 4, for ${ }^{\rho}=3 \ll 2=3$ there are two values for the chem ical potential but we have num erically veri ed that lower one corresponds to an unstable soliton ic solution. For $>2=3$ there are no solitary-w ave solutions due to the collapse of the condensate.

In the case of static dark solitons, the boundary conditions are: $(0)=0$ and ! 0 for $z$ ! 1 . Starting from the 1D NPSE the analytical form ula of the dark soliton is quite intricate because it involves elliptic integrals. N evertheless, sim ple expressions can be found in
the weak-coupling and in the strong-coupling lim it. In the weak-coupling lim its one nds

(20) is the fam iliar form ula of stationary dark soliton for the 1D nonlinear Schrodinger equation (1D GPE), while in the strong-coupling lim it one has

The study of the stability of our solitary-w ave solutions is left to a future work. 3D num erical calculations [14.] suggest that B ose condensed dark solitons are stable for su ciently sm all num bers of atom s or large transverse con nem ent. M oreover, a recent experim ent [1] ${ }^{-1}$ ] has shown that dark solitons, created in a sphericalB ose condensate, decay into vortex rings.

## III. EFFECTIVE 2D EQUATION

In this section we derive the 2D reduction of the 3D GPE equation by using again a variational approach. In this case we take a trapping potential that is harm onic in the axialdirection and generic in the transverse direction: $U(r)=W(x ; y)+\frac{1}{2} m!{ }_{z}^{2} z^{2}$. As trial wave-function we take the follow ing

where ( $x ; y ; t$ ) is a variationalfunction that describes the $w$ idth ofthe condensate in the axialdirection. $W$ e assum $e$ that the axialw avefunction $f$ is slow ly varying along the transverse direction $w$ ith respect to the axial direction, i.e. $r^{2} f$, $\frac{\varrho^{2} f}{@ z^{2}}$. By inserting the trial wave-function in (2) and after spatial integration along $z$ variable, one nds the follow ing E uler-Lagrange equations:

$N$ ote that the second Euler-Lagrange equation can be written as ${ }^{4} \quad 2(2)^{1=2} a_{z}^{4} a_{s} N j \rho^{\rho} \quad a_{z}^{4}=0$, and, contrary to the case of 1D reduction, it does not have a elegant analytical solution but it can be easily solved [16]. $W$ e name the 2 D non-polynom ial Schrodinger equation (25), w ith the condition (26), 2D NPSE. In Fig. 5 we com pare the radial density pro le (r) of the B ose condensate obtained by solving 2D NP SE w ith the exact one obtained by solving the 3D GPE. For sim plicity, we use a ham onic trapping potentialW ( $\mathrm{x} ; \mathrm{y}$ ) $=\frac{1}{2} \mathrm{~m}!{ }_{?}^{2}\left(\mathrm{x}^{2}+\mathrm{y}^{2}\right)$ also in the transverse radialdirection. $F$ ig. 5 show $s$ that 2D NPSE is quite reliable in describing the ground-state of disc-shaped B ose condensate. For exam ple, the relative error in the calculation of the density at the orgin ranges from 0:7\% to 5\% by increasing $a_{s}=a_{z}$.

W e can analyze the lim its of weak and strong interaction of 2D NPSE. In the weakly-interacting case one nds $=a_{z}$ and the equation ofm otion becom es

where the constant $h!_{z}$ has been om itted because it does not a ect the dynam ics. This equation is a 2 D G ross$P$ itaevskii equation. The nonlinear coe cient $g^{\infty}$ of this 2D GPE can be thus obtained from the nonlinear coefcient $g$ of the 3D GPE by setting $g^{\infty}=g=\left((2)^{1=2} a_{z}\right)$.

Eq. (27) describes a disc-shaped Bose condensate in a quasi-2D con guration. In fact, the weakly-interacting lim it corresponds to a condensate with a chem ical potential lower than $h!_{z}$ 㢢. In the strongly-interacting case one has instead $=\sum^{1=3} a_{z}^{4=3} a_{s}^{1=3} N^{1=3} j J^{f=3}$, and the resulting nonlinear Schodinger equation is

where ${ }^{\infty}$ is the chem ical potential, xed by the norm alization condition. T he sam e dependence is obtained starting from the $T$ hom asFerm i approxim ation of the stationary 3D GPE, i.e. neglecting the spatial derivatives in Eq. (1), and then integrating along $z$ variable. In this way one nds a form ula that di ers from the previous one only for the num erical factor which is ${ }^{\mathrm{P}} \overline{2}=(3)$ instead of $1=\left(3^{P}\right)$.

## CONCLUSIONS

W e have found that the 1D non-polynom ial nonlinear Schrodinger equation we have obtained by using a G aussian variationalansatz from the 3D G ross $P$ itaevskiiaction functional is quite reliable in describing the ground state and axialcollective oscillations of cigar-shaped condensates. W e have also tested the accuracy of the nonpolynom ial nonlinear equation in the case of a Bose condensate scattering and tunneling on a G aussian barrier. The agreem ent w th the results of the 3D G ross$P$ itaevskii equation is very good for both ground-state and dynam ics of the condensate. This equation will be useful for detailed num erical analysis of the dynam ics of cigar-shaped condensates, particularly w hen the local density $m$ ay undergo sudden and large variations. In fact, the accurate $m$ apping we have provided, allow $s$ to $m$ aintain a very good spatialresolution $w$ ith $m$ odest com putationale ort even if the breakdown of the weak interaction condition during tim e evolution prevents the use of standard 1D GP equation. This case is often encountered in the study of re ection and tunneling events and in the propagation of solitary waves, which are currently being experim entally investigated. By using the 1D non-polynom ial Schrodinger equation we have obtained analytical form ulas for bright and dark solitons
which generalize the ones known in the literature for the 1D non-linear cubic Schrodinger equation. Finally, we have deduced e ective 2 D equations describing the axial dynam ics of disc-shaped condensates. From the 3D G ross $P$ itaevskiiaction functional and using another G aussian variational ansatz we have derived the e ective 2 D nonlinear Schrodinger equation, which again has a non-polynom ial structure. This structure sim pli es in the weak and strong interacting regim e.
