E ective wave-equations for the dynam ics of cigar-shaped and disc-shaped B ose condensates

Starting from the 3D G ross-P itaevskii equation and using a variational approach, we derive an e ective 1D wave-equation that describes the axial dynam ics of a Bose condensate con ned in an external potential with cylindrical sym m etry. The trapping potential is harm onic in the transverse direction and generic in the axial one. Our equation, that is a time-dependent non-polynom ial nonlinear Schrodinger equation (1D NPSE), can be used to model cigar-shaped condensates, whose dynam ics is essentially 1D .W e show that 1D NPSE gives much m ore accurate results than all other e ective equations recently proposed. By using 1D NPSE we nd analytical solutions for bright and dark solitons, which generalize the ones known in the literature.W e deduce also an e ective 2D non-polynom ial Schrodinger equation (2D NPSE) that models disc-shaped Bose condensates con ned in an external trap that is harm onic along the axial direction and generic in the transverse direction. In the limiting cases of weak and strong interaction, our approach gives rise to Schrodinger-like equations with di erent polynom ial nonlinearities.

I. IN TRODUCTION

B ose condensates are now adays routinely produced by m any experim ental groups all over the world. The therm al and dynam ical properties of B ose condensates have been investigated with di erent atom ic species and various trap geom etries. An interesting theoretical problem is the derivation of 1D and 2D equations, describing cigar-shaped and disc-shaped condensates, respectively. At zero tem perature, a good theoretical tool for the study of the dynam ics of dilute condensates is the tim e-dependent 3D G ross-P itaevskii equation [1]. In the case of reduced dim ensionality, various approaches have been adopted to derive e ective equations from the 3D G ross-P itaevskii equation [2{4].

In this paper we analyze both cigar-shaped and discshaped condensates. By using a variational approach, we obtain an e ective 1D time-dependent non-polynom ial nonlinear Schrodinger equation that describes the axial dynamics of a Bose condensate con ned in an external potential with cylindrical symmetry. We demonstrate that our equation exactly reproduces previous ndings in the lim its of weak-coupling and strong-coupling. M oreover, we show that our variational approach is more accurate than all other recently proposed procedures in the evaluation of both static and dynam ical properties of the condensate. We also investigate the 2D reduction of the 3D Gross-Pitaevskii equation. In this case it is not possible to analytically determ ine an single e ective 2D wave-equation which describes the dynamics of discshaped condensates. Nevertheless, analytical equations can be found in the weakly-interacting lim it and in the strongly-interacting lim it.

II.EFFECTIVE 1D EQUATION

The 3D Gross-Pitaevskii equation (3D GPE), which describes the macroscopic wavefunction (r;t) of the Bose condensate, is given by

where U (r) is the external trapping potential and $g = 4 h^2 a_s = m$ is the scattering am plitude and a_s the s-wave scattering length [1]. N is the number of condensed bosons and the wave-function is norm alized to one. Note that the 3D GPE is accurate to describe a condensate of dilute bosons only near zero tem perature, where therm al excitations can be neglected [5].

The 3D GPE can be obtained by using the quantum least action principle, i.e. 3D GPE is the Euler-Lagrange equation of the following action functional

W e consider an external potential with cylindrical symm etry. In particular we analyze a trapping potential that is harm onic in the transverse direction and generic in the axial direction: U (r) = $\frac{1}{2}m \frac{1}{2}(x^2 + y^2) + V(z)$. W e want to m inim ize the action functional S by choosing an appropriate trial wavefunction. A natural choice [3] is the following

where both and f are norm alized and is represented by a G aussian:

The variational functions (z;t) and f(z;t) will be determ ined by m inim izing the action functional after integration in the (x;y) plane. The choice of a Gaussian shape for the condensate in the transverse direction is well justi ed in the limit of weak interatom ic coupling, because the exact ground-state of the linear Schrodinger equation with harm onic potential is a Gaussian. Moreover, for the description of the collective dynam ics of Bose-E instein condensates, it has already been shown that the variational technique based on Gaussian trial functions leads to reliable results even in the large condensate num ber limit [6,7].

We assume that the transverse wavefunction is slow by varying along the axial direction with respect to the transverse direction [3], i.e. r^2 ' r_2^2 where $r_2^2 = \frac{\theta^2}{\theta x^2} + \frac{\theta^2}{\theta y^2}$. By inserting the trial wave-function in (2) and after spatial integration along x and y variables the action functional becomes

The Euler-Lagrange equations with respect to $f \ \mbox{ and } read$

The second Euler-Lagrange equation reduces to an algebric relation providing apone to one correspondence between and f: ${}^2 = a_2^2 \frac{1 + 2a_s N}{1 + 2a_s N} \frac{1}{f} \frac{2}{f}$, where $a_2 = \frac{1}{\frac{h}{m!_2}}$ is the oscillator length in the transverse direction. One sees that depends in plicitly on z and t because of the space and time dependence of $\frac{2}{f} \frac{2}{f}$. Inserting this result in the rst equation one nally obtains

This equation is the main result of our paper. It is a timedependent non-polynom ial nonlinear Schrödinger equation (1D NPSE).

We observe that from 1D NPSE in certain limiting cases one recovers familiar results. In the weakly-interacting limit $a_s N$ jf $\hat{f} << 1$ one has ${}^2 = a_2^2$ and the previous equation reduces to

where the additive constant h!, has been om itted because it does not a ect the dynam ics. This equation is a 1D Gross-Pitaevskii equation. The nonlinear coe cient q⁰ of this 1D GPE can be thus obtained from the nonlinear coe cient g of the 3D GPE by setting $g^0 = g = (2 a_2^2)$. This ansatz has been already used by various authors, for example in Ref. [2]. Note that the $\lim\,i\!t\,\,a_sN\,\,j\!f\,\, \stackrel{\circ}{j}\,\,<<\,1\,$ is precisely the regime where the healing length is larger than . In this regime the cigarshaped condensate is quasi-1D, as shown in a recent experiment [8]. It is well known that in 1D and at ultralow densities $(a_s N \neq f < a_s^2 = a_2^2 < 1)$ an interacting Bose gas becom es a Tonks gas, i.e. a gas of spinless Ferm ions [9]. Such a transition cannot be described by the cubic 3D GPE equation and therefore by 1D NPSE because in the Tonks regime the inter-atom ic interaction cannot simply be approxim ated by a zero-range pseudopotential in mean eld approximation [10]. Instead, in the strongly-interacting high density $\lim it a_s N = \frac{1}{f} + \frac{1}{f} > 1$ (but N j $\overset{p}{J}a_{s} << 1$ to satisfy the diluteness condition) one nds $^{2} = \overset{p}{2}a_{2}^{2}a_{s}^{1=2}N^{1=2}$ j jand the 1D NPSE becom es

In this lim it, and in the stationary case, the kinetic term can be neglected (I hom as Ferm iapproxim ation) and one nds the follow ing analytical form ula for the axial density pro le

where ⁰ is the chem ical potential, xed by the norm alization condition. It is important to stress that this 1D Thom as Ferm i density pro le is quadratic in the term

 0 V (z). The same quadratic dependence is obtained starting from the Thom as Ferm iapproximation of the 3D stationary GPE, i.e. neglecting the spatial derivatives in Eq. (1), and then integrating along x and y variables. In this way one nds a form ula that di ers from (11) only for the numerical factor which is 1=4 instead of 2=9.




FIG.1. Normalized density prole $(z) = jf(z)f^2$ along the axial direction z for the cigar shaped trap. Number of Bosons: N = 10⁴ and trap anisotropy: $!_2 = !_z = 10$. Four dierent procedures: 3D GPE (solid line), 1D GPE (dashed line), CGPE (long-dashed line) and 1D NPSE (dotted line). From top to bottom: $a_s = a_z = 10^{-4}$, $a_s = a_z = 10^{-3}$, $a_s = a_z = 10^{-2}$. Length z in units of a_z and density in units of a_z^{-1} .

To test the accuracy of the full 1D NPSE, Eq. (8), and compare it with other procedures proposed in the last few years, we num erically investigate the simple case of harm onic trapping also in the axial direction: V(z) = $\frac{1}{2}m !_z^2 z^2$. In this case, the 1D NPSE can be $\frac{h}{m!}$, the written in scaled units: z in units of $a_z =$ oscillator length in the axial direction, and t in units of $1=!_{z}$. In order to assess the accuracy of the various 1D approximations we have also solved numerically the 3D Gross-Pitaevskii equation (3D GPE), given by Eq. (1) with imaginary time [11]. Note that the numerical solution of the 1D NPSE is not more time consuming than the solution of the standard 1D GPE. In Fig. 1 we plot the normalized density pro le $(z) = \frac{1}{2}(z)^{\frac{2}{2}}$ of the ground-state wave-function of a cigar-shaped condensate con ned in a trap with an aspect ratio $a_z = a_i = 10$.

We compare the results of four dierent procedures. The rst procedure is the "exact" one, i.e. the solution of the 3D GPE. The second procedure is the numerical solution of the 1D Gross-Pitaevskii equation (1D GPE) given by Eq. (9) with an imaginary time. The third procedure is that proposed by Chiofalo and Tosi [4]. In this case the nonlinear term of the 1D Gross-Pitaevskii equation is found by in posing that the 1D wave-function has the same chemical potential of the 3D one (CGPE). The fourth and last procedure is the num erical solution of our non-polynom ial nonlinear Schrodinger equation (1D NPSE), i.e. Eq. (8) with imaginary time. As shown in Fig. 1, the 1D NPSE results are always very close to the "exact" ones and much better of the other approximations. Moreover, the CGPE procedure gives better results than the 1D GPE for large values of the scattering length where Eq. (9) is not reliable but in any case the 1D NPSE is superior.

The very good performance of Eq. (8) is not limited to the ground-state. We have investigated the dynamics of the condensate by taking the previously calculated ground-state wavefunctions but changing the harmonic trap in the axial direction: from V (z) = $\frac{1}{2}m !_z^2 z^2$ to V (z) = $\frac{2}{5}m !_z^2 z^2$. In this way the condensate shows large collective shape oscillations along the z axis.




FIG.2. Squared am plitude < z^2 > as a function of time t. Number of Bosons: N = 10^4 and trap anisotropy: !_? =!_z = 10. Four diement procedures: 3D GPE (solid line), 1D GPE (dashed line), CGPE (long-dashed line) and 1D NPSE (dotted line). Scattering length: $a_s = a_z = 10^{-3}$ Length z in units of a_z , density in units of a_z^{-1} and time t in units of $1 = !_z$.

In Fig. 2 we plot the time evolution of the squared amplitude $\langle z^2 \rangle$ of the condensate in the axial direction, given by $\langle z^2 \rangle = dzz^2$ (z;t), where (z;t) = dxdyj (r;t) \hat{f} in the case of the 3D GPE and (z;t) = $\hat{f}(z;t)\hat{f}$ in the other cases. A part the better evaluation of the amplitude that is a consequence of the better evaluation of the ground-state wave-function, one sees that our 1D NPSE reproduces quite well also the "exact" sinusoidal behavior of the collective oscillation. For exam ple, after four oscillations the relative error in the determ ination of the instant t of m inim um radius $\langle z^2 \rangle$ is about 1%. The other two procedures (CGPE and 1D GPE) clearly show a frequency delay with respect to the 3D GPE and 1D NPSE results: after four oscillations their relative errors, with respect to the 3D GPE result, are about 5% and 6% respectively.

We rem ind that the 1D NPSE has been obtained by using a factorization of the 3D wavefunction with a variational ansatz for the transverse part of the wavefunction and neglecting the term $\frac{h^2}{2m} = \frac{\theta^2}{\theta z^2}$. Under the condition of the present computations the last assumption is fully justi ed because we have numerically veried that the ratio between the neglected term and the total energy ranges form 10⁻³ in the weak-coupling lim it to 10⁻⁷ in the strong-coupling lim it.




FIG.3. Four frames of the axial density prole (z) of the Bose condensate tunneling through the Gaussian barrier (Eq. (3)). Start-up kinetic energy per particle of the condensate: $E_0 = 10$. Gaussian barrier parameters: $V_0 = 10$ and = 1. Interaction strength: N $a_s=a_z = 10$. C om parison among 3D GPE (solid line), 1D NPSE (dotted line) and 1D GPE (dashed line). Length in units of $a_z = (h=m!_z)^{1=2}$, density in units of a_z^{-1} , time in units of $!_z^{-1}$, and energy in units of $h!_z$.

To test the accuracy of 1D NPSE in the description of the dynam ics of a cigar-shaped Bose condensate in m ore complex problem, we investigate the scattering and tunneling of the condensate on a G aussian barrier. The initial wave function of the condensate is found by solving the equations with imaginary time and imposing a harm onic trapping potential also in the horizontal axial direction:

To have a cigar-shaped condensate we choose $!_2 = !_z = 10$. We set $z_0 = 20$, where z_0 is written in units of the harm onic length $a_z = (h=m !_z)^{1=2}$. For t > 0 the trap in the axial direction is switched o and a Gaussian energy barrier is inserted at z = 0. The potential barrier is given by

where V_0 is the height of the potential barrier and its width. The condensate is moved towards the barrier by adding an initial momentum p_0 in the axial direction:

In the case of a non-interacting condensate, i.e. $a_s = 0$, the total energy per particle is practically the start-up kinetic energy $E_0 = p_0^2 = (2m)$, and the transverse energy $h!_2$ does not a ect the dynam ics.

As shown in Fig. 3, where we plot the density prole of the condensate along the symmetry axis at dierent instants, a fraction of the condensate tunnels the barrier while the rest is relected. As expected, one sees also the interference between the incident wave function and the relected wave function. Fig. 3 shows that the "exact" axial density prole obtained with the 3D GPE and that of the 1D NPSE are always quite close, also during the impact and tunneling time. These results suggest that 1D NPSE is very adequate also in the description of tunneling phenom ena.

The cigar-shaped con guration of the condensate is useful to study topological objects, like bright and dark solitons. By using 1D NPSE one nds out solitonic solutions which generalize what has been previously found with 1D GPE [3,12]. Dark solitons ($a_s > 0$) of Bose condensed atoms have been experimentally observed [13], while bright solitons ($a_s < 0$) are more elusive due to the collapse of the condensate with a large num ber of atom s.

Let us rst consider bright solitons. Starting from our 1D NPSE, setting V (z) = 0, scaling z in units of a_{2} and t in units of $!_{2}^{-1}$, with the position

The boundary condition ! 0 for ! 1 implies that E = 0. Then, by quadratures, one obtains the bright-soliton solution written in implicit form

M oreover, by imposing the normalization condition one also nds

The norm alization relates the chemical potential to the coupling constant , while the velocity v of the bright soliton remains arbitrary. In the weak-coupling limit ($^2 << 1$), the norm alization condition gives = 1 2 =2 and the bright-soliton solution reads

The above solution is the text-book bright soliton of the 1D non-linear cubic Schippdinger equation (1D GPE). As shown in Figure 4, for $\overline{2}=3 < 2=3$ there are two values for the chem ical potential but we have num erically veri ed that low er one corresponds to an unstable solitonic solution. For > 2=3 there are no solitary-wave solutions due to the collapse of the condensate.



In the case of static dark solitons, the boundary conditions are: (0) = 0 and $!_0$ for z ! 1 . Starting from the 1D NPSE the analytical formula of the dark soliton is quite intricate because it involves elliptic integrals. Nevertheless, simple expressions can be found in the weak-coupling and in the strong-coupling lim it. In the weak-coupling lim its one nds

where $_0 = ^{1=2} = \frac{p}{2}$ and $\sim = ja_s j N = a_?$, with N the number of m issing Bosons due to the hole in the condensate produced by the dark soliton. Eq. (20) is the fam iliar form ula of stationary dark soliton for the 1D nonlinear Schrödinger equation (1D GPE), while in the strong-coupling lim it one has

The study of the stability of our solitary-wave solutions is left to a future work. 3D num erical calculations [14] suggest that B ose condensed dark solitons are stable for su ciently sm all num bers of atom s or large transverse con nem ent. M oreover, a recent experim ent [15] has shown that dark solitons, created in a spherical B ose condensate, decay into vortex rings.

III.EFFECTIVE 2D EQUATION

In this section we derive the 2D reduction of the 3D GPE equation by using again a variational approach. In this case we take a trapping potential that is harm onic in the axial direction and generic in the transverse direction: U (r) = W (x;y) + $\frac{1}{2}$ m ! $\frac{2}{z}z^2$. As trial wave-function we take the following

where (x;y;t) is a variational function that describes the width of the condensate in the axial direction. We assume that the axial wavefunction f is slow by varying along the transverse direction with respect to the axial direction, i.e. $r^2 f' = \frac{g^2 f}{g z^2}$. By inserting the trial wave-function in (2) and after spatial integration along z variable, one nds the follow ing Euler-Lagrange equations:




FIG.5. Radial density prole (r) of the Bose condensate for a disc shaped trap. Number of Bosons: N = 10^4 and trap anisotropy: $!_2 = !_z = 1=10$. 3D GPE (solid line) and 2D NPSE (dotted line). From top to bottom $: a_s = a_z = 10^{-4}$, $a_s = a_z = 10^{-3}$, $a_s = a_z = 10^{-2}$. Length $r = \frac{10^{-2}}{x^2 + y^2}$ in units of a_z and density in units a_z^{-1} .

Note that the second Euler-Lagrange equation can be written as 4^{2} 2(2) $^{1=2}$ $a_{z}^{4}a_{s}N$ j j $a_{7}^{4} = 0$, and, contrary to the case of 1D reduction, it does not have a elegant analytical solution but it can be easily solved [16]. We name the 2D non-polynom ial Schrodinger equation (25), with the condition (26), 2D NPSE. In Fig. 5 we compare the radial density pro le (r) of the Bose condensate obtained by solving 2D NPSE with the exact one obtained by solving the 3D GPE. For sim plicity, we use a harm onic trapping potential W (x;y) = $\frac{1}{2}$ m ! $\frac{2}{2}$ (x² + y²) also in the transverse radial direction. Fig. 5 shows that 2D NPSE is quite reliable in describing the ground-state of disc-shaped Bose condensate. For example, the relative error in the calculation of the density at the orgin ranges from 0:7% to 5% by increasing $a_s = a_z$.

W e can analyze the limits of weak and strong interaction of 2D NPSE. In the weakly-interacting case one nds = a_z and the equation of motion becomes

$$\ln \frac{\theta}{\theta t} = \frac{h^2}{2m} r_{?}^2 + W + \frac{gN}{(2)^{1-2} a_z} j_z^2$$
; (27)

where the constant h!_z has been om itted because it does not a ect the dynamics. This equation is a 2D G ross-P itaevskii equation. The nonlinear coe cient g⁰⁰ of this 2D GPE can be thus obtained from the nonlinear coefcient g of the 3D GPE by setting g⁰⁰ = g=((2)¹⁼²a_z). Eq. (27) describes a disc-shaped Bose condensate in a quasi-2D con guration. In fact, the weakly-interacting limit corresponds to a condensate with a chemical potential lower than $h!_z$ [B]. In the strongly-interacting case one has instead = $\frac{P}{2} \frac{1=3}{1=3} a_z^{4=3} a_s^{1=3} N^{1=3} j j^{2=3}$, and the resulting nonlinear Schodinger equation is

$$ih\frac{\theta}{\theta t} = \frac{h^2}{2m}r_{?}^2 + W + \frac{3}{4}\frac{gN^{2=3}}{2=3}a_z^{4=3}a_s^{1=3} j j^{4=3} ;$$

Note that in this limit, and in the stationary case, the kinetic term can be neglected (Thomas-Fermi approximation) and one nds the following analytical formula for the transverse density prole

$$j(x;y)\hat{j} = \frac{1}{3^{\frac{1}{3}}} \frac{1}{(h!_z)^{3=2} a_s a_z N} (0^{0} W(x;y))^{3=2};$$

where ⁽⁰⁾ is the chemical potential, xed by the normalization condition. The same dependence is obtained starting from the Thomas-Fermi approximation of the stationary 3D GPE, i.e. neglecting the spatial derivatives in Eq. (1), and then integrating along z variable. In this way one nds a form ula that di ers from the previous one only for the numerical factor which is $\overline{2}=(3)$ instead of $1=(3, \overline{3})$.

CONCLUSIONS

W e have found that the 1D non-polynom ial nonlinear Schrodinger equation we have obtained by using a Gaussian variational ansatz from the 3D G ross-P itaevskii action functional is quite reliable in describing the ground state and axial collective oscillations of cigar-shaped condensates. We have also tested the accuracy of the nonpolynomial nonlinear equation in the case of a Bose condensate scattering and tunneling on a Gaussian barrier. The agreement with the results of the 3D G ross-Pitaevskii equation is very good for both ground-state and dynamics of the condensate. This equation will be useful for detailed num erical analysis of the dynam ics of cigar-shaped condensates, particularly when the local density may undergo sudden and large variations. In fact, the accurate m apping we have provided, allows to maintain a very good spatial resolution with modest com putational e ort even if the breakdown of the weak interaction condition during time evolution prevents the use of standard 1D GP equation. This case is often encountered in the study of re ection and tunneling events and in the propagation of solitary waves, which are currently being experimentally investigated. By using the 1D non-polynom ial Schrodinger equation we have obtained analytical formulas for bright and dark solitons

which generalize the ones known in the literature for the 1D non-linear cubic Schrodinger equation. Finally, we have deduced e ective 2D equations describing the axial dynamics of disc-shaped condensates. From the 3D G ross-P itaevskii action functional and using another G aussian variational ansatz we have derived the e ective 2D nonlinear Schrodinger equation, which again has a non-polynom ial structure. This structure sim pli es in the weak and strong interacting regim e.
