M acroscopic dynam ics of a trapped Bose-E instein condensate in the presence of 1D and 2D optical lattices

The hydrodynam ic equations of super uids for a weakly interacting B ose gas are generalized to include the e ects of periodic optical potentials produced by stationary laser beam s. The new equations are characterized by a renorm alized interaction coupling constant and by an e ective m ass accounting for the inertia of the system along the laser direction. For large laser intensities the e ective m ass is directly related to the tunneling rate between two consecutive wells. The predictions for the frequencies of the collective m odes of a condensate con ned by a m agnetic harm onic trap are discussed for both 1D and 2D optical lattices and com pared with recent experim ental data.

The experimental realization of optical lattices [1 [6] is stimulating new perpectives in the study of coherence phenomena in trapped Bose-Einstein condensates. A rst direct measurement of the critical Josephson current has been recently obtained in [3] by studying the center ofmassmotion of a magnetically trapped gas in the presence of a 1D periodic optical potential. Under these conditions the propagation of collective modes is a genuine quantum e ect produced by the tunneling through the barriers and by the super uid behaviour associated with the coherence of the order parameter between dierent wells. The e ect of the optical potential is to increase the inertia of the gas along the direction of the laser giving rise to a reduction of the frequency of the oscillation.

The purpose of the present work is to investigate the collective oscillations of a magnetically trapped gas in the presence of 1D and 2D optical lattices taking into account the e ect of tunneling, the role of the mean eld interaction and the 3D nature of the sample. Under suitable conditions these e ects can be described by properly generalizing the hydrodynam ic equations of super uids [7].

Let us assume that the gas, at T=0, be trapped by an external potential given by the sum of a harm onic trap of m agnetic origin $V_{\rm ho}$ and of a stationary optical potential $V_{\rm opt}$ m odulated along the z-axis. The resulting potential is given by

where $!_x$, $!_y$, $!_z$ are the frequencies of the harm onic trap, q = 2 = is xed by the wavelength of the laser light creating the stationary 1D lattice wave, $E_R = h^2 q^2 = 2m$ is

the so called recoil energy and s is a dimensionless param eter providing the intensity of the laser beam. The optical potential has periodicity d = -q = -2 along the z-axis. The case of a 2D lattice will be discussed later. In the following we will assume that the laser intensity be large enough to create m any separated wells giving rise to an array of several condensates. Still, due to quantum tunneling, the overlap between the wave functions of two consecutive wells can be su cient to ensure full coherence. In this case one is allowed to use the G ross-P itaevskii (GP) theory for the order param eter to study both the equilibrium and the dynam ic behaviour of the system at zero tem perature [8]. Eventually, if the tunnelling becomes too small, the uctuations of the relative phase between the condensates will destroy the coherence of the sample giving rise to new quantum con gurations associated with the transition to a M ott insulator phase [2,6].

In the presence of coherence it is natural to make the ansatz

for the order parameter in terms of a sum of many condensate wave-functions relative to each well. Here $S_k(x;y)$ is the phase of the k-component of the order parameter, while $_k$ and f_k are real functions. We will make the further periodicity assumption $f_k(z) = f_0(z \quad kd)$ where f_0 is localized at the origin. The above assumptions for and f_k are justiled for relatively large values of s where the interwell barriers are signily higher than the chemical potential. In this case the condensate wave functions of dilerent sites are well separated (tight binding approximation).

U sing the ansatz (2) for the order parameter one nds the following result for them ean eld expectation value of the eld externation of

where in the two-body and in the magnetic interaction terms as well as in the radial kinetic energy we have ignored the overlap contributions arising from di erent wells. In the evaluation of the axial kinetic energy and of the optical potential term we have instead kept also the overlap terms originating from consecutive wells. These are proportional to the quantity

related to the tunneling rate and responsible for the occurrence of Josephson e ects.

By setting $S_k = 0$ (groundstate con guration), the variation of E with respect to f_0 yields the di erential equation

where $\frac{P_0}{R_{d=2}}$ is introduced to ensure the norm alization condition $\frac{1}{d=2} dz f_0^2 = 1$ which implies that the functions k are normalized to the number of atoms N k occupying each site: $\frac{2}{k} dx dy = N_k$. In eq. (5) we have ignored the contribution arising from the two-body interaction. Estimates of [9] show that this is a good approximation already at moderately larges. We have also neglected the external magnetic potential which is justied if $\frac{P}{SE_R} >> h!_x$; $h!_y$. Since in the following we are interested in the low energy excitations of the system we will always keep the function f_0 equal to the groundstate solution of (5).

In order to discuss the macroscopic properties of the system, including its low energy dynamics, it is convenient to transform the discretized formalism described above into the one of continuum variables. This is obtained through the replacement _k ! (1=d) dz in the various terms of the energy. Through such a procedure one naturally introduces a smoothed or "macroscopic" density de ned by

with z' dk, and a sm oothed phase S ($S_k ! S(x;y;z)$).

By applying the sm oothing procedure to eq.(3) we obtain the following macroscopic expression for the energy functional

where we have introduced the renorm alized coupling constant $g = gd = f_0^4 dz$; we have neglected quantum pressure terms originating from the radial term in the kinetic energy and we have set $_{k \ k+1} = \frac{2}{k} = dn_M$. We have also om itted som e constant terms (rst two terms in eq. (3)) which do not depend on n_M or on S.

W ith respect to the functional characterizing a trapped Bose gas in the absence of optical con nement, one notices two important di erences: rst the interaction coupling constant is renorm alized due to the presence of the optical lattice. This is the result of the local compression of the gas produced by the tight optical con nement which increases the repulsive e ect of the interactions. Second the kinetic energy term along the z-direction has no longer the classical quadratic form as in the radial direction, but exhibits a periodic dependence on the gradients, which is the case in the study of sm all am – plitude oscillations, one derives a quadratic term of the form $(h^2=2m)$ $dV\,n_M~(\theta_z\,S\,)^2$ characterized by the e ective m ass

where is de ned by eq. (4). Notice that within the employed approximation the value of , and hence of m , does not depend on the number of atom s, nor on the mean eld interaction.

The equilibrium density pro le, obtained by m inim izing eq.(7) with S = 0 has the typical form of an inverted parabola [10]

which conserves the aspect ratio of the original magnetic trapping. The size of the condensate has instead increased since g > g. For large s the increase of the coupling constant can be large ($g = s^{l=4}$ [9]). However, since the radius of the sample scales like the 1/5-th power of g the resulting increase in the size of the system is not very spectacular (for s = 15 we nd an increase of the size by 20% for the experimental setting of [3]).

The functional (7) can be used to carry out dynamic calculations. In this case one needs the action $A = dt hH i \operatorname{Rinh}_{let}^{le} i$; with the second term given by ihh(l=let)i = $dV hn_M$ S. The resulting equations of motion are obtained by in posing the stationarity condition on the action with respect to arbitrary variations of the density n_M and of the phase S. The equations take the form

In particular, at equilibrium these equations reproduce result (9) for the equilibrium density. Furthermore, Josephson-type oscillations are among those captured by eqs. (10) and (11). To see this consider the case of a uniform gradient of the phase along z, $@_z S = P_z$ (t)=h, where P_z is a time-dependent parameter. From eqs. (10) and (11) one can then derive equations of motion for the center of mass Z (t) = $dV zn_m$ (t)=N and for the conjugate momentum variable P_z [3,11]

which have the typical Josephson form .

In the lim it of sm all oscillations the solutions of eqs. (10) and (11) have the form $n = n_M^0 + n (r)e^{i!t}$ with n obeying the hydrodynam ic equations:

where = gn_M^0 (0) is the chem ical potential of the sam ple and n_M^0 (0) is the equilibrium density (9) evaluated at the center. The solutions of (14) provide the low energy excitations of the system. In the absence of magnetic trapping one nds phonons propagating at the velocity $c = gn_M^0 = m$, in agreement with the result obtained in [12] for a 1D array of Josephson junctions. In the presence of harm onic trapping the discretized frequencies of the time-dependent solutions of (14) do not depend on the value of the coupling constant. By applying the transformation z ! m = m z, one actually nds that the new frequencies are simply obtained from the results of [7] by replacing

For an elongated trap $(!_x = !_y = !_?)$!₂) the lowest solutions are given by the center-ofm ass motion $!_{p} = p^{m} = m^{-1} !_{z}$ and by the quadrupole mode $!_{Q} = 5 = 2 \text{ m} = \text{m} !_{z}$. The center-of-m ass frequency coincides with the value obtained from eqs. (12) and (13) in the lim it of sm all oscillations. Concerning the quadrupole frequency we note that the occurrence of the factor 5=2 is a non-trivial consequence of the mean eld interaction predicted by the hydrodynam ic theory of super uids in the presence of harm onic trapping [7]. In addition to the low-lying axialm otion the system exhibits radial oscillations at high frequency, of the order of ! ? . The most important ones are the transverse breathing and quadrupole oscillations occuring at $! = 2!_{?}$ and $! = 2!_{?}$ respectively. For elongated traps the frequencies of these modes should not be a ected by the presence of the optical potential. D i erent scenarios are obtained for disc-shaped traps ($!_z >> !_{?}$). The above results apply to the linear regime of sm all oscillations. Eqs. (12)

and (13) show that in the case of center-offm ass oscillations, the linearity condition is achieved for initial displacements x of the trap satisfying $x < \frac{1}{2} = m \frac{1}{z}^2$, a condition that becomes more and more severe as the laser intensity increases. For larger initial displacements the oscillation is described by the pendulum equations. For very large amplitudes the motion is how ever dynam – ically unstable [11,13].

From the previous discussion it emerges that the effective mass is the crucial parameter needed to predict the value of the sm all am plitude collective frequencies. An estimate of m=m can be made by neglecting the magnetic trapping as well as the role of the mean eld interaction. W ithin this approximation the e ective mass is easily obtained from the excitation spectrum of the Schrodinger equation for the 1D Ham ilto- $(h^2=2m) (\theta^2=\theta z^2 + sE_R sin^2 qz)$, avoiding the nian H = explicit determ ination of the tunneling parameter (4). One looks for solutions of the form $e^{ipz=h} f_p(z)$ where p is the quasi-m om entum of the atom and $f_p(z)$ is a periodic function of period d. The resulting dispersion law "(p) provides, for sm all p, the e ective m ass according to the identi cation "(p) ' " $_0$ + p²=2m . The value of m =m , which turns out to be a universal function of the intensity parameters, has been evaluated for a wide range of values of s (see g.1). These results for m can be used to estim ate the actual value of the collective frequencies. The method described here to calculate m is expected to be reliable not only for very large laser intensities s when the tight binding approximation applies and the e ective m ass can be expressed in term s of the tunneling rate (see eqs. (8),(4)), but also for sm aller values of s. O f course for very small laser intensities, as in the experim ent [14], the determ ination of m requires the inclusion of the mean eld interaction and of the magnetic trapping through the explicit solution of the GP-equation.

In g.2 we compare our predictions for the frequencies of the center-of-m ass motion with the recent experimental data obtained in [3]. The comparison reveals good agreement with the experiments. Our results also agree well with those obtained from the numerical solution of the time-dependent GP-equation [11,13].

The above form alism is naturally generalized to include a 2D optical lattice where the optical potential is $V_{opt} = sE_R sin^2 qx + sE_R sin^2 qy$. The actual potential now generates an array of 1D condensates which has already been the object of experim ental studies [4]. For a 2D -lattice the ansatz for the order parameter is [15]

In the TF-lim it the groundstate sm oothed density $n_M = \frac{2}{k_x ; k_y} = d^2$ still has the fam iliar form $n_M^0 = (V_{no}) = g$ with the rede ned coupling constant $g = g d^R dx f_0^{4-2}$, where f_0 is still given by the solution of eq. (5) and we have used the same approximations as in the 1D case.

A loo with regard to dynam ics, one can proceed as for the 1D lattice. One nds that the equations of motions, after linearization, take the form

The frequencies of the low energy collective modes are then obtained from those in the absence of the lattice [7] by simply replacing $!_x$! $m = m !_x and !_y !$ $m = m !_v$. For large laser intensities the value of m coincides with the one calculated for the 1D array. If $!_z >> !_x$ m = m ; !y m = m , the lowest energy solutions involve the motion in the x y plane. The oscillations in the z-direction are instead xed by the value of $!_z$. These include the center-of-m assumption (! = $!_z$) and the low est, com pression mode $(! = 3!_z)$ [7,8]. The frequency $! = 3!_z$ coincides with the value obtained by directly applying the hydrodynam ic theory to 1D system s [16,17] and reveals the 1D nature of the tubes generated by the 2D lattice. If the radial trapping generated by the lattice becom es too strong the motion along the tubes can no longer be described by the mean eld equations and one jum ps into m ore correlated 1D regim es [18].




FIG.1. E ective mass as a function of the laser intensity s (see eq.(1)) calculated neglecting the e ects of interaction and harm onic trapping.




FIG.2. Frequency of the center-ofm ass motion for a condensate trapped by the combined magnetic and optical potential (1) as a function of the laser intensity. The circles and triangles are, respectively, the experimental and theoretical data of β]. The triangles have been obtained by evaluating the tunneling rate within a G aussian approximation for the order parameter in each well β]. The solid line refers to our theoretical prediction.
