G lassy behaviour in short range lattice m odels without quenched disorder

A bstract

W e investigate the quenching process in lattice system s with short range interaction and several crystalline states as ground states. W e consider in particular the following system s on square lattice:

-hard particle (exclusion) m odel

-q states planar Potts m odel.

The system is initially in a hom ogeneous disordered phase and relaxes tow ard a new equilibrium state as soon as the tem perature is rapidly lowered. The tim e evolution can be described numerically by a stochastic process such as the M etropolis algorithm. The number of pure, equivalent, ground states is q for the Pottsm odel and r for the hard particle m odel, and it is known that for r, or q d+ 1, the nalequilibrium state m ay be polycrystalline, i.e. not m ade of a uniform phase. W e nd that in addition n_g and q_g exist such that for $r > r_g$ or $q > q_g$ the system evolves toward a glassy state, i.e. a state in which the ratio of the interaction energy am ong the di erent crystalline phases to the total energy of the system never vanishes; moreover we nd indications that $r_g = q_g$. W e infer that $q = q_g$ (and $r = r_g$) corresponds to the crossing from second order to discontinuous transition in the phase diagram of the system.

Introduction

A large variety of m aterials occurs as glass or am orphous (E lliot 1990) but m echanism s driving m atter into such kind of states are far from clear. Because of the inherent com plexity of the problem, much e ort has been devoted also to the investigation of sim ple m odels like lattice m odels. These system s m ay reproduce at least a few of the characteristic features of glassy behaviour, how ever they are generally characterized by quenched disorder or com peting interactions. In contrast with real glass form er such m odel system s are not able to crystallise and therefore cannot give any inform ation on possible transitions from glassy to crystalline behaviour.

In this work we show that also simple lattice models with short range interaction and no quenched disorder may enter a kind of glassy phase. In particolar we show in section 2 that if a q state Potts system is quenched from in nite to zero temperature, it relaxes toward a state of minimum energy only if q is small enough. O therwise it slow ly equilibrates into a state with energy well above the ground state. A nalogous observations on di erent lattice models are elaborated in section 3 and indicate that such behaviour may be universal.

The Potts m odel

Consider a regular lattice in which each site can stay in one of q distinct states, or colours. To each site one may associate a variable $_i$ that takes the values 0;1;2;:::;q 1. The energy of a conguration is given by (Potts 1952)

$$E = \sum_{\substack{(ij) \\ (ij)}}^{X} (1);$$

where the sum m ation is over pairs of nearest neighbour sites. If two nearest neighbour sites have the same colour their contribution to the total energy vanishes, otherwise they contribute with an energy . There are therefore q distinct ground states; in each of them all sites in the lattice have the same colour and the total energy takes the absolute m inim um value, E = 0. These states are crystalline states.

Let n_p the number of site pairs such that the two sites have distinct colours, that is v

thus

$$E = n_p \tag{3}$$

and in a crystalline state $n_{\rm p}$ = 0. A polycrystalline state is composed of clusters of crystalline states of distinct colours separated by $n_{\rm p}$ site pairs of di erent colours. The number $n_{\rm p}$ however must be small. M ore precisely we call state polycrystalline when $= n_{\rm p} = N$! 0 as the number of lattice sites N ! 1, so that the total energy per site u = E = N ! 0, the same of the crystalline state.

We have simulated a quench to zero temperature as follows (Metropolis et al. 1953). At each step of simulation a site is chosen at random and its new colour is chosen at random. If the energy does not increase, the new colour is taken as the new state. The initial con guration of the system is a high temperature one, that is each site has a colour chosen at random.

We have studied the time behaviour of the energy per site u = E = Nafter the quench on a square lattice for several values of $N = L^2$. It is well known that the dynam ics of the Potts model usually gets pinned very soon into a non equilibrium state because of the nite size of lattices used in the simulations (G lazier et al. 1990). In order to escape this trap we have used both periodic boundary conditions and xed boundary conditions. In the latter, all sites on the lattice boundary are frozen in a given state, say the = 0 state. By this way one can discrim inate nite size and boundary e ects in the behaviour of the system. In fact we have assumed that, when plotting energy vs time, the superim posing section of curves resulting from dierent simulation conditions, may be identied with the genuine relaxation of the system. We have extrapolated the behaviour for L ! 1 from the 1= (t) part of these curves. As examples, the plots resulting from q = 3 and q = 7

From simulations on a square lattice we have drawn the following conclusions:

a) for q = 2 the system relaxes toward a crystalline state: $n_p ! 0$ and

are shown in gures 1 and 2.

b) for q = 3 the state is polycrystalline: $n_p \in 0$ but $= n_p = N ! 0$,

This agrees with the Lifshitz proposition (Lifshitz 1962) that the nalstates are non pure crystalline when q + 1 (q + 3 in d = 2). However the proposition does not say anything about the energy of these states; c) for q > 4 we observe that u ! u > 0 when t ! 1, since ! > 0, i.e.

The nalstate is not polycrystalline and, in addition, its energy is above the energy of the ground state (in fact it is seen to be a monotonic function of q). We call such pinned state a glassy state.

d) for q = 4 the asymptotic behaviour is well tted by

P relim inary results from simulations of quenches at T > 0 indicate that the observed features persist as far as T is not too large.

H ard core particles on a lattice

Extension of the above observations to di erent lattice m odels, also characterized by short range interaction and absence of quenched disorder, leads to rem arkable conclusions. W e discuss here som e results reported in the literature for a class of lattice gas m odels, namely exclusion m odels with random sequential adsorption and in-plane di usional dynam ics.

These models consist of a regular lattice in which particles are placed at the sites of the lattice. The deposition of a particle in a site blocks that site and the sites in a certain neighbourhood, whereas the energy is simply given by

$$E = (n \quad n_{cp}) \tag{8}$$

where > 0 is the chem ical potential, n is the total number of deposited particles and n_{cp} is the number of deposited particles in the closest packed con guration. The con guration of closest packing is a ground state con guration because the number of particles gets maximum so that the energy E is minimum (> 0) (in analogy with the Potts model the ground state energy is arbitrarily set to zero).

If a particle blocks the deposition of other particles in a certain neighbourhood the ground state is not unique. W hen for instance nearest neighbours sites are blocked on a square lattice (NN m odel) then there are two ground states corresponding to place the particles on either one or the other of two sub-lattices. If a particle blocks the nearest neighbours as well the next nearest neighbours (NNN m odel) then there will be four relevant ground states, corresponding to four di erent sub-lattices. If besides nearest neighbours and next nearest neighbours the particle blocks also the next nearest neighbours (NNNN m odel) then the number of ground states will be ve.

Once deposited, particles m ay di use along the lattice, with the prescription that they cannot overlap other particles. This process, called di usional relaxation, m akes possible to depose m ore particles and, in principle, the system enter an ordered phase, com ing eventually to the closest packed state where density cannot further increase.

Depending on the model (NN, NNN, NNNN, etc.), the nalstate may be crystalline, polycrystalline or glassy, and can be classi ed in a way sim ilar to the case of the Potts model discussed above. Let n_s be the number of sites at the surface of clusters of sites in the same state, i.e. occupying the same sub-lattice:

$$n_{\rm s} = n_{\rm cp} \quad n: \tag{9}$$

In analogy with the Potts model, if $n_s = 0$ the state is monocrystalline. If $n_s \in 0$ but $n_s = N ! 0 \text{ as } N ! 1$, the state is polycrystalline, and is glassy in the opposite case.

W e brie y elaborate here on som e results reported in the literature by W ang, N ielaba and Prixm an (1993, 1993a), and by E isenberg and B aram (1998, 2000). In the simulation a lattice initially empty is led sequentially by placing particles at the non excluded sites. D eposited particles may di use to next neighbour sites if these are not blocked or occupied. A lthough the implementation of this dynam ics varies slightly from one author to the other, their results are of general validity. Let us denote by r the num ber of ground states so that $n_{cp} = N = r$, and let u = E = N. By analysing the papers cited above one concludes that:

a) for r=2 (NN model) n_s ! 0 and u ! 0 (W ang et al. 1993) since

b) for r = 4 (NNN model), $n_s \in 0$ but $n_s = N ! 0$ as N ! 1, (W ang et al. 1993a, Eisenberg and Baram 1998) and u ! 0 as

c) for r = 5, u ! u > 0 and

$$u_{s} t^{1} + u_{s}; u_{s} > 0:$$

This t¹ behaviour has been observed in the very late stage (E isenberg and B aram 2000), when the (nite) system is almost completely lled, and therefore is not to be compared with the asymptotic, size independent, behaviour t¹⁼² of the Potts model. The relevant point here is that u ! u > 0 when t ! 1, if r > 4. Frozen states with density lower than in the closest packing have been observed recently also in di erent exclusion models (G rigera et al. 1997, Fusco et al. 2001).

D iscussion and conclusions

The results obtained for the exclusion model are very similar to those obtained for the Potts model. An important point to stress is that the two models are predicted to have the same symmetries and thus the same critical behaviour (D om any et al. 1977). However they are intrinsically di erent because there are features of the Potts model, like surface tension and spontaneous magnetization, that are not shared by the hard particle model. Similarities in their behaviour support therefore the idea of $q_g = 4$ (and $r_g = 4$) as an upper bound for polycrystalline behaviour also in the Potts model.

From the above considerations it can be argued that these di erent behaviours are actually related to the equilibrium phase diagram of the system. In fact, in two dimensions, for both Potts (W u 1982) and hard particle models (R unnels 1983) the upper critical number of ground states is four.

A nother in portant point to remark is that the appropriate procedure to get the limiting energy is to take rst the thermodynamic limit L ! 1, and then the in nite time limit t ! 1. This is a very important point that makes possible the observation of glassy phases in the kind of systems considered here. In fact systems with only short range interaction and no quenched disorder cannot have metastable states in the usual sense (G ri ths 1964, Yeom ans 1992).

In conclusion we have shown that dynam ics of simple lattice models exhibits a transition from (poly) crystalline to glassy behaviour when the num ber of ground states increases. Investigations on the Potts model and on exclusion models support the hypothesis that the critical number of states at which the transition takes place is related to the equilibrium properties and, for system s with this symmetry, is four. 


Figure 1: Behaviour of the energy per site with time, for a q = 3 Potts model on a square lattice. Dierent curves correspond to dierent size (L) and boundary conditions (pbc = periodic, fbc = xed). The dashed line is an extrapolation to t = 1 of the 1= (t) regime at large times.




Figure 2: The same as gure 1 for q=7.




Figure 3: The increase of the excess energy for increasing q, when t! 1, is well visible from the time behaviour of the energy per site for xed boundary conditionss (L = 1000).
