Truncation of power law behavior in \scale-free" network models due to information ltering

We form ulate a general model for the growth of scale-free networks under Itering information conditions that is, when the nodes can process information about only a subset of the existing nodes in the network. We not that the distribution of the number of incoming links to a node follows a universal scaling form, i.e., that it decays as a power law with an exponential truncation controlled not only by the system size but also by a feature not previously considered, the subset of the network \accessible" to the node. We test our model with empirical data for the W orld W ide W eb and nd agreement.

There is a great deal of current interest in understanding the structure and growth mechanisms of global networks [1, 2, 3] such as the world-wide-web (W W W) [4, 5] and the Internet [6]. Network structure is critical in m any contexts such as Internet attacks [2], spread of e-m ail virus [7] or dynam ics of hum an epidem ics [8]. In all these problem s, the nodes with the largest number of links play an important role on the dynam ics of the system. It is therefore important to know the global structure of the network as well as its precise distribution of number of links.

Recent em pirical studies report that both the Internet and the W W W have scale-free properties, that is, the number of incoming links and the number of outgoing links at a given node have distributions that decay with power law tails [4, 5, 6]. It has been proposed [9] that the scale-free structure of the Internet and the W W W may be explained by a mechanism referred to as \preferential attachm ent" [10] in which new nodes link to existing nodes with a probability proportional to the num ber of existing links to these nodes. Here we focus on the stochastic character of the preferential attachm ent m echanism, which we understand in the following way: New nodes want to connect to the existing nodes with the largest number of links i.e., with the largest degree because of the advantages o ered by being linked to a well-connected node. For a large network it is not plausible that a new node will know the degrees of all existing nodes, so a new node must make a decision on which node to connect with based on what inform ation it has about the state of the network. The preferential attachment mechanism then comes into play as nodes with larger degree are more likely to become known.

This picture has one underlying and unstated assum ption, that the new nodes will process (i.e., gather, store, retrieve and analyze) inform ation concerning the state of the entire network. For very large networks, such as the W W W or the scienti c literature, this would correspond to the unrealistic situation in which new nodes can process an extrem ely large am ount of inform ation | i.e., have unlim ited inform ation-processing capabilities. Indeed, it is likely that nodes have lim ited inform ation-processing capabilities and so must liter incom ing inform ation according to their particular \interests". Thus, new nodes of a large grow ing network will only process inform ation concerning a subset of existing nodes, since there is a cost associated with processing inform ation. The new nodes will then m ake decisions on with whom to link, based on

Itered inform ation. From the standpoint proposed here, most models studied in the literature work under the unrealistic assumption of un Itered inform ation | i.e., a new node processes inform ation about all the existing nodes in the network.

Here we consider for the rst time the e ect on network growth of Itering information due to limited information-processing capabilities. First, we calculate the in-degree distributions of web-pages using two databases. The rst database, which com prises 2 10 pages [9], surveys a very signi cant fraction of the entire WWW, while the second, which comprises 3 10 pages, lists the University of Notre Dame domain [4] ie. the set of URLs containing the string \nd edu". For the rst database, we calculate the cum ulative in-degree $k^{0} > k p(k^{0})$ where p(k) is the probdistributions P(k) =ability distribution. We con m that the in-degree distribution decays as a power law [9] of the form




FIG. 1: Distribution of number of incoming links for the WWW. Cumulative in-degree distribution from two databases, the entire Web [9], and the University of Notre Dame domain [4]. We also plot a power law function with exponent $_{\rm in} = 1.25$ (dashed line) and a Yule function [10] of the form k $^{\rm in}$ exp(k) (solid line). A cut-o degree k ' 200,000 is visible in the data.

with an exponent in = 1.25 0.05 (Fig. 1). Further we nd an exponential truncation of the scale-free behavior for k > k 2 1 $\hat{\theta}$, in contrast with the plateau reported in other studies [2, 11]. For the second database, we also nd a power-law regime with the same exponent, but the exponential truncation appears to be absent, suggesting that the truncation is not due to the nite size of the databases.

To explain these empirical results, we hypothesize that the authors of new web-pages lter som e of the inform ation regarding existing web-pages, that is, the new nodes m ake linking decisions under inform ation-ltering conditions. To investigate this process, we consider network grow th models in which new nodes process inform ation from only a fraction of existing nodes which one m ay view as matching the \interests" of the new nodes. If the fraction f of \interesting" nodes in the network is much less than one, then the attachment of new links is a random process, so the generated network will be a random graph with an exponentially-decaying in-degree distribution. In contrast, if f 1, then preferential attachment is recovered and the in-degree distribution is scale-free.

We rst de nethe network grow th rule: At time t = 0, one creates n_o nodes with n_o 1 links each. At each time step, one adds to the network a new node with n_o 1 outgoing links. These n_o links can connect to a random ly selected subset C containing $n(t) = (t + n_o)f$ nodes. The links to the nodes in the subset are selected according to the preferential attachment rule, i.e., the probability that node i belonging to C is selected is proportional to the num ber of incom ing links k (i) to it




FIG.2: In-degree cum ulative probability distributions P (k) under inform ation litering. Constant f case: (a) Results for $S = 5 \quad 10^5$ and di erent values of f. (b) Results for f = 10^{-3} and di erent values of S. (a) and (b) show that k decreases with f and increases with S. (c) D ata collapse of the num erical results according to Eq. (3) with $_{\rm in} = 1.97 \quad 0.05$ and $_1 = 0.45 \quad 0.04$. Constant n case: (d) Results for S = $5 \quad 10^5$ and di erent values of n showing the decrease in the cut-o degree k with decreasing n. (e) Results for n = 2;10 and 1;000 for di erent values of S showing that P (k) does not depend on S. (f) D ata collapse according to Eq. (4) with $_{\rm in} = 2:00 \quad 0.03$ and $_2 = 0:65 \quad 0:04$.

In Fig.2(a), we show our numerical results for the indegree cumulative distributions for networks with $S = 5 \quad 10^6$ nodes and $n_o = 1$, for a sequence of f values. For f = 1, we reproduce the results reported for the scalefree m odel [9] i.e. we observe an in-degree distribution that decays as a power law with an exponent in 2. For $f < 10^{-2}$, we observe a crossover at k = k from power-law behavior to exponential behavior.

To further investigate the e ect of changes in f on the cut-o degree k , we plot in Fig. 2 (b) the in-degree

distributions for di erent network sizes S and a xed value of f. W e nd that k increases as a power law with S. All of our num erical results can be expressed com pactly by the scaling form

$$P(k;f;S) / k \stackrel{in}{=} F_1 \frac{k}{k}$$

with k $(Sf)^1$. We nd $_{in} = 1.97$ 0.05, $_1 = 0.45$ 0.04 and $F_1(x)$ const: for x 1, $F_1(x)$ e ^x for x 1. As a test of the scaling form Eq. (3), we plot in Fig.1(c) the scaled cumulative distribution versus the scaled in-degree. The gure con rms our scaling Ansatz, since all data \collapse" onto a single curve, the scaling function $F_1(x)$.

We consider next a situation in which new nodes are not processing inform ation from a constant fraction f of nodes but from a constant number n of nodes. That is, as the network grows, the new nodes are able to process inform ation about a smaller fraction of existing nodes. Thism odelm ay be more plausible for networks that have grown to a very large size, since the fraction f of all nodes represents a very large number. In the case of the scientic literature, this e ect leads to the fragmentation




FIG.3: Dependence of the in-degree distribution exponent in on the out-degree distribution exponent out. We show results for models (i) without thess ((i) = const.) and (ii) with thess ((i) uniform ly distributed). For the form er case, in increases initially approximately linearly with out, and then saturates at in 2 for out > 2. This saturation of in is to be expected as in = 2 for the case of a peaked distribution ofno. For the latter case, in increases approximately linearly with out initially, and then saturates at in 1:25 for out > 1:9. This saturation is to be expected as in = 1:255 for the case of a peaked distribution of no [11].

of a scientic eld as it grows [12].

For the constant n case, the fraction of known nodes at time t is f (t) = $n = (t + n_o)$, in plying that as the networks grows there are two antagonistic trends a ecting k. The rst is a tendency to increase due to the growing size of the network, and the second is a tendency to decrease due to the decreasing value of f. Hence, one may hypothesize that there will be a characteristic network size S_c above which k will no longer depend on S.

W e now test these arguments with numerical simulations. In Fig.2(d)-(e), we show our results for growing networks for which new nodes process information only from n random ly selected existing nodes. We nd, in agreement with our scaling arguments, that for S S_c the in-degree distribution obeys the scaling relation

with k n^2 , $_{in} = 2:00 \quad 0:03$, $_2 = 0:65 \quad 0:04$, and where the scaling function $F_2(x)$ has the same limiting behavior as $F_1(x)$. To test the scaling form Eq. (4), we plot in Fig.2 (f) the scaled cumulative distribution versus the scaled in-degree. This con ms our scaling Ansatz since the data collapse onto a single curve, the scaling function $F_2(x)$.

C om parison of the two scaling relations Eq. (3) and Eq. (4) reveals an unexpected result. By replacing Sf by n in (3) one would naively expect to obtain (4) with $_1 = _2$ and $F_1(x) = F_2(x)$. Surprisingly, we nd that $_1$ is signi cantly di erent from $_2$ and that $F_1(x)$ is significantly di erent from $F_2(x)$. In order to understand this result, consider two growing networks that have reached

size S. For the rst, new nodes process inform ation from a fraction f of existing nodes, while, for the second, new nodes process information from n = fS existing nodes. At a time t, prior to the network having reached its nal size S, there are $t + n_o < S$ sites, and the preferential attachm ent is acting for the rst network on a num ber of nodes $(t + n_0) f < S f = n$. The preferential attachm ent mechanism can operate e ectively only when it acts on a num ber of nodes com parable to S, so the fact that for the rst network new nodes have always processed inform ation from fewer existing nodes suggests the rst network will not develop nodes with as large a degree as the second network. Thus, we expect that (i) the two resulting networks have di erent in-degree distributions, and (ii) the in-degree distribution for f xed has a sharper truncation and a smaller cut-o than for n xed, which is indeed what we nd.

O ur numerical results are in qualitative agreement with empirical data. However, the value of the power law exponent in 125 found for the W W W is significantly smaller than the value in = 2 predicted by the model. This fact prompts the question of the e ect of the cost of information ltering on models generating an in-degree distribution closer to the empirical results. To answer this question, we investigate two possible explanations for the observed value in 125.

(i) E ect of out-degree distribution on in . The scalefree m odel[9] is m issing an important ingredient: a heterogeneous distribution of num ber of outgoing links. Indeed, the out-degree distribution considered so far is restricted to a single value $m = n_o$ 1, i.e. $p_{ut}(m) =$ $_{\rm m, n_{\circ}-1}$, while for the empirical data of the W W I t decays as a power law of the form $p_{\text{out}} \, (\!\! m \,) \,$ m $^{_{\text{out}}} \, w \, \mbox{ith}$ out = 1:68 0:05. We show in Fig. 3 the computed value of the exponent $\ _{\rm in}$ of the in-degree distribution as a function of _{out} [13]. We nd that _{in} increases approximately linearly with increasing values of the exponent out until it reaches the limiting value in = 2. 1:7, which is the empirically-observed value For _{out} for the WWW, we nd in 1:8, which does not agree with the empirical value of 1.25, so the power-law decaying out-degree distribution alone cannot explain the results obtained for the W W W .

(ii) E ect of thess on $_{\rm in}$. The preferential attachm ent m echanism is modi ed by a \ thess" factor [11]: Nodes have di erent thess, and tter nodes are more likely to receive incoming links than less t nodes with the same value of k. Uniform ly-distributed thess is known to lead to a smaller exponent $_{\rm in}$ = 1:255 [11], which is quite close to the value measured for the W W W. Hence, we assign to each node a thess (i) [11], re ecting the fact that for equal values of k some nodes are more \attractive" than others[14]. The probability that a new node will link to node i is

$$p(i;t) \quad \frac{p(i)k(i)}{p(t+n_{o})} : \quad (5)$$

We consider here the case in which (i) is a uniform ly

distributed random variable [15]. Figure 3 shows that the in-degree distribution decays as a power law with values of $_{\rm in} < 125$. For $_{\rm out} > 1.9$, the exponent approaches the limiting value $_{\rm in}$ 125. Interestingly, for $_{\rm out}$ 1:7, the empirical value for the W W we end $_{\rm in}$ 12, in agreement with the empirical value $_{\rm in}$ 125.

O ur results for the model with tness show that information ltering and node tness are both necessary in order to approximate the empirical results. An open question is which type of ltering is more appropriate for the W W W, constant f or constant n? To answer this question one would need W W W data for a dierent sample size, which are not available to us at present. However, due to the sheer size of the W W W, it seems a plausible that constant n would be the more appropriate case.

Our key nding is that limited inform ation-processing capabilities have a signi cant and quanti able e ect on the large-scale structure of growing networks. We nd that information litering leads to an exponential truncation of the in-degree distribution for networks growing under conditions of preferential attachment. Surprisingly, we nd simple scaling relations that predict the in-degree distribution in terms of (i) the informationprocessing capabilities available to the nodes, and (ii) the size of the network.

We also quantify the e ect of a heterogeneous outdegree distribution on the in-degree distribution of networks growing under conditions of preferential attachment. We nd that for a power law decaying out-degree distribution with exponents $_{out} < 2$, the exponent in characterizing the tail of the in-degree distribution will take values smaller than those predicted by theoretical calculations [2, 3].

The exponential truncation we nd may have dram atic e ects on the dynam ics of the system, especially for processes where the nodes with the largest degree have im – portant roles. This is the case, for example, for virus spreading [7], where for networks with exponentiallytruncated in-degree distributions there is a non-zero threshold for the appearance of an epidem ic. In contrast, scale-free networks are prone to the spreading and the persistence of infections no matter how small the spreading rate. Our nding of a mechanism leading to an exponential truncation even for system s where before none was expected [16] indicates that the most connected nodes will have a smaller degree than predicted for scalefree networks leading, possibly, to di erent dynam ics, e.g., for the initiation and spread of epidem ics.

In the context of network growth, the impossibility of knowing the degrees of all the nodes comprising the network due to the Itering process | and hence the inability to make the optimal, rational, choice | is not altogether unlike the bounded rationality" concept of Sim on [17]. Remarkably, it appears that for the description of W W growth, the preferential attachment mechanism, originally proposed by Sim on [10], must be modified along the lines of another concept also introduced by him | bounded rationality [17].
