# Truncation of power law behavior in \scale-free" netw ork models due to inform ation ltering

#### Abstract

We form ulate a general model for the grow th of scale-free netw orks under ltering inform ation conditions that is, when the nodes can process inform ation about only a subset of the existing nodes in the network. We nd that the distribution of the num ber of incom ing links to a node follow s a universal scaling form, i.e., that it decays as a pow er law with an exponential truncation controlled not only by the system size but also by a feature not previously considered, the subset of the netw ork \accessible" to the node. $W$ e test our m odel with em pirical data for the $W$ orld $W$ ide W eb and nd agreem ent.

$T$ here is a great deal of current interest in understanding the structure and grow th $m$ echanism $s$ of global net-
 and the Intemet $[\underline{G}]$. $N$ etw ork structure is criticalin $m$ any contexts such as Intemet attacks $[\underset{Z}{[ }]$, spread of e-m ail virus $[\overline{1}, 1]$ or dynam ics of hum an epidem ics [ $\overline{[1} \overline{1}]$. In all these problem $s$, the nodes w th the largest num ber of links play an im portant role on the dynam ics of the system. It is therefore im portant to know the global structure of the netw ork as well as its precise distribution of num ber of links.

R ecent em pirical studies report that both the Intemet and the W W W have scale-free properties, that is, the num ber of incom ing links and the num ber of outgoing links at a given node have distributions that decay w ith
 the scale-free structure of the Intemet and the $\bar{W} \mathrm{~W}$ W $m$ ay be explained by a $m$ echanism referred to as \preferentialattachm ent" [10] in which new nodes link to existing nodes w ith a probability proportional to the num ber of existing links to these nodes. Here we focus on the stochastic character of the preferential attachm ent $m$ echanism, which we understand in the follow ing way: New nodes want to connect to the existing nodes with the largest num ber of links| i.e., w ith the largest degree| because of the advantages o ered by being linked to a well-connected node. For a large netw ork it is not plausible that a new node will know the degrees of all existing nodes, so a new nodem ustm ake a decision on which node to connect w ith based on what inform ation it has about the state of the netw ork. T he preferential attachm ent $m$ echanism then com es into play as nodes with larger degree are $m$ ore likely to becom e know $n$.
$T$ his picture has one underlying and unstated assum ption, that the new nodes $w$ ill process (i.e., gather, store, retrieve and analyze) inform ation conceming the state of the entire netw ork. For very large netw orks, such as the W W W or the scienti c literature, this would correspond
to the unrealistic situation in which new nodes can process an extrem ely large am ount of in form ation |i.e., have unlim ited inform ation-processing capabilities. Indeed, it is likely that nodes have lim ited inform ation-processing capabilities and so m ust lter incom ing inform ation according to their particular \interests". Thus, new nodes of a large grow ing netw ork w ill only process inform ation conceming a subset ofexisting nodes, since there is a cost associated $w$ ith processing inform ation. The new nodes w ill then m ake decisions on w th whom to link, based on ltered in form ation. From the standpoint proposed here, m ost m odels studied in the literature w ork under the unrealistic assum ption of un trered in form ation | i.e., a new node processes inform ation about all the existing nodes in the netw ork.

Here we consider for the rst time the e ect on netw onk grow th of ltering inform ation due to lim ited inform ation-processing capabilities. First, we calculate the in-degree distributions of web-pages using two databases. The rst database, which com prises 210 pages [ig $[\underline{1} 1$, surveys a very signi cant fraction of the entire W W W , while the second, which comprises 3 1 10 pages, lists the University of $N$ otre $D$ am e dom ain $\left[\begin{array}{l}{[4]} \\ \hline\end{array}\right]$ i.e. the set of UR Ls containing the string \nd.edu". For the rst database, wepcalculate the cum ulative in-degree distributions $P(k)=k^{0}>k p\left(k^{0}\right)$ where $p(k)$ is the probability distribution. We con $m$ that the in-degree distribution decays as a pow er law $[\underline{[1]}]$ of the form

w ith an exponent in $=1: 25 \quad 0: 05$ ( F ig $\left.{ }_{2}^{1-1} 1\right)$. Further we nd an exponential truncation of the scale-free behavior for $k>k \quad 21 \overline{0}$, in contrast $w$ ith the plateau $r e-$
 we also nd a power-law regim ew ith the sam e exponent, but the exponentialtruncation appears to be absent, suggesting that the truncation is not due to the nite size of the databases.

To explain these em pirical results, we hypothesize that the authors of new web-pages lter som e of the inform ation regarding existing web-pages, that is, the new nodes $m$ ake linking decisions under inform ation- lering conditions. To investigate this process, we consider netw ork grow th m odels in which new nodes process inform ation from only a fraction of existing nodes which one may view asm atching the \interests" of the new nodes. If the fraction f of \interesting" nodes in the netw ork is much less than one, then the attachm ent of new links is a random process, so the generated netw ork w illbe a random graph w ith an exponentially-decaying in-degree distribution. In contrast, if $\mathrm{f} \quad 1$, then preferential attachm ent is recovered and the in-degree distribution is scale-free.

W e rst de ne the netw ork grow th rule: At tim et=0, one creates $n_{o}$ nodes $w$ th $n_{o} 1$ links each. A t each tim $e$ step, one adds to the netw ork a new node with $n_{0} 1$ outgoing links. T hese $n_{0}$ links can connect to a random ly selected subset C containing $n(t)=\left(t+n_{0}\right) f$ nodes. $T$ he links to the nodes in the subset are selected according to the preferential attachm ent rule, i.e., the probability that node i belonging to $C$ is selected is proportional to the num ber of incom ing links k (i) to it

In $F$ ig. degree cum ulative distributions for netw orks with $S=$ $510^{5}$ nodes and $n_{0}=1$, for a sequence off values. For $f=1$, we reproduce the results reported for the scalefree m odel $[\underline{1} 1] \mid$ i.e. we observe an in-degree distribution that decays as a power law w ith an exponent in 2 . For $\mathrm{f}<10^{2}$, we observe a crossover at $k=k$ from power-law behavior to exponentialbehavior.

To further investigate the e ect of changes in $f$ on the cut-o degree $k$, we plot in $F$ ig. ${ }_{2}^{\prime \prime}(\mathrm{b})$ the in-degree

distributions for di erent netw ork sizes $S$ and a xed value of $f$. We nd that $k$ increases as a power law with S. All of our num erical results can be expressed com pactly by the scaling form

with k (Sf) ${ }^{1}$. We nd in $=1: 97 \quad 0: 05,1=$ $0: 45 \quad 0: 04$ and $F_{1}(x)$ const: for $x \quad 1, F_{1}(x) \quad e^{x}$ for $x \quad 1$. A s a test of the scaling form Eq. ( $\overline{-1})$, we plot in Fig. $I_{1}^{11}(\mathrm{c})$ the scaled cum ulative distribution versus the scaled in-degree. The gure con m sour scaling A nsatz, since all data \collapse" onto a single curve, the scaling function $F_{1}(x)$.

W e consider next a situation in which new nodes are not processing inform ation from a constant fraction $f$ of nodes but from a constant num ber $n$ of nodes. That is, as the netw ork grow s , the new nodes are able to process inform ation about a $s m$ aller fraction of existing nodes. Thism odelm ay bem ore plausible for netw orks that have grown to a very large size, since the fraction $f$ of all nodes represents a very large num ber. In the case of the scienti c literature, this e ect leads to the fragm entation

For the constant $n$ case，the fraction ofknow $n$ nodes at tim et is $f(t)=n=\left(t+n_{\circ}\right)$ ，im plying that as the netw orks grow s there are tw o antagon istic trends a ecting k ．The rst is a tendency to increase due to the grow ing size of the netw ork，and the second is a tendency to decrease due to the decreasing value off．H enœe，one $m$ ay hypothesize that there willbe a characteristic netw ork size $S_{c}$ above which $k$ w ill no longer depend on $S$ ．

W e now test these argum ents $w$ th num erical sim ula－ tions．In $F$ ig． $\bar{Z}_{1}^{(1)}(\mathrm{d})$－（e），we show our results for grow ing netw orks for which new nodes process inform ation only from n random ly selected existing nodes．We nd，in agreem ent w th our scaling argum ents，that for $S \quad S_{c}$ the in－degree distribution obeys the scaling relation

w th $\mathrm{k} \quad \mathrm{n}^{2}$ ，in $=2: 00 \quad 0: 03,2=0: 65 \quad 0: 04$ ，and where the scaling function $F_{2}(x)$ has the sam e lim iting behavior as $F_{1}(x)$ ．To test the scaling form Eq．（ $\overline{4}_{4}$ ），we plot in Fig． the scaled in－degree．This con m s our scaling A nsatz since the data collapse onto a single curve，the scaling function $F_{2}(x)$ ．

C om parison of the two scaling relations Eq．（了ु）and Eq．（ $\overline{1} \overline{1}_{1}^{1}$ ）reveals an unexpected result．By replacing $\mathrm{S} f$ by $n$ in $\overline{(\overline{3})}$ ）one would naively expect to obtain（ $\overline{4}$ ）w ith $1_{1}=2$ and $F_{1}(x)=F_{2}(x)$ ．Surprisingly，we nd that ${ }_{1}$ is signi cantly di erent from 2 and that $F_{1}(x)$ is sign if－ icantly di erent from $\mathrm{F}_{2}(\mathrm{x})$ ．In order to understand this result，consider two grow ing netw orks that have reached
size $S$ ．For the rst，new nodes process in form ation from a fraction $f$ of existing nodes，while，for the second，new nodes process inform ation from $n=f S$ existing nodes． At a tim et，prior to the netw ork having reached its nal size $S$ ，there are $t+n_{0}<S$ sites，and the preferential attachm ent is acting for the rst netw ork on a num ber of nodes $\left(t+\mathrm{n}_{0}\right) \mathrm{f}<\mathrm{Sf}=\mathrm{n}$ ．The preferential attachm ent $m$ echanism can operate e ectively only when it acts on a num ber ofnodes com parable to $S$ ，so the fact that for the rst netw ork new nodes have alw ays processed inform a－ tion from fewer existing nodes suggests the rst netw ork w ill not develop nodes w th as large a degree as the sec－ ond netw ork．Thus，we expect that（i）the tw o resulting netw orks have di erent in－degree distributions，and（ii） the in－degree distribution for $f$ xed has a shanper trun－ cation and a sm aller cut－o than for $n$ xed，which is indeed what we nd．

O ur num erical results are in qualitative agreem ent w ith em pirical data．H ow ever，the value of the power law exponent in $1: 25$ found for the $W \mathrm{WW}$ is signif－ icantly $s m$ aller than the value in $=2$ predicted by the $m$ odel．This fact prom pts the question of the e ect of the cost of inform ation ltering on $m$ odels generating an in－degree distribution closer to the em pirical results．To answer this question，we investigate tw o possible expla－ nations for the observed value in 1：25．
（i）E ect＿of out－degree distribution on in．The scale－ free m odel $\left[{ }_{l}^{1}\right]$ is m issing an im portant ingredient：a het－ erogeneous distribution of num ber of outgoing links．In－ deed，the out－degree distribution considered so far is re－ stricted to a single value $m=n_{0} \quad 1$ ，i．e．But $(m)=$ $m ; n$ 。 1 ，while for the em piricaldata of the $W$ W W it de－ cays as a power law of the form pout $(m) \quad m$ out $w$ th out $=1: 68$ 0：05．W e show in Fig 1 value of the exponent in of the in－degree distribution as a function of out［131］．We nd that in increases approxim ately linearly $w$ ith increasing values of the ex－ ponent out until it reaches the lim iting value in $=2$ ． For out 1：7，which is the em pirically－observed value for the W W W，we nd in $1: 8$ ，which does not agree $w$ ith the em pirical value of 125 ，so the power－law de－ caying out－degree distribution alone cannot explain the results obtained for the W W W ．
（ii）E ect of thess on in．The preferential attach－
 N odes have di erent tness，and tter nodes are m ore likely to receive incom ing links than less $t$ nodes with the same value of $k$ ．Uniform ly－distributed tness is known to lead to a sm aller exponent in $=1: 255$［1］$]$ ， which is quite close to the valuem easured for the $W \mathrm{~W} \overline{\mathrm{~W}}$ ． H ence，we assign to each node a thess（i）$\left[1 \overline{1}_{1}^{1}\right]$ ，re ect－ ing the fact that for equal values of $k$ som $e$ nodes are $m$ ore $\backslash$ attractive＂than others［ $\left.14^{-1}\right]$ ．The probability that a new node will link to node $i$ is

W e consider here the case in which（i）is a uniform ly
distributed random variable [][']. Figuren in-degree distribution decays às a power law w ith values of in < 1:25. For out $>1: 9$, the exponent approaches the limiting value in $1: 25$. Interestingly, for out 1:7, the em pirical value for the W W W, we nd in 1:2, in agreem ent w ith the em pirical value in $1: 25$.

O ur results for the m odel w th tness show that inform ation ltering and node thess are both necessary in order to approxim ate the em pirical results. An open question is which type of ltering is $m$ ore appropriate for the W W W, constant $f$ or constant $n$ ? To answer this question one would need W W W data for a di erent sam ple size, which are not available to us at present. H ow ever, due to the sheer size of the W W W, it seem S plausible that constant $n$ w ould be the $m$ ore appropriate case.

O ur key nding is that lim ited inform ation-processing capabilities have a signi cant and quanti able e ect on the large-scale structure of grow ing netw orks. W e nd that inform ation ltering leads to an exponential truncation of the in-degree distribution for netw orks grow ing under conditions of preferential attachm ent. Surprisingly, we nd sim ple scaling relations that predict the in-degree distribution in term $s$ of (i) the inform ationprocessing capabilities available to the nodes, and (ii) the size of the netw ork.

W e also quantify the e ect of a heterogeneous outdegree distribution on the in-degree distribution of networks grow ing under conditions of preferential attach$m$ ent. $W e$ nd that for a power law decaying out-degree distribution $w$ ith exponents out $<2$, the exponent in characterizing the tail of the in-degree distribution will
take values sm aller than those predicted by theoretical


The exponentialtruncation we nd $m$ ay have dram atic e ects on the dynam ics of the system, especially for processes where the nodes w th the largest degree have im portant roles. This is the case, for exam ple, for virus spreading $[\underline{Z}, 1]$, where for networks w ith exponentiallytruncated in-degree distributions there is a non-zero threshold for the appearance of an epidem ic. In contrast, scale-free netw orks are prone to the spreading and the persistence of infections no $m$ atter how sm all the spreading rate. O ur nding of a $m$ echanism leading to an exponentialtruncation even for system $s$ where before none $w$ as expected [1] ] indicates that the $m$ ost connected nodes $w$ ill have a sm aller degree than predicted for scalefree netw orks leading, possibly, to di erent dynam ics, e.g., for the initiation and spread of epidem ics.

In the context of netw ork grow th, the im possibility of know ing the degrees of all the nodes com prising the network due to the ltering process | and hence the inability to $m$ ake the optim al, rational, choige is not altogether unlike the \bounded rationality" concept of $\operatorname{Sim}$ on [171]. Rem arkably, it appears that for the description of W W $\bar{W}$ grow th, the preferential attachm ent $m$ echanism, originally proposed by $S$ im on [ $[1][1]$, m ust be modi ed along the lines of another concept also introduced by him | bounded rationality [ [7]l.
