The e ect of annealing on the nonlinear viscoelastic response of isotactic polypropylene

A bstract

Three series of tensile relaxation tests are performed on isotactic polypropylene at room temperature in the vicinity of the yield point. In the rst series of experiments, in jection-molded samples are used without thermal pre-treatment. In the second and third series, prior to testing the specimens are annealed at 130 C for 4 and 24 hours, respectively.

C onstitutive equations are derived for the time-dependent response of sem icrystalline polymers at isotherm alloading with small strains. A polymer is treated as an equivalent temporary network of macrom olecules bridged by junctions (physical cross-links, entanglements and crystalline lamellae). Under loading, junctions slip with respect to their positions in the bulk material (which rejects the viscoplastic behavior), whereas chains separate from their junctions and merge with new ones at random times (which rejects the viscoelastic response). The network is thought of as an ensemble of meso-regions (MR) with various activation energies for detachment of chains from temporary nodes.

A djustable param eters in the stress{strain relations are found by tting observations. Experimental data demonstrate that the shape of the relaxation spectrum (characterized by the distribution of MR swith various potential energies) is independent of mechanical factors, but is altered at annealing. For specimens not subjected to therm al treatment, the growth of longitudinal strain does not a lect the volume fraction of active MRs and the attempt rate for detachment of chains from their junctons. For annealed samples, the concentration of active MRs increases and the attempt rate decreases with strain. These changes in the time-dependent response are attributed to broadening of the distribution of strengths of crystalline lamellae at annealing.

1 Introduction

This paper is concerned with the in uence of annealing at an elevated tem perate on the nonlinear viscoelastic response of isotactic polypropylene (iPP) at room tem perature. The objective of this study is three-fold:

- 1. to report experimental data in tensile relaxation tests on specimens annealed for various amounts of time at strains in the vicinity of the yield point,
- 2. to derive stress{strain relations for the nonlinear viscoelastic behavior of a sem icrystalline polymer at isotherm al uniaxial deformation,
- 3. to assess the e ect of annealing on the time-dependent response of iPP in terms of the constitutive model.

Isotactic polypropylene is chosen for the analysis because of num erous applications of this polymer in industry (oriented lms for packaging, reinforcing bres, nonwoven fabrics, blends with therm oplastic elastomers, etc.). The goal of this study is to establish some correlations between mechanical properties, morphology and processing conditions (annealing at an elevated temperature) for injection-molded specimens. For a review of previous works on this subject, see [1] and the bibliography therein.

The nonlinear viscoelastic response of polypropylene was analyzed by W ard and W olfe [2], see also [3], and Sm art and W illiams [4] three decades ago, and, m ore recently, by A riyam a [5, 6, 7, 8], W ortm ann and Schulz [9, 10], Ibhadon [11], Tom lins [12], Read and Tom lins [14, 15], D utta and E dward [13] and Tom lins and Read [16].

The e ect of physical aging (annealing at an elevated tem perature followed by quench to am bient tem perature) on the time-dependent behavior of PP was studied by Struik [17, 18], Chai and M cC rum [19], Ibhadon [11], Tom lins [12], Read and Tom lins [14, 15] and Tom lins and Read [16].

D ynam ic m echanical analysis shows that the loss tangent of iPP demonstrates two pronounced maxim a being plotted versus temperature [20, 21]. The rst maximum ({ transition in the interval between T = 20 and T = 10 C) is associated with the glass transition in the most mobile part of the am orphous phase, whereas the other maximum ({ transition in the interval between T = 70 and T = 110 C) is attributed to the glass transition in the remaining part of the am orphous phase. This conclusion is con rm ed by D SC (di erential scanning calorim etry) traces for quenched PP that reveal an endoterm at T = 70 C which can be ascribed to therm all activation of am orphous regions with restricted mobility under heating [21].

Isotactic polypropylene exhibits three di erent crystallographic form s: monoclinic crystallites, (pseudo) hexagonal structures, orthorhom bic polymorphs, and \sm ectic" m esophase (arrays of chains with a better order in the longitudinal than in transverse chain direction). For a detailed review of iPP polymorphs, the reader is referred to the survey [22]. At rapid cooling of the melt (which is typical of injection molding), crystallites and sm ectic m esophase are mainly developed, whereas metastable and structures arise as minority components. Crystallization of forms occurs either under stresses or with the help of -nucleating agents added to the melt [23, 24]. Form ation of polymorph requires high pressure for commercial grades of iPP, while it can observed at atm ospheric pressure in isotactic polypropylene with low molecular weight [25]. A unique feature of structures in iPP is the lam ellar crosshatching: development of transverse lam ellae in spherulites that are oriented in the direction perpendicular to the direction of radial lam ellae [26].

Scanning electron m icroscopy [27, 28], atom ic force m icroscopy [29] and X -ray di raction [21, 23, 24] reveal that in injection-m olded specimens spherulites have the characteristic size of the order of 100 m and they contain crystalline lam ellae with thickness of 10 to 20 nm. The am orphous phase is located between spherulites and inside the spherulites between lam ellae. It consists of (i) relatively m obile chains between spherulites and between radial lam ellae inside spherulites, and (ii) severely restricted chains in the regions bounded by radial and tangential lam ellae in spherulites.

A nnealing of injection-m olded $\mathbb{P}P$ at an elevated tem perature results in (i) secondary crystallization of a part of the amorphous phase, (ii) thickening of radial lam ellae, (iii) development of subsidiary lam ellae, (iv) formation of lam ellar superstructure, and (v) grow th of the crystal perfection [30]. O ther changes in the crystalline morphology of $\mathbb{P}P$ driven by them all treatment are the subject of debate. Some researchers [23, 24, 28, 29] conclude that the fraction of spherulites increases at annealing in the interval of tem peratures between 110 and 140 C, which enhances ductility of $\mathbb{P}P$ and in proves its in pact properties. A coording to other authors [21, 26, 31], annealing of $\mathbb{P}P$ induces transformation of the smectic phase into monoclinic spherulites without noticeable development of polymorph.

M echanical bading results in inter-lam ellar separation, rotation and twist of lam ellae, ne and coarse slip of lam ellar blocks and their fragmentation [21]. Straining of iPP specimens causes chain slip through the crystals, sliding and breakage of the chains and activation of restricted am orphous regions driven by lam ellar disintegration. In the postyield region, these changes in the micro-structure im ply cavitation, breakage of crystalls, and formation of brills [32].

It is hard to believe that these m orphological transform ations in iPP can be adequately described by a constitutive m odel with a small number of adjustable parameters. To develop stress{strain relations, we apply a method of hom ogenization of micro-structure" [33]. A coording to this approach, an equivalent phase is introduced whose deform ation captures essential features of the response of a sem icrystalline polymer with a complicated micro-structure. In this study, an am orphous phase is chosen as the equivalent phase because of the following reasons:

- 1. The viscoelastic response of sem icrystalline polymers is conventionally associated with rearrangement of chains in am orphous regions [29].
- 2. Sliding of the chains along and their detachment from lamellae play the key role in the time-dependent response of sem icrystalline polymers [34, 35].
- 3. The viscoplastic ow in sem icrystalline polymers is assumed to be \initiated in the am orphous phase before transitioning into the crystalline phase" [36].
- 4. Conventional models for polyethylene [33], polypropylene [37] and poly (ethylene terephthalate) [38] treat these polymers as networks of macromolecules.

Above the glass transition temperature for the mobile amorphous phase, isotactic polypropylene is thought of as a network of chains bridged by junctions. Deformation of a specimen induces slip of junctions with respect to their positions in the bulk material.

Sliding of junctions rects slippage of the molecules along lamellae and ne slip of lamellar blocks which are associated with the viscoplastic behavior of a sem icrystalline polymer.

W ith reference to the concept of transient networks [39, 40, 41, 42], the viscoelastic response of iPP is modelled as separation of active chains from their junctions and attachment of dangling chains to temporary nodes. The network of macrom olecules is assumed to be strongly inhom ogeneous (this heterogeneity rejects the eject of spherulites on rearrangement of surrounding chains), and it is treated as an ensemble of meso-regions (MR) with various potential energies for detachment of active strands. Two types of MRs are distinguished: (i) active domains where strands separate from junctions as they are therm ally agitated (these MRs model a mobile part of the amorphous phase), and (ii) passive domains where detachment of chains from junctions is prevented. Passive MRs are associated with a part of the amorphous phase whose mobility is restricted by (i) radial and tangential km ellae and (ii) surrounding macromolecules (because of density uctuations in the amorphous phase).

Separation of active chains from temporary nodes is treated as a therm ally-activated process whose rate obeys the Eyring equation [43] with a strain-dependent attempt rate. An increase in the relaxation rate of am orphous polymers at straining is conventionally attributed to the mechanically-induced growth of free volume" between macrom olecules which, in turn, implies an increase in their mobility [44, 45, 46].

Stretching of a specim en results in (i) a mechanically-induced changes in the rate of detachmens of strands in active MRs and (ii) an increase in the concentration of active MRs. The latter is ascribed to (i) partial release of the amorphous phase in passive mesodom ains driven by fragmentation of lamellae and (ii) breakage of van der W aals links between compactly packed chains in meso-dom ains with higher density.

The exposition is organized as follows. Section 2 is concerned with the description of the experimental procedure. K inetic equations for sliding of junctions and reformation of active strands are developed in Section 3. Constitutive equations for uniaxial deformation are derived in Section 4. In Section 5 these relations are applied to t experimental data. A brief discussion of our notings is presented in Section 6. Some concluding remarks are formulated in Section 7.

2 Experim ental procedure

Isotactic polypropylene (N ovolen 1100L) was supplied by BASF (Targor). ASTM dum bell specimens were injection molded with length 14.8 mm, width 10 mm and height 3.8 mm. Three series of tests were performed. In the rst series, the sam ples were used as received without therm alpre-treatment. In the second series, the specimens were annealed in an oven at the temperature 130 C for 4 h and slow ly cooled by air. In the third series of experiments, the specimens were annealed at the same temperature for 24 h and cooled by air.

D i erential scanning calorim etry m easurem ents were carried out on STA 449/N etzsch apparatus at the heating rate 5 K /m in. The specim ens with weight of about 15 m g were tested in A 1_2 O $_2$ pans covered by lid. The therm alanalyzer was calibrated with 7 references ranging from In to N i. The speci c enthalpy of melting, H $_{\rm m}$, equals 86.9, 98.1 and 101.7

J/g, for non-annealed specim ens, specim ens annealed for 4 h, and specim ens annealed for 24 h, respectively. W ith reference to [47], we accept the value 209 J/g as the enthalpy of fusion for a fully crystalline polypropylene. The degree of crystallinity, $_{\rm c}$, is estim ated as 41.6%, 46.8% and 48.7% for specim ens not subjected to therm all treatment, sam ples annealed for 4 h, and specim ens annealed for 24 h, respectively.

A lthough the degree of crystallinity changes rather weakly (but consistently) with an increase in the annealing time, the shape of DSC curves is noticeably altered in the interval of temperatures between 120 and 160 C.DSC traces depicted in Figure 1 are similar to those found by other authors, see, e.g., [23, 26]. Labour et al. [23] attributed the growth of the low-temperature shoulder on the melting curve to the ! transition at annealing. A coording to Lijim a and Strobl [26], the endotherm al contribution on the low-temperature side of the DSC trace indicates the presence of crystallites with varying stability.

Uniaxial tensile relaxation tests were performed at room temperature on a testing machine Instron{5568 equipped with electro-mechanical sensors for the control of longitudinal strains in the active zone of samples (the distance between clips was about 50 mm). The tensile force was measured by the standard loading cell. The engineering stress was determined as the ratio of the axial force to the cross-sectional area of the specimens in the stress-free state.

Any series of mechanical experiments included 9 relaxation tests at the longitudinal strains $_1 = 0.02$, $_2 = 0.04$, $_3 = 0.06$, $_4 = 0.08$, $_5 = 0.10$, $_6 = 0.12$, $_7 = 0.14$, $_8 = 0.16$, $_9 = 0.18$, which corresponded to the domain of nonlinear viscoelasticity, sub-yield and post-yield regions for isotactic polypropylene (the yield strain, $_y$, was estimated by the supplier as 0.13). Mechanical tests were carried out at least one day after annealing of specimens to avoid the in uence of physical aging on the time-dependent response of iPP.

Each relaxation test was performed on a new sample. No necking of specimens was observed in experiments (except for the test with $_{9} = 0.18$ on a specimen not subjected to therm altreatment, which was excluded from the consideration). In the kth relaxation test (k = 1;:::;9), a specimen was loaded with the cross-head speed 5 mm/m in (that roughly corresponded to the strain rate $_{0} = 0.05 \text{ m in}^{-1}$) up to the longitudinal strain $_{k}$, which was preserved constant during the relaxation time $t_{r} = 20 \text{ m in}$.

The engineering stresses, , at the beginning of the relaxation tests are plotted in Figure 2 together with the stress (strain curves for the specimens strained up to $_9 = 0.18$. The gure demonstrates fair repeatability of experimental data.

Figure 2 shows that annealing for 4 h results in a pronounced increase in stress com – pared to virgin specimens. The growth of the annealing time implies a decrease in stress in the sub-yield region. The discrepancy between the stress{strain curves for specimens annealed for 4 and 24 h practically disappears in the post-yield dom ain.

D espite the coincidence of the stress{strain diagram s in the post-yield region for specim ens annealed for 4 and 24 h, these samples demonstrate a noticeably dimenstrate different necking behavior. Necking of specimens not subjected to thermal pre-treatment occurs at the strain $_n = 0.18$, necking of specimens annealed for 4 h takes place at the strain $_n = 0.25$, whereas no necking is observed for specimens annealed for 24 h at stretching up to the strain = 0.30.

The longitudinal stress, , is plotted versus the logarithm (log = \log_{10}) of timet (the

initial instant t = 0 corresponds to the beginning of the relaxation process) in F igures 3 to 11. These gures demonstrate that the time of annealing strongly a ects the shape of relaxation curves (especially, in the sub-yield region, see F igures 3 and 4). For any strain > 0:02, stresses in the annealed specimens exceed those in the sam ples not subjected to therm all pre-treatment. In the sub-yield domain (< 0:1) stresses in the specimens annealed for 4 h are higher than stresses in the sam ples annealed for 24 h.

Our aim now is to develop constitutive equations for the time-dependent behavior of a sem icrystalline polymer to be employed for the quantitative analysis of these observations.

3 A micro-mechanicalmodel

A sem icrystalline polymer is treated as a temporary network of chains bridged by junctions. The network is modelled as an ensemble of meso-regions with various strengths of interaction between macromolecules. Two types of meso-domains are distinguished: passive and active. In passive MRs, inter-chain interaction prevents detachment of chains from junctions, which implies that all nodes in these domains are permanent. In active MRs, active strands (whose ends are connected to contiguous junctions) separate from the temporary junctions at random times when they are thermally agitated. An active chain whose end detaches from a junction is transformed into a dangling chain. A dangling chain returns into the active state when its free end captures a nearby junction at a random instant.

Denote by X the average number of active strands per unit m ass of a polymer, by X $_{\rm a}$ the number of strands m erged with the network in active MRs, and by X $_{\rm p}$ the number of strands connected to the network in passive MRs. Under stretching some crystalline lam ellae (restricting m obility of chains in passive MRs) break, which results in a grow th of the number of strands to be rearranged. As a consequence, the number of strands in active MRs increases and the number of strands in passive m eso-dom ains decreases. This is plies that the quantities X $_{\rm a}$ and X $_{\rm p}$ become functions of the current strain, , that obey the conservation law

Rearrangement of strands in active MRs is thought of as a thermally activated process. The rate of detachment of active strands from their junctions in a MR with potential energy ! in the stress-free state of a specimen is given by the Eyring equation [43]

where k_B is Boltzm ann's constant, T is the absolute tem perature, and the pre-factor $_a$ is independent of energy ! and tem perature T. Introducing the dimensionless activation energy ! = !=($k_B T_0$), where T_0 is a reference tem perature, and disregarding the e ects of sm all increments of tem perature, T = T T $_0$, on the rate of separation, , we arrive at the form ula

We suppose that Eq. (2) remains valid for an arbitrary bading process, provided that the attempt rate, a_{a} , is a function of the current strain, a = a().

The distribution of active MRs with various potential energies is described by the probability density p(!) that equals the ratio of the number, $N_a(;!)$, of active meso-dom ains with energy ! to the total number of active MRs,

The distribution function for potential energies of active M R s, p(!), is assumed to be strain-independent.

The ensemble of active m eso-dom ains is described by the function $n_a(t; ;!)$ that equals the number of active strands at time t (per unit m ass) belonging to active M R s with potential energy ! that have last been rearranged before instant 2 [0;t]. In particular, $n_a(0;0;!)$ is the number (per unit m ass) of active strands in active M R s with potential energy ! in a stress-free m edium,

Changes in the function $n_a(t;0;!)$ are governed by two processes at the micro-level: (i) detachment of active strands from temporary nodes, and (ii) mechanically-induced activation of passive MRs. The kinetic equation for this function reads

The kinetics of rearrangement of strands in active MRs is described by Eqs. (2), (3), (8) and (14). These relations are determined by (i) the distribution function p(!) for active MRswith various potential energies !, (ii) the function $_{a}()$ that characterizes the e ect of strains on the attempt rate, and (iii) the function

that re ects mechanically-induced activation of passive MRs.

Rearrangem ent of strands in active MRs rejects the viscoelastic response of a sem icrystalline polymer. The viscoplastic behavior is associated with the mechanically-induced slippage of junctions with respect to their positions in the bulk material.

Denote by $_{u}$ (t) the average strain induced by sliding of junctions between m acromolecules (the subscript index u" means that $_{u}$ (t) coincides with the residual strain in a specimen which is suddenly unbaded at instant t). The elastic strain (that rejects elongation of active strands in a network) is denoted by $_{e}$ (t). The strains $_{e}$ (t) and $_{u}$ (t) are connected with the macro-strain (t) by the conventional formula

W eadopt the rst order kinetics for slippage of junctions with respect to the bulk m aterial, which implies that the increment of the viscoplastic strain, d $_u$, induced by the growth of the macro-strain, , by an increment, d, is proportional to the absolute value of the stress ,

The last multiplier in Eq. (17) determines the direction of the viscoplastic ow of junctions. Equation (17) is presented in the form

which im plies that the rate of sliding vanishes when the macro-strain, , remains constant.

4 Constitutive equations

An active strand is modelled as a linear elastic solid with the mechanical energy

where is the average rigidity per strand and e is the strain from the stress-free state to the deform ed state.

For strands belonging to passive m eso-dom ains, the strain e coincides with $_{\rm e}$. Multiplying the strain energy per strand by the number of strands in passive MRs, we nd the mechanical energy of m eso-dom ains where rearrangement of chains is prevented by surrounding lamellae,

W ith reference to the conventional theory of tem porary networks [42], we assume that stresses in dangling strands totally relax before these strands merge with the network. This implies that the reference (stress-free) state of a strand that is attached to the network at time coincides with the deform ed state of the network at that instant. For active strands that have not been rearranged until time t, the strain e(t) coincides with e(t), whereas for active strands that have last been merged with the network at time 2 [0;t], the strain e(t;) is given by

G iven a strain 0 , Eqs. (30) and (32) are determined by 5 m aterial constants:

- 1. an analog of the average potential energy for rearrangem ent of strands $\$,
- 2. an analog of the standard deviation for distribution of potential energies ,
- 3. the attempt rate for separation of strands from temporary junctions in active MRs $_{\rm a\prime}$
- 4. the coe cients C $_1$ and C $_2$.

Our aim is to determ ine these parameters by thing experimental data depicted in Figures 3 to 11.

5 Fitting of observations

We begin with matching relaxation curves for specimens not subjected to thermal treratment. First, we approximate experimental data measured at the strain $_2 = 0.04$. This strain is chosen because it is located substantially below the yield point, on the one hand, and the testing machine ensures high accuracy of control of the strain level in the relaxation mode, on the other.

Because the rate of rearrangement, a, and the average potential energy, , are mutually dependent [according to Eqs. (30) and (32), the growth of results in an increase in a], we set a = 1 s and approximate the relaxation curve by using 4 experimental constants: , , C 1 and C 2. To nd these quantities, we x the intervals [D; $_{max}$] and [D; $_{max}$], where the \best-t" parameters and are assumed to be located, and divide these intervals into J subintervals by the points $_{i} = i$ and $_{j} = j$ (i; j = 1;:::;J) with $= _{max}=J$, $= _{max}=J$. For any pair, f $_{i}$; $_{j}g$, we evaluate the integral in Eq. (30) numerically (by Simpson's method with 200 points and the step $_{i} = 0:1$). The

A fler determining the \best-t" values, i and j, we repeat this procedure for the new intervals [$i_1; i_{i+1}$] and [$j_1; j_{i+1}$] to ensure good accuracy of thing. Figure 4 demonstrates fair agreement between the experimental data and the results of numerical simulation with = 429 and = 4:34.

To approximate relaxation curves at other strains, k, we x the constants and found by m atching observations at $_2$ and tevery relaxation curve by using 3 adjustable parameters: $_{a}, C_{1}$ and C_{2} . These quantities are determined by using a procedure similar to that employed in the approximation of the relaxation curve at $_2$. We x the interval $[0; m_{ax}]$, where the \best-t" attempt rate a is supposed to be located, and divide this interval into J subintervals by the points i = i(i= 1;::;J) with = _{max}=J.For any i, we calculate the integral in Eq. (30) num erically and calculate the coe cients $C_1 = C_1$ (i) and $C_2 = C_2$ (i) by the least-squares m ethod from the condition of m in in um for function (34). The \best-t" attempt rate m in imizes the function J on the set , (i= 1;:::;J) . When this \best-t" value, i, is found, the procedure is repeated for the new interval [i 1; i+1] to ensure an acceptable accuracy of thing. Figures 3 to 11 show good agreem ent between the observations and the results of num erical analysis.

The above algorithm of tting is repeated to approximate the relaxation curves for specimens annealed for 4 and 24 hours. The \best-t" parameters and read 5.70 and 4.88 for samples annealed for 4 h and 5.19 and 3.80 for specimens annealed for 24 h, respectively.

For a quasi-G aussian distribution function (32), the parameters and do not ∞ -incide with the average potential energy for detachment of active strainds, $_0$, and the standard deviation of potential energies for separation of strands from the network, $_0$. The latter quantities read

The dimensionless parameters $_0$, $_0$ and = $_0=$ $_0$ given by Eq. (35) are listed in Table 1 which shows that the width of the quasi-G aussian distribution (characterized by the ratio) monotonically decreases with annealing time (how ever, changes in are rather weak).

For any longitudinal strain $_k$, the attempt rate, $_a(_k)$, is determined by m atching an appropriate relaxation curve. The fraction of active MRs, $_a(_k)$, is found from Eq. (31),

These quantities are plotted versus strain in Figures 12 and 13. The experimental data are approximated by the phenomenological equations

where the coe cients $_{i}$ and k_{i} are found by the least-squares m ethod. Figures 12 and 13 reveal that the viscoelastic behavior of specimiens not subjected to thermal treatment is rheologically simple in the sense that the quantities $_{a}$ and $_{a}$ in Eq. (30) are independent of strain. On the contrary, annealed samples demonstrate the time-dependent behavior that is strongly a ected by loading: with an increase in strain, the attempt rate, $_{a}$, exponentially decreases and the fraction of active MRs, $_{a}$, linearly grows.

A coording to Figure 12, the attempt rate, $_{a}$, is strain-independent for non-annealed specimens (however, the scatter of the experimental data is rather large). A detailed analysis of relaxation curves for non-annealed samples [49] shows that the attempt rate increases in the range of strains from = 0:005 to = 0:02 and remains constant at

0:02. This implies that the free-volum e concept [44, 45, 46] is valid for isotactic polypropylene, but the area of its applicability is conned to relatively small deform ations far below the yield strain.

6 D iscussion

Several approaches were recently proposed to the description of the viscoplastic behavior of isotactic polypropylene in the vicinity of the yield point. A boulfarajet al. [27] presum ed that plastic slip m echanisms had noticeably di erent features in and structures. K arger-K ocsis and Varga [50] and K arger-K ocsis et al. [51] explained toughening of iPP by m echanically-induced ! transform ation of crystallites. R aab et al. [52] associated the di erence in the response of and spherulites with di erent types of chain folding in lam ellae.

Three substantial shortcom ing of these concepts should be mentioned:

- 1. they are based on some hypotheses about the di erence in the mechanical behavior of and crystallites which have not yet been con med experimentally,
- 2. these models imply that changes in the stress{strain diagram s of iPP at annealing are associated with an increase in the content of -polymorph, which contradicts to WAXS (wide angle X -ray scattering) diagram s obtained by Iijim a and Strobl [26],
- 3. these approaches do not expound a pronounsed decrease in the relaxation rate with strain for annealed samples exhibited in Figure 12.

The results presented in Figures 1, 12 and 13 m ay be explained in terms of the growth of heterogeneity in the distribution of lam ellar strength notwithstanding whether the fraction of spherulites increases at annealing.

An increase in the low-temperature shoulder of the DSC traces depicted in Figure 1 (at a practically constant enthalpy of melting) means that the content of \weak" crystalline lam ellae (that melt at relatively low temperatures) noticeably grows. These \weak" lam ellae may be associated with subsidiary lam ellae in spherulites. U sing a them o-m echanical analogy, one can speculate that the grow th of the fraction of them ally weak lam ellae at annealing is tantam ount to an increase in the concentration of lam ellae which can be easily fragm ented under stretching. The latter relects an increase in structural disorder of crystallites at annealing far below the melting point observed as substantial variations in the relative intensity of Bragg relections [53].

On the other hand, annealing of isotactic polypropylene induces thickening of radial lam ellae, which results in the growth of elasticm oduli of the polymer. This implies that at relatively small strains (< 0.02 to 0.04, when fragmentation of lam ellae does not occur), annealing of PP leads to an increase in the longitudinal stress (which is demonstrated in Figure 2). At higher strains, the coarse slip starts in weak lam ellae of specimens annealed for 24 h (which are less hom ogeneous than those annealed for 4 h), whereas no lam ellar fragmentation takes place in samples annealed for 4 h. As a consequence, the stress{strain curve 2 is located higher that the curve 3 in Figure 2. W ith an increase in strain, lam ellar fragmentation occurs in both specimens, which implies that the stress{strain curves for annealed specimens practically coincide at strains exceeding the yield point $_{v} = 0.13$.

Further increase in strain in the post-yield region results in total fragmentation of lamellae that can be broken at a given stress intensity in specimens not subjected to thermal treatment. Because homogeneous (along a specimen) crystal slip becomes impossible, spatial heterogeneity in the distribution of stresses arises at the macro-level, which leads to necking of the specimens at $_n = 0.18$. For the samples annealed for 4 and 24 hours, the concentration of \weak" lamellae is higher, which implies that the strains corresponding to the total fragmentation of weak lamellae and transition to the spatially heterogeneous deformation of specimens exceed that for the non-annealed material ($_n = 0.25$ and $_n > 0.30$, respectively).

Noticeable fragmentation of lam ellae in spherulites implies that some am orphous regions are released (whose deformation was previously screened by surrounding lam ellae in non-broken crystallites), which results in an increase in the fraction of active MRs, $_{\rm a}$, with strain. This release of restricted am orphous phase is substantially less pronounced in the specimens not subjected to thermal treatment (curve 1 in Figure 13) compared with the annealed specimens (curves 2 and 3 in Figure 13). Three features of the curves depicted in Figure 13 are worth to be mentioned:

- 1. At small strains (less than 0.04), the concentration of active MRs monotonically decreases with annealing time. This phenom enon may be attributed to an increase in the fraction of am orphous regions whose mobility is restricted by surrounding lamellae at annealing (driven by development of subsidiary lamellae).
- 2. The content of active m eso-dom ains linearly grow swith strain in annealed specim ens with the rate that is practically independent of the annealing time. This may be explained by changes in the m icro-structure of spherulites at annealing: although the rate of lam ellar fragm entation is assumed to be higher in iPP annealed for 24 h, the am ount of am orphous phase released at any fragm entation act is sm aller than in iPP annealed for 4 h.
- 3. Curves 2 and 3 intersect curve 1 in the region between = 0:08 and = 0:12, i.e., in the close vicinity of the yield point for non-annealed specimens (see Figure 2).

W ith reference to C oulon et al. [29] and R aab et al. [52], we suppose that under stretching lam ellae are fragm ented into sm all aligned blocks that serve as extra physical cross-links in am orphous meso-dom ains. A coording to the concept of transient networks [42], an increase in the concentration of permanent cross-links results in a decrease in the net rate of rearrangement. This rate is characterized in the model by the attempt rate, a, which is considered as an average (over MRs) rate of detachment of active strands from their junctions. This conclusion is fairly well con med by the results depicted in Figure 12: the attem pt rate is practically independent of strain for the specim ens not subjected to therm all pre-treatment, and a exponentially decreases with strain for the annealed samples. Dispite apparent similarity in the slopes of curves 2 and 3 in Figure 12, it is rather di cult to assert that the kinetics of the strain-induced decrease in the attempt rate is independent of annealing time because of the large scatter of data for the specim ens annealed for 24 h. It is worth noting that the attem pt rates were determ ined in Section 5 from the condition a = 1 s at = 0.04, which implies that their values cannot be directly compared for specimens annealed for di erent amounts of time (because these sam ples have di erent distributions of potential energies for separation of active strands from tem porary nodes, see Table 1).

7 Concluding rem arks

Constitutive equations have been derived for the time-dependent behavior of sem icrystalline polymers at isothermal loading with small strains. A mean-eld approach is employed to develop stress{strain relations: a complicated micro-structure of isotactic polypropylene is replaced by an equivalent transient network of macrom olecules bridged by junctions (physical cross-links, entanglements and crystalline lamellae). The network is assumed to be strongly inhom ogeneous, and it is thought of as an ensemble of mesoregions with various potential energies for separation of strands from temporary nodes.

The viscoelastic response of a sem icrystalline polymer is ascribed to separation of active strands from temporary junctions and merging of dangling strands to the network in active meso-dom ains. Rearrangement of strands is modelled as a therm o-mechanically activated process whose rate is given by the Eyring equation with a strain-dependent attempt rate.

The viscoplastic response is described by slippage of junctions with respect to their positions in the bulk material. The rate of sliding is assumed to be proportional to the macro-stress in a specimen.

Three series of tensile relaxation tests have been perform ed on isotactic polypropylene at am bient temperature. In the rst series, injection-molded samples are used without therm all pre-treatment. In the second series, the samples are annealed at 130 C for 4 h, and in the last series, the speciments are annealed for 24 h at the same temperature. A djustable parameters in the stress{strain relations are found by tting observations in the range of strains from 0.02 to 0.18. The following conclusions are drawn from the analysis of experimental data:

1. The relaxation spectrum of iPP (which is determined by the distribution function, p(!), for potential energies of detachment of active strands from their junctions) is

not a ected by mechanical factors, but is altered at annealing.

- 2. The attempt rate, a, for separation of active strands from temporary nodes is practically independent of strain for specimens not subjected to therm altreatment, and it exponentially decreases with strain for annealed samples.
- 3. The relaxation strength (which is characterized by the content of active m eso-regions _a) is independent of strain for non-annealed specimens, and it linearly increases with strain for annealed samples.

These notings are qualitatively explained based on the hypothesis that the distribution of strengths of crystalline lam ellae in iPP is noticeably broadened at annealing, which results not only in thickening of lam ellae, but also in the growth of \weak" (subsidiary) lam ellae that are easily fragmented either by heating or by mechanical loading. D SC measurements provide some con mation for this assumption.


























