Structural transform ation induced by magnetic eld and colossal magnetoresistance response above 313 K in M nAs

M nAs exhibits a rst-order phase transition from a ferrom agnetic, high-spin m etal N iAs-type hexagonal phase to a param agnetic, lower-spin insulator M nP-type orthorhom bic phase at $T_{\rm C}=313$ K . Here, we report the results of neutron direction experiments showing that an external magnetic eld, B, stabilizes the hexagonal metallic phase above $T_{\rm C}$. The phase transformation is reversible and constitutes the rst demonstration of a bond-breaking transition induced by a magnetic eld. At 322 K the hexagonal structure is restored for B > 4 tesla. The eld-induced phase transition is accompanied by an enhanced magnetoresistance of about 17% at 310 K. We discuss the origin of this phenomenon, which appears to be similar to that of the colossal magnetoresistance response observed in some members of the manganese perovskite family.

M nAs is a commercially available material, intensively studied, both theoretically and experimentally, since the beginning of the last century. Interest in this compound could come up again as a consequence of new ideas and conjectures formulated during the last decade in connection with the study of the colossal magnetoresistance (CMR) response in Mn perovskites [1]. Among these ideas is the invocation of a phase separation scenario for CMR manganese oxides and related materials [2], that might be of particular relevance in systems, like MnAs, where rst-order phase transitions occur.

To our know ledge, M nAs was rst studied by Heusler [3], and later by Hilpert and Dieckmann [4, 5, 6], who discovered that the compound is ferrom agnetic with a Curie tem perature of $T_{\rm C}$ $^{\prime}$ 313 K . Serres [7] and G uillaud [8] found that a m etal-insulator transition occurs at T_C . The abrupt loss of magnetization at $T_{\mathbb{C}}$ led Meyer and Taglang [9] to assum e a ferrom agnetic-antiferrom agnetic transition at $T_{\mathbb{C}}$. However, a neutron-di raction study by Bacon and Street [10] showed that this was not the case. At the same time, Willis and Rooksby [11] measured a large (1.86%) discontinuous density change at $T_{\mbox{\scriptsize C}}$ that had been previously detected by Sm its, G erding, and Ver M ast [12]. Bean and Rodbell [13] used the volum e change to describe the st-order loss of magnetization, which takes place with a latent heat of 1.79 cal/K [14], in terms of a volum e-dependent exchange interaction. De Blois and Rodbell [15] explored the change in T_C with pressure to P = 1 kbar in elds 0 < B < 11 T. A second-order phase transition, with no volume change, was detected by calorim etric measurements at $T_t = 399$ K [9, 16]. Between T_{C} and T_{t} , the magnetic susceptibility increases with temperature [7, 17], transforming to a

Curie-W eiss law above Tt. X-ray di raction studies[18] revealed a change in the crystallographic arrangement at the rst-order transition point, from the N iAs-type (B &) hexagonal structure to the M nP -type (B 31) orthorhom bic one. The orthorhom bic distortion decreases with increasing temperature and the hexagonal B 31 structure reappears above T_t . It was soon recognized that a crossover from high to low spin states on the manganese site could occur on going from the B 81 to the B 31 structure [19] (Fig. 1). This conjecture led to a study of the M nA s $_{1}$ x P $_{x}$ and M nA s $_{1}$ x Sb $_{x}$ system s that dem onstrated the spin transition [20]. Studies of the in uence of higher hydrostatic pressure on M nAs led to a modi cation of the Bean-Rodbell theory [16, 21]. The spin-state instability appears to be responsible for a giant magnetoelastic response reported recently by Chemenko et al. [22].

Our neutron di raction study of the stability of the orthorhombic B 31 phase of M nAs in an applied magnetic eld B was performed on the high-resolution powder di ractom eter D 2B of the Institute Laue-Langevin in Grenoble, France. Two kinds of polycrystalline sam ples were measured for this work, namely a commercial one provided by Western Inorganics and another synthetized in our laboratory by solid-vapor reaction. M n and Aspowder (-325 mesh) were sealed in evacuated (P $^{\prime}$ 10 5 torr.) quartz tubes and heated at 823 K for 24 hours. This process was repeated several times with interm ediate grindings to obtain the pure compound. In the com m ercial sam ple we detected the presence of M nO im purities, but this has no in uence on the structural results here discussed. For neutron di raction experim ents, two grams of M n Aswere packed in a cylindric vanadium holder and inserted into a 5-tesla superconducting cryomagnet. The instrument is equipped with 64 collimated ³He detectors spaced at 2.5 intervals and covering a 2 angular range from 5 to 165. A complete di raction pattern was obtained by moving the detector bank 100

tim es in angular steps of 0.025. Data have been collected with incident neutrons of wavelength = 1.5943(1) A selected by G e $(3\ 3\ 5)$ m onochrom ators.

At room tem perature, below $T_C = 313 \, \text{K}$, the di raction pattern was that of the hexagonal B 81 phase with lattice param eters in agreem ent with those reported by Willis and Rooksby [11]. Re ections belonging to the orthorhombic B 31 structure described by W ilson and Kasper [18] appeared above T_C. As shown in Fig. 2, the di erences between the di raction patterns measured in zero eld at 300 K and 322 K are readily apparent. However, with the sample held at 322 K, the application of a magnetic eld B modi es substantially the di raction pro le. For a B = 5 T, the di raction pattern at 322 K is essentially the same as that at 300 K in zero applied eld. The hexagonal B 8_1 structure is clearly restored fully by the application of a B = 5 T.As is clear from Fig. 3, the extent of the orthorhom bic distortion decreases continuously as B increases, nearly vanishing by B = 4 T. These data do not show a sharp transition, but rather the coexistence of two phases with the growth of the ferrom agnetic phase at the expense of the param agnetic B 31 phase as B increases. Growth of the ferrom agnetic phase is possible because the B 31 phase is derived from the B 81 phase by a co-operative displacem ent of pairs of [1, -1, 0] rows toward one another to form stronger M n-M n bonds, across shared octahedral-site edges in zig-zag chains within the basal planes. These displacem ents also create shorter M n-A s bonds, which raises the antibonding states that -bond to the As atoms and triggers the transition to a low-spin state [21].

Extrapolation of the Brillouin temperature dependence of the magnetization of the B81 phase to above the storder transition at T_C gives a ctitious Curie tem perature $T_c = 388 \text{ K. Since an applied magnetic}$ eld B stabilizes the high-spin, ferrom agnetic phase relative to the B 31 param agnetic phase, a global insulator-m etal B 31- $B8_1$ transition might be induced by B in the interval T_C < T < T_C . A lternatively, if B 8_1 regions exist within a B 31 m atrix in the interval T_c < T < T_t , we can expect that below $\,T_{C}\,$ the ferrom agnetic B $8_{1}\,$ regions will grow in a magnetic eld at the expense of the param agnetic B 31 m atrix to beyond the percolation threshold. In either case, a CMR would occur between $T_{\rm C}$ and T_c . If the B eld induces a global B 31-B 8 transition, it would give a CMR analogous to that found, for example, at the m etam agnetic transition of the charge and orbitalordered CE phase of the perovskite N d_{0.5} Sr_{0.5}M nO₃ [23]. If, on the other hand, the magnetic eld nucleates and/or grows the B 81 phase, it would give a CMR phenomenon analogous, for example, to that of the perovskite system (La $_{0:7}$ x P r $_{x}$ C a $_{0:3}$)M nO $_{3}$ [24]. However, whereas the CMR occurs in the manganese oxides at too low a temperature to be technically practical, it would occur in MnAs a little above room temperature and could easily be adjusted to operate at room tem perature by small

com positional changes.

Fig. 4 shows the enhanced magnetoresistance response of M nAs measured in the predicted temperature range, $T_{\rm C}$ < T < $T_{\rm c}$. A lm ost the same results were obtained for both samples used in this study. Although the absolute value of the magnetoresistance is not as large as in other compounds like $La_{2=3}Ca_{1=3}M$ nO 3 [25], we call it a CMR to highlight the common origin with that in the manganites. Analogies between the behavior of M nAs in a magnetic eld above Tc and that of the manganese-oxide perovskites are noteworthy. In the manganese perovskites, the bonding delectron of a high-spin octahedral site M n (III) ion occupies a twofolddegenerate pair of e-orbitals. This e-orbital degeneracy is rem oved by a local distortion of the M nO $_{6=2}$ octahedron; and at lower tem peratures and high M n (III) concentrations, the local distortions are ordered cooperatively so as to m in im ize the associated elastic energy. A recent study of LaM $n_1 \times Ga_xO_3$ [26] has shown that in this singlevalent system, dilution of the M n (III) atom s suppresses the orbital ordering in local ferrom agnetic regions; a vibronic superexchange is ferrom agnetic whereas the orbitally ordered matrix is antiferrom agnetic. In this system, application of B disorders the orbital order of the m atrix to transform a spin glass to a ferrom agnet [26]. In the m ixed-valent perovskite system $La_{1 x} Sr_{x}M nO_{3}$, an orthorhom bic-rhom bohedral structural phase transition is induced by an external magnetic eld for x = 0.17 [27]; this transition involves a change from [1,-1,0] to [1,1,1] of the axis of cooperative rotation of the M nO $_{6=2}$ octahedra. A crossover from localized to itinerant behavior of the bonding e-electrons occurs in the compositional interval 0:1 x 0:17 [28]. In this interval, hole-rich ferrom agnetic regions are segregated from a hole-poor param agnetic m atrix in the param agnetic tem perature range 300 K by cooperative oxygen displacements. The hole-rich regions are mobile, and they grow in a B to beyond a percolation threshold by B = 5 T to give the CMR phenomenon. In the interval 0:1 x 0:15, the transition at T_C is rst-order; and in a narrow temperature range T $_{\text{O}}$ < T < T $_{\text{C}}$, the orbitals undergo a rearrangem ent to another type of order below $T_{0,0}$. Near x=0.1, the interval $T_{0.0}$ < T < T_{C} narrows, and the m atrix remains orbitally ordered in zero magnetic eld to give spin-glass behavior typical of ferrom agnetic clusters having a T_C greater than the N eel tem perature of the matrix. However, the orbitals of the matrix become disordered in a modest B to give ferrom agnetic order below a T_C . Recently, M ira et al. [29] have observed a second-order transition at a temperature $T > T_C$ in the compositional interval where they had noted a rstorder transition at T_{C} [30]. In the range T_{C} < T < T $\,$, a non-Curie-Weiss paramagnetism has been found by de Teresa et al. [31], sim ilar to the behavior of M nAs in the range $T_C < T < T_t$ [7, 8]. M oreo et al. [32] have m ade a computational study to argue that in the mixed-valent

m anganese-oxide perovskites, hole-rich clusters that are m etallic and ferrom agnetic coexist with a param agnetic, hole-poor insulating matrix; the ferromagnetic clusters grow in a magnetic eld B.G oodenough [33] has invoked the virial theorem to make the same deduction for the m anganese-oxide perovskites at the crossover from localized to itinerant behavior of the -bonding electrons. However, MnAs is single-valent, so the analogy with LaM $n_{1 x} G a_{x} O_{3}$ is more appropriate even though this perovskite remains insulating in the ferrom agnetic phase. In M nAs, the basal-plane orbitals on the M n atom s are half- lled, and the electrons approach the crossover from localized to itinerant electronic behavior. In the param agnetic B 31 phase, the M n atoms become displaced below Tt so as to form stronger M n-M n bonds in the zigzag chains and weaker M n-M n bonds between the chains. These displacements not only order the Mn-As bonding so as to induce the low-spin state, but they also represent an ordering of the in-plane M n-M n bonds that changes the translational sym metry so as to split the basal-plane band at the Ferm i energy. Ferrom agnetic interactions by the other d electrons are dom inant, but these interactions are weakened by the transition to the low-spin state, which reduces the M n-M n separation and strengthens the in-plane M n-M n bonding. Since no bonding occurs between half- lled orbitals with parallel spins, stabilization of the high-spin ferrom agnetic B 81 phase suppresses inplane M n-M n bonding and increases the in-plane M n-M n separation. Stabilization of the ferrom agnetic phase in a B with removal of the in-plane Mn-Mn bonding is to be com pared with suppression by a B of the orbital ordering at the M n (III) ions in LaM $n_{1 x}$ G a_{x} O $_{3}$. This is the st crystallographic transition induced by a magnetic eld that involves breaking of metal-metal bonds rather than orbital disorder.




FIG. 1: The orthorhom bic unit cell of the B 31 form of M nAs in relation to the hexagonal B 8_1 type cell. M n (white circles) and As (black circles) atoms are in the 4c special positions of the P nm a space group, (x,1/4,z), with x=-0.005 and z=0.223 for M n, x=0.275 and z=-0.082 for As.




FIG. 2: Selected regions of the di raction patterns recorded at 27 C w ith no eld (circles), at 49 C w ith no eld (squares) and at 49 C w ith an applied eld of 5 tesla (triangles).




FIG.3:M agnetic eld dependence of a selected region of the diraction pattern recorded at $322~\mathrm{K}$, showing the evolution from the orthogonal to the hexagonal form of M nAs.




FIG. 4: M agnetoresistance (M R = [(0)- (5T)/ (0)] x 100) versus tem perature of M nAs and m agnetisation m easured at 0.1 T in zero-eld-cooling conditions.
