K ertesz on Fat G raphs?

Abstract

The identi cation of phase transition points, $_{\rm c}$, with the percolation thresholds of suitably de ned clusters of spins has proved immensely fruitful in many areas of statistical mechanics. Some time ago Kertesz suggested that such percolation thresholds for models de ned in eld might also have measurable physical consequences for regions of the phase diagram below $_{\rm c}$, giving rise to a \Kertesz line" running between $_{\rm c}$ and the bond percolation threshold, $_{\rm p}$, in the M; plane.

A though no therm odynam ic singularities were associated with this line it could still be divined by looking for a change in the behaviour of high-eld series for quantities such as the free energy orm agnetisation. A dler and Stau er did precisely this with some pre-existing series for the regular square lattice and simple cubic lattice Ising models and did, indeed, nd evidence for such a change in high-eld series around $_{\rm p}$. Since there is a general dearth of high-eld series there has been no other work along these lines.

In this paper we use the solution of the Ising model in eld on planar random graphs by Boulatov and K azakov to carry out a sim ilar exercise for the Ising model on random graphs (i.e. coupled to 2D quantum gravity). We generate a high-eld series for the Ising model on 4^{4} random graphs and exam ine its behaviour for evidence of a K ertesz line.

1 Introduction

The question of how to give a geom etrical, percolation-like interpretation of the therm al transition in the Ising model was nally resolved by Coniglio and K lein [1], although the idea is already in plicit in the work of Fortuin and K asteleyn [2] on a correlated bond-percolation model for the q-state Pottsm odel and in many ways is a realisation of F isher's earlier ideas on critical droplets [3]. The key insight was to construct spin clusters in which like spins were joined with probability p = 1 exp(2), where $= 1 = k_B T$ is the inverse temperature. These then percolated at the correct critical temperature T_c and gave the correct therm al exponents. The denition of such stochastic clusters has led directly to the developm ent of cluster algorithm s and sim ilar geom etrical representations in many statistical mechanical models.

Since Coniglio-K lein clusters are intended to access the thermal phase transition of the Ising model they are not usually formulated in the presence of an external eld, since in this case the free energy becomes analytic and the thermal transition is washed out. However it is clear that one can still build such clusters when the external eld is non-zero. For a given external eld value H these clusters will percolate at some temperature T_K (H), and varying H then traces out the so-called K ertesz line shown in Fig.1 in the M; u plane, where M is the magnetisation and u = exp(4). For H = 0 we have the usual thermal Ising transition at u_c , whereas for H ! 1 we recover standard bond percolation for the lattice in question at u_p .

A lthough a percolative transition exists across the K ertesz line no singularities are expected in the therm odynam ic quantities related to the Ising model, since these can only appear for H = 0. N onetheless, som ething physical is going on since the percolative transition is signalled by \wrong-sign", say down, spin clusters losing their surface tension. This begs the question of whether the K ertesz line leaves any discernible signal in measurable quantities. This issue was discussed by K ertesz him self [4], and later investigated num erically by Stau er and A dler [5]. If one considers the num ber of down spin clusters n_s (u; H) in a non-zero up eld H then standard nucleation theory leads to

below the K ertesz line, where $y = \exp(2H)$ and = 1 1=d. The second term arises from the surface tension of the droplets and is a direct extrapolation of the H = 0 (y = 1) result. On the other hand above the K ertesz line a zero surface tension expression of the form

where < 1 is postulated. This means that cluster numbers will decay as

below the K ertesz line whereas they will decay as y^{s-s} above the line.

Physical quantities such as the magnetisation can be expressed in terms of ns,

so we can see that they can be expressed in terms of a (large-eld) expansion in y using equs. (1) and (2). Since equ. (2) shows that y is electively replaced by y above the K ertesz line, one m ight expect the series for M (and others) to converge up to som $e_y > 1$ (since < 1).

2 Square Lattice R eprise

In order to investigate the possible consequences of a Kertesz line Adler and Stau er [5] analysed the radius of convergence of som e long-standing high-eld series for the free energy and the magnetisation of the Ising model using Pade approximants [6]. We brie y review their results here for comparison with the random graphs in the next section. Taking the series for the free energy F or its derivative, we have

where the so-called high-eld polynom ials $L_s(u)$ were calculated up to order 15 for the square lattice in [6].

The series for F, $\frac{dF}{dy}$ and the magnetisation M were subjected to a standard unbiased D log-P ade analysis in order to estimate the radius of convergence. If we assume a singularity of the form F (y y_c), then

and an [L=M]Pade approximant to $\frac{d}{dy}\log F$ (or $\frac{dF}{dy}$, or M),

would be expected to show the pole at y_c as a zero of Q_M (y). For the square lattice for instance $u_c = 3$ 3 2 = 0:17157::: and $u_p = 1=4$, so we would expect to see a change in y_c at, or around, u_p .

We show the results of such an analysis on $\frac{dF}{dy}$ for the estimated radius of convergence as a function of u in Fig. 2. We can see that there is evidence for a change in the behaviour of y_c around u = 1=4. In the plotted data jumps are present in the [7=7] and [6=7] approximants at u_p , and the [5=5] and [6=6] approximants cease to give a real pole term for some u u_p . In Fig. 2 we have plotted the [5=5] and [6=6] approximants up to the largest real pole value obtained. As shown in [5] the behaviour for other approximants and for F and M is similar { in all cases there is evidence of an increase in the estimated y_c around u = 1=4 or the approximant's estimates of y_c become complex.

O ne detail that should be noted is that both here and in the random graph case investigated below there is a tendency for the approximants to throw up spurious cancelling pole/zero pairs, so one must be careful to bok at both the num erator and denom inator of the approximant to make sure that one is determining the \real" pole term. This also introduces a certain degree of subjectivity into proceedings since the poles and zeroes are only equal to within num erical accuracy. All the series calculations were done with exact arithmetic, with xed (but large) precision only being resorted to in the nal stage of obtaining the roots of the Pade num erators and denom inators.

An analysis of the series for the simple cubic lattice Ising model, available up to order 13, in [5] also gave very similar results, with signs of an increase in the estimated radius of convergence, or instability in the approximants, in the vicinity of the percolation temperature for the lattice. The usual caveats of course apply to any such discussion, since the series involved are quite short (and of som e considerable vintage), but the cum ulative evidence of the various approximants and the results on di erent lattices was felt in [5] to lend support to the K ertesz scenario.

3 Fat R and om G raphs

G iven the evidence for a K ertesz line in the Ising m odel on the square and cubic lattices it is tempting to bok elsewhere for the phenom enon. In order to carry out such an analysis for otherm odels (or lattices) we require a high-eld expansion, which are in general rather hard to come by. In what follows we discuss obtaining such an expansion for an exact solution to the Ising m odel in eld on planar (fat) random graphs which was derived by B oulatov and K azakov [7, 8]. They considered the partition function for the Ising m odel on a single planar graph with n vertices

then sum m ed it over som e suitable class fGⁿg of n vertex graphs (e.g. 3 or 4 random graphs) resulting in ______v

before nally forming the grand-canonical sum over dierently sized graphs

where $c = u^{1=2} = exp(2)$. This last expression could be calculated exactly as matrix integral over N N Herm itian matrices,

where the N ! 1 lim it is to be taken to pick out the planar diagram s and we have used the potential appropriate for 4 (4-regular) random graphs.

W hen the integral is carried out the solution is given by

where the function g(z) is

A swe can see this is a solution in eld for the Ising model on random graphs, since g(z) has been obtained in full generality for $y = \exp(2H) \in 1$.

In order to generate a high-eld series from equ. (12) we revert the series for g(z) to get a series z(g). This can then be used in equ. (12) in order to obtain an expansion for the partition function in powers on g (i.e. in the number of vertices). As we noted in [9] it is only necessary to consider the rst of the term s in $Z = Z_1 + Z_2 + Z_3$ with

since $Z_k = \prod_{n=1}^{P} a_k^n A_n$ (u) g^n where A_n (u) is identical for all the Z_k .

This can be traced back to the generic expression for the partition function of any Herm itian matrix model, which is of the form

where in the case of the Ising model on 4^4 graphs f is the solution to

The expression in equ. (12) is obtained from this by dening z = 2gf=c and integrating by parts. One nds that the coecient of g^n in Z_1 should be (n + 1)(n + 2) times the full value obtained from expanding $Z_1 + Z_2 + Z_3$ from these considerations, which can be con med by comparison with the results presented for low orders in [10, 11]. For example, the coecient of g^2 in [10] is found to be¹

as expected. The high-eld polynomials come from an expansion of the free energy F rather than the partition function Z, so there is one further step.

We choose to consider $\frac{dF}{dy}$ for calculational convenience rather than directly taking the logarithm to obtain F, since the operation of taking a logarithm proved to be rather memory intensive. Since the free energy per site is de ned as (absorbing a factor of)

$$F = \lim_{n \ge 1} \frac{1}{n} \log Z_n;$$

we can approxim ate this by

$$\frac{d}{dy}F = \frac{1}{nZ_n}\frac{dZ_n}{dy}$$

for some su ciently large n (in our case we take n = 32). The behaviour observed for $\frac{dF}{dy}$ in [5] was in any case similar to that of F and M.

4 The Percolation Threshold on ⁴ G raphs

K azakov has already calculated the threshold on ³ graphs, so it is a simple matter to repeat the calculation to obtain the result he stated ($p_{cr} = 2=3$), but did not derive, for ⁴ graphs in [7]. We have chosen to work with ⁴ graphs rather than ³ graphs here because the expression for g(z) turns out to be rather more inconvenient with ³ graphs and reverting this in the manner of the previous section to get Z₁ is much more cumbersome than it is for ⁴ graphs.

The idea is to consider the percolation problem as the q! 1 lim it of a q-state Potts model, where the Potts partition function is

with $H = \int_{hiji}^{r} (i; j)$, and the spins i take on q values. This Potts partition function, just as in the Ising case, can be expressed as the matrix integral over N N Herm itian matrices i z

where

and we have used $c = 1 = (\exp(\tilde{}) + q 2)$ for the Potts coupling and temperature to distinguish them from the Ising case. The apparent factor of two di erence between the q = 2 version of c and the Ising coupling in the previous section and the consequent factor of two in the temperature scales is accounted for by the use of a i_{j} interaction in the Ising model and a i_{j} interaction in the Potts model.

This in turn m ay be recast into a matrix external eld integral by introducing a further matrix integration in the dummy N \sim N H erm itian matrix X,

where $h^2 = c$. In the lim it q! 1, the percolative probability $p = 1 \exp(~~)$ is related to these parameters by $h^2 = c = 1 = p$ 1. The mean number of percolative clusters per unit volume f (p) may be calculated from the quantity (g;p), which is given in terms of the Potts free energy by

Evaluating (g;p) in the saddle-point approximation gives

where the x_i are the saddle point values of the X eigenvalues and F⁰(g) is the standard one-m atrix model free energy. As in the ³ model the $\frac{2}{N^2}$ log (x) term is what counts for the percolative critical behaviour, and this gives

where is the eigenvalue density for the one-matrix ⁴ model which has support on [a;a]. The ⁴ model will be critical when the argument of the rst logarithm is zero within the region of integration, which rst occurs when $u^2 = uv = v^2 = a^2 = 2=3$, so $p_{cr} = 2=3$ as announced in [7]. Since $p_{cr} = 2=3 = 1$ exp(\sum_{p}), allowing for the factor of two between Ising and Potts conventions gives exp(\sum_{p}) = exp(2_p) = 1=3, so on the ⁴ graphs $u_p = exp(4_p) = 1=9$ to be compared with the 1=4 of the regular square lattice.

5 Pade Approxim ants for ⁴ G raphs

The procedure is identical to the square lattice investigation: here we take Z_{32} , calculate

$$\frac{d}{dy}F = \frac{1}{32 Z_{32}} \frac{dZ_{32}}{dy}$$

as our estim ate of $\frac{d}{dy}F$ and then take unbiased D log-P ade approximants to this expression in order to determ ine y_c . A gain, exact arithmetic is used until the nalstage of extracting the zeroes and poles of the P ade approximant is reached. Since our starting series is rather longer than the square lattice case, we calculate up to the [15=15] approxim ant. In Fig.3 we show the [13=13], [14=14] and [15=15] approxim ants plotted against u. The near-diagonal approxim ants and lower approxim ants on the ⁴ graphs which we also calculated all give very sim ilar estimates for y_c and we have not shown them for clarity.

It is immediately obvious from Fig. 3 that although there is evidence for a change in the behaviour of the high-eld series for $u > u_p$, it is rather less clear cut than for the square lattice series. We have emphasised the fact by plotting the [7=7] square lattice approximant over the ⁴ results to allow a direct comparison. Indeed, without the prejudice of a previous calculation of u_p it would be fair to state that although there are some signs of an increase in the estimates of y_c in the vicinity of $u_p = 1=9$ the variation is strongly apparent only for larger u values.

O ur calculation of the series for 4 graphs is for a set which includes various degeneracies such as self-energy and \setting-sun" diagrams in the ensemble of graphs, and the inclusion of such graphs has been found empirically to reduce nite-size e ects [12] by comparison with more restricted ensembles of 4 graphs. It is of course possible that any ensemble of random graphs may be subject to greater nite-size corrections than a square lattice so it is conceivable that this might explain a weaker signal for the K ertesz line than on the square lattice.

6 Conclusions

We reviewed the existing results for the existence of the K ertesz line for the Ising m odel on the square lattice, which lend support to the suggestion that a change in the behaviour of the high-eld series should be visible around the percolation threshold. We then m ade use of the Boulatov and K azakov solution of the Ising m odel on planar random graphs to construct a high-eld series for planar ⁴ graphs and subjected this to the sam eD log-Pade analysis carried out on the (shorter) square lattice series. We found that there are clear signs in this series too for a change in behaviour, since the estim ated values of the radius of convergence, y_c, increase as u = exp(4) is increased, as seen in F ig. 3. W hat is less clear is the onset of this behaviour { there are no large jumps in the estim ated y_c at u_p, such as occur for at least som e of the approxim ants to the square lattice series. It is fair to say how ever, that all the plotted approxim ants (and others we have not plotted) do begin to increase around, or just above, the calculated value of u_p for the ⁴ graphs, nam ely 1=9.

On balance therefore, the analysis of the high-eld series for the Ising model on planar ⁴ random graphs also lends support to the existence of a K ertesz line. Since clusters of spins behave in the same manner on ensembles of planar random graphs as they do on the square lattice (the W ol [13] or Swendsen-W ang [14] algorithms, for instance, still do an excellent job of reducing critical slowing down for Ising models on ensembles of random graphs) this is reassuring. It would have been interesting, but beyond the scope of the resources available to us, to extend the order of the ⁴ high-eld series to see what e ect this had on the estimates of y_c . It would also be an interesting exercise to extend the

now vintage square lattice series for further com parison, bearing in m ind that the clearest signal for a jum p in y_c was only seen in the highest available approximants.




Figure 1: A schematic drawing of the Kertesz line in the M ; $u = \exp(4)$ plane. The phase co-existence line is shown in bold, the Kertesz line dotted and the critical u_c and percolation u_p points are marked.




Figure 2: The estim ated radius of convergence for the high-eld series of $\frac{dF}{dy}$ on the square lattice plotted against u. The di erent sym bols represent the di erent approxim ants used. Note that the jump is seen in both the [7=7] (star) and [6=7] (diam ond) approxim ants, whereas the [6=6] (cross) and [5=5] (triangle) approxim ants give com plex roots for some u u_p .




Figure 3: The estimated radius of convergence for the high-eld series of $\frac{dF}{dy}$ on ⁴ graphsplotted against u. The symbols are the estimates obtained from [13=13] (diam ond), [14=14] (circle) and [15=15] (triangle) Pade approximants, and the [7=7] approximant for the square lattice is also shown for comparison using the starred symbol.
