Fracton pairing m echanism for \strange" superconductors: Self-assem bling organic polym ers and copper-oxide com pounds

Self-assembling organic polymers and copper-oxide compounds are two classes of \strange" superconductors, whose challenging behavior does not com ply with the traditional picture of Bardeen, Cooper, and Schrie er (BCS) superconductivity in regular crystals. In this paper, we propose a theoreticalm odel that accounts for the strange superconducting properties of either class of the materials. These properties are considered as interconnected manifestations of the same phenom enon: We argue that superconductivity occurs in the both cases because the charge carriers (i.e., electrons or holes) exchange fracton excitations, quantum oscillations of fractal lattices that m in ic the com plex m icroscopic organization of the strange superconductors. For the copper oxides, the superconducting transition tem perature T_c as predicted by the fracton mechanism is of the order of 150 K.W e suggest that the m arginal ingredient of the high-tem perature superconducting phase is provided by fracton coupled holes that condensate in the conducting copper-oxygen planes ow ing to the intrinsic eld-e ect-transistor con guration of the cuprate com pounds. For the gate-induced superconducting phase in the electron-doped polymers, we simultaneously nd a rather modest transition tem perature of (2 3) K owing to the limitations in posed by the electron tunneling processes on a fractal geometry. We speculate that hole-type superconductivity observes larger onset tem peratures when compared to its electron-type counterpart. This promises an intriguing possibility of the high-tem perature superconducting states in hole-doped com plex m aterials. The theoretical m ethods applied in our study bring together the so-called strange (or fractional) dynam ics and the unconventional, topological description of the complex fractal sets underlying the fracton spectrum. A generalized kinetic equation containing integer time and fractional real-space derivatives is found for the fracton excitations in the harm onic approximation. The fracton superconductivity mechanism is further discussed in connection with experim ental observations. An important prediction of the present study is universality of ac conduction of the strange m aterials above the superconducting transition tem perature T_c.

I. IN TRODUCTION

The physics of two-dimensional electron gases has been in uential in condensed-matter research since the discovery of highly correlated liquid states, such as electron liquids with fractionally charged excitations,¹ and hightemperature superconducting uid phases in copperoxide compounds.² The trademark of copper oxides is challenging superconducting transition temperature² (up to $T_c = 160 \text{ K}$); this somehow involves the speci cm icroscopic organization of the cuprate superconductors com – posed of the alternating conducting-insulating planes.

The fundamental properties of correlated electrons have received attention with the observation of quantum H all e ect in polymeric materials (such as pentracene)³ and superconducting behavior in molecular crystals⁴ and organic polymer lm s.⁵ The discovery of superconducting organic polymers⁵ addressed the correlations between the current-carrying electrons in presence of the multiscale structural disorder associated with the com plax microscopic texture of the polymer system.⁶

O rganic polym er $\,\rm lm\,s^5$ were made to superconduct through charge injection in a eld-e ect-transistor geometry. In eld-e ect transistors, a voltage applied to the gate electrode controls the charge ow along the surface of the active (conducting) layer. The active material in the experiment in Ref.⁵ was solution-cast regioregular poly (3-hexylthiophene) (P 3H T) deposited on an insulating substrate. A superconducting ow was observed below T_c 2:35 K for the high gate-induced carrier concentration of about one charge per 12 thiophene rings. The superconducting behavior in P 3H T was related to the self-assem bly properties of the polymer, which form s thin regular $\,\rm lm\,s$ ow ing to self-organization.^{5;6}

Remark that the gate-induced charge doping introduces no additional disorder into the material, enabling a direct observation of the superconducting transition as a function of temperature and charge carrier concentration.5;6 Conversely, chem ical doping (i.e., injection of suitable in purities such as chlorine or alkali. metals, leading to a surplus or de cit of free electrons) inevitably increases the disorder.⁵ This changes the properties of the conducting system and can suppress the inherent self-organization m echanism sthat m ake organic polym ers superconduct. W ith increasing concentration of the in purities, the superconducting transition temperature T_c shifts to lower values, while the transition region becom es generally broader.⁵ Chem ical doping has thus deed attempts to turn polymers into superconductors.5;7 Until the eld-e ect experiments in Ref.,⁵ the only polymeric material exhibiting superconductivity was a crystalline inorganic polymer polysulfur nitride (SN)x having a transition tem perature of 026 K $\stackrel{8}{.}$

The key issue on the superconducting organic polymers is the comprehension of the electron pairing mechanism. The main problem is that electronic properties of the polymers are dominated by the intrinsic spatial disorder

which supports charge localization at low tem peratures.⁶ (The e ect of the disorder can be provided, for instance, by a multiscale braiding of the polymer molecules.) Superconducting transition in organic polymers have been discussed⁶ in connection with both the conventional picture of Bardeen, Cooper, and Schrie er (BCS) superconductivity relying on the electron-phonon interactions in regular crystals,⁹ and Little's exciton mechanism, in which phonons are replaced by other electrons.¹⁰ An alternative approach could be based on a spin-triplet, even-parity superconductivity for disordered, interacting electron system s.¹¹ W hile strong argum ents in favour of the traditional explanation in terms of phonon-mediated superconductivity have been proposed, $5^{5,6}$ the form ation of the Cooper pairs on the disordered polym er patterns (revealing no regular monocrystalline con guration, contrary to the BCS scenario) remains so far generally unclear.

In this paper, we propose a feasible electron pairing m echanism for the \strange" m aterials like organic polym er P 3H T that m ay observe superconducting behavior in spite of the intrinsic structural disorder. We suggest that electron-electron interactions in such m aterials are m ediated by fractons, quantum oscillations of the m ultiscale conducting arrays organized in a fractal lattice. The fracton pairing m echanism thereby pro ts from the com plex geom etry of the e ective conducting set.

It is instructive to emphasize that fracton-mediated interactions between the current-carrying particles could be characteristic of the disordered solids as a whole, rather than speci cally of the polymeric materials. Selfassembling organic polymers are considered in our study as a suitable guide to the \strange" superconducting properties of complex systems, while the fracton mechanism is not attributed only to the polymers.

W e assum e, as a general condition, that the material posseses com plex m icroscopic organization that supports a well-de ned branch of fracton excitations. W e argue that the fracton modes may then e ectively con ne the current-carrying electrons in couples below a certain tem - perature, thus leading to the occurrence of the marginal superconducting uid state. W e demonstrate, furthermore, that replacing electrons with holes" in the fracton scenario leads to the intriguing hints regarding the nature of the high-tem perature superconductivity in copper oxide materials. The fracton approach may thereby indicate that the superconducting properties of organic polymers and of copper oxides are both parts of the same problem.

The paper is organized as follows. The basic assum ptions of our study are formulated in Sec. II. A short summary on fracton dynamics is condensed to Sec. III. The fundamental topological properties of percolating fractal lattices giving rise to a well-de ned fracton spectrum, are analyzed in Secs. IV V. The fracton wave function is derived in Sec. VI from a fractional kinetic equation in the harmonic approximation. Based on the results obtained, the superconducting transition in selfassembling electron-doped organic polymers is discussed in Secs. VII VIII. A case for high-temperature superconductivity is analuzed in Sec. IX; both hole-doped complex systems and copper-oxide compounds are considered. Implications of the fracton pairing mechanism on ac conduction properties of the strange superconductors above the marginal transition temperature T_c are addressed in Sec. X. The principal conclusions are given in Sec. X I.

II.FRACTAL GEOM ETRY OF PERCOLATION

W e start with a suitable geometric description of the disordered molecular (polymeric) structures. Our basic assum ptions are, 1) self-organization of organic polymers results in development of a multiscale conducting network of molecules, 2) the self-organized conducting networks form percolating sets, and 3) these sets are critical, i.e., at the threshold of percolation. A percolating network is de ned as an in nite connected web-like conguration embedded in an Euclidean space E^d, where d is am bient (integer) dimension; in what follows, d 2. The term \percolating" is synonymous with \in nite connected" and guarantees that the molecular network conducts on the macroscopic scales. The threshold character m eans that the percolating web, although in nite in size, is m in im ally developed in E^d, i.e., observes a sort of a structural extrem um . M ore precisely, assume the e ective conducting web is composed of multiscale conducting links whose concentration in the space E^d is quantied $q 1^{12}$, For q! 0, no connected by the param eter 0 structure can exist as the web lacks conducting elements on all scales; conversely, for q ! 1, the multiscale conducting links densely 11 the am bient space. As q continuously grows from 0 to 1, an in nite connected structure (which occupies only a fraction of the embedding space E^{d}) rst appears for $q = q_{c}$, where $0 < q_{c} < 1$ is some critical concentration of the links. (Roughly speaking, q is \of the order of one half".) The value $q = q_c$ can be identied with the percolation threshold in the system, corresponding to a m in im al (critical) network which conducts on large scales. A sq approaches q_c , the percolation correlation (i.e., pair connectedness) length diverges as

jq _gj ,where is the percolation length exponent depending solely on the embedding dimension d 2. For q > q_c, the probability to belong to the in nite connected network behaves as Q_1 (q) / (q q_c) / ⁼, while dc conductivity goes to zero as (0) / (q q_c) / ⁼. A long with the exponent , the percolation indices and completely characterize the structural properties of the e ective conducting set for q ! +q_c. Both Q_1 (q) and (0) vanish for q < q_c.

The m icroscopic conducting mechanism operating in the polymeric materials such as P3HT is supported by the conjugated structure of alternating single and double bonds linking the carbon atoms in their backbone.⁶ This bonding structure allows one electron from each carbon atom to move along the molecule and become conducting.^{6;13} The multiscale braiding of the polymer molecules gives rise to a complex spatial distribution of the conducting links, modeled in our study by a percolating web-like pattern.

A rem arkable property of percolating networks at criticality (i.e., near the marginal threshold $q = q_c$) is their self-sim ilar (fractal) geom etry.^{12;14 {16} In a physical system, the fractal geom etry approxim ation holds in a wide but nite range of spatial scales , which vary between the microscopic (\lattice") distance min a and the percolation correlation length max a.G iven arbitrary length scale a < < , one nds the number of the links that belong to the percolating network within the volume $d = E^d$ to be N / d_f . The quantity d_f is the generalized (Hausdor) dimension of the network which is not larger than d, i.e., $d_f = d_i^{14;17}$ Speci cally, = for $a^{<}$ $\stackrel{<}{\cdot}$ $\stackrel{12}{\cdot}$ N ote that d_{f} $d_f = d$ 1 for fractal networks adm itting connected pathes to in nity.

The value of the Hausdor dimension d_f is in one-toone correspondence with the topological entropy of the fractal network, S_f :¹⁸

The topological entropy $\rm S_f$ m easures the structural disorder in complex system s.¹⁹ For well-ordered conducting polymer chains without braiding, d_f ! 1 and $\rm S_f$! 0. Such conditions could be realized at low absolute temperatures T ! 0. For the multiscale path-connected braided structures, d_f > 1 and $\rm S_f$ > 0. Similar to the conventional, them odynamic entropy, the topological entropy $\rm S_f$ is a non-decreasing function of T, i.e., $\rm @S_f=\ensuremath{@CT}$ 0. From Eq. (1) one obtains

At length scales exceeding the correlation length , the fractal geom etry of percolation crosses over to a statistically hom ogeneous distribution of the conducting links. Thism eans N / ^d for [>] . At the short length scales [<] a, the m aterialm ay reveal regular crystalline structure; in polymers like P 3H T, this structure can be associated with ordered nanocrystals embedded in a disordered m atrix.⁶ The typical size of the nanocrystals is, a 10⁶ cm.⁵ N ote that the ratio =a in real fractalm aterials is at most 10³ due to the limitations in posed by therm al vibrations and by gravitational stability.²⁰

The form ation of fractal conducting networks in the range of scales a < may be explained by selforganized criticality (SOC), a phenomenon which often underlies the development of fractal structures in complex nonlinear dynamical system s.²¹ Here, the concept of SOC is understood as a synonymous with \selforganization to a state of critical percolation."^{18;22} The inherent dynamics of the ideal SOC state is manifested in the low frequency f¹ uctuation spectrum²¹ custom – arily referred to as icker noise. The feasible existence of the anom alously large icker noise in resistance uctuations for disordered solid materials was addressed in Ref. 23 .

III.FRACTON DYNAM ICS

At the quantum level, the dynamics of a percolating fractal network can be described in terms of elementary (quasi)acoustic excitations term ed fractons.²⁴ Fractons are considered as quantum oscillations of the local disorder in the system. In the harmonic approximation, fractons are well de ned quantum states with in nite inelastic lifetim es.²⁵ Statistical properties of fractons were reviewed by Nakayama et al.¹⁶ in connection with the topological characteristics of fractal sets. A direct experimental observation of fracton modes in real complex m aterials was reported in R ef.²⁰

Fracton excitations of the critical percolating networks form a well-de ned (quasi) acoustic branch representing vibrations of multiscale fractal blobs.²⁵ In fractal geom etries, such vibrations acquire the role of ordinary phonons propagating through periodic crystal lattices. (In polymeric materials like P 3H T, the \blobs" may be identified with the disordered polycrystalline matrices.) Note that phonons having wavelengths shorter than the percolation correlation length are strongly scattered by the structural inhom ogeneitizes associated with the fractal geom – etry of the underlying pattern. Hence phonons cannot be eigen vibrationalm odes of a fractal. C onversely, fractons are localized states, in the Anderson sense,²⁶ with a localization length larger than the characteristic phonon scattering length.^{20,25}

The de ning feature of the fracton branch is the nonlinear relationship^{16;24;25}

where is the index of connectivity of the fractal. The index of connectivity determ ines the m icroscopic com – position of the fractal object through the m arginal links between the constituent elements.²⁷ The value of does not depend on the way the fractal is folded in the em – bedding Euclidean space E^d (as opposed to the H ausdor dimension d_f which relies on the embedding properties of the fractal). Contrary to the H ausdor dimension d_f, the index of connectivity is a topological invariant of the fractal structure, i.e., remains unchanged under the hom eom orphic deform ations that preserve the property

IV.THE PERCOLATION CONSTANT

N ear the threshold of percolation, $q=q_{\rm c}$, the value of the spectral dimension $d_{\rm s}$ can be obtained from topological arguments. 31 In fact, let $0\,\rm N_c$ and N $_{\rm c}$ denote the critical and fat percolating networks, respectively. The fat percolating network is de ned as the set of points which can be path connected^{32} to $0\,\rm N_c$ for all $q < q_c$. O bviously, N $_{\rm c}$ is an open set, 33 and $0\,\rm N_c$ is the boundary 33 of N $_{\rm c}$. (This motivates the commonly used sign $\backslash 0^{\,\rm m}$ in the notation 0 N $_{\rm c}$.) We also de ne the closed set 33 N $_{\rm c}$ = N $_{\rm c}$ $0\,\rm N_c$.

It can be proven³¹ that $(N_c \text{ and } N_c \text{ are topologi-cally equivalent with the fractional (d_s 1)-dimensional sphere S^{d_s 1} and the fractionald_s-dimensional open disk$

The introduction of the fractional manifolds^{31} $S^{d_s\ 1}$ and D^{d_s} extends the notion of the sm ooth integer-dim ensionalm anifolds^{32;34} $S^{d\ 1}$ and D^{d} to arbitrary real dimensionalities $d_s < d$. As is shown in Ref.³¹, the closed fractional manifold $D^{d_s} = D^{d_s} S^{d_s 1}$ admits everywhere a dense coverwhich has no points of selfing by a fractal curve crossings at the critical threshold $q = q_{r}$. The absence of points of self-crossings m in im izes the topology of the network for $q = q_c$ and thereby supports the conditions of the critical percolation. (For $q > q_c$, the corresponding manifolds contain \too many points" to be densely covered by a curve without self-crossings. The minimal closed percolating structure N_c E^d therefore contains \the sam e num ber of points" as a fractal curve without self-crossings, folded in E^d. This serves as the de ning feature of the critical percolation.³¹) Because is dense everywhere in D^{d_s} , it must be based on exactly the same solid angle () = d_s as the fractional sphere $S^{d_s 1} = QD^{d_s}$ [see Eq. (10)]. On the other hand, a curve cannot be principally based on a solid angle () smaller than $_2=2 =$ in d 2 embedding dimensions, for d 2. The criticality condition q = qie., () m in in izes the solid angle d_s , i.e., () = d_s = at the percolation threshold.³¹ The solution to this transcendental algebraic equation is the fundam ental topological parameter C (term ed \the percolation constant" in Ref.²⁸) satisfying, by de nition, the identity³¹

at $q = q_c$. Based on the W hitney embedding theorem,³⁵ one may demonstrate³¹ that Eq. (12) holds for embedding dimensions d between 2 and 5, i.e., 2 d 5. Note that the value of d_s at $q = q_c$ is given by the mean-eld theory³⁶ for all d 6: $q_s = 4=3$. Below the critical embedding dimension of d = 6, the mean-eld percolation is invalidated;^{16;36} this appears in the deviation of the percolation constant C from 4=3 for 2 d 5.

The fact that C is actually smaller than 4=3 is in accord with the prediction of the renormalization-group – expansion to the marginal orders in $^{16;36}$ The issue of the percolation constant $C^{28;31}$ is intimately connected to the widely-known A lexander-O rbach conjecture,²⁴ which up to recently has been amongst the biggest open challenges in the fundam ental percolation theory. Note, also, that Eq. (12) is restricted to contractible³² fractal sets; the noncontractibility e ects tend to diminish the actual value of the spectral fractal dimension d_s at q = q, when compared to the percolation constant C 1:327^{28;31}

where the m ean-eld estimate C 4=3 has been used for simplicity. From Eqs. (8), (9) and (13) one concludes that the fracton states ($d_s = C$ 4=3) are much denser than the phonon states ($d_s = d$ 2) for the frequencies ! smaller than $!_{m in}$ (=a). Fractons could thereby dominate in the excitation spectrum of the system below the characteristic temperature of

V.TOPOLOGICAL CONSTRAINTS ON THE HAUSDORFF DIMENSION

In this section, topological constraints on the Hausdor dimension d_f are found. The results obtained are further used to de ne the admissible values of the index of connectivity and of the exponent = (2 +)=2 in Eq. (14).

The next step is to consider general embedding conditions for the curves that have no points of self-crossings. Indeed, a plane (d = 2) curve can be embedded without self-crossings into at most $S_2 = \ln 8 = \ln 3$ 1:89 < 2 dim ensions,³⁷ where S_2 ln 8= ln 3 is the Hausdor fractaldimension of the square Sierpinski carpet.^{14,38} (The inequality $S_2 < 2$ excludes existence of the Peano curves without self-crossings.) The shape of the fracton wave function in the core region ! x < is thereby a stretched exponential distribution $_{n} (x) \exp[(x=_{n})], with_{n} = (1 +)=! _{n}$. The spatial scale $_{n}$ (i.e., the size of the core region) is offen referred to as the fracton localization length.²⁵ N ote that the values of lie in the interval (19) and m ay depend on the embedding dimension 2 d 5 in general. Num erically, 0.75 < 1.42 for d = 2, and 0.75 < 2.23 for d = 3. In Euclidean geometries, = 1, yielding $_{n}$ 0 for all n. The stretched exponential behavior of the fracton wave function in the core region was rst proposed by Entin-W ohlm an et al.⁴⁶ M uch theoretical and numericale ort has later been invested to determ ine the value of (for a review, see Nakayam a et al.¹⁶ and references therein. In the notations of article¹⁶, d.) The results addressed in Ref.¹⁶ com ply well with the constraint (19) in both cases d = 2 and d = 3.

Equation (30) represents the power-law tail of the fracton wave function $_{n}$ (t;x), with the exponent + 1 varying from approximately 1.75 to 2.42 in two dimensions (d = 2), and up to 3.23 in three dimensions (d = 3). These relatively small values of the power exponent + 1 < 3.5 allow for the considerable probabilities of

nding a fracton beyond the core region when compared to a stretched exponential interpolation. We emphasize that the power-law tail (30) is the fractional dynam ics property contained in the R iesz operator r.

VII.THE INTERACTION HAM ILTONIAN

Similar to the ordinary phonons in regular crystals, fractons may mediate electron-electron interactions in fractalmedia. The implication is that an electron placed on a fractal network generates a structural deformation which a ects another electron. The process is described by the interaction H am iltonian

where a_k^+ is the creation operator for an electron with wave vector k, $\frac{1}{p}_{k}$ is the creation operator for a fracton with wave vector p = k, and W_{kp} are the elements of the interaction $m \operatorname{atrix}_{r} m \operatorname{axim} \operatorname{ized}$ for p =k. The fracton operators p_k^+ and p_k^- are introduced for the excitations that obey the selection rule (27). The H am iltonian in Eq. (31) recovers the conventional electronphonon interaction Ham iltonian³⁰ in the Euclidean geom etry $\lim it d_f ! d and d_s = d_f ! 1. The existence of the$ electron coupled states for the Ham iltonian (31) can be dem onstrated following the standard form alism .9;30 Such states would physically correspond to the \C ooper pairs" on fractal networks. Like in the conventional, phononm ediated picture of electron-electron interactions, $^{9;30}$ the Cooperpairs in fractal geom etry occur because electrons with nearly opposite momenta (k; k) exchange a fracton excitation.

0 wing to the e ect of the fractional dynamics, the electron-fracton interactions are not restricted to the core region !x <, but are extended, by m eans of the R iesz operator r, to the \strange" dom ain !x corresponding to the power-law tail of the fracton wave function. The tail counterpart given by Eqs. (28) (30) supports broad electron-electron couplings in the medium, enabling the formation of the C coper pairs throughout the self-similarity interval a < . In view of inequality (20), the couplings are more extensive at lower absolute temperatures T. In view of the high density of states in Eq. (13) (large com pared to the phonon DOS), fracton excitations bene ciate as a favourable ingredient of the superconducting transition in strange materials.

VIII.TUNNELING EFFECTS

In fractal networks, the onset of superconductivity m ay be limited to the Anderson localization of the Cooper pairs. In fact, as it follows from inequalities (2) and (20), the fractal geometry of the network creates a potential barrier for a particle, with the height proportional to T. A superconducting behavior on a network structure could be the case if the quantum tunneling length for the charge carriers exceeds the characteristic Anderson localization length on the fractal. The Anderson localization length, in its turn, is typically of the order of the microscopic distance a, describing the characteristic scale of the inhom ogeneities present. The quantum tunneling length for a particle of mass m is given by the well known estimate 1 h = 2m T, where T stands for the height of the barrier. A transition to a superconducting state may thereby occur if 1 > a. Taking into account that $m = 2m_e$ for the Cooperpairs, one nds the appropriate temperatures to be

(W e in ply that the material is well supplied with the free electrons that may e ectively participate in the pairing processes. In the experiments in Ref.⁵ the necessary charge carrier concentration was achieved through the gate-induced doping in the eld-e ect device.) Setting a 10^{6} cm,⁵ we have T [<] (2 3) K. This com plies with the onset tem perature T_{c} 2:35 K reported in Ref.⁵

The tunneling of the Cooper pairs through braided m olecular structures is the marginal dynam ical process that lim its the superconducting behavior in the polym eric system s. The corresponding tem peratures T $\,^{<}$ (2 3) K are rather m odest owing to the relatively large 10^6 cm on the threshold tunneling length 1 а right of inequality (32). Decreasing this length might prom ise enhanced tem peratures, of course.] A nticipating the results of the next Section, we note that the fractonm ediated superconductivity m ay com e into play at the considerably higher temperatures (typically, as high as $T_{\rm C}$ 150 K), provided the tunneling limitation (32) is circum vented.

The tunneling processes on a fractal set could be associated with the formation of a disordered array of Josephson junctions enveloping the domains of e ective electron-fracton interactions. In this context, it is worth noting that superconductivity, due to Josephson coupling of the superconducting domains, was in fact observed in polycrystalline system s.⁴⁷ The role of Josephson arrays for the superconducting behavior in P 3H T was addressed in R ef.⁵ in connection with the patchy (granular) topology of the transition regions.

The fracton pairing mechanism might explain why superconductivity has not been observed in inorganic sem is conductor devices,⁷ such as Siand G aA s: The active materials used in such devices lack the structural complexity which might support a well-de ned branch of fracton excitations in the self-sim ilar domain. Conversely, self-assem bling organic polymers like P 3H T reveal a complex organization owing to SOC, that o ers a fertile play-ground for the fracton modes as soon as the criticality condition (12) is satis ed.

IX . A CASE FOR H IGH -TEM PERATURE SUPERCONDUCTIVITY

An important ram i cation of the present study is a model when electrons are replaced by charged \holes"

participating in the fracton exchange processes on a com - plex substrate. The simplest interaction H am iltonian reads

Here, b_k^+ and b_k denote the creation-annihilation operators for a hole with wave vector k. The expression (33) is analogous to the H am iltonian in Eq. (31) for the fractonmediated electron coupling. The interaction processes (33) could dom inate in the nom inally insulating materials at high hole-doping levels. Beside hole-doped system s, the hole coupling e ects m ight be essential in cuprate superconductors ow ing to the speci c crystalline structure of the copper-oxide com pounds. In fact, the cuprate superconductors consist of parallel planes of copper and oxygen atoms arranged in a square grid. The copperoxygen planes are separated by the layered atom sofother elements, which may absorb electrons from the copper sites, leaving positively charged holes behind.48 The integral system operates like a multi-layer eld-e ect transistorwith the conducting copper-oxygen planes con ned between the charge-absorbing insulating substrates. The com plex m icroscopic texture of the com pound supports fractional harm on ic m odes in Eq. (22) that m ay turn the holes into coupled states.

The key point about the holes is that they have negative mass m = jn j < 0, leading to the imaginary fractal tunneling length 1 $ih = 2jn \frac{T}{2}$. This means periodic charge oscillations exp(ix $2jn \frac{T}{2}$ = h) in the copper-oxygen lattice, i.e., a \stripe".⁴⁸ The stripes form a runw ay⁴⁸ along which the coupled holes may ow without resistance. The stripe order can be associated with self-organization of the system to a therm odynam ically pro table one-dimensional charge distribution.

It is fair to rem ark that the issue of stripes is at present widely debated in the literature. Theoretical arguments in favour of the stripes have been proposed in Ref.⁴⁹ C oncerns come from the poor observational support for the charge stripes as an integral part of the superconducting behavior in the cuprates. Intriguing experimental indications of the charge stripe order in high-temperature superconductors have been obtained only recently.^{50,51} (See, also, Ref.⁵² where an evidence for the stripes in a chemically doped cuprate compound was reported.)

Inclusion of stripes makes it possible to bypass the marginal limitation (32) on the superconducting temperature range. The typical superconducting transition tem perature T_c can then be directly evaluated from expression (14), provided the charge is carried by the fracton coupled holes along the stripe runways. Considering condition (20), we maxim ize the index of connectivin the scaling T_c / (=a) =2 to be іtу = max =C)=C, where $S_{\rm d}$ is the Hausdor dimension of 2 (S_d the Cantor cheese^{14;38} in E^d , and C is the percolation constant.28;31 (High-tem perature regime is im plied, enabling one to set = \max from 0 = 0 T 0.) In view

of the plane (d = 2) geometry of the conducting layers in cuprate superconductors,⁴⁸ we nd for the scaling exponent, $=2 = \max_{m ax} = 2 = (S_2)$ C)=C 0:43, where S₂ 1:89 is the Hausdor dimension of the square Sierpinski carpet.^{14;38} A ssum ing further the maxim al^{20} ra- $1\hat{0}$, we estimate the factor (=a) = $\frac{1}{2}$ in Eq. tio =a (14) to be around 20. A fter all, making use of the characteristic values c 10 cm/s for the long-wave 2 10⁶ cm for the miniphonon phase velocity, and a m al fracton wavelength, we have, by order of m agnitude, 150K . This result is in good agree-T_c 40 hc=a m ent with the typical transition tem peratures observed in cuprate superconductors. Enhanced transition tem peratures m ight be speculated for the com pounds having 2 c=a > 10¹² Hz.

W e emphasize that the high transition temperature Τ_c 150 K pro tspfrom the imaginary hole tunneling length, 1 ih= 2jm jT, giving rise to the selforganized charge-stripe order across the conducting set. In cuprate superconductors, this macroscopic order helps coupled holes run freely along the copper-oxygen planes. Conversely, electrons placed on a com plex conducting lattice encount multiscale potential barriers, whose height grows with absolute temperature T. (The e ect of the barriers could be strengthened in the cuprates because of the electron absorbtion processes.) \Loaded" with the positive mass (opposite to that of holes), electrons can enter into a superconducting state at the low enough tem peratures T < h²=4m $_{e}a^{2}$, in accordance with condition (32). Support for this view point can be found in the elde ect doping experiments with CaCuO₂ compound:⁵³ W hile electron-type doping has shown the maximum value of T_c around 34 K, hole-type doping revealed an enhanced superconducting transition temperature T_c near 89 K. Note that the eld-e ect geometry exploited in the experiments in Ref.⁵³ m in ics the inherent m icroscopic organization of the copper oxides com posed of the alternating conducting-insulating layers.

W e suggest that fracton coupled holes is the most probable ingredient of the high-tem perature superconducting phase in copper oxides. This proposal is som ewhat di erent from the theoretical results of B uttner and B lum en,⁵⁴ who argued that such a phase m ight directly occur from the fracton-m ediated electron-electron interactions. N evertheless, the focus on fractons⁵⁴ as the electrice glue that m ay con ne the current-carrying particles in couples on a com plex geom etry is in accord with the basic ideas of our study. Intrinsic multiscale inhom ogeneities that m ight support the fracton m odes in high-tem perature superconductors have been studied experimentally in R ef.⁵⁵

The direct observation of the fracton-hole interactions in the cuprate superconductors is an open challenge. Such interactions m ight be recognized from meandering of the charge stripes, a phenom enon addressed in R ef.⁴⁹ The meandering property has been strongly advocated in R ef.⁵¹ from the novel in-plane transport anisotropy in copper oxides.

X.AC UNIVERSALITY

The complex percolating lattices underlying the fracton excitation spectrum (13) may leave an imprint on the ac conduction properties of the material above the superconducting transition temperature T_c . As is shown in Ref.¹⁸ self-organization of the medium to a state dom inated by the critical percolation structures results in the universal behavior of ac conduction at the \anom alous" frequencies, for which the charge carriers walk on the fractal. The de ning feature of ac universality is independence of the microscopic details of the pattern on which the random walk takes place, and of the nature of the conducting mechanism operating in the system (i.e., classical barrier crossing for ions and/or quantum mechanical tunneling for electrons). A cuniversality can be represented analytically by the power-law dependence of the conductivity () versus frequency : ²³

For the bulk conduction, the exponent lies typically between 0.6 and 1.0.²³ Am ong other m aterials, the bulk ac universality was recognized in ion and electron conducting polymers, am orphous and polycrystalline sem iconductors, organic-inorganic composites, doped sem iconductors at helium temperatures, etc. (see Refs.²³ and⁵⁶, and references therein).

A c universality (34) results from the self-sim ilar behavior of the random walk processes on the fractal geometry.¹⁸ G iven a path-connected fractal distribution with connectivity , one nds the mean-square displacement of the walker (e.g., of the charged particle placed on the disordered conducting array) after tim et to be¹²

The probability to return to the starting point²⁷ scales with time as p(t) / t^ds⁼², where d_s is the spectral dimension of the fractal, which simultaneously arises in the fracton DOS in Eq. (8). This is in accord with the dependence (34) custom arily observed in real disordered materials. The \hyperuniversalⁿ¹⁸ behavior () / $^{1=3}$ in two dimensions should be considered as a speci c prediction of our model: To our best knowledge, reliable experimental data on ac conduction of the fractal lms are almost absent in the literature. Direct observational veri cation of the scaling () / $^{1=3}$ might be performed, e.g., through a charge injection in the eld-e ect-transistor geometry using the pioneering methods discussed in Refs.^{4;5;53}

In higher dimensions (3 d 5), the \H ausdor " term (d 2)C=2d on the right of expression (37) apparently contributes to the exponent . Considering the constraint (17) on the parameter d_f , we locate the value of in the interval m in max, with

Hence, in three dimensions, generally increases with decreasing temperature T , a phenom enon often observed in real disordered m aterials. 23

W e em phasize that ac universality (34), although effective above the typical superconducting transition tem – perature T_c , is an integral part of the fracton scenario as it derives from the same general principles basing on the percolative geom etry of the underlying conducting lattice. A c universality might serve as an indication that the material possesses the com plex enough microscopic organization that supports a wide fracton spectrum. A c-universal materials could thereby be plausible candidates into the strange superconductors dom inated by the fracton-mediated interactions between the current-carrying particles. A test on ac universality might help verify the fracton nature of the pairing mechanism potentially operating in organic polymers and copper oxides.

XI.SUMMARY AND CONCLUSIONS

In spite of the diverse superconducting transition tem peratures, self-assem bling organic polymers and copperoxide compounds bear in portant features in common. In fact, the polymers superconduct in the eld-e ecttransistor geometry at high gate-induced charge-carrier concentrations. The superconducting state is supported by self-organization mechanisms governing the kinetics of the polymer system. Owing to self-organization, the polymers form thin regular lms, on which the superconducting electron uid condensates.

The cuprate superconductors, in their turn, operate like multi-layer transistors due to the intrinsic edde ect crystalline con guration (i.e., conducting copperoxygen planes con ned between charge-absorbing insulating substrates). Self-organization processes appear in the charge-stripe order enabling the current-carrying particles ow along the copper-oxygen planes without resistance.

B oth polymers and copper oxides are \strange" superconductors as they involve unconventional (other than BCS) pairing processes underlying the superconducting phase. In either of the materials, the (quasi)particles mediating the interaction between the charge carriers are suggested to be fractons, quantum oscillations of fractal lattices.

The interaction processes involving fractons allow for larger energies than that of the phonons, leading to a possibility of the high-tem perature superconducting phases

in complex materials. For the cuprate compounds, we estim ate the typical superconducting transition tem perature to be around T_c 150 K, in good agreem ent with the experimental values. We imply that the marginal ingredient of the corresponding high-tem perature superconducting phase are fracton coupled holes that condensate in the conducting copper-oxygen planes ow ing to the speci c eld-e ect-transistor geom etry of the cuprate superconductors. For the gate-induced superconductivity in the self-assembling polymers, we nd much smaller transition temperatures of (2 3) K, provided the charge carriers are fracton coupled electrons, not holes. Such a modest value is due to the lim itations in posed by the electron tunneling processes on the braided polym er structures. We speculate that replacing electrons with holes helps circum vent the tunneling restrictions. The fracton model then promises enhanced onset tem peratures for the hole-doped system s when com pared to their electron-doped counterparts. The hint is that hole-doped com plex m aterials whose structural characteristics m eet a wide fracton spectrum, might be feasible candidates in the high-tem perature superconductors. Support for this suggestion partially com es from the eld-e ect doping experim ents discussed in R ef.⁵³ H ole doping m ight thereby open a perspective on the superconducting system s having large transition temperatures $T_c > 150$ K.

W e found that the fracton wave function contains a power-law tail stretching far beyond the central core region. The power-law constituent supports interactions between the charge carriers throughout the self-sim ilar (fractal) dom ain of the conducting system . In the harmonic approximation, the fracton wave function derives from a generalized kinetic equation with the integer time and fractional real-space derivatives. The latter is given by the Riesz operator addressing the fractional generalization of the Laplacian. The introduction of the fractional kinetic equation for fracton excitations follows the paradigm of the strange dynam ics40, one of the biggest open challenges in the modern nonlinear physics. The param eters of the fracton wave function describing the shape of the core and tail regions could be obtained from the unconventional, topological analysis basing on the concept of the fractional manifold.³¹ The fractional kinetics approach supplied with the topological quide to fractal objects yields insight into the fundam ental dynam ical properties underlying fracton statistics.

The form ation of self-sin ilar (fractal) lattices associated with a well-de ned branch of fracton excitations affects ac conduction properties of the material in the classical energy range (i.e., above the typical superconducting transition temperature T_c). Based on the topological arguments, we demonstrated the universal character of ac conduction in fractal geometries, which does not depend on the details of the lattice, nor on the nature of the microscopic conducting mechanism. This universal character is contained in the scaling () / , with the exponent related to the fundamental topological parameters characterizing the fractal distribution, such

as the percolation constant³¹ and the Hausdor dimension of the Cantor cheese.³⁸ In three dimensions (i.e., for the bulk conduction), the value of varies from approximately 0.56 to 1.0, in precise agreement with the experim ental range 0:6 $^{<}$ $1:0^{23}$. In two dimensions (i.e., for the plane fractal lattices), a \hyperuniversal"¹⁸ 1=3 is recognized, leading to the scalvalue 0:34 $^{1=3}$ in a wide tem perature range T $^{>}$ T_c. ing ()/ This behavior should be considered as a speci c theoretical prediction of our model. Observational veri cation of the scaling () / $1^{=3}$ in plane fractal geometries m ight shed light on the electric properties of the com plex m aterials.

It m ight be extrem ely interesting to verify the scaling () / $^{1=3}$ for cuprate oxides and self-assem bling organic polymers, whose m icroscopic organization seems to support plane fractal lattices. An observation of the scaling () / $^{1=3}$ m ight be a strong argument in favour of the fracton-m ediated pairing processes operating in the strange superconductors. Extensive studies in this direction m ight be strongly advocated.
