Estimating probabilities from experimental frequencies

E stim ating the probability distribution q governing the behaviour of a certain variable by sam pling its value a nite number of times most typically involves an error. Successive measurements allow the construction of a histogram, or frequency count f, of each of the possible outcomes. In this work, the probability that the true distribution be q, given that the frequency count f w as sam pled, is studied. Such a probability may be written as a G ibbs distribution. A therm odynam ic potential, which allows an easy evaluation of the mean K ullback-Leibler divergence between the true and measured distribution, is de ned. For a large number of sam ples, the expectation value of any function of q is expanded in powers of the inverse num ber of sam ples. As an exam ple, the moments, the entropy and the mutual inform ation are analyzed.

I. EST IM AT ING PROBABILITIES FROM EXPERIMENTAL FREQUENCIES

The estimation of probability distributions from a lim ited num ber of sam ples typically involves an error. C onsider, for example, a random variable that can be either 0 or 1, both values with probability 1/2. An experimenter m easures the variable, say, four times. If n_0 (similarly, n_1) is the number of trials the result was 0 (correspondingly, 1), the possible outcom are $n_0 = j; n_1 = 4$ j, where j m ay vary between 0 and 4. Each of those possibilities has probability 3=2j!(4 j)! of occurring. If the experim enter estim ates the underlying probability from the frequencies, his or her claim will be that the probability of getting a zero is $n_0=4$. However, in view that n_0 depends on the particular outcom e of the four trials, only a fraction 3/16 of the tim es will this procedure give the correct result, that is $f_0 = q_0 = 1=2$.

In the above example, there are three probability distributions involved. First, there is the true underlying probability q, actually governing the outcome of the experiment. In vector notation, $q = (q_0;q_1)$, and in the particular instance above, q = (1=2;1=2). Then, there is the frequency count $f = (f_0;f_1)$, where f_i is obtained by dividing n_i by the total number of measurements N (four, in the example). And nally, there is the probability that f = q. To de ne this last probability, one has to consider all possible samples of N trials, and evaluate how often the condition f = q is full led.

M ore generally, one can de ne the probability of measuring a particular f, while the underlying q remains xed. This means to consider a probability distribution of all the possible frequency counts. The independent variable is the vector f, which varies in a discrete set, and the dependent variable is p(f;q).

The frequency count f is an estimation of the underlying q. In many applications, how ever, one is interested not quite in q, but rather in som e function of q. Treves and Panzeri [1], for example, have quanti ed the m ean error that an experimenter makes when evaluating the mutual information in the frequency count f, as an approximation to that in the true (and unknown) q. Their analysis was made in the same spirit as above, that is, they have considered q xed, while the value of f depended on the particular outcome of N m easurements. They have obtained a clean analytical result, under an independence approximation. Their approach may be naturally generalized to situations where q is a probability density, that is, varies in a continuous set [2].

How ever, what the experimenter knows is not the true q, but one particular f, obtained after N observations. H is or her aim is to estimate the most probable value of q (or of some function of q) from the knowledge of f. More generally, the experimenter may be interested in the whole distribution P (q f), that is, the probability that the true distribution be q, given that he or she has measured f. This means to settle the problem the other way round as was studied by Treves and Panzeri, and in the example above. It actually corresponds to W olpert and W olf's approach [3] in the estimation of entropies.

In the following section, the properties of the distribution P (qjf) are studied. In Sect. III, P (qjf) is written as a Gibbs' distribution, where the inverse number of sam ples plays the role of an e ective tem perature, and the Kullback-Leibler divergence between f and q is the equivalent of the energy of state q. As a consequence, a therm odynam ic potential is de ned, thus allow ing the calculation of the mean Kullback-Leibler divergence between f and q by simple derivation. This inspires the expansion m ade in Sect. IV, where the expectation value of an arbitrary function of q can be written as a power series in the inverse number of samples. The case of the entropy, the mutual inform ation, or any mom ent of the distribution q is shown in the exam ples of Sect. V. Next, in Sect. VI the analytical results are confronted with num erical simulations. Finally, in Sect. VII, the main results are sum m arized and discussed.

II. THE PROBABILITY DISTRIBUTION FOR THE TRUE PROBABILITY DISTRIBUTION

Consider the random variable X taking values from the set $x = (x_1; ...; x_S)$, with probabilities $q = (q_1; ...; q_S)$. In principle, there is no need that $x_1; ...; x_S$ be num erical values, it su ces them to be any exclusive and exhaustive set of categories.

An experimenter makes N observations of the value of X and builds a histogram $n=(n_1; {\rm :::;} n_S)$, where n_i is the number of times the outcome was x_i . The experimenter considers the frequencies $f=(f_1; {\rm :::;} f_S)=(n_1=\!N; {\rm :::;} n_S=\!N)$ as an estimation of the true underlying probability distribution q. If the measurements are taken independently, the probability of measuring f given that the data are sorted according to q is equal to the probability of observing each x_i a number n_i of times, that is,

However, the know ledge the experimenter has at hand is f, not q. He or she may therefore wonder what is the probability that the true distribution be q, given that the outcome of the experiment was f. This means to evaluate a probability density P (q f), whose independent variable q runs over all the possible distributions of the data. That is, all vectors in $<^{S}$ such that

The set of all q obeying Eqs. (2) constitutes the dom ain D where P (qjf) is de ned. It is a nite portion of an (S 1)-dimensional plane embedded in $<^{S}$, and is norm al to the vector (1;1;:::;1).

Notice that since each f_i is the ratio of two natural numbers, the set of possible frequencies f is discrete. The domain D, on the contrary, contains a continuum of distributions q. Consequently, p(fg) is a probability, whereas P (qf) is a density.

Bayes' rule states that

where P(q) is the prior probability distribution for q, and

The prior P (q) contains all additional pieces of know ledge about q, apart from the experimental data. Here, the assumption is made that there is no a priori know ledge. However, it turns out to be crucial to specify what is it that is not known [5]. A prior that is uniform over D, as was used by W olpert and W olf β], is certainly not uniform over any non linear function of q, for example the log-likelihood. Thus, not know ing anything about q im plies know ing som ething about ln q, which in turn m ay result in aw kward scaling properties. In this work, the power prior

is repeatedly used, with $Z = p \sum_{p \in S} [()]^{S} = (S)$ (notice that when ! 0;Z ! S). However, as was shown in [5] choosing any of these priors results in a surprisingly peaked a priori distribution of the possible entropies. Hence, the choice of the prior is a delicate issue and, in any particular application, it should be done carefully. Here, no attempt will be made to instruct on the way such a choice should be made, but since the results that follow are strongly grounded on Bayesian inference, their validity is, at most, as good as the prior" [3].

Replacing Eqs. (1) and (4) in Eq. (3),

In the remaining of the section, the properties of P(qf) are studied for the particular P(q) de ned in Eq. (5). In doing so, the integral

is frequently encountered. Equation (9) was rst derived in [3], and an alternative proof may be found in the Appendix.

For the priors in Eq. (5), the function Z Eq. (8) may be calculated analytically, and it reads

The most probable $q^M = (q_1^M; :::; q_s^M)$ is obtained by maxim izing Eq. (12), under the norm alization constrain. The result is

Thus, if P (q) is uniform in D (= 1), then the most probable q is f. W ith the maximum likelihood prior (! 0), the most probable q is shifted from f to-wards lower counts. The K richevsky-Tro m ov estimator [8](= 1=2) and the Shurm ann-G rassberger [9] = 1=S lie in between.

U sing Eq. (9) the expectation value of each component q_i m ay be calculated,

For the uniform prior = 1, this equation reduces to Laplace's estimator of probabilities, rst introduced by in his Essay on probabilities. In gure 1 the di erence




FIG.1: Dierence between hq_ii and f_i , as a function of f_i . The value of has been set to 1. The three lines correspond to N = 3, 6 and 30. Here, X may take 3 values (S = 3). W hen $f_i <$ 1=3, the expectation value of q_i is larger than the measured frequency f_i . As N increases, the elect becomes less important.

between $hg_i i$ and the frequency count f_i is shown, for = 1. It is seen that when f_i is smaller than 1=S, $hg_i i$ is larger than f_i . On the other hand, if $f_i > 1=S$, then $hg_i i < f_i$. That is, the mean value of g_i is displaced from the frequency count so as to approach the at distribution 1=S. O f course, the larger the number of sam ples N, the smaller the e ect. Changing the value of is equivalent to re-scaling the vertical axis of gure 1.

Typically, one wants to make a guess about the true q. Here, two possible estimators have been calculated: the maximum q^M and them ean hqi. By using them aximum, one is choosing the value that is most probably correct. But of course, eventually one will also make an error. If one measures the error as a $(q^M = q)^2$, and averages it with P (qjf), its mean turns out to be larger than if one had chosen hqi [3]. Hence, although q^M is the estimator that gives the correct answerm ost frequently, if one cares for the typical size of the errors, hqi is a better choice.

W hen using hqi as an estim ator, the covariance m atrix $_{ij}$ m ay be of interest. By m eans of Eq. (9) it is easy to show that for $i \notin j$

The negative sign in Eq. (15) derives from the norm alization condition: since the sum of all q_i is xed to unity, if one of them surpasses its mean, it is to be expected that some other component will be below. In contrast, Eq. (16) shows that ii is always positive.

The expectation value of q Eq. (14) together with the covariance matrix Eqs. (15) and (16) are useful to give the Gaussian approximation to P (qjf), centered in its mean:

where the super-script t m eans transposed, and K is a norm alization constant. Equation (17) is only de ned in the plane containing D, norm alto the vector (1;1;:::;1). A ctually, does not have an inverse in the entire space $<^{S}$, since the direction (1;1;:::;1) is one of its eigenvectors, with eigenvalue equal to zero. How ever, being a symmetric matrix, it can be diagonalized by an orthogonal basis. Hence, the S 1 remaining eigenvectors lie in the plane containing D. The restriction of into that subspace is $\tilde{}$, and its inverse is the matrix appearing in the exponent of Eq. (17).

In order to normalize the approximation (17) an integral of a Gaussian function in D is needed. This is certainly not an easy task. If, however, one can assume that the distribution is su ciently peaked so that P (qif) 0,

for q in the border of D, then the domain D can be extended to the whole plane norm alto (1;1;:::;1). In that case, K $^{1} = \frac{P}{2} \frac{1}{j}$, where j are the S 1 eigenvalues of \sim . W hile the calculation of all the j is a di cult problem, it is quite straightforward to show that when N S, all the j are proportional to 1=N. Therefore, the square root of each eigenvalue is a usefulm easure of the width of P (q jf) in the direction of its eigenvector.

However, the Gaussian approximation (17) is not useful for other purposes, as for instance, calculating mean values, since it lacks from analytical expressions as (9). As a consequence, in what follows, the full Eq. (12) is used.

Equation (9) allows the evaluation of all m om ents of P (q_i if)

Since the moments are the coe cients of the Taylor expansion of the Fourier transform of a distribution, the single-component distribution reads

where B (x;y) = (x) (y)= (x + y). Figure 2 displays the distribution P ($q_i j f_i$) for three di erent values of N, and = 1. In all cases, when N is large, the distribution is symmetrical, and reaches its maximum value in $q_i = f_i = 1=3$. In fact, it may be shown analytically that when N 1,

where = $[f_i(1 \quad f_i)=N]^{1=2}$. That is, the distribution tends to a Gaussian function centered at the experimental frequency, and with a m ean dispersion that diminishes with the square root of the number of samples. Notice that in this limit, P (qjf) does not depend on .

It may be seen in Fig. 2 that for smaller values of N, the distribution is no longer symmetrical. In fact, since S = 2 and f₁ = 1=3 < 1=S, the tail in P (q₁ \not f₁) extends to the right, resulting in a positive hq₁i f₁, as predicted by equation (18).

III. THE INVERSENUMBER OF SAMPLES AS AN EFFECTIVE TEMPERATURE

Equation (6) states that P(qf) is completely analogous to a G ibbs distribution, where the number of sam – ples N plays the role of the inverse of the temperature, D (f;q) is the equivalent to the energy of the state q, and P (q) is the density of states. This analogy was rst pointed out in the context of machine learning [6], and

since then, several times in learning theory (see for example [7]). In these cases, when uctuation where neglected, the probability distribution under study had the form of Eq. (6). In the present context, no approximations are needed to write down Eq. (6).

The exponential factor in (6) depends on q and f only in the combination D (f;q), dim inishing exponentially as the divergence between the two distributions grows. Its maximum is attained when D = 0. It can be shown [4] that for any f and q, D (f;q) 0, and the equality holds only when f = q.

De ning the therm odynam ic potential

Here, both N and N f_i have been supposed large, for alli. Since f_i is of the order of 1=S, the above lim it holds when N S. Equation (25) states that for a large num ber of sam ples, the expected value of the divergence between the experim ental frequencies and the true distribution does not depend on the measured f. It grows linearly with the num ber of item s, and decreases as 1=N.

A ccordingly,

In the lim it N $\,$ S , the m ean quadratic dispersion does not depend on the m easured $f_{\rm i}$.

IV. ESTIMATION OF FUNCTIONALS OF q, FOR A LARGE NUMBER OF SAMPLES.

M any times, one is interested in the value of some function W (q). For instance, if X_p takes numerical values, W may be the mean X = ${}_{i}x_iq_i$. Or, in some

other application, W m ay be the entropy of the distribution q (see equation (11)). If the set X is the Cartesian product of two other sets X = $Z^1 = Z^2$, such that $8x_i \ge X : x_i = (z_a^1; z_b^2)$, where $z_a^1 \ge Z^1$ and $z_b^2 \ge Z^2$, then W m ay be the mutual inform ation I between Z^1 and Z^2 :

Since q is unknown, an interesting guess for $\mathbb W$ (q) is its Bayesian estimation

which has the appealing property of m in in izing the m ean square error [3]. The zero order guess for W is W (f). In what follows, a system atic method to improve this value is derived.

In the previous section the expectation value of the divergence between the true and the m easured distribution was calculated, as well as the size of the uctuations, for the priors in Eq. (5). A sthe num ber of sam ples increases, both the expected divergence and the uctuations dim inish as 1=N. Since a sm all divergence m eans that the two distributions are necessarily very sim ilar, only the q that are very near f have a non vanishing probability | for D su ciently sm all, this argument holds for any de nition of sim ilarity.

As a consequence, it is reasonable to expand W (q) in its Taylor series in the neighborhood of f. Hence, Eq. (30) reads

Since P (qjf) decreases dram atically as q departs from f, the higher order term s (large k) in Eq. (31) should become negligible, at least, for large N.

In the st place, the mean values of Eq. (31) are evaluated for the special case of the power law priors. This involves, basically, the computation of integrals in D of $_{i=1}^{S}$ (q_i f_i)^{k₁}, for a set of non negative indexes ($k_i; k_2; :::k_s$) that sum up to K. This can be done using Eq. (9). Of course, the term k = 0 that is, the raw guess{does not depend on N. It may be shown that only k = 1 and k = 2 are proportional to 1=N. Speci cally,

Summarizing, to rst order in 1=N,

This general form ula allows the calculation of the rst correction of the expectation value of an arbitrary function W (q), whenever the prior is given by Eq. (5).

Now, consider the more general case of an arbitrary prior. If P (q) is not given by Eq. (5), then one can still proceed as above, but replacing W (q) by the product W (q)P (q), and setting = 1.

V. EXAMPLES

Here, the expansion (36) is applied to a few particular cases. W olpert and W olf [3] have already calculated the rst two examples exactly (Subsect. V A and V B), in the particular case of = 1. Their results, once expanded up to rst order in 1=N are now compared to Eq. (36), for veri cation. The advantage of Eq. (36) is that, in contrast to W olpert and W olf's approach, it applies to any function W. The counterpart, of course, is that it gives no m ore than the rst correction to hW i. Subsection V C deals with the calculation of m orments.

A. The mean value of the entropy

In the rst place, the function W (q) is taken to be the entropy H of the distribution q, de ned in Eq. (11), for q = f. It is easy to verify that $@H = @q_i = [1 + ln q]$, whereas $@^2H = @q_i@q_j = _{ij}=q_i$, where $_{ij}$ is K roeneker

The quantities $f_{a:}$ and f_{\pm} in Eqs. (40) and (41) are de ned as in (29).

In contrast to the result obtained in [1], the rst order correction to the mutual inform ation does bear a dependence on the values of the individual probabilities f_{ab} . There is no con ict, however, between the two results,

since the mean value in Eq. (40) involves the distribution P (qjf). The approach in [1], instead, uses p(fjq), while the true q is xed. In the present approach, the mean value hI i can be either higher or lower than I (f).

C . The mean value of functions of X $\,$

Consider a function $g : fx_1; ...; x_S g ! R$ that maps the possible values of X into real numbers. For example, if X takes numerical values, then g_k can be such that $g_k(x_i) = x_i^k$. For each such g_p another function G :D ! R is de ned, namely G (q) = $_i g(x_i)q_i$. In the example above, G_k is the k-m on ent of the distribution q. The expectation value hG i is easily calculated using Eq. (36), and reads

In particular, for the g_k considered above, this is the rst order correction to all moments of q.

VI. NUMERICAL SIMULATIONS

In this section, Eq. (36) is confronted to the result of numerical simulations. Once again, and just to follow previous studies, W (q) is set equal to the mutual information. However, in contrast to what was done up to now [1, 2, 3], the simulations are performed strictly within the present framework. That is, the measured frequency f is kept xed, and the probability for the true q is evaluated.

The procedure to measure num erically P (qjf) is now explained. As before, X takes values in a set of S elements. Hence, f and q are S-dimensional vectors. The value of f is xed. The domain D is discretized into a number J of cells. Each cell corresponds to a vector q that will be visited by the program . The larger the num ber of cells J, the better the sam pling of the domain D. For each one of these cells, the value of X is measured N times. The outcomes are sorted with the distribution q of the actual cell. If the frequency count thus obtained equals f, the counter of the selected cell is increased (there is counter for each cell in D). The com parison between the frequency count and the (xed) f is done with precision . The procedure is repeated M times (M large) in order to have enough counts. This algorithm allows to construct a histogram for the probability that a given q 2 D generates the selected f.

For simplicity, in the results below the number of trials M is the same for all cells. This is equivalent to using a uniform prior in D (= 1). A simulation with a non uniform prior can be carried out by choosing a di erent M for each cell.

The two parameters that determ in the precision of the simulations are J and . If D_J is the Kullback-Leibler

divergence between two neighboring q cells, whenever 1=N D_J then the only vector q that produces frequency counts equal to f is q = f. That is, for N su - ciently large, the discretized system behaves as if N = 1. Notice that for large J, two neighboring cells correspond to q and q + q, with each q / J^{S 1}. Thus, the K ulback-Leibzig distance between the two is $S=J^{S-1}$. Thism eans that when N reaches $J^{S-1}=S$, the simulation starts to behave as if N were actually in nite.

On the other hand, if is not smallenough, one mistakenly counts coincidences with f, just because the criterion used in the comparison is too brute. In other words, a large allows that cells q too far away from f do give rise to frequency counts equal to f. That is, the system behaves as if N where smaller than its actual value.

The dots in gure 2 show the result of the above pro-




FIG. 2: Probability distribution P $(q_1 jf_1)$ for the case $f_1 = 1=3$, = 1 and S = 2.D i erent curves correspond to several values of the number of sam ples N. The full line depicts the analytical result Eq. (19), while the dots are the numerical simulations (see Sect. V I).

cedure, for a single component q_1 . As observed, there is very good agreement with the full line, showing the analytical result, Eq. (12).

To evaluate the expectation value of a certain function, one simply needs to calculate the sum




FIG. 3: Dierence between the expectation value of the mutual information hIi and the measured I(f), as a function of the inverse number of samples 1=N. The = 1 prior was considered. The full line represents the analytical result, Eq. (40), and the dots the simulations. In (a), $f_{11} = f_{12} = f_{21} = f_{22} = 1=4$, and I(f) = 0. For each cell in D, 30,000 sets of N samples have been sorted. In (b), $f_{11} = 0.4$, $f_{12} = 0.1$, $f_{21} = 0.1$, and $f_{22} = 0.4$, so I(f) = 0.192745. For each cell in D, 10,000 sets of N samples have been sorted. In both cases, each axis in q space has been divided in 20 intervals, in order to discretize D, while the parameter was set to 0.0125.

using the P (qjf) obtained with the algorithm explained above. Figure 3 depicts the result for the mutual information, with = 1. The dots represent the simulations, Eq. (43), whereas the full line shows the analytical result (40). The computational time required to evaluate P (qjf) increases exponentially with the num ber of dimensions S. Hence, in the present comparison it is desirable to keep S as small as possible. However, in order to dene amutual information two sets Z¹ and Z² are needed, with S₁ and S₂ elements each. In gure 3, S₁ = 2 and

 $S_2 = 2$, thus making a 3 dimensional domain D.

In (a) the selected f had no m utual inform ation: I (f) = 0. The graph shows that the expectation value of I is positive. W ith the chosen parameters (see the caption of the gure), the analytical result (40) coincides exactly with the one derived by Treves and Panzeri [1], that is, hIi = (S₁ 1) (S₂ 1)=2N . Since for I (f) = 0, Eq. (40) reduces to hIi = $S_1S_2 + 1$ S_1 $S_2=2N$, for some particular choices of S_1 and S_3 the two expressions m ay coincide. It should be kept in m ind, how ever, that this is

In contrast, in case (b) the value of I (f) is large (see the caption for details). In this case, the simulations con m the phenom enon that was pointed out in the previous section, namely, that the expectation value hI i may be lower than the measured I (f).

It may be seen that for large N, all the dots concentrate in hIi = I(f). This is, as pointed out before, due to the discretization of D. If the number of cells J is increased, one needs to go to a larger N to nd such a saturation. On the contrary, for smaller N, the simulated hIi lies below its theoretical value. This is a manifestation of the nite nature of , and the phenom enon becomes less evident as is low ered.

VII. DISCUSSION

In this work, the probability density P (qjf) for the true distribution q given the experim ental frequencies f is analyzed. Such a density, it is shown, may be written as a Gibbs distribution, where the inverse number of samples plays the role of an e ective temperature, and the Kullback-Leibzig divergence between f and q is the equivalent of the energy of state q. Its study is not only for academ ic purposes, but eventually also practical. In the ideal situation, it would be valuable to calculate P (q f) while an experiment is being carried out, in order to know when the number of samples is already enough. The experim enter m ay thus decide to give an end to the sam pling process when the width of P (qjf) reaches som e acceptable value. For example, som eone interested in measuring the public opinion prior to an election may wonder how many subjects need to be polled in order to have a reliable estimation of the forthcoming result. M any times, however, experiments comes to an end because of other factors (a deadline, or a oor in the the am ount of m oney, patience or students). An estimation of the width of P (qf) is valuable even in these cases, just to provide error bars.

O ne possibility is to write down the full P (qjf). However, being a function of m any variables, this m ay not be very practical. A convenient parameter measuring the width of P (qjf) in several directions is the square root of the corresponding eigenvalues of \sim . These have been shown to diminish asymptotically as 1=N. From the information-theoretical point of view, a more appealing parameter is the mean divergence D, and its mean quadratic uctuations. As is shown in Eq. (24), for small N such a width depends on the value of f. If N S, how ever, both hD i and D become independent of f and decrease as 1=N (Eq. (25)). Yet another route is to work with the function W (q) one is interested in. By m eans of Eq. (36), it is possible to decide whether the term proportional to 1=N is only a small correction to W (f) or, on the contrary, the two terms are comparable. In the latter case, m ore m easurem ents should be carried out.

A lthough some of the expressions presented here are valid for an arbitrary prior, much of the work deals with the particular case of Eq. (5). The use of a prior that is essentially a linear combination of functions of the form (5) has been proposed [5], speci cally, to be used in the inference of entropies. For this case, the partition function should be constructed by applying the same linear superposition to Eq. (10), and the same holds for Eqs. (13-19). The calculation of D i and $_{\rm D}$ as derivatives of F is still valid, whereas Eq. (12) should also be averaged.

The analysis of P (q jf) carried out in Sect. II, and the statistical mechanical description of Sect. III are valid even for small N . The fact that hD i ! 1=N for large N inspires the expansion of hW i of Sect. IV. It should be clear, nevertheless, that such an expansion is only convergent when N S. Actually, Eq. (12) is the rst order term in powers of S=N , and there is no reason to think that the higher order term s will be negligible, if such a condition does not hold. M oreover, it is necessary 1 for all i. W hen N is large enough, one to have N fi can always de ne the number of categories S as to have them all well populated. But for N S this may well not be the case. The consequences may, in fact, be quite dram atic. For instance, in the example of the entropy (Subsect. V A) one can explicitly see that fi appears in the denom inator of Eq. (37). In other words, the result is m eaningless if there are empty categories.

However, when the condition N S does hold, Eq. (12) may serve to draw non trivial conclusions. For instance, it is usually supposed that limited sam pling, on average, aws the data introducing false correlations. This work shows this is not necessarily the case: limited sam pling may sometimes, on average, lower the correlations. This is clear in the simulations of Sect. V I, where nite sam pling results, in mean, in a downwards bias of the mutual inform ation.
