Param etric Spectral Correlations in D isordered and Chaotic Structures

We explore the in uence of external perturbations on the energy levels of a Ham iltonian drawn at random from the Gaussian unitary distribution of Herm itian matrices. By deriving the joint distribution function of eigenvalues, we obtain the (n,m)-point parametric correlation function of the initial and nal density of states for perturbations of arbitrary rank and strength. A further generalization of these results allows for the incorporation of short-range spatial correlations in di usive as well as ballistic chaotic structures.

Beginning with early pioneering work on resonances in complex atom ic nuclei [1], the statistical properties of general chaotic and disordered quantum structures have come under intense scrutiny [2]. In such systems, it is conjectured (and, in the case of disordered systems, proven explicitly [3]) that the low-energy correlations of eigenvalues (and eigenfunctions) of an individual system can be inferred from the ensemble average properties of a random matrix distribution whose members exhibit the same fundamental symmetries [4]. For an N N matrix H am iltonian H drawn from, say, a G aussian distribution, the statistical properties of the eigenvalues f ig are completely specied by the joint distribution function

O fren one encounters applications where the interest is in the parametric dependence of the energy levels of a random H am iltonian H 0 = H + V subject to an extended non-uniform (but slow ly varying) perturbation V such as that imposed by a magnetic eld or by an external gate voltage on a quantum dot (QD). Surprisingly, such correlations exhibit the same degree of universality: when expressed through the dimensionless parameter x^2 = X $^2h(\theta_i=\theta X)^2i$, where X parameterizes the strength of the external perturbation V (provided the distribution of H 0 is stationary with respect to X), the

statistical properties of the entire random functions $_{i}(x)$ become universal, dependent only on the fundamental symmetries of the system [6, 7].

However, there exists a number of important applications where the perturbation is either local, or rapidly uctuating, or both. One example is presented by the orthogonality catastrophe in a disordered conductor [8] (of volume V) where, in the coordinate basis, V (r) = $vV^{d}(r - r_0)$. Within random matrix theory (RMT), this is modeled by a rank r = 1 perturbation $V_{ij} = vN_{ij}$ in. The shape-distorting e ect of a gate acting on a ballistic QD can be either global or local, depending on the relation between the spatial extent of the gate and the wavelength of the electron $_{\rm F}$. Sim ilarly, attempts have been made to explore the pumping of electrons through a ballistic quantum dot under the action of two local gates [9] which e ectively represent a rank r = 2 perturbation. The potential V (r) = $vV[d(r r_1) d(r r_2)]$ im posed by a bistable impurity in a disordered metallic host presents another application of a rank r = 2 perturbation. A bistable dislocation segment provides an example of a perturbation of a still higher rank. The freedom to explore perturbations of high rank is easily a orded in experiments on microwave resonators with m ovable scatterers [10], or in STM devices where the tip does not resolve the Ferm iwavelength.

The aim of this letter is to show that, when applied to a member of the unitary random matrix ensemble, perturbations of arbitrary rank r can be incorporated into a general scheme which allows analytical expressions for the pint distribution function and the DoS correlation function to be determined explicitly. The diagonal blocks of (3) reproduce the standard correlations (2) (see also Ref. [11]), while, in the particular case of rank r=1, for n=m=1 Eq. (3) recovers the result obtained in Ref. [8]. The corresponding joint distribution function of the combined set of eigenvalues f_{ig} of the matrix H and f_{ig} of H 0 is given by

where P (f_{ig}) represents the distribution function (1) of the eigenvalues of the matrix H for = 2.

To apply these results to physical systems, it is necessary to e ect a generalization to account for cases where the Hamiltonian dynamics H is generated by a sum of regular and random components. This leads to non-vanishing o -diagonal terms in the ensemble average propagator hG(F)i = h(F)H)¹ i. In disordered m etals, the corresponding non-universal term s are known as Friedel oscillations and re ect the short-ranged ballistic nature of wave propagation via the Friedel function $f(r) = (V =) Im hG(_F$ i0;0;r)i. In the presence of an assembly of rank one perturbations V (r) = $_{k}$ v_{k} V^{d} (r rk), param etric spectral correlations are heavily in uenced by the spatial arrangement of the wavefunction around the impurities. Surprisingly, the correlation function in this case retains the overall structure of (3), and the e ect of the Friedel oscillations is incorporated into the expression for R_{nm} by means of the generalization

where the elements of the r r matrix P are prescribed by the Friedel function f_{k1} f $(r_k r_l)$, and r_l is the diagonal matrix with entries $r_k r_l$. If the points r_k and r_l are separated by a distance in excess of the mean-free path, f $(r_k r_l)$ r_l r_l r_l and Eq. (4) is recovered.

W ithin RMT, Eq. (3) applies to perturbations of arbitrary rank and strength. In systems where the Ham iltonian dynamics includes a regular component (such as diusive or ballistic conductors) Eqs. (3) and (6) represent the leading (zeroth) order term in an expansion in the inverse powers of the dimensionless conductance g. W hether the subleading terms in this expansion are

sm all depends sensitively on the range and pro le of the perturbation. If $tr(fV)^2 > tr(VV)$, where is the di usion (Perron-Frobenius) propagator in di usive (ballistic) systems, the results above apply without qualication [12, 13]. In the opposite lim it, when rescaled by a single param eterwhich incorporates di usive correlations at length scales in excess of the mean free path, param etric correlations acquire a universal form [6], independent of the detailed properties of the system. The structure of these correlations can be inferred from the RMT above: for an extended perturbation of rank r the requirement that Dostays nite as N ! 1 implies that $tr V^2$ $O(N^2)$. It follows that, for all n $tr(V=N)^n ! 0$, and \hat{D}_{to} ; $! exp[(trt^2=2)d^2=d^2]$ reproducing identically the results of Ref. [6].

In the standard W igner-D yson RM T, the determ inantal structure (2) of the many-point correlation functions makes it possible to obtain analytical results for properties associated with individual energy levels, such as level spacing statistics and its various generalizations [5]. Similarly, we anticipate that on the basis of the (n;m)-point parametric correlation function obtained in this Letter, an analogous theory of parametric level spacings' in the GUE can be developed.

To illustrate this point, we consider the evolution of a single level under the in uence of a rank r = 1perturbation. Speci cally, we study the distribution $P(d) = h_{i}(u) + d_{i}(v) = h_{i}(v)$ (v) $_{i}$ between a given level $_{i}$ and its \descendant" $_{i}^{0}(v)$. This quantity is of independent interest in the context of Coulom b blockade (CB) peak spacings in disordered QDs. It is known that RMT-based statisticaltheory of peak spacings shows poor agreem ent with experiment [14]. The disagreement is most likely attributable to the e ects of strong Coulomb interaction which manifest them selves as \spectral scram bling" [15] { read justment of single-particle eigenstates to accommodate the non-uniform spatial distribution of the charge of an added electron, and the param etric \gate e ect" [16] { distortion of the shape of the QD as the gate voltage is changed to sweep through a sequence of CB peaks. It would be interesting to study the latter e ect in isolation, for example by comparing the two sequences of CB peaks corresponding to v = 0 and $v \in 0$. If the \gate e ect" obeys RMT statistics, the distribution of di erences in peak positions should coincide with P (d). An r = 1 perturbation can be simulated, for example, by adjusting the voltage on a nger-shaped gate whose tip has a spatial extent sm aller than $_{\text{F}}$.

A particular feature of the r=1 perturbation is the identity $_{i}<_{i}^{0}<_{i+1}$ [8], where the levels are numbered in increasing order (assuming v>0). P (d) thus coincides with the distribution P (d), dened as the probability that an interval of length d is bounded by a pair ($_{i}$, $_{j}^{0}$ (v)) at its ends, and does not contain inside it any levels from either of the two sets. The above identity ensures j=i. The standard method of computing level spacing distributions in RMT [5] a ords a straightfor-




FIG. 1: The P (d) P'(d) curves at several characteristic values of v for a rank r = 1 perturbation.

ward generalization to the parametric case allowing the distribution P (d) to be expressed as

is de ned on the segment [0;d] of the real line, and G (; 0) is the inverse of 1 K 1 . In Fig. 1 we present a set of P (d) curves at several dierent values of v. Note that in the limit v ! 0 the distribution $P_{v! 0}(d) = \frac{1}{v}e^{d=v}$ coincides with the appropriately scaled level velocity distribution [17], while for v & 3 the curves P (d) develop a maximum at a nite value of d signifying weak repulsion between the old and the new levels.

Let us turn now to the derivation of Eqs. (3), (4), and (6). To obtain the correlation function $R_{\,\mathrm{nm}}$ one can fol-

low at least two di erent routes: By im plem enting conventionalm ethods of statistical eld theory, R nm can be expressed in the form of a supersymmetric eld integral with an action of non-linear -model type [3]. Although such an approach has the advantage of allowing a system atic developm ent of non-universal corrections in both the disordered and chaotic environm ents, this m ethod is largely tailored to the consideration of two-point correlation functions (i.e. n = m = 1). Thus, we will follow a complementary route employing a method based on orthogonal polynomials [5]. A similar approach was em ployed in Ref. [18] to study the statistics of eigenvalues of matrices belonging to the GUE under the in vence of a nite rank non-Herm itian perturbation. The latter ensemble serves as a model for describing resonances in quantum chaotic scattering [19].

where P (H) represents the Gaussian distribution function of H, and the matrix—function is understood as a product of N 2 scalar—functions (one per each independent component of the complex Herm itian matrix H). Setting H = U b U $^{\rm y}$ and H 0 = U 0 b 0 U $^{\rm 0V}$ where b and B represent the diagonal matrices of eigenvalues, the joint distribution function P (f $_{\rm ig}$; f $_{\rm ig}^{\rm 0}$) is obtained from (7) by integrating out the angular degrees of freedom,

The overall num erical constant can be restored by demanding the correct normalization. Integration over U and U^0 is performed by means of the Itzykson-Zuber integral [20]

where the sum over P runs over all permutations of the indices 1; ...; N, and $(1)^{\mathbb{P}}$ denotes the signature of the perm utation. However, using the Itzykson-Zuber form ula to undertake the remaining angular integration over U is impractical because of the N r degenerate (zero) eigenvalues of the perturbation V . To sum m arize, we have dem onstrated that the (n;m)-point param etric correlation function of the D oS in GUE possesses a determ inantal structure for perturbations of arbitrary rank. Beyond GUE, a generalization of this determ inantal structure is shown to accomm odate spatial correlations induced by ballistic wave propagation at length scales shorter than the mean free path.
