Observation of Two-dim ensional Spin F luctuations in the B ilayer R uthen ate Sr₃R u_2O_7 by Inelastic N eutron Scattering

We report the rst observation of two-dimensional incommensurate magnetic uctuations in the layered metallic perovskite Sr₃Ru₂O₇. The wavevectors where the magnetic uctuations are strongest are dierent from those observed in the superconducting single layer ruthenate Sr₂RuO₄ and appear to be determined by Fermi surface nesting. No antiferrom agnetic ordering is observed for temperatures down to 1.5 K. For temperatures T > 20 K, the uctuations become predominately ferrom agnetic. Our inelastic neutron scattering measurements provide concrete evidence of the coexistence of competing interactions in Sr₃Ru₂O₇ and of the low energy scale of the uctuations.

The nature of magnetic correlations in layered oxide perovskites such as cuprates, m anganites and ruthenates is at the heart of theoretical and experim ental challenges in contemporary solid state physics. In recent years, the discovery of unconventional superconductivity in the single-layer ruthenate Sr2RuO₄ [1] has generated signi cant interest in this and related ruthenates. The experin ental observation of low energy incommensurate 2D spin uctuations in Sr_RuO_4 [3,4] has raised the question of the relevance of spin uctuations to the mechanism producing p-wave pairing in this material. The closest relative of Sr_2RuO_4 , the bilayer $Sr_3Ru_2O_7$, is a param agnet where ferrom agnetic and antiferrom agnetic correlations m ay be in competition, and ferrom agnetism can be induced by pressure or in purities [5{10]. In highquality single crystals of Sr₃Ru₂O₇, the resistivity exhibits a Ferm i-liquid T² tem perature dependence below 10 K [6,11]. How ever, a moderate magnetic eld induces a metam agnetic transition, which is accompanied by a striking deviation from Fermi liquid behaviour [8,12]. $Sr_3Ru_2O_7$ appears to be a strong candidate to exhibit a m etam agnetic quantum critical end-point, driven by the magnetic eld and characterized by the absence of spontaneous symmetry breaking [12]. In this letter we report the rst observations of low-energy spin uctuations in $Sr_3Ru_2O_7$ as measured by inelastic neutron scattering.

W ith respect to the conducting and magnetic properties of $Sr_3Ru_2O_7$, the fundam ental building blocks of its crystal structure are the RuO_2 bilayers joined by an SrO layer. These slabs are separated along the crystal c-direction by two rock salt-type layers of SrO which decouple the slabs electronically and magnetically. At the same time, and in contrast to the single layer compound Sr_2RuO_4 , the RuO_6 octahedra in $Sr_3Ru_2O_7$ are rotated around the c-axis, by 7, changing the unit cell from body-centred tetragonal to a 2 larger face-centred

orthorhom bic cell [13]. The rotation is expected to reduce the in-plane Ru-Ru hopping, and hence increase the density of states at the Ferm i level [17], which m ay enhance the m agnetic uctuations.

Single crystals of Sr₃Ru₂O₇ were grown using a mirror fumace, and were checked for hom ogeneity and purity by m agnetic, resistive, and crystallographic m easurem ents. All crystals used in this study showed the characteristic peak in susceptibility at a tem perature of 17 K and no ferrom agnetism . For the inelastic neutron scattering experiments, three crystals were mounted so that their axes coincided to form a mosaic sample with total mass 0.9 g. The sample was mounted in a cryostat on the cold neutron three-axis spectrom eter IN 14 at the ILL. For simplicity, we describe our results using the undistorted tetragonal cell of the com pound, which has the a and b lattice parameters equal to the in-plane Ru-O-Ru distance, 3.87 A. The c-axis is perpendicular to the RuO₂ planes and has the magnitude 20.7 A, which is twice the spacing of the RuO₂ bilayers, re ecting the body-centred stacking of bilayers [13]. Using this unit cell, the main nuclear B ragg peaks of the 3-D structure occur at points (h;k;l) in reciprocal space with integer h;k and l and (h + k + 1) even. The less intense ones, arising from the rotations of the octahedra, occur at some of the points where h and k are half-integral and l is an integer.

We perform ed extensive measurements with (h;k;0) as the scattering plane and further measurements in the (h;0;1) plane. Unlike Sr₂RuO₄, magnetic uctuations at our base temperature of 1.5 K were not observed to peak along the (h;h;0) direction from a reciprocal lattice point; instead they were detected along (h;0;0). Figure 1 shows representative scans along major symmetry directions at a constant energy transfer (from neutrons to the sample) of 2 meV. Figure 1 (a) shows a double set of peaks along the (h;0;0) direction at the positions




FIG.1. Inelastic neutron scattering at 1.5K: intensity versus wavevector along lines in the (h;k;0) plane, at a constant energy transfer of 2 m eV. Solid lines are a sum of G aussians as a guide to the eye. The the fwhm Q resolution, calculated for the relaxed collimation of our setup, is comparable to the width of the sym bols. The inset to (d) indicates schematically the Q positions where peaks are observed. All measurements in this Letter, except those in Fig2, were taken with a varying incident energy and constant nal energy of 4.97 m eV, with a cooled beryllium liter before the analyser to remove higher order contamination.

Q (1 0:25;0;0) and (1 0:09;0;0). The intrinsic nature of such peaks was demonstrated by the observation of a signal of sim ilar intensity around the sym m etryrelated (0;1;0) point and the presence of four peaks in the \perpendicular" scan through (1;0;0) shown in Figure 1(b). In addition, the variation of intensity within each set of peaks is quantitatively consistent with the rapid fallo of the Ru m agnetic form factor with the m agnitude of Q [15], providing strong evidence for the m agnetic nature of the excitations.

Furtherm ore, as shown later, the intensity does not increase with tem perature as would be expected if the scattering were due to lattice vibrations. The extent of the m agnetic uctuations in the (h;k;0) plane of reciprocal space was established by the scans shown in F ig.1 (c) and (d). These show that the excitations give a broad peak centred on the (h;0;0) axis. The results are sum m arised in the inset: the excitation intensity peaks at two in-

com m ensurate w avevectors of the form q f0:25;0;0g and q f0:09;0;0g, distributed symmetrically about (1;0;0). It is natural to assume that these arise from peaks in the wavevector-dependent susceptibility at nesting vectors of the Sr₃Ru₂O₇ Ferm i surface. This is not yet known experim entally, although it has been calculated [16,17]. The coupling between the two halves of a bilayer splits each of the three sheets observed in Sr_2RuO_4 . This, and the rotation of the octahedra cause hybridisation between the bands. It appears from the calculations [17], that com pared with Sr₂RuO₄, much of the nesting at the Ferm i level is rem oved, except between parts of the sheets (Ru d_{xz} and d_{yz} orbitals). The calculated sheets have nesting vectors along the (tetragonal) f1;0;0g directions with values which are com parable with (although not equal to) those we observe. It seems reasonable to conclude that the di erences of our results from those on single-layer Sr₂RuO₄ [3,4] arise from the e ects of bilayers and octahedral rotation on the Ferm i surface in our system .




FIG.2. l-dependence of inelastic scattering at 2 m eV and h = 0.75, showing the e ects of the bilayers. The solid line is the t described in the text, plus a constant background. These m easurements were performed at a constant incident energy of 14.67 m eV, with a PG higher order liter in the incident beam.

M easurem ents as a function of lallow us to determ ine the fundamental uctuating unit in SBR u₂O₇ in this energy range. Fig. 2 shows the variation along c* of the intensity of the signal at q. The experim ental data are well-represented by I / f (Q)² \cos^2 (2 lz=c), where f (Q) is the Ru form factor and 2z = 0.194c is the distance between the RuO₂ planes in a bilayer. This function corresponds to the two halves of a bilayer uctuating in phase with each other, but with no correlation between bilayers, so that the uctuations are e ectively two-dimensional. A sim ilar argum ent [19] was used to dem on strate 2D uctuations in YBCO, but with the two halves of the bilayer in antiphase. We point out an important consequence of our results: since (1;0;0) is a reciprocal lattice point of a RuO₂ bilayer, the values of the q-vectors of excitations should be measured from this point, rather than (0;0;0)or (1;0;1), which are the closest reciprocal lattice points of the 3D crystal structure.




FIG.3. Energy and Q -dependence of scattering at 1.5 K. Scans along (h;0;0) with energy transfers of 1,2,3 and 4 m eV.

We now consider the energy dependence of these excitations. Fig. 3 shows four representative Q -scans with energy transfers of 1,2,3 and 4 m eV at T = 1.5 K.

The peaks appear to disperse slightly, and merge at higher energies. We have also performed a Q -scan over this region at zero energy transfer, which showed no evidence for static magnetic ordering near q or q. This result is in agreement with those of [14,18]. We conclude that at nite temperature only nite frequency, shortrange magnetic correlations exist.




FIG. 4. Energy dependence of magnetic scattering at Q = (0.75;0;0), m inus backgrounds taken at (1.48;0;0). The line represents a Lorentzian as described in the text. The ordinate has been connected by the Bose factor, (n (!) + 1) and the Ru form factor and converted to absolute units (with an accuracy 20%) by norm alisation to the intensity of a transverse acoustic phonon, measured at 3.1 m eV around (1;1;0) at 100 K.

Fig. 4 shows the energy dependence of the signal at q. We have tted the response to a simple Lorentzian model for the susceptibility: ${}^{00}(Q;!) = {}^{0}(Q)$! $(Q) = {}^{2}(Q) + {}^{2}$. We nd that the characteristic energy h = 2.3 0.3 meV, which is much less than 9 meV reported in the single layer compound Sr₂RuO₄ [3]. The presence of dispersion on an energy scale much smaller than F and the smallenergy scale of the uctuations indicates the strong renormalising e ects of electron correlations in our compound. We also note that the susceptibility is large, translating to ${}^{0}(Q)$ of 1:6 10² emu/m olRu. This indicates that Sr₃Ru₂O₇ is much closer to magnetic order than its sister compound.




FIG.5. Q -dependence of scattering along (h;0;0) for an energy transfer of 3.1 m eV at three di erent tem peratures: 1.5, 15 and 150 K.

We have also followed the uctuations as a function of tem perature at an energy transfer of 3.1 m eV around Q = (0.75;0;0) (Fig. 5). At base tem perature, the two peaks associated with the incom mensurate spin uctuations are well de ned and intense. How ever, as the tem perature is increased, the intensity of the incom mensurate peaks falls o , and is replaced by a broad peak of similar intensity around the 2D reciprocal lattice point (1;0;0). This position is not a Bragg peak of either the tetragonalor the orthorhom bic cell, so does not give rise to a low energy acoustic phonon. Hence the peak at (1;0;0) is most likely of magnetic origin. We have con-

m ed by m easurem ents along c* that this signal also arises from uctuations of a bilayer unit. Our ndings point to a crossover in the nature of the low energy m agnetic correlations in this m aterial. A thigh tem peratures, 2D ferrom agnetic uctuations dom inate the correlations; as the tem perature is low ered, instead of converging to a long-lived ferrom agnetic state, the system is sidetracked to a di erent behaviour with antiferrom agnetic nite frequency 2D excitations.




FIG. 6. Temperature-dependence of magnetic response from macroscopic and microscopic measurements: (a) Static susceptibility from [6]. (b) Susceptibility, $^{00}(Q;!)$ (units: 2_B =eV=Ru) from neutron scattering at Q = (0:95;0;0) and an energy transfer of 2 meV, minus a background at (0:55;0;0). (c) As for (b) at Q = (0:75;0;0). (d) Fractionalm agnetoresistance, ((2T) (0))= (0), measured with current parallel to the magnetic eld in the basalplane [8,20]. The lines serve as guides to the eye.

In Fig. 6, we show that the change with tem perature in the nature of magnetic uctuations is rejected in macroscopic properties. At a tem perature 20 K, there is a peak in the magnetic susceptibility (a), and and also in the susceptibility close to a ferrom agnetic position measured by neutron scattering (b). The antiferrom agnetic

uctuations (c) fall away rapidly with increasing temperature and this is rejected in the change in sign of the longitudinalm agnetoresistance (d) [7]. It is not clear what causes this dram atic change in magnetic correlations, but it may be related to a loss in c-axis electronic coherence, which reveals itself as a steep rise in the c-axis resistivity in this temperature region [6]. It is of interest that in the compound C $a_2 \ge Sr_x RuO_4$ [21,22], doping with Sr drives the system from an insulating antiferromagnetic state, through a phase with a ferrom agnetic instability to a metallic superconducting one. In contrast, in $Sr_3Ru_2O_7$ the competing interactions coexist in the same high-quality stoichiom etric sam ples.

In conclusion, we have observed strong 2D spin uctuations of the bilayers in $Sr_3Ru_2O_7$. At high tem peratures these uctuations are predom inantly ferrom agnetic in nature, and cross over to incom m ensurate ones at low tem – peratures, with wavevectors close to those expected for nesting vectors of the Ferm i surface. The small characteristic energy of these uctuations and their am bivalent nature suggests that they are in plicated in and related to the m etam agnetic transition observed at low tem peratures. We note that a strong tem perature-dependence of the electronic properties and m agnetic excitations is also observed in H igh T_c superconductors [23] and heavy ferm ion system s [24]. Thus the behaviour of Sr₃R u₂O₇ m ay ultimately be related to its proximity to a quantum critical point [12].
