Full Counting Statistics of a Superconducting Beam Splitter

W e study the statistics of charge transport in a mesoscopic three-term inal device with one superconducting term inal and two norm al-m etal term inals. We calculate the full distribution of transm itted charges into the two sym metrically biased norm alterm inals. In a wide parameter range, we nd large positive crosscorrelations between the currents in the two norm alarms. We also determ ine the third cum ulant that provides additional inform ation on the statistics not contained in the current noise.

The number of charges transfered in a transport process uctuates due to quantum -m echanical uncertainty and statistics. Therefore, the outcom e of a current m easurem ent accum ulated over som e tim e period t_0 is in general described by a probability P (N), where N is the total number of charges transfered. P (N) is called the full counting statistics (FCS) of the transport process [1]. The rst two moments of the FCS are related to the average current and the current noise and are accessible to present experimental techniques. H igher-order correlations are likely to be measured in the future. Several schemes to measure either higher correlators or the full distribution have been proposed recently [1, 2, 3, 4, 5, 6].

The current noise, i.e., the second moment of the FCS, is of particular interest. It can be used as a diagnostic tool to probe the nature and the quantum statistics of the charge carriers [7] and the existence of entanglem ent [8]. For superconductor(S)-norm alm etal(N) heterostructures, a doubling of the shot noise in comparison to the norm al case was predicted [9] and measured in di usive heterostructures [10]. Recent calculations taking into account the proximity e ect in such structures [11] are in good agreement with experimental results [12]. Multiterm inal SN structures have been suggested to produce entangled electron pairs [13, 14].

So far, crosscorrelations, i.e., current correlations involving di erent term inals, were measured only in norm alsingle-channelheterostructures [15]. These have conm ed the prediction [16] that current crosscorrelations in a ferm ionic system are always negative. To our know 1edge, there is no measurement of crosscorrelations in a system with superconducting contacts up to now. Theoretically, positive crosscorrelation with a single-channel beam splitter for Andreev pairs in jected from a superconductor have been predicted [17]. In a setup in which crosscorrelations between a norm al lead and a tunneling probe are considered, the sign of the correlations was found to depend crucially on the sample geometry [18]. A num erical study found positive crosscorrelations in a three-term inaldevice with a few channels with ferrom agnetic contacts [19].

In this Letter we nd the full counting statistics of a many-channel beam splitter that divides a supercurrent in two norm al quasiparticle currents. We calculate the

distribution of the transm itted charges taking the proxim ity e ect into account. For comparison we also calculate the FCS for the case in which the superconducting term inal is replaced by a norm alone.




FIG.1: Three-term inal beam -splitter. One superconducting or norm al term inal (S or N) and two norm al term inals (N $_1$ and N $_2$) are tunnel-coupled by conductances g, g_1 and g_2 to a common central node. A current is passed from S/N into the two norm al leads that are kept at the same voltage. Ideal passive charge counters are indicated by the counting elds , $_1$ and $_2$.

The setup of our three-term inal device with one superconducting and two norm alm etal term inals is shown in Fig. 1. All three term inals are connected by tunnel junctions to a sm all norm alm etal island. We assume the island to be large enough, that we can neglect charging e ects, and sm all enough that we can treat the G reen's functions of the island as constant. Thus, we are restricted to energies below the Thouless energy of the island. The system is then appropriately described by the circuit theory of mesoscopic transport [20], within which the counting statistics is easily accessible [2, 11, 21].

The circuit elements that are important for our case are normal, resp. superconducting term inals and tunnel connectors. The term inals are described by quasiclassical G reen's functions, which depend on the type of the term inal (N or S), chem ical potential, tem perature T and a counting eld . We assume zero tem perature and a sym metric bias at the two normal term inals. Since we are interested in correlations between currents in di erent term inals, we introduce di erent counting elds. The voltage is chosen such that eV . Charge transport (at T = 0) occurs then only in the interval \sharp j eV and we need to consider only this energy interval below.

The Green's functions of the two norm alterm inals are

then given by

where G_N is the same for both normal term inals. At zero temperature $G_N = {}^3_3 {}^3_3 + ({}_1 + i{}_2)\hat{1}$ for $\not{E} j$ eV and $G_N = {}^3_3 {}^3_3 + sgn(E){}^3_3({}_1 + i{}_2)$ for $\not{E} j > eV$. Here ${}^1_i({}_i)$ denote Paulim atrices in Nambu(Keddysh)-space. The counting rotation matrix is ${}_K = {}^3_3 {}_1$. The superconducting term inal in equilibrium is characterized by $G_S = {}^1_1$ and a counting eld , that enters as in (1).

If one node is connected to M term inals by m eans of tunnel connectors, one can nd a general form of the FCS, i.e. the probability P (N₁;:::;N_M) that N₁(2;...,M) charges are counted in term inal 1(2;:::;M). The unknown G reen's function of the central node is denoted by G_c. The m atrix currents into the central node are given by I_k = $\frac{g_k}{2}$ G_c;G_k, where the index k = 1;:::;M labels the term inals and g_k is the conductance of the respective junction. To nd the cumulant-generating function (CGF) S of P (N₁;:::;N_M) we integrate the equations ($ib_{p}=e$)@S($_{1}$;:::; $_{M}$)=@ $_{k} = dETr_{K}I_{k}=8e$ [22]. We obtain

This is the general result for an M-term inal geometry in which all term inals are tunnel-coupled to a comm on node.

We now evaluate Eq. (3) for our three term inal setup. Introducing $p_i = 2gg_i=(g^2 + (g_1 + g_2)^2)$ we nd

This result for the cumulant-generating function incorporates all statistical transport properties for our present setup. The inner argum ent contains counting factors for the di erent possible processes. A term exp(i($_{k}$ + $_{1}$

2) 1) corresponds to an event in which two charges leave the superconducting term inal and one charge is counted in term inalk and one charge in term inall. The prefactors are related to the corresponding probabilities. For instance, p_1 is proportional to the probability of a coherent tunneling event of an electron from the superconductor into term inal 1. A coherent pair-tunneling process is therefore weighted with p_1^2 . This is accompanied by counting factors which describe either the tunneling of two electrons into term inal1(2) [counting factor)) 1] or tunneling into di erent term iexp (i2 (1(2) nals [counting factor exp (i($_1 + _2 2$)) 1]. The double square-root function shows that these di erent processes are non-separable.

It is interesting to compare Eq. (4) with the case in which the superconductor is replaced by a norm alm etal. The resulting CGF is

where $p_{1(2)}^{N} = 4gg_{1(2)} = (g + g_1 + g_2)^2$. Thus, one of the square roots in Eq. (4) can be attributed to the multiple tunnel-junction geometry, which is already present in the norm alcon guration. The second square root in the CGF for the superconducting case must then be due to the proximity e ect.

We now evaluate some average transport properties of the SNN-system and compare them to the NNN-case. The currents into the di erent term inals are obtained from derivatives of the CGF: $I_k =$ (i==b)@S=@ kj_1= _2= =0. The trans-conductances G k = I_k=V into term inalk (= 1;2) are then given by

The superscript S(N) denotes the SjN(NjN)-case. Noise and crosscorrelations are obtained from second derivatives of the CGF, i. e., $P_{k1}^{T} = (2e^2=t_0)e^2S(_1;_2;)=e_ke_{1j_{1}=_2}=0$. We de ne Fano factors $F_{k1} = P_{k1}^{T}=2eI$, and we denote the Fano factor of the total current with $F = F_{11} + F_{22} + 2F_{12}$. We also calculate the third cumulant of the total charge transfer (norm alized to the Poisson value) $C_3 = (ie=It_0)e^3S(0;0;) = e^{-3}j_{=0}$. The results in the




FIG. 2: Conductance, Fano factors, crosscorrelations and third cumulant of the beam splitter. The thick lines correspond to the $S_N N$ -case and the thin lines to the $N_N N$ -case. The conductance (upper-left panel) in the superconducting case shows a maximum around $g = g_1 + g_2$. In the normal state, the conductance varies between g and $g_1 + g_2$. In both cases, the current noise (upper-right panel) shows a suppression around $g = g_1 + g_2$ as compared to the limiting values of 2 in the SNN-case and 1 in the NNN-case. Large positive crosscorrelations occur in the superconducting case (lowerleft panel), whereas they are always negative in the norm al case. A round $g = g_1 + g_2$, the superconducting crosscorrelations become negative. Note, that what is plotted here is $f_{12}^{S=N} = F_{12}^{S=N} (g_1 + g_2)^2 = g_1 g_2$. The third cumulants (lowerright panel) are always positive. Around $g = g_1 + q_2$ they are strongly suppressed. In the $S_{1}N$ -case, C_{3}^{S} has a doubleminimum here, as shown in the blow-up.

In the N NN case, on the other hand, we nd

All other Fano factors can be deduced from F_{12} and F using the relations $_{k}F_{k1} = 0$ and $F_{k1} = F_{1k}$. The transport properties are summarized in Fig. 2. In the

gure the crosscorrelations are plotted as $f_{12} = F_{12} (g_1 +$ g_2)²= g_1g_2 . M ost remarkably, the crosscorrelations F_{12}^S are positive if x is sm all, whereas F_{12}^{N} is always negative in the norm al state. Here, the Fano factor F $^{\rm S}$ (F $^{\rm N}$) is close to 2(1). Going to the regime g $(q + q_2)$ suppresses the Fano factor F^{S(N)} below 2(1) and leads to negative crosscorrelations F_{12}^{S} . In the lim iting case $g = (g_1 + g_2)$ the Fano factors are $F^{S} = 3=4$ and $F^{N} = 1=2$, and the crosscorrelations are $F_{12}^{S} = F_{12}^{N} = q_{12} q_{2} = 4 (q_{1} + q_{2})^{2}$. The third cumulant is always positive, but shows a strong suppression around the resonant conductance ratio $g = (g_1 + g_2)$. In the lim it of sm all x (x_N) the third cum ulant is 4 (1), corresponding to the e ective charge squared transferred in a tunneling process [3]. However, the variation with $g=(g_1 + g_2)$ in the S₁NN-case is more pronounced than in the N NN-case.

A san interesting side rem ark we point out that $F_{12}^{S} = 0$ and $F^{S} = 1$ for $x^{2} = 1=5$. This boks like a signature of uncorrelated charge transfer in units of e. How ever, the third cum ulant $C_{3}^{S} = 13=25$ di ers from the corresponding value for uncorrelated 1e-charge transfer, viz., $C_{3} = 1$. Thus, higher correlations show that the charge transfer is still correlated.

We brie y discuss the in uence of an asymmetry $g_1 \notin g_2$ of the beam splitter. The crosscorrelations are reduced, both in the SNN and in the NNN case. However, the positive crosscorrelations in the superconducting state persist for all values of the asymmetry. Cumulants of the total charge transfer like the conductance, F ^{S}N and C ^{S}N are independent of this asymmetry.

U sing the CGF from Eq. (4), we can identify the physical processes leading to our previous results. We have seen from (7) that positive crosscorrelations are found if $g=(g_1 + g_2)$ is not close to 1. Then, $p_{1,2}$ 1 and we can expand Eq. (4) in $p_{1,2}$. D ropping the trivial dependence on , the CGF can be written as

The CGF is composed of three di erent terms, corresponding to a charge transfer of 2e either into term inal 1 or term inal 2 (the rst two terms in the bracket) or separate charge transfer into term inals 1 and 2. A coording to the general principles of statistics, sum s of CGFs of independent statistical processes are additive. Therefore, the CGF (9) is a sum of CGFs of independent Poissonian processes. C rosscorrelations are obtained from derivatives with respect to $_1$ and $_2$. Thus, the rst two terms in (9) corresponding to two-particle tunneling either into term inal 1 or 2 do not contribute. It is only the last term which yields crosscorrelations, and those are positive. Poissonian statistics are the statistics of uncorrelated events, which in our case means all tunneling events are independent. Thus, a two-particle tunneling event into one of the norm al term inals is not correlated with other tunneling events and does not contribute to crosscorrelations, but only to the autocorrelations. The two-particle tunneling into di erent term inals, how ever, is autom atically positively crosscorrelated. The crosscorrelations are therefore positive.

The total probability distribution P (N₁;N₂) corresponding to (9) can be found. It vanishes for odd values of (N₁ + N₂) and for even values it is

Here we have de ned the average number of transfered electrons N = $t_0 G^S V = e$ and the probabilities $T_{1(2)} = g_{1(2)} = (g_1 + g_2)$ that one electron leaves the island into term inal 1(2). If one would not distinguish electrons in term inals 1 and 2, the charge counting distribution can be obtained from (9) by setting $_1 =$ and performing the integration. This leads 2 = to P_{tot}^{S} (N) = exp(N=2) (N=2)^{N=2} = (N=2)!, which corresponds to a Poisson distribution of an uncorrelated transfer of electron pairs. The full distribution (10) is given by P_{tot}^{S} (N₁ + N₂), multiplied with a partitioning factor, which corresponds to the number of ways how $N_1 + N_2$ identical electrons can be distributed among the term inals 1 and 2, with respective probabilities T_1 and T_2 . Note, that $T_1 + T_2 = 1$, since the electrons have no other possibility to leave the island.

In contrast to that, we obtain in the norm all case for $t_{1,2}^N$ 1 the probability distribution:

Here we have abbreviated the average number transfered into term inaliby N_i. Thus, the distribution in the normal case is the product of two Poisson distributions of charge transfers into the two term inals. In the superconducting case such a factorisation is not possible.

In conclusion, we have studied the full counting statistics of a three-term in aldevice with one superconducting and two norm al leads. The system is biased such that a supercurrent is passed from the superconductor into the two norm al leads, with no net current between the norm al leads. Thus, the device acts as a sort of beam splitter. W e have calculated the full distribution of transm itted charges using the extended K eldysh-G reen's function method fully accounting for the proximity e ect. Our main nding are large positive crosscorrelations of the currents in the two norm alterm inals in a wide param eter range. These should be easily accessible experimentally. These positive correlations originate from independent Poisson processes of coherent tunneling of charges into the di erent term inals. These dom inate the crosscorrelations, since two-particle tunneling into the same lead

does not contribute to the crosscorrelations. We have also calculated the third cum ulant which provides additional inform ation on the current statistics not contained in the current noise.
