## D ynam ics of collapsing and exploding B ose-E instein condensate

Recently, Donley et al. perform ed an experim ent on the dynamics of collapsing and exploding Bose-Einstein condensates by suddenly changing the scattering length of atom ic interaction to a large negative value on a preform ed repulsive condensate of <sup>85</sup>Rb atom s in an axially sym metric trap. Consequently, the condensate collapses and ejects atom s via explosions. We show that the accurate num erical solution of the tim e-dependent G ross-P itaevskii equation with axial sym metry can explain som e aspects of the dynamics of the collapsing condensate.

Since the successful detection  $[1 \{5\} \text{ of } B \text{ ose-} E \text{ instein}$ condensates (BEC) in dilute bosonic atoms employing m agnetic trap at ultra-low temperature, one problem of extrem e interest is the dynam ical study of the form ation and decay of BEC for attractive atom ic interaction [4,5].

For attractive interaction the condensate is stable for a maximum critical number  $N_{\rm CT}$  of atoms [4]. When the number of atoms increases beyond this critical number, due to interatom ic attraction the radius of BEC tends to zero and the central density tends to in nity. Consequently, the condensate collapses emitting atoms until the number of atoms is reduced below  $N_{\rm CT}$  and a stable con guration is reached. With a supply of atoms from an external source the condensate can grow again and thus a series of collapses can take place, which was observed experimentally in the BEC of <sup>7</sup>Liw ith attractive interaction [4]. Theoretical analyses based on the time-dependent mean-eld Gross-Pitaevskii (GP) equation also con im the collapse [6{11].

It is possible to manipulate the interatom ic interaction by an external magnetic eld via a Feshbach resonance [12]. Roberts et al. [13] and Comish et al. [14] (at JILA) exploited this idea to suddenly change the atom ic scattering length by a large amount in experiment. They have been able to even change the sign of the scattering length, thus changing a repulsive condensate in to an attractive one and vice versa. Consequently, a stable preform ed repulsive condensate is suddenly turned to a highly explosive and collapsing attractive condensate. In a classic experiment performed at JILA Donley et al. [15] studied the dynam ics of collapsing and exploding condensates form ed of 85 Rb atom s. The natural scattering length of <sup>85</sup>Rb atom s is negative (attractive). By exploiting the Feshbach resonance they made it positive (repulsive) in the initial state. They have provided a quantitative measurement of this explosion by counting the number of emitted and remaining atoms in the condensate as a function of time until an equilibrium is reached. They also measured the energy distribution of the emitted atoms. They claim that their experiment revealm any interesting phenom ena that challenge theoreticalm odels.

W e dem onstrate that som e aspects of the above  $\infty$ lapse and explosion of the attractive condensate of  ${}^{85}Rb$ 

atom s can be explained from an accurate num erical solution of the GP equation in an axially symmetric trap, where we include a quintic three-body nonlinear recombination term which accounts for the decay of the strongly attractive condensate. The num erical method, we use, for the solution of the time-dependent GP equation with an axially symmetric trap has appeared elsewhere [16{22].

There have been other theoretical studies [6{10] to deal with dynamical collapse including an absorptive term to account for the loss of particles. Instead of attempting a full numerical solution of the GP equation with axial symmetry, these investigations used various approximations to study the time evolution of the condensate or employed a spherically symmetric trap.

The time-dependent Bose Einstein condensate wave function (r; ) at position r and time may be described by the following mean-eld nonlinear GP equation [11]

Here m is the mass and N the number of atom s in the condensate, g = 4  $h^2 a=m$  the strength of interatom ic interaction, with a the atom ic scattering length. The trap potential with cylindrical symmetry may be written as  $V(r) = \frac{1}{2}m!^2(r^2 + {}^2z^2)$  where ! is the angular frequency in the radial direction r and ! that in the axial direction z. We are using the cylindrical coordinate system r (r; ;z) with the azim uthal angle. The root mean square (rm s) sizes  $x_{\,\text{rm}\,S}$  and  $y_{\,\text{rm}\,S}$  are dened by

It is now appropriate to calculate the param eters of the present dim ensionless GP equation (3) corresponding to the experiment at JILA [15]. We follow the notation and nom enclature of Ref. [15]. Their radial and axial trap frequencies are radial = 17.5 H z and axial = 6.8 H z, respectively, leading to = 0.389. The harm onic oscil $lator_plength 1$  for  $^{85}Rb$  atom s for ! = 217:5 Hz is h=(m!) = 25905A.One unit of time t of Eq.1 = (3) is 1=! or 0.009095 s. They prepared a stable  $^{85}$ Rb condensate of N<sub>0</sub> = 16000 atom s with scattering length  $a = a_{initial} = 7a_0, a_0 = 0.5292 A$ , such that the initial n = 2288. Then during an interval of time 0.1 m s the scattering length was ram ped to  $a = a_{\text{collapse}} = 30a_0$ such that naln =9:805. The nal condensate is strongly attractive and unstable and undergoes a sequence of collapse and explosion.

The sequence of collapse in many theoretical studies has been explained by introducing an absorptive in aginary three-body quintic interaction term of strength responsible for recombination loss. Consequently Eq. (3)becomes [6{8]

There are many ways to account for the loss mechanism [6,7]. It is quite impossible to include them all in a self consistent fashion. Here we simulate the loss via the most important quintic three-body term with parameter . We use this single parameter to reproduce the experiment at JILA [15]. For £0 in Eq. (7), N<sub>norm</sub> £ 1:

W e solve the GP equation (7) num erically by time iteration with a given initial solution. In the time-evolution of the GP equation the radial and axial variables are dealt with in independent steps. For this purpose we discretize it using time step = 0.001 and space step 0:1 for both x and y spanning x from 0 to 15 and y from 25 to 25. This dom ain of space was su cient to

encom pass the whole condensate wave function even during and after explosion and collapse. The preparation of the initial repulsive wave function is now a routine pb and was done by increasing the nonlinearity n of the GP equation (7) by 0.0001 in each time step during time iteration starting with the known harm onic oscillator solution of Eq. (7) for n = 0 [16]. The initial value ofn (= 2:288) was attained after 22880 time steps. The nonlinearity n is then ramped from 2,288 to 9:805 in 0.1 m s. A sone unit of dim ension less tim e t is 0.009095 s, 0.1 m s corresponds to 11 steps of time . In the present simulation, n is ram ped from 2,288 to 9:805 in the GP equation by equal amount in 11 steps. The absorptive was set equal to zero during above time iteration. term Now the system is prepared for the simulation of collapse and explosion.

For the remaining simulation the nonlinear term is maintained constant and a nonzero value of is chosen. The time-evolution of the GP equation is continued as a function of time t = evolve starting at 0. Because of the nonzero dissipative term , the norm alization (4) is no longer maintained, and the number of remaining atom s N in the condensate is given by N =  $N_0 N_{norm}$ , where N $_0$  is the initial number. The time-evolution is continued using time step = 0:001. A fter a sm all experimentation it is found that = 3:12 ts the data of the experiment at JILA for  $a_{\text{collapse}} =$ 30a<sub>0</sub> their Fig. 1(b). This value of was used in all simulations reported here. The rem aining num ber of atom s vs. tim e is plotted in Fig. 1.

It is pertinent to com pare this value of (= 3:12) with the experimental measurement of three-body loss rate on <sup>85</sup>Rb [23]. For that, we need to restore the proper dimensions in the three-body term of Eq. (7) by rewriting it as i  $(aN = 1)^2 j \quad f \quad 1^6 = 8$  and equating it to the convensional form iK  $_3N \quad ^2 j \quad f \quad = 2!$ , where K  $_3 = (4.24^{+0.70} \quad 0.85)$  $10 \quad ^{25} \quad cm \quad ^6/s$  is the experimental rate [23]. From this we nd K  $_3 = a^2 1^4 ! = 4$ : Under experimental condition of an external magnetic eld of 250 gauss on  $^{85}$ Rb [23] the scattering length was a  $350a_0$ . Consequently, the present value of (= 3:12) corresponds to K  $_3'$  13 10  $^{25}$ cm  $^6/s$ , about three times larger than the experimental 7) value above.

In the experim ent at JILA [15] it was observed that the strongly attractive condensate after preparation remains stable with a constant num ber of atom s for an interval of time  $t_{collapse}$ . This behavior is physically expected. Im - m ediately after the jump in scattering length from  $7a_0$  to

 $30a_0$ , the attractive condensate shrinks in size during  $t_{collapse}$  until the central density increases to a maximum. Then the absorptive three-body term takes full control to initiate the sequence of collapse and explosion. Consequently, the num ber of atom s remains constant for evolve <  $t_{collapse}$ . The present result (full line) also show s a sim lar behavior. However, in this simulation the absorptive term is operative from evolve = 0 and the atom num ber decreases right from beginning, albeit

at a much sm aller rate for evolve < t<sub>collapse</sub>.

D onley et al. [15] repeated their experiment with dierent values of nal scattering length. U sing the same value of (= 3:12), we also repeated our calculation with the nal scattering lengths:  $a_{collapse} = 6:7a_0$  and  $250a_0$ : These results are also plotted in Fig. 1. The initial delay  $t_{collapse}$  in starting the explosion is large for small  $ja_{collapse}$  jas we see in Fig. 1. A fler the initial delay, the decay rates of the number of atom s are quite similar as observed in the experiment. Similar e ect was observed in the experiment for an initial condensate of 6000 atom s as shown in their Fig. 2.

A fier a sequence of collapse and explosion, D onley et al. [15] observed a \rem nant" condensate of N rem nant atom s at large tim es containing a certain fraction of initial N<sub>0</sub> atom s. Experim entally, the fraction of atom s that went into the rem nant decreased with  $\dot{p}_{collapse}$ j and was 40% for  $\dot{p}_{collapse}$ j < 10a<sub>0</sub> and was 10%  $\dot{p}_{collapse}$ j > 100a<sub>0</sub>. Figure 1 also shows this behavior. W e repeated the simulation of Fig. 1 with N<sub>0</sub> = 6000 where we also found a sim ilar behavior. The number in the rem nant condensate could be much larger than N<sub>CT</sub>.

The above evolution of the condensate after the jump in scattering length to  $30a_0$  for N<sub>0</sub> = 16000 can be understood from a study of the wave function and we display the central part of the wave function in Fig. 2 for evolve = 0;3:5;4; and 10 m s. The wave function immediately after jump at time evolve = 0 is essentially the same as that before the jump at 0:1 m s. There is not enough time for the wave function to get modi ed at evolve = 0. From Fig. 2 we nd that at 3.5 m s the wave function is only slighty narrower than at 0 m s but still sm ooth and has not yet collapsed signi cantly. As evolve increases, the wave function contracts further and the explosion starts. At 4 m s som e spikes have appeared in the wave function showing the beginning of explosions and loss. From the study of the wavefunctions we nd that the explosions start at  $evolve = t_{collapse} ' 3:7 \text{ ms}$ in agreem ent with the experiment at JILA.We also nd that at 3.7 m s before the loss began the bulk BEC did not contract dram atically as also observed in the experiment. In numerical simulation for this case we nd that at  $evolve = 0; x_{IMS} = 2:98 \text{ m}$  and  $y_{IMS} = 4:21 \text{ m}$  and at  $evolve = 3:7 \text{ ns}, x_{ms} = 2:53 \text{ m} \text{ and } y_{ms} = 4:10 \text{ m}.$ From Fig. 2 we see that at 10 m s the wave function is very spiky corresponding to m any violent ongoing explosions.

D onley et al. [15] also observed that the rem nant condensate oscillated in a highly excited collective state with approximate frequencies 2  $_{axial}$  and 2  $_{radial}$  being predom inantly excited. The measured frequencies were 13.6(6) Hz and 33.4(3) Hz. To nd if this behavior emerges from the present simulation we plot in Fig. 3 sizes x<sub>IM S</sub> and y<sub>IM S</sub> vs. time for the condensate after the jump in the scattering length to 30a<sub>0</sub> from 7a<sub>0</sub> for N<sub>0</sub> = 16000. Excluding the rst 20 m s when the rem nant condensate is being form ed, we nd a periodic oscillation in  $x_{\rm IM}$  s and  $y_{\rm IM}$  s with frequencies 34 Hz and 13.6 Hz, respectively. In addition, for  $x_{\rm IM}$  s, superposed on 34 Hz we note a prominent frequency of about 3.5 Hz, e.g., 0.2 radial.

Though we have explained som e aspects of the experin ent at JILA, there are certain detailed features that have not been obtained in this Letter. Donley et al. [15] have classi ed the em itted atom s in three categories: burst, jet and m issing atom s. D etailed study of the wave function is needed to identify the jet atom s that appear possibly from the spikes in the wave function when the collapse is suddenly interrupted. The jets were also not always found to be symmetric about the condensate axis [15]. This makes an axially symmetric mean-eld model as used in this Letter inappropriate for a description of the jet atom s. M oreover a clear-cut distinction between the burst and m issing atom s em itted during explosions seems to be di cult in the present model. A loo because of the missing (undetected) atom sit is di cult to predict the energy distribution of the burst atom s in a m ean-eld analysis which will only yield the total energy distribution of the burst plus m issing atom s. A careful analysis of the energy of the emitted atoms is required for explaining these detailed features and would be a welcom e future theoretical investigation.

In conclusion, we have employed a numerical simulation based on the accurate solution [16] of the mean-eld G ross-P itaevskiiequation with a cylindrical trap to study the dynamics of collapse and explosion as observed in the recent experiment at JILA [15]. In the GP equation we include a quintic three-body nonlinear recombination loss term which accounts for the decay of the strongly attractive condensate. The results of the present simulation accounts for the essential features of that xperiment. We

nd that the exact inclusion of the asym m etry param eter in the simulation is essential for a proper description of the experim ent. In the experim ent at JILA a strongly attractive <sup>85</sup>Rb condensate was prepared by ram ping the scattering length to a large negative value and the subsequent decay of the condensate was measured. We have been able to understand the following features of this dynam ics from the present num erical simulation: (1) The condensate undergoes a sequence of collapse and explosion and nally stabilizes to a remnant condensate at large tim es containing about 10% 40% of the initial num ber N<sub>0</sub>. The num ber in the rem nant condensate can be larger than the critical num ber for collapse N cr for the same atom ic interaction. (2) Both in the experiment and our simulation the remnant condensate executes radial and axial oscillations in a highly excited collective state for a long time with frequencies 2  $_{radial}$  and 2  $_{axial}$ : (3) The rate of decay of the num ber of particles is reasonably constant independent of N  $_0$  and a collapse: (4) A fter the sudden change in the scattering length to a large negative value, the condensate needs an interval of time t<sub>collapse</sub> before it experiences loss via explosions. Consequently,

the decay starts after the interval of time t<sub>collapse</sub>.
