## R enorm alization group approach to the interacting boson ferm ion systems

We study a pseudogap region of the mixed boson ferm ion system using a recent formulation of the renormalization group technique through the set of in nitesimal unitary transformations. Renormalization of ferm ion energies gives rise to a depletion of the low energy states (pseudogap) for temperatures  $T > T > T_{\rm c}$  which foreshadows appearance of the pairwise correlations with their long range phase coherence being missed. With a help of the low equations for boson and ferm ion operators we analyze spectral weights and nite life times of these quasiparticles caused by interactions.

M any experim entalm easurem ents of e.g. the angle resolved photoem ission (ARPES), tunneling spectroscopy (STM), speci cheat as well as the optical and m agnetic characteristics (see for an overview [1]) point at a presence of pseudogap in the norm alphase spectrum of underdoped cuprate superconductors. It is believed that a proper description of this phenom enon would be crucial for understanding of the HTSC mechanism.

M odel of itinerant ferm ions coupled via the charge exchange interaction to boson particles [2], for example of bipolaronic origin, has been shown to posses such a pseudogap in the normal phase ferm ion spectrum. Its occurrence has been obtained on a basis of the selfconsistent perturbation theory [3], diagram matic expansion [4] and also by solving the dynamical mean eld equations for this model within the non-crossing approximation (NCA) [5]. Unfortunately, these techniques have not been able to study a superconducting phase of the model, so evolution of the pseudogap into the true superconducting gap could not be investigated. Only very recently we have reported some prior results for the boson ferm ion (BF) model using the ow equation method [6] where superconducting gap and normal phase pseudogap could be treated on equal footing. Both gaps originate from the same source (from the exchange interaction between ferm ions and bosons) but they are differently scaled against a magnitude of this interaction and the total concentration of charge carriers. Still the most intriguing question concerning the evolution from the pseudo- to the superconducting gap is poorly understood due to technical diffusion are currently under consideration.

In this paper we address another important issue concerning life time e ects of the quasiparticles. The high resolution ARPES data [7] reveal that normal phase of underdoped cuprates has the marginal Fermi liquid type properties where the quasiparticle weight and life time are very sensitive to temperature. We want to check how the life times of fermions and bosons depend on temperature T and momentum using the BF model scenario.

Flow equation for any arbitrary operator, say A (1), is given by

where  $^{\circ}$  is a generating operator of the continuous canonical transform ation. The initial BF model Hamiltonian consists of the free part

and the interaction

In order to decouple ferm ion from boson subsystems we have previously chosen in a form [6]

with  $k_{7q} = \frac{\textbf{w}^{\#}}{k} + \frac{\textbf{w}^{\#}}{q}$  E  $_{k+q}$ . U sing the general ow equation (1) we transform ed the H am ilton operator Ĥ (1) so that in the lim it 1! 1 the charge exchange interaction got elim inated  $v_{k,q}$  (1 ) = 0.

In a course of the continuous canonical transform ation the initial boson and ferm ion operators change according to the following ow equations

Sim ilar equations can be derived for their herm itean conjugates  $\hat{b}_{q}^{y}(1)$ ,  $\hat{c}_{k:r}^{y}(1)$ . By inspecting (5) we notice that initial boson annihilation operator is coupled to the electron pair operator  $\Phi_{k,j}$  (1)  $\Phi_{q,k,j}$  (1). Thereofone should in a next step determ ine a corresponding ow equation for the nite momentum pair operator, however this process will never end (like equations of motion for the G reens functions). There would be the higher and higher order product of operators getting involved into the di erential ow equations.

Following the other works using such continuous canonical transformation [8]-[10] we term in ate the ow equations by postulating some (physical) Ansatz. In a context of the BF model it seems natural to postulate the following decom positions

Unknown parameters  $Y_{q;k}$  (1),  $B_{k;q}$  (1) can be found directly from the ow equations (5,6)

There is no unambiguous way for determining the other missing coe cients A  $_k$  (1), X  $_q$  (1) because with the Ansatz (7,8) the ow equations still do not close. In what follows bellow we determ ine these param eters using the constraint

Here  $f_k$ , ,  $b_t$  denote the Ferm i and Bose distribution functions. They appear after introducing the normal ordered form s for operators left of the commutation (12) and anticommutation (13) when substituting (7,8).

We solved numerically a set of the coupled equations (10,11,14,15) simultaneously with the additional ow equations for  $"_k$  (1), E $_k$  (1) and  $v_{k,q}$  (1) given in the Ref. [6]. Initially, for l=0, we assum ed: a) the one dim ensional tight binding dispersion " $_k$  (l= 0) = 2tcosk,b) localized bosons E $_q$  (l= 0) =  $_B$  and c) local exchange interaction  $v_{k,q}$  (l= 0) = v. For the sake of comparison with the previous studies of this model we used D = 4t 1,  $_B$  = 0.6, v = 0.1 and total concentration of carries xed to be 1.





FIG.1. Momentum dependence of the ferm ion coecient  $A_k$  (1) for three temperatures T=0.01,0.02 and 0.03 (in units of the initial ferm ions bandwidth). Note a strong renormalization of the coecient  $A_k$  around the characteristic momentum k.

In gure 1 we plot the momentum dependence of  $A_k$  coe cient for l=1 (when ferm ion subsystem is decoupled from the boson one). Considerable variation of the parameter  $A_k$  from its initial value (being 1) can be observed for such momenta which are located near k '0.89. As discussed in the Ref. [6] this situation corresponds to the resonant scattering processes when  $l_k + l_k = l_B$ . It is worth mentioning that for  $n_{tot} = 1$  the Ferm imomentum approaches this k from bellow when temperature decreases. We could think of the coe cient  $A_k$  as a measure of the spectral weight for ferm ions. The missing part  $l_k$  is transferred towards some composite objects (mixtures of ferm ions and bosons or ferm ion pairs). Taking into account the fact that for a decreasing temperature  $l_k$  shifts closer and closer to  $l_k$ , we shall thus observe a diminishing spectral weight of ferm ions. This is in agreement with interpretation of the ARPES experimental results [7].






FIG.2. Momentum dependence of the boson coecients X  $_{q}$  (1 ) and  $_{k}^{P}$  Y  $_{q;k}$  (1 ) for the same temperatures as in gure 1. The most ecient renormalization of boson coecients occurs near q 2k.

For a completeness we illustrate also the resulting (l=1) values of the boson coe cients given in (7). Parameter  $X_q$  shows only a small deviation from its initial value 1. This time such a change is most elective for boson momenta close to 2k. It is exactly the same region of the Brillouin zone where the elective boson dispersion shows a kink (see quire 3).

Them issing part of the boson spectral weight is transferred to the ferm ion pairs, as given by the Ansatz (7). Bottom gure 2 shows that  $_k$   $Y_{q,k}$  (which roughly measures the ferm ion pairs spectral weight) changes a lot for q=2k. A gain, if we recall that for a decreasing temperature  $k_F$ ! k we can conclude that there is an increasing probability of nding more and more ferm ion pairs, even though our system is not in the superconducting phase. This is one of possible ways for observing the precursor e ect.




FIG.3. E ective boson dispersion  $E_k$  (l=1) as measured from 2 level for the same set of temperatures as in gure 1. Recall that initially (for l=0 bosons were localized.

In conclusion we studied evolution of ferm ion and boson operators in the BF m odel. During a continuous transform ation which elim inated the exchange interaction we observe transform ation of the initial ferm ion and boson particles into the composite objects. In particular we not that ferm ion (boson) spectral weights at  $k_F$  ( $2k_F$ ) are reduced when temperature decreases. This elect is in an agreement with the recent interpretation of the ARPES measurements for underdoped B i2212 cuprates. To clarify a problem of the quasiparticles life time we need a more detailed study of the correlation functions. Such an analysis is currently under investigation and the results will be published elsewhere.
