# $F$ in ite-size and asym ptotic behaviors of the gyration radius of knotted cylindrical self-avoiding polygons

#### Abstract

Several nontrivial properties are show $n$ for the $m$ ean square radius of gyration $R_{K}^{2}$ of ring poly$m$ ers with a xed knot type K. Through com puter simulation, we discuss both nite-size and asym ptotic behaviors of the gyration radius under the topological constraint for self-avoiding polygons consisting of N cylindrical segm ents w ith radius r . W e nd that the average size of ring polym ers with a knot $K$ can be much larger than that of no topological constraint. The e ective expansion due to the topological constraint depends strongly on the param eter r which is related to the excluded volum e. The topological expansion is particularly signi cant for the sm all r case, where the sim ulation result is associated $w$ ith that of random polygons $w$ th the knot K .

## I. INTRODUCTION

A ring polym er is one of the sim plest system $s$ that have the e ect of topological entanglem ent. The topological state of a ring polym er is given by a knot, and it is xed after the ring polym er is form ed. The entropy of the ring polym er with the xed knot is m uch sm aller than that of no topologicalconstraint. T hus, there should be severalnontrivialproperties in statisticalm echanics of ring polym ers w ith a xed topology. Furtherm ore, som e dynam ical or therm odynam icalproperties of ring polym ers under topological constraints could also be nontrivial. In fact, various com puter sim ulations of ring polym ers $w$ ith xed topology were
 unsolved problem s related to the topological e ect, such as the average size of a knotted ring polym er in solution.

In the paper, we discuss how the excluded volum e controls the topologicale ect on the average size of ring polym ers in good solution. As a m odel of ring polym ers we em ploy a $m$ odel of self-avoiding polygons consisting of cylindrical segm ents $w$ ith radius $r$. Through num erical sim ulation, we investigate the $m$ ean square radius of gyration of cylindrical self-
 the excluded volum e e ect. Thus, we can investigate the topologicale ect system atically through the sim ulation of cylindrical self-avoiding polygons for various values of cylinder radius r.

Let us consider the two cases when the radius r is very large or very small. W hen the radius $r$ is very large, the sim ulation should be related to that of the self-avoiding polygons
 to random polygons w ith a xed topology, as we shall see explicitly through the data. In fact, there is quite an interesting suggestion $[\overline{1} \overline{6}, 1 \overline{1} \overline{1}, 1 \overline{1} \bar{i}]$ that under a topological constraint the average size of ring polym ens w ith no excluded volum e should be sim ilar as that of ring polym ens w th the excluded volum e, since nontrivial entropic repulsion should be derived from the topological constraint. A coording to the suggestion, the average size of random polygons w ith the trivial knot should be given by $N$ saw $w$ th respect to the number $N$ of polygonal nodes, where sAw is the exponent of self-avoiding walks. Thus, the sm all r case of the sim ulation in the paper should be im portant also in the study of the topologicale ect on random polygons.

T he outline of the paper is given in the follow ing. In Sec. II we explain self-avoiding polygons (SAPs) consisting of cylinder segm ents. W e also discuss the e ective exponent of the $m$ ean square radius of gyration under no topological constraint $R^{2}$. In Sec. III, we discuss various nontrivial nite-size properties of the $m$ ean square radius of gyration $R_{R}^{2}$ for cylindricalSA P s w ith a given knot type $K$. The ratio $R_{K}^{2}=R^{2}$ expresses the e ective expansion due to the topological constraint. Through the sim ulation, we nd that the topological $e$ ect is im portant particularly in the $m$ all $r$ case for cylindrical SAPs. Furtherm ore, the e ective topological expansion is controlled by the param eter $r$. In Sec. IV, we discuss the asym ptotic expansion of the ratio $R_{K}^{2}=R^{2}$ with respect to the num ber $N$. F inally, in Sec. $V$, we graphically explain the e ective expansion of the cylindricalSAPs under the topological constraint, through the graphs in the $\mathrm{N} \quad \mathrm{r}$ plane.

## II. CYLINDRICALSELf-AVOID $\mathbb{N} G \operatorname{POLYGONS}$

A. Cylindrical ring-dim erization algorithm and random knots

Let us introduce a m odel of ring polym ers in good solution. W e consider self-avoiding polygons consisting of $N$ rigid im penetrable cylinders of unit length and diam eter $r$ : there is no overlap allow ed for any non-ad jacent pairs ofcylindricalsegm ents, while next-neighboring cylinders $m$ ay overlap each other. $W$ e call them cylindrical self-avoiding polygons or cylindrical SAP s, for short. The cylinder radius r can be related to the sti ness of som e sti polym ers such as D NA s 畒, 'ī

In the sim ulations of the paper, we have constructed a large num ber of cylindrical SA P s by the cylindrical ring-dim erization $m$ ethod [i] 1 ]. The $m$ ethod is based on the algorithm of ring-dim erization [īill, and very useful for generating long self-avoiding polygons (for details, see Ref. [1] [1] ). Here we note that another algorithm is discussed in Ref. [ब-1] for the $m$ odel of cylindrical SA P s, where self-avoiding polygons of im penetrable cylinders with N < 100 are constructed in association w th knotted D NA s [1] $\overline{1}, 1$ rion $]$.

In the cylindrical ring-dim erization $m$ ethod, a statistical weight is given to any selfavoiding polygon successfiully concatenated. Thus, when we evaluate some quantity, we take the weighted average of it with respect to the statistical weight. Som e details on the

how ever, we do not express the statistical weight, for sim plicity.
Let us describe the processes ofour num ericalexperim ents. First, we construct $M$ sam ples of cylindrical SAPs w th $N$ nodes by the cylindrical ring-dim erization $m$ ethod. We put $M=10^{4}$. Here we note that various knot types are included in the $M$ random samples. Second, wem ake knot diagram s for the three-dim ensionalcon gurations ofcylindricalSA P s, by projecting them onto a plain. Then, we calculate two knot invariants $\mathrm{K}_{\mathrm{K}}(1)$ and $\mathrm{V} / \mathrm{K}$ ) for the knot diagram s. Third, we select only such polygons that have the sam e set of values of the two knot invariants, and then evaluate physical quantities such as mean-squared gyration radius for the selected cylindrical SA P s.

The sym bol к ( 1) denotes the determ inant of a knot $K$, which is given by the A lexander polynom ial ( $t$ ) evaluated at $t=1$. The symbol $\mathrm{V}(\mathrm{K})$ is the Vassiliev invariant
 sim ulation of random polygons w ith a large num ber of polygonalnodes. In fact, it has been dem onstrated in Ref. [1-1] ] that the Vassiliev invariant $\mathrm{v}_{2}(\mathrm{~K})$ can be calculated not only in polynom ial tim e but also w ithout using large $m$ em ory area.

## B. Characteristic length of random knotting $\mathrm{N}_{\mathrm{C}}(\mathrm{r})$

For a given knot $K$, we consider the probability $P_{K}(\mathbb{N} ; r)$ that the topology of an $N-$ noded self-avoiding polygon with cylinder radius $r$ is given by the knot type K . We call it the knotting probability of the knot K . Let us assum e that we have $\mathrm{M}_{\mathrm{K}}$ self-avoiding polygons with a given knot type $K$ am ong $M$ sam ples of cylindrical SAP s with radius r. Then, we evaluate the knotting probability $\mathrm{P}_{\mathrm{K}}(\mathbb{N} ; r)$ by $\mathrm{P}_{\mathrm{K}}(\mathbb{N} ; r)=\mathrm{M}_{\mathrm{K}}=\mathrm{M}$.

For the trivial knot, the knotting probability $P_{\text {triv }}(\mathbb{N} ; r)$ for the cylindricalSA $P s$ is given by

Here the estim ate of the constant $C_{\text {triv }}$ is close to 1.0 [1] 1$] . W$ e call $N_{C}(r)$ the characteristic length of random knotting. It is also show $n$ in $R$ ef. [1] $]$ that $N_{C}(r)$ can be approxin ated by an exponential function of $r$ :

The best estim ates of the two param eters $\mathrm{N}_{\mathrm{C}}(0)$ and are given by $\mathrm{N}_{\mathrm{c}}(0)=292 \quad 5$ and $=43: 5 \quad 0: 6: 1$

For several knots, it is shown $\left[\begin{array}{l}\overline{1} \overline{4} \\ \hline 1\end{array}\right]$ that the knotting probability $P_{K}(\mathbb{N} ; r)$ of a knot $K$ is given by

It is num erically suggested in Ref. [1] $\overline{1}$ ] ] that $N_{K}(r)$ should be independent of $K: N_{K}(r)$ $N_{C}(r)$, and also that the constant $C_{K}$ should be independent of the cylinder radius $r$.
C. M ean-squared gyration radius w ith a topological constraint

The $m$ ean square radius of gyration $R^{2}$ of a self-avoiding polygon is de ned by

H ere $R_{n}$ is the position vector of the $n$th segm ent (or the $n$th node) and $<\quad>$ denotes the ensem ble average, which is taken over allpossible con gurations of the self-avoiding polygon.

Suppose that we have M selfavoiding polygons. Then, we evaluate the $m$ ean square radius of gyration $R^{2}$ by the sum $: R^{2}=P_{i=1}^{M} R_{i}^{2}=M$, where $R_{i}^{2}$ denotes the gyration radius of the ith SAPs in the given M SAPs.

Let us de ne the $m$ ean square radius of gyration $R_{K}^{2}$ for such self-avoiding polygons that have a gìven knot type K :

where $R_{K ; i}^{2}$ denotes the gyration radius of the ith self-avoiding polygon that has the knot type $K$. In term $s$ of $R_{K}^{2}, R^{2}$ is given by $R^{2}={ }^{P}{ }_{K} R_{K}^{2} M_{K}=M$.

In $F$ ig. 1, the estim ates of the $m$ ean square radius of gyration $R^{2}$ are plotted against the num ber $N$ of nodes in a double-logarithm ic scale, for the cylindrical SAP s w ith r $=0: 003$ and $r=0: 03$. We may con $m$ the standard asym ptotic behaviors of the $m$ ean-squared gyration radius $\mathrm{R}^{2}$ in F ig. 1. H ere we rem ark on an e ective exponent e , which is de ned through the power-law approxim ation: $R \quad N$ e. It is show $n$ in $[\underline{2} \overline{3} \overline{3}]$ that the estim ate of the e ective exponent e for the cylindricalSAPswith radius r is consistent w ith that of the cylindrical SAW sw ith radius r.
III. FIN ITE-SIZE BEHAVIORSOF R ${ }_{k}^{2}$ FOR SOMEKNOTS

Let us discuss sim ulation results on the $m$ ean square radius of gyration $R_{K}^{2}$ for the cylindrical SAP s w th a knot $K$ and of radius $r$. For two prim e knots (the trivial and trefoil knots) and a com posite knot (the double-trefoil knot, $\left.3_{1}\right] 3_{1}$ ), we have investigated the $m$ ean-squared gyration radius $R_{K}^{2}$ under the topological constraint in the range of the num ber $N$ satisfying $21 \mathrm{~N} \quad 1001$, and for 14 di erent values of cylinder radius r.

The gyration radius $\mathrm{R}_{\mathrm{K}}^{2}$ can approxim ately given by som e power of N . In F ig. 2, doublelogarithm ic plots of $R_{K}^{2}$ versus $N$ are given for the trivial and trefoil knots, $w$ ith tw o values of cylinder radius: $r=0: 003$ and 0.03. W e see that all the double-logarithm ic plots of Fig. 2 to som e straight lines. W e note that for other values of cylinder radius r, several double-logarithm ic plots of $R_{K}^{2}$ versus $N$ are explicitly show in $R$ ef. [2̄3ī1].
$W$ th the number $N$ xed, $R_{K}^{2}$ should increase $w$ ith respect to the radius $r$ for any knot. In $F$ ig. 2, closed squares for $r=0: 03$ are located higher in the vertical direction than closed circles for $r=0: 003$, through the whole range of $N$ both for the trivial and trefoil knots.
A. $R$ atio $R_{K}^{2}=R^{2}$ and the e ective expansion under the topological constraint

Let us now consider the ratio of $R_{K}^{2}$ to $R^{2}$ for a given knot $K$. Ifthe ratio is larger (sm aller) than 1.0 , then the average size of SAPswith the knot $K$ is relatively larger (sm aller) than that of no topological constraint. W e say that the SAPs with the knot $K$ is e ectively $m$ ore (less) expanded. In $F$ ig. 3, the ratio $R_{K}^{2}=R^{2}$ versus the number $N$ is plotted in a double-logarithm ic scale for the trivial and trefoil knots. H ere, we have depicted only the case of $r=0: 003 \mathrm{am}$ ong m any sets of the cylindrical SAP $\mathrm{s} w$ ith the 14 di erent values of cylindrical radius.

For the trivial knot, we see in $F$ ig. 3 that the ratio $R_{\text {triv }}^{2}=R^{2}$ is greater than 1.0 when $\mathrm{N}>50$. Thus, the average size of the ring polym ers w ith the trivial knot en larges under the topological constraint. It gives a typical exam ple ofe ective expansion.

In Fig. 3, the graph of the trivial knot is convex dow nw ards: the ratio $R_{\text {triv }}^{2}=R^{2}$ is alm ost constant w ith respect to N for $s m$ all N such as $\mathrm{N}<100$; for $\mathrm{N}>300$ the ratio $\mathrm{R}_{\text {triv }}^{2}=\mathrm{R}^{2}$ increases w ith respect to N w ith a larger gradient, and the graph can be approxim ated by a power law such as $R_{\text {triv }}^{2}=R^{2} / N{ }_{e}^{\text {triv }}$. H ere the symbol ${ }_{e}^{\text {triv }}$ denotes the e ective exponent
for the trivial knot. W e note that the characteristic length $\mathrm{N}_{\mathrm{C}}(\mathrm{r})$ is approxim ately given by 300 for $r=0: 003$. Thus, we may say that the power law behavior is valid for $\mathrm{N}>\mathrm{N}_{\mathrm{c}}(\mathrm{r})$.

For the trefoil knot, the graph can be approxim ated by a power of $N$ such as $R_{\text {tre }}^{2} / N{ }_{e}^{\text {tre }}$ through the range of $100 \mathrm{~N} \quad$ 1001. Here the sym bol ${ }_{e}^{\text {tre }}$ denotes the e ective exponent of the trefoil knot. In Fig. 3, we nd that when $N<100$ the ratio $R_{\text {tre }}^{2}=R^{2}$ is sm aller than 1.0, while it is larger than 1.0 when $\mathrm{N}>300$. Thus, when N is m all, the topological constraint of the trefoil knot gives e ective shrinking to ring polym ers, while it does not when $N$ is large. For a nontrivial knot $K$, we expect that the ratio $R_{K}^{2}=R^{2}$ is less than 1.0 when $N$ is small, while it can be larger than 1.0 when $N$ is large.
$T$ he properties of the ratio $R_{K}^{2}=R^{2}$ discussed in the last three paragraphs are consistent $w$ th the sim ulation results of aussian random polygons polygons that the double-logarithm ic graph of $R_{K}^{2}=R^{2}$ versus $N$ is given by a dow nward convex curve for the trivial knot, while it is given by a straight line for the trefoil knot and also for other several nontrivial knots; for the nontrivial knots investigated, the ratio $R_{K}^{2}=R^{2}$ is given by som e power of $N$ such as $N{ }_{e}{ }^{K}$. Thus, there are indeed $m$ any im portant properties valid both for the sim ulation of the $G$ aussian random polygons and that of the cylindrical SA P s w ith a sm all radius such as $r=0: 003$.

The observations derived from $F$ ig. 3 should be valid particularly for nite-size system $s$. Adm itting that $N$ is nite, we can only understand that the $G$ aussian random polygons and the cylindrical SA P s have the sim ilar topological properties in com $m$ on. If we discuss asym ptotic behaviors, SA P s and random polygons should be quite di erent. H ow ever, if we consider such properties that are valid for nite $N$, then they can hold both for SAPsw th sm all exchuded volum e and random polygons that have no excluded volum e.

Let us discuss again the convexity of the graph of the trivialknot, which hasbeen observed in $F$ ig. 3. W e consider how the convexity depends on the radius r. In Fig. 4, the graphs of the ratio $R_{\text {triv }}^{2}=R^{2}$ versus $N$ are given in a double-logarithm ic scale for four di erent values of cylinder radius $r$. Then, we see that the graph with $r=0: 05$ is less convex than that of $r=0: 003$. Thus, the convexity in the graphs of the e ective expansion for the trivial knot should be valid only when cylinder radius $r$ is sm all.

Let us assume that the convexity of the graphs of $R_{\text {triv }}^{2}=R^{2}$ for the sm all $r$ case should correspond to a crossover behavior of $R_{\text {triv }}^{2}=R^{2}$ w th respect to $N$. Then, the crossover behavior could be related to that of G aussian random knots, which is recently discussed by

G rosberg [1] $\overline{-1}]$ for $G$ aussian random polygons. W e can discuss the convexity of the doublelogarithm ic graph of $R_{\text {triv }}^{2}=R^{2}$ versus $N$, taking an analogy with the crossover of the $G$ aussian random knots. Thus, we call the convexity of the trivial knot in Fig. 3 the crossover, hereafter in the paper.

For the non-trivialknots investigated, we do not see any crossover in the graph of $R_{K}^{2}=R^{2}$ versus $N$. For instance, for the $4_{1}$ and $\left.3_{1}\right] 3_{1}$ knots, the slope of the graph near $N \quad N_{C}(r)$ is straight in the double-logarithm ic scale. The crossover at $N \quad N_{C}(r)$ should be valid only for the trivial knot.
B. The plateau in the graph of $R_{K}^{2}=R^{2}$ versus $N$ for large $N$
$W$ e discuss how the ratio $R_{K}^{2}=R^{2}$ depends on the num ber $N$, considering both the excluded volumee ect and the e ective expansion due to the topological constraint. In Fig. 5, the graphs of the ratio $R_{K}^{2}=R^{2}$ versus $N$ for di erent values of cylinder radius $r$ are show in linear scales: (a) for the trivial knot; (b) for the trefoil knot.

Let us rst consider the large $N$ behaviors of the graphs show $n$ in $F$ ig. 5 for the trivial and trefoil knots. The graphs of $R_{K}^{2}=R^{2}$ versus $N$ have a com $m$ on tendency that they becom $e$ constant w ith respect to N when N is very large. It is particularly the case for the larger values of cylinder radius $r$ such as $r=0: 03$ and 0.05. They approach horizontal lines at som e large values of $N$. W hen $r$ is sm all such as $r=0: 003$, the graph becom es at only for large $N$, as shown in $F$ ig. 5 .

From the atness of the graphs of $R_{K}^{2}=R^{2}$ for large $N$, it follows that the power law behavior: $R_{\text {tre }}^{2}=R^{2} / N N_{e}^{\text {tre }}$ does not hold when $N$ is very large. In Fig. 3, we have discussed that the ratio $R_{\text {tre }}^{2}=R^{2}$ versus the number $N$ can be approxim ated by the power law for $r=0: 003$ through the range of 100 N 1001. H ow ever, the power-law approxim ation should be valid only within some nite range of $N$.

Let us discuss other nite $N$ behaviors of the ratio $R_{K}^{2}=R^{2}$. For the trefoil knot, the ratio $R_{\text {tre }}^{2}=R^{2}$ is less than 1.0 when $N$ is sm all; it approaches or becom es larger than 1.0 when $N$ is large enough. $W$ hen cylinder radius $r$ is sm all such as $r=0: 003$ and $r=0: 01$, the ration $R_{\text {tre }}^{2}=R^{2}$ is clearly greater than 1.0 when $N$ is large enough. $W$ hen $r$ is sm all, there should be a critical value $N_{\text {critical }}$ such that $R_{\text {tre }}^{2}=R^{2}<1: 0$ for $N<N_{\text {critical }}$, and $R_{\text {tre }}^{2}=R^{2}>1: 0$ for $\mathrm{N}>\mathrm{N}_{\text {critical }}$. Furtherm ore, we have a con jecture that the critical value $\mathrm{N}_{\text {critical }}$ should
be roughly equal to the characteristic length $N_{C}(r)$ of random knotting. It seem $s$ that the con jecture is consistent with the graphs of F ig. 5 (b).

Let us discuss the con jecture on $\mathrm{N}_{\text {critical, }}$ explicitly. In Fig. 5 (b), we see that for $r=0: 003$, the ratio $R_{\text {tree }}^{2}=R^{2}$ becom es 1.0 roughly at $N=300$, and also that for $r=0: 01$, the ratio $R_{\text {tre }}^{2}=R^{2}$ is close to 1.0 roughly at $N=400$. The observations are consistent $w$ th the estim ates of $N_{C}(r)$ in Ref. [ī3], $: N_{c}(r)=(2: 72 \quad 0: 06) \quad 10$ for $r=0: 0$ and $N_{c}(r)=(4: 72 \quad 0: 14) \quad 10$ for $r=0: 01$. Thus, the consistency supports the conjecture on $\mathrm{N}_{\text {critical }}$.
C. D ecrease of the topologicale ect under the increase of the excluded volum e

Thee ect of a topologicalconstraint on the gyration radius decreases when the excluded volume increases. There are two exam ples: the decrease of ratio $R_{K}^{2}=R^{2} w$ th respect to cylinder radius $r$ while $N$ being $x e d$, and the disappearance of the crossover for the trivial knot show n in F igs. 3 and 4.

Let us rst discuss how the excluded-volume can modify the ective expansion due to the topologicalconstraint. A s we clearly se in $F$ ig. 5, the ratio $R_{K}^{2}=R^{2}$ decreases as cylinder radius $r$ increases $w$ ith $N$ xed, both for the trivial and trefoil knots. Thus, the e ective expansion of SAPs under the topological constraint becom es sm aller when the excluded volum e becom es larger.

It is quite nontrivial that the e ective expansion given by the ratio $R_{K}^{2}=R^{2}$ decreases as cylinder radius $r$ increases. In fact, the value of $R_{K}^{2}$ itself increases $w$ ith respect to $r$, as we have observed in Fig. 2. Furtherm ore, one $m$ ight expect that the e ective expansion due to a topologicalconstraint should also increase with respect to cylinder radius $r$, sim $p l y$ because the average size of ring polym ens w ith larger excluded volum e becom es larger, as observed in Fig. 1. H ow ever, it is not the case for the ratio $R_{K}^{2}=R^{2}$.

Let us now discuss the crossover behavior of the trivial knot again, from the view point of the com petition betw een the topologicale ect and the excluded volume e ect. Here we recall that the crossover has been discussed in x3 A w ith $F$ igs. 3 and 4. H ere we regard the crossover as a characteristic behavior derived from the topological constraint of being the trivial knot.

A s a working hypothesis, let us assum e that the crossover should occur at around the
characteristic length $N_{C}(r)$. Recall that $N_{C}(r)$ is larger than 1000 for $r=0: 03$ and 0.05, as we have estim ated: $N_{c}(r) \quad 1200$ for $r=0: 03$, and $N_{C}(r) \quad 2600$ for $r=0: 05$. If the above hypothesis would be valid, then the graphs for $r=0.03$ and 0.05 should also be convex. In Fig. 4, how ever, we see no change in the gradient of the graph of $R_{\text {triv }}^{2}=R^{2}$ versus $N$ for $r=0: 03$ or 0.05 . The assum ed crossover of the trivial knot does not appear for $r=0.03$ or 0.05. W e m ay thus consider that the crossover as a topologicale ect is dim inished by the excluded volumee ect when $r$ 0:03.
D. C haracteristic length of random knotting $N_{C}(r)$ and the e ective expansion

In term sof the characteristic length $N_{c}(r)$, we can explain som e properties of the ective expansion of cylindrical SA P s under a topological constraint. H ere we recall that the ratio $R_{K}^{2}=R^{2}$ describes the degree of the e ective expansion under the topological constraint of a knot K .

W e rst consider the case when the characteristic length $N_{C}(r)$ is very large. Let us show that the ratio $R_{\text {triv }}^{2}=R^{2}$ should be close to 1.0 for $N \quad N_{c}(r)$. First, we recall that the probability $P_{\text {triv }}(\mathbb{N})$ of the trivial knot decays exponentially $w$ ith respect to the num ber $N$ of polygonal nodes: $\mathrm{P}_{\text {triv }}(\mathbb{N})=\exp \left(\mathrm{N}=\mathrm{N}_{\mathrm{C}}(\mathrm{r})\right)$. If $\mathrm{N}=\mathrm{N}_{\mathrm{C}}(\mathrm{r})$ is very sm all, the probability $P_{\text {triv }}(\mathbb{N})$ is close to 1.0 , ie., alm ost all SA P s have the trivial knot. Then, the $m$ ean-squared gyration radius with no topological constraint $R^{2}$ should be alm ost equal to that of the trivial knot $R_{\text {triv }}^{2}$. C onsequently, the ratio $R_{\text {triv }}^{2}=R^{2}$ should be close to 1.0.

W hen $r \quad 0: 05$, the characteristic length $N_{C}(r)$ is larger than 2600. Then, the trivial knot is dom inant am ong the possible knots generated in SAPsw ith $N<1000$. Thus, $R_{\text {triv }}^{2}$ should alm ost agree w ith $R^{2}$, which is the $m$ ean-squared gyration radius of SA $s$ under no topologicalconstraint. There is no e ective expansion under the topological constraint: the $R_{\text {triv }}^{2}=R^{2}$ is close to 1.0 .

Let us next consider the case when the characteristic length $N_{c}(r)$ is sm all or not large. $T$ hen we show that the $m$ ean square radius of gyration of SAP s w th the trivial knot $\mathrm{R}_{\text {triv }}^{2}$ should be larger than that of no topological constraint $R^{2}$ for $N>N_{C}(r)$. In fact, various types of knots can appear in a given set of random ly generated SA P s of the cylinder radius $r$, since the probability of the trivial knot $P_{\text {triv }}(\mathbb{N})$ is exponentially sm all for $N>N_{c}(r)$. W e note that the fraction of nontrivial knots is given by $1 \exp (\mathrm{~N}=\mathrm{N}(\mathrm{r})$ ). Thus, it is not
certain whether the ratio $R_{\text {triv }}^{2}=R^{2}$ is close to the value 1.0 or not. H ow ever, we m ay expect that the ratio $R_{\text {triv }}^{2}=R^{2}$ should be indeed larger than 1.0. H ere we consider the follow ing points: when $N>N_{C}(r)$, the $m$ ajorty of SAP s generated random ly should have $m$ uch $m$ ore com plex knots than the trivial knot; the $m$ ean square radius of gyration of $N$-noded SA P s w ith a very com plex knot should be much sm aller than that of the trivial knot.

The explanation on thee ective expansion discussed in the above is com pletely consistent w ith the sim ulation results, as having been discussed in x3, in particular, through Figs. 3, 4 and 5.
IV. ASYMPTOTIC BEHAVIORSOF R ${ }_{K}^{2}$
A. $T$ he exponent of $R_{K}^{2}$

Let us discuss an asym ptotic expansion for the $m$ ean square radius of gyration of cylindrical SAPswith a given knot $K$. Here we assume that $R_{K}^{2}$ can be expanded in term $s$ of $1=\mathrm{N}$ consistently w ith renorm alization group argum ents. Then, the large N dependence of $R_{K}^{2}$ is given by

\end{equation*}
$$

Here, the exponent k should be given by that of self-avoiding walks: $\mathrm{K}_{\mathrm{k}}=$ sAw . In order to analyze the num erical data system atically, how ever, we have introduced $к$ as a tting param eter. Thus, for the ratio $R_{K}^{2}=R^{2}$, we have the follow ing expansion:

R_{K}^{2}=R^{2}=\left(A_{K}=A\right) N^{2}{ }^{\mathrm{K}} 1+\left(B_{K} \quad B\right) N \quad+O(1=N)^{i}: \tag{7}
\end{equation*}

Here we have put $\quad$ к as a tting param eter.
W e have analyzed the data for the three di erent knots: the trivial, trefoil and $313_{1}$ knots, applying the expansion ( ( $\bar{i})$ to the num erical data of $R_{K}^{2}=R^{2}$ for $N \quad 300$. The best estim ates of the three param eters are given in Tables 1, 2 and 3 for the trivial, trefoil and $\left.3_{1}\right] 3_{1}$ knots, respectively.

Let us discuss the best estim ates of the di erence of the exponents: $\quad$. $W$ e see in Tables 1,2 and 3 that all the results of $\quad$ suggest that they should be given by 0.0 , w th respect to the con dence interval. Let us exam ine the best estim ates m ore precisely. It is
rather clear from Tables 1, 2 and 3 that for a given cylinder radius $r$, the best estim ates of к are independent of the knot type.

There is another evidence supporting that $\quad$ к $=0: 0$ for the trivial and trefoil knots. Let us consider the plots of the ratio $R_{K}^{2}=R^{2}$ versus $N$ in $F$ ig. 5 for the trivial and trefoil knots. W e recall that the graphs are likely to approach som e horizontal lines at som e large $N$. The tendency of the graphs becom ing at for large $N$ suggests that $R_{K}^{2}$ and $R^{2}$ should have the sam e exponent, i.e., sAW .

From the two observations, we conclude that the di erence of the exponents is given by 0.0: $\quad$ к $=0: 0$ for any value ofr. There is thus no topologicale ect on the scaling exponent de ned in the asym ptotic expansion of $\mathrm{R}_{\mathrm{K}}^{2}$.
B. Amplitude ratio $A_{K}=A$

Let us now consider the am plitude $A_{K}$ of the asym ptotic expansion ( $\bar{\eta}_{1}$ ). In Tables 1, 2 and 3, the best estim ates of the ratio $A_{K}=A$ are larger than 1.0 for the three knots, when $r$ is $s m$ all. $T$ he observation $m$ ust be im portant. In fact, if the am plitude ratio $A_{K}=A$ is larger than 1.0 in the asym ptotic expansion ( $(\bar{i})$, then $R_{K}^{2}$ is larger than $R^{2}$ for any large value of $N$. It $m$ ight sem that the consequence is against the standard them odynam ic lim it of statisticalm echanics.

H ow ever, there is a clear evidence for the observation that $A_{K}=A>1: 0$ for som e sm all values ofcylinder radius r. In fact, the graphs of the ratio $R_{K}^{2}=R^{2}$ versus $N$ arem onotonically increasing w ith respect to $N$, as we see in $F$ igs. 3, 4 and 5. It is clear that the graphs $w$ ith the sm aller values of cylinder radius $r$ are larger than 1.0 when N is large. This observations off igs. 3, 4 and 5 con $m$ that $A_{k}=A>1: 0$ when cylinder radius $r$ is sm all. $T$ hus, we $m$ ay conchude that the topological constraint gives an e ective expansion also to asym ptotically large cylindrical SA P s when the radius $r$ is $s m$ all
$T$ he value of $A_{K}=A$ decreases $w$ ith respect to the radius $r$ for the three knots. $W$ e see it in Tables 1 to 3, where the best estim ates of $A_{K}=A$ are listed. It is also consistent $w$ ith the fact that the ratio $R_{K}^{2}=R^{2}$ decreases w ith respect to $r$, which we have discussed in x3.C . H ow ever, the decrease of $A_{K}=A$ is quite nontrivial, since the $m$ ean-squared gyration radius $R_{K}^{2}$ itself increases $w$ ith respect to $r$, for the trivial and trefoil knots, as shown in $F$ ig. 2. H ere we recallin $F$ ig. 1 that the gyration radius under no topological constraint $R^{2}$ increases
$w$ th respect to $r$.
From the view point of asym ptotic behaviors, we have shown that the ective expansion derived from the topological repulsion decreases $w$ th respect to cylinder radius $r$. $W$ e have also discussed that $R_{K}^{2}$ is larger than $R^{2}$ for any large value of $N$, when cylinder radius $r$ is sm all.

## C. The r-dependence of the am plitude ratio

Let us discuss the $r$ dependence of the amplitude ratio $A_{K}=A, m$ ore quantitatively. For this purpose, we analyze the data of $R_{K}^{2}=R^{2}$ versus $N$ again, assum ing $k=$ in eq. (彳亍) . W e evaluate the am plitude ratio $A_{K}=A$ by the follow ing form ula:

Here we have replaced with $k$ and $k, A_{K}=A$ and $B_{K} \quad B$ in '(i), respectively. Here we have also introduced a technical assum ption: $={ }_{\mathrm{K}}=0.5$ in ( (i) $_{1}$ ).

W e have obtained the num erical estim ates of $к$, applying the tting form ula '( $(\mathrm{B})$ to the data of $R_{K}^{2}=R^{2}$ with $N \quad 300$. The estim ates of $k$ versus $r$ are show in $F$ ig. 6 in the double-logarithm ic scale for the trivial, trefoil, and $\left.3_{1}\right] 3_{1}$ knots. To be precise, the values of ${ }_{k}$ are a little larger than those of $\mathrm{A}_{\mathrm{K}}=\mathrm{A}$ given in $\mathrm{Tables} 1,2$ and 3.
$T$ he estim ate of the param eter $к$ becom es close to the value $1.0 \mathrm{when} \mathrm{cylinder} \mathrm{radius} r$ is large enough. Furtherm ore, it is suggested from Fig. 6 that к should be independent of the knot type. In fact, the data points for the trivial, trefoil and the double-trefoil $\left(3_{1} \# 3_{1}\right)$ knots overlap each other. T hese tw o observations are consistent $w$ th the sim ulation result of the self-avoiding polygons on the lattice [īi, in in in .

Interestingly, we see in Fig. 6 that the ratio k decreases $m$ onotonically with respect to the cylinder radius $r$. For the data with 0:001 r 0:01, we nd that ${ }_{k}$ is roughly approxim ated by a decreasing function ofr such as $k=0 r \exp (r)$, with $0=1.00 \quad 0.12$, $=-0.05 \quad 0.02$ and $=5.78 \quad$ 4.79. $T$ he ${ }^{2}$ value is given by 1 .

## V. D ISC U SSIO N

W th some graphs in the $N$ r plane, we can illustrate the nite-size behaviors of the ratio $R_{K}^{2}=R^{2}$ discussed in $x 3 . W$ e recall that the topologicale ect has played a central role
as well as the exchuded-volum e e ect. Thus, we consider two lengths with respect to the num ber $N$ of polygonal nodes: the characteristic length of random knotting $\mathrm{N}_{\mathrm{C}}(\mathrm{r})$ and the \excluded-volum e length" $N_{\text {ex }}(r)$. W hen $N>N_{\text {ex }}(r)$, the excluded-volum ee ect should be im portant to any N -noded SAP w ith radius r .

W e de ne $\mathrm{N}_{\mathrm{ex}}(\mathrm{r})$ by $\mathrm{N}_{\text {ex }}(\mathrm{r})=1=\mathrm{r}^{2}$. The derivation is given in the following. W e rst note that the param eter $z$ of the excluded-volum e is given by $z=C$ onst: ${ }^{p} \bar{N} B={ }^{3} / N^{1=2} r$, where the cylindrical segm ents have the diam eter $d$ and the length ', and the second virial coe cient B of a polym er chain is given by $\left.{ }^{2} d \underline{\underline{2}} \overline{\underline{D}}\right]$. Here we also note that the ratio $d=$ ' corresponds to the radius r of the cylindrical SA P S. W em ay consider that when $z \quad 1$, the exchuded volum e can not be neglected. T hus we have the num ber $\mathrm{N}_{\mathrm{ex}}(\mathrm{r})$ from the condition: $\mathrm{P} \overline{\mathrm{N}_{\mathrm{ex}}(\mathrm{r})} \mathrm{r}=1$.
$W$ e consider two graphical lines in the $N \quad r$ plane: $N=N_{e x}(r)$ and $N=N_{C}(r)$. In $F$ ig. 7, the vertical line of the diagram expresses the r -axis and the horizontal one the N -axis. The graph $N_{C}(r)=N$ reaches the $N$ axis at $N=N_{C}(0) \quad$ 300. Here we recall that the function $N_{C}(r)$ is given by eq. (2̄) $: N_{C}(r)=N_{C}(0) \exp (r)$. There is a crossing point for the two curved lines. The coordinates of the crossing point is approxim ately given by $\mathrm{N}=1300$ and $r=0: 03$. For a given sim ulation of the ratio $R_{K}^{2}=R^{2} w$ ith a xed radius $r$, we have a series of data points located on a straight line parallel to the N axis.

Let us rst consider the case ofsm all values ofr such as $r=0: 003$ and $r=0: 01$. From the sim ulation of $x 3$, it is shown that the e ective expansion due to the topological constraint is large. This is consistent with the follow ing interpretation of the $\mathrm{N} \quad \mathrm{r}$ diagram : if we start from the region near the $r$ axis and $m$ ove in the direction of the $N$ axis, then we cross the line $N=N_{C}(r)$ before reaching another one $\bar{N} \bar{r}=1$; thus, we expect that the exchuded-volum e rem ains sm all when the topologicale ect becom es signi cant.

The above explanation should be consistent w ith the observation that the crossover of the trivial knot occurs near $\mathrm{N}=\mathrm{N}_{\mathrm{c}}(\mathrm{r})$ for sm all values of r . H ere we recall F igs. 3 and 4 . $W$ hen $r$ is very $s m a l l$, then we cross the line of $N_{c}(r)=N$ alm ost at $N_{c}(0) 300$.
$W$ hen radius $r$ is large such as $r=0: 03$ and 0.05 , it is shown in $x 3$ through simulation that the e ective expansion is sm all: the ratio $R_{\mathrm{K}}^{2}=R^{2}$ is close to 1.0. In the $N \quad r$ diagram, when we m ove rightw ards from the region near the $r$ axis $w$ ith $r$ xed, we cross the line ${ }^{\mathrm{P}} \overline{\mathrm{N}} \mathrm{r}=1$ before reaching another line $\mathrm{N}_{\mathrm{c}}(\mathrm{r})=\mathrm{N}$. Thus, the e ective expansion as the topologicale ect should be sm all.

Finally, we should rem ark that som e im portant properties of $R_{K}^{2}$ of cylindricalSA P sw ith radius $r$ have been discussed system atically through scaling argum ents w ith the blob picture
 param eter z are explicitly discussed in the $\mathrm{N} \quad \mathrm{r}$ diagram s . It would thus be an interesting future problem to investigate how far the predicted properties of $R_{K}^{2}$ are consistent $w$ th simulation results.
