D om ain structure of superconducting ferrom agnets

In superconducting ferrom agnets the equilibrium dom ain structure is absent in the M eissner state, but appears in the spontaneous vortex phase (them ixed state in zero externalm agnetic eld), though with a period, which can essentially exceed that in norm al ferrom agnets. M etastable dom ain walls are possible even in the M eissner state. The dom ain walls create m agnetostatic elds near the sam ple surface, which can be used for experim ental detection of dom ain walls.

Recently there has been a growing interest to materials, in which superconductivity and ferrom agnetism coexist [1{5]. A number of unusual phenomena and structures have been predicted and observed, spontaneous vortex phase as an example [6,7]. But the theory mostly addressed macroscopically uniform structures, whereas ferrom agnetic materials, even ideally uniform, inevitably have a domain structure, which is a ground-state property of ferrom agnets. So a further progress in studying materials with coexisting ferrom agnetism and superconductivity requires an analysis of the domain structure. The present work is the state propint this direction.

An object of the study is a material, in which the magnetic transition occurs earlier, i.e. at a higher tem perature, than the superconductivity onset. This was called \superconducting ferrom agnet" [7], in contrast to \ferromagnetic (or magnetic) superconductors" where the superconductivity sets in before the magnetic transition, which have been studied mostly in the past [8]. Com petition of ferrom agnetism and superconductivity m ay result in various structures with the magnetic moment rotating in space (spiral structures, cryptoferrom agnetism and so on). This also can be considered as a \dom ain structure", but with a period determ ined by intrinsic properties of materials. However, our goal is the domain structure due to magnetostatic elds generated by nonzero average bulk magnetization ${\tt M}$. In this case the domain size depends on a sam ple size. W e shall consider type-II superconductivity, bearing in m ind ruthenocuprates [1,4,5], which are type II high- T_c superconductors.

Before analyzing the dom ain structure it is useful to sum marize the magnetic properties of a single-dom ain superconducting ferrom agnet. The total free energy of the superconducting ferrom agnet can be written as [7]

where is the London penetration depth and B is the magnetic induction. The energy $f_E (M; r M)$ is the exchange energy, which depends on the absolute value of M and on gradients of M. As a rule [9], in magnetic materials this is the largest energy, which xes M. The anisotropy energy K (M = M) is smaller and depends on

the direction of M. We shall consider a stripe m agnetic structure, which is possible only if K essentially exceeds the m agnetostatic energy M^2 [9]. The latter is determined by the magnetic eld H = B + 4 M [the third term in Eq. (1)]. The expression Eq. (1) includes also the kinetic energy related to the superconducting current !

where $_0$ is the magnetic-ux quantum, ' is the phase of the superconducting order parameter, and the vector potential \tilde{A} determ ines the magnetic induction $\tilde{B} = \tilde{r}$

A. The kinetic energy of superconducting currents is absent in a norm al ferrom agnet.

M inimization of the energy with respect to the vector potential A yields the M axwell equation

Together with the equation

this yields the London equation which determ ines B:

Here we took into account that $\tilde{r} = 0$ inside domains. In contrast to Ref. [7], we neglect the di erential susceptibility (M does not depend on a magnetic eld), which renormalizes the London penetration depth.

These equations and the boundary conditions at the sample boundary (continuity of the tangential component of \mathbf{H} and of the norm alcomponent of \mathbf{H}) yield the distribution of \mathbf{H} and \mathbf{H} . This distribution is shown in Fig. 1 for the case of \mathbf{M} parallel to the sample boundary and for zero external magnetic edd. The magnetic induction and the related magnetic ux exist only in the layer of the thickness . Meissner currents in this layer screen the internal edd 4 \mathbf{M} , as well as they screen the external magnetic superconductor.

Let us consider now the mixed state of the superconducting ferrom agnetic, in which vortices (m agnetic uxons) are present in the bulk. Since ferrom agnetism does not a ect the London equation (5), one expect the sam e m agnetic-induction distribution in the m ixed state as for nonm agnetic type II superconductors [7], and the free energy is given by

where F_0 (B) is the free energy of a nonmagnetic type II superconductor, and B' now is the magnetic induction averaged over the vortex-array cell. The energy F_0 (B) contains both the magnetic energy B²=8 and the kinetic energy of the superconducting currents inside the vortex cell. D eterm ining the magnetic eld

we see that the magnetization curve of a superconducting ferrom agnet is described by $B = B_0 (\dagger T + 4 M \dagger)$ where B₀(H) is the equilibrium magnetization curve for a nonm agnetic type II superconductor [7] (Fig. 2a). Note that in this relation the magnetic eld H has a di erent physical meaning from that used in the Meissner state. For the M eissner state we introduced $\mathbf{H} = \mathbf{B}$ 4 M~, where the moment M originates from \molecular" currents responsible for ferrom agnetism, the superconducting currents being treated as external currents. In the m ixed state, which is considered now, it is more convenient to de nether agnetic eld as $\mathbf{H} = \mathbf{B} + \mathbf{M} + \mathbf{M}_{s}$, i.e. the de nition includes also the diam agnetic m om ent $M_s = (B_0 \quad H) = 4$ of the superconducting currents circulating around vortex lines in the mixed state. Thus these currents are treated in the sam e m anner as m olecular currents responsible for ferrom agnetism .

Figure 2b show s that in a superconducting ferrom agnet the M eissner state (B = 0) exists until H + 4 M < H $_{\rm cl}$, where H $_{\rm cl}$ = ($_0$ = 2) ln (=) is the lower critical eld in a nonmagnetic superconductor and is the coherence length, which determines the vortex core size. So ferrom agnetism decreases the lower critical eld H $_{\rm cl}$ = H $_{\rm cl}$ 4 M . If 4 M > H $_{\rm cl}$, the M eissner state is absent (Fig. 2c) and the superconducting ferrom agnet is in the mixed state with vortices penetrating into it even in zero external eld H = 0. This is spontaneous vortex phase with nonzero magnetic induction B = B $_0$ (4 M) in the bulk.

Now let us consider form ation of the dom ain structure in the standard geometry [9]: a slab of the thickness d along the anisotropy easy axis y and in nite in directions of the axes x and z (Fig. 3). We start from a normal ferrom agnet. In the absence of an external magnetic

eld the average m agnetic induction inside the slab m ust vanish. Therefore, B = 0 in a single-dom ain structure (Fig. 3a), and there exists an uniform m agnetostatic eld H = 4 M in the entire sample, an analog of the electrostatic eld in a charged plane capacitor. This results in a high m agnetostatic energy H²=8 M². How ever, the domain structure with period 1 (1 d) suppresses this energy in the domain bulk: H 0 and B = 4 M, except for the area \hat{f} near the sam ple boundary (Fig. 3b). But the average induction still vanishes, since M changes its sign from a domain to a domain. For the stripe structure one can solve the equations of magnetostatics, \tilde{r} H = 0 and \tilde{r} H = 4 M, exactly [9,10]. Here M = \tilde{r} M is the magnetic charge. The magnetostatic energy per unit volume of the slab is

This energy is by a factor 1=d less than the magnetostatic energy in a single-dom ain structure. However, the dom ain walls increase the energy. The energy of one domain wall (per unit length along the slab) is K d, where

is the wall thickness and the num erical factor depends on the detailed de nition of K and . Its speci cation is not essential for the present analysis. The dom ain-wall energy per unit volume of the sample is

The equilibrium value of the period 1 is determined by minimization of the energy $E_w + E_s$ [9]:

Let us return back to a superconducting ferrom agnet. In the M eissner state the m agnetic induction m ust vanish in the bulk, which is compatible only with the singledom ain structure. Thus the equilibrium dom ain structure is impossible in the Meissner state. However, domainswith the changing direction of M can appear in the spontaneous vortex phase with nonzero $B = B_0 (4 M)$. Like in a norm al ferrom agnet, the magnetic ux / B in dom ains should produce the magnetostatic elds in the i, but in a superconducting ferrom agnet these area elds are by the factor B_0 (4 M)=4 M sm aller. We can take it into account introducing the e ective magnetization $M^{\sim} = B_0 (4 \text{ M})=4$. Then the period of the domain structure is given by Eq. (10), where M must be replaced with M. In the limit of large 4 M H _{c1}, one has M ! M and the e ect of superconductivity on the dom ain structure vanishes. In the opposite lim it of smallM, when 4 M ! H_{cl}, M vanishes and the period l becom es in nite, as it should be in the M eissner state 4 M < H_{c1}. However, this calculation of lassumes that the penetration of the magnetostatic eld into a superconducting ferrom agnet is sim ilar to the penetration into a norm al ferrom agnet. The assumption is correct if rigidity of the vortex array is negligible and the e ective penetration depth is in nite. We can also consider the opposite lim it of a very rigid vortex array, when the magnetostatic elds penetrate only into the layer of the

thickness . If 1, the penetration of the magnetic ux into a superconductor becomes insigni cant. This increases the magnetic elds outside the sample, as well as the totalm agnetostatic energy, by a factor of 2, while the correspondingly period 1 decreases by a factor of $\frac{1}{2}$ (Fig. 3c), in analogy with the e ect of a superconducting substrate on a dom ain size in a ferrom agnetic slab [10]. Thus avoiding a detailed analysis of the vortex and eld pattern in the dom ains close to the sam ple border we lose only a num erical factor of not more than $\frac{1}{2}$. In any case, superconductivity, which coexists with ferrom agnetism in the sam e bulk, always increases the dom ain size, in contrast to the superconductor-ferrom agnet bilayer, where superconductivity shrinks ferrom agnetic dom ains [10].

The absence of the equilibrium domain structure in the M eissner state does not rule out a possibility of m etastable domain walls, as topologically stable planar defects. D om ains can appear also because of disorder, or grain structure. The structure of the domain wall should be found by solution of the coupled equations of m agnetostatics and the London electrodynam ics. W e restrict ourselves to the simplest case, when the London penetration depth essentially exceeds the domain wall thickness . This means that at the spatial scales of order

the dom ain-wall structure is governed by large energies [the exchange energy and the anisotropy energy, see Eq. (1) and is not a ected by the magnetostatic and kinetic energy. On the other hand, at scales one can nd the distribution of B and H from the London equation at constant M . This is shown for the B loch dom ain wall (the magnetization ${\tt M}^{\sim}$ rotates in the plane of the wall and does not produce the magnetostatic charges) in Fig. 4a. Though our picture corresponds to a 180 wall, a similar picture is expected for any domain wall. The jump of the tangential component of the moment M at the wall de nes the current sheet, responsible for a jump of the magnetic induction parallel to the wall, whereas a possible jump of the norm alcomponent of M (a \charged" dom ain wall) would produce a jump of the normal component of the eld H.

The magnetic ux on the opposite sides from the domain wall creates the magnetostatic elds outside the sample, where the wallmeets the sample boundary (Fig. 4b). The magnetic uxes, which exit from the sample at two sides from the wall, are equal in magnitude (4 M per unit length along the wall) but opposite in direction. The magnetostatic eld from domain walls could be used for their experimental detection. At distances r from a line, where the wall exits to the sample boundary, this eld is a dipole eld of the order of $M^2 = r^2$.

In summary, the letter presents the rst analysis of the domain structure in superconducting ferrom agnets. There is no equilibrium domain structure in a superconducting ferrom agnet in the M eissner state. In the spontaneous vortex phase the period of the domain structure m ay essentially exceed that in the norm al ferrom agnet. But m etastable dom ain walls can exist even in the M eissner state. They generate the m agnetic ux in layers of a thickness , which can be revealed by m agneto-optical m ethodic.




FIG.1. Magnetic induction B (solid line), magnetic eld H (dashed line), and 4 M (dotted line) at the boundary between a superconducting ferror agnet (x < 0) and vacuum (x > 0).




FIG.2. M agnetization curve: a) nonmagnetic type-II superconductor; b) superconducting ferrom agnet, 4 M < H $_{\rm cl}$; c) superconducting ferrom agnet, 4 M > H $_{\rm cl}$.




FIG.3. Dom ain structure in norm al and superconducting ferrom agnets. The thick arrows show directions of the m agnetic m om ent M , the thin lines with arrows are force lines of the m agnetostatic eld H. The m agnetic charges are show n by + and -. a) A single-dom ain structure. In the whole bulk B = 0 and H = 4 M . b) A stripe dom ain structure in a norm al ferrom agnet. The m agnetostatic elds are present in areas 1^2 inside and outside the sam ple. In the rest parts of dom ains H = 0 and B = 4 M . c) A superconducting ferrom agnet in the spontaneous vortex phase with a rigid vortex array. The m agnetostatic elds appear only in areas 1^2 outside the sam ple. In the bulk of dom ains H = 0 and B = B₀ (4 M).




FIG.4. Dom ain wall in the M eissner state: a) M agnetic induction B (solid line), m agnetic eld H (dashed line), and 4 M (dotted line) near the dom ain wall in the superconducting ferror agnet. b) M agnetic ux lines around the exit of the dom ain wall (of thickness) to the sam ple surface.
