C lassical heisenberg antiferrom agnet away from the pyrochlore lattice lim it: entropic versus energetic selection

The stability of the disordered ground state of the classical Heisenberg pyrochlore antiferrom agnet is studied within extensive M onte C arlo simulations by introducing an additional exchange interaction J^0 that interpolates between the pyrochlore lattice ($J^0=0$) and the face-centered cubic lattice ($J^0=J$). It is found that for $J^0=J$ as low as $J^0=J=0.01$, the system is long range ordered: the disordered ground state of the pyrochlore antiferrom agnet is unstable when introducing very small deviations from the pure $J^0=0$ limit. Furthermore, it is found that the selected phase is a collinear state energetically greater than the incommensurate phase suggested by a meaneld analysis. To our knowledge this is the level of the production of the energetic one.

I. INTRODUCTION

In recent years, there has been a great interest in the study of fully frustrated Heisenberg antiferrom agnets (HAF), both from the experim ental and theoretical point of view 1,2. These systems often show unconventional ground-states, noncollinear, incom m ensurate3 or disordered4. In these systems, the classical Mean Field (MF) description indicates a macroscopic ground-state degeneracy and no long range order is predicted. This property is directly related to the extensive number of degrees of freedom that still uctuate at low temperature⁵. Nevertheless, in many cases, thermalor quantum uctuations give rise to an entropic selection within the ground state m anifold, known as \order by disorder "6. This phenom enon m ay induce a selection of a subset of the continuous degenerate ground states as it does for the kagom e antiferrom agnet⁷, and som etim es can even select a particular ground state as it is the case for the face centered cubic (fcc) antiferrom agnet8.




FIG. 1: The pyrochlore lattice.

Am ong these systems, the 3D pyrochlore lattice is of particular interest since it does not display such \order by disorder" and remains disordered down to zero tem perature 5,6,9 . It consists in a three dimensional ar– rangement of comer-sharing tetrahedra (see Fig. 1). All m agnetic com pounds which cristallize in the pyrochlore structure exhibit unusual magnetic properties. A few order at well de ned Neel tem perature³ while many of them behave as spin glasses despite the high degree of stoichiom etry4. In the Heisenberg antiferrom agnetic S = 1=2 quantum case, the pyrochlore lattice exhibits no magnetic transition even at T = 0K, and behaves as a spin-liquid. The spin-spin correlation length never exceeds the inter atom ic distance and it is expected that there is a continuum of singlet states within the singlettriplet gap^{11} . For classical H eisenberg sp in s, M onte C arlo

simulations have shown that the pyrochlore HAF also behaves as a spin-liquid, with short ranged spin correlations both in space and time 5,9 , which allows for its description to take into account only the tetrahedral unit $\operatorname{cell^{10}}$. The exactly solvable in nite-component spin vectorm odel on the pyrochlore lattice also does not order down to zero temperature 12 . Classical models providing much informations close to the characteristics obtained in the quantum case, it indicates that the low-energy physics in the pyrochlore structure is mainly related to the geometry of the lattice.

An interesting aspect of the problem is to study how this disordered classical ground-state resists to perturbations as it could enlarge its observation in real compounds. It has been shown that ordering is very easily induced either by including further neighbour interaction 13,14 or easy plane anisotropy 5,15 or lattice deform ations 16 . The purpose of this paper is to explore

the e ect of coupling the spins of the pyrochlore net to the remaining nearest-neighbor (nn) spins in the fcc net via standard classical Monte Carlo (MC) calculations. The question is wether the system will select an ordered state when switching on this coupling or maintain disorder as in the pyrochlore HAF. As obtained in previous works, an energetic comparison of all magnetic phases at the MF level already lifts the degeneracy and strongly supports that any deviations from the pyrochlore limit will drive the system to an ordered state (sec. II). But strikingly, it is shown that thermal uctuations do not select the expected mean eld ground state but prefer a collinear phase which is more stable from the entropic point of view (sec. III).

II. FROM THE PYROCHLORE LATTICE TO THE FCC LATTICE : THE J J O M ODEL




FIG. 2: The J $\,$ J 0 n.n. fcc lattice. The fcc lattice is decomposed into two pyrochlore nets: A sites (plain lines) and B sites (dashed lines). J couples A Ann. sites (plain lines) while J 0 couples B Bnn. sites (dashed lines) and A Bnn. sites (not drawn for clarity). This model contains 8 sites per unit cell.

In both fcc and pyrochlore lattices, the classical energy is m in im ized by any con guration for which the total spin of each elementary tetrahedron in the lattice is zero. The main di erence in the ground-states of these two lattices com es from the fact that in the foc net the ordering at one tetrahedron will select a unique global ordering, while in the pyrochlore net, since the tetrahedra are m ore sparsely connected, there rem ains an extensive number of degrees of freedom 5 . In the fcc HAF, the MF ground-states are degenerate along the =a(1;q;0) direction in reciprocal space. Therm al uctuations break this degeneracy and select the collinear ordered phase $q_0 = (=a;0;0)^8$. These results have been con rm ed by standard M onte C arlo sim ulations 17 which show evidence for a rst order phase transition. In the pure pyrochlore HAF, the MF ground-states are degenerate throughout the entire Brillouin zone. Num erical works have shown that no long-range order occurs at nonzero term perature in that case, even in a regime where the temperature is below the energy scale set by interaction^{5,9}. In between where J couples the n.n. spins on a pyrochlore net and J⁰ the remainder n.n. spins on the underlying foc net (see Fig. 2). This leads to the following classical Heisenberg ham iltonian:

where S_i is a vector spin of unit length occupying the i^{th} fcc lattice site, i and i^0 design sites on two pyrochlore nets shifted by (2a;0;0) respectively and the sum s <> run over n.n. pairs. We have limited our study to the antiferrom agnetic case, i.e. all negative interactions. $J=J^0<0$ corresponds to the fcc HAF and $J^0=0$, J<0 leads to the pyrochlore HAF. The cubic lattice constant is 2a.

We have rst studied the MF ground-states degeneracy for small = $J^0=J$. One way to do so is to compute the Fourier transform of the interactions on the lattice,




FIG. 3: Largest eigenvalue $_{\text{m ax}}$ (q)=jJ j along the high sym-m etry axis of the fcc B rillouin zone for = 0.01 < $_{\text{c}}$ 0.21.

 J_q . The ground-state (ifunique) then corresponds to the highest eigenvalue $_{m\ ax}\ (q_1)$ of J_q and is described by the propagation vector $q_1^{\ 18}$. For the J J^0 m odel, J_q is a 8 8 m atrix that has already been calculaited by R eim ers et al. 13 .

For $0 < c_0$ 0.21, we have reported the largest eigenvalue $_{m \text{ ax}}$ (q)=jJjalong the high sym m etry axis of the fccBrillouin zone on gure 3. The degeneracy is completely lifted and $_{m \text{ ax}}$ (q) has an absolute maximum q1 along the (0;q;q) direction, selecting an incommensurate phase of wave vector q1. Within the MF approximation the J J model selects an ordered phase for $0 < c_0$.

For $_{\text{c}}$, the situation is very similar to the fcc case. The MF degeneracy is lifted except on lines along =a(1;q;0) direction: the system remains disordered in that case.

We have reported in gure 4 the MF energy dierence E=jJ j between the two ground states: the q_1 incommensurate state and the =a(1;q;0) states (including the q_0 collinear state) as a function of . We see that E=jJ is much lower than the energy scale set by the interaction (E=jJj =100). Thus the degeneracy is very




FIG. 4: MF energy di erence 10^3 E = jJjbetween the two MF ground-states as a funtion of (E = E (q₁) E (q₀), see text).

slighty lifted for < c: the highest branch is almost at over the whole B rillouin zone and very similar to the pyrochlore one. If we add thermal uctuations on these MF ground-states, it is not clear what will happen. They can either select a particular state, the q_1 noncollinear state (energetic selection) or a collinear state (entropic selection) or induce disorder.

III. MONTE CARLO RESULTS

We have performed standard MC simulations using the sample sizes of N = 864 6912 spins with periodic boundary conditions, over a temperature range extending down to $T=jJj=10^4$. We started from both random and ordered initial con gurations. In each run, up to 10^7 MC steps per spin have been discarded for equilibrating and up to $2 10^7$ MC steps per spins have been used for averaging. We have checked that our simulations reproduce the Monte-Carlo results for the pyrochlore net and those for the fice net 17 . In order to determine unambigously whether the J J fice HAF order or not, we have measured more specically the specic heat per spin and a correlation function which quantify the collinearity of spins.

An unbiaised way to look for uctuations induced order is to measure heat capacity, since it is very sensitive to the presence of zero modes (modes whose energy is independent of displacement to second order at all wave vectors) 5,7 . From the classical equipartition theory, quadratic modes contribute a factor T $^{1=2}$ to the partition function Z, while quartic modes contibute a factor T $^{1=4}$: at low temperature, the behavior is thus dominated by uctuations around the ground-states with the largest number of zero modes. These zero modes leave a signature in the heat capacity (since they contribute to $k_{\rm B}$ =4 instead of $k_{\rm B}$ =2 for the quadratic modes) that can be checked with M onte C arlo simulations.

In the n.n. pyrochlore HAF, uctuations around the collinear states lead to one zero m ode per tetrahedron resulting in a heat capacity per spin C = $3k_B$ =4 in absence

of order (instead of C = $5k_B$ =8 if a collinear state is selected). This value has already been checked by M onte C arlo calculations^{5,9}. In the fcc n.n. HAF, uctuations select the collinear state and since it contains only degeneration lines, the heat capacity per spin is simply equal to C = k_B in that case.

As the heat capacity derived from energy uctuations by MC simulations is rather noisy at low temperatures, we have estimated the heat capacity directly from the slope of the asymptotic internal energy at low temperatures. The obtained results are reported in Table I and clearly show that for 0.01, thermal uctuations select an ordered state at zero temperature. To show more directly whether the system selects the collinear ordering or not, we have calculated a parameter that measures the collinearity 5 :

where $r_{i;j}$ is the distance between i and j sites. So P = 1 for collinear spins and P = 0 in the high tem perature $\lim_{n \to \infty} it$. This parameter is represented in qure 5 as a function of the separation r (in units of n.n. distances) at T=jJj=10 4 for dierent values of . We not that as soon 0:01, the collinearity param eter is of long range, and close to 1, contrary to the pyrochlore lim it which shows a correlation for r < 2 only. We can note that the order parameter P (r! 1) is rather lower than 1 despite the low-tem perature taken, as for the XY model on the pyrochlore antiferrom agnet⁵. Figure 6 shows the tem perature dependence of the collinearity param eter for neighbouring spins r = 1. As soon as 0:01, the spins become collinear in the low temperature limit, by contrast with the pyrochlore case which has a small but nite correlation length. We have reported in gure 7 the critical tem perature as a function of \mathbb{J}^0 for $\mathbb{J}^0 \in \mathbb{O}$. It is of the order of $jJ^0 = 2$. We have checked that these results do not depend on the initial con guration choosen, by starting from collinear and random states. And the sizes considered are large enough since no marked nite-size e ects are observed.

We have checked the low temperature phase starting from collinear and random states. We found the q_0 collinear state for 0:01. Let's notice that starting from a random con guration, stacking faults set in at low temperatures in MC calculations, as it is usual in




FIG. 5: Dependence of the collinearity parameter P (r) at T=JJ=5 10 4 for di event values of $=J^0=J$, 4 L^3 , L=12 H eisenberg spins and starting from random spin congurations. r is given in units of n.n. distances.

fully frustrated system s^{17} . At T=jJj=5 10 4 and for =0.01 and N=6912, we found two collinear blocks (of q_0 type) of around N=2 spins and two non collinear walls of few hundred spins. For $_{\rm c}$, we observe an order by disorder e ect very similar to the fcc HAF: thermal uctuations induces the collinear magnetic order q_0 via an entropic selection. For $0<<_{\rm c}$, the low temperature state selected by thermal uctuations is not the q_1 incommensurate state selected at the MF level, neither a state with a MF energy close to the q_1 state and commensurate with the periodic boundary conditions we have taken, but the collinear state q_0 whose wave vector is far from q_1 in the Brillouin zone. Even for

0:1, where the M F energy di erence between these two ground states becom es greater (E=jJj 10 3 , see Fig. 4) than the lowest temperature we have considered T=jJj=5 10 4 , the system still selects the collinear state. The entropic selection always overcom es the energetic one in that case.

IV. CONCLUSION

We have studied in this paper the e ect of small deviations from the pyrochlore n.n. HAF to the foc one via standard MC simulations. As soon as we switch on J^0 (= J^0 =J 0.01), correlation functions are longranged in space and the speci c heat at zero temperature does not indicate the presence of zero modes. The J J^0 HAF selects the q_0 = (=a;0;0) collinear state at low-temperature and ordering occurs at nite temperature. For small, thermal uctuations do not select the MF ground-states at low temperatures but the collinear state. The entropic selection prevails over the energetic

one. This is the rst case, to our know ledge, where such a phenomenon is pointed out. The pyrochlore lattice




FIG. 6: Tem perature dependence of the collinearity parameter P (r=1) for di erent values of $= J^0=J$, di erent sizes $4 L^3$ and starting from random spin con gurations.




FIG.7: Phase diagram of the J J^0 m odel versus = J^0 =J $(q_0 = (=a;0;0))$.

thus remains the only 3D example known with classical Heisenberg spins remaining disordered at all temperatures.
