# Dimensional Crossover in the Non-Linear Sigma Model

#### Abstract:

We consider dimensional crossover for an O (N) model on a d-dimensional layered geometry of thickness L, in the -model limit, using \environmentally friendly" renormalization. We show how to derive critical temperature shifts, giving explicit results to one loop. We also obtain expressions for the elective critical exponents  $_{\rm e}$  and  $_{\rm e}$  that interpolate between their characteristic xed point values associated with a d and (d 1)-dimensional system in the limits T !  $T_{\rm c}(L)$ , with L (T  $T_{\rm c}(L)$ ) ! 1, and T !  $T_{\rm c}(L)$  for L xed respectively, where  $T_{\rm c}(L)$  is the L-dependent critical temperature of the system .

### 1 Introduction

Crossover behavior | the interpolation between qualitatively dierent e ective degrees of freedom of a system as a function of scale | is both ubiquitous and extremely important. Calculation of scaling functions associated with crossover behavior is, generally speaking, much more dicult than the calculation of more standard universal quantities, such as critical exponents, the latter being calculable in an approximation scheme suitable for the asymptotic region around one critical point.

An important, non-trivial and experimentally accessible example is seen in the context of conned systems and their analysis via nite size scaling. As far as the uctuations in a system are concerned there is, in principle, a very marked difference between an \environment" consisting of in nite three dimensional space and a three dimensional box of \size" L. A general formalism for studying such crossover systems using renormalization group (RG) methods is that of \environmentally friendly" renormalization [1]. To access the sensitivity to environment implicit in such a system it is necessary to implement a renormalization programme which is explicitly dependent on the relevant environmental parameters, such as nite size L. By so doing one can access several xed points of one globally defined RG, and what is more, one may achieve this perturbatively using one uniform approximation scheme.

The main gist of the approach is based on the simple intuition that, viewed as a coarse graining procedure, a \good" coarse graining will be one that when e ected to a length scale comparable to any length scale set by the environment will reect the in uence of the latter by changing continuously as a function of scale the type of e ective degree of freedom being coarse grained. However, and this is a point to be emphasized, although the intuition is grounded in a coarse graining procedure the actual mechanics are totally dierent to that of a Kadano /W ilson type coarse graining. Instead the form alism is based on the notion of a RG as describing the invariance under reparam etrization of a system, an idea which goes back to the original form ulation of the eld theoretic RG back in the '50's. Just as there are good and bad coarse grainings so there are good and bad reparam etrizations. An \environm entally friendly" reparam etrization is one that tracks the qualitatively changing nature of the e ective degrees of freedom of a crossover system. As has been emphasized previously a necessary condition for an environ entally friendly RG to satisfy is that the number of xed points of the RG, de ned globally on the space of parameters, be diffeom orphic to the number of points of scale invariance of the system. Unfortunately, favourite form s of eld theoretic renorm alization, such as m in im al subtraction, m anifestly do not satisfy this criterion and therefore are of only limited use in describing crossover behavior.

Previously [1], we have considered crossover behaviour for an O (N) model in the context of a Landau-G inzburg-W ilson representation of the underlying lattice model based on a '4 theory. G iven that for a dimensional crossover "expansion methods cannot work a xed dimension expansion was used to access the crossover the essential characteristics of the perturbation theory being based on an expansion around the

Gaussian xed point. As is well known, when an O (N) symmetry is spontaneously broken massless Goldstone modes give singularities at large distances for any value of the tem perature. The thermodynamics of these spin waves is described in the long distance limit by a Landau-Ginzburg-Wilson Hamiltonian which is that of the eld theoretic non-linear -model [2]. The appropriate expansion parameter in this case is the temperature, T, and hence perturbation theory corresponds to a low temperature expansion.

Crossover behaviour in the context of the non-linear -m odel has been considered previously. In particular, Am it and G oldschm idt extended their original treatment of bicritical systems above the critical temperature using G eneralized M in imal Subtraction [3] to below the critical temperature [4] thus describing the crossover between a system exhibiting an O (N) symmetry to that of an O (M) symmetry. In this case "methods were perfectly feasible due to the fact that the upper critical dimension of the two xed points was the same. In the context of nite size scaling B rezin and Z inn-Justin described crossover of the non-linear -m odel in the context of a box or a cylinder [5] by treating the lowest infra-red modes of the system non-perturbatively while treating other modes in a perturbative "expansion. However, this method does not work in the context of a dimensional crossover such as in a thin lim where the reduced dimension system also exhibits a non-trivial xed point.

M ore recently, the quantum version of the non-linear -m odel [6] has generated a great deal of attention as it can describe the long-wavelength, low-temperature behaviour of a two-dimensional quantum. Heisenberg ferrom agnet which in turn has been proposed as a model of high-temperature superconductors. Given the close analogy between a (d+1)-dimensional layered system with periodic boundary conditions and a d-dimensional quantum system it is certainly of interest from this point of view to investigate further dimensional crossover in the context of the non-linear -m odel.

In this paper we will consider dimensional crossover of a ferrom agnet with 0 (N) symmetry in the broken phase using as starting point the non-linear -m odel and utilizing the techniques of environmentally friendly renormalization to access the full universal crossover behaviour. One of the bene ts of doing so is a better understanding of how environmentally friendly renormalization functions in the context of a low temperature expansion as opposed to an expansion around the critical point.

In section 1 we brie y outline some important features of the non-linear -model. In section 2 we consider some formal renormalization results leaving explicit one loop answers for the case of dimensional crossover in a lm geometry to section 3. In section 4 we calculate the shift in critical temperature due to nite size e ects while in section 5 we derive one-loop expressions for some relevant e ective critical exponents in the broken phase. Finally, in section 6 we draw some conclusions.

#### 2 The Non-Linear -M odel.

We begin with the Landau-Ginzburg-Wilson Hamiltonian for a Heisenberg model with O (N) symmetry in the -m odellimit on a d-dimensional (d < 4) Im geometry of thickness L

where i 2 [1;N ], 2 [1;d],  $T_B$  is proportional to the tem perature of the system and '  $^i_B$  is subject to the constraint

We will restrict our attention here to the case of periodic boundary conditions.

The partition function Z is obtained by performing the path integral over the order parameter elds,  $^{\prime}_{B}$ , with the H am iltonian (1) subject to the constraint (2). Choosing the direction of sym metry breaking to be along the N th direction we de ne  $^{\prime}_{N}$  = and  $^{\prime}_{B}$ : (i  $\in$  N). The constraint in plies that  $(x) = (1 \quad ^{2})^{\frac{1}{2}}$ . Thus the partition function becomes

Clearly this theory is highly non-polynomial. The non-trivial measure term, which ensures the O (N) invariance of the theory, can of course be exponentiated and expanded in powers of  $^2$ . These terms are necessary to cancel corresponding O (N) non-invariant terms that arise in perturbation theory. We will assume that such terms have been cancelled in the rest of this paper and not consider them further. Rotations are implemented linearly in the (N) 1)-dimensional  $^i$ -subspace and non-linearly in the  $^i$  directions. A rotation by an in nitesimal!  $^i$  induces the changes

As long as  $j^{i}j < 1$  the sym m etry will remain broken. As T ! 0, (x) ! 1.

From the way in which T appears in (3) we can see that an expansion in terms of temperature is equivalent to an expansion in the number of loops, the only subtlety being that the measure term is then linear in T and therefore contributes to an higher order in T than the other two terms. The free propagator for the eld in the absence of a magnetic eld is

The magnetic eld coupled to the eld acts as an IR cuto . This can be seen by expanding the term H  $_B$  (1  $_B^{i\ 2})^{\frac{1}{2}}$  in powers of . The resulting two-point vertex function is

From the form of the Hamiltonian, in terms of an expansion in , there are interactions of arbitrary order. However, interactions with more than four powers of contribute at higher than one loop order, i.e. more powers of the \small" coupling T. Consequently to rst order in T, i.e. one loop, one need only consider the four-point interaction

In this paper we will restrict our attention to O (T) results and therefore will not consider higher order interactions any further.

#### 3 Renom alization

In spite of the fact that the theory is non-polynom ial, as is well known [2], it is renormalizable using only two renormalization constants  $Z_T$  and Z associated with the temperature and the eld respectively. The relation between the bare and renormalized parameters is

To preserve the rotational invariance of the renormalized constraint the eld must renormalize in the same way as . Invariance of the term  $\frac{H_{B-B}}{T_B}$  thereby yields the renormalization of H

The bare and renormalized vertex functions are related via

where is an arbitrary renormalization scale and an ultraviolet cuto. The RG equation, which is a consequence of the invariance of the bare theory, follows immediately on dierentiating (11) with respect to

where we have introduced a dimensionless temperature  $t = T^{-d-2}$  and  $= \frac{d \ln Z}{d \ln}$  is the anomalous dimension of the eld. The two -functions are

The two renormalization constants must be xed by normalization conditions. The essence of environmentally friendly renormalization is that in order to obtain a perturbatively well dened description of the crossover the renormalization procedure must depend explicitly on L. The normalization conditions we will use are

Note that T (2) is just the inverse susceptibility associated with the eld.

### 4 Explicit Results

We now proceed to exam ine the crossover perturbatively. To one loop

There are three di erent xed points associated with (20), a d-dimensional ultraviolet xed point in the limit L + 1, L + 1; a (d + 1)-dimensional ultraviolet xed point in the limit L + 1; and nally, a zero temperature infrared xed point in the limit L + 1; and nally, a zero temperature infrared xed point in the limit L + 1; and the approach to L + 1; and the depends on whether we consider L + 1; L + 1;

Because the coupling twas made dimensionless with a factor  $^{\rm d}$  2, in the limit L ! 0, ! 1 one nds that t! 0 (L ). However, as emphasized in [1], this does not imply that in the dimensionally reduced limit that uctuations are unimportant, as loops enter with a factor (L )  $^{\rm 1}$ , which diverges. The issue is made more transparent in this limit by passing to a more appropriate coupling  $t^0 = t = L$ . In the dimensionally reduced limit  $t^0 = t = L$ . lim it  $t^0$ ! O (1=L ). Thus  $t^0$  looks m ore natural in the dimensionally reduced lim it and t in the bulk lim it. O f course, these simple changes of variables cannot a ect the results for physical quantities they just help make more transparent what is going on. A coupling that is natural across the entire crossover, the oating coupling, can be introduced [1]. It is dened via  $h = a_2 t$  in the present case, where  $a_2$  is the coe cient of  $t^2$  in equation (20).

In terms of the oating coupling one nds

The quantity  $d_e=2+$  "(L ) can be interpreted as a measure of the e ective dimension of the system interpolating between d and d 1 in the limits L ! 1 and L ! 0 respectively, where in both cases we are considering ! 1 , i.e. the behaviour near the critical point.




Figure 1: Graph of separatrix solution of (21) as function of In L.

The corresponding xed points for hare: d 2, d 3 and 0. In Figure 1 we see a plot of has a function of  $\ln L$  for d=3. In this case, as the theory is asym totically free in two dimensions, the coupling goes to zero in the dimensionally reduced  $\lim it$ , i.e. the (d 1)-dimensional ultraviolet xed point and the trivial infrared xed points coincide. This dimensional crossover in the coupling is controllable in the low temperature expansion. It is in fact the solution to (21) that we use as a \small" parameter in the perturbative expansion of all other quantities. It is the fact that h captures the crossover between the dierent xed points that gives us a uniform expansion parameter and therefore perturbative control of the crossover. Of course

when d 2 is not small one really needs to work to higher order and attempt some resummation method. It should be clear however that there is no impediment to continuing this calculation to arbitrary order in the loop expansion.




Figure 2: Graph of separatrix solution of (21) as function of In L.

In Figure 2 we see the corresponding result for d=3.5. Here, the \double" crossover between the dierent xed points is manifest. A symptotically in the ultraviolet there is a xed point at h=1.5 that corresponds to the 3.5-dimensional critical point. In the intermediate region h asymptotes to the critical point of the 2.5-dimensional dimensionally reduced theory while, nally, in the infrared h! 0 corresponding to behaviour controlled by the zero-temperature xed point that controls the coexistence curve.

Turning now to the anom alous dimension of the eld, , we nd




Figure 3: G raph of  $g_f = 0$  on the separatrix solution of (21) as a function of 1 L.

The anomalous dimension also exhibits a dimensional crossover, as can be seen in Figure 3, for the case d=3, N=3, 4, 5, interpolating between the values  $\frac{N-1}{N-2}$  (d 2) and  $\frac{N-1}{N-2}$  (d 3) in the limits L=1 and L=0 respectively, where once again we are considering the behaviour near the critical point. Note that in contrast to the case of an expansion around the critical point using a ' Landau-G inzburg-W ilson Ham iltonian isn't simply the critical exponent . This is due to the fact that the canonical dimension of the elds and here is zero. The bulk, L=1, value of is (1)=(d-2+1) where the critical exponent =(d-2)=(N-2). In the limit L=0, L=1 we see that L=1 (L=1) where L=1 decomposed L=1 and L=10 where L=11 and L=12 is the critical exponent of the dimensionally

reduced system. In the large-N lim it, N ! 1 , note that !  $h = d_e^e$  , where  $d_e^e$  is the elective dimension that was found in considerations of dimensional crossover in the large-N lim it of a '4 theory [7].

## 5 Critical Temperature Shift

The function equation is easily integrated to nd

where f(1) simply picks out the n=0 term in the sum in f(L). Choosing the initial temperature and initial scale in (25) and (27) to be the same one obtains

where a factor of <sup>2 d</sup> has been absorbed into the dimensionless temperature. The interpretation of equation (28) is that given a particular renormalization scale in

two systems of size L and of in nite size then the corresponding temperatures in the two systems are related as above. Given that the limit! 1 corresponds to the approach to the critical point we can take this limit in (28) to nd

Taking the  $\lim_{i \to \infty} 1$  0 corresponds to choosing the initial dimensionless temperature to be zero. The shift then becomes

The result (30) is fully in agreement with the expectations of nite size scaling [8] with the exponent = 1 = (d 2). In the limit  $d! 3b_i! 1$  as there is a divergence in the function at d = 2. This corresponds to the fact that the the shift is ill dened due to the non-existence of a critical point in two dimensions as discussed by Barber and Fisher [9].

### 6 E ective Exponents

A useful set of universal scaling functions are de ned by e ective critical exponents that interpolate between those characteristic of the end points of the crossover of interest. Here, given that the non-linear  $\neg m$  odel is restricted to the broken phase we concentrate on the two e ective exponents  $_{\rm e}$  and  $_{\rm e}$  de ned as

where  $_{\rm e}$  is de ned along the critical isotherm of the nite size system and  $_{\rm e}$  on the coexistence curve of the nite size system . To derive  $_{\rm e}$  we solve the RG equation for the magnetization, 'with initial condition '(=0) = 1. We then substitute the anomalous dimension (24) and consider the limit L ! 1 to nd

In the lim it (t<sub>c</sub>(L) t)! 0, L<sup>d 2</sup>(t<sub>c</sub>(L) t)! 1 one nds that  $_{\rm e}$ ! (d 2+ )=2, while in the lim it (t<sub>c</sub>(L) t)! 0, L<sup>d 2</sup>(t<sub>c</sub>(L) t)! 0 one obtains  $_{\rm e}$ !  $^{0}$ (d<sup>0</sup> 2+  $^{0}$ )=2. At one-loop order, using equation (24),  $_{\rm e}$  interpolates between the above asymptotic values, where now = 1=(d 2), = (d 2)=(N 2),  $^{0}$ = 1=(d<sup>0</sup> 2),  $^{0}$ = (d<sup>0</sup> 2)=(N 2) and d<sup>0</sup>= d 1.

Similarly, one nds for e that




Figure 4: G raph of 1=d=1=e on the separatrix solution of (21) as function of  $\ln L$ .

where  $_{t}$  (  $_{t}$ =t). In the limit ( $t_{c}$ (L) t)! 0,  $L^{1=}$  ( $t_{c}$ (L) t)! 1 one has ! (d 2+ ) and  $_{t}$ ! 0. Hence, we see that  $_{e}$ ! (d+2 )=(d 2+ ). In the limit ( $t_{c}$ (L) t)! 0,  $L^{1=}$  ( $t_{c}$ (L) t)! 0 one nds that ! (d<sup>0</sup> 2+ <sup>0</sup>) and  $_{t}$ ! 1. Thus, in this limit  $_{e}$ ! (d<sup>0</sup>+2  $_{e}$ )=(d<sup>0</sup> 2+  $_{e}$ ), where d<sup>0</sup> and  $_{e}$ 0 are as above. At the one-loop level is as given by (24) and  $_{t}$ = "(L) h. In Figure 4 we see a graph of  $_{e}$ 1 as a function of ln L for d = 3 and N = 3, 4, 5 where the full dimensional crossover is evident.

#### 7 Conclusions

In this paper we have used environmentally friendly renormalization to consider dimensional crossover in the context of a non-linear -model on a d-dimensional lm geometry with periodic boundary conditions. Using an explicitly L dependent renormalization we derived one loop formulas for the anomalous dimension of the Goldstone eld and for the -function, describing the ow of the temperature as a function of RG scale. We found that there were three xed points exhibited in the one dierential equation. A d-dimensional critical point, a (d 1)-dimensional critical point and a zero temperature infra-red xed point. The function when integrated described

the global ow between all three of these xed points. Critical temperature shifts are a particularly interesting consequence of nite size behaviour. Here, we showed how such shifts could explicitly be calculated noting an expression to one-loop in agreement with nite size scaling arguments.

Finally, we derived one-loop expressions for the two elective critical exponents  $_{\rm e}$  and  $_{\rm e}$  showing how they interpolated between the asymptotic expressions associated with the corresponding d and (d  $_{\rm e}$ 1)-dimensional critical exponents. Evidently there is much more that could be done, such as deriving the full equation of state etc. Of particular interest will be to adapt the results to that of a quantum non-linear  $_{\rm e}$ 1 m odel and apply them to the case of a high-tem perature superconductor. The same mathematical model, though with a quite dierent physical interpretation, will also describe a d-dimensional relativistic, quantum eld theoretic non-linear  $_{\rm e}$ 2 m odel. We hope to return to these interesting issues in a future publication.
