## A bstract:

W e consider dim ensional crossover for an $O(\mathbb{N})$ m odelon a d-dim ensional layered geom etry of thickness $L$, in the $-m$ odellim it, using \environm entally friendly" renorm alization. W e show how to derive critical tem perature shifts, giving explicit results to one loop. W e also obtain expressions for the e ective critical exponents e and e that interpolate between their characteristic xed point values associated with a d and ( d 1 )-dim ensionalsystem in the lm its $\mathrm{T}!\mathrm{T}_{\mathrm{C}}(\mathrm{L})$, w th $\mathrm{L}\left(\mathrm{T} \mathrm{T}_{\mathrm{C}}(\mathrm{L})\right.$ ) ! 1 , and $T$ ! $T_{C}(L)$ for $L$ xed respectively, where $T_{C}(L)$ is the $L$-dependent critical tem perature of the system.

## 1 Introduction

C rossover behavior | the interpolation between qualitatively di erent e ective degrees of freedom of a system as a function of scale | is.both ubiquitous and extrem ely im portant. C alculation ofscaling functions associated w ith crossover behavior is, generally speaking, much more di cult than the calculation of m ore standard universal quantities, such as critical exponents, the latter being calculable in an approxim ation schem e suitable for the asym ptotic region around one critical point.

An im portant, non-trivial and experim entally accessible example is seen in the context of con ned system s and their analysis via nite size scaling. As far as the uctuations in a system are concemed there is, in principle, a very $m$ arked di erence between an \environm ent" consisting of in nite three dim ensional space and a three dim ensional box of \size" L. A general form alism for studying such crossover system susing renorm alization group ( $\mathrm{R} G$ ) m ethods is that of \environm entally friendly" renom alization ${ }_{\text {tin }} 1 \mathrm{l}$. To access the sensitivity to environm ent im plicit in such a system it is necessary to im plem ent a renom alization program $m e$ which is explicitly dependent on the relevant environm ental param eters, such as nite size L. By so doing one can access several xed points of one globally de ned RG, and what is $m$ ore, one $m$ ay achieve this perturbatively using one uniform approxim ation schem e.

Them ain gist of the approach is based on the simple intuition that, viewed as a coarse graining procedure, a \good" coarse graining will be one that when e ected to a length scale com parable to any length scale set by the environm ent w ill re ect the in uence of the latter by changing continuously as a function of scale the type of e ective degree of freedom being coarse grained. H ow ever, and this is a point to be em phasized, although the intuition is grounded in a coarse graining procedure the actualm echanics are totally di erent to that of a K adano /W ilson type coarse graining. Instead the form alism is based on the notion of a RG as describing the invariance under reparam etrization of a system, an idea which goes back to the original form ulation of the eld theoretic RG badk in the '50's. Just as there are good and bad coarse grainings so there are good and bad reparam etrizations. A n \environm entally friendly" reparam etrization is one that tracks the qualitatively changing nature of the e ective degrees of freedom of a crossover system. A s has been em phasized previously a necessary condition for an envirom entally friendly RG to satisfy is that the num ber of xed points of the RG, de ned globally on the space of param eters, be diffeom orphic to the num ber of points of scale invariance of the system. U nfortunately, favourite form sof eld theoretic renorm alization, such as minim al subtraction, $m$ anifestly do not satisfy this criterion and therefore are of only lim ited use in describing crossover behavior.

P reviously [ī1], we have considered crossover behaviour for an $\mathrm{O}(\mathbb{N}) \mathrm{m}$ odel in the context of a Landau-G inzburg-W ilson representation of the underlying lattioe $m$ odel based on a ${ }^{\prime 4}$ theory. G iven that for a dim ensional crossover " expansion $m$ ethods cannot work a xed dim ension expansion was used to access the crossover the essential characteristics of the perturbation theory being based on an expansion around the

G aussian xed point．A s is well known，when an $O(\mathbb{N})$ sym $m$ etry is spontaneously broken $m$ assless $G$ oldstone $m$ odes give singularities at large distances for any value of the tem perature．T he them odynam ics of these spin w aves is described in the long distance lim it by a Landau－G inzburg－w ilson H am iltonian which is that of the eld theoretic non－linear m odel $[\overline{\ln }]$ ．The appropriate expansion param eter in this case is the tem perature， T ，and hence perturbation theory corresponds to a low tem perature expansion．

C rossover behaviour in the context of the non－linear m odel has been considered previously．In particular，A m it and G oldschm idt extended their originaltreatm ent of bicritical system $s$ above the critical tem perature using $G$ eneralized $M$ inim alSubtrac－ tion［了了， system exhibiting an $O(N)$ sym metry to that of an $O(M)$ sym $m$ etry．In this case＂ $m$ ethods were perfectly feasible due to the fact that the upper critical dim ension of the two xed points was the sam e．In the context of nite size scaling B rezin and Zinn－Justin described crossover of the non－linear $m$ odel in the context of a box or a cylinder［⿹\zh26灬｜］by treating the low est infra－red m odes of the system non－perturbatively while treating otherm odes in a perturbative＂expansion．H ow ever，thism ethod does not work in the context of a dim ensional crossover such as in a thin m where the reduced dim ension system also exhibits a non－trivial xed point．
$M$ ore recently，the quantum version of the non－linear $m$ odel $\frac{[-\bar{q}]}{]}$ has generated a great deal of attention as it can describe the long－w avelength，low－tem perature behaviour of a two－dim ensional quantum Heisenberg ferrom agnet which in tum has been proposed as a m odelofhigh－tem perature superconductors．G iven the close anal－ ogy betw een a（ $\mathrm{d}+1$ ）－dim ensional layered system w th periodic boundary conditions and a d－dim ensional quantum system it is certainly of interest from this point of view to investigate further dim ensional crossover in the context of the non－linear m odel．

In this paper we will consider dim ensional crossover of a ferrom agnet w ith $\mathrm{O}(\mathbb{N})$ sym $m$ etry in the broken phase using as starting point the non－linear model and utilizing the techniques of environm entally friendly renorm alization to access the fiull universal crossover behaviour．O ne of the bene ts ofdoing $s o$ is a better understand－ ing of how environm entally friendly renorm alization functions in the context of a low tem perature expansion as opposed to an expansion around the critical point．

In section 1 we brie $y$ outline som e im portant features of the non－linear m odel． In section 2 we consider some form al renorm alization results leaving explicit one loop answers for the case of dim ensional crossover in a m geom etry to section 3. In section 4 we calculate the shift in critical tem perature due to nite size e ects while in section 5 we derive one－loop expressions for som e relevant e ective critical exponents in the broken phase．F inally，in section 6 we draw som e conclusions．

## 2 The N on－Linear -M odel．

We begin w ith the Landau－G inzburg－w ilson $H$ am ittonian for a $H$ eisenberg model $w$ ith $O(\mathbb{N})$ sym metry in the $m$ odel lim it on a d－dim ensional（ $d<4$ ）lm geom etry of thickness L

W e w ill restrict our attention here to the case of periodic boundary conditions．
The partition function $Z$ is obtained by perform ing the path integral over the order param eter elds，${ }_{B}^{i}$ ，w ith the H am iltonian（1in）sub ject to the constraint（ Choosing the direction of sym $m$ etry breaking to be along the $N$ th direction we de ne $r^{N}=$ and ${ }^{\prime}={ }^{i}$ ；$(i \in N)$ ．The constraint implies that $(x)=\left(\begin{array}{ll}l^{2}\end{array}\right)^{\frac{1}{2}}$ ．Thus the partition function becom es
$C$ learly this theory is highly non－polynom ial．The non－trivialm easure term，which ensures the $O(\mathbb{N})$ invariance of the theory，can of course be exponentiated and ex－ panded in powers of ${ }^{2}$ ．These term $s$ are necessary to cancel corresponding $O(\mathbb{N})$ non－invariant term $s$ that arise in perturbation theory．$W$ ew illassum e that such term $s$ have been cancelled in the rest of this paper and not consider them further．R otations are im plem ented linearly in the（ $\mathbb{N}$ 1）－dim ensional ${ }^{\text {i}}$－subspace and non－linearly in the ${ }^{i}$ directions．A rotation by an in nitesim al！${ }^{i}$ induces the changes

As long as $j^{i} j<1$ the sym $m$ etry will rem ain broken．A s $T$ ！ $0,(x)!1$.
From the way in which $T$ appears in（（⿳亠二口欠）we can see that an expansion in term $s$ of tem perature is equivalent to an expansion in the num ber of loops，the only subtlety being that the $m$ easure term is then linear in $T$ and therefore contributes to an higher order in $T$ than the other tw o term $S$ ．The free propagator for the eld in the absence of a magnetic eld is

From the form of the Ham iltonian, in term $s$ of an expansion in, there are interactions of arbitrary order. H ow ever, interactions w ith m ore than four pow ers of contribute at higher than one lop order, i.e. m ore pow ers of the \sm all" coupling T. C onsequently to rst order in T, i.e. one loop, one need only consider the fourpoint interaction

In this paper we will restrict our attention to $O$ ( $T$ ) results and therefore will not consider higher order interactions any further.

## 3 R enorm alization

In spite of the fact that the theory is non-polynom ial, as is w ell known $\left[\frac{\overline{2}}{\overline{2}}\right]$, it is renor$m$ alizable using only two renom alization constants $Z_{T}$ and $Z$ associated $w$ ith the tem perature and the eld respectively. T he relation betw een the bare and renorm alized param eters is

where we have introduced a dim ensionless tem perature $t=T \quad{ }^{d} 2$ and $=\frac{d \ln z}{d \ln }$ is the anom alous dim ension of the eld. The two -functions are

The two renorm alization constants $m$ ust be xed by norm alization conditions. The essence of environm entally friendly renorm alization is that in order to obtain a perturbatively well de ned description of the crossover the renorm alization procedure m ust depend explicitly on L . The norm alization conditions we will use are

$N$ ote that $T{ }^{(2)}$ is just the inverse susceptibility associated with the eld.

## 4 E xplicit R esults

W e now proceed to exam ine the crossover perturbatively. To one loop

There are three di erent xed points associated w ith ( xed point in the lim it $L!1,!1$; a (d 1)-dim ensionalultraviolet xed point in the lim it $\mathrm{L}!0,!1$; and nally, a zero tem perature infrared xed point in the lim it ! 0. H ow ever, the approach to $t=0$ depends on whether we consider ! 0 for xed L or L ! 1 , ! 0.
Because the coupling $t$ was made dim ensionless with a factor d 2 , in the lim it $\mathrm{L}!0,!1$ one nds that t ! $\mathrm{O}(\mathrm{L})$. How ever, as em phasized in [1] does not im ply that in the dim ensionally reduced lim it that uctuations are unim portant, as loops enter w ith a factor ( $L$ ) ${ }^{1}$, which diverges. The issue is $m$ ade $m$ ore transparent in this $\lim$ it by passing to a $m$ ore appropriate coupling $t^{0}=t=L$. In the dim ensionally reduced lim it $t^{0}$ ! $O\left(d^{0} \quad 2\right)$, where $d^{0}=d \quad 1$, while in the bulk
lim it $t^{0}$ ! $O(1=L)$. Thus $t^{0}$ looks $m$ ore natural in the dim ensionally reduced lim it and $t$ in the bulk lim it. O f course, these sim ple changes of variables cannot a ect the results for physicalquantities they just help $m$ ake $m$ ore transparent what is going on. A coupling that is natural across the entire crossover, the oating coupling, can be introduced $\left.{ }_{[-1}^{1}\right]$. It is de ned via $h=a_{2} t$ in the present case, where $a_{2}$ is the coe cient of $t^{2}$ in equation ( $\left.2 \overline{0} \overline{1}\right)$.

In term s of the oating coupling one nds

The quantity $d_{e}=2+"(L)$ can be interpreted as a m easure of the e ective di$m$ ension of the system interpolating betw een $d$ and $d \quad 1$ in the lim its $L$ ! 1 and L ! 0 respectively, where in both cases we are considering ! 1 , i.e. the behaviour near the critical point.


Figure 1: G raph of separatrix solution of (2111) as function of $\ln \mathrm{L}$.
The corresponding xed points for $h$ are: $d \quad 2, d \quad 3$ and 0 . In $F$ igure 1 we see a plot of $h$ as a function of ln L for $\mathrm{d}=3$. In this case, as the theory is asym totically free in two dim ensions, the coupling goes to zero in the dim ensionally reduced lim it, i.e. the ( $d$ 1)-dim ensional ultraviolet xed point and the trivial infrared xed points coincide. This dim ensional crossover in the coupling is controllable in the low tem perature expansion. It is in fact the solution to ( $\overline{2} \overline{1} 1$ ) that we use as a \sm all" param eter in the perturbative expansion of all other quantities. It is the fact that $h$ captures the crossover between the di erent xed points that gives us a uniform expansion param eter and therefore perturbative control of the crossover. Of course
when d 2 is not sm all one really needs to work to higher order and attem pt som e resum $m$ ation $m$ ethod. It should be clear how ever that there is no im pedim ent to continuing this calculation to arbitrary order in the loop expansion.

In Figure 2 we se corresponding result for $d=3: 5$. Here, the \double" crossover between the di erent xed points is $m$ anifest. A sym ptotically in the ultraviolet there is a xed point at $\mathrm{h}=1: 5$ that corresponds to the $3: 5$-dim ensional critical point. In the interm ediate region $h$ asym ptotes to the critical point of the 2:5-dim ensionaldim ensionally reduced theory while, nally, in the infrared $h$ ! 0 corresponding to behaviour controlled by the zero-tem perature xed point that controls the coexistence curve.

Tuming now to the anom alous dim ension of the eld, ,we nd

The anom alous dim ension also exhibits a dim ensional crossover, as can be seen in $F$ igure 3, for the case $d=3, N=3,4,5$, intenpolating between the values $\frac{\mathrm{N}-1}{\mathrm{~N} 2}$ ( d 2) and $\frac{\mathrm{N} \frac{1}{\mathrm{~N}} 2}{}(\mathrm{~d}$ 3) in the $\lim$ its $\mathrm{L}!1$ and $\mathrm{L}!0$ respectively, where once again we are considering the behaviour near the critical point. N ote that in contrast to the case of an expansion around the critical point using a ${ }^{4}$ Landau-G inzburg-W ilson $H$ am iltonian isn't smply the critical exponent. This is due to the fact that the canonical dimension of the elds and here is zero. The bulk, L ! 1 , value of is $(1)=(d 2+)$ where the critical exponent

## 5 C ritical Tem perature Shift

The function equation is easily integrated to nd

This corresponds to the fact that the the shift is illde ned due to the non-existence of a critical point in two dim ensions as discussed by B arber and $F$ isher $\left.\underline{\omega}_{\underline{1}}^{-1}\right]$.

## 6 E ective Exponents

A usefiul set of universal scaling functions are de ned by e ective critical exponents that interpolate between those characteristic of the end points of the crossover of interest. H ere, given that the non-linear $m$ odel is restricted to the broken phase we concentrate on the two e ective exponents $e$ and e de ned as

where $e$ is de ned along the critical isotherm of the nite size system and $e$ on the coexistence curve of the nite size system. To derive e we solve the RG equation for the $m$ agnetization,' $w$ th initial condition' $(=0)=1$. W e then substitute the anom alous dim ension ( $\underline{2}_{-1}^{1}$ ) and consider the $\lim$ it $L$ ! 1 to nd

At one-loop order, using equation (2-4̄) , e intenpolates betw een the above asym ptotic values, where now $=1=\left(\begin{array}{ll}\mathrm{d} & 2\end{array}\right), \quad\left(\begin{array}{ll}\mathrm{d} & 2\end{array}\right)=\left(\begin{array}{ll}\mathrm{N} & 2\end{array}\right),{ }^{0}=1=\left(\begin{array}{ll}\mathrm{d}^{0} & 2\end{array}\right)$, ${ }^{0}=\left(\begin{array}{ll}d^{0} & 2\end{array}\right)=\left(\begin{array}{ll}\mathbb{N} & 2\end{array}\right)$ and $d^{0}=d \quad 1$.

At the one-loop level is as given by (2 $\overline{4}$ ) and $t="(L)$ h. In Figure 4 we se a graph of $e^{1}$ as a function of $\ln L$ for $d=3$ and $N=3,4,5$ where the fiull dim ensional crossover is evident.

## 7 C onclusions

In this paper we have used environm entally friendly renorm alization to consider di$m$ ensional crossover in the context of a non-linear m odel on a d-dim ensional m geom etry w ith periodic boundary conditions. U sing an explicitly L dependent renor$m$ alization we derived one loop form ulas for the anom alous dim ension ofthe $G$ oldstone eld and for the -function, describing the ow of the tem perature as a function of RG scale. W e found that there were three xed points exhibited in the one di erentialequation. A d-dim ensional critical point, a (d 1)-dim ensional critical point and a zero tem perature infra-red xed point. The function when integrated described
the global ow between all three of these xed points. C ritical tem perature shifts are a particularly interesting consequence of nite size behaviour. H ere, we showed how such shifts could explicitly be calculated nding an expression to one-loop in agreem ent w ith nite size scaling argum ents.
$F$ inally, we derived one-loop expressions for the tw o e ective criticalexponents e and e show ing how they intenpolated betw een the asym ptotic expressions associated w ith the corresponding $d$ and ( $d$ 1)-dim ensional criticalexponents. Evidently there is $m$ uch $m$ ore that could be done, such as deriving the fullequation of state etc. Of particular interest will be to adapt the results to that of a quantum non-linear $m$ odel and apply them to the case of a high-tem perature superconductor. T he sam e m athem atical m odel, though w ith a quite di erent physical intenpretation, will also describe a d-dim ensional relativistic, quantum eld theoretic non-linear model. We hope to retum to these interesting issues in a fiuture publication.
