A continuum growth equation in 1+1 dimensions is obtained by considering the contributions to the underlying current from kinetics of adatoms on the surface. These considerations reproduce the slope dependent term that represents a stable or an unstable growth depending on the sign of the associated coe cient. In addition an h! h symmetry breaking nonlinear term is obtained. Im plications of this term on the stable! unstable growth transition are discussed. This term is tilt independent and is expected to be present independent of the source of the current in the conserved growth. computer simulation based on a zero di usion bias model is used to verify some of the predictions of the m inim al growth equation. It is shown that the growth equations for cellular autom ata type m odels involving instantaneous relaxations can be obtained from the proposed m ethod by addressing the corresponding kinetics of adatom s.

A continuum description of conserved growth from vapor is obtained from Langevin type equation @th + r J = F where h(r;t) is height function, J is current due to adatom relaxation on the growing surface and F is the average ux with white noise. The current J includes an equilibrium and a nonequilibrium (NE) contribution. Most of the experim ental grow th is far from equilibrium and has been studied over last m any years [1,2]. Description of such grow th is essentially through the nonequilibrium current $J_{N E}$. The contributing terms to $J_{N E}$ are obtained by comparing the behaviour of growth equation containing sets of di erent term s, satisfying required symmetry and invariances of the problem, with the experimental observations [3,4] or, appealing to the underlying kinetics [5,6]. Form er is an em pirical approach while later, a direct approach. It is desired that from kinetic considerations , $J_{N E}$ could be constructed, describing the experim ental observations. Such an approach was adopted by Villain [6] earlier. In reference [6], from com puter based solutions of the equations describing step velocities in 1+1 dimensions, and the consequent interface pro les, it was concluded that the local form of the grow th equation should com prise of a) a term of the form $\frac{m}{(1+a^0jm \ j)(1+b^0jm \ j)}$ where a^0 and b^0 are constants, related to the di usion kinetics, b) an h ! h symmetry breaking term and c) a term of the form r ${}^{4}h$.

In what follows we show that these terms can be derived by appropriately identifying the kinetic processes that contribute to the nonequilibrium current. To our know ledge the method proposed in this work has not been used to obtain $J_{N E}$ in any of the previous work related to grow th from vapor. Most of our discussion will be pivoted around the symmetry breaking term that assumes the form $r^2 (r h)^2$ for small inclinations while at large slopes takes the form $\frac{1}{m^3} \theta_x m$ thus unifying the descriptions [2,6] at small and large slopes. While obtaining the NE contributions to the current, we will consider grow th with Schwoebel-Ehrlich (SE) [7] barrier to account the stable as well as unstable grow th. However

the m ethod of obtaining these contributions can be applied to any other m odels not employing the SE barrier [8,9]. We have applied it later to a stochastic m odel with cellular autom at a type rules that m in ic the m olecular beam epitaxial (MBE) grow that low temperature [10] referred in the literature as DT m odel.

Consider grow th on a 1 dim ensional at substrate with lattice constant a. W ew ill consider the situation depicted in Fig. 1 for obtaining various contributions to the current where steps are such that positive slope is obtained. A datom s are random ly deposited on the substrate. Let D_s be the di usion constant on the terrace, l_c be the average distance that an adatom travels on a terrace before encountering another adatom . Detachment from steps or nuclei on the terrace is negligible. A datom s hopping down the descending steps contribute to the downward current jd while those hopping on the terrace can get attached to an ascending step contribute to the in-plane current j_i . Referring to Fig. 1, the adatom s reaching site A and hopping down the step to the left constitute j_d and those reaching site B and hopping to the right towards the ascending step constitute j_i . The net current is $j_d + j_i$. These are obtained as follows,

 $j_{d(i)}$ = (local density of site A (B)) (ux of adatom s approaching A (B)) (probability for hopping across A (B)).

Since the relaxation of adatom s is through the diusion on the terrace or across the step edges, the density of sites A and B is same as density of steps which is approximately given by $\frac{jn}{1+jn}$, where m is the local slope. In the absence of nucleation, lateral ux (LF) approaching site B or A is $\frac{nF}{2jn}$, a jn j¹ being the average local terrace width and n is unit vector in the x direction. W hen terrace size is large enough, this ux is restricted due to the nucleation. The nucleation process will restrict the di usion to an average length l_c on a large terrace.

As a result, even for very large terraces, the approaching ux LF is almost constant. The e ect of nucleation is incorporated by introducing l_c in the expression for LF as $\frac{\hbar F}{2(l_c^{-1} + j_B^{-1})}$, so that for small slopes the expression is reduced to a constant value. Let P_A and P_B represent the probabilities of hopping across sites A and B respectively. The Schwoebel length [5] l_s / (P_B = P_A). Hence from the Eq.(1) the current is

The LF approaching sites A and B is how everm odi ed due to the relative motion of the steps. Consider the situation in Fig.1 where v is the velocity of the step bearing the terrace while v^0 that of the higher one on the positive slope. For $v^0 > v$ the terrace width is reduced, depleting the LF approaching sites A and B. The reduction in ux is / v where $v = (v^0 v)$. A datom s hopping across upper step as well as those attaching in-plane, both contribute to the velocity of the step. Thus the velocity $v \ / \ j_s$ except that the coe cient (P $_B$ P_A) is replaced by $(P_{A} + P_{B})$. Hence $v / \frac{(P_{A} + P_{B})}{l_{c}^{1} + j_{B} j_{a}^{-1}} (\theta_{x} \frac{j_{B} j_{a}}{2(1 + j_{B} j)(l_{c}^{-1} + j_{B} j_{a}^{-1})})$ Corresponding current will not depend on (P $_{\rm B}$ $\,$ P $_{\rm A}$) since this part of the ux is rem oved from the LF. The current is therefore obtained by multiplying the LF by density of steps. P_A and P_B are relative probabilities so that $P_A + P_B = 1$. A counting for this e ect the expression for the current becom es,

In the lim it of sm allm, the current reduces to,

The second term in general will have the form $r (r h)^2$. This term was derived using the Burton-Cabrera-Frank (BCF) theory and assuming that at small slopes the particle density on the terraces depends on the even powers of local gradient [2,6]. In the presnt case the di erence in the velocities of two consecutive steps on a slope is related to the di erence in the adatom densities on their terraces. How ever we do not explicitly assume the dependence of density on the even powers of slope. Further, in ref. [4] it was conjectured that such a term can arise due to the di erences in the velocities of the steps near the top and the bottom of a pro le.

In the lim it of large slope, jn ja 1 l_c 1 the current reduces to,

The second term is proportional to $\frac{1}{m^3} \mathfrak{G}_x \mathfrak{m}$, which was derived in the large slope lim it in reference [6]. Thus the geom etrical dependence of the symmetry breaking term in Eq.(3) exactly matches with previously derived two terms in the small and large slope lim its. This shows that present method of deriving current, appropriately accounts for the physical processes contributing to it.

W e further argue that a curvature dependent current must be present in any adatom relaxation process that involves downward hops across the descending step edges. This argument is based on the observation that, in a 1+1 dimensional simulation, if adatoms are restricted completely to the in-plane hops (in nite SE barrier) then correlations do not grow beyond the diffusion length. On the other hand, when such hops are allowed, correlation length for stable growth and mound size for unstable grow th increases in time [11]. Hence if the downward hops are allowed but the current is tiltindependent, then it m ay be expressed as a linear com bination $a_1 r^{3}h + a_2 r^{5}h + \dots$ including the nonlinear term s of the form $r (r^{3}h)^{2}$. We will retain only $r^{3}h$ in the current corresponding to our m in in al grow th equation. Thus the form of the current corresponding to the minimalgrowth equation is

The rst term has been studied widely as the stable growth mode [12,13] and as the unstable growth mode [14]. In order to nd the e ect of asymmetry term on the growth exclusively, we have performed simulations of a 1+1 dimensional solid-on-solid model with no diusion bias. A fourth ordered equation was earlier proposed by V illain [5] for similar situation. Under this condition $P_A = P_B$ and rst term vanishes in the Eq(3). The resultant growth equation in the moving frame with growth front is of the form,

where, a is the appropriate constant for the asymmetry term and is white noise with $\langle (x^0;t^0) (x;t) \rangle = D(x^0 x)$ (t t). In the limit of small slopes, renormalization group (RG) analysis shows that the roughness exponent = 1 and the roughness evolves with

the exponent = 1=3 [4]. For large slopes, asymmetric term , on power counting leads to z 3, while noise term gives z 1 2. If a is assumed to be invarient under renorm alization, then again = 1 and = 1=3as in the case of sm all slope. Corresponding m odel is as follows. A tom s are rained on a 1-d substrate of length L random ly with constant ux. On deposition a given adatom is allowed to hop n times, as in a random walk. If the hopping adatom encounters another adatom before n hops are exausted, the adatom stays there perm anently. If n hops are exausted without any encounter, it stays perm anently at the last position occupied after n hops. Thus for hopping, all sites with zero neighbor are equivalent, ensuring $P_A = P_B$. We have measured width w₂, height-height correlations \wp (r;t) and skewness for this model where, $w_2 = \frac{1}{N} \frac{1}{i} (h_i h) t^2$ and G (r;t) = $\frac{1}{N} \frac{1}{r^0} (h (r + r^0; t) h (r^0; t))^2$. The skew ness = $w_3 = w_2^{3=2}$, where $w_3 = \frac{1}{N} \frac{P}{i} (h_i h)^3$ [15].

P resence of r⁴h term is veried from the atness of the saturated width for small L. We have chosen, n= 25 giving l_c 5. The saturated width is at almost up to $5l_c$, showing that r⁴h dom inates at small lengths [6]. Fig. 2 (a) shows the morphology of the interface after 80000M L are grown. As predicted by the Eq.(7), the asymmetry is evident in the gure with = 0:47 0:05. . Fig. 2 (b) shows plot of w₂ in time. We obtain initially

around 0.3 that attains a steady value of 0:355 0:015. Initial sm all value can be related to the sm all slope region that predicts a value of 1/3 (com pare data in the region from 10 M L to 200 M L in the gure with the line having slope of 2=3). Correspondingly h-h correlations lead to the roughness exponent that increases from 0.5 0:01. These results indicate that most of the to 0:65 m orphological features of the grow th with di usion without detachm ent are captured by the current expression in Eq.(6). It also shows that di usion of the adatom sroughens the growing surface. Di usion bias causes additional e ects in terms of stability or instability of growth. In particular, if the bias is varied from extrem e -ve SE barrier to extrem e + ve SE barrier, a stable! unstable transition is observed. In this transition however h ! h symmetry is broken asymptotically. Note that for -ve SE barrier $_2r^2h$ term dom inates with + ve value of $_2$ [12], so that asymptotically, asymmetric term becomes irrelevant rendering = 0. At exactly zero SE barrier, 0:5) is obtained. can be regarded nite value of (as the symmetry parameter, that changes abruptly at the transition point. Thus the growth transition is like 2nd order phase transition. Details of such a transition in com puter sim ulations of suitable m odels w ill be discussed elsew here.

Extension of this equation to 2+1-dim ensions is possible by similar kinetic considerations. For isotropic di usion, same form as Eq.(6) is obtained with f = r h = jr h j and replacing length-derivative product in asymmetric

term by $\frac{r h r}{(l_c^{1} + jr h)jr hj}$. For small slopes one obtains r (r h)² term [4] which seem s to describe m any experimentally observed grow th roughness m easurem ents from vapor [16].




FIG.1. A typical step structure form ed during growth along positive slope. v and v^0 are velocities of the steps.

A sm entioned earlier, the presentm ethod for obtaining current from kinetic considerations appropriately brings out the geom etrical dependence in grow th equation. We have applied this method to one of the stochastic grow th m odels proposed to capture the essential feature of low tem perature molecular beam epitaxy (MBE) the DT model [10]. Based on noise reduction technique, the simulations of this model [17] con m that, 1) exponent = 3=8,2) the morphology is asym metric with 0:5 and 3) the current is tilt independent [2,17]. The observed value of 3/8 is constant alm ost over 8 orders of magnitude [17]. The relaxation rules for adatom in this model allows it to hop only when it is deposited at site A or B (see Fig. 1). A lso only downward hop is allowed, if deposited at A and towards the step, if deposited at B. If it has choice of sites A, A or B, B or A, B etc. on two neighboring sites, then it will hop random ly to the left or right. A pplying the considerations for obtaining current for this situation shows that the LF approaching sites A or B in the present set of rules is $\frac{F}{a^{-1} + j_{0} j_{a}^{-1}}$, since the ux is a ected only at large enough slope when site A and B overlap due to the short terrace width. Further, the LF is a ected by relative motion of steps only when sites A and B di er by a lattice constant. The expression for the current is then,

From the rules it is clear that $P_A = P_B$. The growth equation corresponding to this current in the moving framewill be,

where, a accounts for various constants in the corresponding expression for current. The power counting in this equation leads to , z = 4 from the rst term, and z = 1 + 2 for large slopes corresponding to the second term which is expected to be operative mainly over large inclinations. The relation obtained from the second term is exactly same as the one obtainable from the noise term

. For z = 4 all the term s are marginal. This implies that z = 4 and z = 3=8. The second term is symmetry breaking. Hence, above equation accounts for all the observed facts mentioned above in the simulation of DT model. In 2+1-dimensions, with above rules for adatom relaxation, the local density of sites A and B need not be equal since, uctuations in step edges render con gurations that show

bias for sites A or B. As a result, slope dependent current will dom inate the grow th [17]. Further im plications of this equation are presently under study.

In conclusion, we have proposed a simple method for obtaining current in a solid-on-solid growth in 1+1-dimension. The resultant equation shows that presence of di usion alone is resposible for roughning of a singular surface. It induces an asymmetric term in the continuum equation. As a result a stable to unstable transition will be associated with symmetry breaking. We have also demonstrated the application of this method of obtaining current to a stochastic model referred as DT model. The corresponding continuum equation is shown to predict observed exponents and the nature of the interface prole correctly.




FIG.2. (a) M orphology of the surface after 80000 number of layers. (b)P lot of width as a function of time. Straight lines with slope 3=4 and 2=3 are drawn for reference.
