FLUCTUATION EFFECTS IN M IXED STATE OF TYPE II SUPERCONDUCTOR.

Comparison of Experimental Results with Theoretical Predictions.

### 1. Introduction

Investigation of the uctuation phenom ena changes habitual notion about the mixed state of type II superconductors. Before the uctuation investigation one thought that the second-order phase transition from the normal state into the Abrikosov state takes place in the second critical ed, H  $_{c2}$  [1]. Now it is clear that a phase transition in  $H_{c2}$  is absent and the transition in the Abrikosov state, called now often as "vortex lattice melting", occurs below H  $_{c2}$  [2]. Now it is widely recognized that the normal state with superconducting uctuation, called as "vortex liquid", exists not only above but also below  $H_{c2}$  [2]. This becomes widely known in the last time, after the investigation of the uctuation phenomena in high-T  $_{\rm c}$  superconductors (HTSC). Therefore most of scientists connect these changes of the habitual notion about the mixed state with the HTSC investigation rst of all. M oreover som e authors suppose that these changes of the notion relate to H T SC only because they think that the uctuation e ects in conventional superconductors are very sm all [3]. But it is not right. M oreover just the investigation of the uctuation phenomena of conventional superconductors have shown rst that the transition into the Abrikosov state occurs below H  $_{c2}$ . It was

m ade before the HTSC discovery. But these result are not enough known. Therefore Iw illwrite about these results rst of all in this report. Iw ill show that the results obtained on high quality samples of YB  $a_2$ C  $u_3$ O<sub>7 x</sub> repeat in the main our results obtained by the investigation of bulk conventional superconductors. In the end I will discuss the main unsolved problem the nature of the transition into the Abrikosov state.

2. Fluctuation e ects in bulk superconductors

I will write about results of investigation which have been obtained in 1980 - 1984 years. Partly they have been published in that time [4-7], partly they have been published recently [8], and some results [9] have not been

published for the present. The transition called now "vortex lattice m elting" was observed in 1981 [5]. On gure 1 the result obtained in this paper on conventional superconductors  $V_3Ge$  is compared with results obtained on high quality YB  $a_2Cu_3O_7$  x samples in many papers in last time [10–12]. In both case a change of the same resistive properties is interpreted as a transition. But in our work [5] this change was interpreted as a transition from the norm al state with superconducting uctuation (which we called as "one-dim ensional state") into the Abrikosov state whereas in YB  $a_2Cu_3O_7 x$  this change is interpreted as vortex lattice m elting [10–12]. A lthough the denom ination "vortex lattice m elting" has become very popular I think that it is bad denom ination for this transition.

The denom ination "vortex lattice melting" assumes a existence of a other transition from the vortex liquid into the normal state. Many scientists think that the vortex liquid is the Abrikosov state also and a transition from the vortex liquid into the normal state exist. For example, in some works [13] the experimental dependencies of resistivity above the "vortex lattice melting" are compared with the ux ow resistivity dependencies. It can not be right. There does not exist a experimental base to think that two di erent transition take place on the way from the normal state into the Abrikosov state. Moreover our experimental results show that the sole transition from the normal state into the Abrikosov state is observed in conventional superconductors.

The denomination "vortex lattice melting" has appeared from "a approach from bottom ". In this approach the uctuation in the Abrikosov state is considered. The Abrikosov state is considered as a vortex lattice. The uctuations cause oscillations of the vortex. When the oscillations become enough big the vortex lattice melting takes place [14]. This image is very clear but this approach is quite no rigorous. The theoretical description of the Abrikosov state of the real superconductors is very di cult because the pinning e ect plays very important role there. Therefore all theories of the vortex lattice melting base on di erent models which have m any assumptions. In most of theories a superconductor without pinning is considered. And this is a main assumption that the Abrikosov state exists in superconductors without pinning. It is obvious from experiment [15] that the A brikosov state exists in real superconductors but it has not been proved that the Abrikosov state exists in ideal superconductor without pinning centers. Moreover some authors are proving that the Abrikosov state can not exist in ideal superconductors [16-18]. If they are right the theories of vortex lattice melting are not right in base.

I will follow in my paper to "a approach from top". In the beginning I will write about the linear approximation region above  $H_{c2}$ . A fler that I will come down in the critical region at  $H_{c2}$ . Then I will tell about the changes which are observed at the transition from the normal state into the A brikosov state. In the end of this part I will write about experimental results which we have obtained in the A brikosov state. Because it is obvious now that the transition into the A brikosov state takes place below  $H_{c2}$  we ought denote the position of this transition. In work [19] I have denoted the position of this transition as  $H_{c4}$ . Below I will use by this denomination.

# 2.1. LINEAR APPROX MATION REGION ABOVE H $_{\rm c2}$

Theoretical description of uctuation in norm all state is more easy than in the Abrikosov state. Therefore more rigorous theories were made for this region. Especially rigorous theoretical description was made for the linear approximation region [20]. This description is so reliable that on base of it we discovered institute transition into the Abrikosov state takes place below H  $_{c2}$  [4]. Later we have con immed this by a determination of H  $_{c2}$  from the magnetization measurement [7].

O ur [4,6,8,9] investigation have shown that the experim ental dependencies in linear approximation region are described very well by Am iM aki theory [20]. The paraconductivity value along and across them agnetic eld direction is an isotropic near H  $_{\rm c2}$  [8,9]. The an isotropy decreases with removal from H  $_{\rm c2}$ . I want draw your attention the rigorous theory by Am i and M aki [20] only are valid for HTSC and "dirty" conventional superconductors [9]. The approximation theoretical dependencies used in most of works, for example obtained from popular H ikam iHarkin [21] and Law rence-D oniac [22] works, do not have a validity region in HTSC.

## 22. CRITICAL REGION

O ur investigations have shown that in the critical region, the experim ental dependencies of the magnetization and paraconductivity of bulk conventional superconductors can be plot as universal function of value (h  $h_{c2}$ ) (ht) <sup>2=3</sup> G i <sup>1=3</sup> and are close to a theoretical dependencies for a onedimensional superconductor [6-9]. t = T=T<sub>c</sub>, h = H =H <sub>c2</sub> (0), H <sub>c2</sub> (0) =

 $T_c (dH_{c2}=dT)_{T=T_c}$ ,  $Gi = (k_B T_c = H_c^2 (0)^3 (0))^2$  is the G inzburg number of a bulk superconductor. This result repeated the result of the speci c heat investigation near  $H_{c2}$  obtained in works [23,24]. These results have easy explanation if we use the lowest Landau level (LLL) approximation of the uctuation G inzburg-Landau theory. The therm odynamic average of any quantity, for example order parameter

is function of tem perature, magnetic eld value and superconductor param – eters through the relation  $F_{GL}=k_B T$  only. In a dimensionless unit system

 $n = (t + h + 2nh) = G_{\frac{1}{2}}; G_{\frac{1}{2}} = G_{\frac{1}{2}}^{1-3} (th)^{2-3}$  is G inzburg number in magnetic eld; k = (n;q;1); n is the number of the Landau level.

A coording to (1) and (2) therm odynam ic averages depend on tem peratures, magnetic eld value and superconductor parameters through =  $_{n=0} = (t \quad 1 + h)=G_{\frac{1}{2}}$  only if terms with n = 0 (LLL) take into account only in (2). Thus, in the LLL approximation region the scaling law is general consequence of the uctuation G inzburg-Landau theory.

The relation (2) in LLL approximation is close to one for a one-dimensional superconductor. We may write this relation in following form

 $j j^2$  is a spatial average value of order parameter. This expression is similar to one for one-dimensional superconductor. A main difference consists in a difference of a generalized Abrikosov parameter value  $a = j j^4 = j j^2$  which is determined by a distribution of the order parameter in the space. Much below the transition (r) = const in one-dimensional superconductor and consequently a = 1. But function (r) = const is not belong to LLL. (This has a simple interpretation: a magnetic for the space through superconductor.) Therefore m in a > 1 for type II superconductor in a magnetic eld. As it is well known Abrikosov has been found, in his fam ous work [25], a = 1.18 for a square symmetry structure but later K leiner, R oth and Autler [26] have shown that a triangular symmetry structure has a lesser value a 1:16. Now there are no reasons to doubt that m in a 1:16 for the LLL approximation.

The di erence  $_{a}$  value of the LLL and the one-dimensional superconductor is small ( $_{a}$  changes from 2 above H $_{c2}$  to  $_{c2}$  to  $_{c2}$  in the rst case and from 2 above T $_{c}$  to 1 below T $_{c}$  in the second case). Therefore the dependencies of the quantities connected with a value of the spatial average order parameter (see (3)) (m agnetization, speci c heat and others) of bulk superconductors near H $_{c2}$  are close to the one of a one-dimensional superconductor.

The LLL approximation is valid at h G i; h  $h_{2}$  2h and h >  $h_{c2}$ =3. For conventional superconductors a LLL crossover eld H <sub>LLL</sub> = H <sub>c2</sub> (0)G i 10 e. It is much smaller than the experimental values of the magnetic eld  $10^{4}$  0 e used usually for mixed state investigation. But for HTSC the H <sub>LLL</sub> value is much more: for Y B a<sub>2</sub>C u<sub>3</sub>O<sub>7 x</sub>, H <sub>LLL</sub>  $10^{4}$  0 e, for B iS rC aC u0, H <sub>LLL</sub>  $10^{6}$  0 e. Therefore the validity of the LLL approximation for HTSC is no so obvious as for conventional superconductors. However it was shown in som e works [27] that the experimental dependencies of the magnetization and the speci c heat of HTSC follow the scaling law obtained in the LLL approximation.

#### 2.3. TRANSITION INTO THE ABRIKOSOV STATE

It is followed from the scaling law that in LLL region a transition must takes place at the same  $_{c4}$  value for all superconductors. Our experimental investigations have con med this. We have measured [7] the (H  $_{c4}$ =H  $_{c2}$  1) value in V<sub>3</sub>Ge and N b<sub>94:3</sub>M o<sub>5:7</sub> with di erent value of the G inzburg num – ber. The relation G i<sub>VGe</sub>=G i<sub>N bM o</sub> is equal approximately 1000 but for both superconductors the  $_{c4}$  1 [19]. The  $_{c4}$  value of Y B a<sub>2</sub>C u<sub>3</sub>O<sub>7 x</sub> is equal approximately –1 also. Thus now there are not reasons to think that the uctuation e ects in Y B a<sub>2</sub>C u<sub>3</sub>O<sub>7 x</sub> di er heavily from the one of conventional bulk superconductors.

The transition in the H  $_{c4}$  connects with changes of resistive properties rst of all. There are observed the following changes: 1) Above H  $_{c4}$  the current-voltage characteristics are 0 hm ic and below H  $_{c4}$  they are non-0 hm ic. 2) Above H  $_{c4}$  the resistive dependencies are described by the paraconductivity theory and below H  $_{c4}$  they can not be described by this theory. 3) The m ain change: the resistive properties of enough hom ogeneous sam ples with di erent am ount of pinning centers are universal above H  $_{c4}$  and they are non-universal below H  $_{c4}$ . It is obvious that this changes connect with the vortex pinning appearance.

From these results which we have obtained freen years ago [5] was clear that the transition into the Abrikosov state occurs below  $H_{c2}$ . Our investigations of high hom ogeneous sam ples have shown that this transition much narrower than the "transition" on the speci c heat, magnetization and on other properties connected with the spatial average order parameter. Thus, the experimental data indicate that two "transition" are observed [19]. It is obvious that the wide "transition" is a crossover connected with change of the spatial average order parameter and the narrow transition is connected with a change of a distribution of the order parameter in space (see values  $j j^2$  and a in the relation (3)). The fam ous Abrikosov work [25] investigated the distribution of the order parameter in space (the value of the spatial average order parameter can be easy calculated (see relation (3)). Therefore the narrow transition (but no the wide crossover) ought be considered as the transition into the Abrikosov state.

A bove three changes are observed in Y B  $a_2$ C  $u_3$ O  $_{7 x}$  single-crystals also. We observed a fourth change also: 4) The ux ow resistivity decreases at H  $_{c4}$  [4,9]. Such changes of the ux ow resistivity we observed on all enough hom ogeneous superconductors which we measured. It is follow from these results that the theoretical dependencies for the ux ow resistivity obtained in the mean eld approximation (see [28]) do not have a validity region in "dirty" superconductors.

O ur m easurement of resistivity along magnetic eld and the measurement the non-local resistivity [8.9] have shown that any transition connected with break of symmetry along magnetic eld [2] is not observed above H  $_{c4}$  in conventional superconductors. Thus, our results prove that the sole transition from the normal state into the Abrikosov state is observed near H  $_{c2}$  in conventional superconductors.

2.4. PROPERT ES OF THE ABRIKOSOV STATE OF REAL SUPER-CONDUCTORS

Below H<sub>c4</sub> the resistive properties of di erent sam ples are non-universal. The current-voltage characteristics are non-0 hm ic and have di erent form for di erent sam ples. At big current the current-voltage characteristics of sam ples with a small critical current can be described by a relation  $E = f(j = j_d)$ , where f is the ux ow resistivity and  $j_{cd}$  is the dynam ic critical current. But even the ux ow resistivity dependence is no quite universal for di erent sam ples [9].

The critical current dependencies  $j_c(H)$  of di erent sam ples are very different.  $j_c(H)$  of some sam ples have a pick near  $H_{c4}$  and the one of other sam ples do not have this pick [9]. The height of the pick was di erent in di erent sam ples. The critical current value in the pick reached 50 of this value before the pick [9].

The ux creep was observed in some samples near  $H_{c4}$  and was not observed in other samples [9]. We observed the change a curvature on a logI logV plot which was interpreted in some recent papers [29] as a transition from a vortex-glass into the vortex liquid. But our results [9] are explained by classical K in -A nderson ux creep theory.

Our investigation have shown that the irreversibility line can not be interpreted as a position of a transition, because the position of this line is no universal for di erent samples [9]. The irreversibility line of sam ples with weak pinning is situated wellbelow the H  $_{c4}$  [9]. The sam e was shown recently for Y B  $a_2$ C  $u_3$ O  $_7$  x [30].

In consequence of the ux creep the resistivity at small current may be very smallbelow H  $_{c4}$  [9]. It causes a artifact in the magnetization dependence if a sample moving is used at the measurem ent [7,9]. In resent works [30,31]

a "discontinuity" in the magnetization at the transition into the Abrikosov state was observed in YB  $a_2Cu_3O_7$  x sample with weak pinning. This discontinuity was interpreted as a consequence of a rst order transition. But this discontinuity may be the artifact caused by sharp decreasing resistivity of sample below H  $_{c4}$  as well as in conventional superconductors.

You see now that the state below H  $_{\rm c4}$  is much more dicult for theoretical description than the state above H  $_{\rm c4}$ . It is very dicult to described a state in which properties are not universal. Therefore the "approach from bottom" is bad.

3. A bout nature of the transition into the A brikosov state

It is clear from the experimental results what occurs in  $H_{c4}$ . Above  $H_{c4}$  we have the normal state with superconducting uctuation. Below  $H_{c4}$  the voltage at sm all current is equal zero if the ux creep is absent. A coording to the Josephson relation hd' = dt = 2eV, V = 0 m eans that the phase dimense dimense is a constant in time. This means that above  $H_{c4}$  we can not conduct a line through superconducting region only and below  $H_{c4}$  we can make it. Thus, it is obvious that the phase coherence appears below  $H_{c4}$ . But it is not known now what type is this transition. This problem is connected with a problem of existence of the A brikosov state in ideal superconductors without pinning.

Results of our recent investigation of uctuation e ects in thin  $\ln s$  of conventional superconductors [32] are important for the understanding the nature of the transition into the Abrikosov state. We have found that the position of the change of the resistive properties which we interpret as the transition into the Abrikosov state depend on a am ount of pinning centers in thin  $\ln s$ . In thin  $\ln s$  with sm all am ount of pinning centers this change do not observed up to very low magnetic eld. The resistivity dependencies are described by the paraconductivity dependencies well below H<sub>c2</sub>.

We interpret it as a dependence of a position of the transition into the Abrikosov state,  $H_{c4}$ , on a amount of pinning centers of two-dimensional superconductors and absence of the Abrikosov state in ideal superconductors. In my recently work [18] I have propose a concept of the transition into the Abrikosov state in two-dimensional superconductor according to which the position of this transition depend on a sample size or a amount of pinning centers.
