Conceptual design of nanostructures for e cient photoinduced phase transitions

By means of M onte C arb simulations on a kinetic model, we demonstrate that the e ciency of a photoinduced phase change can in general be enhanced drastically by using a superstructure of an appropriate combination of two components. This is due to the accelerated nucleation of converted dom ains in the structural blocks relatively close to local instability. The present m echanism provides a general guideline on the design of photocontrollable m aterials with potential applications for m em ory and storage devices.

C ontrol of m aterial phases by external stimuli, especially by light, has been a subject of much interest in recent years in view of potential applications form em ory and storage devices in the future. It requires a material exhibiting bistability between two distinct phases. In many cases the global bistability of a solid has a local origin [1{4], while the photo-conversion between phases usually proceeds in a cooperative fashion [3,4]. This phenom enon is therefore called a photoinduced phase transition, in analogy with ordinary (therm ally induced) phase transitions.

The actual observation of the phenom enon has been limited within a small number of materials: one or a few examples from each class of materials, including spincrossover complexes [3], P russian blue analogues [1,5], organic charge-transfer complexes [4] and conjugated polymers [6]. The scarcity of materials is presumably related to the requirem ent that the two phases must be energetically close to each other, otherwise the metastable phase would return to the stable phase quickly.




FIG.1. (a) Schem atic bistable potentials with opposite relative stabilities in and units. (b) Schem atic one-, two-, three-dimensional superlattice structures consisting of the and blocks.

Here we propose a general scheme to overcome this difculty. Suppose we have a bistable material in which the m etastable state B is much higher in energy than the stable state A, so that photo-conversion is di cult. Let us then prepare a companion material in which the relative stability is opposite (see Fig.1(a)). If we com bine the two materials in an appropriate fashion, e.g., in a superlattice as shown in Fig.1(b), and if there are su cient cooperative interactions that favor the and units being in the same state (either A or B), then the energy of the A phase in the total system can be made degenerate with that of the B phase. This is rather an obvious way of designing new suitable materials in general. However, this approach yields more than that: W e will dem onstrate in the following that the photo-conversion e ciently is drastically enhanced in such mixed struc-

tures com pared with uniform structures. W e consider a phenom enological model described by

the Ising H am iltonian [7,8]

on a three-dimensional lattice, where the 'spin' variable

 $S_i =$ 1 denotes the two states (B and A) of the site i with the energy di erence 2". The nearest neighbor (n.n.) coupling J_{ij} is assumed to be a positive constant J, so that the neighboring sites prefer to be in the sam e state. W e use a simple cubic lattice of N Ν N sites with periodic boundary conditions. N = 60 is a typical size used in our simulations. We consider the superstructures consisting of two kinds of blocks, and , alternating in one-, two-, or three-dimensional (1D, 2D, 3D) directions as shown in Fig. 1(b). The size of each block is n in the con ned directions. (The system size N must be an integer multiple of 2n.) The site potential "_i is assumed to be constant in each of the blocks, =2 and

=2 in the and blocks, respectively, corresponding to the situation illustrated in Fig. 1(a). Note that the system is symmetric with respect to the interchange of A and B (and). The case of = 0 corresponds to the uniform system .

For > 0, the and blocks favor the A and B states, respectively. However, the system still tends to be in a uniform state without phase separation, if the block thickness n is not very large and the inter-block interface energy proportional to J outweights the intrablock energy gain proportional to j i. The condition for uniform ity is written as j j < c 4dJ=n, where d is the dimensionality of the superstructure. Under this condition, the uniform ground states are doubly degenerate: The phase of all the sites being in the A state has the same energy as that of all the sites in the B state.

We have studied the kinetics of the model at nite temperatures under external excitations by means of a classical M onte C arlo simulation [9], wherein the spin

ipping rate at each site j is the sum of the therm al and external term s: $w_j = w_j^T + w_j^P$. When we consider selective excitation from A to B, we set w_j^P (A ! B) = W and w_j^P (B ! A) = 0. In each M onte C arb step (M C S), both therm al and external spin- ip trials are performed at every site once on average. The heat bath m odel is used for the therm al ipping rate w_j^T , although we have checked that other algorithm s such as the G lauber, M etropolis, and A rrhenius m odels give essentially the same results.

Suppose the system is initially in the A phase and develops under an excitation rate W from A to B at tem –

perature $k_B\,T$ = J. Figure 2 (a) shows the fraction of sites in the B state as a function of the excitation time t for various W in the hom ogeneous case of = 0. For weak excitation with W = 0.09, the system remains perm an ently in the A phase, whereas conversion to the B phase occurs for larger W. The converted fraction does not increase linearly with time but grows rather suddenly after a certain time. This is a clear relation of the cooperative nature of the phase change. This type of behavior was actually observed in a spin-crossover com plex, where the transition occurs with the absorbed photon ux of about 10^{18} cm 3 s 1 [3].




FIG.2. M onte C arlo simulation on the kinetics of the excitation-induced phase transition in the system of 60 60 60 sites at $k_B T = J$. (a) The fraction of converted sites as a function of the excitation time t in M onte C arlo steps (M CS) with = 0 for various excitation rate W per M CS. (b) The converted fraction in the 2D superstructure with n = 1 for W = 0.05 per M CS at $k_B T = J$, in the case of = 0.8 $_c$ = 6.4J (thick line) compared with the case of = 0 (thin line). Solid, broken and dotted thick lines show the total fraction and the partial fractions of the and blocks, respectively.

W em ove on to the case of a superstructure with ~~6~~0. Figure 2 (b) displays the time evolution for a weak excitation rate W = 0.05 at $k_{\rm B}\,T$ = J in the 2D superstructure with the block size n = 1 and = 0.8 $_{\rm c}$ = 6.4J. The phase change occurs in a short time in contrast to the case of = 0, for which there is no indication of a phase transition. (Note the di erent time scales of Fig.2 (a) and Fig.2 (b).)

To clarify the underlying mechanism of the accelerated phase transition, we plot in Fig. 2 (b) the converted fractions in the blocks and in the blocks separately. The converted fraction of the blocks grows quickly from the beginning, and then that of the blocks gradually follows. By tracking the time evolution of all the sites, it has been found that a nucleated dom ain of B states in a

block does not decay so quickly as in the case of the uniform structure because of the local stabilization energy , thereby allowing further grow th of the B dom ain around the nucleus rstly in the block and then onto the surrounding blocks. Although the energy di erence counteracts as an energy cost in the blocks, the grow th process continues once the stable nucleus is form ed.




FIG.3. Dependence of the conversion time t_p on the excitation intensity W in the 2D superstructure with n = 1 at $k_B\,T$ = J for various with $_c$ = 8J.

The time of continuous excitation required for inducing the phase transition, t_p , depends on the excitation intensity W . The W -dependence of t_p is shown in Fig. 3 for various in the 2D superstructure. Here t_p is de-

ned by the tim e of the converted fraction exceeding 0.8. There is a threshold W $_{\rm c}$ below which the phase transition does not occur for each , and t_p sharply diverges from above W $_{\rm c}$. W e have con m ed the critical behavior by extending simulations up to 100,000 M CSs. Similar results have been obtained for 1D and 3D superstructures. The existence of a threshold light intensity for the photoinduced phase transition was also suggested in real m aterials [3,10]. The threshold W $_{\rm c}$ at which t_p diverges is reduced drastically with increasing j j. The results in Fig. 3 in ply that the required tim e t_p at each W drastically decreases with increasing j j. For example, at W = 0.12, the phase transition in the case of = 0.9 $_{\rm c}$ requires only one tenth of the excitation time for the hommogeneous structure with the same excitation intensity.

In conclusion, by using nanostructures, we can drastically reduce the threshold light intensity and enhance the e ciency of phase switching in both the forward and backward directions. With this principle, which does not rely on the details of m aterials, the range of useful m aterials can be extended substantially, because an appropriate com bination of inferior m aterials can produce a superior m aterial for photoinduced sw itching.

The present mechanism was hinted by the study of the photoinduced magnetism in cobalt-iron cyanides [1,5,11{14], which can be considered as a mixed system of di erent local environments with cooperative interactions due to lattice distortions [14]. It would be very interesting to make a superstructure in this class of materials as well as in other materials such as perovskite manganese oxides [15,16], for which a photoinduced metalinsulator transition was observed in the bulk [17].
