Orbital Zeem an e ect: Signature of a massive spin wave mode in ferrom agnetism

By deriving the quantum hydrodynam ic equations for an isotropic single-band ferrom agnet in an arbitrary magnetic eld, we not that a massive mode recently predicted splits under the action of the eld. The splitting is a peculiarity of charged ferm ions and is linear in the eld to leading order in q bearing resemblance to the Zeem an elect in this limit, and providing a clear signature for the experimental observation of this mode.

Magnetism in solids has been one of the most studied sub jects in physics for the past decades. In particular the behavior of propagating spin waves in metallic materials has now a long list of contributions in the literature. Spin waves in ferrom agnetic materials were rst predicted by Bloch [1] and Slater [2] and later observed in iron by Low de. [3] These rst theories were constructed based on lattice models of local moments. Predictions for spin waves using Ferm i liquid theory [4] were rst made by Silin for param agnetic system s. [5] Param agnetic spinwaves were found to propagate only under an applied magnetic eld. Abrikosov and Dzyaloshinskii [6] were the rst to develop a theory of itinerant ferrom agnetism based on Landau's theory of Ferm i liquids. Although correct at the phenom enological level, the microscopic foundations for this theory were estabilished only much later by D zyaloshinskii and K ondratenko. [7]

In this paper we derive the hydrodynam ic equations of the ferrom agnetic Ferm i liquid theory (FFLT) for a nite magnetic eld and show that an intrisic degeneracy of a recently predicted massive mode [8] exists and is lifted under the external eld, similarly to the Zeem an splitting of a single spin in a magnetic eld. Underneath this elect we identify the breaking of chiral symmetry by the external magnetic eld in the case of charged fermions, which relates to the orbital motion developed under the Lorentz force. Besides being a clear signature of the massive mode, it is suggested that quantization of this mode will lead to a system of massive magnons with \up" and \upwredown" states that split under an external eld. We estimate the values for the elds where the elect will be observed in typical weak ferrom agnets.

For isotropic m etals, the equations describing dynam – ics of param agnetic spin waves are similar to the ones that result from FFLT in the smallmoments limit. This is expected since in this limit quasi-particles can be dened and one recovers the kinetic behavior of ordinary Fermiliquid theory. However, FFLT rests on the assumption of a quite dierent, symmetry-broken, ground state and the resulting spin waves propagate with no external

m agnetic eld present. The Goldstone mode associated with spontaneously broken spin rotation invariance has been the paradigm of spin-waves in an isotropic single band ferrom agnet and can be derived from FFLT (as well as from lattice models). However, FFLT contains spin-wave modes that have not yet been observed, as pointed out in Ref. [8], where the proper hydrodynam ics and param eters for the propagation of the lowest in energy of these modes have been studied. Such mode is not a Goldstone mode, hence its dispersion may in principle be gapped for q = 0. Indeed, for low q and zero external magnetic eld, its dispersion has been shown to be of the q^2 , [9] and propagation is possible only form $! = !_1^+$ in the quantum hydrodynam ic regime (at tem peratures for which collisions are almost absent). This is in contrast to the Goldstone mode which is purelly quadratic and also propagates at collision dom inated tem peratures. [10] P ropagation of the m assive m ode also requires that the interactions have some nite amplitude with p-wave sym m etry. Lack of observation of such a mode in neutron scattering experim ents can be attributed to the low spectralweight the mode carries at small q (q^2 when rated against the Goldstone mode), however indirect signs of its existence have already been observed. We begin our derivation by writing the equal time propagator for a system of interacting ferm ions, $G_{1\ 2}(r_1r_2)$ $ha^y_{_1}(r_1)a_{_2}(r_2)i$, where a is the usual ferm ion anihilation Heisenberg operator and the average is taken with a ferrom agnetic ground state. The equation of motion for G is, in spin space, $\varrho_tG(r_1r_2)+(i=h)$ $dr^0[H(r_1r^0)G(r^0r_2)$ $G(r_1r^0)H(r^0r_2)]=g[G];$ where H is the interaction Hamiltonian and the functional g[G] is the full time-derivative of G. Following an usual script, one takens to a mixed r-p representation by dening H $_p(r)=dr^0e^{ip}$ $\stackrel{\hat{V}=h}{=}H(r+r^0=2;r$ $r^0=2)$, and likewise for N $_p(r)$, which brings the equation of motion to the form

where we have (anti) com mutation if m + n is (odd) even and sum ation over repeated G reek indices.

It is clear from this expression that the repeated action of the derivatives on the uctuating elds generate ∞ cients that are higher order in q for higher powers of h. If we keep term sup to set order in q,

where square braces indicate the usual comm utator while curly braces are Poisson brackets. Therefore, keeping rst order in q leads to the same result obtained by dropping terms in the series that are explicitly 0 (h^2). However, H $_{\rm P}$ (r) is itself a function of h, which disables, at this point, comparison with a semi-classical approach.

For the ferrom agnetic Ferm i liquid there are two distinct underlying scenarios that we call (following Ref. [8]) classical and quantum spin hydrodynamics. We want here to discuss in a general way the origin of these two regimes. For this purpose, it should be recalled that the equilibrium density matrix for a ferrom agnetic state is written in the quite general form, [6]

where are Pauli matrices and m $_0$ is the equilibrium magnetization density, which is a conserved quantity of the ferromagnetic Hamiltonian. From this it is clear that the commutator in (3) is zero unless there are uctuations about equilibrium.

At high tem peratures, therm all uctuations dominate and this commutator remains irrelevant. The remaining \classical" terms lead to the known Bloch-like hydrodynamics for the Goldstone mode. This regime is refered to as \classical spin hydrodynamics."

At low tem peratures quantum uctuations dom inate, and the commutator in (3) becomes important. It remains nite as long as the uctuations contain, besides the usual Goldstone-mode, contributions from non conserved quantities as it is the case of spin-current, whose oscillations give rise to the gapped mode studied in Ref. [8], where this regime has been called \quantum spin hydrodynamics."

The crossover temperature for these two regimes has been found to scale with $(!_1^+)^{1=2}$, where $!_1^+$

 $2 \text{ jm }_0 \text{ j(F}_1^a=3 \quad \text{F}_0^a)=h \text{N (0)}$ is the gap, $\text{F}_0^{(a)s}$ are the usual dimensionless spin (anti) symmetric interaction parameters, and N (0) is the density of states at the Fermi surface.

The preceding discussion is general and establishes the origin of the massive mode. We now turn to the small moments limit, where kinetic equations can be amenably derived. In this limit, we write the extive quasiparticle Hamiltonian and density matrix respectively as H $_p$ $_0$ (r) = $_p$ (r) $_0$ + $_p$ (r) $_0$; and N $_p$ $_0$ (r) = $_p$ (r) $_0$. These forms for the Hamiltonian and density in mediately give

Here the internal eld is given by

where P are Legendre polynom ials, H is an external magnetic eld, and all coupling constants are h independent. We see then from Eqs.(5) and (6) that the commutator of Eq.(3) gives two contributions: a zero-th order term in h which is just the (Larmor) precession of the internal magnetization and a rst order term in h that is the precession about the eld generated internally. Carefull examination of Eq.(2) shows that this term is the only rst order term in h of the series. That is, provided that the elective H amiltonian is of the Fermi liquid type, the long wavelength limit is equivalent to a Wentzel-K ramers-B rillouin or (eikonal) semi-classical approximation.

We want now to have the Lorentz-force operator explicitly factorized. This is achieved by rewriting Eq.(3) in a gauge transform ed $\$ for which A = 0. Also, to leading order in the uctuations, the non-commuting parts of the Poisson brackets can be dropped, giving

We see that the gauge boost factorizes a non-chiral term whose am plitude is proportional to $e \not H$ j. This is the contribution from the orbital motion of charged quasiparticles, a result similar to the one found in the theory of normal metals, [11] where it is known simply to shift the param agnetic resonances. In the isotropic ferrom agnetic case we are studying here this term plays a more essential role. Equation (7) is formally identical to the one obtained in a normal metal. The dierence rests on the broken symmetry ground state, whose density is given by Eq.(4).

Let $R^{+(\cdot)}$ be a simultaneous proper (improper) rotation of real and momentum axes and likew ise $SU^{+(\cdot)}$ for

the spin axes. Exam ination of Eq.(7) reveals that in the absence of a magnetic eld, R are sym m etry operations both in the param agnetic and ferrom agnetic cases, SU is not a sym m etry in either case, and SU † distinguishes the two cases, being a broken sym m etry in the ferrom agnetic case. The presence of H adds two terms to the equation, one that couples to spin through $h_{\rm p}$ and the orbital one discussed above which couples to charge. In a charged param agnet, the form er will break SU † sym metry yielding propagating param agnons as a consequence, while the latter will break R (chiral) sym m etry. However, since the spin modes are sustained by a nite H, [5] the degeneracies associated with chiral sym m etry are lifted with H, before spin waves can propagate.




FIG.1. D ispersion relations at vanishing temperatures. H e ${\rm H~_0~j(1+F_0^{~a}=3)=m}$.

In the isotropic ferrom agnet, spin waves can propagate in the absence of H , for the SU † is a spontaneously broken symmetry and the internal \sustaining" eld is provided by m $_0$. Hence propagating m odes exist before the formation of orbits with the breaking of R by a nite H , and some of these modes may be degenerate. B reaking chiral symmetry should then lift such degeneracies. Note that the Goldstone mode should not be a ected by H (apart, of course, from shifting) for the term breaking chiral symmetry only couples to charge. However, the gapped spin-wave mode splits as it is seen in the dispersion relations of Fig.(1).

In order to see how this happens, we nish linearizing Eq.(7), and then solve it in the hydrodynam ic lim it. [9] In particular, since we are seeking equations on the total magnetization density metric $_{\rm p}$ N $_{\rm p}$], and spin current tensor j $_{\rm i}$ tr[$_{\rm p}$ (0H $_{\rm p}$ =0p $_{\rm i}$)N $_{\rm p}$], we trace the product of with Eq.(7) and keep only terms that are linear in the uctuations. The result is a set of coupled equations,

Here m m m₀, H H H₀ where H₀ is a uniform magnetic eldapplied parallel to the z axis dened by the equilibrium magnetization m₀, ₀ hN (0)=2 J + F₀^a j H = eJ + J(1 + F₁^a=3)=m is the orbital amplitude, $c_s^2 = (v_F^2 = 3)$ J + F₀^a j(1 + F₁^a=3) is the squared spin wave velocity, and !_D = $(1 + F_1^a = 3) = D$ is the p-wave amplitude of the scattering integral for a spin-diusion relaxation time D.

We consider the response to a driving eld H which is transverse to \hat{z} and oscillates with frequency ! . It is then easy to see that the three longitudinal components \hat{z} j vanish together with m_z . This means that there are no magnetization gradients in the longitudinal direction and there is no transport of longitudinal magnetization in any direction. The remaining 6 components can be

conveniently \folded" onto the complex \vector" j⁺ % j % + i % j % , which measures the transport of transverse magnetization m⁺ m_x + i m_y under the driving eld H⁺ H_x + i H_y . Solving Eqs.(8) and (9) for the Fourier components yields [12]




FIG. 2. Spectral weight in arbitrary units. The splitting is clearly seen as the magnetic eld increases. Numbers on the upper left corner give the amplitude of one plot relative to the next. These amplitudes are of order of 10^{-2} the (not shown) Goldstone mode amplitudes which do not split under the external eld. The curves are translated vertically to facilitate analysis. The values of H correspond to hundreds of Gauss in, e.g., MnSi.

This condition is obtained in practice by sheding neutrons or photons adequately on a nite sample's surface, and is the condition that maxim izes the non-chiral orbital contribution in Eq.(10); in the in nite system, we can think of transverse magnons if we wish to quantize the hydrodynam ics. Longitudinal magnons will be treated elsewhere. [12] In Fig.(1) we see the dispersion relations for dierent values of the external eld. These are obtained by looking into the free modes (H = 0). It is clear that the degeneracy is only exact at q = 0. We see also that it constitutes a three-fold degeneracy, however, the two constant branches shown $! = ! \frac{1}{1}$) are spurious when H₀ = 0 in the sense that there is no spectral weight associated with them, as seen in Fig.(2) where $S(q;!) / Im[m^+ = H^+]$ (which is the important quantity in experiments) is plotted as a function of! and H . Under a nite magnetic eld only one of the spurious branches develops weight while the degeneracy is lifted.




FIG.3. Linear behavior of the dispersions with H . The e ect of H on the Goldstone mode (! $!_{\,\rm L}$ 0) is seen to merely shift its frequency.

The important point to note is that the frequencies of the Goldstone mode (the traditional spin-waves) only shift their loci as the external magnetic eld increases whereas the gapped mode splits. This can be seen in Fig.(3) where the behavior of these dispersions with the external eld is shown (including the Goldstone mode). It is then clear that the splitting of the gapped mode should be considered as a distinctive feature in experiments searching for a direct observation of it. It should be helpful to make a statement about the quantities involved for some traditional materials: From data found in the literature we estimate the elds shown to be in the range of hundreds of Gauss for typical weak ferrom agnets like MnSi, $ZrZn_2$, and Ni₂Al. This corresponds to a gap of tenths of meV in these materials. [13]

For small values of H and q (up to $0.1!_1^+$), the dispersions may be put in the simple form $! = c_s^2 q^2 = !_1^+$ for the Goldstone mode and $! = H + !_1^+ - q^2$ for the gapped mode. [14] Q uantization of the theory in this lim it will yield massive magnons with an \up-down" degeneracy which is lifted by the magnetic eld, in much

the sam eway as in the Zeem an e ect of a single spin. The possible existence of (low temperature) magnons with mass and a Zeem an-like degeneracy makes room for new questions realated, e.g., to the collective behavior of a handful of these excitations. Before these questions are put forward it is, however, prudent to focus on the issue of whether these results can be observed by traditional experiments. The spectral weight of this mode, of order of 10^{-2} the usual spin waves (see Fig.(2)) stands as an obstacle. Our main emphasis here is whence on the additional criterium such a degeneracy provides to track down the massive mode. In a companion longer article we also discuss how these results are expected to show in a conduction ressonance experiment. [12]
