# R egular binary therm al lattice-gases

#### Abstract

W e analyze the pow er spectrum of a regular binary them al lattice gas in two dim ensions and derive a Landau $P$ laczek form ula, describing the pow er spectrum in the low -w avelength, low frequency dom ain, for both the full $m$ ixture and a single com ponent in the binary $m$ ixture. The theoretical results are com pared w ith sim ulations perform ed on this $m$ odel and show a perfect agreem ent. The pow er spectrum s are found to be sim ilar in structure as the ones obtained for the continuous theory, in which the central peak is a com plicated superposition of entropy and concentration contributions, due to the coupling of the uctuations in these quantities. Spectra based on the relative di erence betw een both com ponents have in general additional B rillouin peaks as a consequence of the equipartition failure.

## I. INTRODUCTION

Lattioe-gas autom ata (LGA), as introduced by Frisch, H asslacher, and Pom eau [IM1] are ideal testing system s for kinetic theory. A though they have a sim ple structure, which $m$ akes them extrem ely e cient sim ulation tools, they still address the fullm any-body particle problem. M uch of the e ciency originates from the discretization of the positions and velocities of the point-like particles onto a lattice. T he sim pli ed dynam ics is a cyclic process: a stream ing step, where all particles propagate to neighboring lattice sites, follow ed by a local collision step. T he collisions typically conserve $m$ ass and $m$ om entum, and in addition energy if the $m$ odel under consideration is therm al.

Lattice-gases are capable of sim ulating macroscopic uid ow hand can be used for studying ow through porousm edia $\left[\begin{array}{l}1 \\ 1\end{array}\right]$, im $m$ isciblem ulticom ponent uids [ill
 m odels are not G alilean-invariant, tem perature is not w ell-de ned, the transport coe cient have unexpected behavior
 di cult to $m$ ake connections w ith realistic system $s$. A though in the early years the LG A's were thought to seriously com pete $w$ th other uid ow solvers, the $m$ ain line of research has shifted to a testing ground for concepts in kinetic theory. The $m$ ain $m$ otivation for this paper lies in the exploration of the lim its of them al lattice-gas capabilities conceming di usion-like phenom ena.

Di usion can be incorporated in LGA's in several ways. The com putationalm ost e cient m ethod is the color
 in such a m ixture painted w ith a probability corresponding to the concentration and a color-blind observer would not notige any di erence, i.e. all transport properties are the sam e as for the single-com ponent uid. But in addition there is an extra hydrodynam ical and color-dependent di usion $m$ ode that does not interfere $w$ ith the other $m$ odes.

In this paper we consider a di erent way to include di usion, nam ely the regularbinary m ixture [il $\overline{2}_{\mathrm{n}} \mathrm{l}$. In the regular binary $m$ ixture one has tw o distinct species of particles, i.e. di erent $m$ ass. For particles of the sam e species the exclusion principle holds and hence there can be at m ost one particle of a given species in any velocity channel. There is, how ever, no mutual exclusion for particles o di erent species. C onsequently, a given velocity channel can be occupied by tw o particles, provided they both belong to a di erent species.

O ne can interpret this as each species living on its own but identical lattioe with exclusion. Since each specie is restricted to its ow $n$ lattioe there can be no $m$ ass exchange betw een the tw o lattioes and there is localm ass conservation

for both species. U pon interaction, how ever, particles of both lattices corresponding to the sam e node are able to exchange $m$ om entum and energy, provided this does no violate localm ass conservation and exclusion for each species. $C$ onsequently, the dynam ics of the regular binary $m$ ixture is $m$ uch $m$ ore involved than that of the colorm ixture, but it is closer to the dynam ics of real uids. For sim plicity we here will assum e the special case of the two species having the sam e physicalproperties, i.e. the sam em ass, and distinguish both species by a di erent color label.
$W$ e analyze the $m$ odel at the $m$ icroscopic level and focus $m$ ainly on the behavior of the power spectrum. T he coupling betw een energy transport and di usion that arises in these system $s$, results in a $m$ ore com plicated structure of the pow er spectrum $[1], 1], 1][1]$, in which the centralpeak now contains com bined e ects ofboth entropy uctuations and concentration uctuations. M acroscopically this coupling $m$ anifests itself as the D ufour e ect (a concentration gradient induces a heat- ow ) and the Soret e ect (a tem perature gradient induces a di usion ux).

The rem ainder of this paper is organized as follow s . W e start by introducing the regular binary therm al lattice gas m odel in section II and use the $m$ olecular chaos assum ption to obtain the linearized collision operator. Section 'III is concemed w th a m ode analysis of the linearized system, revealing the appearance of an extra di usion $m$ ode. The m odes related to therm aldi usivity and m ass-di usion are coupled and form two non-propagating, di usive $m$ odes. Furthem ore, in section 'IV', we derive a Landau P laczek analogue, a form ula which describes the pow er spectrum in the hydrodynam ic lim it (long w avelength, sm all frequency dom ain), which we check w ith sim ulation results perform ed on this system in section In the nal section we give a brief overview of the $m$ ain results and som e concluding rem arks.

## II. THEREGULAR BINARY GBL-MODEL

T he LGA m odelwe like to consider here is a them alm odelconsisting oftw o di erent interacting species ofparticles w ith identicalm ass. They can be thought of to live on separate two-dim ensional hexagonal lattices on which they propagate independently, but red and blue particles corresponding to the sam e node interact during the collision. The velocities are discretized and have a spatial layout as shown in gure $\overline{\underline{1} 1}$. They are distributed $\beta$ ver four rings: one ring contains a single null-velocity, and three rings each contain six velocities $w$ ith $m$ agnitude $1, \overline{3}$, and 2 . T he velocity set is of size 19, and equivalent to the G B L-m odel, proposed by G ros $1 \mathrm{~s}, \mathrm{~B}$ oon, and Lallem and [181]. Since the m odel under consideration is basically a combination of tw o GBL models, particles of di erent type (red and blue) can have the sam e velocity. H ow ever, there can not be $m$ ore than a single particle of each type in a given velocity state. The multiple rings correspond each to a di erent energy level and are a necessary requirem ent in order to introduce therm alproperties. This particular velocity set guarantees the absence of spurious invariants and results in m acroscopically isotropic behavior [19].
$T$ he state of a node can be speci ed by a set ofboolean occupation num bers $n_{i}$, denoting the presence or absence of a particle of type $=f r ; b g$ in velocity channel $c_{i}$, where $i$ is a label running over all 19 velocities. D ue to the boolean nature of the LGA, the ensemble average of the occupation num bers $f_{i}$ in equilibrium, is described by a

$T$ he collision rules that are used are taken in to account by the transition $m$ atrix $A$, which contains the probability that on collision a state is transform ed into an lequivalent" state. $W$ e denote the collection of states that can be tpansform ed

We adopt m axim alcollision rules, i.e. under collision a state can transform in any other state w ith in the sam e equivalence class, including itself, thus ful lling all conservation laws. The density and energy density enter the collision operator through $P$ ( $s$ ), the probability of occurrence of state $s$ in equilibrium. In the Boltzm ann approxim ation, the velocity channels are assum ed to be independent, hence $P$ ( $s$ ) can be w ritten as

$w$ here the diagonal matrix $i_{i j}$ is determ ined by $i_{i j}=f_{i}\left(1 \quad f_{i}\right)$, which is the variance in the occupation num ber of a channel w th the corresponding labels. It can easily be checked from Eq. (5) that is a symmetric 3838 m atrix. In contrast w the colored LGA [1] [1], is a 38 -dim ensional diagonalm atrix due to the fact that there is no mutual exclusion of a red and blue particle $w$ th the sam e velocity. It also enables us to introduce the colored them al scalar product $[11,1$

where we adopt the convention that the $m$ atrix is attached to the right vector.

## III. PERTURBATION THEORY

In rst approxim ation the behavior of the system can be obtained by considering the uctuations $f_{i}(r ; t)=$ $f_{i}(r ; t) \quad f_{i}$ and analyze these deviations from the uniform equilibrium state in term $s$ of eigenm odes. The solutions of the Boltzm ann equation (2) are then of the form

$T$ his form is determ ined by the requirem ent that it is orthogonal to the four other invariants. In the case of equal red and blue density the last term on the righthand side vanishes, but in general this is not the case. The origin of this term is in fact the absence of equipartition in this $m$ odeldue to the exclusion_principle, which causes the ratio $f_{\text {ir }}=f_{i b}$ to be dependent on the velocity of the particles as can be seen from Eq. (II). N ote that this last invariant is also

$T$ he choice of jsi and jdim ade here is based on the correspondence of the de nition of jisi $w$ ith the one $m$ ade for the G BL m odel and its colored countenpart [1" 1 going to be the zeroth order of an eigenm ode the choice is som ew hat arbitrary and any two linear com binations that are $m$ utual orthogonal could be used as well. The current choice, how ever, w ill facilitate us to m ake a connection w ith continuous theory and the proper transport coe cients.
$N$ ote that this is sim ilar to what is done in the case of continuous theory and generalized versions of hydrodynam ics (See R ef. [] $]$ ] and references therein), where one also needs to obtain a set of variables that are statistically independent based on them odynam ic uctuation theory. This does not uniquely $x$ these variables, and the freedom that rem ains can be used in order to select an appropriate, orthogonal set for the speci c problem.

Follow ing the $m$ ethod of $R$ esibois and Leener [20 ${ }^{-1}$ ] we need to nd the $k$-dependent eigenfunctions and eigenvalues of the single-tim e step Boltzm ann propagator

Equating the determ inant to zero we nd that there are three di erent eigenvalues and we can obtain the form of the rem aining three zeroth order eigenfunctions. A s the form of the last three quantities suggests by com parison with Eq. (3) , these quantities are related to transport coe cients. In the low density lim it and in the lim it of only one specie, one can identify as being the therm al di usivity of the GBL model. In the low density lim it D w ill correspond to the self-di usion coe cient. Their interpretation as transport coe cients is justi ed in A ppendix $\mathbb{P}^{-1} \mathrm{I} T$ he rem aining value $Q$ can not be interpreted as a transport value, but rather is som e m easure of the coupling betw een di erent $m$ odes.

U sing Eq. ( $\left.\left.{ }^{3} \overline{3}\right]_{1}\right)$ we can evaluate the ve transport coe cients corresponding to the hydrodynam ic $m$ odes. In the case of the tw 0 soundm odes (2-G) th is leads to the sounddam ping

In the low density lim it one nds that the two eigenm odes ( $\left.\overline{3} \overline{7}_{1}\right)$ up to a norm alization factor w ill converge to jisi and jdi as de ned in Eqns. (111) and (121). C onsequently one obtainss ! ; , which is an illustration of the decoupling of entropy and concentration uctuations in this lim it. In general, how ever, these tw o \true" transport coe cients do not seem to correspond w ith a conventional transport coe cient, but rather they alw ays appear in com bination w ith each other, and it is only in the appropriate lim its that they reduce to the them al di usivity and di usion coe cient. This is com pletely in agreem ent w ith the results know $n$ for the continuous theory $\left[\frac{1}{2}\right.$ of uctuations in concentration and entropy results in the sam e e ect.

In the present $m$ odel, how ever, there is som e am biguity in the choice $m$ ade for the basic invariants. To arrive at this last form ula it was only necessary to assum e that the invariants ji and jdi, are mutually orthogonal, and span a 2 -dim ensional subspace in the null-space which is perpendicular to $\dot{j} \cdot i, \dot{\mathcal{J}}$ ? $i$, and $\bar{p} i$. A good choice necessarily leads to the proper $m$ odes in the fully know $n \lim$ 进 of one specie. A though this puts som elm itations on the possible choices it $w$ ill not uniquely $x$ the basis. The present choice for $\bar{j} i$ in ( $\left(1 \overline{1}_{-1}^{\prime}\right)$ is how ever the $m$ ost natural extension of the conventional form ulation [1d] and we w ill refer to as being the generalized them al di usivity.
$T$ his problem is $m$ ore easily identi ed in the di usion-like $m$ ode jdi. In the present form ulation (il2 ${ }^{2}$, it contains in general a contribution proportional to pi, rather than being a w eighted di erence of the red and blie densities only as found in the colored G BL m odel [14]. This already suggests that th is vector is not the proper generalization of the self-di usion $m$ ode. This is consistent w the continuous theory $[1 \overline{1} \bar{d}$, where the analogue of the $s$ also depend on $m$ ore than the them aldi usivity and di usion only. W e will address this sub ject again in a later section.

An exam ple of the full w ave-vector dependent realeigenvalue spectrum is show in F ig. ${ }^{1,1}$, which also con m s the absence of spurious invariants. O fall eigenvalues only the ve related to the hydrodynam ic $m$ odes go to zero in the $\lim$ it $k!0$. It is $w$ ith these $m$ odes that the binary $m$ ixture responds to deviations from therm alequilibrium

The rst tw o eigenvalues describe sound propagation in the two opposite directions parallelto k w ith $\mathrm{C}_{\mathrm{s}}$ the adiabatic sound speed, the third eigenvalue describes the shear mode, and the last tw o eigenvalues represent purely di usive, non-propagating processes. In this hydrodynam ic regim e characterized by $k \quad 1$, where is the $m$ ean free path length, one can exploit the fact that the realcom ponent of the eigenvalues of the hydrodynam ic $m$ odes is $m$ uch sm aller than that of the kinetic $m$ odes. W e will use this in the next section in order to obtain the Landau P laczek form ula ( $5 \cdot{ }^{-1}{ }^{\prime}$ ) for the pow er spectrum .
 $T$ his is the generalized hydrodynam ic regim $e(k<1)$, and the transport coe cients become $k$ dependent. The hydrodynam ic m odes are, how ever, stillsm aller than the kinetic m odes yielding a reasonable accurate Landau-P laczek form ula. In the kinetic regim e $(k>1)$ the hydrodynam ic $m$ odes and kinetic $m$ odes becom $e$ of the sam e order of $m$ agnitude. The distinction betw een fast and slow $m$ odes can not be $m$ ade and all $m$ odes contribute to the pow er spectrum .

In $F$ ig. . $\overline{13} 1$ are the $m$ odes observed in the eigenvalue spectrum and are com binations of , D , and Q . In the low density lim it these tw om odes converge to the them aldi usivity and di usion, i.e. $s_{+}!$, $s!D$, and is caused by the decoupling of the uctuations in the concentrations and entropy. In our $m$ odel this $m$ eans that the ratio $Q=(D)$ vanishes. $T$ he value of $Q$, how ever, $w$ ill in general rem ain $s m$ all but nite due to the divergencies of the transport coe cients in the low density lim it ofLGA. The same is observed in the high density lim it, which is merely an illustration of the duality of the LGA $m$ odel if one interchanges particles and holes. In both cases this is a direct consequence of the fact that the uctuations in the occupation num bers becom e linear in the average occupation densities, thus leading to equipartition.

A $s$ an additional rem ark we like to $m$ ention that the value of $Q$ can be both positive and negative. Therefore the correct curves of s need not be continuous as a function of the density, but can contain discontinuities located at points where $Q$ changes sign. C onsequently, depending on the system param eters, the role ofs ${ }_{+}$and $s$ is interchanged
 im portance.

For som e interm ediate values of the density one also nds that the values of s and ;D coincide. This is, how ever, not caused by decoupling of the uctuations. In these cases there is no e ective equipartition, but one obtains $Q=0$ as a consequence of the cancellation of term s . M oreover, the location of these points depends in a non-trivialw ay on the system param eters.

The di usive transport properties versus the relative concentration of both species at xed density and reduced tem perature is shown in $F$ ig. In . In the low density lim it we haves ! ;D for all relative concentrations. This is not generally true as can be seen from the higher density gure. It does, how ever, reveal that the decoupling also occurs in general for the single specie lim its $P_{r}!0$ and $P_{r}!1$. This is not surprising, as in those lim its the $m$ odel e ectively reduces to a norm alGBL modelw ith only a single di usive $m$ ode related to the therm al di usivity. This is actually also the case in the high density lim it of F ig. $\overline{3}$,, because there one has a situation in which the red lattige is alm ost com pletely lled and therefore an e ective blue system that rem ains.
$F$ inally, decoupling can also be observed in the case $P_{r}=P_{b}$. In fact this is a rather special lim it and could be analyzed com pletely in a m anner sim ilar to the one used for the colored GBL m odel [14], because based on the sym $m$ etry of the problem one can decom pose the linearized Boltzm ann operator in two type of contributions, i.e. Ri+ $-B i$ and $R i \quad \beta i$.

For $P_{r}=0$ the di usion $m$ ode vanishes, since we then recover the originalG BL $m$ odel, but for $P_{r}!0$ the di usion $m$ ode rem ains nite. This case is illustrated in $F$ ig. $\bar{N} 1 \mathbf{N}$. H ere, in the low density lim it the di usion m ode becom es equal to the self-di usion of the GBL m odel (and hence also equal to the di usion m ode in the GBL colorm ixture), but for higher density they deviate. A behavior that nds its origin in the fact that the colorm ixture does not allow $m$ ore than one particle in a single velocity channel and, although the num ber of particles of the second specie gets very sm all, they still have a large im pact on the di usion.

IV. LANDAU-PLACZEK THEORY

A. Full sp ectrum

In the hydrodynam ic regim e of sm all wavevectors ( $k$ ! 0 ) and the frequency ! being linear in $k$, the spectral density $S(k ;!)$ can be expanded in powers of $\{k$. In this long-w avelength, sm all frequency lim it the hydrodynam ic $m$ odes are well separated from the kinetic $m$ odes, which can be neglected due to their exponential decay. By keeping only term s up to $O\left(k^{2}\right)(!=k$ is kept constant for consistency), one obtains the Landau $P$ laczek approxim ation.

It has been show $n$ that the dynam ic structure factor can be evaluated by [1d]

The spectrum contains an unshifted centralpeak that is form ed by tw o Lorentzians due to the tw o processes related to the non-propagating $m$ odes $s$. The tw o propagating $m$ odes lead to the presence of the tw o shifled B rillouin lines. $T$ heir $w$ idth at half-height can be used as a $m$ easurem ent of $k^{2}$, the position of the peaks can be used a m easurem ent of $\quad$ gk. The last two term $s$ in Eq. ( 5 (59) give an asym $m$ etric correction to the $B$ rillouin peaks and induce a slight pulling of the peaks tow ard the central peak.
$T$ he sym $m$ etry of the di erent contributions is such that the ratio of the integrated contributions of the central peak and the Brillouin com ponents is constant and given by

In $F$ ig. ${ }^{\prime}$ 'G , the Landau P laczek form ula is com pared w ith the full B oltzm ann spectrum for tw o di erent w avevectors. For the sm allest w avevector inside the hydrodynam ic regim e they coincide, while for the larger they di er considerably and indicates that this w avevector is outside the hydrodynam ic, and in fact inside the kinetic regim e.

In general the contributions form ing the central peak cannot easily be separated. Even in the case they di er su ciently in order to $t$ the central peak with two Lorentzians, one only obtains inform ation on the values of s, $w$ hich is not enough to determ ine the $m$ ore interesting values of the therm aldi usivity and di usion. An exam ple of th is is show $n$ in $F$ ig. $\overline{1}_{1}$, where we decom posed the centralpeak in the tw o Lorentzians using the theoretical expressions. For com parison we included the least square $t$ according to Eq. (59) to the fill range of the spectrum, including the B rillouin peaks, where we only used a single Lorentz for the central peak.

For this reason it is im portant to consider the lim its where decoupling occurs, since in those cases the the relevant transport values can be obtained from the spectra. H ere w e have how ever an interesting di erence w ith respect to light
scattering experim ents [1]]. W hereas in that case the sensitivity of the dielectric uctuations $w$ ith respect to density is $m$ uch larger than w ith respect to tem perature, the am plitude factors $w$ ill di er orders ofm agnitude. This results in the observation that the di usion com ponent will usually dom inate the spectrum. For LG A this does not apply, and by using the decoupling lim its ! ;D on the rst term o the Landau $P$ laczek form ula ( 5.9 ), one im $m$ ediately obtains that the central com ponent of the spectrum is given by a single peak characterized by the them aldi usivity

In principle the quantities ${ }_{r}, D_{r}$, and $r$ can be expressed in the norm altransport values. H ow ever, these relations lead to $m$ ore com plex expressions and are for that reason om itted here. In $F$ ig. 'ig this form ula is com pared w the the full Boltzm ann red spectrum for a w ave vector in the hydrodynam ic regim e, yielding a satisfactory approxim ation, and one in the kinetic regim ewith a large discrepancy.

## C. D i usion spectrum

$F$ inally we like to consider the spectra of the di usive processes only. D ue to the nature of LG A, how ever, it is not obvious how to de ne di usion properly. On the one hand we have the requirem ent that a di usive process is not propagating, on the other hand one expects the di usion only to be related to the densities of both com ponents in the $m$ ixture. A swe w ill show in this section, it tums out that these tw o view s are not com pletely com patible.

The origin of this problem is that we have two di erent di usive m odes and any linear com bination would lead to a di usive spectrum. H ow ever, due to the lack of equipartition the di erent choiges of uctuations one $w$ ishes to consider do not coincide, not even after the propagating part is elim inated.
$N$ aively one would expect a com bination of the red and blue com ponent only and in addition it should be perpendicular to the propagating $m$ odes. This leads to the follow ing generalization of the atherm al result (72), which in the case of an atherm alm odelwould coincide

O bviously there is som e freedom here in order to choose the generalization of the di usion. The natural extension would be one that that satis es the appropriate lim its. H ow ever, in the low density lim it and in the lim it $\mathrm{P}_{\mathrm{r}}$ ! 1 , they all converge to the sam e value equal to the one found for the single com ponent GBL m odel. The special case of an equal density for red and blue particles is not helpful either. This lim it can be com pletely analyzed in a m anner analogous to what is done for colored G B L m odel [1] [1]. For reasons of sym $m$ etry this $w$ ill cause none of the de nitions to have a propagating character and the resulting dí usions would coincide.

In A ppendix "Be we derive the proper de nition (B) (B) for the transport values related to these quantities. Since none of them are proportionalto a single eigenm ode the usual form ulation ( 3 in $F$ ig. ${ }^{\prime}$, where the di usions obtained for the various di 's are shown as function of the density. In general the ve di erent di 's described above all lead to di erent values for the corresponding transport value, although depending on the choice of system param eters this di erence $m$ ight be $m$ arginal. A lso com pare $w$ ith $F$ ig. ${ }^{1}$, to see the di erence w ith respect to D.

A though the choice (7) is the $m$ ost natural generalization, the di usion is only properly identi ed in the lim iting cases. In general som e arbitrariness rem ains in a binary therm al lattice gas.

The corresponding di usion spectrum is obtained by

 for the them alm odelE q. (73). For com parison we also included the curve forwhich the propagating part in Eq. (72) is subtracted as was described above. The rst di usion spectrum has a B rillouin-like pair of peaks which is a $m$ anifestation of the propagating part of jdi i according to ( $72 \eta$, while the other tw o are di erent superpositions of tw o Lorentzians characterized by $s{ }^{(0)}$.
V. SIM ULAT IO N RESULTS

W e have veri ed our results w th sim ulation results. Som e notes on the im plem entation are in order. The m odel we consider is a true 38 -bits m odel, i.e. the collision operator can act on $2^{38}$ di erent states. In a previous article we reported the sim ulation results of a colored GBL m odel [1] $]$. T he num ber of states in that modelwas $3^{19}$, since no red and blue particle could exist w ith the sam e velocity. The sim ulations could, how ever, be perform ed by realizing
that the collisions could be separated in a nom al G BL collision followed by a redistribution of the colors over the di erent particles present. These tw o separated processes can easily be perform ed by any com puter.

In the present $m$ odel this approach can not be used. O ne could of course $m$ ake use of the sym $m$ etries present in the m odel. T he hexagonal lattice leads to six rotations and tw o re ections. In addition we can $m$ ake use of the interchange of red and blue particles, and the interchange of particles and holes. At best this would lead to a reduction with a factor of 48 on the total num ber of di erent states, but in practice this factor is less because a large fraction of the states is invariant w ith respect to som e of these sym $m$ etries. This is how ever still too large in order to be applied in any but the largest supercom puters available at present. An altemative, but rather ine cient schem e, would be to store only part of the collision table and generate other collisions on the $y$.
$B$ inary $m$ ixtures, how ever, do allow for a m ore convenient solution, which is less e cient than storing the com plete collision table, but still has a relative good perform ance (about a factor 2-5 slow er than the colored GBL model). $R$ ather than storing a collision table based on the states, we $m$ ake one based on the di erent classes. In the G BL $m$ odel there are 29926 di erent classes $C=(M$; ; ; ) , characterized by the totalm ass, $m$ om entum, and energy. Since the the binary $m$ ixture is the com bination of tw o GBL m odels there are $29926^{2}$ di erent com binations ( $C_{R}$; $C_{B}$ ) of a red and blue class which form a totalof 4478568 classes $=\left(M_{r} ; M_{b} ; P ; E\right)$. If $w e$ combine this $w$ ith the 48 sym $m$ etry operations we get a working algorithm that already can be used on a com puter w ith 256 M B ofm em ory.

A $n$ arbitrary input state is now analyzed in order to determ ine to which class it belongs. From its characterization one can easily $n$ nd which transform ation is needed in order put it in a form with $M_{R} \quad M_{B}, M_{R}+M_{B} \quad 19$, and $0 \quad P_{y} \quad P_{x}=\overline{3}$. The last inequality con nes the totalm om entum to an angle of $=6$. For each in this lim ited set of classes only, all the classes $C_{R}$, that $w$ ith the appropriate class $C_{B}$ can give rise to it, have been stored, including the num ber of states in each ( $C_{R} ; C_{B}$ ) com bination. From this we generate $w$ ith the proper weight an loutgoing" class com bination to which the inverse transform ation is applied. Finally we only need to determ ine a random state in $C_{R}$ and $C_{B}$, which is just a GBL-like process.

Sim ulation results along w ith the B oltzm ann approxim ation and the Landau $P$ laczek form ula are shown in $F$ ig. for both the norm al and red spectrum. In the F igs. 'Ga and Landau $P$ laczek form ula describes the pow er spectrum very well. If we increase the wavevector $k$, and/or low er the density, the hydrodynam ical regim e is left and deviations start to appear. In that generalized regim e, the transport properties are $k$-dependent. $F$ igs. 'Gc and 'Gd show a spectrum even further aw ay from the hydrodynam ic regim e, in the kinetic regim e. Several kinetic $m$ odes invade the spectrum, and a param eterization into Lorentzians has lost all physicalm eaning. T he full spectrum based on the Boltzm ann approxim ation, however, still leads to a very good description, supporting the $m$ olecular chaos assum ption.

## VI. D ISCUSSIO N

W e have constructed a them al binary lattice gas mixture. The model is characterized by crosse ects betw een energy transport and di usion. T he Landau $P$ laczek form ula derived in the the low wavevector, low frequency dom ain gives an excellent description. For larger w avevectors it will fail, but the spectra can still accurately be described by the Boltzm ann approxim ation.

The Landau $P$ laczek form ula for a regular binary them al $m$ ixture is quite sim ilar in structure as the one for the continuous case. The $m$ ain feature is a central peak form ed by two Lorentzians due to the coupled entropyconcentration uctuations. In the lim its of low density, single specie, their dual intenpretations, and equal red and blue density it is possible for the centralpeak of the spectrum to be decom posed into tw o Lorentzians w ith linew idths given by $\mathrm{k}^{2}$ and $\mathrm{Dk}^{2}$, otherw ise the linew idths depend on both these values.

In the low density lim it the truem odes s converge to and D. M oreover, they can be identi ed w ith the therm al di usivity and mass-di usion coe cient of the GBL m odeland coincide w th the low density lim it of the continuous binary $m$ ixture. In contrast $w$ ith continuous theory, how ever, it is the them al di usivity that dom inates the central part of the spectrum, rather than the di usion. The interpretation of as the therm aldi usivity can be extended to the general situation. For D this not true, since the related spectrum will contain B rillouin peaks, which is a not a purely di usive property. A though it is possible to correct for this, there rem ains som e am biguity in the choice for the generalized di usion coe cient.
$T$ he analysis and results presented here are in general true for binary them al lattioe gasses and not restricted to this particular model only. It also reduces autom atically to the proper form ulation for an atherm alm odel, in which case som e of the am biguities are rem oved.
