# C om pletely $m$ onotone solutions of the $m$ ode-coupling theory for m ixtures

#### Abstract

W e establish that a m ode-coupling approxim ation for the dynam ics of $m$ ulti-com ponent system s obeying Sm oluchow ski dynam ics preserves a subtle yet fiundam ental property: the $m$ atrices of partial density correlation functions are com pletely m onotone, i.e. they can exactly be written as superpositions of decaying exponentials only. This statem ent holds, no $m$ atter what further approxim ations are needed to calculate the theory's coupling param eters. The long-tim e lim it of these functions ful lls a $m$ axim um property, and an iteration schem efor its num ericaldeterm ination is given. We also show the existence of a unique solution to the equations of $m$ otion for which pow er series both for short tim es and sm all frequencies exist, the latter exœept at special points where ergodic-to-nonergodic transitions occur. These transitions are bifurcations that are proven to be of the cuspoid fam ily.

## I. IN TRODUCTION

D ensity correlation functions are convenient tools to characterize the dynam ics of liquids or disordered system $s$. They can be $m$ easured in experim ent, e.g. by inelastic neutron scattering, dynam ic light scattering in coloidalsystem $s$, or can be determ ined from com puter sim luation techniques. O $n$ the other hand, one can calculate them from theory, but in the case of strongly interacting system $s$, one typically has to invoke certain approxim ations in order to obtain the desired results. There are, how ever, som e general properties of such correlation functions, directly related to the tim e-evolution operator of the system. It is a nontrivial point to show that all approxim ations involved in deriving a theory's equations ofm otion preserve these general properties.

O ne exam ple are colloidal suspensions obeying Sm oluchow ski dynam ics. O ne knows from general grounds that in such system $s$ the $m$ atrioes of partial correlation functions are com pletely $m$ onotone, i.e. they can be written as a supenposition of decaying exponentials only. An approxim ative theory calculating such quantities should aim to reproduce these properties, since they are direct oonsequences of the structure of the tim e-evolution operator. H ow ever, the concept of com plete m onotonicity is quite subtle, and it is therefore likely that a given approxim ation prevents the approxim ative solutions from sharing this feature w ith the com plete solution .

At high densities, coloidal system $s$ are known to undergo glassy dynam ics, provided crystallization can be suppressed for a su ciently long tim e. In these cases the so-called m ode-coupling theory of the glasstransition (MCT) hasbeen successfulin describing m uch of the experim ental facts. For one-com ponent, i.e. m onodisperse, system $s$ the theory has been proven $\left[\begin{array}{l}{[1]}\end{array}\right]$ to give results for the density correlation functions, which indeed reproduce the above m entioned features. H ow ever, liltle is know $n$ about m ulti-com ponent, or polydisperse, m ixtures. R ecently, glassy dynam ics in a binary colloidal suspension has been studied [̄̄] challenging detailed com parisons of the M CT for m ixtures w ith experim ent.

M C T tries to describe the motion of particles on a $m$ icroscopic scale by an approxim ation of the frequency- and wavenum ber-dependent viscosity in term s of density- uctuation products. Such an approach com es about naturally if one considers the potential stresses to be built up by the density uctuations of the liquid itself. T he resulting equations contain a feedback $m$ echanism induced by the slow ing dow $n$ of relaxations due to the so-called
cage e ect. It has been shown that these equations allow for an ideal glass state, given the interactions are strong enough, e.g. at high densities. The ideal glass is characterized by a nonvanishing long-tim e lim it ofdensity correlation functions which corresponds to an elastic scattering contribution in the dynam ical structure factor. In the \phase diagram " , there occur critical m anifolds, referred to as glasstransition singularities, that separate ergodic liquid from ideal glass states and can also extend into the glass state. Upon approaching a singularity point, the long-tim e lim it of the density correlators, som etim es referred to as the glass form factor or the Edw ards-A nderson param eter of the system, changes discontinuously. This holds for both liquid-glass transitions, where the change is from zero to som e nonzero value, as well as glass-glass transitions.

C lose to the transition, analytic form ulas providing asym ptotic solutions of the M CT equations ofm otion have been derived. There occur tw o tim e fractals w ith nontrivial exponents, and tw o diverging tim e scales, accom panied by corresponding scaling law s. On these tim e scales the dynam ics of the glass form er is also referred to as structural relaxation. T he asym ptotic predictions as well as num erical solutions of the fiull M CT equations for $m$ odel system s have been extensively tested against experim ental data; for a detailed discussion of the glass-transition scenario, the reader is referred to a recent review [र्క్, 1 .

The aim of this paper is to generalize from the case of one-com ponent system $s$ to that of m ulti-com ponent mixtures proofs of the basic properties of M CT solutions. In particular, we show that the structural relaxation can be represented as a continuous superposition of decaying exponentials, i.e. that the density correlation functions indeed are com pletely $m$ onotone. Furthem ore, the long-tim e lim its can be obtained by a sim ple iteration procedure that does not involve the solution of the com plete dynam icalequations. A $n$ investigation of this iteration brings out glass transitions in general to be bifurcations of the cuspoid type. In addition, a short-tim e expansion of the density correlation functions is dem onstrated to be convergent for short tim es, and sim ilarly, a power series for sm all frequencies is show $n$ to exist.

T he paper is organized as follow s: In Sec. II, we w ill introduce the equations ofm otion for the $m$ ixtures considered, together w ith som e basic properties and the M CT approxim ation. Section solution which is com pletely m onotone. In Sec. "īili, the long-tim e lim it of these solutions w ill.be discussed, and in Sec.iNV.', the existence of pow er series solutions both in the tim e and
frequency dom ain is show $n$, the latter by proving rst that all $m$ om ents of the correlation


## II. EQUATIONSOFMOTION

A. G eneral P roperties

W e consider a classical system enloosed in a box of volume V w ith a total num ber of particles $N=P_{=1} N$, consisting of $s$ di erent species with num ber concentrations $x=$ $\mathrm{N}=\mathrm{N}$. The particles are supposed to be structureless, i.e. they do not possess any intemal degrees of freedom, and are thus fully described by their positions, $m$ om enta, and species index. The variables

are then the uctuating densities of species to wave vector $q$. Here, $\mathbb{x}_{i}$ denotes the position of the i-th particle of species . The sim plest statistical inform ation on structural dynam ics that can be extracted from a multi-com ponent supercooled liquid is the $m$ atrix of density correlation functions

Here, the brackets $h j i$ denote the $k u b o$ product $w$ ith $h A B i=h A B i$, where $A=$ A hA i , and $\mathrm{h}::$ :i indicates canonical averaging. Since $(\mathrm{q} ; \mathrm{t})$ is the spatial Fourier transform of a function that is real, translational-invariant and isotropic, it is itself real and depends only on the $m$ agnitude of the wave vector $q=$ iqj. The time evolution is given by $n(q ; t)=\exp [i S t] n$ (q). For a liquid obeying $N$ ew tonian dynam ics, the operator $S$ is just the Liouville operator, which is H em titian w ith respect to the $\mathrm{K} u b o$ product. In this case, tim e inversion sym $m$ etry im plies the density correlation $m$ atrix to be sym $m$ etric $w$ ith respect to interchange of the species indioes.

Let us focus on colloidal liquids, and $S$ denote the Sm oluchow ski operator. There, tim e inversion sym $m$ etry is broken explicitly, but still the sym metry $\quad(q ; t)=\quad(q ; t)$ holds, although this has to be proven seperately $\left[\begin{array}{l}\overline{4} \\ \hline\end{array}\right.$.

O ne then has the spectral decom position $\exp [i S t]={ }^{R} \exp (\quad t) d P, w$ ith eigenvalues fullling $\quad 0$, and $P$ denoting the pro jector onto the corresponding linear subspace. This

A function having these properties is called com pletely m onotone. In particular, $(q ; t)$ is a positive de nite $m$ atrix for alltim es, and for alll the tim e derivatives ( 1$)^{1} @_{t}^{1} \quad(q ; t)$ are positive de nite. Let us also introduce the Laplace transform $\quad(q ; z)=i_{0}^{R_{1}} e^{i z t} \quad(q ; t) d t$. Then the representation Eq. (З了̄) show s that

which is positive as is already im plied by the passivity of the system. O ne also has that the long-tim e lim it of the correlators exists. If this quantity is nonvanishing,

it is called the glass form factor or nonergodicity param eter, and the spectrum exhibits an elastic contribution $F$ (q) (!). Passivity requires $F$ (q) 0 which is consistent w ith Eq. (

Let us stress again that the above properties of density autocorrelation functions are direct consequences of the eigenvalue spectrum of the Sm oluchow ski operator; in general, they hold for any system whose tim e-evolution operator has nonnegative, real eigenvalues only.

## B. M ode-C oupling Theory

M ode-coupling theory starts from the form ally exact representation of the density correlation $m$ atrix in term $s$ of a $m$ em ory kemelm atrix. In the Laplace dom ain this results in the m atrix equation

Since M $(q ; z)!0$ for $z!1$, one can identify the $m$ atriges $S$ and $w$ ith the short tim $e$ expansion of the tim e density correlation function, ( $q ; t)=S(q) \quad{ }^{1}(q) t+O\left(t^{2}\right)$. The $m$ atrix $S(q)$ is called the structure factor, and from the de nition Eq. (니) one checks that for every $q$ it is sym $m$ etric, real and positive de nite. T he sam e properties hold for the $m$ atrix
(q) characterizing the initial decay of (q). W e shall throughout this paper discuss the above equation for $q \in 0$ and therefore assum e both $S(q)$ and (q) to be invertible, whidh is the generic case as long as all num ber concentrations are nonvanishing.

The Zwanzig-M ori form alism gives an explcit expression for the $m$ em ory $m$ atrix in term $s$ of so-called uctuating forces. W e shall only be concemed w ith its general structure, which in the tim e dom ain is

In order to avoid overoounting we restrict the pair m odes to $\tilde{K}>p, \tilde{K}^{0}>p^{0} w$ ith som e order relation. In particular, for $t=0$ this im plies an approxim ate norm alization and suggests to introduce an approxim ate projector

Since the tensor product of positive de nite $m$ atrices again represents a positive de nite $m$ atrix in the corresponding product space, it is clear from Eq. ( $\overline{1} \overline{2} \overline{2})$ that $M \quad(q ; t)$ is positive de nite, provided that the density correlation $m$ atrix $\quad(q ; t)$ is positive de nite for allw ave vectors. M ore generally, if we write

we see that $F \mathbb{F} ; G]$ is sym $m$ etric in $F$ and $G$, and is positive de nite for every $q$, provided both $\mathrm{F} \quad 0$ and $G \quad 0$ for every k and p . In particular, we have $\mathrm{M}(\mathrm{q} ; \mathrm{t})=\mathrm{F}_{\mathrm{q}}[$; ].

Let usm ention that the vertex can be evaluated and expressed in term softhe static structure factorm atrix and the three-particle static correlation functions. U sually the structure factor is know $n$ only approxim ately. K now ledge of triple correlations is often lacking entirely, although in principle they can be determ ined from com puter sim ulation tily. H ow ever, the property of M ( $q ; t$ ) being a positive de nite quantity is a direct consequence of the M C T approxim ation structure, and is indeed independent of the approxim ations $m$ ade in order to evaluate the vertex in Eq. (1] $\overline{1} \overline{3})$. N ote in addition that one can in principle include a regular contribution to the $m e m$ ory kemel, $M^{\text {reg }}(q ; z)$, accounting for transient dynam ics not captured in the M CT approxim ation, e.g. hydrodynam ic interactions and the like. Under the assum ption of such a term being com pletely $m$ onotone, the follow ing discussion rem ains
 be proven in the follow ing section.
III. COMPLETELY MONOTONESOLUTIONS

## A. C om plete M onoton icity

W e denote the space of $s \quad s m$ atrices, where $s$ is the num ber of species, by A. It is clear that A, equipped w ith standard m atrix m ultiolication and H erm itean scalar product, is indeed $a C$ ? algebra. For elem ents $a_{q} 2 A$, we form vectors $a=\left(a_{q}\right)_{q=1 ;:: M} 2 A A^{M}$. O ne easily checks that $A^{M}$ w ith allm atrix operators over $A$ de ned elem entw ise in $q$, and equipped w ith the $m$ axim um norm $k a k=m a x_{q} k a_{q} k$, can again be tumed into $a C$ ? algebra. An elem ent a $2 A^{M}$ shall be called positive, a 0 , if $a_{q} \quad 0$ for every q; sim ilarly, we use a 0 , or $\mathrm{a} b$, the latter meaning $a b \mathrm{~b} 0$. N ote that the norm preserves ordering, i.e. for a b we also have kak kbk.

In the follow ing, we shall assum e wave vectors to be discretized to som e nite set $q=$ 1; : : : $M$, such that allm atrioes appearing in the equations of $m$ otion are elem ents of $A^{M}$.

N ow assume ${ }^{(n)}(t)$ to be completely monotone. It is then clear from Eq. (1̄2̄) that $M^{(n)}(t)$ inherits this property. In particular, its Laplace transform has the properties (i) to (iv) ofEq. (4, (í) . But then ${ }^{(n+1)}(z)$ as de ned by

Let us com plete the proof of existence of a uniquely determ ined, com pletely $m$ onotone solution to Eqs. ( $(\bar{i})$ ) and ( $(\overline{1} \bar{Z})$ by show ing that the thus constructed sequence converges uniform ly to some (t).

## B. Existence and U niqueness

The equation ofm otion in the tim e dom ain can be obtained from Eq. (ī) which yields

Furtherm ore, this solution depends sm oothly on the vertioes $V$ as control param eters for any xed nite tim e interval. $N$ ote that this theorem cannot be extended to in nite tim e intervals.

Togetherw ith the preceding paragraph, we have proven the existence of a unique solution to Eq. $(\underline{\bar{T}}, \mathbf{1})$ that it is the lim it of a convergent sequence of com pletely $m$ onotone functions. It is therefore itself com pletely $m$ onotone, due to the continuity theorem for Laplace transform $s$ [1] $\overline{1} 1]$.
IV. GLASS FORM FACTORS

In this section we shallprove that the glass form factor $F=(t!1)$ can be obtained w ithout solving the integro-di erential equation ( $1 \mathbf{1} \overline{9}_{1}$ ).

In this space, the solution corresponding to the glass form factor shall be show $n$ to be $m$ axim al $w$ ith respect to the sem i-ordering de ned on $A^{M}$.

## VI．CONCLUSION

W e have show $n$ that，for a m ulti－com ponent colloidalm ixture driven by Sm oluchow skidy－ nam ics，the m ode－coupling theory of the glass transition（MCT）provides an approxim ation to the density correlators that preserves the com plete m onotonicity im posed by the general structure of the tim eevolution operator．Thus，positivity of the spectra is guaranteed．Since the correlation functions are superpositions of purely decaying exponentials in the sense of Eq．（⿳亠二口灬亍），the term \structural relaxation＂given to the dynam ics close to a glass transition is justi ed．The glass form factor was found to be determ ined by a maxim um principle．It can be evaluated by an iteration schem e whose linearization ful lis the prepositions needed for a generalized Perron $\mp$ robenius theorem under the natural assum ption that the system has no decoupling w ave－vector subspaces．This in tum ensures a non－degenerate $m$ axim um eigenvalue that was show $n$ to be sm aller than，or equal to unity for all physical states．T hus w ithin the M CT ofm ulti－com ponent system s ，the only possible glass－transition singularities are bifurcations of type A ，occuring at points where the $P$ erron $\mp$ robenius eigenvalue equals unity．

The proofs presented here suggest num erical schem es for the solution of the nonlinear equations of $m$ otion，that are stable in the sense that they $w i l l$ converge to the uniquely de ned，sym $m$ etric，com pletely $m$ onotone solution．In particular，the glass form factor can be found w ithout solving the dynam icalequations．

Typical solutions to the M C T equations appear in F ig．＇in．W e chose as the sim plest case a binary $m$ ixture of hard spheres．Then the state of the system is determ ined by three num bers，which we take to be the total packing fraction，${ }^{\prime}={ }^{\prime}{ }_{\mathrm{A}}+{ }_{\mathrm{B}}$ ，the diam eter ratio
$=\mathrm{C}_{\mathrm{B}}=\mathrm{d}_{\mathrm{A}}$ ，and the packing contribution of the second species，${ }^{\prime}{ }_{\mathrm{B}}={ }^{\prime} . \mathrm{H}$ ere，the species are labeled w th subscripts $A$ and $B$ ，and ${ }^{\prime}=\left(d^{3}=6\right)(\mathbb{N}=V)$ are the partial volum es
occupied by each species．To calculate the M CT vertex，Eq．（1］ī），one needs to know the static structure factor of the system，as well as static three－particle correlation functions． For the latter，to our know ledge，no analytic expressions are available，and thus we follow the com $m$ only applied approxim ation through two－particle correlations be approxim ated using the well－know n Percus－Yevidk（PY）approxim ation to the O mstein－ Zemike integral equation．W ithin this fram ew ork，\PY－exact＂solutions are available［1］9］． A s was already mentioned in connection with Eq．（ī⿱一⿱㇒⿵冂⿰丨丨一心 ），the approxim ations involved in evaluating the vertex are of no im portance for the $m$ athem atical aspects of the solutions we w ish to dem onstrate．

F igure＇ī1 show s norm alized correlation functions $(q ; t)=S^{1=2}(q)(q ; t) S^{1=2}(q)$ for a particular wave vector $q=6: 2=d_{A}$ ．They are num erical solutions of Eq．$\left(\bar{\eta}_{i}\right)$ w th $\quad(q)=$ $1=\left(q^{2} D^{0}\right)$ and $D^{0}=0: 005=R$ ，on a grid of 100 w ave vectors $q=0: 2 ;::: 39: 8 \mathrm{w}$ th $q=$ $0: 4$ ．The size ratio and the concentrations are kept xed at $\left(;^{\prime}{ }_{B}=^{\prime}\right)=(0: 6 ; 0: 2)$ ，and the totalpacking fraction is varied as indicated in the gure caption；a procedure corresponding to what has been done in experim ent［íl］．N ote that while the two diagonalm atrix elem ents are positive and m onotonically decreasing for all tim es $t$ ，both needs not be true in general for the o－diagonal elem ents．For com parison also show $n$ is the suggested starting point of Eq．（ $\overline{1} \overline{1}(\underline{)}),{ }^{(0)}(\mathrm{t})=\mathrm{S}^{1=2} \exp \left[(\mathrm{~S})^{1} \mathrm{t}\right] \mathrm{S}^{1=2}$ ，which is com pletely m onotone by construction． O ne notioes a drastic slow ing down in the relaxation of the correlation functions tow ards their long－tim e lim its．This dem onstrates the dynam ics close to a critical point where the Perron $\mp$ robenius eigenvalue $r=1$ ，which in this system occurs at ${ }^{c} c \quad 0: 519608$ and which is the concem of the asym ptotic solutions to m ode－coupling theory．T he solutions for the long－tim e lim it at ${ }^{\prime}={ }^{\prime}$ c as determ ined from Eq．（ $2 \overline{-} \bar{S}_{1}$ ）are inchuded in the gure．

C om plete $m$ onotonicity requires alleigenvalues of（ $t$ ）to be positive for allt．To dem on－ strate that our num ericalsolution is in accordancew ith this，we show in Fig．＇ e（t）as functions oftim e for a xed totalpacking fraction．O ne clearly recognizes the above statem ent to hold．

A power series in the tim e dom ain exists，and at regular points，ie．for vertioes such that the Perron $\mp$ robenius eigenvalue is $s m$ aller than unity，also for $s m$ all frequencies the pow er series has a nonzero radius of convergenœ．In particular，the existence of all $m$ om ents of the density correlation function at regular points，and of a nite radius of convergence for
the frequency-dom ain power series im plies the existence of a nal exponential relaxation,

The m ode-coupling theory for mixtures can also be applied to system s w ith N ew tonian, instead of stochastic, short-tim e dynam ics, e.g. m etallic melts. Furtherm ore, a recent extension of M C T to m olecular liquids that treats each molecule as consisting of s constituent sites also leads to substantially the sam e equations tation of Eq. (3-1) through decaying exponentials only w ill not be valid in general, the proofs presented here cannot readily be applied. W ork published for one-com ponent N ew tonian system $s\left[\begin{array}{c}\overline{1} \\ 1\end{array}\right]$ suggests that existence and uniqueness of the solution, even if it will not be com pletely $m$ onotone, can nevertheless be proven. This has, how ever, not been done so far.

It is an observation ofboth theory $[\overline{2} \overline{2}]$ and com puter experim ent $[\overline{[ } \overline{2} \overline{1}]$, that the di erent short-tim e behavior does not in uence the dynam ics at su ciently long tim es apart from an overall shift in tim e scale, given a strong enough coupling such that M C T contributions are im portant. O ne then expects the long-tim e lim it of the $N$ ew tonian dynam ics solutions to exist and to be govemed by Eq. ( $\overline{(25})$ ). N ote that the properties of this equation and its maxin um xed point do not depend on the short-tim e dynam ics, nor do the com $m$ only applied asym ptotic form ulas. Sim ilarly, the prediction of only A , singularities as glass transitions w ill rem ain valid as long as the linearization of q. (2-15) is irreducible. This can be expected unless som e special sym $m$ etry will introduce zero-couplings in the vertex, which in principle can happen $w$ ithin the $m$ olecular site-site description of $R$ ef. $\overline{\underline{2}} \overline{\underline{q}}]$.
