Noise through Quantum Pumps

We study the current noise through an unbiased quantum electron pump and its mesoscopic uctuations for arbitrary tem peratures and beyond the bilinear response. In the bilinear regime, we not the full distributions of the noise power and the current-to-noise ratio for a chaotic quantum dots with single-channel and many-channel ballistic point contacts. For a dot with many-channel point contacts we also calculate the ensemble-averaged noise at arbitrary temperature and pumping strength. In the limit of strong pumping, a new temperature scale appears that corresponds to the broadening of the electron distribution function in the dot as a result of the time-dependent perturbations.

I. IN TRODUCTION

A periodic perturbation of a con ned electron system may produce a direct current. The initial theoretical proposals [1,2] and experimental realizations [3{5] for electron pumps were for a pump where the spectrum is gapped and the charge pumped in one cycle quantized and not subject to uctuations. Recently, attention has shifted to pumps that are well connected to electron reservoirs, and, hence, do not have a gapped excitation spectrum [6{9}]. If the pump relies on a time-dependent perturbation that mainly a ects the quantum mechanical phases of the electrons, and not their classical trajectories, it is referred to as a \quantum electron pump". Such a quantum pump was fabricated by Switkes et al. [10].

The current that is pumped through a quantum electron pump is subject to mesoscopic uctuations and to quantum or thermal uctuations (noise). Mesoscopic uctuations of the current refer to the fact that the magnitude and direction of the time-averaged current vary from sample to sample. For a quantum pump built from a chaotic quantum dot, as is the case in the experim ent of Ref. [10], the mesoscopic current uctuations were investigated for various regim es of tem perature, pum ping am plitude and dot conductances [8,9,11{14]. On the other hand, noise | quantum and them al uctuations of the current is a property of the current pum ped through a particular realization of an electron pump. Noise in an electron pump is best described by the uctuations of the charge pum ped through the system in a certain num ber of pumping cycles. The statistics of such charge uctuations was studied in Refs. [15{22] for tem peratures and pum ping frequencies much smaller than the inverse dwell time (escape rate) of electrons in the quantum dot.

In this paper, we consider the mesoscopic uctuations of the noise. We do not im pose any restrictions on the relative magnitudes of temperature T, pumping frequency!, escape rate and pumping amplitude. This is important, as in an experimental realization of a quantum

pump, T and are usually comparable, while both are much larger than !. Previous works by Andreev and K am enev [15] and Levitov [16] addressed the full counting statistics, but at temperatures kT h! only. The mean square charge uctuations for h!;kT (but including the case h! kT) were considered very recently by M oskalets and Buttiker [22].

Denoting the quantum mechanical average with a bar, the quantum and thermal uctuations of the pum ped charge are described by

Here $_0$ is the observation time and Q is the total charge pumped through the dot in the time $_0$. The noise in an electron pump can be divided onto a Nyquist-Johnson component S^N and pumping component S^P . The former is the thermal equilibrium noise due to the thermal uctuations of electrons in the leads, and depends on the electron temperature T in the leads and the time-averaged conductance G of the quantum dot through the uctuation-dissipation theorem,

The pumping contribution S^P , in contrast, is a true non-equilibrium noise due to the perturbation of electrons inside the dot. As we shall discuss in Sec. III, this contribution to the noise can be seen as arising due to the heating of electrons inside the dot as a result of the time-dependent perturbation.

In the adiabatic regime h! one needs to vary at least two system parameters periodically in order to generate a direct current. Current noise, however, is already generated if only one parameter is varied. The problem of current noise (and full counting statistics) for a single time-dependent scatterer with frequency h! was addressed by Levitov and coworkers [19,20]. Our results can be used to compute the mesoscopic uctuations of the current in that case. We not that the main elect

of the second time-dependent parameter in a true electron pump is to reduce the mesoscopic uctuations of the noise.

The paper is organized as follows: A form alexpression for the noise in terms of the time-dependent scattering matrix of the dot S is derived in Sec. II. Section III considers the mesoscopic uctuations of the noise through a chaotic quantum dot with two (orm ore) time-dependent parameters. For an adiabatic quantum pump at temwe consider the full distribution of perature kT the mesoscopic uctuations of the noise in Sec. IIIA. We focus on the cases of a quantum dot with singlechannel and many-channel point contacts. For a dot with m any-channel point contacts, the sam ple-to-sam ple uctuations of the noise are much smaller than the average. In Sec. IIIB we then present the ensemble-averaged noise for a dot with many-channel point contacts at arbitrary tem perature and pum ping strength. We conclude in Sec. IV. Finally, in Appendix we give some details of the calculations of the averages over the ensemble of chaotic quantum dots.

II. GENERAL FORM ALISM




FIG.1. Schematic drawing of the quantum dot and the leads. There are N $_{\rm L}$ (N $_{\rm R}$) propagating modes in the left (right) contact. The shape of the dot is controlled by the voltages of two shape-de ning gates. The vectors $a_{\rm L},_{\rm R}$ and $b_{\rm L},_{\rm R}$ of annihilation operators for the incoming and outgoing states, respectively, in the left (L) and right (R) leads are related by the scattering matrix S .

We consider uctuations of charge transmitted the sample during the observation time $_0$. The sample is connected to electron reservoirs through two point contacts with N $_{\rm L}$ and N $_{\rm R}$ open channels, respectively, see Fig. 1. It is subject to a periodic perturbation at frequency !=2; The perturbation is described by specifying the time-dependence of parameters X $_1$ (t), X $_2$ (t), ..., X $_n$ (t) characterizing H am iltonian of the sample. The electrons in the two reservoirs are held at the same chemical potential and temperature T at all times during the pumping cycle.

We calculate the noise of the quantum pump using the scattering formalism of Buttiker [23]. In Buttiker's original application there are no time-dependent pertur-

bations, so that the system is described by a scattering m atrix that depends on energy, but not on time. On the other hand, as long as pum ping frequencies and tem peratures much smaller than the escape rate are considered, the system with a time-dependent perturbation can be described using a scattering matrix that depends on time, but not on energy [15,16,19{22]. When kT, h! and are all comparable, one needs to use a scattering matrix S that depends on both time and energy, or, equivalently, that depends on two times or two energies. Here we shallmake use of a formulation with a scattering matrix S $(t;t^0)$ that depends on two times. This form ulation was used to calculate the tim e-averaged conductance and pum ped current in the Ref. [13]. The form alism is equivalent to the two-energy scattering formalism developed by Buttiker and cow orkers for time-dependent transport through m esoscopic structures [24{27].

The scattering matrix S $(t;t^0)$ relates the annihilation [creation] operators a (t) [ay (t)] and b (t) [by (t)] of incoming states and outgoing states in channel = 1;:::;2N of the leads (the index includes the spin degree of freedom),

Here the indices and label the propagating channels in the point contact contacting the dot to the left and right reservoirs for ; = 1;:::;2N $_{\rm L}$ and ; = 2N $_{\rm L}$ + 1;:::;2N , respectively. The 2N 2N m atrices SY and S are related as

Causality requires that $S(t;t^0) = 0$ if $t < t^0$. We restrict our attention to the case where spin rotation invariance is preserved, and, hence, S is proportional to the 2 unit matrix in spin grading.

The expression for the current I_L in the left lead is

A similar expression holds for the current I_R in the right lead. Since we are only interested in the charge pumped through the dot in a long time interval and the charge on the dot is conserved after each cycle, we replace the expression for the current operator by a suitable combination of I_L and I_R ,

In terms of the current operator I, the time-averaged pumped current I reads

where the observation time $_{0}$ is an integer number of pumping cycles. The noise S is de ned as [cf. Eq. (1)]

U sing Eq. (3) to elim inate the operators b (t) and b^y (t) from Eq. (6a) and Eq. (9) to compute the quantum mechanical expectation values, we not the average current

where the Nyquist-Johnson and pumping contributions $S^{\,\text{N}}\,$ and $S^{\,\text{P}}\,$ read

(These equations can also be derived using the Keldysh form alism, see Ref. [28].)

For adiabatic pumping, h!, Equation (11) is equivalent to the time-averaged current of Refs. [8] and [9]. The Nyquist-Johnson contribution to the noise is related to the time-averaged conductance G of the system at temperature T, see Refs. [29,30] and Eq. (2) above.

A . B ilinear adiabatic pum ping

Of particular interest is the case when the perturbation is slow compared to the (elastic) escape rate of the electrons from the sample into the reservoirs. This is the regime of the adiabatic quantum pump of Ref. [10]. In this approximation it is advantageous to use an analog

of the W igner transform for the matrix S $(t;t^0)$:

Up to corrections of order h! =, the matrix S(";t) is equal to the \instantaneous" scattering matrix $S_X(")$, which is obtained by \freezing" allparam eters X_j to their values at time t $\beta 1,32$].

If, in addition to being adiabatic, the parameters X_j , j=1;:::;n, undergo only small excursions from their average value, which we set to zero, we may further expand in X_j . To not the noise it is su cient to expand S up to the second order in X. A rranging the parameters X_j in an n-component vector $X=(X_1;:::;X_n)^T$, we thus not

In the bilinear regime and at zero temperature, the time-averaged current I and the noise S^P are succient to de ne the total counting statistics of the pump [16]: To lowest order in the excursions of the parameters X_j , the pumping cycles are statistically independent. A pumping cycle is characterized by quantum mechanical probabilities P_R and P_L that an electron is pumped from left to right or from right to left, respectively. Both P_R and P_L are small, of order X^2 , and one has $I = (e! = 2) (P_L - P_R)$, $S^P = (e^2! = 2) (P_L + P_R)$.

For a typical quantum dot with capacitance C and mean level spacing , the charging energy e 2 =2C . The derivatives in Eq. (16b) should be taken at a constant value of the chemical potential , which, in the Hartree approximation, is equal to sum of the electron's kinetic energy and the electrostatic potential. In the absence of electron-electron interactions all derivatives are taken at constant value of the kinetic energy. As we prefer to take derivatives at constant kinetic energy (i.e., at constant") in both cases, we substitute the parametric derivatives as [24,33].

Equation (17) di ers from a similar expression in Ref. [8] by factor of 1=2 in front of the traces because of the double size of matrix S as a result of the inclusion of spin.

III. APPLICATION TO CHAOTIC QUANTUM DOTS

We now consider the mesoscopic uctuations of the pumping noise S^P for the case of a chaotic quantum dot. The quantum dot is characterized by a mean level spacing , escape rate = N =2 , Thouless energy $E_{\,\mathrm{T}\,h}$ = h= $_{\mathrm{erg}}$, and capacitance C , with charging energy e^2=2C . It is coupled to two electron reservoirs via ballistic point contacts with N $_L$ and N $_R$ channels each, see Fig. 1.

The dot is driven by periodically varying param eter(s) X_i , $i=1;\dots;n$ with frequency !, cf. Fig. 1. In the experiment of Ref. [10], the param eters X_i correspond to the voltages on external gates that control the dot shape. The precise relation between the param eters X used in the theory and in the experiment is not known a priori, but can be established using independent measurements of, e.g., the derivative of the conductance [33] or the rate of change of the position of Coulomb blockade peaks when the point contacts between the dot and the reservoirs are pinched o [13]. Following Refs. [8,11,13], we will assume that the dierent param eters X_i correspond to dierent perturbations of which the matrix elements between states (of the closed dot) within a Thouless energy from the Fermilevel " = 0 are Gaussian

and independently distributed. We choose the scale for the parameters X_i such that the mean square derivative h(@"=@ X_i)(@"=@ X_j)i= $_{ij}$ 2 = 2 , where is the mean level spacing and " is an energy level in the closed dot.

The transm itted charge Q is measured during a time $_{0}$, which we will assume to be a large number of pumping cycles. This requirement of large observations is discussed in detail in Ref. [20]. For short observation times boundary elects related to switching processes in the system need to be taken into account.

A .W eak adiabatic low tem perature pum ping

If not only the frequency h! is much smaller than the escape rate , but also kT , the scattering matrix S (";t) in Eq. (16) can be taken at the Ferm i level " = 0, and we not the simple result

in m ore detail. For this case, Eq. (18a) is factorized into a factor F ($T;!;_0$) that depends on the relevant time and energy scales, and a sample specic contribution,

To nd the integral F (T;!; $_0$) for the physically relevant lim it of long observation times $_0$ 1=T, we note that in this lim it the distribution function f (t) is given by Fourier transform of the equilibrium Fermi distribution function,

In the opposite lim it $_0$ h=kT,F (T;!; $_0$) can be found using the procedure proposed by Ivanov and Levitov [20]. In a nite observation time $_0$, energy levels are resolved up to h= $_0$, so that we must set

Then, following Ref. [20], we change the time variable t 2 [0; $_0$] to $z = e^{2 \text{ it= }_0}$, and perform contour integration in the circle jzj=1 in complex plane. The result coincides with the low-tem perature limit of Eq. (22) above.

The physical meaning of the function F (T;!; $_0$) with $_0$ 1=T becomes clear once it is written in energy representation,

Equation (24) m easures the change in the number of equilibrium electron-hole pairs due to absorption and em ission of the pumping eld quantum h!. At temperatures kT h! the Fermi distribution is sharp, and F=!=2. At high kT h!, the Fermi distribution is smooth on the scale!, so that F is small, F h!=kT.

Fluctuations of the noise are described by the second factor in Eq. (20), which varies from sample to sample. To not the mesoscopic uctuations of the noise, we use the joint distribution of the matrices R $_{\rm i}$ (i = 1;2) derived in Ref. [34]. The resulting distribution of this mesoscopic contribution depends on two parameters,

Equality $C_c = C_1$ is achieved if $X_1 = X_2$ and = = 2, corresponding to the circular contour in the $(X_1; X_2)$ plane. Below we consider the noise distribution for a quantum dot with single-channel point contacts $(N_L = N_R = 1)$, and for a dot with many-channel point contacts $(N_L; N_R = 1)$ separately.

1. Two channel geometry, N = 2




FIG. 2. Main panel: Distribution of pumping noise S^P for a chaotic quantum dot with single-channel point contacts and two time-dependent parameters X_1 and X_2 given by Eq. (19) with $C_1 = C_c$. [The parameters C_1 and C_c are defined in Eq. (25).] The noise is measured in units of e^2C_1F . The plots are with and without time-reversal symmetry (TRS) and for $e^2=C$ (weak electron-electron interactions inside the dot) or $e^2=C$. Inset: Distribution of the current-to-noise ratio $I=S^P$, measured in units of $I=C_0$. There is no divergence at $I=S^P$!

For small N, the full distribution of the noise can be obtained using the method of Ref. [35] to numerically generate the matrices R $_1$ and R $_2$ according to the appropriate distribution, see Appendix for details. Figure 2 shows the distribution of the noise power SP and the current-to-noise ratio I=SP for a quantum dot with single-channel leads (N = 2) for the case $C_1 = C_c$. The distributions are shown with and without time-reversal sym m etry (TRS). For reference we have also included the distributions for the case e^2 =C of weak electronelectron interactions inside the dot. The case $C_c < C_1$ (i.e., the dependence on the phase di erence) is illustrated in Fig. 3. The current-to-noise ratio shown in Figs. 2 and 3 accounts for the pumping noise S^P only. The Nyquist-Johnson noise S^N presents a di erent noise

source, which will dominate over the pumping noise if $kT > h!^{\frac{p}{C_1}}$.




FIG. 4. The same as Fig. 2 for a quantum dot with N $_{\rm L}$ = N $_{\rm R}$ = 5. Curves with weak and strong electron-electron interaction are indistinguishable.

W e note that the distributions of S^P and $I=S^P$ are highly non-Gaussian. In particular, the mean hSP i of the noise distribution is dominated by the algebraic tail for large S^P , and is not representative of the distribution itself. For example, in the absence of time-reversal symm etry and for $e^2 = C$, the m ean hS P i = 8=3 (e^{2} C $_{1}$ F), while the most probable value is for SP We also note that, while the phase di erence the typical size of the time-averaged pumped current I / e! Cc but not the form of the distribution, changing has a smalle ect on the average noise hS P i, but changes the shape of the noise distribution signi cantly, see Fig. 3. In particular, the probability to nd small SP is signicantly higher for close to zero than for The reason for this dierence is that the case =2 corresponds to noise generated by two independent sources, while close to zero corresponds to only a single noise source. Furtherm ore, the current-noise ratio I=SP has a maximum at $I=S^P = e$, as was predicted by Levitov [16]. For a quantum dot with single-channel point contacts, there is a nite probability density to achieve this optimum current-to-noise ratio, as is seen in the inset of Fig. 2. For point contacts with more than one channel, the probability density to attain the maximum value $I=S^P = e \text{ vanishes [16], see, e.g., Fig. 4.}$




FIG. 3. D istribution of the pumping noise S^P (main panel) and the current-to-noise ratio $I=S^P$ (inset) for a quantum dot with two single channel point contacts and broken time-reversal symmetry, for various values of $C_c=C_1$. The values of $C_c=C_1$ shown are $C_c=C_1=1$, $\sin(=4)$, $\sin(=12)$, and 0. If the variations of the parameters X_1 and X_2 have equal amplitudes, this corresponds to phase dierence ==2, =4, =12, and 0, respectively. The noise S^P is measured in units of e^2C_1F and the current I is measured in units of e^2C_1F and the current I is measured in units of $I=S^P$ of (not shown).

2. Multichannel lim it, N 1

For large N , the ensemble average and variance of the noise can be expressed in terms of an integral over the unitary group and over the eigenvalues of the W igner—Sm ith time-delay matrix R = ih (@S=@")S\$^V [38]. These integrals can be calculated using the method of Refs. [36,37], together with asymptotic expressions for the density and two-point correlations of the eigenvalues of the W igner-Sm ith time-delay matrix, see Appendix for details.

where we abbreviated $g=N_LN_R=N$. The factor F depends on ! and T and was de ned in Eq. (22). Note that the uctuations of S P are a factor 1=N smaller than the average. Higher cumulants of the noise are even smaller, so that we conclude that, for N 1, the noise distribution becomes sharply peaked at the average hS P i

and that the rem aining sam ple-to-sam ple $\mbox{ uctuations}$ are G aussian.

In Fig. 4 we show the results of a numerical calculation of the distribution noise S^P and the current-to-noise ratio $I{=}S^P$ for a dot with N $_L=N_R=5$, N =10. This value of N can be seen as intermediate between the small-N regime, where the distributions are strongly non-Gaussian and the large-N regime where the distributions are Gaussian. We note that for N =10 the noise distribution still has pronounced tails for large S^P .

B.Noise at arbitrary pumping for multichannel dots

In this subsection we consider a general time dependence and am plitude of the parameters X_j . We lime it ourselves to the calculation of the ensemble averaged noise, since the mesoscopic uctuations of the noise are smaller than the average by a factor 1=N if N 1, see Eq. (26).

For a calculation of the ensemble average noise hs Pi, we need to know the correlation functions of scatter-(t;t0) for an ensemble of chaotic ing m atrix elem ents S quantum dots. The indices and refer to the \orbital" channels as well as to the spin of the electrons. In order to discrim inate between the orbital and spin degrees of freedom, we set = (i;), where = to spin and i = 1; :::; N denotes the orbital channels, i = 1;:::; N L for channels in the left point contact and i = N_L + 1;:::; N for channels in the right point contact. In this notation, the scattering matrix $S = S_{ij}^{\circ}$ o is proportional to the 2 2 unit matrix in spin space. The correlator of the orbital part S_{ii} reads

where $x / (=_0)(_{\rm erg})^{-1=2}$ is a dimensionless parameter describing the magnetic ux penetrating the quantum dot and $_0$ the ux quantum [39]. The unitary ensemble, when time-reversal symmetry is fully broken, corresponds to the limit x ! 1.

In the literature, two equivalent approaches have been taken to calculate correlators such as Eq. (27) above, the H am iltonian and scattering approaches [39]. In the H am iltonian approach the fundam ental object is the random H am iltonian of the closed chaotic quantum dot and

the G reen functions related to it. Once the scattering matrix S is expressed in terms of G reen functions, the correlator (27) can be analyzed by standard diagram—matic techniques. The two terms C and D then appear as the cooperon and di uson contributions. The fundamental object of the scattering approach is a statistical model for the scattering matrix S of an ensemble of dots. Equivalence of both methods, including the parametric and energy dependence of S is shown in Ref. [34]. A derivation of Eq. (27) using the scattering approach is given in Ref. [40]. We refer to Ref. [28] for a discussion based on the Ham iltonian approach.

K now ing the correlator (27), we can nd the ensemble-averaged noise hS^P i,

where $g = N_L N_R = N$ is the dot conductance, = N = 2 the escape rate, and we assumed $_0$ 1=!; h=. The Cooperon contribution C of Eq. (27) does not contribute to hS^P i to leading order in 1=N; its contribution is a factor 1=N smaller, see, e.g., Eq. (26a).

Equation (31) gives the ensemble-averaged noise for arbitrary !, T, and , and for arbitrary excursions of the param eters X_j . We now investigate Eq. (31) for the case that there are two time-dependent parameters X_1 and X_2 with time dependence given by Eq. (19). In order to distinguish regimes of \weak" (bilinear) and \strong" pumping, we introduce the energy scale [13,30]

The meaning of the energy scale kT becomes clear when we view the pumping process as \diusion in energy space": carriers absorb or emit energy quanta of size h! at a rate X 2 =h [13]. Weak (bilinear) pumping corresponds to the case when the probability to absorb or emit

one orm ore quanta is small, i.e., to the regime X 2 or kT h!. For kT h! many quanta are absorbed or em itted, so that the carriers in the dot shift their energies by an amount h! $X^2 = T$. If T exceeds the tem perature T of the electrons in the leads, the timedependent potentials in the dot lead to signicant heating" of the electrons inside the dot and T can be viewed as an electron temperature inside the dot. The latter regime is referred to as \strong" pumping.

For weak pumping, kT h!, we can expand D to rst order in X 2 and we recover the result Eq. (26a), now without a restriction on the temperature T. For strong pumping, kT maxfh!; kTg, a simple expression for the noise power can be obtained if pumping is adiabatic, h!. In that case, we note that D in Eq. (31) contains the fast decay exp() and a slow by varying contribution from the time-dependence of the parameters X $_j$. Since the X $_j$ vary slow by on the time scale h=, the integration over can be done, and the result is




FIG.5. Noise hS^P i in units of $e^2g!$, as a function of the dimensionless pumping strength kT = h! and for various choices kT = h!.

The low temperature asymptotics can be easily obtained from this result, and reproduce the Eq. (36) for kT h! or kT h! . For intermediate values of kT = h! and kT=h!, Eq. (37) is plotted in Fig. 5. As long as both h! and kT are much smaller than kT, the integral (37) is dominated by h! = kT 1, so that the strong pumping asymptote of Eq. (36b) is reached, irrespective of! or T.

An analytical expression for 60 can, in principle, be obtained from Eq. (33) as well. The qualitative behavior as a function of pumping strength and temperature is similar to that shown in Fig. 5 for the case =0. The limit of strong pumping should converge to the limit Eq. (34) of T = 0, similarly to the case = 0 studied above.

IV.CONCLUSION

In this paper we calculated the current noise generated in a quantum pump using a scattering matrix form alism with a scattering matrix S $(t;t^0)$ that depends on two times. With this formalism, we could consider arbitrary pumping frequency!, temperature T, escape rate , and pumping strength X. We then calculated the average and variance of the noise for an ensemble of quantum pumps consisting of a chaotic quantum dot.

One issue that has received considerable attention recently is the question whether one can build a noiseless quantum pump [41]. While our results for the bilinear pumping regime show that there is a nite (mesoscopic) probability for zero noise, it is not possible to have no noise and a nite pumped current at the same time in the bilinear regime [16,42], cf. Figs. 2 and 3. This is dierent beyond the bilinear regime, where a quantized, and, hence, noiseless pump has been proposed using a pumping contour that encircles a resonance in an almost closed quantum dot [43].

 tions to the noise are comparable at T $\,$ T $\,$ An experiment cannot separate the two contributions to the noise, since it measures the total noise power. The pumping contribution to the noise is dominant as long as T $\,$ T $\,$.
