Is there a true M odel-D critical dynam ics?

We show that non-locality in the conservation of both the order parameter and a noncritical density (model D dynamics) leads to new xed points for critical dynamics. Depending upon the parameters characterizing the non-locality in the two elds, we nd four regions: (i) modelA like where both the conservations are irrelevant (ii) model B-like with the conservation in the order parameter eld relevant and the conservation in the coupling eld irrelevant (iii) modelC like where the conservation in the order parameter eld is irrelevant but the conservation in the coupling eld is relevant, and (iv) model D-like where both the conservations are relevant. While the rst three behaviours are already known in dynamical critical phenomena, the last one is a novel phenomena due entirely to the non-locality in the two elds.

B ased on the long tim e behaviour, the dynam ics of different critical system s are classied [1] in various dynam ic universality classes. These classes are characterized by several factors like the number of conserved eld, nonvanishing Poisson brackets etc, in addition to the usual quantities necessary for equilibrium. Am ong the models which have no propagating modes, M odelA is a system in which there are no conserved elds, M odelB is a system with a conserved order param eter while M odelC is the class of system s with a non-conserved order param eter

eld coupled to a conservative eld. A fourth classi cation was also m ade - M odel D, in which both the order parameter eld and the coupled eld are conserved. This m odel, how ever, was shown to be equivalent to M odel B as the coupling to the eld becomes irrelevant in the large length long time scale lim it.

The dynam ical behaviour in system swith one or more conserved eld like M odels B, C and D in the above classi cation is usually studied by considering local conservation. How ever, conservation is by no means necessarily local and in fact, non-local conservation is a more general condition. A few recent studies on critical or nearcritical dynam ics show that non-locality in the conserved

eld m ay change the dynam ical class, besides the obvious m odi cations in nonuniversal details. This kind of e ect of non-locality in the conservation has been noted in the study of critical dynam ics of m odel B and C and in the num erical study of the early time e ect of a m odel believed to belong to the class of m odel C and on the zero tem perature dynam ics (phase-ordering kinetics or O stwald ripening) [2, 3, 4, 5, 6, 7]. Besides the theoretical interest on its own right, one of the important applications of nonlocal dynam ics is in speeding up num erical simulations, prom pting im plem entation of various types of nonlocalm oves [8]. Hence the need of a general classi-

cation of e ects of nonlocality in dynam ics.

In a sense, model D is the most generalised class of dynam ical critical phenom ena with dissipative dynam ics. How ever, with local conservation, it is equivalent to M odel B showing no novel features. M otivated by the results of m odel C [4], we investigate the problem of nonlocal conservation in M odel D in the m ost general way by keeping both the conservations in the order param – eter eld and the coupled eld non-local. One of our m ain results is to show the emergence of a true m odel D behaviour by nonlocal dynam ics, unlike the local conservation case.

W e introduce non-locality by using a non-local kernel [2, 3, 4] in the chem ical potential keeping the continuity equation intact. U sing for the order parameter and m for the secondary coupling parameter, the H am iltonian of m odel D is given by

where ${}^{2}(\mathbf{x}) = {}^{P} {}^{n} {}^{2} {}^{i}_{\mathbf{x}}(\mathbf{x}); {}^{4}(\mathbf{x}) = {}^{P} {}^{n} {}^{2} {}^{i}_{\mathbf{x}}(\mathbf{x}) {}^{2}; r = 0$ is the mean eld critical point, and C > 0 ensures noncriticality of m. There is a short distance cuto which in momentum space is an ultraviolet cuto . We shall set = 1 in the calculation. The above Ham iltonian, Eq. (1) is the same as in M odel C [1, 4]. M aking = 0 e ectively reduces the above m odel to m odel A.

The dynam ics ^[yy] is given by the follow ing equations:

[[]yy] Additional torques for n = 3 (Heisenberg model) m ay lead to new dynamic universality classes[9]. We do not consider such e ects.

Here, k = j k j and we have introduced two di erent parameters and to denote the non-localities in the order parameter eld and the coupling eld respectively. The dissipative or the kinetic coe cients (0 and 0) are denoted by the subscript 0 while the transport coefcients (and) by the corresponding powers of k. For the local case, both and assume a value equal to 2. Results are known for some limiting values of and : a) (= 0; = 0) corresponds to model A [1], b) (= 2; = 0) and (= 2; = 2) give model B like behaviour [1], c) any value of > 0 and = 0 is a non-local

ModelB [2, 5], and d) = 0 with any > 0 is non-local modelC [4].

A Ham iltonian of the type of Eq. 1 occurs near the critical wings of a tricritical system or in critical systems with additional constraints. M odelD dynam ics are relevant in such cases, for example in three or four component mixtures or in spin-1 or Potts m odels[10]. A spin $\frac{1}{2}$ exam ple, though a bit unrealistic, would be an antiferrom agnetic system with conserved m agnetisation (as in m odelC [6, 11]) as well as conserved staggered m agnetisation. The K aw asaki dynam ics can be used to conserve the m agnetisation m aintaining at the sam e tim e that the exchanges between opposite spins have to be done in such a way that the order param eter is unchanged.

A momentum -shell renorm alization group approach is used to study the long distance long time behaviour. In this approach, small scale uctuations in space (between e ¹ and in momentum space) are integrated out, and the cuto rescaled to . One then obtains an effective Hamiltonian and e ective equations for the dynam ics valid for longer scales. The universal features are obtained from the xed points of the ow equations for the various param eters of the problem . A sper the usual RG scheme, any parameter that vanishes (grows) in the long scale lim it is called an irrelevant (relevant) variable. A xed point is then characterized by the set of relevant parameters. In this scheme the four dynamics classes correspond to the relevance and irrelevance of and as mentioned in the abstract.

The statics of this system is the same as in M odel C and the xed point values of the parameters r;u and ${}^{2}C$ are as given in ref [4]. The dynamical equations, on the

other hand, take the form s:

where $Q = 1 + 0^{1}$, $P = 1 + 0^{1}$ and $K_{d} = 2^{1 d} d^{d=2}$ (d=2). The parameters ; 0; ; 0; and C appearing in the above equations are all l dependent. To simplify notation, this l-dependence has been suppressed.

From (4b) we get

where x = - is the dimensionless ratio of the two coefcients for the primary order-parameter (note: = 1). This quantity x satis es

Here we have introduced the ratios of the transport and kinetic coe cients of m with the kinetic coe cient of , namely,

We consider the di erent solutions of the equations for x and . Corresponding to the relevance of the conserved quantities, one gets di erent regions in the plane with di erent dynam ic critical behaviour. It should be mentioned here that for n 4, the coupling scales to zero and one e ectively gets a non-local M odel B. This has already been considered and shown to be model A - like when globally conserved [2]. Our discussions are for the n < 4 region where the coupling survives.

There are three xed points of x: x = 0, x = 1 and a non-zero nite xed point value for x from Eq. (6):

 $C a \le 1 \cdot x = 0$ in the long length scale lim it:

This corresponds to non-local M odel C : the conservation of the order parameter is irrelevant. The xed points and their stabilities of non-local m odel C, which were obtained in Ref. [4] from the solutions of , now depends on the value of . In general, x = 0 will be a stable xed point as long as < Y. We focus on the stability of the various regions for non-zero values of .

(a) has a nite xed point value and z = + =. This is a stable solution in the region (2=n) 1 > p > 1(where $p = \frac{2}{=}$) for = 0. For non-zero this remains stable for .

(b) = 1 : this is valid for p > (2=n) 1. Here z = 2+2 = n. This solution x = 0, = 1 is stable as long as < 2 = n.

(c) For = 0, the stability of x = 0 is valid only for p < 1 and < 0 (²). Here z = 2 + 0 (²) and the behaviour is model A like. Any non-zero value of thus destroys this model A like region. Therefore, a region where both the conservations are irrelevant is restricted strictly to = 0.

Case 2.A nite non-zero value of x in the long length scale limit: This occurs when = Y. In order that $_0$ reaches a nite xed point value, we must have z = 2 + .In this case, again has the following xed points: (a) = 1 for 2 + = >(b) = 0 for 2 + = <(c) nonzero nite for 2 + = =

Physically a nite valued xed point of x m eans that the conservation in the order parameter is relevant. If at the same time attains a non-zero xed point value, the conservation of the coupling eld m is also relevant. This occurs if the xed points (a) and (c) are stable.

For case (a), $x = \frac{2 = n}{2 = n}$ and for non-negative value of x, > 2 = n . Hence in between = 2 = n and = 2 + = , a stable region is obtained where both the conservations are relevant.

For case (b), $x + 1 = \frac{(2z =)}{2^{2} = n^{2}}$. This has a nite valued solution for x only for $O(^{2})$. Hence for > 2 + = , x ! 1 is the only solution for = 0. It is a conventionalm odel B xed point.

Case (c): Here z = + = and in principle along the entire line 2+ = = a solution exists where both the conservations are relevant. How ever, there is a restriction on the value of from the condition of existence of a nonzero nite value of . We nd that

Hence with = 2 + p = ; we get the condition (1 + p) < 2(x + 1)=n. Since x is also non-zero, this implies that this solution with both x and nite is valid for p+1==(=) with at least p < (2=n) = 1.




FIG.1: The di erent regions in the non-local M odel D with n = 1 is shown in the rescaled p plane where = = (=) and $p = \frac{(-2)}{2}$. Regions I and II are m odel C like with z = + = and z = 2 + 2 = respectively. Region III' is m odel A like (as in m odel C of Ref. 4) with z = 2 + 0 (2). Reg IV is the "M odel D " region, z = + 2; Reg V is M odel B like, z = + 2. The line p + 1 = is also m odel D -like upto point S (shown by the dashed line). There are no discontinuities of z along any boundary except at the boundary between III' and V.

In the rest of the plane, the only solution is x = 1 and 1 = 0 for which only the conservation of the order parameter is relevant. Here z = +2.

All the above possibilities of di erent dynamic behaviours are summarized in Fig. 1 in the plane (for n = 1). The possibility of seeing a region where both the conservation conditions are relevant raises new issues like early time e ect and boundary or surface e ects[12] in the new regime. These remain to be studied.

To summarize, Model D can be viewed as the most general dynam ic m odel with purely dissipative dynam ics and we indeed obtain all the four types of behaviours as soon as non-locality in the conservations (as in Eq. (2)) are introduced. Since our general model subsum es the previously studied nonlocalm odelC and localm odelD, it is natural to expect A -like, B -like and C -like regimes. The modelA like region, how ever, turns out to be unstable for any nite value of . The model C like regions are stable for small nonzero values of but ultim ately disappear for larger values of . The most non-trivial result, for general values of and , is the appearance (Region IV in Fig. 1) of a region with a new dynam ical behaviour where both the conservations are relevant. This we call a true model D like region { a consequence of nonlocal conservation laws.
