Steady state properties of a mean eld model of driven inelastic mixtures.

Abstract

W e investigate a M axwellm odel of inelastic granular m ixture under the in uence of a stochastic driving and obtain its steady state properties in the context of classical kinetic theory. The m odel is studied analytically by computing the moments up to the eighth order and approximating the distributions by means of a Sonine polynom ial expansion method. The main indings concern the existence of two di erent granular temperatures, one for each species, and the characterization of the distribution functions, whose tails are in general more populated than those of an elastic system. These analytical results are tested against M onte C arb num erical simulations of the model and are in general in good agreem ent. The simulations, how ever, reveal the presence of pronounced non-gaussian tails in the case of an in nite temperature bath, which are not well reproduced by the Sonine method.

I. IN TRODUCTION

G ranularm aterials, a term coined to classify assemblies of macroscopic dissipative objects, are ubiquitous in nature and play a major role in many industrial and technological processes.

Interestingly, when a rare ed granular system is vibrated som e of its properties are sin ilar to those of m olecular uids, while others are unique and have no counterpart in ordinary uids [1]. A spectacular manifestation of this di erence can be observed in a driven mixture of granular particles: if one measures the average kinetic energy per particle, proportional to the so called granular temperature, one inds the surprising result that each species reaches a di erent value. Such a feature, observed in a recent experiment [2], is in sharp contrast with the experience with other states of matter. At a more fundamental level such a behavior is in conict with the Zeroth Law of thermodynamics. This principle states that when two systems globally isolated are brought into therm al contact they exchange energy until they reach a stationary state of mutual equilibrium, characterized by the same value of their temperatures. A corollary to such a principle is the statement that the therm al equilibrium between systems A and B, i.e. $T_A = T_B$, and between A and C ($T_A = T_C$) in plies the therm all equilibrium between B and C [3].

On the contrary, when two granular system A and B subject to an external driving force exchange energy they may reach in general a mutual equilibrium, characterized by two constant but dierent granular temperatures T_A and T_B . In addition even when A and C are in equilibrium at the same temperature T_C and B and C also have the temperature T_C one cannot conclude that A and B would be in mutual equilibrium at the same temperature. In other words, one of the most useful properties of the temperature, i.e. the independence from the them al substance is lost when one deals with granular materials.

In the present paper we shall investigate the properties of a simple model of two component granular mixture. The motivation of our study relies in the fact that granular materials being mesoscopic objects are often constituted by assemblies of grains of dierent sizes and/or dierent physical and mechanical properties. The study of granular mixtures has attracted so far the attention both of theoreticians [4] and of experimentalists [2]. In particular G arzo and D uffy have studied the evolution of a mixture of inelastic hard spheres in the absence of external driving forces, a process term ed free cooling because associated with a decrease of the average kinetic energy of the system, i.e. of its granular term perature. D uring the cooling of a m ixture, which can be hom ogeneous or not, according to the presence of spatial density and velocity gradients, each species m ay have di erent granular tem peratures, although these m ay result asym ptotically proportional, i.e. they m ight decrease at the sam e rate.

M enon and Feitosa instead studied several mixtures of vibrated inelastic grains and reported their failure to reach the same granular tem perature.

In the present paper our interest will be concentrated on the statistically stationary state obtained by applying an energy feeding mechanism represented by a stochastic driving force.

The most widely used model of granular materials is, perhaps, the inelastic hard sphere model (IHS) [5], which assumes the grains to be rigid and the collisions to be binary, instantaneous and momentum conserving. The dissipative nature of the collisions is accounted for by values less than 1 of the so called restitution coe cient r. Even such an idealized model represents a hard problem to the theorist and one has to rely on numerical methods, namely Molecular D ynamics or Event D riven Simulation, or to resort to suitable truncation schemes of the hierarchy of equations for the distribution functions. One of these schemes is represented by the Boltzm ann equation based on the molecular chaos hypothesis, which allows to study the evolution of the one-particle distribution function. Its generalization to the two component mixture of inelastic hard spheres has been recently considered by G arzo and D uffy.

O ur treatm ent will depart from previous studies, because we have chosen an even simpler approach based on the so called gases of inelastic (pseudo)-M axwellm olecules. These gases are natural extensions to the inelastic case of the m odels of M axwellm olecules [6], where the collision rate is independent of the relative velocity of the particles. Such a feature greatly simpli es both the analytical structure of the Boltzm ann equation and the num erical im plem entation of the algorithm simulating the gas dynam ics. A lthough the constant collision rate is som endow unrealistic one m ay hope to be able to capture som e salient features of granular m ixtures, and in particular to reach a better understanding of their global behavior, because the m odel lends itself to analytical studies.

This type of approach to granular gases had recently a surge of activity since the work of Ben-Naim and Krapivsky [7, 8], our group [9, 10, 11], Ernst and coworkers [12] and Cercignani and collaborators [13, 14], and is providing a series of new important results concerning the energy behavior and the anom alous velocity statistics of granular system s.

The paper is organized as follows: in Section 2 we de ne the model and deduce the associated Boltzm ann equations governing the evolution of the velocity distribution functions of the two species and set up theirm on ent expansion; in section 3 we shall the exact values of the stationary granular tem peratures; in section 4 we consider the moments up to the eighth order and compute the distribution functions by means of the so called Sonine expansion. In section 5 we simulate on a computer the dynam ics of the inelastic mixture and compute num erically the distribution functions and compare these with the theoretical predictions. Finally in 6 we present our conclusions.

II. DEFINITION OF THE MODEL

In the following we shall consider a mixture of M axwell inelastic m olecules subject to a random external driving. Let us consider an assembly of N₁ particles of species 1 and N₂ particles of species 2. For the sake of simplicity we assume the velocities v_i , with = 1;2, to be scalar quantities. The two species m ay have dimensional masses, m₁ and m₂ and/or constant restitution coecients which depend on the nature of the colliding grains but not on their velocities, i.e. r_{11} ; r_{22} and $r_{12} = r_{21}$.

The mixture evolves according to the following set of stochastic equations:

where the total force acting on particle i is made of three contributions: the impulsive force, F_i , due to mutual collisions, the velocity dependent force, $f_i = v_i$, due to the friction of the particles with the surroundings and the stochastic force, i, due to an external random drive. Since we are interested in the rapid granular ow regime, we model the collisions as instantaneous binary events, sim ilar to those occurring in a hard sphere system.

The presence of the frictional, velocity dependent term in addition to the random forcing [15], not only m in ics the presence of friction of the particles with the container, but also is motivated by the idea of preventing the energy of a driven elastic system (! 1), to increase inde nitely.

Let us observe that in the absence of collisions the velocity changes are described by the following 0 mstein-U hlenbeck process:

where the stochastic acceleration term is assumed to have a white spectrum with zero mean:

By rede ning the bath constants $= \frac{D}{m}$ and $D = \frac{D}{m^2}$, it is straightforward to obtain the probability distributions of the velocity of each species, P (v;t). In fact, the Fokker-P lanck equations associated with the process (2):

possess the following stationary distribution functions:

where $T_b = \frac{D}{2}$ represents the tem perature of the heath-bath, that we x to be the same for the two species [16].

In order to represent the e ect of the collisions on the evolution of the system we assume that the velocities change instantaneously according to the rules:

where the primed quantities are the post-collisional velocities and the primed are the velocities before the collisions. A nite fraction of the kinetic energy of each pair is dissipated

during a collision. Between collisions the velocities perform a random walk due to the action of the heat-bath. The typical time _c between particle-particle collision is assumed to be large compared to the time between random kicks. On the other hand the typical time scales associated with the bath are $_{b1} = \frac{m}{1} = \frac{1}{1}$ and $_{b2} = \frac{m}{2} = \frac{1}{2}$. When ! 0 we must also take D ! 0 in performing the elastic limit, otherwise the kinetic energy would diverge asymptotically. In fact in section V we shall discuss the situation of inelastic particles with vanishing friction, a case already considered in refs. [7] [13].

The evolution equations for the probability densities of nding particles of species with velocity v at time t for the system subject both to external forcing and to collisions are simply obtained by adding the two e ects:

where the collision integrals Q consist of a negative loss term and a positive gain term respectively:

where $p = N_1 = (N_1 + N_2)$. In writing eqs. (9) we have assumed that the collisions occur instantaneously and that collisions involving more than two particles simultaneously can be disregarded. Moreover, all pairs are allowed to exchange in pulse regardless of their mutual separation. In this sense we are dealing with a mean eld model. In order to proceed further it is convenient to take Fourier transforms of eqs. (9) and employ the method of characteristic functions [17] de ned as:

From the mathematical point of view the driven case is very dimensional from the cooling case. A swe have seen in the latter case the tails are originated by the presence of a singular point at the origin in the equation for the characteristic function [18]. The singularity is due to the conspiracy of the constant cooling rate and of the scaling form of the evolution equation. Such a singularity is removed in the driven case, thus high velocity tails cease to exist and the distribution will be much more well behaved.

The mathematical structure of eqs. (11) is particularly simple and in fact there exists a standard method of solution. It consists in expanding the Fourier transform \hat{P} (k;t) of the distributions P (v;t) in a Taylor series around the origin k = 0:

and substituting (13) into eqs. (11).

Equating like powers of k we obtain a hierarchy of equations for the $_n$ (t) which can be solved by a straightforward iterative method. At this stage one can appreciate the m athem atical convenience of the M axwell m odel. In fact, the coe cients of the Taylor series represent the m om ents of the velocity distributions

Since the evaluation of the m om ents of a given order requires only the know ledge of the m om ents of low er order one can proceed without excessive di culty to any desired order. In practice, we carried on our calculation up to the eighth m om ent, assum ing that the initial distributions were even, so that the odd m om ents vanish. In order to render the reading of the paper m ore expeditious we shall report the equations determ ining the stationary value of the m om ents in the Appendix.

III. TW O TEM PERATURE BEHAVIOR

In order to determ ine the granular tem peratures we equate the coe cients of order k 2 in eqs. (11) and obtain the governing equations for the second m om ents:

The rhs. of eqs. (15) represent the balance between the energy dissipation due to inelastic collisions and friction and the energy input due to the bath. We denot the global and the partial granular temperatures respectively as $T_g = pT_1 + (1 \ p)T_2$ and $T = \frac{1}{2}m < v^2 >$, where the average is performed over the noise $_1$. Since the energy dissipation and the energy supply mechanisms compete, the system under the in uence of a stochastic white noise driving achieves asymptotically a statistical steady state. Notice that eqs. (15) feature only the second moments of the velocity distributions, so that the solution is straightforward. Such a state of a airs should be contrasted with the analogue problem of determining the partial temperatures in Boltzm ann models [4].

Let us start analyzing the behavior of the M axwell gas in the one component lim it lim it p! 1. The granular tem perature approaches its stationary value T_1 exponentially:

where the constant represents a combination of the two characteristic times of the process given by:

which shows that T_b is an upper bound to the granular tem perature. We also obtain a simple relation between the tem perature of the bath and the granular tem perature T_1 :

On the other hand, when the two components are not identical eqs.(15) show that the equilibrium macro-state is specified by two different partial granular temperatures, both proportional to the heath bath temperature. Hence, the temperature ratio is independent from the driving intensity D as one can see from the formula:

Form ula in eq. (19) illustrates the two temperature behavior of an inelastic mixture subject to external driving. Notice that the temperature ratio in the driven case is di erent from the corresponding quantity in the cooling undriven case, for the same model system. In the undriven case we found that the hom ogeneous cooling state was characterized by two di erent exponentially decreasing temperatures, but whose ratio was constant. However, no simple relation exists between the ratio relative to the two cases, on account of the fact that the energy exchanges involved are rather di erent. Thus, in the presence of a heath bath the inelastic mixture displays the two temperature behavior already reported in the free cooling case [4, 18] and in experiments [2]. This feature seem s to be a general property of inelastic system s. In g. (1) we display the temperature ratio as a function of the mass ratio for two di erent values of the inelasticity. Notice that the temperature of the heavier component is lower than the one of the lighter species.




FIG.1: Tem perature ratio as a function of the mass ratio for di erent choices of the inelasticity parameter, for p = 0.5 and $r_{11} = r_{22} = r_{12} = r = 0.8$ (solid line) and r = 0.5 (dashed-line)




FIG. 2: Tem perature ratio as a function of the asymmetry $r_{22}=r_{11}$ for p = 0.5, = 1 and dimensional dimensiona dimensional dimensi dimensiona dimensi

In g. 2 the ratio of the temperatures of the two species is plotted in the case of an asymmetry in the restitution coe cients parametrized by the form : $r_{22} = r_{11} \times w$ ith $r_{12} = (r_{22} + r_{11})=2$, for p = 1=2, identical masses and three dimensions of the coe cient r_{11} as shown in gure. One sees that the variation of $\frac{T_1}{T_2}$ is much smaller than the corresponding variation with respect to the mass asymmetry shown in g. 1 in agreement with

the experimental observation of reference [2]. It seems reasonable to conclude that the mass asymmetry is the larger source of temperature di erence between the two components.

IV. VELOCITY DISTRIBUTION FUNCTIONS

An interesting aspect of granular systems concerns the nature of the single particle veboity distributions. The inelasticity, in fact, causes marked departures of P (v;t) from the Gaussian form which characterizes gases at them al equilibrium. In undriven gases these deviations are particularly pronounced and one observes inverse power law high-velocity tails both in gases of pseudo-Maxwell molecules [18] and in IHS [19]. In the driven case, i.e. in system s subject to G aussian white noise forcing (similar to that represented by eq. (2) with = 0) exponential tails of the form $\exp(v^{3-2})$ have been predicted theoretically in inelastic hard-sphere models [19] and tested by direct simulation M onte Carlo of the Enskog-Boltzm ann equation [20]. Have these non Gaussian tails a counterpart in Maxwell models? Ben-Naim and Krapivsky [7] on the basis of a re-summation of the moment expansion concluded that the scalar M axwell m odels with vanishing viscosity (= 0) should display Gaussian-like tails. However, this prediction is in contrast with the argument, em ployed by Emst and van Noije in the case of IHS, which consists in estimating the tails of the distribution by linearizing the master equation (9) by neglecting the gain term. This assumption simplies the analysis and allows us to reach the conclusion that the velocity distribution for large v should vanish as:

with $v_0^2 = D_c$. C learly such a result is in sharp contrast with the result of ref. [7] and seem s to indicate that the Sonine expansion does not reproduce faithfully the high-velocity tails in the case of M axwell m odels with vanishing viscosity. The test of the lim it (20) will be shown in the section 6, where we illustrate the results of our num erical simulations.

On the other hand, the same kind of asymptotic analysis sketched above, allows us to conclude that the presence of a viscous damping is the redeeming feature which renders convergent the Sonine expansion and the associated G aussian tails. In fact, with a nite value of the asymptotic solution is of the form :

W e shall test such a prediction in the remaining part of this section and study the velocity distributions of the individual species when 60 by constructing the solution to the master equation using the Sonine polynom ial expansion method, one of the traditional approaches to the solution of the Boltzm ann equation [21].

We shall also investigate whether the two partial distributions can be cast into the same functional form upon re-scaling the velocities with respect to the partial granular therm al velocity, in other words if it is possible to have a data collapse for the two distributions.

We shall rst obtain the steady state values of the rst eight moments as illustrated in the Appendix and then compute the approximate form of the distribution functions by assuming that these are Gaussians multiplied by a linear combination of Sonine polynomials.

Let us begin by writing the following Sonine expansion of the distribution functions:

and $c^2 = v^2 = 2_2$. The expansion gives the distributions in terms of the coe cients a_n of the Sonine polynomials $S_n(c^2)$. In practice, one approximates the series (22) with a nite number of terms. Since the leading term is the Maxwellian, the closer the system to the elastic limit, the less term su ce to describe the state. The expression of the rst polynomials is:

In order to obtain the rst m values a_m , we need to compute the re-scaled m om ents hc^n i of the distribution functions up to order 2m. These m om ents are evaluated in Appendix by m eans of a straightforward iterative m ethod. At the end, knowing the re-scaled m om ents, one obtains the following relation for the coe cients:

where N_n is a normalization constant. Notice that in order to obtain our results we have not assumed weak inelasticity, therefore these hold for any value of the restitution coecients.




FIG. 3: Second Coe cient of the Sonine expansion a $_2$, for each component as a function of the mass ratio , m $_1 = 1$ and for p = 0.5 and r $_{11} = r_{22} = r_{12} = 0.5$. We have also xed $\frac{1}{b1} = 200$ and $_c = 25$.

In g. (3-5) we display the behavior of the Sonine coe cients for both components in the case of equal restitution coe cients r = 0.5 as a function of the mass ratio.

In gs. (6-8) we illustrate the variation of the Sonine coe cients for the two components as a function of the inelasticity for two di erent values of the mass ratio: = 1 and = 2. Notice that the coe cients are monotonic functions of the inelasticity as already noticed in pure systems [19].

In g.(9) we show the distribution functions for the heated system with non vanishing viscosity. The tails become fatter with increasing order of the approximation, i.e. the high energy tails are overpopulated. Moreover, one sees that when p = 1=2 and the restitution coe cients are all equal the species with the larger tails is the lighter. On the other hand,




FIG.4: Third C oe cient of the Sonine expansion a $_3$, for each component as a function of the mass ratio . The remaining parameters as in g.3




FIG. 5: Fourth C oe cient of the Sonine expansion a $_4$, for each component as a function of the mass ratio . The remaining parameters as in g. 3

for a system with the same masses, but dierent restitution coecients, the more elastic species displays the larger tails. We also show the numerical data obtained by simulating the the dynamics. The agreement is quite satisfactory and validates the approximation method employed.

On the other hand, it is also evident, that the two distributions fail to collapse one over the other after the rescaling of the velocities. This fact is consistent with the di erent values




FIG. 6: Second Coe cient of the Sonine expansion a $_2$, for each component as a function of the inelasticity $r = r_{11} = r_{22} = r_{12}$, for p = 0.5 and $m_1 = 1$ and = 2 and = 1. The remaining parameters as in g. 3.




FIG. 7: Third Coe cient of the Sonine expansion a $_3$, for each component as a function of the inelasticity $r = r_{11} = r_{22} = r_{12}$, for p = 0.5 and $m_1 = 1$ and = 2 and = 1. The remaining parameters as in g. 3.

assumed by the coe cients a_n^1 and a_n^2 . However, this e ect is rather small and can be appreciated only by studying the high velocity region of the distribution functions.




FIG. 8: Fourth C oe cient of the Sonine expansion a $_4$, for each component as a function of the inelasticity $r = r_{11} = r_{22} = r_{12}$, for p = 0.5 and $m_1 = 1$ and = 2 and = 1. The remaining parameters as in g. 3.




FIG. 9: Rescaled distribution functions for the two components for a model system characterized by $m_1 = 1$, $m_2 = 0.5$ and equal inelasticities $r = 0.5 T_b = 1$ and the remaining parameters as in g. 3

V. NUMERICAL SIMULATIONS

To investigate the validity of the previous results and in particular to test the convergence of the Sonine expansion in di erent situations we shall present in this section numerical results obtained by simulating an ensemble of N particles subject to a Gaussian forcing, viscous friction and inelastic collisions.

The scheme consists of the following ingredients:

i tim e is discretized, i.e. t = n dt

ii update all the velocities to simulate the random forcing and the viscous dam ping:

where W (t) is a norm ally distributed deviate with zero m ean and unit variance.

- iii Choose random ly N $\frac{dt}{2_{c}}$ pairs of velocities and update each of them with the collision rule (7). In this way a mean collision time _c per particle is guaranteed.
- iv Change the time counter n and restart from ii.

In other words, at every step each particle experiences a G aussian kick thus receiving energy from the bath, whereas it dissipates energy by collision and by dam ping. For exam ple, by choosing dt = 1, $m_1 = b_1 = 200$ and c = 25, we obtain that each particle in the average experiences 25 G aussian kicks between two successive collisions and that the resulting average kinetic energy is stationary. In order to com pare our num erical simulations with the theoretical predictions we keed the tem perature of the bath to be $T_b = 1$, i.e. chosen D = c. The results of such simulations are presented in g. 9 and show a very good agreem ent between the theory and the simulation.

On the contrary, the agreem ent between the Sonine expansion and the simulation is not completely satisfactory when we consider a system subject to a white noise acceleration, but without viscous friction, a driving proposed by some authors [22], [23]. This can be considered as the limit $! 0, T_b ! 1$, keeping constant $D = T_b$, in the model de ned by eqs. (8): note that in this case the elastic limit r ! 1 cannot be performed without taking also the limit D ! 0 as discussed at the beginning, in order to avoid a divergence of kinetic energy. For the sake of simplicity, we simulated a one component system (p = 1 and m = 1) with vanishing viscosity = 0, but D = 0.0008, $_c = 250$ and r = 0.5. Such a choice yields a granular temperature $T_g = 16=15$, as predicted by our formula (18). Notice that in this case the heath bath temperature diverges and the gas does not have a proper elastic limit, since all moments diverge when ! 0. We observed that the tails of the velocity distribution function are strongly non G aussian. These decay as a simple exponential as predicted by our simple analysis of the previous section. In g. (9) we report our simulation results against the Sonine approximation. We observe that the theoretical estimate, in spite of incorporating the exact values of the rst eight moments, deviates from the numerical data in the large velocity region. In particular the Sonine expansion can only give G aussian tails, whereas the simulation indicates a slower exponential decay. The reason for such a discrepancy is to be ascribed to the slow convergence of the expansion when = 0.




FIG. 10: Rescaled distribution functions for a one component system (p = 1) with vanishing viscosity (= 0), D = 0.0008, r = 0.5 and $_c = 250$. We show the initial Gaussian distribution (t = 0) and the asymptotic (t = 3000) stationary distribution. Notice the presence of high velocity tails. For the sake of comparison we report the theoretical estimate of the distribution obtained by means of the Sonine expansion.

VI. DISCUSSION AND CONCLUSIONS

To sum m arize we have studied the behavior of a m odel, which perhaps represent the sim – plest description of a driven inelastic gas m ixture, namely an assembly of two types of scalar pseudo-M axwell m olecules subject to a stochastic forcing. We have obtained the velocity distributions for arbitrary values of the inelasticity, of the composition and of the m asses by solving the associated Boltzm ann equation by m eans of a controlled approxim ation, the

m om ent expansion. The distributions were obtained by computing exactly the m om ents up to the eighth order and then imposing that the corrections to the M axwell distribution stem m ing from the inelasticity are G aussians multiplied by a linear combination of Sonine polynom ials with am plitudes determ ined self-consistently.

The model predicts a steady two temperature behavior which is in qualitative agreement with existing experimental results. The granular temperatures can be obtained by very simple algebraic manipulations for arbitrary values of the control parameters.

By num erical simulations we demonstrated that the velocity distributions are well described by our series representation in the case of systems in contact with a bath at nite temperature T_b , whilst the series expansion breaks down in the case of systems in contact with bath at in nite temperature, i.e. with zero viscosity.

W hat can be learned from such a simple model of granular mixture? Besides obtaining a global picture of the behavior of the system with a minimal numerical e ort both in the cooling and in the driven case, the model displays the novel feature of two di erent distribution functions, which remain di erent even after rescaling by the associated partial granular temperatures. Of course the detailed form of the probability velocity distributions are strictly model dependent, i.e. depend on the assumption of a constant collision rate inherent in M axwellm odels. Finally, the vectorial character of the velocities could be included at the cost of a moderate additional e ort. A more interesting and di cult problem would be that of including in the mixture case a collision frequency proportional to an appropriate function of the kinetic granular tem peratures, generalizing the work of C ercignani [13].

Finally we might ask the general question of the meaning of granular temperature. Our ndings seem to indicate that it is still the main statistical indicator of the model granular system we studied. However, with respect to the temperature of a perfectly elastic system it fails to satisfy a very basic requirement which is known as the zeroth principle of thermodynamics.

In the present Appendix we sketch the derivation of the various moments of the distribution functions. By equating the equal powers of k in the master equation (11) we obtain a set linear of coupled equations for the moments. The method of solution is iterative, because the higher moments depend on the lower moments. Thus, for instance, to evaluate the lowest order moments of the distribution functions we must solve the following equations for the steady state value of the fourth moments:
