Continuum eld theory of string-like objects. Dislocations and superconducting vortices

Sum m ary: Dense distributions of string-like objects in material media are considered in terms of continuum eld theory. The strings are assumed to carry a quantized abelian topological charge, such as the Burgers vector of dislocations in solids, or magnetic ux of supercurrent vortices in type-II superconductors. Within this common framework the facts known from dislocation theory can be extended, in appropriately modied forms, to other physical contexts. In particular, the concept of incompatible distortions is transplanted into the theory of type-II superconductivity. The compatibility law for type-II superconductors is derived in terms of dierential forms. As a result, one obtains an inhom ogeneous generalization of the classic Londons' equation.

K eyw ords: linear defects, dislocations, incom patible distortion, type-II superconductivity, m agnetic ux lines

1 Introduction

The heuristics of the present paper can be conveniently developed by starting from the striking analogy between dislocations in solids and magnetic vortices in superconductors. While the former determine the behaviour of materials in plastic deformation processes, the latter are responsible for magnetic and transport phenomena in type-II superconductors. The physical contexts in the situations are indeed very dierent. Nevertheless, the analogy is far from being super cial. It suces to note common fundamental features such as the distinguished linear structure, quantized dynamical quantities concentrated on and conserved along the lines, as well as large amount of irreversibility in their dynamical behaviour.

In most situations the number of vortices in a macroscopic superconducting specimen is very large, what enables an elective description of vortex networks with the aid of continuum eld theories [1-3, 5{6, 8{11, 18}}.

In the present paper we shall concentrate our attention on the com patibility laws which govern the behaviour of the continuum elds describing the macroscopic quantities. We adopt the following term inological convention. Whenever



m ore precise language concerning type II superconductivity is necessary we shall make use of the term—uxon in place of informal terms like—ux line or magnetic vortex. It, however, should be contrasted with the term—uxoid, for which we adopt London's de nition [10].

Thoughout the paper, a theoretical description of a string system will be term ed m acroscopic if it deals with collective quantities without paying attention to individual lines. The description which refers to individual strings, but not to individual atoms, will be called mesoscopic; the term microscopic will be reserved for the atom istic description.

2 A nalogy with dislocation networks

In general term s, the relation between m agnetic ux lines and m acroscopic m agnetic properties of superconductors is similar to the relation between dislocation lines and the macroscopic mechanical properties of solids.



Later on we shall not limitations of this analogy. For the present purposes it turns out to be useful, and we shall try to get some prots from it.

The continuum theory of distributed dislocations has been developed by K roner in his classic work [13]. The theory has been generalized to moving dislocations by K osevitch [12]. M odern geometric formulations of continuum theory of dislocations have been given by K roner [14, 15], M istura [16], and Trzesowski [17]. The dynamics of networks of string-like objects has been considered recently by Rogula & Sztyren [19, 20].

A single dislocation line L is characterized by its Burgers vector $b_{\rm L}^i$, which is topologically quantized and conserved along the line. On the other hand, a single magnetic ux line is characterized by associated magnetic ux $_{\rm L}$, which also is topologically quantized and conserved along the line. An immediately visible dierence between the two cases is the vectorial nature of $b_{\rm L}^i$ and the pseudoscalar nature of $_{\rm L}$. This dierence, however, athough important in many respects, does not break the analogy.

The presence of dislocation lines in a material continuum results in a distortion eld which is well de ned in the region of "good material" { outside the

dislocation cores. The good material is, however, multi-connected and the dislocations give rise to the distortion eld which cannot be represented with the aid of a globally de ned single (valued displacement eld. One of the possibilities here is to make use of multi(valued displacement elds. A nother possibility consists in the following. Instead of a multi(valued displacement eld ui, one considers a single (valued dierential form dui de ned by the relation

where the right{hand side denotes the total Burgers vector of the dislocation lines encircled by the contour C. The entire contour C is con ned to the good material and is otherwise arbitrary.

3 M acroscopic averages in string systems

To describe e ectively the material media which contain a very large amount of string-like objects one has the need for a fully macroscopic theory which operates with quantities describing large collections of such objects without paying much attention to an individual string.

3.1 String density and string current

The placem ent and m ovem ent of an individual line segm ent at the m esoscopic level can be conveniently described with the aid of the following quantities, valid generally for networks of moving lines L = L (t)

where $v^1(x^0)$ denotes the velocity of the line element at x^0 . Only the components of velocity perpendicular to the line element contribute to the string current (3).

Note that the above de ned quantities, which may be interpreted as the oriented string density and oriented string current, depend solely on the orientation and geometry of the lines, and are independent of any physical characteristics of the strings. For the string density and string current we obtain the following balance equations

It is expedient to notice that, in the case of point-like particles, the analogue of the rst of the above equations expresses the conservation of the number of

For networks of dislocations in crystals and magnetic ux lines in superconductors, the related quatities are de ned in the following subsections.

3.2 D islocation networks

Notation: b_L^i represents the Burgers vector associated with the line segment L.

The dislocation density ij and the dislocation current J_k^i satisfy the equations

which express the Burgers vector conservation laws.

M agnetic ux networks

Notation: $_{\rm L}$ and $_{\rm 0}$ represent the quantized ux associated with the line segm ent L and the elem entary ux quantum, respectively. Typically $_{L}$ =

The density $_{i}$ and the current K $_{i}$ satisfy the conservation equations

which are the analogues of eqns. (10). The quantity $\,^{i}$ represents the contribution of the magnetic ux lines (uxons) to the macroscopic induction eld B i ; therefore it will be called the (oriented) uxon density. The quantity K $_{j}$ represents the macroscopic uxon current density resulting from the motion of uxons. On the other hand, the ux current produces some electric eld, coupled to the moving magnetic ux through Maxwell equations. In consequence, we arrive at the following interpretation

where B str and E str stand for the contribution of strings to the electrom agnetic elds.

Several approaches to the continuum description of superconductors containing dense distributions of vortex lines are known from the literature; see e.g. London & London [9, 10], Laue [8], Zhou [11], Abrikosov [1, 2], Anthony & Seeger [3], Chapman et al. [5, 6], Rogula [18]. Some of them can be derived with the aid of particular assumptions concerning the macroscopic averages. Note that, in general, due to statistical correlations between mesoscopic string con gurations and their motions, the inequality

holds. There are, however, in portant special cases, such as coherent uxon ow, or else uncorrelated random ness of and v, when both sides of the formula (18) are identical to a good degree of approximation, and the corresponding assumption of the vortex-density model [6] is justified. The uxon current K and the uxon density are then related through the macroscopic average of the uxon's velocity by the equation

valid in this special case.

4 The compatibility equations

4.1 The distortion eld and dislocation density

The presence of continuously distributed dislocation lines in a material continuum causes an incompatible macroscopic distortion of the medium. The situation may be brie y sketched as follows. While the multi-valued mesoscopic displacement elds, mentioned in Section 2, are rather hard to be averaged, and would lead to ill-de ned macroscopic diplacement elds, the single-valued dierential forms allow for unequivocal averages. Therefore, to describe incompatible distortion elds at the macroscopic level, instead of ill de ned displacement

eld u^i one considers the well{de ned di erential form du i undestood as the macroscopic average of the mesoscopic di erential form (1). The corresponding continuum eld equations, expressed in terms of the material distortion $\frac{i}{j}$ and the dislocation density i^i , take the form

and can be obtained from the expression

by taking into account the equations (1) and (7). Keeping that in m ind, we will search for an analogue of the above relations in the fram ework of superconductivity.

4.2 The uxoid density and superconducting vortices Let us consider the expression

for the supercurrent density (for sim plicity we start from an isotropic superconductor) with the following notation: = (x;t) represents the G inzburg-Landau order parameter, its complex conjugate, $A_k = A_k$ (x;t) the electom agnetic vector potential, e and e denote the electric charge and the e ective m ass of a Cooper pair, respectively. We substitute

where jz j = 1 so that z = z (x;t) equals the phase factor of the order parameter eld. The eqn. (22) m ay then be rewritten as

Now, let us introduce the following di erential form:

which represents the phase di erential. With the aid of this form we can write

The right {hand side of the above equation represents the uxoid density. A fter integration over an appropriately smooth surface S, we obtain

where [C] equals the total uxoid encircled by the contour C = @S,

In consequence, passing to the di erential relation, we obtain the analogue of eqn. (20)

with $n_s=j-\hat{j}$. The left{hand side of this equation corresponds to the gauge invariant Londons' equation

with the charge e and mass m replaced by the Cooper pair charge e and e ective mass m , respectively, and with j j interpreted as $n_{\rm s}$. Hence one can see that the incompatibility of the superconducting order parameter due to continuously distributed ux lines modiles Londons' relation (32) between the magnetic induction eld and the supercurrent density.

Due to the electrom agnetic character of the quantities involved, an electric counterpart of eqn. (31) has also to be valid. In fact, taking into account the ux ow balance (16) and making use of the Maxwell equation

The above equation can be conveniently integrated to the form

Note, however, that the integrated relation (35) becomes algebraically independent of the equations derived up to this point. This is due to the new gradient

term $_{;i}$ which depends on speci c features of the con guration under consideration.


The tensor

generalizes the (squared) Londons' penetration depth $\frac{2}{1}$.

5 Conclusion

The heuristic form ulation of the analogy between dislocations in solids and ux lines in superconductors can now be stated in a more precise way: the diagram given in the Introduction should be complemented by the following scheme:



Due to the presence of extra quantities { the uxon density and the uxon current { the above given m acroscopic equations, even when augmented with m aterial constitutive relations, are incomplete. They can be completed by a variety ofm athem aticalm odels stated in terms of the elds $^{\rm i}$ and K $_{\rm j}$ and taking into account the string kinetics. In this way one can, for instance, reproduce the behaviour of superconductors described by critical state models, such as

Bean's [4] or K im & Stephen's [7] ones. On the other hand, by making use of the above stated analogy, one can adapt a selection of models conceived in the theory of dislocations in order to describe the irreversible behaviour of dense string systems.
