Inverse problem for the Landau-Zener e ect

A bstract. { We consider the inverse Landau-Zener problem which consists in nding the energy-sweep functions W (t) $"_1$ (t) $"_2$ (t) resulting in the required time dependences of the level populations for a two-level system crossing the resonance one or more times during the sweep. We nd sweep functions of particular forms that let manipulate the system in a required way, including complete switching from the state 1 to the state 2 and preparing the system at the exact ground and excited states at resonance.

The Landau-Zener (LZ) e ect [1, 2, 3], which consists in the quantum -m echanical transition between the two time-dependent levels of a two-level system (states 1 and 2) caused by crossing the resonance, is a well known phenom enon in many areas of physics. Well known applications of the LZ e ect are those to molecular collision and dissociation [4, 5]. Recently, LZ e ect has been used to measure the tunnel splitting in molecular magnets whereby detecting topological interference e ects [6] which were predicted theoretically [7, 8, 9]. If the system was in state 1 before crossing the resonance, then, for a constant sweep rate v, the probability to stay in this state after crossing the resonance is given by

$$P = \exp -\frac{2}{2hv} ; \qquad (1)$$

where V = (1) j W (t) $"_1(t) "_2(t), "_{1;2}(t) = h_{1;2} \hat{H} j_{1;2}i$, $2h_1 \hat{H} j_2 i, W$ (t) satisfies W (1) = 1 and is the tunnel level splitting. For fast energy sweep rates v the system spends too little time in the vicinity of the resonance so that the tunneling matrix element $h_1 \hat{H} j_2 i$ cannot bring the system into the state 2 (say, onto the other side of a potential barrier), and the system remains in the initial state 1. For slow sweep rates the probability to remain in the initial state becomes exponentially small, and the system travels into the state 2 remaining on the lower exact energy term " (t) of

The corresponding adiabatic time dependence of the probability to be in state 1 is given by

In the case where hv 2 and v is constant, the solution of the Schrödinger equation for $\dot{p}_{1}(t) f$ can be found analytically [1, 2, 3] and it is oscillating at t > 0 slow ly approaching P given by Eq. (1) att! 1.

The known results above are valid for the linear energy sweep, W (t) = vt:O ne can consider, how ever, other sweep functions W (t) that behave nonlinearly in the vicinity of the resonance, W . If the tunneling resonance is not too narrow and its position is well de ned, nonlinear sweeps of a controlled form can be realized experimentally. A lthough no general analytical solution of the Schrödinger equation is known for the LZ problem with an arbitrary W (t); one can look for the functions W (t) that result in a desired time dependence of the probability $j_{l_1}(t) j$, thus solving the inverse LZ problem. It is the main motivation of this Letter to study this inverse problem which, for instance, will allow to determ ine W (t) needed to manipulate and to prepare a quantum system in a speci c state.

One class of solutions of the time-dependent Schrödinger equation are smooth, nonoscillating functions of time that describe the complete switching of the system from the state 1 to the state 2, e.g., E.q. (3). Another class of solutions are those starting in $_1$ at t = 1 o resonance and ending in a given superposition of the exact states at resonance [N (t) = 0 for t 0]. The most interesting variants of the latter are the system in the ground state at resonance and in the excited state $_+$ at resonance. These possibilities to manipulate the system in a required way could prove to be useful for the quantum computing (Q C). Another interesting possibility is to sweep at a high rate (nonlinearly in time) far from the resonance thus making the whole process of crossing the resonance much shorter. Exploring these new types of solution of the LZ problem is the aim of this Letter.

To this end, we consider the Schrödinger equation for the coe cients in the wave function $(t) = c_1 (t)_1 + c_2 (t)_2$ that can be written in the form




Fig. 1. { The cubic-parabola energy sweep with W (t) = $2.5t + 1.83t^3$ and = h = 1. Time dependence of the probability $j_{l_1}(t)f = j_1(t)f$ can be tted with $j_2f = [1 \tanh(\sinh t)]=2$ with graphic accuracy. The function $j_2f = [1 \tanh t]=2$ is shown for comparison.

with $p(t) = e^{i''_1 t}c_1(t)$ and $q(t) = e^{i''_1 t}c_2(t)$. We are looking for sweep functions W (t) that result in a required time dependence of the state populations. Before solving this inverse LZ problem analytically, we will illustrate numerically the possibility of time-symmetric solutions of Eq. (4) going from p(1) = 1 to p(1) = 0 for strongly nonlinear sweep functions W (t). The simplest of these cases is the cubic-parabola sweep with W (t) = $2.5t + 1.83t^2$ where we have set = h = 1 in Eq. (4). The time dependence of the probability $\dot{p}(t)\dot{j}^2$ shown in Fig. 1 can be tted by $\dot{p}\dot{j}^2(t) = [1 - \tanh(\sinh(t))]=2$ which is, however, not the analytical solution of Eq. (4).

To nd analytical solutions of the inverse LZ problem, one should rewrite Eq. (4) in terms of the probability m \dot{p}_{j}^{2} and some phase variable. We thus de ne

and substitute it in Eq. (4). Evidently the global phase of the system $('_p + '_q)=2$ is irrelevant and the resulting Schrödinger equation can be formulated in terms of m and the phase di erence $' = '_q$ $'_p$:

This system of equations can be brought into a more elegant form by introducing

Then Eqs. (6) can be put into the reduced form

The boundary condition for this equation is y(1) = -2 whereas the value of '(1) is irrelevant. In general, far from the resonance '() strongly oscillates with time and the derivative (9 y is not small. Below we will consider special kinds of solutions of Eq. (10) which are characterized by a smooth, non-oscillating dependence sin'() and (9 y(1) = 0. We will solve the inverse problem for Eq. (10) which consists in nding \overline{W} () resulting in a required function x(). One easily obtains from Eq. (10) a general form ula

The sign in front of \cos' determ ines the sign of the function \overline{W} (). Since $jc_1(1)^2 = 1$ and thus x(1) = 1 and y(1) = -2 one has tan y(1) = 1. To comply with the condition W(1) = -1 one has to choose, in general, the negative sign:

Before considering particular cases, we will comment on some general properties of the functions x() and $\overline{W}()$. If x() is an odd function of time then y() is also odd and (y()) is even, whereas $(2^{2}y())$ and tan y() are odd. Then from the rst of Eqs. (10) follows that $\sin'()$ is even. If the sign of \cos' does not change, which is the generic situation, $\cos'()$

is even. Then from Eq. (11) follows that \overline{W} () is odd. In a similar way one can show that if x () is even (the system returns into the initial state 1 after crossing the resonance) then \overline{W} () is even, too.

There is an important special case, how ever, which is realized if the derivative @ y at some point 0 attains its maximal value $\frac{19}{9}$ yj = 1 which follows from the rst of Eqs. (10). At this point cos' turns to zero and changes its sign to positive. The latter corresponds to the phase ' going from the interval =2 < ' < into the interval 0 < ' < =2. Note that $\frac{0}{2}y = 0$ at $=_0$ thus Eq. (12) does not diverge. If $_0 = 0$ then cos' () is an odd function: cos' < 0 for < 0 and cos' > 0 for > 0. As a result, the parity of \overline{W} () become sinverse to the parity of x(). If $_0 \notin 0$ then for a symmetric function x() the similar happens at $=_0$. That is, cos' () changes sign two times and is an even function, thus the parity of \overline{W} () coincides with that of x(). It should be noted that parity considerations for the direct LZ problem do not apply: Symmetric forms of \overline{W} () do not necessarily result in symmetric solutions x(). If, how ever, the solution x() satis esx(1) = 1 or x(1) = 1 and \overline{W} () is time symmetric, then x() is also symmetric. This follows from the time reversibility of the Schrodinger equation and the symmetry of the boundary values of x().

A nother in plication of this analysis is the existence of the maximal rate of the probability change. We have seen that j^0 yj 1, then from 0 = 1 + 1 + 2 = 1 + 2

One of possible solutions is of the form

For n odd it describes switching of the probability from $_1$ to $_2$, whereas for n even the system returns into the initial state. For n = 1 the form of Eq. (13) corresponds to Eq. (3) by taking into account Eq. (7) with $m = j_2 j_1 f_1$. However, the reader should note that Eq. (3) is realized with the very slow sweep \overline{W} () of an arbitrary functional form, whereas Eq. (13) is valid for a particular form of \overline{W} () which is not necessarily slow. One obtains from Eqs. (8) and (13)

whereas $\tan y = x = \frac{p}{1 - x^2} = (1)^n u^n$. The derivative @ y has a chance to attain the value 1 at its maximum that is determined by $@^2y = 0$, i.e., at

should be fullled. For $a < a_{max} Eq.$ (12) yields




Fig.2. { a { Energy sweep function \overline{W} () of Eq. (18) with n = 1 [profEq. (20)] for di erent values of the sweep rate a. b { The same with n = 5. c { The population of the exact excited level, j_r , j_r , for n = 1 and di erent values of a. d { The same for n = 5. D ashed lines in all graphs correspond to a = a_{max} and \overline{W} () without jumps [see, e.g., Eq. (21)].

This function is plotted for n = 1 and n = 5 and di erent values of the parameter a in Figs. 2a and 2b. For a ! $a_{m ax}$ discontinuities in Eq. (18) are formed at $u = u_{n ax}$. These discontinuities result from the invariably negative choice for \cos' . For $a = a_{m ax}$ the sign of \cos' can change at $u_{\overline{h}} u_{m ax}$ and then these discontinuities disappear. This form of \overline{W} () includes the factor sgn $1 + u^{2n}^{2}$ anu^{n 1²}, in addition to Eq. (18). Note that Eq. (18) cannot be extended into the region $a > a_{m ax}$ preserving \overline{W} () real, in contrast to Eq. (13). The sm all- and large-argument form s of \overline{W} () are

In the case n = 1, Eq. (18) simplifies to

O ne can see that for u 1 the function \overline{W} () describes a linear energy sweep with the velocity v = a. For u 1 the form of \overline{W} () is nonlinear and for $a < a_{max} = 1$ the resonance is crossed three times, including u = 0. For a = 1 Eq. (20) yields the even function

This sweep crosses the resonance two times, in the forward and backward directions, which means that the system is in the excited state $_2$ at the end of the sweep at t = 1. For a < 1 and far from the resonance Eq. (20) has the form

thus the corresponding linear sweep rate is $v = 2^a = h$. The maximal sweep rate that ensures the complete switching to $_2$ is realized at a = 1 is $v_{max} = 2^a = h$. For a comparison, in the regular LZ e ect with the probability to stay in the initial state given by Eq. (1) the sweep rate $v = 2^a$ (2h) is required for a complete switching. For $v = 2^a = h$ the probability to stay in the initial state is still P = 0.208.

Another solution that describes switching from state 1 to state 2 is

Here the sweep function determ ined from Eq. (12) reads

$$\overline{W}() = \frac{\sinh u}{1 \quad a^2 = \cosh^2 u} \quad 1 \quad \frac{2a^2}{\cosh^2 u} \quad : \tag{24}$$

In the range $l = \frac{p}{2} < a < 1$ the function \overline{W} () changes its sign three times and its derivative at = 0 is negative. W ith a ! 1 this derivative increases unlimitedly and a jump of \overline{W} () at = 0 is form ed. For a = $a_{max} = 1$ the solution with eliminated jump is an even function

This sweep function crosses the resonance two times. Again, Eq. (24) cannot be continued into the region a > 1.

Now we return to the solution for the probability x described by Eq. (13) and analyze its behavior for large n. It has a form of three plateaus x = 1 for $u^{<}$ 1, x = 0 for $1^{<} u^{<} 1$, and x = 1 for $1^{<} u$ with two narrow transition regions between them. In the central region $1^{<} u^{<} 1$ one has $j_2 f = j_1 f = (1 + x)=2 = 1=2$, i.e., the system is in the mixture of the states $_1$ and $_2$ with equal weights. The sweep function \overline{W} () of Eq. (18) is fast approaching the resonance at u = 1 and remaining in the close vicinity of the latter until u = 1. Since

the probabilities $jc_1 \hat{f} = jc_2 \hat{f} = 1=2$ do not oscillate in the range $1 \le u \le 1$ (unlike the case in which the system is instantaneously brought into resonance), one is lead to the conclusion that the system is in one of the exact quantum states or $_+$. It is naturally of interest to question in which of these exact states does the system come under the in uence of the energy sweep described by Eq. (18). We will see below that both variants can be realized. This opens a possibility to prepare the system in the ground or excited state in resonance by the appropriate choice of \overline{W} (). Indeed, for n 3 one has \overline{W} () = 0 y = 0^2 y = 0 at = 0; thus from Eq. (10) one can see that the sweep can be stopped at = 0 and the system will rem ain in this state. To demonstrate this behavior one should rewrite the wave function of the system = c_1 (t) $_1 + c_2$ (t) $_2$ determ ined above in the basis of the exact states

corresponding to the time-dependent \energy eigenvalues" of Eq. (2) as $= c_{+}(t) + (t) + c_{-}(t)$. The corresponding probabilities are given by

O ne can see that in resonance at t = 0 ($\overline{W} = x = 0$, $\cos s' = 1$) the situation depends on the sign of $\cos s'$. For sweep functions given by Eq. (18) with $a < a_{m ax}$ one has $\cos s' = 1$ and the system is in the ground state (jc (t) j = 1, jc_{+} (t) j = 0). For the special sweep functions with $a = a_{m ax}$ one has $\cos s' = 1$ and the system is in the excited state (jc (t) j = 0; jc_{+} (t) j = 1), the transition from the ground state (t) to the excited state $_{+}$ (t) occuring form 1 in the vicinity of $u = u_{m ax}$ of Eq. (15). These features are illustrated for the sweep functions of Eqs. (18) and (21) in Figs. 2c and 2d. Note that for n = 1 and $a = a_{m ax} = 1$ the sweep function of Eq. (21) returns to 1 at = 1 and the system ends up in the excited state $_{+} = 2$.

To conclude, we have solved the inverse Landau-Zener problem for a two-level system, i.e., we have established the form of the sweep function $W(t) = "_1(t) "_2(t)$ needed to insure a given probability $\dot{p}_1(t) \dot{f}$ to be in the state 1 at time t. We have discussed two examples for which the system performs a complete transition from 1 to 2. In contrast to the direct LZ problem with a linear sweep, this can be accomplished by a nite sweeping rate. Further we have found such sweep functions that prepare the system in its exact ground state or in its exact excited state at resonance. It is not di cult to nd W (t) that prepare the system in an arbitrary mixture of the exact states at resonance, which can be potentially used in quantum computing based on tunneling units.
