Fractal P late Tectonics

A bstract. We analyze in details the statistical significance of the claim by Bird [2002] of a power law distribution of plate areas covering the Earth and con m that the power law with exponent 0.25 0.05 is the most robust and parsimonious model for all plates, including the very largest plates, when taking into account the constraint that the plates areas must sum up to 4 steradians. We propose a general class of fragm entation models that rationalize this observation and discuss the im plications for the earth dynamics and the general selforganization of tectonic deform ations at multiple scales.

Introduction

According to the theory of plate tectonics, the outerm ost 100 km of the solid Earth is composed of a relatively sm all number of internally rigid plates (lithosphere) that move over a weak substrate (asthenosphere). The plate sizes and positions change over time and are driven by the internal mantle convection. DeM ets et al. [1990] perform ed a global inversion to determ ine the relative rotation rates of the 12 largest plates (the NUVEL-1 model) later re ned into the NUVEL-1A solution [DeM ets et al., 1994]. The edges of these plates, where they move against each other, are sites of intense geologic activity, such as earthquakes, volcanoes, and mountain building. These plate edges are not sharp narrow boundaries but are often constituted of com plex system s of com peting faults and other geological structures of width extending over several hundreds of kilom eters for transform and subduction boundaries and up to thousands kilom eters for continental collisions. It is now common lore to view such tectonic deformation as possessing som e kind of self-sim ilarity or fractal properties [Scholz and M andelbrot, 1989], or better a hierarchical structure [Ouillon et al., 1996]. In addition, several researchers have repeatedly proposed to describe this multi-scale organization of faulting by a hierarchy of blocks of multiple sizes [Gelfand et al., 1976; Gorshkov et al., 2001]. In these models, blocks slide against each

other, rotate, lock at nodes or triple junctions which m ay represent the loci of m a jor earthquakes, in a way sim ilar to (but at a reduced scale com pared to) the relative m otion of the m a jor tectonic plates. An exam ple of a com plex network of faults is observed in the broad San Andreas transform boundary between the Paci c and the N orth Am erican plates in C alifornia, for which B ird and R osenstock [1984] have suggested 21 possible m icroplates within southern C alifornia alone.

K eeping in mind these ingredients of a few major plates at large scales on one hand and a hierarchical self-sim ilar organization of blocks at the boundary scale on the other hand, the recent reassessment of present plate boundaries on the Earth by Bird [2002] is particularly inspiring: taking into account relative plate velocities from magnetic anomalies, moment tensor solutions, and/or geodesy, to the 14 large plates whose motion was described by the NUVEL-IA poles, model PB2001 [Bird, 2002] includes 28 additionalsm allplates, for a total of 42 plates. Bird [2002] suggests that the cum ulative-num ber/area distribution for his model follows a power-law for plates of less than 1 steradian of area.

Statistical analysis of the size distribution of the 42 plates

A nalysis with rank-order statistics and the Pareto law

The statistical analysis of such a data set is very difcult due to its sm all size N = 42 but is not in possible. Figure 1 shows the complementary cumulative number N (A) of plates as a function of area A in steradians, i.e., the number of plates with an area equal to or larger than A. Most of the data except for a few largest plates follow a linear dependence in the double log-scale of the gure. The slope of this straight line is close to 0.25. We rst compare this sample with a pure power law (the Pareto distribution). For this purpose we use the rank-ordering m ethod (see [Somette et al., 1996]). We put the sample into descending order $A_1 = A_2 = \dots = A_N$. The probability density function (PDF) of the n-th rank, denoted $n_{\rm N}$ (x), is well-known

where F(x); f(x) are the distribution function (DF) and PDF of the random values in question. Putting the Pareto law F(x) = 1 (a=x), x a, into (1), we get

The mode M $_{n,N}$ of the PDF (2) (i.e., the maximum of the PDF) is the most probable value of the random variable A $_n$:

Besides, an interval around the mode containing some prescribed probability (say, 90%) can be derived from the density $_{n,N}$ (x). The dependence (3) with = 1=4 is shown as the long-dashed line in Fig. 1. The two short-dashed lines represent the upper/lower lim its of the 90% -con dence interval. The data are well accounted for by the power law, except, perhaps, for the three smallest ranks, i.e. the three largest plates, the P aci c, the Antarctica, and the A frica plates, which fall outside the con dence interval.

\F in ite-size" constraint on the PDF of plate sizes

From a visual inspection of gure 1, it m ight be arqued that the deviation from the power law prediction (3) occurs som ew hat earlier, say, at rank n = 7, i.e., the seven largest plates with area m ore than 1 steradian belong to a di erent population than the rest of the plates. The simplest possibility is that the largest plates are sensitive to a \ nite-size" e ect, namely that the sum of areas over all plates must sum up to 4 . The largest continent and ocean plates are commensurable with the size of the convection cells in the upperm antle and they would thus feel the constraints due to the nite size of the Earth surface. In contrast, one could argue that the smaller plates appeared as a result of the interaction and collision between the larger plates and do not feel any super cial restriction. More precisely, the smaller plates m ay be the result of fragm entation/creation processes in the neighborhood of the borders and especially near triple points of the seven largest plates.

The distribution $g_{N,c}(x)$ of sample values x_1 ; ..., x_N conditioned by the constraint

where C is a constant (4 for the plates) is modied from its unconditional Pareto density expression $f(x) = a = x^{1+}$ for x a and f(x) = 0 for x < a. The lower threshold (the minimum value) for the plate data is a = 0.00178 steradian and corresponds to the sm allest documented plate in [Bird, 2002]. Denoting the unconditional density of the sum $S_k = x_1 + \dots + x_k; k = N$ 1;N by $s_k(x)$, we have $g_{N, C}(x) = s_{N-1}$ (C x) $f(x) = s_N$ (C), for a x C.

Thus, the constraint (4) decreases the unconditional Pareto density f(x) by a factor s_{N-1} (C x)= s_{N} (C) which acts as a \taper."

In order to use the M axim um Likelihood (M L) m ethod for the estimation of the exponent , we need the vectorial distribution of conditional sample to take into account the interdependence between the di erent variables (areas of the plates) x_1 ; \dots ; x_{42} induced by the constraint (4). The corresponding likelihood function is therefore

The resulting M L estimate is = 0.25 0.05. W ith this value, we generate an arti cial sam ple of 1045 conditional 42-dim ensional (42D) vectors with the condition (4) with C = 4 . Rank-ordering each of these 1045 vectors, we determ ine their sample medians M_1 ; :::; M_{42} , where M_j is the median of the j-th rank. These conditionalm edians are slightly sm aller than given by (3) for the unconditional Pareto distribution. The conditional distribution (5) allow sus to construct a con dence domain for the 42D random vectors, de ned as a \corridor" of the form $[M_{i}; (1=c)M_{i}]$, the constant c = 0.244being chosen such that 95% of vectors fall within this corridor. The medians M 1; :::; M 42 and their corridor are shown in Fig. 2: all samples of the tectonic plates falls within the 95% con dence corridor, showing that (in contrast with the \pure" Pareto used in Fig.1) the Pareto model together with the total area constraint (4) accounts satisfactorily for all the data, including the largest plates.

We have perform ed m any other tests which all conmute for the goodness of t of the constrained P areto distribution (or of its approximation by the truncated P areto distribution). Using W ilks' theorem [Rao, 1965], we used the so-called G amma-distribution with complementary cumulative distribution function G (x), truncated from both sides G (x ja; b) = C (a; b) $\frac{e^{ax}}{x^{1+b}}$ for u_0 x u_1 and nd that (1) the introduction of the additional parameter a in the exponential does not increase signi cantly (probability of rejection 38%) the likelihood as compared with the truncated P areto and (2) the truncated P areto distribution is much preferable compared with the truncated exponential distribution (signi cance 1 10^8). This conclusion is strongly con-

m ed by tests using so-called su cient statistics for both the power law and exponential models. W e also tested the popular lognorm al DF, which is a natural model for fragm entation since it is the lim it distribution for processes of subdivision of rock under rather general assumptions (basically multiplicative processes) [K olm ogorov, 1941]. U sing the K olm ogorov test and the bookstrap m ethod, we estimate that the data deviates signi cantly from the lognorm all F at the 95% signi cance level.

D iscussion

Our main result is that B ind's suggestion [2002] of a power-like distribution of plates areas is con med up to the largest plates, when taking into account the very natural constraint that the plates areas must sum up to 4 steradians.

G iven this strength of the validity of the Pareto distribution for the 42 plates docum ented in Bird, 2002], one can expect that it can be extrapolated beyond this range to sm aller yet undetected plates. U sing the com plem entary Pareto distribution (a=x) with a = 0.00178steradian and = 0.25, this extrapolation predicts 100 plates larger than 1:35 10⁴ steradian (5;500km² or 74 km) [Bird, 2002]. The total area needed to 74 de ne another 58 plates ranging from this size up to the sm allest size in PB2001 would be only about 0:028 steradians, which could be taken from large plates like EU and NA without materially a ecting their areas. As discussed by Bird [2002], the places where additional sm all plates are most likely to be recognized is within the zones of distributed deform ation identi ed in Bird, 2002], which have total area of 0:838 steradians (6.7% of Earth).

The main suggestion inspired by Bird's discovery is that the separation of scales between a plate tectonics involving a few major plates at large scales and tectonic deformation at smaller scales may be an artifact that resulted historically from insu cient statistics and m ore recently from a not quite correct interpretation of \visual" deviations from the pure power law. With the improved extended compilation of [Bird, 2002] which will probably still improve in the years to come, we conjecture that there is a hierarchy of plates and block sizes from the largest ones to the smallest scales, which m ay be the result of the self-organization of the plate m otions, creation and destruction overm illions of years. In other words, we suggest that our view of plate tectonics should be revised in term s of a dynam icalm odel of plates with creation, fragm entation and destruction that may occur at all scales. This view may provide a link between the large organization of major plates down to the block structures at scales oftens of kilom eters or less discussed in the introduction.

W hat could be the mechanism (s) at the origin of the observed power law distribution of plate areas? We pro-

pose a fragm entation model with source terms, which can be progressively enriched by taking into account the kinem atic com patibility constraints between plates. There is a large class of such fragmentation models that can be solved explicitely within the scaling theory of [Cheng and Redner, 1988]. In a nutshell, their approach is to write down a linear integro-di erential coupled equation for the time evolution of fragment populations. The fragment distribution p(1) is characterized by the moments $m = \frac{N_1}{0} l p(l) dl$. Note that calculating a moment corresponds to taking the Mellin transform of p(l). The moments m give access to p(l) by taken the inverse M ellin transform. The equations of evolution for the fragm ent population then transform into the following recurrence equation for the moments: $m + = ! \frac{1}{L - 1} m$, where is the exponent describing the overall rate of breakup (assumed to be proportional to 1), ! is a norm alizing constant and $L = \int_{0}^{R_{1}} x b(x) dx, \text{ where } b(x) \text{ is the probability that}$ the fragment ratio be x. From the factor $\frac{1}{L-1}$, if there is a value such that L = 1, then all m om ents with will become in nite. Provided reasonable an->

alyticity conditions hold, it follows that the value is a pole of m . Taking the inverse M ellin transform of m then allows us to get p(1) and, using the existence of the pole at , this immediately predict that l $^{(1+}$ $^{+}$ $^{)}$ is a power law distribution. This p(1) model was used by Ouillon et al. [1996] to account for the power law distribution of pint spacing in a granitic m assif in Saudi A rabia, with exponent $_{s} = 1=2$. Note that block sizes are proportional to spacing taken to the second power, which then predicts = s=2=1=4, which is in agreement with our best estimate = 0.25for the plate area distribution. This agreem ent between two very di erent system sm ay be fortuitous but is worth keeping in m ind, especially in view of our claim of a continuity of the physics of fragmention from the large plates to the blocks. W e note also that the fragm entation m odel of [C heng and Redner, 1988] predicts generically log-periodic corrections to the main power law since, for a large variety of b(x), there are solutions of L = 1 with complex exponents . This has been shown to signal the existence of discrete scale invariance [Ouillon et al. 1996]. It is tempting to interpret in this way the three approxim ately regular oscillations observed in gure 1, with a prefered scaling ratio approximately equal to 10. This value is in good agreem ent with the square of the prefered scaling ratio 3:5 found in the discrete hierarchy of linear sizes in fracture of rocks by Sadovskiy et al. [1984].

Our present conclusion on a universal fractal char-

acter of plate fragm entation does not prevent the existence of som e underlying distinctions. For instance, P. B ird (private communication and [Bird,2001]) proposes three main tectonic origins for plates: plum e-assisted rifting for the larger plates (ranks 1-8 in Figs. 1 and 2), continental collision stress for the interm ediate plate sizes (ranks 8-20), and back-arc spreading for the sm allest plates (ranks 21-42). In Figs. 1 and 2, one can discem slightly di erent patterns of the tail behavior of these three subgroups. However, any form al statistical analysis of these possible distinctions would be, to our opinion, excessive due to the extrem e sm allness of the data set.




