Phase Diagram of the Super uid Phases of ³He in 98% A erogel

The phase diagram of the super uid phases of ³He in 98% aerogel was determined in the range of pressure from 15 to 33 bars and for elds up to 3 kG using high-frequency sound. The super uid transition in aerogel at 33.4 bars is eld independent from 0 to 5 kG and shows no evidence of an A1 A2 splitting. The rst-order transition between the A and B-phases is suppressed by a magnetic eld, and exhibits strong supercooling at high pressures. We show that the equilibrium phase in zero applied eld is the B-phase with at most a region of A-phase < 20 K just below T $_{\rm c}$ at a pressure of 33.4 bars. This is in contrast to pure ³He which has a large stable region of A -phase and a polycritical point. The quadratic coe cient for magnetic eld suppression of the AB-transition, g_a (), was obtained. The pressure dependence of g_a () is markedly di erent from that for the pure super uid, g_0 (), which diverges at a polycritical pressure of 21 bars. We compare our results with calculations from the hom ogeneous scattering m odel for ga (), de ned in a G inzburg-Landau theory in terms of strong-coupling parameters . We nd qualitatively good agreement with the experiment if the strong-coupling corrections are rescaled from known values of the 's for pure ${}^{3}He$, reduced by the suppression of the super uid transition temperature. The calculations indicate that the polycritical pressure in the aerogel system is displaced well above the melting pressure and out of experim ental reach. We cannot account for the puzzling supercooling of the aerogel AB-transition in zero applied eld within the fram ework of known nucleation scenarios.

I. IN TRODUCTION

Q uenched disorder in condensed matter systems is manifest in a wide variety of materials from glassy solids and liquid crystals to them ixed state of superconductors. It arises in diverse phenom ena ranging from cosm ological models for the evolution of the universe to vortex tangles in super uid ⁴He. D isorder in super uid ³He is of special interest since the order parameter structure of this super uid is non-trivial, although well known, and its various phases exhibit a number of spontaneously broken symmetries. Q uenched disorder in a super uid can be generated extrinsically by a random impurity eld with inhom ogeneity on a length scale short compared to the coherence length. In the present case this is achieved by im bibing ³He into silica aerogel, a highly-porous material m ade of random ly inter-connected strands of SiD₂.

A erogels have been used to study liquid crystals¹, super uid ${}^{4}\text{He}^{2}$, ${}^{3}\text{He}^{4}\text{He}$ m ixtures³ and super uid ${}^{3}\text{He}^{4;5}$. G lassy e ects have been observed in the liquid crystalaerogel system s. In ${}^{3}\text{He}^{4}\text{He}$ m ixtures a profound inuence of aerogel on the phase diagram ³ was reported. Super uid ${}^{3}\text{He}$ in aerogel was found to have a suppressed, but relatively sharp, transition temperature and the order parameter appears to be reduced^{4;5}. How ever, the nature of the phase diagram , and identication of the therm odynam ically stable phases, have not yet been clearly established. Here we report the use of high resolution transverse acoustic in pedance to m ap out this phase diagram .

The ${}^{3}\text{He-A}$ and -B super uid phases were discovered in 1972 by Oshero, Richardson and Lee⁶. The or-

der parameter is now established to be a p-wave spintriplet which has two therm odynam ically stable superuid phases in zero eld. The A-phase is the axial state which separately breaks spin and orbit rotational symmetries. The B-phase is the isotropic state which breaks relative spin-orbit symmetry. The stability of the A-phase over the B-phase at elevated pressure, above the polycritical pressure of 21 bars in zero eld, is a consequence of strong coupling in the quasiparticle interactions. A fler 30 years of extensive experim ental and theoretical investigation ³H e is the best understood of all unconventional super uids or superconductors. M otivation to investigate disorder in this super uid derives in part from our need to understand impurity e ects in this, and in sim ilar, unconventionally paired systems. New families of superconducting materials such as $Sr_2RuO_4^7$, URhGe⁸, and organic conductors⁹ may be unconventional superconductors, and in some cases, a p-wave structure has been suggested.

At m illikelvin temperatures ${}^{3}\text{He}$ is the purest material in nature. Its properties have been investigated extensively as a system entirely free of impurity scattering other than at surfaces. The in uence of aerogelon ${}^{3}\text{He}$ is to suppress the transition retaining a narrow width and to alter the behavior of the super uid phases. In contrast, for surface scattering, the orientation and the am – plitude of the order parameter are both constrained and the super uid becomes spatially inhom ogeneous. The use of highly-porous aerogels to introduce in purity scattering in ${}^{3}\text{He}$ has provided a signi cant opportunity to learn about unconventional pairing states. The rst observations of super uidity were torsional oscillator ex-

periments to measure the super uid density performed at Cornell⁴ and Nuclear M agnetic Resonance (NMR) at Northwestem^{5;10}. These results were found to be consistent with theoreticalm odels for impurity scattering¹¹. In its simplest form, the Homogeneous Scattering M odel (HSM), the suppression of the super uid transition is given by the well-known A brikosov-G orkov formula

where $T_{\rm ca}\left(T_{\rm c0}\right)$ is the super uid transition temperature of the aerogel (bulk) system, $_0$ $hv_{\rm f}\!=\!2~k_{\rm B}~T_{\rm c0}$ is the bulk coherence length, and $l_{\rm tr}$ is the transport mean free path. These earlier results triggered numerous experim ental investigations $^{12}\{^{17}\right.$ and theoretical work $^{11,18}\{^{25}$ aim ed at characterizing and understanding the properties of the dirty' super uid form ed inside the aerogelm atrix. How ever, the identic cation of the super uid state in the $^3{\rm H}\,e$ -aerogel system has been controversial, and only recently has there been agreem ent as to which are the super uid phases observed.

The rst NMR measurement in pure ³He and 12 kG suggested a super uid in an equal-spin pairing (ESP) state⁵ sim ilar to the bulk A -phase. W ith ⁴He additions a non-ESP state was found¹⁰ like the bulk B-phase. NMR m easurem ents at lower elds (50 G) without ⁴H e found evidence for a B-phase super uid in aerogel¹² and Barker et al.¹⁵ found a transition between a ESP and a non-ESP state at 284 G with ⁴He coverage. This transition was found to supercool quite readily and was identied to take place between A and B super uids, but it should be kept in m ind that the orbital symmetry of the order param eter in aerogel has not yet been determ ined. The aerogeLAB -transition was also observed recently by a vibrating viscom eter at low pressures²⁶, and was studied near the bulk polycritical pressure (PCP) using highfrequency sound²⁷. The reason for covering the strands with some ⁴He (2 or more atom ic layers) is to replace m agnetic solid ³He that contributes to m easurem ent of the ³H e m agnetization and m ay also a ect the nature of the scattering and possibly properties of the dirty superuid. In the present work, we present a comprehensive acoustics study of the phase diagram of the A and Bsuper uid phases of ³He in a 98% aerogel without ⁴He and from 0 to 3 kG.

II. EXPERIM ENTAL

High-frequency sound (MHz) has proven to be a powerful tool to study the properties of pure ${}^{3}\text{He}$ in the normal Fermi liquid and in the super uid state. For example, Landau's seminal prediction of collisionless sound, called zero-sound, in a Fermi liquid was experimentally veried with high-frequency sound attenuation measurements²⁸. High-frequency sound also couples strongly to the order parameter collective modes (OPCM) of the super uid and num erous OPCM have been observed in both the A and B-phases of pure ${}^{3}\text{He}$ (see²⁹ for a review). Transverse sound was predicted to exist in norm al ${}^{3}\text{He}$ by Landau, and was shown to propagate in ${}^{3}\text{He-B}$ from the observation of an acoustic Faraday e ect³⁰. In what follows, we describe a technique used to probe the phase diagram of ${}^{3}\text{He}$ in aerogelusing both transverse and longitudinal high-frequency sound waves.




FIG.1. Schem atics of the acoustic cavity. The X -cut (longitudinal sound) and AC-cut (transverse sound) transducers are separated by 270 m spacers and the 98% porous aerogel was grown in situ. Each transducer has two active sides; one probes the aerogel- lled cavity while the other probes the bulk liquid outside the cavity.

The acoustic technique is similar to that reported previously^{31;32} and a schematic of our acoustic cavity is depicted in Fig.1. The cavity was form ed with two quartz transducers separated by two parallel stain less steel wires of diam eter $d = 270 \text{ m}^{33}$. O ne transducer was AC-cut for transverse sound, and the other X -cut for longitudinal sound, with a diam eter of 9.5 mm. Their fundam ental frequencies were 4.8 M H z and 2.9 M H z, respectively. This arrangement allowed us to perform experim ents with either transverse or longitudinal sound. The aerogel was grown in situ, in the volume between the transducers. Each transducer has two active sides; one probes the aerogel-lled cavity, and the other the bulk liguid outside the cavity. All experiments were performed with pure ³He which was veried to contain less than 250 ppm of⁴He, much less than the am ount required to cover the aerogel strands with one atom ic layer of ${}^{4}\text{He}$.




FIG.2. Left: transverse acoustic response at 25 bars and zero applied ekl (upper panel) and 2.57 kG (lower panel). In each panel, the data in the upper (lower) trace is taken on cooling (warm ing). The tem perature scale is for warm ing only; for cooling the traces were o set for clarity. The various transitions in the bulk and aerogel super uids are indicated by arrows. The inset is an enlarged view of the bulk super uid transition T_{c0} in zero ekl (upper), and 2.57 kG (lower) which shows the bulk A_1 and A_2 transitions. R ight: an enlarged view of the aerogel AB-transition on warm ing is shown at 25 bars and 2.57 kG for the acoustic response of transverse sound at 8.691 M H z in the upper panel and longitudinal sound at 14.635 M H z in the lower panel.

The electrical impedance of the transducers was measured using a continuous wave spectrom eter. The measurements were performed at a xed frequency corresponding to odd harmonics of the fundamental resonance, with a frequency modulation of 400 H z and m odulation amplitude of 3 kHz. In the case of longitudinal sound, the medium inside the cavity is of su ciently low attenuation that a standing wave pattern is established throughout the cavity. Sm all changes in the attenuation and velocity, induced by changes in temperature or pressure, produced changes in the electrical in pedance of the transducers that can be detected by the spectrom eter^{31;33}. For transverse sound, the highly attenuating medium prohibits the existence of well-de ned standing waves and the measurem ent is similar to that of an accustic in pedance measurem ent 32 . It is not possible

with this technique to separate individual contributions from attenuation, sound velocity, or coupling to collectives modes in the transverse acoustic impedance. How – ever, we have found that, at low frequencies ($^{<}$ 10 M Hz), the transverse sound impedance changes abruptly at all of the known phase transitions in each of the bulk and aerogel super uids, Fig 2.

The transverse acoustic response at 8.691 M H z and a pressure of 25 bars is shown in the left panels of Fig 2on cooling (upper trace) and warming (lower trace) and at zero (upper panel) and 2.57 kG applied m agnetic eld (lower panel). The phase transitions in the bulk liquid and the aerogel are denoted by arrow s. On cooling, and in zero applied eld, we successively observed the bulk super uid (T_{c0}), bulk AB (T_{AB0}), aerogel super uid (T_{ca}) and aerogel AB (T_{ABa}) transitions. The therm on etry scales for cooling and warm ing are di erent. The scale shown in the gure is for slow warm ing such that equilibrium is assured between the LCMN therm om eter used in low eld, the melting curve therm om eter, and the aerogel sam ple. For the results in Fig.2 and Fig.4, we corrected the therm on etry for the m ore rapid cooling experin ents using the tem perature dependence of the acoustic impedance established in equilibrium during warm ing. This provides a convenient and intrinsic secondary therm om eter, but for clarity the cooling traces are o -

set. W hen a magnetic eld is applied, we also observed the bulk $A_1 = A_2$ splitting as a knee' in the acoustic response, as shown in the inset of the lower left panel. The bulk A_1 and A_2 -transitions are completely resolved in the acoustic trace at a eld of 5 kG and above.

In the right panels of Fig.2 we show a direct com parison of the signatures from transverse and longitudinal sound for the aerogel AB-transition observed on warm ing at 25 bars and 2.57 kG.A sm all jump in the acoustic trace of longitudinal sound, coincident in temperature with that of transverse sound, was observed when the AB-transition occured at temperatures su ciently well. below T_{ca} . The condition for observing the signature in longitudinal sound was that the transition be either supercooled or that it appear on warming in a eld B >2 kG . How ever, we cannot determ ine whether this jum p in the longitudinal sound trace arises from a change in attenuation due to collective modes, or from quasiparticle excitations. The observation of the aerogel ABtransition in longitudinal sound ensures that the transition observed with transverse sound is not a local effect occurring near the surface of the transducer. We have shown previously^{31,33} that a well-de ned longitudinal sound mode can be established in our acoustic cavity, and therefore the AB-transition observed with this mode re ects the behavior of the super uid over the entire aerogelsam ple. W e have also veri ed that the change of slope in the transverse acoustic trace labeled T_{ca} corresponds to the tem perature at which the attenuation of longitudinal sound decreases at the onset of the superuid transition³¹. However, the wider range of observability of the aerogel AB-transition by transverse sound, as compared with longitudinal sound, and its higher precision make it a better tool to map out the phase diagram of ³He in 98% aerogel. The frequency dependence of the bulk super uid transition T_{c0} , as observed with transverse sound, was also system atically studied at a pressure of 17 bars and for frequencies ranging from 3 MHz to 55 MHz. We found that the transverse acoustic signature signaling T_{c0} is weakly frequency dependent but that it recovers the transition tem perature T_{c0} in the low-frequency lim it, < 10 M Hz. The transition tem peratures observed in our sample are in excellent agreem ent with those reported elsew here^{5;15;34} for the sam e density of aerogel. In what follows, the (P,T,B) phase diagram of ³He in aerogel was determ ined using transverse sound at a frequency of 8.691 M Hz.

III. RESULTS AND DISCUSSION

A.P-T-B dependence of the AB-transition in aerogel

O ne of the key issues in the study of super uid ³He in aerogel is to determ ine in what way the super uid phase diagram is modied by impurity scattering. Unlike swave superconductors for which only magnetic impurity scattering is pair breaking, p-w ave C ooper pairs are sensitive to all form s of scattering. For super uid ³He in aerogel, there is now general agreem ent that in purity scattering suppresses the super uid transition tem perature and the amplitude of the order parameter, and that a non-ESP phase sim ilar to the bulk B-phase is favored near zero eld. However, most experiments have been perform ed in di erent regions of P, T, and B and also under di erent experim ental conditions, e.g. with or without ⁴He preplating on the aerogel strands and with dierent aerogeldensities. In particular, the phase diagram of the pure super uid phases of pure ³H e in 98% aerogelhas not been established; the zero-eld phase diagram is largely unknown. W e em phasize that only the spin structure of the pairing state of ³He in aerogel has been identied through NMR m easurem ent of the magnetization $^{10;15}$ or the stability of the transition in a magnetic $eld^{26;27}$. In the latter case, assuming triplet pairing, we can infer the spin component of the order parameter (ESP or non-ESP) from the eld dependence of the phase boundaries. The orbital symmetry is more elusive. For example, it would be helpful to investigate the OPCM which couple to orbital degrees of freedom of the order param eter, but they have not yet been observed³¹. Nonetheless, we use the earlier notation $^{15;26;27}$ A' and B' for the aerogel super uid phases corresponding to ESP and non-ESP states, by analogy with the bulk, and we discuss later implications from our measurements for the orbital symmetry of the aerogel super uid.




FIG.3. Phase diagram s of the super uid phases in aerogel at various pressures in a magnetic eld. The triangles are the super uid transition temperature, $T_{\rm ca}$, determ ined from transverse acoustics. The supercooled aerogel AB-transitions, $T_{\rm AB\,a}$, are shown on cooling (empty circles) and in equilibrium on warm ing (lled circles). The data are plotted as function of B 2 to illustrate the quadratic suppression of the AB-transition at low eld. The dashed lines show the average value of $T_{\rm ca}$ and the dotted lines are an extrapolation of $T_{\rm AB\,a}$ to zero eld. Note that the eld axis is di erent for the left and right panels.

The phase diagram s of the aerogel AB -transition as a function of B² and for various pressures are shown in Fig.3. The triangles denote the super uid transitions, T_{ca}, as determined by the change of slope in the transverse acoustic trace, the lled circles are the equilibrium AB -transitions taken on slow warming, and the empty circles are the supercooled AB -transitions. The long-dashed lines show the average values of T_{ca} and the dotted lines are extrapolations to zero eld. With our technique, we were unable to observe directly the aerogelAB - transitions on warming at elds below 1.4 kG, i.e. for T_{AB a}=T_{ca} > 0.9. An independent check on the validity of our extrapolation to zero eld will be discussed below.

The magnetic eld independent transition from normal to super uid state, and eld-dependent transitions from A to B-super uids strongly suggest that these are transition between norm al uid to ESP super uid states, and between ESP and non-ESP states, as in the bulk. The strong supercooling of the AB-transition, even in zero applied eld, shows that the transition is rst-order. How ever, there are key di erences in the aerogel phase diagram as compared to the bulk. In particular, the zeroeld equilibrium region of aerogel A-phase is extrem ely narrow, ≤ 20 K at 33.4 bars, if it exists at all.

In order to locate the AB-phase boundary at 33.4 bars in zero applied eld, we have performed a series of tem – perature sweeps in which the temperature was slowly raised from low-temperature (0.6 m K) to a temperature in the vicinity, but slightly less than, T_{ca} , and then rapidly cooled. If the AB-phase boundary were reached on warming, the supercooled AB-transition would be observed on cooling, whereas in the opposite case the aerogel super uid would remain in the B-phase with no evidence for an AB-transition. This procedure depends on the absence of what is called a memory e ect for secondary nucleation which we veried indpendently in modest magnetic $elds^{35}$.




FIG.4. Lower panel: transverse acoustic response at 33.4 bars and zero applied eld during slow warm ing in the vicinity of T_{ca} and subsequent rapid cooling. The traces labeled 1 to 4 correspond to severalm axim um temperatures reached prior to rapid cooling. The corresponding cooling traces are shown in the upper panel as a function of time and the bulk and aerogel AB transitions are denoted by arrow s. For traces 1 and 2 the aerogel AB transition was not crossed on warm ing and for traces 3 and 4 it was. The trace labeled 5 shows the aerogel AB transition but for a cooling experiment originating from the norm al state. In the lower panel, the vertical solid line is T_{ca} as determined from the change in slope of the acoustic response on warming, and the dotted line is a lower bound on the tem perature for the aerogel AB -phase boundary, 20 K below T_{ca} .

Fig.4 shows these various traces upon warming to a temperature in the vicinity of T_{ca} (lower panel and traces labeled 1 to 4, vertically o set for clarity), and then rapidly cooled. The thermal disequilibrium during sudden cooling is su cient to m ake the cooling traces appear to m ove up in this gure. The lowest trace shows the complete acoustic record with T_{ca} indicated by a change of slope and m arked by a solid vertical line.

In the upper panel, we show the same acoustic traces for rapid cooling (1 to 4) as a function of time while the trace labeled 5 is for a cooling experiment originating from the normal state. We do not observe the aerogel AB-transition upon cooling in the trace 1 and 2 (and also for any partial warm up to tem peratures below those show n here), while in the traces 3 and 4 the aerogelAB-transition is observed on cooling. This shows that the equilibrium aerogelAB-transition lies at a temperature som ewhere between the traces 2 and 3, which is indicated in the lower panel of Fig.4 by a dotted line. This is close to T_{ca} ($^{<}20$ K) and is approximately the width of T_{ca} itself (30 K), su ciently close that we cannot say that the normal state of the ³He uid in aerogel had not been reached som ewhere in the sample. Consequently, we have inferred that the region of A-phase in aerogel in zero applied eld is extrem ely narrow, $^{<}20$ K at a pressure of 33.4 bars. We have also veri ed at a pressure of 20 bars that the AB-phase boundary in zero applied eld is indistinguishable from T_{ca} using the sam e slow warm ing and quench-cooling m ethod.




FIG.5. Three-dimensionalphase diagram (P,T,B) of the A and B super uid phases of ³He in 98% aerogel. The aerogel phases are labeled A ' and B' and are delineated by solid lines while for the pure phases they are labeled A and B and show n w ith dotted lines. The shaded area show s the volum e spanned by the equilibrium A -phase in aerogel. The open circles are data from the present work, and the lines connecting them are ts to the data. At pressures below 10 bars, T_{ca} , was taken from M atsum oto et al.³⁴, together with the eld dependence of the AB-transition observed by the Lancaster group at 4.8 bars²⁶.

From the data of Fig.3 we construct a threedimensionalphase diagram for pressure, temperature and magnetic eld for the super uid phases of pure ³He in 98% aerogel, Fig.5. The relative stability of the superuid phases of the pure and dirty super uids can be directly visualized and compared. The data of the equilibrium AB-transition from Fig.3 are shown as empty circles, and the thick solid lines are a smoothed t of T_{ABa} and T_{ca} . Below 10 bars, the data from M atsum oto et al.³⁴ were used to describe T_{ca} . They found a critical pressure of 6 bars in the zero-tem perature lim it. The thick solid curve at a pressure of 4.8 bars was taken from the

eld dependence of the aerogel AB-transition m easured by the Lancaster group with a vibrating viscom eter²⁶, but with its super uid transition adjusted to m atch that of M atsum oto et al.³⁴. Above 10 bars our data for T_{ca} in zero eld are sin ilar from that of M atsum oto et al.³⁴ and the data points are not shown for reasons of clarity. The aerogel phases are denoted by A' and B' while the pure phases are denoted by A and B. The shaded volum e em phasizes the aerogel A-phase opening up with applied m agnetic eld, and the dotted lines are the pure phase diagram shown here for com parison³⁶. The eld dependence of the aerogel super uid transitions T_{ca} plotted as a solid line at 33.4 bars will be discussed later.

The three-dimensional plot of the (P,T,B) phase diagram of³He in 98% aerogelshows the elects of impurity scattering on the equilibrium A-phase. The equilibrium region of A-phase is destabilized by impurity scattering in zero eld; how ever, we believe that there is a very thin sliver of equilibrium A-phase that gives rise to supercooling of the A-phase observed in zero applied eld²⁷ at pressures above 15 bars. Barker et al.¹⁵ observed a metastable aerogel AB-transition on cooling using an NMR technique at 284 G and with ⁴He preplating. At 32 bars, an equilibrium region of A-phase of 70 K was inferred from the data. This is som ewhat larger than our results at the same eld. The magnetization discontinuity at the AB-transition known to occur in the bulk system was not observed in aerogel, making it di cult to locate the equilibrium AB-transition. Furtherm ore, given the scatter of the data¹⁵ and the therm om etry resolution 20 K, it seems plausible that the A-phase region might have been smaller than 70 K and consistent with our ndings here.

${\tt B}$. M agnetic suppression of the A B -transition and the H om ogeneous Scattering M odel

The G inzburg-Landau (G L) theory for super uid ³He describes the free energy near the transition temperature expanded in powers of the order parameter. W ith this approach the relative stability of various possible p-wave states can be explored in terms of the expansion coe cients of the theory ³⁷. An extension to the dirty super uid has been developed¹¹ using a model that describes elastic quasiparticle scattering. There are ve possible fourth order com binations of the order parameter that are invariant under all the symmetries of the p-wave super uid. These fourth-order terms are characterized by the coe cients, (1; 2; 3; 4; 5), which in the G L-theory are determined by thermodynamic quantities such as heat capacity, the magnetization, the phase diagram and the NMR frequency shift. In principle one

could uniquely determ ine the $_i$'s (thus the free energy functional) if ve independent therm odynam ic m easurements were performed; the fact that in bulk super uid 3 H e there are only four such measurements is unfortunate. Nonetheless, combinations of the $_i$'s can be extracted from experiment and are very helpful in the understanding the magnetic suppression of the B-phase of 3 H e in aerogel.

In the pure super uid the G L-theory can be used to describe the suppression of the AB-transition by m agnetic eld only for pressures less than 21 bars, the pressure of the polycritical point. For super uid ${}^{3}\text{He}$ in aerogel, the data from Fig.3 suggest that this theory can be applied at all pressures with

where g_a () is a strong-coupling parameter de ned in a manner sim ilar to that of the pure super uid and B $_0\,$ is de ned as,

with the gyrom agnetic ratio of ${}^{3}\text{H}\,\text{e}$ and F_{0}^{a} is a Ferm i liquid parameter. In the Hom ogeneous Scattering M odel (HSM) which we describe below, B_{0} is modiled by im - purity scattering according to ${}^{24;20}$

where x $hv_f = 4 k_B T_{ca} l_{tr}$ and l_{tr} is the transport mean free path. This correction is about 2.5% at 25 bars with a 200 nm mean free path. We use the weak coupling approximation in Eq.3 which has been shown to be appropriate for bulk ${}^{3}\text{H}\,{e}^{38}$. Assuming that the aerogel AB-transition occurs between the axial and the isotropic states, as in the pure super uid, the coe cient g _a() is written as,

where we have used the Merm in-Stare convention, $_{ijk}$ $_{i} + _{j} + _{k}$. In the weak-coupling limit, $_{5}^{\text{wc}} = \frac{_{4}^{\text{wc}}}{_{4}^{\text{c}}} = \frac{_{3}^{\text{wc}}}{_{3}^{\text{c}}} = \frac{_{2}^{\text{wc}}}{_{2}^{\text{c}}} = 2 \frac{_{1}^{\text{wc}}}{_{1}^{\text{c}}} = 2 \frac{_{0}^{\text{wc}}}{_{0}^{\text{c}}} \text{ with}$ $_{0}^{\text{wc}} = 7$ (3)N (0)=240 ($k_{B} T_{c0}$)² and N (0) the density of states. In the weak-coupling limit, g_{a} ($^{\text{wc}}$) = 1.




FIG.6. Pressure dependence of the strong-coupling coecient g(). The aerogel data from the present work (solid circles) are compared to the bulk (empty circles)³⁶. The data at 4.8 bars denoted by a star are from Brussard et al.²⁶. The solid line is a guide-to-the-eye. The dotted line is the HSM with $l_{\rm tr}$ = 200 nm and for which the pure ³H e strong-coupling corrections are used. The same m odel was used with strong-coupling corrections rescaled from pure ³H e by the factor $T_{\rm ca}=T_{\rm c0}$ and two values of transport m ean free path were choosen, $l_{\rm tr}$ = 200 nm (dashed) and 150 nm (dot-dashed).

The coe cient g_a () can be taken directly from the low-eld slope, m, of the data in Fig.3, m = g_a () $T_{ca}=B_0^2$. In Fig.3, the dotted lines show the quadratic suppression of T_{ABa} for the smallest eld at which the transition was observed, and the extrapolation to zero eld was veri ed using the quench-cooling m ethod we have described above, see Fig.4. The pressure dependence of q_a () obtained from the data between 15 and 33.4 bars is shown in Fig.6 (lled circles), together with the measured values from the bulk, g_0 (), taken from Hahn et al.³⁶ (open circles). For the aerogel data, B_0 was de ned as in the pure case; using B_0^{HSM} increases q_a () slightly, however, its e ect for a mean free path of 200 nm remains within the experimental error bar. For this reason and for clarity, we have used B_0 which does not depend on the transport mean free path. We have also deduced the value of g_a () at 4.8 bars from the m agnetic suppression of the aerogel AB-transition m easured by the Lancaster group²⁶, denoted in Fig.6 with a star. The solid line is a guide-to-the-eye and the dotted, dashed, and dot-dashed lines are calculations using the hom ogeneous scattering m odel (HSM) which we discuss below. The pressure dependence of q_a () is markedly di erent from the pure super uid, g_0 (), which diverges at the PCP near 21 bars. The alm ost linear dependence on pressure observed in the aerogel super uid, even at high pressure, is a substantial modi cation of the phase diagram induced by impurity scattering.

The sim plest model of in purity scattering is the H om ogeneous Scattering M odel (HSM) 11 . In this model, the scattering probability is independent of position and the m edium is completely isotropic. This model has the advantage that the G inzburg-Landau theory is only slightly modi ed from that ofpure $^3{\rm H\,e.}$ The super uid transition in aerogel, $T_{\rm ca}$, is given by solving Eq.1 in the form ,

where x $hv_f = 4 k_B T_{ca} l_{tr}$ and l_{tr} is the transport mean free path. The 's have been calculated for the HSM and are given by¹¹,

where the coe cients a_1 and a_2 are given by,

and the ^{sc}'s are the strong-coupling corrections to the free energies. Note that in the bulk limit (l_{tr} ! 1), $a_1 ! \overset{w c}{}_{0}$ and $a_2 ! 0. W e$ choose a random scattering phase shift $_0$ such that $\sin^2_0 = 1=2$ and $a_2 = 0$. Calculations performed with a scattering phase shift in the unitary limit ($\sin^2 0 = 1$) or Born limit ($\sin^2 0 = 0$) have only a smalle ect on the magnitude of g_a () and do not alter our conclusions. The strong-coupling corrections relative to the weak-coupling value $_{i}^{sc} = _{0}^{wc}$, essential to calculate accurately g_a (), are taken from pure ${}^{3}\text{H}\,e^{38}$; namely, ${}_{345}$ is derived from measurements of the B-phase NMR g-shifts and longitudinal resonance frequency 38 , $_{12}$ from the norm alto B-phase heat capacity jum $p^{39}\text{,}$ and $_{245}\text{ and }_{5}\text{ are from }m\text{ easurem ents}$ of the A_1 A_2 splitting⁴⁰ and m agnetic suppression of the bulk AB-transition, q_0 ()³⁶. The only unknown param eter in the HSM is the transport mean path, $l_{\rm tr}$, for which high-frequency acoustic measurements on our sam ple were found to be consistent with a mean free path of 200-300 nm $^{31;33}$. In all of the calculations, $T_{\rm ca}$ was solved using Eq. 7 and was used consistently throughout our calculations of the i's.

In Fig.6, the dotted line shows the calculations of g_a () which assumes that the strong-coupling corrections are the same as in the pure super uid and with a transport m ean free path of 200 nm. The e ect of scattering is to increase the polycritical pressure, where g_a () diverges, thus increasing the stability of the dirty B-phase. This model does not describe our experimental data for any reasonable value of the transport m ean free path. However, we expect that the strong-coupling corrections

should scale to rst-order as i $(T_c=T_F) \stackrel{wc}{_0}$, hence being reduced (relative to the weak-coupling value) in the dirty system accordingly to $(\sum_{i=1}^{sc})_a = a^{wc}$ $(\sum_{i=1}^{sc})_0 = 0^{wc}$ $\frac{T_{ca}}{T_{c0}}$ where $(_{i}^{sc})_{a}$ and $(_{i}^{sc})_{0}$ are the strong-coupling corrections in the dirty and the pure super uids. In Fig.6 the calculations of g_a () were also perform ed with the HSM using the rescaled strong-coupling coe cients. They are shown with two choices of transport mean free path of 200 nm (dashed line) and 150 nm (dot-dashed line). Considering the lim itations of the HSM, the agreem ent between the data and calculated q_a () is reasonably good. However, the better agreem nt with the smaller m ean free path of 150 nm indicates that sm aller values of T_{ca} than the epexerim ental ones are needed to correctly decsribe the strong-coupling corrections in aerogel. But more importantly, the HSM calculations shows unam biguously that the strong-coupling corrections (relative to weak-coupling) are reduced by in purity scattering and that the PCP is increased in a 98% porous aerogelabove the melting pressure, beyond experimental reach. At the PCP, the heat capacity jump in the A-phase equals that of the B-phase, equivalent to the condition, $3_{13} = 2_{345}$ in Eq. 6. The HSM with rescaled strong-coupling corrections predicts a PCP of 34 bars for a mean free path of 200 nm and a PCP of 40 bars for a mean free path of 150 nm . The alm ost linear dependence on pressure of g_a () that we observe suggests that the true $P\,C\,P$ may even be higher than estimated from the HSM . Experim ents with higher porosity aerogels, having a correspondingly larger m ean free path, m ay be able to clarify this situation. It might also be necessary to take into account modi cation of the strong-coupling corrections beyond a simple rescaling as we have done, e.g. the effect of impurities on spin-uctuation feedback⁴¹.

The qualitative agreem ent of our data with the HSM calculations using a rescaling of the strong coupling corrections to the 's provides qualitative evidence that the orbital symmetry of the order parameter in the aerogel system is similar to that of the pure super uid. The expression, Eq. 4, for suppression of the AB-transition is speci c to the transition between axial and isotropic states and so the agreem ent between the model and our m easurem ents of the transition is consistent with, but not a proof of, their identi cation with A and B phases in the dirty super uid.

F inally, it is worth noting that in the pure super uid g_0 () does not recover its weak-coupling value (1) at zero pressure, but rather takes the value 1.61^{36} . This rather large deviation from weak-coupling theory at zero pressure, 40° , is unexpected since all other therm o-dynam ic m easurem ents indicate m uch sm aller deviations from weak coupling at low pressure. At zero pressure, the B-phase heat capacity jum p³⁹ and A₁ A₂ linear eld splitting⁴⁰ are within 3% of their weak-coupling values. This nite contribution to g_0 () at zero pressure has been interpreted as evidence that ³He is not a weak-coupling super uid at zero pressure³⁶. A swe have show n above, the strong-coupling corrections are reduced by scattering

(scaling with $T_{\rm ca}$) and should therefore be dram atically reduced at low pressure where $T_{\rm ca}$ is most strongly suppressed. We therefore expect g_a () to recover its weak-coupling limit in aerogel at low pressure, if indeed the deviation of g_0 () from weak coupling in pure $^3{\rm He}$ at low pressure is due to strong-coupling corrections. Our data in aerogel do not allow us to extrapolate to zero pressure and so an accurate measurement of g_a () at low pressures would be desirable since it might shed light on this problem .

C . Field dependence of T_{ca}




FIG.7. Field dependence the aerogel super uid transition $T_{\rm ca}$ at 33.4 bars. The dashed line shows the average value of $T_{\rm ca}$. The slopes of the two dotted lines are the same as for the A_1 A_2 splitting measured for pure $^3{\rm H\,e\,near\,m\,elting}$ pressure 40 .

The eld dependence of T_{ca} at 33.4 bars is shown in Fig.7 for elds ranging from 0 to 5 kG. The transition is clearly eld independent and from this we can infer that the super uid transition is from a normal uid to an ESP super uid. These data contradict earlier NMR work where a B² eld dependence was reported for the super uid transition in aerogel¹⁰. Upon reanalysis of these same earlier results including some additional experiments, by H aard³⁸, it was found that the NMR data are consistent with the acoustic experiments presented here to within experimental error.

In pure super uid ³He, owing to particle-hole asymmetry, a magnetic eld produces a linear splitting of the norm al to A-phase transition⁴⁰. The eld dependence of the splitting between the A₁ and A₂ phase lines is 6 K/kG near melting pressure and is shown in Fig.7 as dotted lines shifted to the average value of T_{ca} .

In contrast, for the aerogel super uid we do not observe any deviation of T_{ca} from its zero- eld value, nor do we observe signi cant broadening of the transition region in the acoustic trace even at our highest eld of 8 kG (not shown in Fig.7. This splitting may be hard to resolve ow ing to the rather broad super uid transition in aerogel, 30 K. The expected linear $A_1 = A_2$ splitting in the dirty super uid can be estimated from calculations based on G inzburg-Landau theory and the HSM (see above). The bulk $A_1 = A_2$ splitting can be expressed by the quantity U_0 de ned as,³⁶

which ranges for pure $^{3}\text{H}\,\text{e}$ from 0.97 at zero pressure to 1.81 at m elting pressure. In the HSM, the U parameter can be calculated from $_{5}$ and $_{245}$ and in aerogel takes the value at m elting pressure of U_a ' 0.85U_0 with a m ean free path of 200 nm. For this estimate, we have used the rescaled bulk strong-coupling corrections as discussed above. M easurements of T_{ca} in high elds su cient to resolve this splitting are desirable in order to establish a better understanding of the therm odynam ics of the dirty super uid.

D.Supercooling of the aerogel AB-transition in zero applied eld

We have shown that the polycritical point vanishes for super uid ³He in 98% aerogel. Consequently, in zero eld we expect that super uidity occurs by a second order transition from the norm all state directly to the B-phase without supercooling. Our observation of supercooling giving a large region of metastable A-phase with no applied eld is quite unexpected. Supercooling was rst noted by Barker et al.¹⁵ for the aerogel AB-transition at 284 G with ⁴He preplating. This was also found for zero applied eld and was studied as a function of magnetic eld by Gervais et al.^{27;35}. Our smallest eld in this case was estim ated to be less than 10 G. There are a num ber ofpossible intrepretations and so a review of the expected behavior in the lim it of low magnetic eld is appropriate.

Taking pure super uid ³He as a guide, the rst transition encountered on cooling in a sm allbut non-zero m agnetic eld is from the norm al state to the A1-phase and then, in the absence of supercooling, to the B-phase. If there were to be supercooling it is likely that the A $_2$ transition would be encountered before reaching the B-phase. This follows since the A₁ transition increases linearly with eld whereas the B-phase is suppressed quadratically. Consequently, the supercooling of the aerogel ABtransition at 284 G observed by Barker et al¹⁵ can be explained in a trivial way: a sm all region of A₁-phase in equilibrium , $^<$ 1 K , is rst encountered on cooling, lead– ing to a m etastable A -phase that supercools until the Bphase nucleates. However, the mechanism for producing relative stability of one phase over another, or the nucleation of the most stable phase, has not been explored in such a sm all interval of tem perature near T_c.




FIG.8. Phase diagram for metastable ³H e A -phase in 98% porous aerogel in zero applied magnetic eld. The triangles are the aerogel super uid transition and the open circles the aerogel A -B transition on cooling. The inset shows the magnitude of supercooling of the aerogel A -B transition as a function of pressure. The dotted lines are the pure ³H e super uid phase with A, B and solid phases indicated.

C an the sam e argum ent for supercooling in 284 G hold at very low eld as well? If the total eld for the case of zero applied eld were less than 10 G then the window of stability of the A_1 -phase would be only < 0.03 K.We nd supercooling under these circum stance to be even m ore remarkable since there is no evidence of sim ilar supercooling for the pure super uid at pressures below the polycritical point. If the phenom enon of supercooling in low eld were to be unique to the dirty super uid then it would require a correspondingly unique nucleation seenario speci c to the aerogelAB-transition, which, in addition, must also account for our observation that the extent of supercooling is eld independent²⁷. Furtherm ore, it seems not to make sense to rely on details for phase stability in such a narrow window of tem perature when the super uid transition T_{ca} is inhom ogeneously broadened over an interval three orders of m agnitude larger. A second possibility, and one that we believe to be more likely, is that there must be a thin, but unobserved, sliver of A-phase near T_{ca} which gives rise to the m etastability that is observed. This sliver is at most < 20 K wide, but might be stabilized by inhom ogeneity in the aerogel structure in a manner that is not yet understood. In Fig.8, them etastable phase diagram from Gervais et al.²⁷ is shown with no applied magnetic eld ranging in pressure from 15 to 33.4 bars. The region of metastability is strikingly sim ilar to that observed by Barker et al.¹⁵ in a eld of 284 G, with ⁴He preplating, and for a much larger aerogel sam ple. The critical radius R_c for B-phase nucleation m ay play an important role, since a large critical radius in the aerogelm ight give rise to the observed m etastability. An estim ate³⁵ nearm elting pressures from the susceptibility di erence and eld dependence of TABA shows that it is slightly larger in aerogel, R $_{\rm c}^{\rm aero}$ 5R^{bulk} at the same value of $T = T_{AB}$. In pure ³He the critical radius has not been measured below melting pressure. Future work in a magnetically shielded environment and with di erent aerogel densities, together with characterization of R_c as a function of pressure, could bring som e understanding to this puzzle.

For all experiments to date it has been unavoidable that pure and dirty super uids be juxtaposed. In future work it may be possible to explore the connection between these two unconventional super uids and such experiments can bene t from detailed knowledge of the phase diagram. In this spirit we have recently investigated the nucleation of the AB-transition³⁵ showing that proximity coupling between the pure and dirty super uids is too weak to act as a source of nucleation.

IV.CONCLUSION

W e have described the phase diagram of super uid 3 H e in 98% aerogel. In this phase diagram we nd two equilibrium states which we call A and B, by analogy with pure ³He. The B-phase is favored in zero eld and is destablized by a magnetic eld yielding the A-phase. The super uid transition from the norm al state, i.e. norm al to A-phase transition, is insensitive to magnetic eld. On this basis alone we can be con dent of the nature of the spin part of the order param eter associated with each of these phases: the A -phase is an equal spin pairing state and the B-phase is a non-equal spin pairing state. The eld dependence of the AB-transition can be understood from calculations using the HSM model combined with a simple rescaling of strong-coupling corrections to the quasiparticle interactions, assuming that the A and B dirty phases are in fact the axial and isotropic p-wave states. The theory and experim ent both concur that sufcient in purity scattering, as is the case for 98% aerogel,

causes the polycritical point to vanish. It is intriguing that no hint of the expected but sm all $A_1 = A_2$ splitting was observed even at elds of 8 kG; how ever, higher eld experim ents will be better able to address this question.

The extensive supercooling of the AB-transition, especially with no applied eld, remains a puzzle. It cannot be simply explained in terms of the phase diagram that we present, nor in terms of current nucleation scenarios. This raises further questions concerning the nature of the super uid state in aerogel and whether it m ight be inherently inhom ogeneous.

In sum mary, the measurements of the equilibrium phase diagram of ${}^{3}\text{He}$ with impurity scattering improves our understanding of pure and dirty super uids and sets the stage for a better understanding of its non-equilibrium behavior, metastability and nucleation.
