# Scaling, Multiscaling, and Nontrivial Exponents in Inelastic Collision Processes

We investigate velocity statistics of hom ogeneous inelastic gases using the Boltzm ann equation. Employing an approximate uniform collision rate, we obtain analytic results valid in arbitrary dimension. In the freely evolving case, the velocity distribution is characterized by an algebraic large velocity tail, P (v;t) v . The exponent (d; ), a nontrivial root of an integral equation, varies continuously with the spatial dimension, d, and the dissipation coe cient, . A lthough the velocity distribution follows a scaling form, its moments exhibit multiscaling asymptotic behavior. Furtherm ore, the velocity autocorrelation function decays algebraically with time, A (t) = hv (0) v (t)i t , with a non-universal dissipation-dependent exponent = 1= . In the forced case, the steady state Fourier transform is obtained via a cum ulant expansion. Even in this case, velocity correlations develop and the velocity distribution is non-M axwellian.

I. IN TRODUCTION

Inelastic gases consist of hard sphere particles that interact via contact interactions and dissipate kinetic energy upon collisions [1]. They are used extensively to study dynam ics of granular materials. Numerically, molecular dynam ics simulations are quite successful in modeling many of the observed collective phenomena that include size segregation, phase transitions, shocks, clustering, and development of other spatial structures [2{10]. In parallel, kinetic theory is utilized to system atically derive macroscopic properties from the microscopic collision dynam ics [11{13].

Inelastic gases, a prototype nonequilibrium interacting particle system, are interesting on their own rights [14{21]. Recent theoretical and experimental studies show that the velocity distributions exhibit anom alous large-velocity statistics with exponential, stretched exponential, and Gaussian tails [6{8,22{25]. Inelastic gases involve signi cant velocity and spatial correlations in contrast with traditional molecular gases [26{28]. Kinetic theory assumes that spatial velocity correlations are small. While this assumption can be justi ed for strongly driven gases, the situation for freely evolving gases is more di cult since velocity correlations can be ignored only in the early hom ogeneous phase [29[31], but must be taken into account in the asymptotic clustering phase. C learly, the strong energy dissipation raises challenging new questions [32].

Yet, even more elementary questions remain unanswered. For example, random collision processes e ectively generate thermal, purely Maxwellian, velocity distributions when the collisions are elastic. In particular, di erent components of the velocity become uncorrelated. In this study, we consider these very same processes but with inelastic collisions. We show that energy dissipation fundamentally alters the behavior. The system is intrinsically a nonequilibrium one, and the resulting velocity distributions are far from thermal.

W e consider a collision process where random pairs of

particles undergo inelastic collisions with a random in – pact direction. This process, often called the M axwell m odel, is described by a Boltzm ann equation with a uniform collision rate. In classical kinetic theory of gases, the analytically tractable M axwell m odel precedes the Boltzm ann equation [33]. H istorically, it played an im – portant role in the developm ent of kinetic theory [34{36}], and it still remains the subject of current research [37,38].

Very recently, it has been noted that the Maxwell model is analytically tractable even for inelastic collisions [39{43]. Interesting behavior emerges in the freely evolving case. In one dimension, while moments of the velocity distribution exhibit multiscaling [39], the velocity distribution itself still approaches a scaling form with an algebraic large velocity tail [40]. Here, we show analytically that in arbitrary spatial dimension the velocity distribution admits a scaling solution with an algebraic large velocity tail. The corresponding exponent, a root of a transcendental equation, depends on the spatial dimension and the restitution coe cient. Additionally, we nd that the multiscaling behavior extends to higher dimensions, and that the velocity autocorrelation function exhibits aging and nonuniversal asym ptotic behavior. In general, velocity components develop signi cant correlations. Such correlations dim inish in the forced case, although the velocity distribution remains non-Maxwellian.

The rest of this paper is organized as follows. The basic Boltzm ann equation for the velocity distribution and its Fourier transform are presented in Sec. II. In Sec. III, we investigate the scaling regime, and obtain the extrem al velocity statistics, m om ents of the velocity scaling function, and velocity correlations. In Sec. IV, we illum inate the nonequilibrium dynamics by studying the time dependent behavior of the m om ents and the velocity autocorrelation function. In Sec. V, we consider nonequilibrium steady states in the driven case, and obtain the steady state distribution as a cum ulant expansion. A few generalizations are brie y m entioned in Sec. V I, and conclusions are given in Sec. V II.

#### II. THE MAXWELL MODEL

W e study a hom ogeneous system of identical inelastic spherical particles. The mass and the cross-section are set to unity without loss of generality. Particles interact via binary collisions that lead to exchange of momentum along the impact direction. The post-collision velocities  $v_{1,2}$  are given by a linear combination of the pre-collision velocities  $u_{1,2}$ ,

Here  $g=u_1\quad u_2$  is the relative velocity and n the unit vector connecting the particles' centers. In each collision, the norm alcom ponent of the relative velocity is reduced by the restitution coe cient  $r=1\quad 2$ . The energy dissipation equals  $E=(1)(g-\hat{n})$  so for =0 collisions are elastic, while for  $=1{=}2$  collisions are perfectly inelastic with maximal energy dissipation. Since the collision rule (1) is Galilean invariant, the average velocity can be set to zero without loss of generality.

W e investigate the  $\M$  axwell model" where the collision rate in the Boltzm ann equation equals the typical velocity, rather than the actual relative velocity [35,36]. This kinetic theory describes a stochastic process where random ly chosen pairs of particles undergo inelastic collisions according to (1) with a random ly chosen in pact direction n. In such a process, no spatial correlations develop, and the norm alized velocity distribution function, P (v;t), obeys

The overall collision rate equals  $g = {p - \over T}$  where T is the granular tem perature, or the average velocity uctuation per degree of freedom,  $T = {1 \over d}$  dv v<sup>2</sup>P (v;t) with v jv j. The restriction g n > 0 on the angular integration range in Eq. (2) can be tacitly ignored, because the integrand obeys the re ection symmetry n<sub>R</sub>! n. This angular integration should be norm alized, dn = 1.

W e study primarily the freely evolving case where in the absence of energy input the system  $\cools$ " inde - nitely. From the Boltzm ann equation (2), the tem perature rate equation is

The constant = 2 (1 ) dn  $n_1^2$ , is obtained using the identity  $n_1^2$  + :::+  $n_d^2$  = 1 that yields dn  $n_1^2$  = 1=d. Solving Eq. (3) we not that the temperature decays according to Ha 's cooling law [14]

with the time scale  $t = d = (1)^{p} \overline{T_{0}}$  set by the initial temperature,  $T_{0}$ .

Given the convolution structure of the Boltzmann equation (2), we introduce the Fourier transform [36] of the velocity distribution function,

We conveniently reset the collision rate to unity by modifying the time variable. The collision counter is dened via the transformation  $\frac{d}{d} = \frac{p_{T}^{1}}{T} \frac{d}{dt}$ . Speci cally,

equals the average num ber of collisions experienced by a particle. Applying the Fourier transform to Eq. (2) and integrating over the velocities gives

with q = (1) (k n) n. This equation rects the momentum transfer occurring during collisions.

We restrict our attention to isotropic situations, and write the Fourier transform F (k; ) F (z; ) in term s of the variable  $z = k^2$ . To perform the angular integration, it proves useful to employ spherical coordinates with the polar axis parallel to k, so that  $\hat{k}$  n = cos . The -dependent factor of the measure dn is proportional to (sin )<sup>d</sup> <sup>2</sup>d . In term s of the variable = cos<sup>2</sup> one has dn D, with

The governing equation (7) for the Fourier transform can now be rewritten in the convenient from

with the shorthand notations = 1 (1 <sup>2</sup>) and = (1  $\hat{f}$ . Hence, the Fourier equation is both nonlinear and non-local. Interestingly, while it is dicult to integrate this equation with respect to time, most of the physically relevant features of the velocity distributions including large velocity statistics and the time dependent behavior of the moments can be found analytically, as will be shown below.

## III. SCALING SOLUTIONS

N um erical simulations in two-dimensions suggest that the velocity distribution approaches the scaling form [40]

The scaling form of the Fourier transform reads

In the k ! 0 limit, the Fourier transform behaves as F (k;t) = 1  $\frac{1}{2}k^2T$ . This implies that the set two terms in the Taylor expansion of the corresponding scaling function are universal, (x) = 1  $\frac{1}{2}x$ . Substituting the above scaling form into the governing equation (10) and using the temperature cooling rate  $\frac{d}{d}T = T$  yields the governing equation for the scaling function

0 ne can check that the velocity distribution is purely M axwellian  $(x) = e^{x=2}$  in the elastic case [44]. Indeed,

= 0 and + = 1 in this case. A stochastic process of elastic collisions e ectively random izes the velocities and leads to a therm all distribution.

#### A . A lgebraic tails

It is instructive to consider st the one-dimensional case. Here, integration over is immediate as this variable equals unity, and the scaling function satis es

Performing the inverse Fourier transform gives the velocity distribution as a squared Lorentzian

The scaling solution (15) is universal as it is independent of the dissipation  $\cos c$  cient . Its key feature is the algebraic tail, P (w) w<sup>4</sup> as jv j! 1.

In general dimension d, the large velocity behavior of the velocity distribution can be determined from the smallwavenum berbehavior of its Fourier transform. For example, the small-x expansion of the one-dimensional solution (14) contains both regular and singular terms: (x) = 1  $\frac{1}{2}x + \frac{1}{3}x^{3-2} +$ , and the dominant singu-

lar  $x^{3=2}$  term re ects the w <sup>4</sup> tail of P (w). In general, an algebraic tail of the velocity distribution (11),

indicates the existence of a singular component in the Fourier transform ,

The inverse is also correct. This can be seen by recasting the Fourier transform (x) /  $\frac{1}{R_1}$  dw w<sup>d</sup> <sup>1</sup>P (w) e<sup>iw<sup>F</sup>x</sup> into a Laplace transform I(s) /  $\frac{1}{0}$  dw w<sup>d</sup> <sup>1</sup>P (w) e<sup>ws</sup> by writing x = s<sup>2</sup>. The smalles expansion of I(s) contains regular and singular components. For exam – ple, when < d, the integral I(s) diverges as s ! 0 and integration over large-w yields the dom inant contribution  $I_{sing}$  (s) s <sup>d</sup>. When d < < d + 1, I(0) is nite, but the next term is the above singular term, so I(s) = I(0) +  $I_{sing}$  (s) s <sup>d</sup>, thereby leading to Eq. (17).

The exponent can be now obtained by inserting  $(x) = _{reg}(x) + _{sing}(x)$  into Eq. (13) and balancing the dom inant singular term s. We not that is a root of the integral equation

This relation, originally derived in Refs. [41,42], can be recast as an eigenvalue problem. Indeed, de ning = hl i we can rewrite Eq. (18) as = 1 with =  $\frac{d}{2}$ . Note that 1, so there is an obvious solution = 1, or = d + 2. In this case, the singular term simply coincides with the dom inant regular term,  $x^{(d)=2} = x$ . Hence, this solution is trivial and in the following we shall seek a solution with > d + 2.

The integral equation (18) can also be rewritten in terms of special functions. The rst integral on the right-hand side of (18) can be expressed in terms of the hypergeom etric function  $_2F_1(a;b;c;z)$  [45] and the second as a ratio of beta functions:

W e conclude that the exponent (d; ) depends in a nontrivial fashion on the spatial dimension d as well as the dissipation coecient.

First, let us investigate the dependence on the dissipation coe cient by considering the quasi-elastic limit

C learly, the quasi-elastic limit is singular. D issipation, even if m inute, seriously changes the nature of the system [6,25,31]. Further corrections can be obtained via a

Next, we discuss the dependence on the dimension. First, one can verify that = 4 when d = 1 by utilizing the identity  $_{2}F_{1}(a;b;b;z) = (1 z)^{a}$ . In the innite dimension limit, the second integral  $h^{(d)=2}$  i in Eq. (18) is negligible as it vanishes exponentially with the dimension. To evaluate the second integral we take the limits d! 1 and ! 0 with z = d=2 xed.The integration measure (8) is transform ed according to ! (z)  ${}^{1=2}e_{R_{1}}^{z}dz$ , and the basic Eq. (18) becomes (1)  $u = {}^{R_{1}}_{0}dz$  (z)  ${}^{1=2}e^{[1+(1)^{2})u]z}$  with the D shorthand notation  $u = \frac{1}{d}$  1. Perform ing the integra-(1  $u = [1 + (1 ^{2})u]^{1=2}$ . 


FIG.1. The exact exponent , obtained from Eq. (19), versus the dissipation parameter . The exponent was scaled by the dimension d. Shown also is the limiting large dimension expression (21).

In general, / d, and therefore, the algebraic decay becomes sharper as the dimension increases. The exponent (d; ) increases m onotonically with increasing d, and additionally, it increases m onotonically with decreasing (see Fig. 1). Both features are intuitive as they m irror the m onotonic dependence of the energy dissipation rate = 2 (1)=d on d and . Hence, the com -

pletely inelastic case provides a lower bound for the exponent, (d; ) (d; = 1=2) with (d;1=2) = 6.28753, 8:32937, for d = 2, 3, respectively. Numerical simulation results are consistent with the former value [46]. The algebraic tails are characterized by unusually large exponents which may be di cult to measure accurately in practice; for instance, typical granular particles are characterized by the dissipation coe cient 0:1 yielding

30 in three dimensions. Figure 1 also shows that the quantity =d weakly depends upon the dimension, and the large-d lim it (21) provides a good approximation even at moderate dimensions.

## B.D ivergence of the m om ents

The algebraic tail of the velocity distribution in plies that su ciently small moments of the scaling function

(x) are nite, while moments larger than some index diverge. In the scaling regime, moments of the velocity distribution can be calculated by expanding the Fourier transform in powers of x,

The coe cients  $_{n}$  yield the leading asymptotic behavior of the velocity moments,  $M_{k}(t) = dv v^{k} P(v;t)$ , via the relation  $(2n)!T^{n}_{n}$ , '  $h^{n}$  iM  $_{2n}$ . Inserting the moment expansion into the governing equation (13) yields the closed hierarchy of equations

with  $_{n} = hl$   $^{n}$  i and  $_{m;l} = h^{m}$  <sup>l</sup>i. The rst few coe cients are written explicitly in Appendix A. Starting with  $_{0} = 1$  and  $_{1} = 1=2$ , further coe cients are determined recursively from (23). In the elastic case (=0), one has  $_{n} = (n!2^{n})^{-1}$ , consistent with (x) = e  $^{x=2}$ . For general, the rst two terms are

The behavior is determ ined by two parameters: d and . Fixing , we see that a given moment  $_n$  is nite only if the dimension is su ciently large,  $d > d_n$  (). In particular,  $_n$  is nite only if the left-hand side of Eq. (23) is positive,  $_n \quad n \mid_2 > 0$ . This condition is satisticed only if the dimension is su ciently large  $d > d_n$ , with  $d_n$  being the spatial dimension at which  $_n = n \mid_1$ . For example,  $_2 > 0$  when  $d > d_2$ , and  $_3$  is nite only when  $d > d_i$  with the following crossover dimensions

C onversely, for a xed dimension, a given moment is nite only if the dissipation is su ciently small. For example,  $_3$  is positive only when < 0.302074;0.427438at d = 2;3. Such values, obtained by solving polynom ial equations yield integer values of the large velocity decay exponent (2;0.302074) = 8 and (3;0.427438) = 9, in accord with direct numerical solution of Eq. (19).

#### C.Velocity correlations

M axwell's sem inal derivation of the M axwellian distribution (see R ef. [26], p. 36) relies on two basic assum ptions: (1) Isotropy of the velocity distribution, and (2) A bænce of correlations between the velocity components. The latter assumption is directly probed using the follow ing correlation m easure

A non-vanishing Q indicates that velocity correlations do exist, and the larger Q the larger the correlation. In the freely evolving case, this quantity easily follows from the small-x behavior of the scaling function

(x). By de nition,  $h_X^2 i = h_X^2 i = T$  and furthermore,  $h_X^2 v_y^2 i = \frac{\theta^2}{\theta k_x^2} \frac{\theta^2}{\theta k_y^2} F = 4T^2 \quad (0)$ . Consequently, one has Q = 4  $\quad (0)$  1 = 8 2 1. Using Eq. (24) we nd

when  $d > d_2 = 1 + 3^2$ , and Q = 1 otherwise. While the quantity Q is physical when d 2, it is sensible to use analytic continuation to reveal the underlying divergence. Velocity correlations vanish for elastic gases. Interestingly, inelasticity introduces strong velocity correlations, and the larger the larger the correlations as Q increases monotonically with increasing . The perfectly inelastic case ( = 1=2) again provides a bound:  $Q < Q_{max} = 6$ , 6=5 for d = 2, 3, respectively. This behavior is som ew hat intuitive as the unisotropic collision rule (1) discrim inates the velocity component norm alto the impact direction.

#### IV.NONEQUILIBRIUM DYNAM ICS

Thus far, we focused on the leading asymptotic behavior of the velocity distribution. The diverging moments and the dissipative nature of this system suggest that the time dependence may exhibit rich behavior. Thus, we study relaxation of velocity characteristics such as the moments and the autocorrelation function.

#### A.M ultiscaling of the m om ents

W hile m om ents of the scaling function diverge, the actual m om ents m ust rem ain nite at all times, particularly at the scaling regime. Therefore, the above m om ent analysis suggests that know ledge of the leading asymptotic behavior is not su cient to characterize the time dependent behavior of su ciently large m om ents.

The time evolution of the moments can be studied using the expansion

The actual m om ents are related to the coe cients via (2n)  $f_n = h^n iM_{2n}$ . Substituting the expansion (28) into (10) yields the evolution equations

We demonstrate multiscaling asymptotic behavior by evaluating the second, fourth, and sixth moments. The second moment is obtained from  $\frac{d}{d}f_1 + {}_1f_1 = 0$  with  ${}_1 = 2 (1) = d$ . Hence, we recover Ha's law  $f_1() = f_1(0)e^{-1}$ , or  $f_1(t) = f_1(0)(1 + t = t)^2$ . A symptotically, the second moment of the velocity distribution has the universal behavior, M<sub>2</sub> t<sup>2</sup>. The next coe cient  $f_2$  satis es

Solving Eq. (30) we not that  $f_{c}$  () is a linear combination of two exponentials, e  $^{2}$  and e  $^{2}$   $^{1}$ , whose decay coefficients are equal  $_{2}$  = 2  $_{1}$  at the crossover dimension d<sub>2</sub>.

Integrating the rate equation (30) and translating back to the physical time t, we obtain

$$f_2(t) = C_1 \ln (1 + t=t) + C_2 (1 + t=t)^4;$$
 (32)

with  $C_1 = {}_{1,1}f_1^2(0)$  and  $C_2 = f_2(0)$ . Thus for  $d > d_2$ , the fourth moment exhibits ordinary scaling,  $f_2 = t^4$ , or M<sub>4</sub> M<sub>2</sub><sup>2</sup> t<sup>4</sup>. When  $d < d_2$ , multiscaling become s apparent as  $f_2 = t^{2-2}$  and therefore the ratio M<sub>4</sub>=M<sub>2</sub><sup>2</sup> diverges asymptotically. This is consistent with the divergence of the fourth moment of the scaling function

(x) that occurs at the same crossover dimension  $d_2$ . A logarithm ic correction occurs at this dimension. In sum – mary, we nd the following leading asymptotic behavior of the fourth moment

A similar calculation can be carried for the sixth moment. The solution of  $\frac{d}{d}f_3 + {}_3f_3 = ({}_{1;2} + {}_{2;1})f_1f_2$ , with  $f_1$  and  $f_2$  given above involves three exponentials: e  ${}^3$ , e  $({}^{1+}{}^2)$ , and e  ${}^{3-1}$ . A symptotically, the rst exponential dom inates when d < d<sub>3</sub>, and consequently, M  $_6$  t  ${}^2$   ${}^3$ ; otherwise, the third exponential dom inates and thence ordinary scaling occurs, M  $_6$  t  ${}^6$ . G enerally, the leading asymptotic behavior of the 2n-th moment is characterized by two di erent regimes

Further logarithm ic corrections a ecting sub-dom inant term s occur at the crossover dimensions  $d_2$ ;:::; $d_{n-1}$ .




FIG.2. The crossover dimensions  $d_n$  ( ) of Eq. (25) versus the dissipation  $\infty$ e cient for n = 2, 3.

The dependence of  $d_n$  () on the dissipation coe cient is shown in Figure 2. In the physical dimensions d = 2;3, the fourth moment exhibits ordinary scaling behavior. The sixth order moment exhibits multiscaling if the dissipation coe cient is large enough: > 0:302074;0:427438 for d = 2;3, respectively. In the large n limit, n ! 1 so from  $n = n_1$  we nd  $d_1$  ! 2 (1 ) n. Thus, regardless of the dissipation parameters and the dimension, su ciently large moments exhibit multiscaling:

Interestingly, the multiscaling exponents saturate asym ptotically, n ! d= 2 (1 ) as n ! 1 . Of course, ifthe dimension increases or the dissipation parameter decreases, the order of the lowest moment exhibiting multiscaling increases, and in practice, it may be dicultto observe deviations from ordinary scaling. For exam –ple, at <math>d = 3 and = 0:1, multiscaling occurs only for moments whose index exceeds 30!

#### B.Non-universal velocity autocorrelations

The autocorrelation function quanti es m em ory in the velocity of a tagged particle [26]. The velocity autocorrelation, A ( $t_w$ ;t), is de ned via

where the overline denotes averaging over all particles and  $t_w$  is the \waiting" time,  $t_w < t$ .

It is simple to show (see appendix B) that the autocorrelation evolves according to the following linear equation

where time is again expressed in terms of the collision counters  $_{\rm W}$  and . Equation (37) is solved to give A ( $_{\rm W}$ ; ) = A ( $_{\rm W}$ ;  $_{\rm W}$ ) exp[ $\frac{1}{d}$  ( $_{\rm W}$ )], or equivalently

$$A (t_w;t) = A_0 (1 + t_w = t)^{1} (1 + t_{=}t)^{1} (38)$$

with  $A_0 = dT_0$ . Therefore,  $A(t_w;t)$  is a function of the waiting time  $t_w$  and the observation time t, and not simply of their di erence,  $t_w$ . This interesting history dependence or \aging" is another signature of the nonequilibrium nature of our system.

M em ory of the initial conditions can be quantiled by setting  $t_w = 0$ . W riting A (t) A (0;t) we arrive at the following algebraic decay

In contrast with the temperature which decays with a universal law, T (t) t<sup>2</sup>, the autocorrelation decays with a non-universal law, A (t) t<sup>1=</sup>. The exponent is independent of the dimension. However, it strongly depends on the dissipation, and the stronger the dissipation, the stronger the mem ory of the initial conditions. This decay exponent is bounded by 2 1= 1. In the elastic case, = 0, a sim ple exponential decay occurs, and in the totally inelastic case, = 1=2, the autocorrelation and the temperature are proportional to each other.

The autocorrelation function allows calculation of the long-time spread in the position of a tagged particle  $^2$  (t) high (t) x (0)  $\stackrel{2}{p}$  i. U sing x (t) x (0) =  $^{R_{t}}_{0} dt^{0}v$  (t<sup>0</sup>), one can immediately express  $^2$  (t) via the autocorrelation function,  $^2 = 2 {}_{0} dt^{0} {}_{0} dt^{0} A$  (t<sup>0</sup>;t<sup>0</sup>). Substituting (38) into this expression and performing the integration yields  $^2$  (t) = C<sub>1</sub> ln (1 + t=t) + C<sub>2</sub> (1 + t=t)^{1-1} 1 with C<sub>1</sub> = 2A\_{0}t^{2} = (1 ) and C\_{2} = C\_{1} = (1 ). A symptotically, the second term is negligible, and the spread has a generic logarithm ic behavior

re ecting the t<sup>1</sup> decay of the overall velocity scale [47,48].

## V.STEADY STATES

Thus far, we have discussed freely cooling systems where the energy decreases inde nitely. In typical experimental situations, however, the system is supplied with energy to balance the energy dissipation [6{8,23]. Theoretically, it is natural to consider white noise forcing [22,49], i.e., coupling to a therm all heat bath which leads to a nonequilibrium steady state. Interestingly, a stretched exponential behavior, P (v) / exp( $v^{3=2}$ ), is found for the driven inelastic hard sphere gas [22].

Speci cally, we assume that in addition to changes due to collisions, velocitiesm ay also change due to an external forcing:  $\frac{dv_j}{dt} j_{leat} = j$  with  $j = 1; \dots; d$ . We use standard uncorrelated white noise  $h_i(t)_j(t^0)i = 2D_{ij}$  (t  $t^0$ ) with a zero average  $h_ji = 0$ . The rate equation for the temperature is modiled by the additional source term  $\frac{d}{dt}T + T^{3=2} = 2D$ , and the system approaches a steady state,  $T_1 = (2D = )^{2=3}$ . The relaxation tow and this state is exponential,  $JT_1 = Tj e^{\text{const: t}}$ .

Uncorrelated white noise forcing amounts to di usion in velocity space. Therefore, Eq. (7) is modiled as follows,  $\frac{\theta}{\theta}$  !  $\frac{\theta}{\theta}$  + D k<sup>2</sup>. In the steady state, the Fourier transform, F<sub>1</sub> (k) (y) with  $y = D k^2$ , obeys

T his equation is solved recursively by employing the cumulant expansion

The cumulants <sub>n</sub>, de ned as

are related to the case cients  $_{n}$ , viz.  $_{n} = (2n) D^{n} _{n}$ . W riting 1+ y = exp  $_{n-1}$  (y)<sup>n</sup>=n , we recast Eq. (41) into

with the auxiliary variables  $e_n = n(1 n)$ . The desired cumulants n are obtained by evaluating recursively the angular integrals of the auxiliary variables,  $h_n^e$  i, and then using the identities  $n = h_n^e i = n$ . In one dimension,  $h^n i = 1$  and one immediately obtains  $h_n^e i = n^{-1}$ , and consequently  $n_n = [1 2^n (1 )^{2n}]^{-1}$  [39]. In higher dimensions, the quantities  $h_n^e i = 1$ ,  $h_2^e i = \frac{1}{2}h_1^{e_2}i$ , and  $h_3^e i = h_1^e e_2 i = \frac{1}{6}h_1^{e_3}i$ . The rst few values for n can be then evaluated. In particular, 1 = 1 = 1 and

 $_2 = (1)$   $f = 2 \frac{2}{1} \frac{2}{2}$ , from which one can determine explicit expressions:

Thus, the steady state distribution is not purely Maxwellian.

To probe velocity correlations or alternatively, deviations from a factorizing M axwellian distribution, we consider the quantity Q, de ned in Eq. (26). At the steady state, it is given by

In terms of the rst two coe cients of the cumulant expansion,  $Q = 2_{2} = \frac{2}{1}$ . Substituting the value of these coe cients yields




FIG.3. The velocity correlation measure Q versus the dissipation coe cient . The scaling regime result (27) is shown in the top graph, and the steady state result (47) is shown in the bottom graph.

Note that for a xed spatial dimension, this quantity is maximal in the completely inelastic case. For instance,  $Q_{\rm max} = 2$ =11 in two dimensions and  $Q_{\rm max} = 2$ =15 in three dimensions. These values are smaller by an order of magnitude or more than the corresponding values in the unforced case. Intuitively, one expects that white noise forcing random izes the velocities of the particles. Indeed, velocity correlations are much less pronounced in this case, as seen in Figure 3. Additionally, velocity correlations diminish as the dimension increases. At large dimensions, velocity correlations vanish according to Q d<sup>1</sup>, indicating that the velocity distribution becomes purely Maxwellian, (y) ! exp( y=2), when d! 1.

The above results can be generalized in a number of ways. For example, the development of spatial correlations can be considered by placing particles on a lattice and allowing for nearest-neighbor collisions only. In this section we brie y mention two straightforward generalizations to: (1) energy generating collisions, and (2) distribution of restitution coe cients.

Thus far, we discussed only the physical case of dissipative collisions, namely < 0. However, the above results in the freely evolving case hold for energy generating collisions, i.e., > 0 as well. A though the typical velocity scale diverges, the velocity distribution still follow s the scaling solution (11) with algebraic large velocity statistics. The corresponding exponent is still obtained from Eq. (19). How ever, the behavior does change, as follows from the analytically tractable d! 1 behavior. In contrast with the dissipative case, the second term on the right-hand side of Eq. (19) now dom inates, and it grows exponentially as  $/ a^{(d)=2}$ . Since the left-hand side of Eq. (19) is of order unity, the constant a must be equal to one. On the other hand, the constant a is evaluated using the Stirling form ula (x)  $(x=e)^{x}$  to give  $d)d^{d=(d)} = (d)$ . Equating a = 1, a = (1 )<sup>2</sup> ( we arrive at

= d; with (1)  $\overline{1} = (1)^{2}$ : (48)

W hile the exponent rises linearly with the dimension, it exhibit dierent -dependence. Numerical solution of shows that this large dimension estimate again yields a useful approximation even at moderate dimensions.

Several recent studies have used a distribution of restitution coe cients to model driven granular system s, including for example, a one-dimensional gas of rods with internal degrees of freedom [50,51], and vertically vibrated layers [52]. By tuning the distribution properly, one can have a situation were overall, energy is conserved as dissipative collisions are balanced by energy generating collisions. When the restitution coe cient is drawn from the distribution (), one simply integrates the collision integral in the Boltzm ann equation (2) with respect to the measure (). In one dimension, one can check that the scaling solution (x) =  $1 + \frac{p}{x} e^{-\frac{p}{x}}$  stillholds, and in particular the exponent = 4 is robust. In general dimension, the exponent is given by

$$1 \qquad \frac{d}{2} = d \qquad () \qquad (d) = 2 + (d) = 2 \qquad (49)$$

with the decay rate = d () (). We conclude that algebraic large-velocity statistics extend to situations where the dissipation coecient is drawn from a given distribution.

We have studied inelastic gases within the fram ework of the M axwellm odel, a Boltzm ann equation with a uniform collision rate. We have shown that this kinetic theory is analytically tractable as closed evolution equations characterize the Fourier transform and consequently moments of the velocity distribution. In the freely evolving case, the system approaches a scaling regime, and the velocity distribution has an algebraic large velocity tail. The corresponding exponent varies continuously with the spatial dimension and the degree of dissipation. The decay exponents can be very large and therefore it may be di cult to distinguish a power law from a stretched exponential. In the driven case, we have determined the cum ulants of the velocity distribution.

The time dependent behavior displays a number of interesting features. Moments of the velocity distribution exhibit multiscaling asymptotic behavior, and know hedge of the typical velocity is insu cient to characterize all moments. The velocity autocorrelation decays algebraically with time, and the corresponding exponent depends on the restitution coeccient only.

In contrast with elastic collisions, stochastic inelastic collision processes are not e ective in mixing particle velocities. The stronger the inelasticity, the stronger the history dependence, i.e., memory of previous behavior. A dditionally, inelasticity can generate signi cant correlations between di erent velocity components. Such correlations do develop even in the forced case, where dissipation is balanced by energy input, and one may expect that M axwellian velocity distribution emerge.

The M axwellm odel is truly mean eld in nature with all aspects of the collision process being random. W hile it is not surprising that such a theory is solvable, the rich structure of the solution is som ewhat unexpected. For example, the exponent follows from a transcendental equation, and can not be obtained from heuristic arguments or dimensional analysis. Remarkably, even the leading asymptotic behavior in the large dimension lim it remains nontrivial as it involves roots of cubic or transcendental equations.

We have explored only the basic characteristics. C learly, one can study higher order velocity correlation m easures as well as higher order autocorrelations. Furtherm ore, the relaxation tow and the steady state appears analytically tractable. The straightforward analysis is cum bersom e and it may be useful to expand rst the solutions in term s of m ore natural building blocks, e.g., orthogonal polynom ials.

W e stress that the M axwellm odel is exact for stochastic inelastic collision processes with random collision partners and impact angles. It may be applicable in situations where an e ective stirring mechanism leads to perfect mixing. O therwise, it should be regarded as an uncontrolled approximation of the Boltzm ann equation. Indeed, existing theoretical and numerical studies give little evidence for algebraic tails characterizing inelastic gases. The only exception was observed in a system with random restitution coe cients drawn from a broad distribution. In one dimension, both molecular dynamics sim - ulation and direct integration of the Boltzm ann equation for inelastic hard spheres show that the velocity distribution has a power law tail [52].

In conclusion, our results, com bined with previous kinetic theory studies that nd exponential, stretched exponential, and G aussian tails, indicate that extrem al velocity characteristics can be sensitive to the details of the model, let alone parameters such as the restitution coe cient, and the dimension.

Finally, the second term in the third line vanishes, v(w) = 0, since the velocity u() of the random ly chosen collision partner is uncorrelated with v(w).
