K ondo screening in d-wave superconductors in a Zeem an eld and implications for STM spectra of Zn-doped cuprates

We consider the screening of an impurity moment in a d-wave superconductor under the in wence of a Zeem an magnetic eld. Using the Numerical Renormalization Group technique, we investigate the resulting pseudogap Kondo problem, in particular the eld-induced crossover behavior in the vicinity of the zero-eld boundary quantum phase transition. The impurity spectral function and the resulting changes in the local host density of states are calculated, giving species predictions for high-eld scanning tunneling microscopy measurements on impurity-doped cuprates.

I. INTRODUCTION

Impurity e ects provide valuable information about bulk properties of correlated electronic systems such as cuprate superconductors. Remarkably, non-magnetic impurities like Zn and Lican induce a localmoment on the neighboring lattice sites at intermediate energies 1,2,3,4,5. On the other hand, Zn is known to act as pair breaker and strong scatterer, e.g. in low-temperature transport measurements, and at present it is not clear whether this behavior arises from bare potential scattering only, or if other e ects like K ondo physics play a role.

Local impurity moments { arising either from magnetic impurities or induced by non-magnetic defects { interact with the low-energy bulk excitations. For cuprates at temperatures T below the superconducting $T_{\rm c}$, these are the fermionic quasiparticles of the d-wave superconductor and collective bosonic spin uctuations. The coupling to the spin uctuations mainly plays a role at intermediate energy scales of the order of the spin gap (an estimate is given by the position of the so-called resonance mode at 40 meV) { their election the impurity dynamics has been discussed recently in Ref. 6.

For sm aller energies, the dynam ics of the im purity moments is governed by the interaction with the ferm ionic Bogoliubov quasiparticles. Importantly, their singleparticle density of states (DOS) vanishes at the Fermi energy, therefore the physics is quite distinct from the usual K ondo e ect in metals7. Extensive studies of the pseudogap K ondo m odel8,9,10,11,12, where the host DOS follows a power-law near the Fermilevel, (!) (r = 1 for d-w ave superconductors), have shown the existence of a boundary quantum phase transition between a free m om ent and a screened m om ent as the K ondo coupling is increased. Applied to the cuprates, we have argued¹¹ that this can lead to a strongly doping-dependent K ondo tem perature, caused by the doping dependence of the size of the d-w ave gap. These theoretical ndings are consistent with NMR experiments3 measuring the local susceptibility near a non-magnetic impurity. This susceptibility has been found to show Curie-Weiss-like behavior, with a Weiss temperature being nite at optimal doping but apparently vanishing for underdoped sam ples

{ this implies the existence of unscreened moments in the underdoped regime down to temperatures of order 1 K.

Interesting impurity signatures have also been observed in recent scanning tunneling microscopy (STM) experim ents of the high temperature superconductor $B_{12}Sr_{2}CaCu_{2}O_{8+}$ (BSCCO)^{13,14}. Studies in the vicinity of Zn im purities on the Cu sites 13 have found a large peak in the di erential conductance at small energies of 1{2 m eV near the Zn site, with a characteristic spatial variation of the signal. This peak could represent a quasibound state in a potential scattering model 15,16,17, but such a state appears at low energies only for a range of large potential values depending upon microscopic details¹⁷. Recently, it has been proposed^{10,11} that som e of the properties of the Zn resonance can be explained by the Kondo spin dynamics of the magnetic moment induced by Zn. The screening of this moment by the Bogoliubov quasiparticles provides a natural low-energy scale (the K ondo tem perature) explaining the energetic location of the peak seen in STM { in this case the potential scattering model might still apply as an e ective m odel at low tem peratures. However, not all features of the Zn resonance can be understood within the existing m odels, and important ingredients in the theoretical description, e.g., the actual tunneling path of the electrons from the tip to the CuO_2 plane¹⁸, are not well known, calling for further experim ental clarication.

In this paper we study the screening of an impurity moment embedded in a d-wave superconductor in a Zeeman magnetic eld; we do neglect the changes in the quasiparticle spectrum due to the super ow induced by vortices which is appropriate for in-plane magnetic elds (parallel to the copper oxide layers) and for impurities located in between two vortices. In particular, we calculate the eld-dependent impurity spectral density { based on these results, we propose that STM tunneling experiments in high magnetic elds will be able to distinguish between the possible sources of the observed impurity STM signal, and thus contribute to clarify the nature of impurity scattering in cuprate superconductors.

II. M O D E L

We begin by describing our model H am iltonian, H = $H_{BCS} + H_{imp}$, for a superconductor with a single impurity. The rst term describes the host superconductor, which we model by a simple BCS H am iltonian

Here $_k=(c_{k\,"};c_{k\,\#}^{y})$ is a Nambu spinor at momentum $k=(k_x\,;k_y)$ in standard notation. $^{x\,;y\,;z}$ are Paulimatrices in particle-hole space, and is the chemical potential. For the kinetic energy, $^{u}_{k}$, we have rst (t), second (t⁰), and third (t⁰) neighbor hopping, while we assume a d-wave form for the BCS gap function $_k=(_{0}=2)(\cos k_x)$ cosk $_y$). The spin quantization axis lies in the direction of the (in-plane) Zeem an eld $h_{\rm bulk}$.

The G reen's function of the conduction electrons described by H_{BCS} is $G^0(k;!) = [! (!!_k)^z h_{bulk} k^x]^1$ in matrix notation. The in uence of a Zeem an magnetic eld on a d-wave BCS superconductor has been studied in Ref.19. For low temperatures and small elds, $h_{bulk} = 0$, the eld-induced change in the gap function k can be neglected. Thus the main elect of the Zeeman eld is to split the quasiparticle spectrum by h_{bulk} , which leads to a nite DOS at the Fermi level.

We will not consider the coupling of the external eld to the orbital motion of the electrons { the primary effect of the eld-induced super ow would be an additional shift in the quasiparticle spectrum. Neglecting this Dopplere ect is approximately justified for elds applied parallel to the CuO planes of the system: Due to the layered crystal structure and strong anisotropy, the orbital elect of the magnetic eld is much weaker for in-plane elds, and vortex elects are likely to be small¹⁹. Furthermore, we expect our approximation to apply also for elds in c-axis direction, i.e., perpendicular to the planes, for impurities located in between two vortices where the super ow tends to cancel and hence the Doppler shift is small.

The impurity, located at $r_0 = (0;0)$, is described by an elective model consisting of a scattering potential U and a K ondo term for the spin-1/2 impurity spin S:

where $s_R = N_s^{-1} \frac{P}{k \, k^0}$ $e^{i(k \, k^0)R} \, c_k^{\gamma} \, \frac{1}{2}$ c_{k^0} is the conduction band spin operator at site R. As discussed in Refs. 6,10,11 we will consider two cases: (i) a local magnetic moment where $N = fr_0g$, and (ii) a spatially extended magnetic moment (modelling Zn) where N is a set of sites in the neighborhood of r_0 ; guided by NMR experiments we take N to be the four neighbors of r_0 , i.e., $J_R = J$ for R $r_0 = (1;0)$; (0; 1) and $r_0 = 0$ otherwise. Note that this four-site model describes an induced moment uctuating as a single entity, in agreement




FIG. 1: Schem atic zero-tem perature phase diagram s for the asym m etric pseudogap K ondo model in a Zeem an eld, deduced from NRG.a) Local eld $h_{\rm loc}$ only, i.e., for $h_{\rm bulk}=0$. There is a line of continuous phase transitions at nite elds, term inating in the multicritical point at $J=J_{\rm c},\,h_{\rm loc}=0$. (The phases LM , ASC , and POL are explained in the text.) b) Uniform eld $h=h_{\rm loc}=h_{\rm bulk}$. Here, the asym ptotic low-T , low-frequency behavior at nite elds is always that of a conventional K ondo-screened spin in a magnetic eld (SCR phase), but there is a sharp crossover separating regions which are dominated by ASC and POL behavior at nite energies.

with spin relaxation experiments⁵. The Kondo term in the four-site case de nes a multichannel Kondo problem; however, the low-energy physics in the present situation is dominated by a single channel given by the d-wave-like linear combination of the conduction electrons on the four neighboring sites^{10,11}.

The potential scattering term in (2) can be accounted for exactly:

The K ondo problem we consider in the following is then de ned by the spin-dependent DOS seen by the impurity. For a single-site impurity we have

which behaves as $_{\rm e}$; (!) j! 3 at $h_{\rm bulk}=0$. Here, $'_{\rm R}=+[$]1 for R $_{\rm F}=($ 1;0)[(0; 1)] describe the d-wave channel of the four-site in purity, G is the G reen's function (3) in Nambu notation, and ${\rm sgn}()=1$ for = ";#.

III. BOUNDARY CRITICAL POINTS AND CROSSOVER BEHAVIOR

In the following, we describe our numerical results for the above K ondo model in an external eld, obtained




FIG. 2: NRG results for the local impurity magnetization m $_{\rm loc}$ = hS $^{\rm z}$ i, calculated for a four-site impurity in a cuprate band structure (t = 0.15 eV , t $^{\rm 0}$ = t=4, t $^{\rm 00}$ = t=12, $_{\rm 0}$ = 0.04 eV , = 0.14 eV) with J $_{\rm c}$ 0.23 eV for U = 0.22, as a function of the applied eld. a) Local eld h $_{\rm loc}$ only, for a J > J $_{\rm c}$ with T = 5 K . At the phase transition the magnetization follows a power law, jm $_{\rm loc}$ m $_{\rm loc;c}$ j jh $_{\rm loc}$ h $_{\rm loc;c}$ j, with 0.1. b) Uniform eld h = h $_{\rm loc}$ = h $_{\rm bulk}$, for a J > J $_{\rm c}$ with T = 25 K . Here, the magnetization evolves smoothly through the crossover region of Fig. 1b. The lower gures show zoom s of the upper ones.

with Wilson's Numerical Renormalization Group (NRG) technique $^{\!20}$. The zero-eld pseudogap Kondo problem in the presence of particle-hole asymmetry is known to show a boundary quantum phase transition between an asymmetric strong-coupling (ASC) phase with a screened impurity moment and a local moment (LM) phase with Curie behavior of the impurity susceptibility $^{\!9,11}$.

We start by considering the case of a local eld only, $h_{loc} \in 0$ but $h_{bulk} = 0$, such that the host DOS is unaffected by the eld. From the analysis of the xed points of the NRG calculation we have found that even in a nite local eld there is still a phase transition upon varying the K ondo coupling. The T = 0 phase diagram deduced from NRG is schematically shown in Fig. 1a { there is a line of nite-eld transitions ending in the zero-eld transition point known from earlier work^{9,11} which can be viewed as a multicritical point. The three stable phases are easily understood: The ASC phase at $J > J_c$ extends to nite eld (with weak spin polarization for $h_{loc} \in 0$), whereas the LM phase at $J < J_c$ with a free impurity spin exists at zero eld only. Applying a eld at J < Jc im m ediately leads to a phase with strong polarization of the impurity spin, therefore we term this phase POL.

All transitions found are continuous phase transitions, characterized by a smallenergy scale T , which vanishes at the transition, and de nes the crossover energy above which quantum -criticalbehavior is observed. In the ASC phase at zero eld, T (J_i h=0) can be identified with the K ondo temperature 11, i.e., with the binding energy of the K ondo singlet. The transition from ASC to POL is characterized by breaking this singlet by the external eld { consequently the critical eld $h_{\rm loc;c}$ close to the multi-

critical point is given by T (J;h=0) times a prefactor depending on the DOS exponent r. Note that this novel eld-induced K ondo transition is unique to the pseudogap model studied here { in the metallic host case (r=0) the application of a eld leads only to a gradual suppression of the K ondo e ect²¹.

From the above discussion we expect that a uniform Zeem an eld $h_{bulk} = h_{loc} = h$ rem oves the critical point, because a nite h_{bulk} leads to a nite DOS at the Ferm i level. Our num erical calculations show that this is indeed the case { for any nite h the asymptotic zero-tem perature behavior is that of a conventional (i.e. m etallic-host) K ondo-screened spin in a magnetic eld. However, the characteristic energy scale below which this behavior occurs is tiny, as it is exponentially small in the eld-induced DOS at the Ferm i level. (The same applies to e ects arising from the small low-energy DOS induced by a nite concentration of impurities, i.e., the so-called im purity band^{11} .) Therefore, at practically accessible tem peratures the nite-eld behavior is determined by the physics of the POL and ASC phases described above, and both regim es are now separated by a sharp crossover, Fig. 1b. This crossover eld turns out to be som ew hat smaller than the critical local eld in Fig. 1a; their ratio depends on the eld-induced DOS at the Fermilevel (i.e. the DOS exponent r).

The properties of the phases are rejected in the edinduced in purity magnetization, Fig. 2. This quantity is nite for any non-zero eld, but shows a power-law singularity at the transition in the localed case (Fig. 2a). Note that the behavior of m $_{\rm loc}$ near the transition is not universalbut depends on J { the reason is that the niteeld transitions actually represent a line of critical xed points in the RG sense. In the uniform – eld case, Fig. 2b, the singularity in m $_{\rm loc}$ is replaced by a relatively sharp crossover.

IV. IM PURITY T M ATRIX AND STM

Turning to the dynam ic properties of the K ondo in purity, we now discuss the conduction electron T m atrix, T (!), which is the in portant input quantity for the calculation of the localD O S m easured by STM. The T m atrix spectral density, T (!) = Im T (!) = , in zero external eld has been studied in Ref. 11 using NRG. It was found that T (!) j! j' in the stable LM and A SC phases. The critical point at J_c is characterized by T (!) j! j' (for T 1) 1,12. The crossover from quantum-critical j! j' behavior at high energies to j! j behavior at low energies leads to a characteristic peak in the spectral density on one (!) side of the Ferm i level at an energy T (J; h = 0), which can be viewed as K ondo peak (note that the problem at hand is intrinsically particle-hole asymmetric).

For nite eld, the spin degeneracy is lifted: applying a small eld to the system with $J>J_{\rm c}$ splits the Kondo peak, in a manner roughly similar to the eld-induced peak splitting in the conventional (metallic) Kondo effects



fect²¹. For $h_{bulk} = 0$ the low-frequency lim it of $_T$ (!) still behaves as j! f; of course, nite h_{bulk} will lead to a nite value of T (! = 0). The simple peak-splitting picture is modied when the eld becomes comparable to the zero-eld peak energy, i.e., close to the transition/crossover lines in Fig. 1. In the case of a purely local eld, we observe that the spectral peak for one spin direction approaches the Ferm i level and becom es sharper as hocic j is decreased; it diverges at the phase transition as j! j r, whereas the spectrum for the opposite spin broadens and remains non-critical. For a uniform eld, this e ect is again smeared out: in the crossover region of Fig. 1b the spectral function shows a peak with a nite, small width at the Ferm i level, see Fig. 3. Rem arkably, the weight of the K ondo peak (in set of Fig. 3) stays nearly constant at small elds (ASC regime), but rapidly decreases (POL regine) once the crossover region is passed.

Applying a eld to a system with J < J_c in mediately suppresses the spectral function for one spin species whereas the other one shows a smaller peak which moves away from the Fermileveland gradually looses intensity { so there are no drastice ects as suggested by the phase diagram.




FIG. 4: Field evolution of the tunneling DOS for the four-site K ondo impurity, measured on the impurity site, without taking into account a possible liter e ect¹⁸. The host paramaters are as in Fig. 2, the K ondo coupling is chosen to yield a zero-eld peak at 1.4~meV (T = 15 K), the potential scattering is U = 0. The results have been broadened corresponding to a measurement temperature of 4.5~K; the dashed line shows the bulk DOS. (The external eld B is related to h by h = g B = 2.)

Using the T matrix from the NRG method 23 it is straightforward to determ ine the local conduction electron DOS 11 as measured by STM . Fig. 4 shows a set of calculated on-site tunneling spectra for a four-site impurity in a cuprate band structure, which is supposed to describe the moment induced by a Zn impurity in BSCCO . For a zero-eld peak position of $1.4\,\mathrm{m}$ eV , the crossover region of Fig. 1b is reached at an in-plane eld of approximately 20 T . For larger elds, the peak moves to positive bias and looses intensity similar to the inset of Fig. 3. The spatial intensity pattern of the signal is nearly eld-independent; it is alternating from site to site, i.e.,

the nearest neighbor of the impurity has a very small intensity, whereas the second neighbor has again higher intensity 10,11,15 . Fig. 4 shows results for zero potential scattering U , we note that no qualitative modi cations occur for small and moderate U values up to the hopping energy t, see also Ref. 11.

V. CONCLUSIONS

Sum marizing, we have studied the e ect of a Zeem an eld on the Kondo screening of impurity moments embedded in a host with a pseudogap density of states. The application of a local magnetic eld leads to a novel eld-induced boundary phase transition, associated with breaking up the K ondo singlet { this transition has characteristic signatures in the local magnetization and the im purity spectral function. In the context of Zn im purities in cuprate d-wave superconductors we predict a characteristic evolution of the impurity STM spectrum with applied eld which can be tested in future experiments. The spectra in Fig. 4 can be contrasted to the results for a pure potential scattering model²⁴, where the scattering peak is simply split by the Zeem an energy, but is not modied in its total weight { therefore these experim ents will help to clarify the general role played by non-magnetic impurities in cuprates.
