Variational Perturbation Theory for Markov Processes

We develop a convergent variational perturbation theory for conditional probability densities of Markov processes. The power of the theory is illustrated by applying it to the di usion of a particle in an anharm onic potential.

I. INTRODUCTION

Variational perturbation theory [1] transforms divergent perturbation expansions into convergent ones with the convergence extending to in nitely strong couplings. The theory has been developed for the path integral representation of the free energy and the density matrix in quantum statistics, and has been tested for many systems, in particular the anharm onic oscillator and the hydrogen atom without and with a homogeneous magnetic eld [1, 2, 3, 4, 5, 6, 7]. The procedure is based on approximating a potential by a local trial oscillator whose frequency is optimized order by order for each set of external end points. Recently, variational perturbation theory has also been successfully extended to statistical eld theory to calculate highly accurate critical properties of second-order phase transitions [8].

In this paper we develop a similarly convergent variational perturbation theory for the path integral representation of the conditional probability density of M arkov processes. In close analogy with the previous method we approximate a given stochastic process by a trial B rownian motion with a linear drift coecient, and optimize the damping constant. We illustrate the procedure by calculating the time dependence of the conditional probability density for a nonlinear stochastic model. After some introductory remarks on Markov processes in Section II, the path integral for the conditional probability density is treated perturbatively in Section III, and evaluated variationally in Section IV.

II. M ARKOV PROCESSES

We start by sum marizing the basic properties of Markov processes [9, 10, 11, 12] needed in the sequel.

A. Fokker-Planck Equation

A M arkov process for a single stochastic variable x is characterized by the conditional probability density P $(x_b t_b \dot{x}_a t_a)$ that the event x_b is realized at the time t_b once the event x_a has taken place at time t_a . It has the initial condition

and obeys, for additive noise, the Fokker-P lanck equation

with the Fokker-Planck operator

where K (x) and D denote the drift and di usion coe cient, respectively. An important example is provided by the overdamped motion of a Brownian particle with mass M and friction constant in an external potential V (x). In this case, the drift coe cient reads

and the di usion coe cient is proportional to the temperature T via E instein's relation

Since the spatial derivatives in the Fokker-P lanck equation (2), (3) are all on the left-hand side, they guarantee the probability conservation

such that the normalization integral, which is unity at the initial time $t_b = t_a$ due to (1), remains so for all times:

In the long-time $\lim_{x \to a} t_0 t_0 = 1$, the conditional probability density $P(x_0, t_0, x_0) = 1$, becomes stationary

where $P_{st}(x_b)$ denotes the time-independent solution of the Fokker-Planck equation (2), denoted by

By applying the Fokker-Planck operator (3), we verify this solution is

where the normalization constant N follows from (7) and (8)

B. Path Integral

The solution of the Fokker-P lanck initial value problem (1) { (3) has the path integral representation

with the generalized Onsager-Machlup functional

where all paths x (t) contribute which connect the spacetime points $(x_a;t_a)$ and $(x_b;t_b)$. The extra term in (13) is needed since the path integral (12), (13) is by de nition symmetrically ordered in the product of \underline{x} (t) and K (x (t)), corresponding to a midpoint discretization [1]:

Making use of the stationary solution (10), the path integral (12), (13) can be factorized as

This coincides with the quantum -statistical imaginary-time evolution amplitude [1]

To the path integral (17), we can apply directly the known variational perturbation theory [1], which will lead us in the present context to a solution of the Fokker-P lanck initial value problem (1) { (3).

C. Brownian Motion

A solvable trial path integral is provided by the Brownian motion with a linear drift coe cient

The conditional probability density factorizes therefore according to (15) as

It describes a quantum -statistical harm onic oscillator with the potential $U(x) = M^2x^2=2$. Inserting the imaginary-time evolution amplitude of the harm onic oscillator [13] and taking into account the identication (18), we obtain

The resulting conditional probability density of the Brownian motion (20) follows from (22), (24) and leads to the well-known Gaussian distribution

It can easily be veri ed that the conditional probability density (25) { (27) satis es the initial condition (1), and obeys the Fokker-Planck equation associated with the drift coe cient (20):

In general the drift coe cient K (x) of a M arkov process is a nonlinear function in x, and the corresponding conditional probability density P ($x_b t_b j_k a_k$) cannot be calculated exactly. We must then resort to approximation methods, and we want to show in this paper that variational perturbation theory is a very e cient one. For this we rst need an ordinary perturbation expansion which will be derived in the next section for a typical example.

III. PERTURBATION THEORY

Consider the nonlinear drift coe cient

$$K(x) = x qx^3 (29)$$

with a coupling constant g. Such a stochastic model is useful, for instance, to describe the statistical properties of laser light near the threshold in semiclassical laser theory [12, 14]. In this case, the stochastic variable x is identified with the electric eld. The parameter is proportional to the difference between the pump parameter and its threshold value threshold value threshold usion constant g describes the interaction between light and matter within the dipole approximation, and the diffusion constant D characterizes the spontaneous emission of radiation. For such a stochastic process, the stationary solution (10), (11) reads

where K (z) denotes a modi ed Bessel function [15]. The path integral for the conditional probability density corresponding to (12), (13) reads:

For zero coupling constant g, we obtain the conditional probability density (23) of the Brownian motion (20). Expanding the exponential in powers of g, we not the rst-order approximation

We evaluate harm onic expectation values of polynom ials in x arising from the generating functional (37) according to a slight generalization of the standard W ick theorem [16,17]. The generalization is required by the presence of the linear term in (37). The evaluation is most economically done in a recursive procedure which we illustrate with the harm onic expectation value

- (i) Contracting $x(_1)$ with $x^{n-1}(_1)$ and $x^m(_2)$ leads to a Green function $G(_1;_1)$ and $G(_1;_2)$ with multiplicity n-1 and m, respectively. The rest of the factors remains inside the expectation symbol, leading to $hx^{n-2}(_1)x^m(_2)i$ and $hx^{n-1}(_1)x^{m-1}(_2)i$.
- (ii) If n > 1, we extract one x(1) from the expectation value giving $x_{cl}(1)$ multiplied by $hx^{n-1}(1)x^m$ (2)i.
- (iii) Add the terms (i) and (ii).
- (iv) Repeat the previous steps until only products of expectation values hx (1) i = $x_{cl}(1)$ remain.

W ith the help of this recursive procedure, the rst-order harm onic expectation value hx 4 (1)i is reduced to

Inserting the harm onic expectation values (43) and (44) into the perturbation expansion (34) leads to the rst-order diagram s

Evaluating the diagram s, the conditional probability density for the drift coe cient (29) following from (32) and (48) becomes to the rst order in the coupling constant g




FIG. 1: Temporal behavior of the expansion coe cients (50) of the conditional probability density (49) as a function of t_a (t_b t_a) for t_b t_a (for t_b t_a) for t_b t_a (t_b t_a) for t_a t_a

where the expansion coe cients $c_{ij}^{(1)}$ () are the following functions of the dimensionless variable = $(t_b t_a)$ (see Fig. 1):

It is easy to verify that the conditional probability density (49) { (50)

(i) obeys the corresponding Fokker-Planck equation following from (2), (3) and (29)

with the initial condition (1), because of

- (ii) is normalized according to (7) for all times to.
- (iii) approaches the stationary solution (30) in the long-time lim it (8).

All these properties of P (x_b, t_b, x_a, t_a) are satisfied to instruction of the coupling constant g. As such the perturbative result (49) { (50) is only applicable for small values of the coupling constant g. This limitation is removed by a variational evaluation which enables us to indicate approximate conditional probability density for all values of the coupling constant g.

IV. VARIATIONAL PERTURBATION THEORY

Variational perturbation theory in quantum statistics approxim ates a given potential by adding and subtracting a local trial harm onic oscillator whose frequency is then system atically optim ized [1]. Here we transfer this procedure to M arkov processes and modify the nonlinear drift coe cient (29) by adding and subtracting a trial B rownian motion with a yet unknown damping constant K:

A first this, we treat the combined second term as being small of the order of the coupling constant g. The result is obtained most simply by replacing the damping constant in the original drift coe cient (29) according to the substitution rule (compare with Chap. 5 in Ref. [1])

where we have introduced the abbreviation

W riting the conditional probability density (49) as

we apply the substitution rule (54) to the cumulant expansion $W(x_b t_b; x_a t_a)$, and reexpand up to the rst order in the coupling constant g. A flerwards the abbreviation r is reexpressed in terms of and K via (55). This leads to

and the rst-order expansion coe cients (50) are functions of the dimensionless variable = K (t_b t_a). Note that using (50) in (57) necessitates to substitute by K.

We now remove the dependence of the cumulant expansion (57) from the articially introduced trial damping constant K. A coording to the principle of minimal sensitivity [18], we minimize its in uence on W $^{(1)}$ ($x_b t_b j_k a_t j_k a_$

It may happen that this equation is not solvable within a certain region of the parameters $x_b; t_b; x_a; t_a$. In this case we look for turning points instead in accordance with the principle of minimal sensitivity [1, 17], i.e. we determine the variational parameter K ⁽¹⁾ $(x_b t_b; x_a t_a)$ from solving

The solution K $^{(1)}$ (x_b t_b ; x_a t_a) from (59) or (60) yields the variational result

for the conditional probability density. Note that variational perturbation theory does not preserve the normalization of the conditional probability density. Although the perturbative result (49) { (50) is still normalized in the usual sense (7) to rst order in the coupling constant g, this normalization is spoilt by choosing an x_b -dependent damping constant K ⁽¹⁾ ($x_b t_b; x_a t_a$). Thus we have to normalize the variational conditional probability density according to (61) at the end (compare the similar situation for the variational ground-state wave function in Refs. [17, 19]).




FIG. 2: Conditional probability density P $(x_b t_b j_x a_t a_t)$ below the laser threshold at = 1, D = 1, and $x_a = t_a = 0$. For the coupling constants g = 0.1 in a) and g = 10 in b) the distribution is shown for the times $t_b = 0.05; 0.1; 0.2; 0.5; 1$ from the top to the bottom at the origin, respectively.




FIG. 3: Conditional probability density P $(x_b t_b; x_a t_a)$ above the laser threshold at = 1, D = 1, and $x_a = t_a = 0$. For the coupling constants g = 0.1 in a) and g = 10 in b) the distribution is shown for the times $t_b = 0.1;0.2;0.5;1;1.5;2;3;4$ and $t_b = 0.05;0.1;0.2;0.5$ from the top to the bottom at the origin, respectively.

We have applied variational perturbation theory to analyze the nonlinear stochastic model (29) with $D=1; x_a=t_a=0$ below and above the laser threshold, i.e. =1 and =-1, for small and strong coupling g=0:1 and g=10.T he results for the conditional probability density $P(x_bt_ajk_at_a)$ are plotted in Figs. 2 and 3.0 n the scale of the gures, they show no signicant deviation from numerical solutions of the corresponding Fokker-Planck equation, some minor deviations only occur above the laser threshold =-1 for g=0:1 [20]. Both gures illustrate how the densities, originally peaked at the origin, turn into their stationary solutions in the long-time limit. The stationary solution reveals below the threshold one extrem um in Fig. 2, whereas above the laser threshold in Fig. 3 two extrem a occur.

V. CONCLUSION

We have presented the lowest-order variational calculation for the conditional probability density of the nonlinear drift coe cient (29). By going to higher orders in variational perturbation theory, it is straightforward to increase system atically the accuracy to any desired degree [1].

Note Added in Proof

M eantime we became aware of the alternative approach [21] to variationally analyze the nonlinear model (29). Above the laser threshold = 1, that method yields for all times t_b a unique solution of the extremal condition corresponding to (59). However, the resulting conditional probability density shows for larger times t_b signicant deviations from our and from numerical solutions of the Fokker-P lanck equation.
