## A natom y of Spin-Transfer Torque

Spin-transfer torques occur in m agnetic heterostructures because the transverse com ponent of a spin current that ows from a non-m agnet into a ferrom agnet is absorbed at the interface. We demonstrate this fact explicitly using free electron m odels and rst principles electronic structure calculations for real m aterial interfaces. Three distinct processes contribute to the absorption: (1) spin-dependent re ection and transm ission; (2) rotation of re ected and transm itted spins; and (3) spatial processes reduce the transverse com ponent of the transm itted and re ected spin currents to nearly zero for m ost systems of interest. Therefore, to a good approximation, the torque on the m agnetization is proportional to the transverse piece of the incom ing spin current.

### I. IN TRODUCTION

W hen a current of polarized electrons enters a ferrom agnet, there is generally a transfer of angular m on entum between the propagating electrons and the magnetization of the lm. This concept of \spin transfer" was proposed independently by Slonczew ski<sup>1</sup> and Berger<sup>2</sup> in 1996. Experiments soon followed where anomalies in the current-voltage characteristics of magnetic heterostructures were interpreted as evidence for spin transfer.<sup>3</sup> U nam biguous con m ation came when the phenomenon of giant magnetoresistance<sup>4</sup> was used to detect magnetization reversal in ferrom agnetic multilayers with large current densities owing perpendicular to the plane of the layers.<sup>5,6,7</sup> Subsequently, spin transfer has been in plicated to explain the observation of spin precession for high-energy, spin-polarized electrons that traverse a magnetic thin lm<sup>8</sup> and enhanced G ilbert damping in magnetic multilayers compared to one-component magnetic lm s.<sup>9</sup> M ore experiments may be expected in the future because spin transfer is expected to play an important role

in the nascent eld of \spin electronics". $^{10}$ 

Theoretical work on spin transfer generally falls into one of three categories. One group of articles focuses on deriving and solving classical equations of motion for the magnetization.<sup>11,12,13,14,15,16</sup> These studies generalize the Landau-Lifshitz equation to take account of spin currents, spin accumulation,<sup>17</sup> and the mechanical torques which necessarily accompany (spin) angular momentum transfer. A second group of articles generalizes charge transport theory to take account of spin currents and spin relaxation.<sup>18,19,20,21,22</sup> These theories compute the spin-transfer torques that serve as input to the magnetization calculations. The torque can be computed phenom enologically, or from the Boltzmann, K ubo or Landauer form alisms that incorporate quantum mechanical information explicitly. F inally, there are articles that report quantum mechanical calculations of the parameters that serve as input to the transport theories. The model studies of S lonczew ski<sup>1</sup> and Berger<sup>2</sup> are of this sort, as are the rst-principles, electronic structure calculations of X ia and co-workers.<sup>23</sup>

In a previous paper,<sup>22</sup> the present authors used a 2 2 m atrix Boltzm ann equation to compute spin currents, spin accum ulation, m agnetoresistance, and spin-transfer torques in a Co/Cu/Comultilayer with non-collinear m agnetization. The physics of spin transfer entered this sem i-classical, kinetic theory calculation through quantum m echanically derived m atching conditions in posed at each ferrom agnet/non-m agnet interface. Speci cally, we took account of a rejection mechanism<sup>1</sup> that arises because the interface rejection and transm ission amplitudes for polarized electrons are spin dependent. We also took account of an averaging mechanism<sup>2</sup> that arises because conduction electron spins precess around the magnetization vector in each ferrom agnet. The present work was motivated originally by two assumptions we made to simplify the Co/Cu/Co calculations. First, we set to zero the transverse component of the spin of the conduction electron ensemble in each ferrom agnet. Second, we disregarded the phase of the rejection and transm ission amplitudes. As best we can determ ine, the sam e assumptions are implicit in the Landauer-type model calculations reported in Ref. 19 and Ref. 20. Therefore, before calculations of this sort are carried very much further, it seem ed appropriate to bok more carefully into the correctness of these assumptions. As we will the spin transfer process is more subtle and complex than previously managed.

In this paper, we analyze quantum mechanically the fate of a polarized current that enters a ferrom agnet from a metallic non-magnet. Using both the free electron model and rst principles electronic structure calculations, we conclude that the assumptions in question are largely justimed. An important point is that the spin of an electron generally rotates when it is rejected or transmitted at an interface. This separates the rejection mechanism into two

pieces. A spin-liter e ect reduces the transverse spin component of each electron individually. A further reduction occurs when we sum over all Ferm i surface electrons because substantial phase cancellation occurs when the distribution of spin rotation angles is broad. As for the mechanism we called \averaging" in Ref.<sup>22</sup>, cancellation occurs because electrons have di erent precession frequencies. This leads to an asymptotic, oscillatory, power-law (rather than exponential) decay of the transmitted transverse spin component. Putting everything together, we nd that (except in very exceptional cases) the transverse spin current is almost completely absorbed within a few lattice constants of the interface. N one, or very little, is rejected or transmitted. As a result, the spin-transfer torque is very nearly proportional to the transverse piece of the incident spin current.

The plan of this paper is as follows. In Section II, we de ne the basic variables of spin transport and establish our notation. Section III analyzes the spin current and spin-transfer torque near a magnetic/non-magnetic interface using a free electron model for both materials. Section IV generalizes the analysis of Section III to the case of real materials. We sum marize our results in Section V.

## II. BACKGROUND

To help introduce the theory of spin transport, it is useful rst to set down the familiar equations of particle transport. These involve the number density,

where  $\hat{v} = (ih=m)r$  is the velocity operator and i; (r) is an occupied single particle wave function with state index i and spin index. The continuity equation,

expresses the conservation of particle num ber. In this paper, we will be interested exclusively in steady-state situations where the time derivative in (3) is zero. Not far from equilibrium, the current takes the phenom enological form,

where n = n  $n_{eq}$  is the deviation of the number density from its equilibrium value, E is an electric eld, is the conductivity, and D is a di usion constant. The latter two are second rank tensors in the general case.

For the spin degree of freedom, the analogs to (1) and (2) are the spin density,

where s = (h=2) and is a vector whose C artesian components are the three P aulim atrices. The spin current is a tensor quantity. The left index of Q<sub>ij</sub>(r) is in spin space and the right index is in real space. Spin is not conserved so the analog of (3) generally has non-zero term s on the right hand side. For our problem,

where  $n_{ext}$  is an external torque density,  $r = Q = Q_{ik}$  and  $m = (jn j m_{eq})m$  is the so-called spin accumulation.<sup>17</sup> The rst term on the right side of (7) accounts for the transfer of angular momentum between the spin current and the lattice due to spin-ip. This process, with relaxation time  $m_{\#}$ , changes the magnitude of the local spin density,

but not its direction. The second term on the right side of (7) describes all external torques that act to change the direction of the local magnetization For example, the Landau-Lifshitz-G ilbert torque density,

includes an elective eld B  $_{\rm e}$  and phenom enological dam ping. The elective eld is due to exchange, anisotropies, and any external elds that might be present.

To study magnetization dynamics, we merely rearrange (7) to

is the current-induced contribution to the torque density. The divergence theorem then shows that, apart from spinip, the torque on the totalm agnetization in a volume V arises from the net ux of spin current into and out of the

surface S that bounds V. Phenom enologically, the spin current is driven by drift and di usion:

As in (4), we assume the simplest form for the spin transport coe cients. That is, we use the vector  $p = (m_{\#}) m$  rather than a third rank tensor and the scalar D p rather than a fourth rank tensor. The conductivities  $m_{\#}$  and  $m_{\#}$  refer to majority and m inority electrons, respectively.

In a non-m agnet, " = # and a spin current arises only if there are regions of the m etal where there is a gradient in the spin accumulation, m (r). This implies that the spin density m (r) and the spin current density Q (r) are only indirectly related to each other. They need not be collinear and are generally not proportional. In a ferrom agnet, an electric eld produces a current of polarized spins simply because " $\notin$  #. This spin current is modiled by gradients in spin accumulation also. However, the second term on the right side of (11) is valid (at most) when the direction of the ferrom agnetic m agnetization is uniform in space. Corrections are necessary when the m agnetization rotates continuously in space, e.g., inside a dom ain wall.<sup>11</sup>




FIG.1: Three states of spin current scatter from an interface. The current ows from left-to-right, from the non-m agnet into the ferrom agnet.  $Q_{xx}$  is longitudinal (parallel) to the m agnetization M .  $Q_{xx}$  and  $Q_{yx}$  are transverse to M . Only  $Q_{zx}$  can be non-zero in the bulk of the m agnet. The transverse spin currents are absorbed in the interfacial region.

W ith this background, the remainder of this paper is devoted to a detailed analysis of the fate of a spin polarized current that ows from a metallic non-magnet into a metallic, single-domain ferromagnet through an ideal, at interface. Speci cally, we point the particle current density vector j along positive x, we point the ferrom agnetic magnetization vector M along positive z, and we x the interface at x = 0. Figure 1 shows three possible steady states of pure current polarization in the non-magnet and the associated non-zero component of the spin current density tensor. For each case, we let only one component of  $Q_{-x}$  be non-zero.  $Q_{zx} \notin 0$  corresponds to longitudinal (parallel to M) current polarization.  $Q_{xx} \notin 0$  or  $Q_{yx} \notin 0$  correspond to transverse (perpendicular to M) current polarized current in the non-magnet, it is su cient that the current ow into the non-magnet from an adjacent ferrom agnet and that the thickness of the non-magnet be small compared to the non-magnet spin- ip di usion length.<sup>17</sup> For this reason, magnetic multilayer structures are the rule in most spin-transfer experiments. We refer the reader to R ef. 22 for som e insight into the polarization process for the Co/Cu/Co system.




FIG.2: Interfacial pillox used as the integration volum e when the divergence theorem is applied to (3) and (10) to derive (12) and (13).

Figure 1 also indicates that, of the three incident states of pure current polarization shown, only  $Q_{zx}$  transm its into the bulk of the ferrom agnet. The magnet absorbs the transverse components. Furtherm ore (see below), alm ost none of the transverse spin current rejects from the interface. Therefore, if we choose a rectangular pillbox that just straddles the interface, the divergence theorem discussion below (10) in plies that a current-induced spin-transfer torque is exerted on the interfacialm agnetization. To be more precise, Figure 2 illustrates such a pillbox and incident, rejected, and transmitted charge current density vectors. Integrating the steady state (\_= 0) version of the continuity equation (3) over the pillbox gives

where A is the area of the interface. Eq. (12) says that the incoming  $ux j^{in}$  At minus the outgoing  $ux j^{tr}$  At +  $j^{ref}$  (At) equals zero. The rejected ux has a minus sign relative to the transmitted ux because it passes through the opposing face of the pilbox.

Ignoring spin ip, the same integration applied to (10) yields

where Q<sup>in</sup>, Q<sup>ref</sup>, and Q<sup>tr</sup> are the spin current density (6) computed using incident state, rejected state, and transmitted state wave functions. Eq. (13) says that the incoming spin ux Q<sup>in</sup> At minus the outgoing spin ux Q<sup>tr</sup> At + Q<sup>ref</sup> (At) equals the torque on the magnetization inside the pillbox.<sup>24</sup> The torque N<sub>c</sub> is a vector in spin space because we have contracted the space index of the spin current density with the space vector  $\pounds$ . The approximate form on the right of Eq. (13) says that the torque is proportional to the tranverse part of Q<sub>in</sub>. That is the main message of this paper. The following sections are devoted to a demonstration that the tranverse transmitted and rejected spin currents do indeed disappear in the immediate vicinity of the interface.

### III. FREE ELECTRONS

In this section, we compute the spin current near the interface of a non-m agnet and a ferrom agnet assuming that a free electron description is adequate for the conduction electrons in the non-m agnet and also for both the majority and m inority conduction electrons in the ferrom agnet. We do this in the interest of analytic sim plicity and also because som e authors<sup>13,15</sup> believe this is a fair representation of reality for the purposes of transport calculations.

We rst work out the problem of one electron scattering from a planar interface to determ ine the am plitudes for rejection and transmission. They turn out to be spin dependent. As rst shown by Slonczewski,<sup>1</sup> this fact alone generates a \spin-lter" torque because the wave function for an incident electron with a non-zero component of spin transverse to M can always be re-expressed in terms of up and down spin components.

The actual current polarization in the metal is obtained by summing over the full distribution of conduction electrons. This introduces two electrons. The rst arises because the relectron amplitude for free electron interface scattering is complex. This means that the spin of an incoming electron rotates upon relection. The cancellation which occurs when we sum over all these spin vectors reduces the net transverse spin current because relection and

transm ission both contribute to the outgoing ux from the interface region. A second e ect arises because up and down spin electrons on the Ferm i surface with the same wave vector in the non-magnet no longer have the same wave vector when they transm it into the ferrom agnet. The two states are coherent, so precession in space (rather than time) occurs. The precession frequency is di erent for electrons from di erent portions of the Ferm i surface. Therefore, when we sum over all conduction electrons, alm ost complete cancellation of the transverse spin occurs after propagation into the ferrom agnet by a few lattice constants.

#### A. Spin currents for a single electron

Let us choose the spin quantization axis to be parallel to the magnetization of the ferrom agnet. Then, in the non-magnet, the wave function for an electron whose spin points in an arbitrary direction can always be written as a linear combination of spin up and spin down components. Speci cally,

represents a free electron propagating toward the interface in Figure 1 with its spin pointed in the direction (;) with respect to M. We are interested in conduction electrons so the wave vector  $\mathbf{k} = (\mathbf{k}_x; q)$  satis es  $hk^2 = 2m = E_F$ . The spatial variable is r = (x; R). As the notation indicates, (14) is the incident state for a scattering problem that determ ines the wave function for the entire system. The latter describes a steady-state situation like current ow.<sup>25</sup> Like the incident state (14), the complete scattering state can also be written as a linear combination of spin up and spin down components:

where  $R_*$ ,  $R_{\#}$ ,  $T_*$ , and  $T_{\#}$  are the rejection and transmission amplitudes for up and down spin electrons. These amplitudes do not depend on the angles and . Notice that the up and down spin components do not propagate with the same wave vector for x > 0. The wave vectors dier because their kinetic energy depends on the exchange potential energy in the ferrom agnet. The common factor of exp (iq R) in (16) reminds us that scattering from a at interface conserves the wave vector component parallel to the interface.

The transm ission and re ection amplitudes are determ ined by the magnitude of the potential step at the interface. For a constant e ective mass, this step height is parameterized by  $k_F; k_F^{"}$ , and  $k_F^{\#} < k_F^{"}$ , the Ferm i wave vectors for, respectively, electrons in the non-magnet, majority electrons in the ferrom agnet, and minority electrons in the ferrom agnet. The usual quantum mechanical matching conditions yield the real transmission amplitudes




FIG. 3: Slices through a set of free electron Ferm isurfaces. The two middle panels show the Ferm isurface for the non-magnet and the superim posed Ferm isurfaces of the majority (dashed) and minority (solid) states of the ferrom agnet. The panel just above the magnetic Ferm isurfaces is the probability for transmission into the ferrom agnet for majority (dashed) and minority (solid) electrons. The panel just below the non-magnetic Ferm isurface is the probability for rejection back into the non-magnet for majority (dashed) and minority (solid) electrons. The bottom panel shows the phase in (24) acquired by an electron because its spin rotates upon rejection. The top panel shows the wave vector difference (25) for a transmitted electron.

satisfy R + T = 1 and are plotted in Figure 3 for a slice through the free electron Ferm i surfaces de ned by  $k_F^{"}=k_F = 1.5$  and  $k_F^{\#}=k_F = 0.5$ . For this case, the transmission probability for majority electrons (dashed curve) is unity near the zone center and then falls rapidly to zero near  $k_F$ . The minority electrons (solid curve) transmit similarly except that  $T^{\#}$  falls to zero near  $k_F^{\#}$ .

It is now straightforward to compute and interpret the incident, released, and transmitted number current densities and spin current densities. We need only (2), (6), and the appropriate piece of the wave function (16). The incident current densities are

where  $v_x = hk_x = m$ . Using (20), it is easy to check that  $j_x^{in} = j_x^{tr} = j_x^{ref}$  and  $Q_{zx}^{in} = Q_{zx}^{tr} = Q_{zx}^{ref}$ . The rst relation is consistent with (12) because there is no accumulation of charge at the interface. Using (13), the second relation tells us that there is no torque associated with the transport of longitudinal spin current. However, a similar relationship does not hold for the other two components of Q. There is a discontinuity in the transverse spin current when a spin scatters from an interface. A coording to (13), this implies that a current-induced torque acts on the magnetization. In fact, three distinct mechanisms contribute to the net torque.

O ne source of discontinuity and spin-transfer torque is spin ltering. This occurs when the rejection probabilities are spin dependent.<sup>1</sup> To see this, note inst that the speci c superposition of up and down spin components displayed in the incident state wave function (14) corresponds to a speci c transverse component of the spin vector. If  $R_{*} = R_{\#}$  and  $T_{*} = T_{\#}$ , that speci c linear combination is preserved in the rejected and transmitted pieces of the scattering state and no discontinuity occurs in the spin current. This leads unavoidably to different transverse spin components and thus to a discontinuity in

the transverse spin current. Given the structure of (22) and (23), we use the re-ection and transmission probabilities in the combination  $\frac{P}{R^{*}R^{*}} + \frac{P}{T^{*}T^{*}}$  as a measure of the ability of spin ltering to provide spin-transfer torque. The next-to-top and next-to-bottom panels in Figure 3 display the required information.

A second source of transverse spin current discontinuity and spin-transfer torque is spin rotation. This occurs when the product  $R_R_{\#}$  is not positive real. Speci cally, (22) shows that the transverse components of the rejected spin current contain a factor

The phase evidently adds directly to the azim uthal angle used to de ne the spin direction in the incident state vector (14). In other words, the rejected spin direction rotates with respect to the incident spin direction. This is an entirely quantum mechanical phenomenon for which there is no classical analog. The bottom panel of Figure 3 shows that the range of can be surprisingly large. Indeed, for this choice of Fermi surfaces, the spin direction completely reverses when an electron rejects from the interface at near-normal incidence. There is no corresponding rotation for transmitted electrons because  $T_*$  and  $T_{\#}$  are positive real (for free electrons). The resulting discontinuity in the transverse spin current leads to a spin-transfer torque that is distinct from spin litering.

Finally, a glance at (23) reveals that spin precession is a third source of spin-transfer torque. Note specially the spatially-varying phase factors which appear in the transmitted transverse spin currents because  $k_x^{"} \in k_x^{\#}$  in the ferrom agnet. Their net e ect is spatial precession because  $Q_{xx}$  and  $Q_{yx}$  simply rotate into one another as a function of x.<sup>26</sup> From (10), such a spatial variation of Q contributes a distributed torque density at every point in the ferrom agnet. The top panel of F igure 3 shows the range of spatial precession \frequencies"

#### B. Spin currents for a distribution of electrons

The spin currents relevant to experiment reject the combined eject of all the conduction electrons. In the most general description of transport, it is necessary to keep track of the quantum mechanical coherence between all electrons in dijerent eigenstates. However, to model the spin-transfer torque experiments reported to date,<sup>5,6</sup> it is not necessary to maintain the coherence between states with dijerent Ferm i surface wave vectors. It is su cient to use a sem i-classical theory that maintains only the coherence between up and down spin states at each k-point on the Ferm i surface. A coordingly, we de nea 2 2 electron occupancy distribution matrix

We have suppressed the k and r dependence of and for simplicity.

E lsew here, we have solved the Boltzm ann equation to nd f(k,r) for a typical spin-transfer geom etry.<sup>22</sup> For the simple scattering problem treated here, the rejected and transmitted distributions are determined entirely by the rejection and transmission amplitudes and the incident electron distribution at the interface between the non-magnet and the ferrom agnet: f(k) = f(x = 0; k). For this distribution, the sem i-classical version of the spin current (6) is

The restriction  $v_x > 0$  limits the integration to the occupied electron states that move toward the interface. Using (26), (27) and the cyclic properties of the trace, we get, e.g.,

where  $f_p(k) = f_r(k)$   $f_{\#}(k)$  determines the degree of polarization at each point on the Fermi surface. The angles k and k determine the direction of the spin polarization. Electron states in the immediate vicinity of the Fermi surface dominate the transport of charge and spin. Therefore, we write

In these form ulae, the wave vector for incident states, k, transform s to either k or  $k^{\ddagger}$  when the electron enters the ferrom agnet. The average transm itted velocity  $v^{tr}(k)$  is de ned only at values of q where both spins transm it. A com parison of, say,

At this point, we must make a speci c choice for  $g_p(k)$  and the polarization of the incident spin current. Let us assume the current is completely spin polarized along +  $\hat{x}$ . This xes  $_k = -2$  and  $_k = 0$ . For the distribution (32), we begin with the approximate form

The two terms account for interface and bulk elects, respectively. The velocity-dependent bulk term is familiar from textbook treatments of electrical conductivity<sup>27</sup> except, from (11), gradients in spin accumulation (rather than electric potential) drive the spin current in the non-magnet. The constant term is needed because a spin-dependent chemical potential difference across an interface also drives a spin current. <sup>17</sup> In this paper, we assume that the interface resistance is large (large rejection probability) so we use

W e get  $Q_{yx}^{ref} \in 0$  because, as discussed earlier, m any of the spins rotate upon rejection. On the other hand, the sinusoidal factors lead to substantial self-cancellation of the integrals (43) and (44) when the range of  $_q$  is large (see bottom panel of Figure 3).<sup>23</sup> In m ost cases, we ind the total transverse rejected spin current to be very small.

The norm alized transm itted spin currents are

Based on the behavior of the transverse rejected spin current, we expect (45) and (46) to decay as a function of x because the generally wide range of  $k = k_x^{\#}(q) = k_x^{"}(q)$  (see top panel of Figure 3) ought to induce self-cancellation of the integrals. In fact, like a similar integral that appears in the theory of oscillatory exchange coupling,<sup>28</sup> we can extract the asymptotic form (x ! 1) analytically using a stationary phase approximation. Only small values of q contribute in that instance so for, say, the xx component, we nd

To understand this result, we note (see the top panel of Fig. 3) that the electron states with wave vectors in an interval q near q = 0 (which share the value  $k' k_F$ ) play a special role. These states precess together (coherently) with spatial frequency  $k_F^{\#}$ . Slow dephasing begins only after a distance x where x q = 1.




FIG.4: Decay of transverse transmitted spin current as a function of distance from the interface for three free electron models. In each panel, the solid curve is the exact result (45) and the dashed curve is the asymptotic result (47). Top panel: the m ism atch is very large between the sizes of the m agnetic and non-m agnetic Ferm i surfaces;  $k_{F''}=k_F=1:5$  and  $k_{F\#}=k_F=0:5$ . This is the model used in Fig.3. Middle panel: the Ferm i surfaces are identical for the non-m agnet and the majority electrons in the magnet;  $k_{F''}=k_F=1:0$  and  $k_{F\#}=k_F=0:5$ . Bottom panel: an s-d-like model where the m ism atch is very small between the sizes of the magnetic Ferm i surfaces:  $k_{F''}=k_F=0:5$ .

The oscillatory, algebraic decay exhibited by (47) contrastsm arkedly with the assumption ofm onotonic, exponential decay m ade by others.<sup>2,13,29</sup> O fcourse, incoherent scattering processes may be expected to superimpose an exponential decay on the algebraic decay we nd. The solid curves in Fig. 4 illustrate the behavior of the transmitted spin current (45) for three free-electron models. The dashed curves show the asymptotic behavior from (47). The top panel corresponds to Fig. 3 where the Ferm i sphere of the non-m agnet is signil cantly smaller than the m a prity sphere and signil cantly larger than the m inority sphere. The middle panel is a situation where the Ferm i sphere of the non-m agnet is identical in size to the majority sphere and both are signil cantly larger than the m inority sphere. Finally, the lower panel shows results for majority and m inority spheres which are, respectively, slightly larger and slightly smaller than the Ferm i sphere of the non-magnet. This corresponds to the so-called \s-d m odel" where the conduction electrons bands in the ferrom agnet are regarded as slightly split by exchange with localized m om ents.

The interfacial spin-lter" makes each solid curve in Fig. 4 di er from unity already at x = 0. The lter is most e ective when the Ferm i surface of the non-magnet is poorly matched with one or both of the Ferm i surfaces of

the ferrom agnet. Owing to (17), this is consistent with our earlier discussion where we identi ed the transmission probability condition  $T''(q) \in T^{\#}(q)$  as a prerequisite to the action of the spin liter. The subsequent decay of each curve in Fig. 4 to zero rejects the distribution of spatial precession frequencies as we have indicated. We have repeated these calculations assuming that the distribution function  $g_p$  is proportional to the velocity term in (40) alone rather than the constant term in (40) alone. We indicate the results of Fig. 4.




FIG. 5: G raphical representation of the interfacial torque and transverse spin currents for two free electron models. The x-components are horizontal and y-components are vertical. The horizontal arrow is the incident spin current directed along the x-direction. The dashed arc indicates the reduction in spin current due to the spin-lter" e ect. The thick arrow is the reduction in spin current at x = 0. The thick arrow is the ransmitted spin current at x = 0. The thick arrow is the naltorque taking account of the fact that precessional averaging in the ferrom agnet drives Q<sup>tr</sup>! 0 after a few lattice constants. Panel (a) is the large Ferm i surface m ism atch model of F ig. 3. Panel (b) is the s-d model of the bottom panel of F ig. 4.

We are now ready to use our computed results to nd the spin-transfer torque (13) for free electron models. The top and bottom panels of Figure 5 show the transverse spin space vectors N, Q<sup>in</sup>  $\pounds$ , Q<sup>ref</sup>  $\pounds$ , and Q<sup>tr</sup>  $\pounds$  for the Ferm i surfaces used in the top and bottom panels of Fig. 4. We have suppressed the contraction with  $\pounds$  in the spin current labels for clarity. In fact, the vectors for Q<sup>ref</sup> and Q<sup>tr</sup> represent these quantities just at the interface. Therefore, the rejected piece includes the dephasing e ects of di erential spin rotation whereas the transmitted piece does not include the dephasing e ects of di erential spin precession. As we have seen, the latter reduces the transmitted spin torque to zero not far from the interface. Therefore, we have drawn the torque vector (for a unit area of interface) so N = Q<sup>in</sup> + Q<sup>ref</sup>. The top panel of Fig. 5 (large Ferm i surface m ism atch) shows a signi cant dephasing of the re ected spin current. The bottom panel of Fig. 5 (sm all Ferm i surface m ism atch) shows nearly zero re ected spin current. The re ected spin current is exactly zero for the model (not shown) used in the middle panel of Fig. 4. These results show that, unless the Ferm i surface m ism atch is very sm all, the interface e ectively absorbs the entire transverse com ponent of incident spin current. This abrupt change in angular momentum is the source of current-induced spin-transfer torque at the interface between a ferrom agnet and a non-m agnet.

The dashed arc labeled Q<sup>sf</sup> in each panel of Fig. 5 is a portion of a circle whose center is the \tail" position for all three spin current vectors. The radius of this circle, com pared to the length of the vector Q<sup>in</sup>, gives an indication of the magnitude of the spin liter e ect. Quantitatively, the circle radius is proportional to

W ith this de nition, Q<sup>sf</sup> m easures the magnitude of the total outgoing spin current (re ected plus transm itted) without taking phase cancellation into account. This scalar measure of the spin liter is truly meaningful only when the re ection and transm ission am plitudes are both real and positive, which is not the case. Nevertheless, the dashed arcs give some insight into the e cacy of the spin liter mechanism for di erent free-electron Ferm i surfaces.

The foregoing makes clear that free electron models are useful for building intuition about spin currents and spintransfer torque. However, there is no substitute for rst-principles calculations if we are interested in speci c material interfaces. At the very least, such calculations can be used to judge the correctness of approximate constructs such as the s-d model.

#### IV. REAL INTERFACES

In this section we repeat the calculations of Section IIIB for ten lattice matched interfaces between a non-magnet and a ferrom agnet using a more realistic model of the electronic structure for both. Speci cally, we calculate the transmission and rejection amplitudes using a linearized-augmented-plane-wave implementation of the local-spindensity approximation. The details can be found in Ref. 30 and Ref. 31. Compared to that earlier work, the calculations reported here use a mesh in reciprocal space that is a factor of two denser in each direction. For one case (Co/Cu), we checked that no changes in relative spin currents greater than 10<sup>-3</sup> occurred when the mesh was made another 2 - 2 denser. Evanescent states (which decay exponentially away from the interface) play a crucial role in the calculation of the rejection and transmission amplitudes. We have ignored them in our spin currents computations. Their e ect is to change the wave functions in the immediate vicinity (a few atom ic layers) of the interface in such a way that there is no true discontinuity in the transverse spin current at the interface. As a practical matter, this m eans only that the \interfacial" torque we compute is{in reality{spread out over a few atom ic spacings.




FIG. 6: Same as Fig. 3 for a real material interface: Co/Cu (111) with parallel wave vectors in the [110] direction. The two middle panels show the Ferm i surface for the non-magnet and the superim posed Ferm i surfaces of the majority (dashed) and minority (solid) states of the ferrom agnet. The panel just above the magnetic Ferm i surfaces is the probability for transmission into the ferrom agnet for majority (dashed) and minority (solid) electrons. The panel just below the non-magnetic Ferm i surface is the probability for transmission is the probability for magnet. The non-magnet for majority (dashed) and minority (solid) electrons. The panel just below the non-magnetic Ferm i surface is the probability for magnet. The non-magnet for majority (dashed) and minority (solid) electrons. The panel just below the non-magnetic Ferm i surface is the probability for magnet. The non-magnet for majority (dashed) and minority (solid) electrons. The panel just below the non-magnetic Ferm i surface is the probability for magnet into the non-magnet for majority (dashed) and minority (solid) electrons. The bottom panel shows the phase in (55) acquired by an electron because its spin rotates upon magnet. The top panel shows the wave vector di erence (62) for a transmitted electron.

The two middle panels of Fig. 6 show a slice through the Ferm i surface of copper and the same slice through the majority (dashed lines) and minority (solid) Ferm i surfaces of cobalt for the Co/Cu (111) system. The Ferm i surface topologies here are much more complicated than the corresponding free electron topologies (cf. Fig. 3). Moreover, as the Comminority Ferm i surface shows, there can be more than one pair of states for each parallel wave vector. Consequently, we supplement every integral over parallel wave vectors with a sum over all possible states that move toward the interface for each parallel wave vector. We index these states by n, refer to them as associated with the n<sup>th</sup> sheet of the Ferm i surface, and adopt the notation  $k_n = fq; k_n^x$  g to label Ferm i surface wave functions. We drop the spin index in the non-magnet.

The transverse pieces of the incident spin current for a real interface are

These dier from the corresponding free electron formulae by the sum over the sheet index n. That sum is restricted to the sheets of the Ferm i surface where the electrons move toward the interface.

As before, the e cacy of the spin liter can be judged from the interface transmission and re ection probabilities. These state to state ( $n ! n^0$ ) quantities are

The absolute value is needed in (52) because  $v_{n^{\circ}} < 0$  and  $R_{nn^{\circ}}$  must be non-negative. Fig. 6 shows the transmission and re ection probabilities for one slice through the Co/Cu (111) Ferm i surfaces.

The transverse components of the rejected spin current are

Here, the sum over  $n^0$  is restricted to the sheets of the Ferm isurface where the electrons move away from the interface. Similar to the free electron case, the dephasing of the rejected transverse spin current is determined by rejection phases  $\prod_{n=0}^{R} (q)$  where

The bottom panel of Fig. 6 shows that the Co/Cu (111) phases are both more complicated and exhibit greater dispersion than the corresponding free electron results plotted in Fig. 3.

The transverse pieces of Q<sup>in</sup> and Q<sup>ref</sup> w ritten above are closely related to the mixing conductance,  $G_{mix}$ , introduced by B ratass et al.<sup>19</sup> and computed recently by X is et al.<sup>23</sup> In our notation,

This form ula is relevant to situations where  $g_p(k_n)$ ,  $(k_n)$ , and  $(k_n)$  in (49)–(54) are all constants{a restriction in plicit in the Landauer description of transport. In that case, the real and in aginary parts of  $G_{m ix}$  are proportional to the xx and yx components of  $Q^{in} + Q^{ref}$ . From (13), the latter is proportional to the spin-transfer torque if we neglect the transverse part of the transmitted spin current.<sup>19,22</sup> For the system s treated by both of us, our num erical results for spin-transfer torque agree sem i-quantitatively with the mixing conductance calculations of X ia at al.

The transverse transmitted spin currents are

A part from the sum s over  $n^0$  and  $n^{00}$  (both restricted to sheets of the ferrom agnetic Ferm i surfaces where electrons m ove away from the interface), these formula are less simple than the corresponding free electron results (45) and (46) for two reasons. First, the transm ission amplitudes, T  $_{nn^0}$ , are complex rather than real. Second, the B both wave functions (R;x;k<sub>n</sub>) have a non-trivial dependence on the spatial variable R parallel to the interface plane. For the latter reason, the transm itted spin currents contain a factor  $_{n^{00}n^{0}}(q;x)$  de ned by

G iven the foregoing, it is sensible to de ne transmission phases  $T_{nn^0}(q)$  so that

This tells us that, unlike free electrons, the spins of B loch electrons generally rotate when they transm it through a realm aterial interface. If the distribution of transm ission phases is broad, substantial cancellation of the transm itted spin current occurs at x = 0 when we sum over all transm itted electrons. This elect is independent of the spin liter, which also acts at x = 0.

Any spin current that survives to propagate into the ferrom agnet rapidly disappears due to di erential spatial precession. The (generalized) spatial precession frequency is determined by the di erence in wave vector for di erent sheets of the majority and minority Fermi surfaces:




FIG. 7: Decay of transverse transmitted spin current as a function of distance from the interface for three orientations of C o/C u. For a unit incident transverse polarization, the solid curve in each panel is  $Q_{xx}(x)$ . The dashed curve in each panel is  $Q_{yx}(x)$ .

The top panel of Fig. 6 illustrates the distribution of  $k_{n^0n^{\infty}}$  for a Ferm i surface slice of Co/Cu(111). The large dispersion seen there suggests that the spin current decays very quickly in the ferrom agnet. This is con rm ed by Fig. 7, which shows the computed decay of the transverse spin current for three interface orientations of Co/Cu. The non-zero value of the dashed curves at x = 0 shows that a large am ount of rotation occurs upon transm ission. The Ferm i surfaces are more complicated than the free electron models, so the initial decay is more complicated also. Nevertheless, both the (111) and (110) orientations settle into behavior that is readily characterized as a damped precessing or not. In general, there could be several decaying precessions with di erent precession rates and di erent am plitudes.

It is worth noting that none of these curves (or analogous curves for the other material pairs we have studied) resembles the the bottom panel of Fig. 4 appropriate to the s-d model. This lack of agreement is consistent with the fact that essentially all the Fermi surface wave functions in third-row ferrom agnets contain as much \localized" 3d character as \delocalized" 4s character.<sup>33</sup>




FIG. 8: G raphical representation of the interfacial torque and transverse spin currents for a series of real interfaces. The x-com ponents are horizontal and y-com ponents are vertical. The horizontal arrow is the incident spin current directed along the x-direction. The dashed arc indicates the reduction in spin current due to the spin-lter" e ect. The thick arrow is the reduction is the transmitted spin current at x = 0. The thashed arrow is the transmitted spin current at x = 0. The thashed arrow is the transmitted spin current at x = 0. The thick arrow is the naltorque taking account of the fact that precessional averaging in the ferror agnet drives Q<sup>tr</sup> ! 0 after a few lattice constants.

Figure 8 graphically sum marizes our rst-principles spin current calculations for ten di erent interface com binations. The vectors labeled Q<sup>ref</sup> and Q<sup>tr</sup> correspond to x = 0 and re ect the e ect of spin litering and spin rotation only. Q<sup>ref</sup> is very small and, as we have emphasized, Q<sup>tr</sup>! 0 after a few lattice constants. Therefore, the torque per unit area of interface is Q<sup>in</sup> + Q<sup>ref</sup> / Q<sup>in</sup>. Due to spin litering, di erential spin rotation, and di erential procession, nearly all of the incident transverse spin current is absorbed in the immediate vicinity of the interface. For Co/Cu, Fe/Ag, and Fe/Au, the spin-liter accounts for som ewhat m ore than half of the e ect and the interface dephasing for the rest. For N i/Cu and Fe/Cr the spin liter e ect is weaker. For N i/Cu, the decay of the precessing transm lited spin current plays a large role.

Of course, our calculations pertain to ideal, lattice m atched interfaces. A variety of e ects m ake the interfacial absorption of transverse spin even m ore e cient. We have m entioned already that scattering in the ferrom agnetic layer increases the rate of decay of the precession. Steps at the interface lead to increased dephasing for both re ection and transm ission. For thin layers where the decay of the precession m ight not be complete, the dephasing on passing through the second interface generally leads to a further decay of the transverse spin current. Thickness uctuations further reduce the spin current.

The interface torque we compute is interesting because of the recent dem onstrations of current-induced m agnetization switching.<sup>5,6</sup> How ever, the material pair that optimizes the switching is not determined by the conversion of the spin current into a torque. This process is the same for all of the interfaces considered. For the ideal interfaces considered here, the optimum choice depends on the ability of the material pair to generate a spin current in the rst place. This depends on the spin-dependent interface resistances and the spin-dependent bulk conductivities. The Fe/A u and Fe/A g pairs have the strongest spin dependence of the interface resistance.<sup>32</sup> How ever, in reality the optimum combination will likely depend on grow th considerations. The generalm ismatch between the body-centered-cubic Fe lattice and the face-centered-cubic A u or A g lattice will probably lead to poor grow th, unless the interface is forced to be (100) (where the rotated lattices m atch quite well) and the number of steps at the interface is kept quite small.

# V. SUMMARY

In this paper, we used free electron models and rst principles electronic structure calculations to study the spintransfer torque that occurs when a spin-polarized current ows from a non-magnet into a ferrom agnet through a

perfect interface. The origin of the torque is a transfer of spin angular m om entum from the conduction electrons to the m agnetization of the ferrom agnet. The origin of the angular m om entum transfer is the absorption of transverse spin current by the interface. We identied three distinct processes that contribute to the absorption: (1) spindependent rejection and transmission; (2) rotation of rejected and transmitted spins; and (3) spatial precession of spins in the ferrom agnet. When summed over all Ferm i surface electrons, these processes reduce the transverse component of the transmitted and rejected spin currents to nearly zero for most systems of interest. Therefore, to a good approximation, the torque on the magnetization is proportional to the transverse piece of the incoming spin current.

To be m ore quantitative, we used the analogy between charge current and spin current to show that a spin current owing in the  $+ \hat{x}$  direction (perpendicular to the interface) delivers a torque per unit area

to a microscopically small region around the interface. Here, Q<sup>in</sup>, Q<sup>tr</sup>, and Q<sup>ref</sup> are the incident, transmitted, and re ected spin currents computed using incident, transmitted, and re ected wave functions. We found the latter by solving the one-electron stationary-state scattering problem. In the quasi-classical approximation, the total spin current is the sum of contributions from every conduction electron.

Quite generally, the component of N  $_{\rm c}$  parallel to the ferrom agnetic magnetization is zero. This is consistent with our classical intuition. On the other hand, we found that the transverse components of Q  $^{\rm tr}$  and Q  $^{\rm ref}$  relevant to (63) are also zero (or nearly so), except in very exceptional cases. This means that the entire transverse spin current is absorbed (transferred to the magnetization) in the immediate vicinity of the interface. As indicated above, this is so due to spin litering, di erential spin re ection, and di erential spin precession.

The spin-lter e ect occurs because the wave function for an incident electron with a non-zero spin component transverse to the magnetization spin can always be written as a linear combination of spin-up and spin-down components. Then, because the relation and transmission amplitudes di er for up and down spins, the up and down spin

content of the rejected and transmitted wave functions (which are spatially separated) dijection both each another and from the incident state. The spin currents directly encode this information. As a result, the right side of (63) is non-zero. This is a one-electron electron electron electron that operates independently for every electron.

The two other e ects that help drive the transverse parts of Q<sup>tr</sup> and Q<sup>ref</sup> to zero occur when we sum over the entire ensemble of conduction electrons. The rst arises because the spin of an electron generally rotates when it is rejected or transmitted at the interface between a non-magnet and a ferrom agnet. The rotation is non-classical and the amount of rotation di ers considerably for electrons with wave vectors from di erent portions of the Ferm i surface. Phase cancellation occurs when we sum over all electrons. In the end, we nd that very little remains of the rected transverse spin current. The cancellation of the transmitted spin current is less dram atic.

Finally, due to exchange splitting, the electrons that transmit into the ferrom agnet possess spin-up and spin-down components with the same total energy,  $E_F$ , but di erent kinetic energy and so di erent wave vectors. This im plies that each electron spin precesses (in space) as it propagates away from the interface. However, like the spin rotation angles, the spatial precession frequency varies considerably over the Ferm i surface. Consequently, rapid dephasing of the transverse spin components of the individual electrons occurs as the conduction electron ensemble propagates into the ferrom agnet. The net result is a precessing spin current that damps out algebraically within a few lattice constants of the interface.

Our st principles calculations show that the relative in portance of these three m echanisms di ers for di erent m aterials pairs and also for di erent crystallographic orientations for the sam e m aterial pair. N evertheless, the nal result is the sam e in all cases: the transverse spin current essentially disappears at the interface. The concom itant transfer of angular m om entum delivers a torque to the m agnetization in the immediate vicinity of the interface. O ne of us (A.
