Observation of room -tem perature spontaneous phase segregation in overdoped Bi₂Sr₂CaCu₂O_{8+x} single crystals

The occurrence and development of phase inhom ogeneity in B $_{12}$ Sr₂C aC u₂O $_{8+x}$ single crystals have been investigated by measuring their superconducting transition patterns using a high-sensitivity ac magnetometer. We note that the overdoped B $_{12}$ Sr₂C aC u₂O $_{8+x}$ single crystals, even if they were single-phased immediately after a high-temperature annealing process, show progressively pronounced multiple superconducting transitions with time as they were kept at room temperature in a dry air atmosphere. The results reveal that the oxygen dopants in the crystal are still mobile at room temperature. These dopants tend to re-arrange and thus form dierent phases, at a characteristic time scale of one or two weeks or so. Moreover, the diamagnetization loops in the new ly segregated phase are very weak, presum ably due to the existence of additional inhom ogeneity down to a nanometer scale. Our results also show that the optimally doped B $_{12}$ Sr₂C aC u₂O $_{8+x}$ crystals seem capable to remain in a single phase with time.

That the cuprates are of a single phase at a given tem perature and a carrier concentration is an essential assum ption in the widely-used phase diagram $s_{r}^{1,2}$ based on which many experimental aspects in the normal and superconducting states have been correlated and discussed. However, it is often a primary di culty to obtain single crystals with high structural perfection and doping uniform ity, yet with large enough size suitable for many experiments. Besides the electronic phase separation, 3,4 chemical phases separation at mesoscopic or even larger scales, often related to the inhomogeneous distribution or dom ain form ation of oxygen vacancies or dopants, has also been observed in many families of the cuprates, 5,6 for examples, in La_2CuO_{4+x} , 7,8,9,10 in lightly Sr-doped $La_2 \times Sr_x CuO_4$, in $Nd_2 \times Ce_x CuO_4$, r^{12} and in underdoped $YBa_2Cu_3o_{7x}$ where vacancy ordering domains of di erent types form at the chain layers. 13,14 Phase inhom ogeneity has also been observed in B i_2 S r_2 C aC u_2 O $_{8+x}$ by low temperature scanning tunneling microscopic studies. 15,16 W ith all these observations, however, one still cannot rule out the possibility that the phase separation is an extrinsic e ect, avoidable if the crystals are grown up and annealed properly. In this paper, through investigating the time evolution of the diam agnetization signal, we show that the oxygen dopants in originally single-phased overdoped Bi₂Sr₂CaCu₂O_{8+x} single crystals tend to redistribute spontaneously at room temperature, which eventually and unavoidably leads to the occurrence of phase separation and inhomogeneity in the titled com pound.

The B $_1$ S $_2$ C aC $_{12}$ O $_{8+ \times}$ single crystals used in this experim ent were proven to be of high structural quality and stoichiom etric purity with the resolution limits of our X-ray diraction and energy dispersion X-ray studies. To further guarantee the uniformity of the crystal, only those tiny pieces of crystalline sheets (typically

 $0.05 \, \text{mm}$ 10^{2} mm³ in vol-0.5 mm 0.5 mm um e) cleaved and cut from the center of larger uniform ones were used for investigation. Each crystalwas carefully annealed to maintain a certain and uniform level of overdoping. Then, its susceptibility was measured in a weak ac magnetic eld (0.3 to 60 G) using a highsensitivity vibration-sam ple magnetom eter specially designed for measuring sub-millimeter-sized specimens. 17 This magnetometer uses a double-synchronous detection technique, with a high-frequency acm agnetic eld at 10 kH z (at which the B $\frac{1}{2}$ Sr₂C aC u₂O _{8+ x} crystal is fully penetrated in the normal state), and a low-frequency vibration of the sample at 4.4 Hz. It reaches a resolution of 10^{8} emu in susceptibility (or $3 \cdot 10^{10}$ emu in magnetic m om ents) for a sam ple of volum e 1 m m 3 in a eld of 30 G.W ith such a sensitivity we can resolve any minority superconducting phase whose total volume is as small as 10 7 m m 3, at the sam e tim e w ithout suppressing the superconductivity. Our measurement on optimally doped $B_{12}Sr_2CaCu_2O_{8+x}$ crystals reveals a single sharp transition (will be shown in Fig. 5), which proves the reliability of this homem ade setup on the one hand and the high quality of the pristine crystals used in this experim ent on the other hand.

Figure 1 shows the superconducting transitions of two overdoped B $_2$ Sr₂C aC u₂O _{8+ x} single crystals, sam ples # 1 and # 1′, m easured im m ediately after an annealing treatment in O₂ atm osphere at 550 °C for 52 hours. Sam – ple # 1 is m easured in the conguration of B? c, whereas sam ple # 1′ is a small piece cut from sam ple # 1, in order to be mounted into the quartz-tube sam ple holder in the B? ab conguration. The 10% to 90% transition width for sam ple # 1′ is 1 K in a eld of 0.6 G perpendicular to the ab-plane, which demonstrates that an overdoped crystal could be in a uniform single phase.

For the case of B? c, the diam agnetization signal at

low temperatures refects the nature of intrinsic Josephson couplings along the c-direction. To distinguish the transition regime from this Josephson coupling regime, we not it helpful to plot the data in a logarithmic scale (the inset of Fig. 1). In such a plot the temperature dependence of the susceptibility is very steep in the transition regime but relatively \ at" in the Josephson coupling regime. The crossover between the two regimes takes place at $82.5 \, \mathrm{K}$ for sample # 1.

A lthough the overdoped crystals show a single superconducting transition if measured immediately after an annealing treatment, multiple transitions at dierent levels are always seen after the crystals have been kept at room temperature for a period of time. In our experiment, nine overdoped crystals have been examined, seven of them eventually exhibited a multiple transition pattern, and two of them underwent signicant broadening in transition width, after they have been stored for a certain period of time.


FIG. 2: The time-evolution transition patterns of overdoped BigSr2CaCu2O $_{8+\,\mathrm{x}}$ single crystals. A higher To phase gradually grows up as the crystals are kept at room temperature in a dry-air atmosphere. At the end of the three-month period, the newly segregated phase caused an apparent diamagnetization volume of 10% for the case of B?c (panel (b)), and up to 50% for B?ab (panel (a)) at 82 K.

Figure 2 shows the time evolution of the transition pattern for sample # 2. This crystal was annealed in O $_2$ atm osphere at 450 $^{\circ}\mathrm{C}$ for 48 hours. It was afterwards kept at room temperature in a dry air environment as protected by silica gel, which is a common way of sample storage in most of the laboratories. In a three-month period the susceptibility of the crystal in the B? c conguration was measured for several times. From the panel (b) of Fig 2 it can be seen that the 88 K phase grew up signicantly with time, and reached 10% in diamagnetization at the end of the three-month period.

The measurement performed in the B? ab conguration on sample #2' (which is a small piece taken from sample #2 at the end of the three-month period) also revealed the formation of a very pronounced secondary phase, as shown in the panel (a) of Fig. 2.

The growing up in volume of a higher-Tc phase should re ect the change in local oxygen content and/or arrangement in the crystals. Only with such a mechanism can then the change be reversible, i.e., a single sharp transition can be restored by high-tem perature annealing which was exactly the case for our crystals. Our results therefore reveal that the balanced oxygen content in overdoped B $\frac{1}{2}$ Sr₂C aC u₂O _{8+ x} is a function of the tem perature and the oxygen partial pressure of the crystal's environment. The nearly balanced oxygen content in a crystal, as maintained by high-tem perature annealing in 02atm osphere, must become over saturated as the crystalis cooled down to room temperature. Therefore, the oxygen dopants tend to redistribute and even to escape from the crystal, which nally creates the higher-Tc phase. For this reason, the newly formed phase is likely near the edge of the crystals. It should occupy a substantially large volum e, in order to cause an apparent diam agnetic signal of 10% for sam ple # 2, and up to 50% for sam ple # 2'.

The distinct multiple-transition pattern indicates the form ation of two types of domains in the ab-plane of the crystal, each having a dierent oxygen content. The

m echanism of forming such domains might be similar to that of the vacancy ordering domains in underdoped YBa $_2$ Cu $_3$ O $_7$. 13,14 It has been shown through numerical simulations 19 that an ordered distribution of oxygen vacancies commensurable with the lattice, i.e., forming some types of staging, is energetically more favored than a random distribution.

A non-trivial m obility for the oxygen dopants at room tem perature is another key factor for the occurrence of spontaneous phase separation. It has been shown in La₂CuO_{4+x} that the oxygen mobility is linked to the lattice im perfections, e.g., it is strongly enhanced by the presence of planar defects. For B ½ Sr₂CaCu₂O_{8+x} sam – ples, the existence of incommensurate modulation along the b-axis^{21,22} might in some way in uence the oxygen mobility, which needs to be further studied.

Figure 3 shows the eld dependence of the transition pattern of sam ple # 2' three m onths after the annealing, and sample # 2 24 days after the annealing. Two transitions can be recognized in weak magnetic elds, one onsets at 81.6 K and the other above 86 K. The nucleating and growing up of the superconducting domains below 86 K build up substantially large or enom ous amount of diam agnetization loops in the ab-plane of the crystal. However, these loops are very weak, as they can be dras-1 Gauss, and almost tically suppressed by a eld of washed out by a eld of a few tens Gauss. Such a sensitive eld dependence should come from a Josephson-like weak superconductivity, re ecting the existence of additional inhomogeneity in the ab-plane of the newly segregated phase down to the coherence length scale.23

The di usion process of the dopants to a lower-energy distribution is presum ably driven by the therm alenergy which is signi cantly lower at room temperature compared to that in high temperature annealing. This factor makes the di usion process hardly completed, givn rise to the additional inhom ogeneity in the ab-plane. This picture seems consistent with the recent observation of energy gap inhom ogeneity at nanom eter scale using scanning tunneling microscopy. $^{15,16}\,\rm W$ ith the best single crystals they obtained, Pan and co-workers found that the superconducting energy gap of B $\rm i_2\,Sr_2\,C\,aC\,u_2O_{\,8+\,x}\,$ compound is inhom ogenous from place to place down to the nanom eter scale, though the lattice is highly perfect.

Finally, Fig. 5 shows the transition patterns of two optim ally doped B i_2 Sr $_2$ CaCu $_2$ O $_{8+x}$ crystals (the 88 K phase) 15 days (sam ple # 3) and six months (sam ple # 4) after being annealed in A r atm osphere (600 °C, two weeks). These crystals are from the same batch as sam ple # 1 and # 2. It seems that the tendency of spontaneous phase separation at room temperature is much insigni—cant for optim ally doped crystals, as their transition pattern remains nearly the same after the six months period, and shows no signicant—eld dependence at a level of a few G auss. It indicates that the oxygen dopants in optimally doped crystals are near to a minimum energy distribution which is homogenous down to the coherence length scale.



- The sensitive eld dependence of the transition pattern at a level of a few G auss above 81.6 K is irrelevant to the irreversibility eld H irr nor to the upper critical eld H c2, because these elds are at a much higher level. Nor should the phenom enon be mainly caused by the amplitude uctuation of the order parameter, otherwise we could hardly explain why the whole transition of the higher-Tc phase depends sensitively on the applied eld. Also, the magnetization of the higher-Tc phase deduced from our susceptibility data does not follow the scaling law as expected for critical uctuation (see Z.Tesanovic et al., Phys. Rev. Lett. 69, 3563 (1992); Q.Li, K.Shibutani, M.Suenage, et al., Phys. Rev. B 48, 9877 (1993)).


FIG. 4: The transition patterns of two optimally doped crystals of B½Sr2CaCu2O8 15 days (sample # 3) and six m onths (sample # 4) after being annealed in Aratm osphere at 600 $^{\circ}$ C. Their transition patterns remain nearly the same, and shows no signicant eld dependence at a level of a few Gauss.


