Yang-Lee Zeros of the Q-state Potts Model on Recursive Lattices

Abstract

The Yang-Lee zeros of the Q -state Pottsm odelon recursive lattices are studied for noninteger values of Q. Considering 1D lattice as a Bethe lattice with coordination number equal to two, the location of Yang-Lee zeros of 1D ferrom agnetic and antiferrom agnetic Pottsm odels is completely analyzed in terms of neutral periodical points. Three di erent regimes for Yang-Lee zeros are found for Q > 1 and 0 < Q < 1. An exact analytical form ula for the equation of phase transition points is derived for the 1D case. It is shown that Yang-Lee zeros of the Q -state Pottsm odel on a Bethe lattice are located on arcs of circles with the radius depending on Q and temperature for Q > 1. Complex m agnetic eld m etastability regions are studied for the Q > 1 and 0 < Q < 1 cases. The Yang-Lee edge singularity exponents are calculated for both 1D and Bethe lattice Pottsm odels. The dynam ics of m etastability regions for di erent values of Q is studied num erically. PACS num ber(s): 05.50.+ q, 05.10.-a

1 Introduction

The Q-state Potts m odel plays an important role in the general theory of phase transitions and critical phenomena [1]. It was initially de ned for an integer Q as a generalization of the Ising model (Q = 2) to more-than-two components [2]. Later on, it was shown that the Potts model for non-integer values of Q may describe the properties of a number of physical systems such as dilute spin glasses [3], gelatation and vulcanization of branched polymers (0 < Q < 1) [4]. Also it was shown that the bond and site percolation problems could be formulated in terms of Potts models with pair and multisite interactions in the $Q = 1 \lim it$.

In 1952, for the rst time, Lee and Y ang [5] in their fam ous papers studied the distribution of zeros of the partition function considered as a function of a complex magnetic led (e $\frac{2H}{kT}$ activity, H is a magnetic eld). They proved the circle theorem which states that zeros of

the partition function of an Ising ferrom agnet lie on unit circle in the complex activity plane (Yang-Lee zeros). A fler these pioneer works of Lee and Yang, Fisher [6], in 1964, initiated the study of partition function zeros in the complex temperature plane (Fisher zeros). These methods were then extended to other types of interactions and found wide applications [7].

Recently, much attention was drawn to the problem of Yang-Lee and Fisher zeros of the Q-state Potts model for both integer and non-integer values of Q. The microcanonical transfer matrix method was used to study the Yang-Lee and Fisher zeros of the non-integer Q-state Potts model in two and three dimensions [8]-[11].

Derrida, De Seze and Itzykson [12] showed for the rst time that the Fisher zeros in hierarchical lattice models are just the Julia set corresponding to the renormalization transformation. They found a fractal structure for the Fisher zeros in Q-state Potts model on the diam ond lattice. Recently, Monroe investigated Julia sets of the Potts model on recursive lattices [13]. He found that the box counting fractal dimension of the Julia set of the governing recurrence relation is a minimum at a phase transition. This gives an alternative criterion for studying phase transitions in models de ned on recursive lattices.

In 1994, G lum ac and U zelac [14], using the transfer m atrix m ethod, analytically studied the distribution of Yang-Lee zeros for the one-dimensional ferrom agnetic Potts model with arbitrary and continuous Q 0. For 0 < Q < 1 they obtained that for high temperatures the Yang-Lee zeros lie on a real interval and for low temperatures these are located partially on the real axis and in complex conjugate pairs on the activity plane. Later on, M onroe investigated this model by means of the dynam ical systems approach and con rm ed that for Q < 1 there is a real interval of Yang-Lee zeros [15]. Then, K im and C reswick found that for Q > 1 the Yang-Lee zeros lie on a circle with radius R, where R < 1 for 1 < Q < 2, R > 1 for Q > 2 and R = 2 for Q = 2 [9]. However, it is not clear yet what is the location of Yang-Lee zeros for 0 < Q < 1 at low temperatures [14].

In this paper the Y ang-Lee zeros of the one-dimensional and Bethe lattice Q -state P ottsm odels are studied using the dynam ical system s approach. It is shown that for the one-dimensional Potts model the partition function becomes zero when the corresponding recurrence relation has neutral xed points for a given value of magnetic eld. U sing this correspondence between zeros of the partition function and neutral xed points of the recurrence relation the Yang-Lee zeros of both ferrom agnetic and antiferrom agnetic Potts m odels are com pletely studied analytically. The location of Y ang-Lee zeros of the ferrom agnetic P otts m odel for 0 < Q < 1 is found. A loo, formulas for the density of Y ang-Lee zeros are derived and edge singularity exponents are calculated. For the Potts m odel on a Bethe lattice it is shown that the Yang-Lee zeros are located on a phase coexistence line in the complex magnetic eld plane. Here, the phase coexistence line is de ned as a line in the complex magnetic eld plane, where the absolute values of derivatives of the recurrence relation in two attracting xed points are equal. It is noteworthy that, M onroe [16] used a similar criterion for studying critical properties of the Potts m odel on recursive lattices. For the Bethe lattice case an analytical study of Y ang-Lee zeros is perform ed also. A form ula for Yang-Lee edge singularity points is derived and edge singularity exponents are calculated. Our analitical treatment con med the results of numerical calculations. Further, m etastability regions in a complex m agnetic eld plane are investigated. It is shown that the border of a metastability region may be found from the condition of existence of a neutral xed point of the governing recurrence relation.

The structure of this paper is as follows, in Section 2 an exact recurrence relation (Potts-Bethe mapping) for the Q-state Potts model on a Bethe lattice is derived. Applying the theory

of dynam ical systems to the problem of phase transitions it is shown that critical points may be associated with neutral periodical points of the corresponding mapping. In section 3 the Yang-Lee zeros and edge singularities of ferrom agnetic and antiferrom agnetic Potts models are studied analytically for non-integer Q, considering a 1D lattice as a Bethe lattice with coordination number = 2. In Section 4 the Yang-Lee zeros and edge singularities of the Potts model on a Bethe lattice with coordination number > 2 are studied num erically. In the last section the dynam ics of com plex magnetic metastability regions is studied num erically and the explanation of results is given.

2 The Q-state Potts M odel on the Bethe lattice

The Q state Potts model in the magnetic eld is de ned by the Ham iltonian

where $_{i}$ takes the values 0, 1, 2, :::, Q 1 and = 1=kT. The rst sum in the rhs. of (1) goes over all edges and the second one over all sites on the lattice. The partition function of the model is given by $_{x}$

where the sum m ation goes over all con gurations of the system .

Using the recursive structure of the Bethe lattice (Fig. 1) one can derive an exact recurrence relation and apply the theory of dynam ical system s to investigate the therm odynam ical properties of models de ned on it [17]. Cutting the lattice at the central site 0 one will obtain interacting nth generation branches [18]. By denoting the partition function of the nth generation branch with the basic site 0 in the state $_0 \text{ as } g_n (_0)$ the partition function may be written as follows x

where $_0$ is the Potts variable at the central site 0 of the lattice (Fig. 1). Applying the "cutting" procedure to a nth generation branch one can derive the recurrence relation for g_n ($_0$)

The magnetization of the central site for a Bethe lattice of n generations may be written as

Instead of M () in Eq.(6) it is more convenient to consider the function M () = 2M () 1, which has the same analytical properties as M () and give correct m agnetization for the Ising m odel (Q = 2)

In the following the formulas in Eqs.(5) and (6) will be generalized to non-integer values of Q = 0.

Let us now give some de nitions and brie y discuss the problem of phase transitions on recursive lattices in terms of dynamical systems theory. The point x is called a periodical point with period n of the mapping $x_n = f(x_{n-1})$ if it is a solution to the equation $f^k(x) = x$. Here f^n means a superposition f^n f f f. If k is chilled a xed point. To analyze the stability of a periodic point x of period k, i.e. either iterations of f(x) tend to the periodical point or move away from it, one should compute the derivative of f^k , = $(f^k)^0(x)$ $^0 = \frac{d}{dx}$, at this point. A periodic point x is: (1) attracting (stable) if j j < 1; (2) repelling (unstable) if j j > 1 and (3) neutral (indi erent) if j j = 1.

The therm odynam ic properties of models de ned on recursive lattices may be investigated by studying the dynam ics of the corresponding recursive function. For the ferrom agnetic Ising model, for example, this may be done as follows. For high temperatures ($T > T_c$) the recursive function Eq.(5) has only one attracting xed point corresponding to a stable paramagnetic state. For low temperatures ($T < T_c$) the recursive function Eq.(5) has two attracting xed points. In the absence of a magnetic eld these two attracting xed points correspond to two possible ferror agnetic states with opposite magnetizations. It is well known that for h = 0and $T < T_c$ the system undergoes a rst order phase transition and the condition $j_1 j = j_2 j$ is satisted, where $j_{1,2}$ jare derivatives of f(x) in these attracting xed points. In the presence of a magnetic eld the stable state corresponds to the xed point with maximum j j and the magnetization in this state has the same direction as the external magnetic eld. The other xed point corresponds to a metastable state, which may be achieved by a sudden reversal in the sign of the magnetic eld. The boundary of the metastability region may be found from the condition that one of the xed points becomes neutral. For more details about the dynamics of metastable states see the book by Chaikin and Lubensky [26]. The critical temperature corresponds to the values of the magnetic eld and temperature when the xed points of recursive function f(x) are neutral and repelling. The values of external parameters (temperature, magnetic eld, etc.) at which the recursive function f(x) has a neutral periodical point of period k may be obtained from the following system of equations

Thus, for the models de ned on recursive lattices, critical points and the boundary of metastability regions may be associated with neutral periodical points of the model's mapping. In the following section the Yang-Lee zeros of the 1D Q -state Potts model are investigated in terms of neutral xed points.

3 The Yang-Lee zeros of 1D Q-state Potts m odel

A one-dimensional lattice m ay be considered as a particular case of the Bethe lattice with coordination number = 2. In this case the Bethe-Potts m apping (5) becomes a M obius transformation, i.e. a rational m ap of the form

if $c \notin 0$, while R (1) = 1 when c = 0. The dynam ics of such maps is rather simple [19]: If f(x) is a M obius transformation with two xed points, then either fⁿ(x) converge to one of the xed points of f(x) (one of the xed points is attracting and the other is repelling), or they move cyclically through a nite set of points, or they form a dense subset of some circle (both xed points are neutral). It follows from the dynam ics of the M obius transformation that phase transitions correspond to values of the tem perature and magnetic eld where the recursive function f(x) has only neutral xed points. Thus, to study the Yang-Lee zeros one should study the system (8) to not the values of at which this system has solutions for k = 1. For neutral xed points the system (8) may be written in the form

Excluding x from the equations of the system (9) after some algebra one can d the equation of phase transitions in the form

where $2 \ [0;2]$. Since \cos is an even function of , we may restrict ourselves to $2 \ [0;]$. Thus, for given z and Q the equation (10) is a parametric equation of Y ang-Lee zeros, where

is a parameter. Analyzing Eq.(10) one can distribution of Yang-Lee zeros of the Potts model. It is noteworthy that using this equation one can study the Fisher and Potts zeros¹ in the same way².

First of all note that Eq.(10) is a quadratic equation of with real coe cients. Hence, solutions to this equation lie either on the real axes or in complex conjugate pairs on a circle with radius $R = j j = \frac{jz+Q-2j}{z}$ for any 2 [0;] (See also [9]). The solutions to the Eq.(10) can be written in the form

Let us now study the Yang-Lee zeros of ferrom agnetic Potts model, i.e. J > 0 and z > 1. For Q > 1 one can easily nd that B > 1, hence, all solutions (11) are complex conjugate and lie on an arc of circle with radius $R = \frac{z+Q}{z}$. If 1 < Q < 2 then R < 1 (the arc lies inside the unit circle), if Q > 2 then R > 1 (the arc lies outside the unit circle [9]) and R = 1 [5] for Q = 2 (Ising model). Writing in the exponential form $= R e^{i}$ one can nd

From Eq.(13) one cap see that there are no solutions with arguments in the interval 0 < 0, where $0 = 2 \arccos B^{-1}$. This is the wellknown gap [21] in the distribution of Y ang-Lee zeros. It points to the absence of phase transitions in an 1D ferror agnetic Potts model for Q > 1 at any realtern perature. This is in good agreement with recent studies by G lum ac and U zelac [14], and K in and C reswick [9], where the Y ang-Lee zeros of the 1D Potts model was studied by using the transferm atrix method. C on paring our formula (13) with the corresponding formula (14) of Ref. [9] one can see that the argument of the derivative in our method is nothing but the di erence in the arguments of two maximal eigenvalues in the transferm atrix method. It follows from the Eqs.(11) and (13) that the Y ang-Lee edge elds correspond to = 0 and have the form

0 < B < 1 when z > 2 Q (Q < 1), and all values of <u>'</u>s in (11) are either real or complex depending on . For $0 < <_0$, where $_0 = 2 \arccos B$, solutions (11) are real and lie in the interval [; +]. For $_0 < <$ the solutions (11) are complex conjugate and lie on the circle with radius $R = \frac{z+Q}{z}$.

For Q > 1, the dimension of both sides of Eq.(13) with respect to and gives the density of Yang-Lee zeros g() in the form

From Eq.(15) it follows that the density function g() for Q > 1 diverges in the gap points with the exponent = $\frac{1}{2}$, i.e. $g() / j_0 j$ when ! 0 or ! 0.

For Q < 1, the corresponding density function g() may be obtained by dimension of both sides of Eq.(10)

One can see that g() diverges in the points , i.e. g() / j j, with the exponent $= \frac{1}{2}$. Thus, for Q < 1 the density function of Yang-Lee zeros of the 1D Q-state Potts ferrom agnetic model has singularities only at the points [Eq.(14)] with the edge singularity exponent $= \frac{1}{2}$. The same is true for the antiferrom agnetic case.

G lum ac and U zelac [14] considered for Q < 1 case the contribution of the third eigenvalue of the transferm atrix ($_2$ in their notations). We want to note that for the 1D Potts model the transferm atrix method gives three and more eigenvalues only for Q > 2, hence, the third and other eigenvalues should be neglected for Q < 2. In this case the study of two maximal eigenvalues gives the same results as our method. The summary of results of the 1D ferrom agnetic Potts model is given in Fig. 2. It is interesting to note that the argument of the derivative in Eq.(9) corresponds to the argument of the maximal eigenvalue in the transferm atrix method.

The antiferrom agnetic case m ay be studied in the same m anner. The results are shown in Fig. 3.

4 Yang-Lee zeros of the Q state Pottsm odelon a Bethe lattice (Q > 1)

Let us, at rst, consider the ferror agnetic Potts model on the Bethe lattice with coordination number = 3. In this case the system (8) may be studied analytically for neutral xed points (k = 1). The exclusion of x from both equations (8) gives the following equation

where $y = (z \quad 1)(z + Q \quad 1)=2$ and $2 \quad [0;2]$. This equation describes the border of the m etastability region in the complex plane (Fig. 4). The dashed areas in Fig. 4 show the m etastability regions for di erent tem peratures. Inside the m etastability region there are two attracting xed points and there is only one outside of it. The other xed points are repelling. Note that such a behavior is valid for any . At at least two of the xed points become

neutral. It will be shown below that at the magnetization function (7) is singular and

correspond to the Yang-Lee edge singularity points. These are solutions to the equation (17) for = 0 and the critical temperature may be obtained from the condition $_{+} =$. It follows from Eq(17) that the edge singularity points lie on a circle with radius $R^2 = \frac{(z+Q-2)^3}{z^3(Q-1)}$. Since there is no phase transition on the boundary of a metastability region it will not give rise to zeros of the partition function [26]. The metastability region in the complex -plane points to the existence of the rst order phase transition for complex magnetic elds. The problem of nding the Yang-Lee zeros of models with rst order phase transitions attracted much attention for many years. Recently, Biskup et al., showed that the position of partition function zeros is related to the phase coexistence lines in the complex planes [23]. Dolan et al., used this approach to study F isher zeros for Ising and Potts m odels on non-planar ('thin') regular random graphs. It is interesting to note that the locus of F isher zeros on a Bethe lattice is identical to the corresponding random graph [27]. For our models the phase coexistence line is de ned as a line in the complex plane, where the absolute values of the recursive function derivatives in two attracting xed points are equal (see also [16]). Our num erical study showed that the phase coexistence line for $T > T_c$ is an arc of a circle with radius R ending at the edge singularity points (the dashed line in Fig. 4).

Let us now study the analytical properties of the magnetization function (7) to prove that the edge singularity points correspond to its singularities. The xed point equation of the Potts-Bethe mapping (5) may be written in the form

For continuity at \bigcirc 0, x is defined to be equal to (Q 1)=(z + Q 2) at = 0. Considering x as function of , one can study the singularities of x () that also correspond to singularities of M (). The singular points of x () are = 0, = 1 and (x), x being the points, where the derivative @x=@ is in nite. x satisfies the equation

Eq.(19) is obtained after di erentiation both sides of Eq.(18) with respect to and x from the condition that $\ell = \ell x$ vanishes. Note that Eq.(19) may be derived from the system (8) for k = 1 and = 0 by excluding from both of the equations. At the singularity points of M () the recursive function has two neutral xed points with = 0 and the others are repelling.

The critical temperature may be obtained from the condition $_{+} =$ or setting the discriminant of the quadratic equation (19) to zero

For $Q_q > 1$ and $1 < z < z_c$ the solutions x are complex conjugate numbers with modulus $R_x = \frac{z+Q-2}{z(Q-1)}$ and for $z > z_c$ they become real valued. For Q < 1 the solutions x are always real numbers. Substituting $x = R_x e^i$ into Eq.(18) one nds after some algebra

Note that the xed point equation f(x) = x and the magnetization M () are invariant under the transformation G : $f(x) = \frac{R^2}{x}$, $x = \frac{R^2_x}{x}$, M oreover, for the magnetization function one has

The Yang-Lee zeros of the Pottsm odelon the Bethe latticem ay be obtained also analytically by studying the analytical properties of the magnetization function (7). This was done for the rst time by Bessis, D roue and M oussa [24] for the Ising model on Bethe lattice. Making use of singularities of x () in analogy with [24] a careful analysis of the analytic properties of the function M Eq. (7) for Q > 1 gives the following picture for Yang-Lee zeros: (a) For $z < z_c$: M () is analytic in the complex plane cut along an arc of the circle with radius R² = $\frac{(z+Q-2)}{z-(Q-1)^{-2}}$, that contains the point R and is limited by the points , which are complex conjugate. Due to relation (23), the discontinuity along the cut is real and never vanishes except at the Yang-Lee edge singularity points . This is in a good agreement with the Yang-Lee theory [5]. The density of zeros g (R;) may be calculated from

Our num erical study of Eq.(24) shows that close to the edge singularity points $= e^{i_0}$, g(R;) has an exponential behavior $g(R;) / j_0 j$ and $_0(T) / (T T_c)$ where = 1=2 for $z < z_c$, = 1=3 ($= \frac{1}{2}$) for $z = z_c$ and $= \frac{3}{2}$ (=). Our results are in a good agreem ent with those of [22], [21], where it was shown that the exponent is universal and always equal to 1=2 for $T > T_c$ and = 1= for $T = T_c$ in ferror agnetic models on lattices with spatial dimension d > 6.

(b) For $z > z_c$ the function M () is split into two di erent functions: M₊() de ned for j j< R and M () de ned for j j> R. The function M₊() can be analytically continued outside the circle j j= R into the z plane cut along the real axes from (x₊) to 1, where x₊ is the largest root of Eq.(19). The point (x₊) increases from unity to in nity when z increases from z_c to in nity. The discontinuity of M₊() across the cut is purely in aginary and does not change the sign. Hence, it has no in uence on physical properties of the model and the Yang-Lee zeros lie on the circle j j= R. The points correspond to the boundary of m etastability for real magnetic elds and the plots of the iteration function f (x) at these points are given in Fig.5.

5 Complex M agnetic Field m etastability regions

In the previous section the neutral xed points of the recursive function f(x) (5) was considered only. It was found that the set of values of the magnetic eld, for which the recursive function (5) has at least one neutral xed point gives the boundary of the metastability region in the complex -plane. Inside it there are two attracting xed points and others are repelling.

N um erical experiments show that in the -p lane the recursive function Eq.(5) has a complex behavior with period doubling bifurcations. The question arises: W hat will happen to the m etastability region if neutral periodical points of period k 1 are also considered? To answer this question one has to study the system (8) for any k 1. Since it is impossible to solve 1 and 3 analytically and even num erically for large k and the system (8) directly for k , the method developed in [20] is used. It gives a numerical algorithm for searching neutral periodical points for the recursive functions like Eq.(5) and is based on the theory of complex dynam ical systems and the well known fact that the convergence of iterations to neutral periodical points is very weak and irregular, i.e. one has to make a number of iterations in order to approach a neutral periodic point. The algorithm is to nd all critical points of the recursive function and investigate the convergence of all the orbits started at critical points (critical orbits). If all critical orbits converge to any attracting periodical point one says that the recursive function has only attracting and repelling periodical points. If at least one of the critical orbits does not converge, for example, after n iterations, one says that the recursive function has a neutral periodical point. Of course, the last statem ent is not rigorous from the strong mathematical point of view since a weak convergence to an attracting periodical point is also possible. Depending on the choice of n and " (the accuracy of approaching an attracting periodical point), the resulting picture on the -plane m ay change. Our simulation experiments show that n = 700 and $" = 10^{5}$ are optimal values and the data generated with this algorithm do not qualitatively change when n and/or " di er from their optim al values. For m ore details of the m ethod and the $C + + program \mod 20, 25$].

One can easily nd all critical points of the mapping f from Eq.(5). The critical points are: x = 0 with multiplicity 2 and x = 1 with multiplicity 2. The degree of our mapping f is d = (1). It may be shown that these are the only critical points of the mapping f [20]. Hence, one has to consider only the orbits of the points $x_0 = 0$ and $x_0 = 1$. For numerical calculations it is convenient to start iterations at the points $x_1 = f(0) = 1 = z$ and $x_1 = f(1) = (z + Q)$ 2)=(Q 1).

In Fig. 6 the dynamics of metastability regions of the Q-state Potts model on the Bethe lattice with coordination number = 3 and z = 3 is shown depending on Q. We have experimental evidence that in white regions all critical orbits converge. Figs. 6(a)-(d) show the metastability regions for the case Q > 1. It is seen that the sets of black points are similar to the boundary of the M andelbrot set of the quadratic mapping $z ! z^2 + c$ (Figs. 6(c),(d)). This fact is known as the universality of the M andelbrot set [28]. The metastability region of the Ising model (Q = 2) at the critical temperature is shown in Fig. 6(c). It intersects the positive sem i-axis at = 1, which is an evidence of the existence of real temperature second order phase transition in conform ity with exact calculations [18]. The Q < 1 case is shown in Figs. 6(e)-(i). O ne can see that Fig. 6(e) resembles a mirror rejust of the M andelbrot set boundary of (cf. Fig. 6(d)-(e)). It is noteworthy that for Q = 1 and = 3 the Bethe-Potts mapping becomes a quadratic one [29], and our numerical method fails [20]. By lowering Q the metastability regions become more and more complicated Figs. 6(f)-(i). Note that the dynamics of the metastability regions remains the same if one xes Q and changes the temperature.

6 Conclusions

We showed that the stability analysis of attracting xed points of the recurrence relation, i.e. the condition that the absolute values of derivatives of the governing recurrence relation in two attracting xed points are equal at a phase transition, may be successfully applied to a study of zeros of the partition function. Note that in the one-dimensional case the condition of a phase transition is equivalent to the condition of existence of neutral xed points. It will be interesting to check the M onroe's conjecture that at a phase transition the box counting dimension of the Julia set of the governing recurrence relation is a minimum for zeros of the partition function [13]. We suppose that the box counting dimension of the Julia set of the recurrence relation should be a minimum for zeros of the partition function also. This may serve as a new criterion for studying zeros of the partition function for models on recursive lattices.

In conclusion we observe that num erical m ethods proposed in this paper are generic and m ay be used for investigation of zeros of the partition function and m etastability regions of other m odels on recursive lattices.
