Jam m ing, freezing and m etastability in one-dim ensional spin systems

A bstract

We consider in parallel three one-dimensional spin models with kinetic constraints: the paramagnetic constrained Ising chain, the ferromagnetic Ising chain with constrained G lauber dynamics, and the same chain with constrained K awasaki dynamics. At zero temperature the dynamics of these models is fully irreversible, leading to an exponentially large number of blocked states. Using a mapping of these spin systems onto sequential adsorption models of, respectively, monomers, dimers, and hollow trimers, we present exact results on the statistics of blocked states. We determine the distribution of their energy or magnetization, and in particular the large-deviation function describing its exponentially small tails. The spin and energy correlation functions are also determined. The comparison with an approach based on a priori statistics reveals systematic discrepancies with the Edwards hypothesis, concerning in particular the fall-o of correlations.

1 Introduction

In a great variety of system s, such as structural glasses, spin glasses, and granular materials, the dynam ics at low temperature or high density is so slow that the system falls out of equilibrium [1]. For long, glassy dynam ics has been described as a slow motion in a complex energy (or free energy) landscape [2], with many valleys separated by barriers. Several approaches have been proposed in order to make this heuristic picture more precise. Valleys thus appear under various names (and with various de nitions) in dierent contexts: metastable states, TAP states [3], pure states [4], inherent structures [5], quasi-states [6]. From a dynamical viewpoint these concepts are not equivalent [7]. Metastability is indeed unambiguously de ned form ean—eld models only, where metastable states have in nite lifetimes, as barrier heights diverge with the system size. For nite-dimensional systems with short-range interactions, barrier heights and valley lifetimes are always nite at nite temperature, so that metastability becomes a matter of time scales [8].

Once these valleys are appropriately de ned, one can estimate their number at $\ xed$ energy (or free energy) density E . This number generically grows exponentially with the system size, as

where S_{ap} (E) is the congurational entropy or complexity. The subscript 'ap' (a priori) refers to the fact that, when counting valleys, each of them appears with the same weight. In this a priori ensemble, valleys are combinatorially equivalent.

In contrast, a key question concerns the dynam ical weight of each individual valley. Do all the valleys play a similar role in the dynam ics? This question arises for instance when a system is instantaneously quenched into the glassy phase, starting from a disordered con guration. Assuming this initial con guration is chosen at random, does the system sample all the possible valleys with a given nalenergy E with equal statistical weights, i.e., with a uniform or at measure, or, to the contrary, does the size of the attraction basin of each valley really matter? The same question is also relevant in another situation commonly referred to as tapping [9, 10, 11]. Under tapping a granular material continuously jumps from a blocked con guration to a nearby one. Does the non-equilibrium steady state thus obtained admit a statistical description in terms of a at ensemble of blocked con gurations?

The answer to this question for the rst situation (relaxational or aging dynam ics) is positive at least in some mean-eld models, where valleys are known to be explored with a at measure [6]. The concept of ergodicity, and the resulting thermodynam ical construction, therefore hold, as in equilibrium situations, up to the replacement of con gurations by valleys. The con gurational temperature $T_{\rm ap}$, defined by

has a therm odynam icalm eaning. It also coincides with the elective temperature involved in the generalized uctuation-dissipation formula in the appropriate temporal regime.

Besides the mean-eld geometry, another physical situation where metastable states are unambiguously dened is the zero-temperature limit, where no barrier can be crossed at all. Valleys are just blocked congurations under the chosen dynamics. For instance, for an Ising model with single-spin dynamics, a valley is a conguration where each spin is aligned with its local eld, provided the latter is non-zero.

In the context of granular m aterials, Edwards [12] proposed to describe the slow compaction dynamics by means of a at ensemble average over all the blocked congurations of the grains with prescribed density. Extending the range of application of this idea, the so-called Edwards hypothesis consists in assuming that all the valleys with a given energy density are equivalent. This hypothesis has two consequences. First, the value of an observable can be obtained by a at average over the aprioriensemble, or Edwards ensemble, of all those valleys. Second, the temperature $T_{\rm ap}$ of (12), also known as the Edwards temperature, has the usual therm odynamical meaning of a temperature.

The present paper is devoted to the analytical study of the zero-tem perature dynamics of simple one-dimensional systems with kinetic constraints. Kinetically constrained models have been the subject of numerous investigations [13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26]. Here we specialize to Ising chains without frustration nor quenched disorder, namely paramagnetic chains (CIC) [14, 15, 16, 17] (section 2) and ferrom agnetic chains [18, 19, 20, 21, 22] (sections 3 and 4). The common feature of all these models is the irreversible nature of their zero-tem perature dynamics: each spin ips at most once in the whole history of the system.

The central goal of this paper is to obtain exact results on the statistics of the blocked con gurations reached by these systems, pursuing the eorts made by the authors of some recent works [18, 19, 20, 21, 22, 23, 24, 25, 26]. Thus doing we are able to critically revisit the questions raised above. In the derivation of these results we will take advantage of the fact that the zero-tem perature dynamics of these models can be rephrased in terms of random sequential adsorption (RSA) or cooperative sequential adsorption (CSA) [27], for which analytical techniques are available in one dimension. A blocked con guration thus appears as a jam med state of the corresponding RSA or CSA model. The Edwards hypothesis is, in this speci c context, akin to the question raised long ago [28] whether RSA con gurations are equilibrated or not. Our results con me that the answer is negative. A more extensive discussion will be given in section 5.

2 Constrained Ising chain

2.1 De nition of the model

Constrained Ising chains (CIC) [14, 15, 16, 17] are among the simplest examples of kinetically constrained models [13]. Although they have trivial equilibrium properties, the presence of kinetic constraints leads to slow dynamics at low temperature, and to metastability at zero temperature.

Consider a param agnetic Ising chain, made of independent spins $_n = 1$, submitted to a positive unit magnetic eld. This model has a Hamiltonian

with a unique ordered ground state, where all the spins are up ($_n = +1$).

K inetic constraints are introduced as follows. Consider single-spin- ip dynamics with rates

The rst factor in the right side is the Metropolis acceptance rate, ensuring detailed balance with respect to the Hamiltonian Hat temperature T=1=. The second factor imposes a kinetic constraint: the ipping rate of a spin depends on its environment, i.e., on the value of its neighbors n=1 and n+1. Let us make the choice [23]

The parameter 0 a 1 allows to interpolate between known limiting cases. For a = 1=2, the constraint factor is $\binom{n-1}{n+1}=2$, i.e., half the number of neighboring down spins. The symmetrically constrained chain (SCIC) [14, 15] is thus obtained. For a = 0, the constraint factor is n+1: the spin n can only ip if its right neighbor is down. The right asymmetrically constrained chain (ACIC) [16, 17] is thus recovered. Similarly, the left ACIC is obtained for a = 1.

At zero tem perature, the dynam ics of the CIC simplies drastically. An initially up spin ($_n = +1$) remains up forever, while a down spin ($_n = -1$) can ip at most once, according to stochastic rules depending on its two neighbors:

For a nite chain of N spins, the dynam ics stops after a nite jam m ing time $T_{\rm N}$, which depends both on the initial con guration and on the history of the chain. The jam m ing time will be shown to grow as $T_{\rm N}$ $\,$ ln N , up to nite uctuations given by extreme value statistics. The system is thus left after a nite time $T_{\rm N}$ in a jam med or blocked state.

This state, which is an attractor for the dynamics, is a spin con guration where each down spin is isolated, i.e., surrounded by two up spins. The blocked con guration thus obtained depends on the parameter a, on the initial con guration of the chain, and on its whole stochastic history.

The problem may be equivalently described as an irreversible process of particle adsorption. Consider indeed down spins as representing empty sites (), and up spins as representing occupied sites ():

The zero-tem perature dynamics of the CIC thus maps onto a problem of particle adsorption, where individual particles (monomers) are irreversibly deposited according to:

The deposition rate at site n depends on the occupation state of both neighboring sites. We are thus facing a cooperative sequential adsorption (CSA) model [27]. The limit (jam ming) coverage of this model is related to the mean magnetization per spin M (1) in the blocked con qurations by

In the following, we will use the language of spins, magnetization, spin correlations, and so on, leaving the picture of particle deposition for illustrative purposes only.

2.2 A priori statistics

We have shown that the attractors of the zero-tem perature dynamics of the CIC, for any value of the parameter a, are the spin con gurations where each down spin is isolated, i.e., surrounded by two up spins.

A natural statistical description of these attractors is provided by the a prioriensem – ble, or Edwards ensemble, as explained in the Introduction, where all the blocked spin con gurations are taken with equal weights.

For a nite chain of N spins, consider the restricted ensemble of blocked con gurations for which exactly n spins are down. Their magnetization M is such that N M = N 2n, with 0 n N = 2, hence 0 M 1. The number of such con gurations reads

Indeed this is the number of ways of inserting n down spins in the N n + 1 spaces made available by the presence of N n up spins, with at most one down spin per

space. This number grows exponentially, according to (1.1), where the a priori entropy reads [23, 25, 18]

One can also consider the full (or unrestricted) ensemble of all the blocked congurations, irrespective of their magnetization. The number N (N) of such congurations can be determined as follows. For a chain of N 3 spins, a conguration either ends with (+) (there are N (N 2) such congurations) or with (+) (there are N (N 1) such congurations). We thus obtain the recursion relation N (N) = N (N 1) + N (N 2), with N (1) = 2, N (2) = 3, hence

where F_N are the Fibonacci numbers. This expression is also equal to the sum of (2.4) for n ranging from 0 to N = 2. It grows as N (N) exp (N S_{av}^2), with

where = $(1 + {}^{p} - 5) = 2$ is the golden mean. The result (2.6) is the maximum value of the function S_{ap} (M) (2.5). This maximum is reached for

which is therefore the typical a priori magnetization of a blocked con guration.

The distribution of the number n of down spins in the a priori ensemble is given by

For a large sample (N 1), the probability density of the magnetization M is therefore given by an exponential estimate of the form

The result (2.8) has the form of large-deviation estimates in probability theory, which hold e.g. for the arithmetic mean of N independent random variables. The large-deviation function (or entropy function) $_{\rm ap}$ (M) will be plotted in Figure 4. It vanishes quadratically near M = M? as

The bulk of the a priori distribution of M is therefore asymptotically a narrow G aussian around M?, with a scaled variance given by N VarM 1=(2c)=4 5=25=0.357771.

The a priorientropy can alternatively be evaluated by the transfer-m atrix m ethod [29]. For a nite chain of N spins, we introduce the characteristic function of the magnetization

where the sum runs over all the blocked con gurations C. Note that N M (C) is the opposite of the total energy of the con guration, according to the H am iltonian (2.1), so that $Z_{\rm N}$ () coincides with the usual partition function of the model, at a ctitious inverse temperature .

The partition functions Z_N of a nite chain of N spins, labeled by the prescribed value $_N=1$ of the last spin, obey the recursion

The spin correlation function $C_n = h_0$ ni can also be evaluated in the a priori ensemble at xed magnetization by the transfer-matrix method [29]. We have, for n 0 in the bulk of an in nitely long chain,

The connected correlation function thus exhibits an exponential decay, modulated by an oscillating sign.

The full ensemble of blocked con gurations is obtained by setting = 0 in the above results, which indeed corresponds to taking a at average over all blocked con gurations. This prescription amounts to replacing the magnetization M by its typical value M? (2.7). We thus obtain in particular

We end up by mentioning that the blocked spin con gurations considered so far are the degenerate ground states of the antiferrom agnetic Ising chain in a constant magnetic eld h = 2J > 0 [30], whose Hamiltonian reads

As a consequence, the above expressions are exact results for the latter model at equilibrium at zero temperature. This is one of the simplest models with a non-zero entropy at zero temperature, given by (2.6).

2.3 Dynamics of cluster densities and magnetization

We now turn to the exact analysis of the zero-tem perature dynam ics of the C $\rm IC$, starting with the mean cluster densities and magnetization.

W e consider an uncorrelated m agnetized initial state, given by

so that the mean initial magnetization reads M (0) = 1 2p.

For p 1=2, the initial state (2.13) is the equilibrium state of the Ising chain with Hamiltonian (2.1) at inverse temperature

In particular, a random (unmagnetized) initial con guration, i.e., p = 1=2, corresponds to in nite temperature, i.e., 0 = 0.

It is a common feature of one-dimensional RSA and similar problems [27] that the densities of certain patterns, including active clusters, obey closed rate equations. Consider clusters of exactly ' 1 consecutive down spins. Their density per unit length at time t reads

Because zero-tem perature dynam ics is fully irreversible, the densities p (t) obey rate equations, which can be derived as follows. Clusters of length '= 1 are inactive. Consider a cluster of length '= 2, renum bering its sites as n = 1; :::; '. The spin n can ip from down to up, at a rate given by (2.3), thus generating one or two smaller clusters of the following length

G athering the contributions of all these events, we obtain the rate equations




Figure 1: Plot of the nalenergy E (1) against the initial energy E (0). Full line: C IC (2.23). D ashed line: ferrom agnetic chain with constrained G lauber dynamics (3.7). Long-dashed line: ferrom agnetic chain with constrained K awasaki dynamics (4.5).

The mean nalmagnetization of the blocked states reached by the dynamics thus depends on the parameter p characterizing the initial state. This non-trivial dependence demonstrates that the dynamics is not ergodic. For an initial state close to the ground-state (p ! 0, ie., M (0) ! 1), the behavior M (1) M (0) + $2\vec{p}$ is easily explained in terms of clusters of two down spins: the density of these clusters scales as p^2 , and only one of the two spins will ip. For a random (unmagnetized) initial conguration (p = 1=2, ie., M (0) = 0), we have

As this number is the nalm agnetization of a typical initial state, it is natural to compare it to the prediction (2.7) of the a prioriensemble. This comparison will be presented in Table 1. Finally, for the ordered initial state where all spins are down (p = 1, ie., M) (0) = 1, we have the smallest possible value of the nalm agnetization:

Figure 1 shows a plot of the nalenergy E(1) = M(1) against the initial one, E(0) = M(0), for the present model, as well as for the ferrom agnetic chain with constrained G lauber and K awasaki dynamics (see sections 3 and 4).

To close up, we present an analysis of the distribution of the jam m ing time T_N of a large but nite system of N spins, a question which does not seem to have been considered in previous works on R SA . Equation (2.21) shows that the late stages of the dynam ics are governed by an exponentially small density of surviving clusters made of two down spins, p_2 (t) e^t , with e^t . The dynam ics can therefore be e^t ectively described by a collection of N such clusters, each cluster decaying exponentially with unit rate, when a down spin ips. The jam ming time T_N is the largest of the decay times of those clusters. For a large sample, it is therefore distributed according to extrem e^t value statistics [31]. Setting

we not that the uctuation X_N remains of order unity, and that it is asymptotically distributed according to the G umbel law




Figure 2: D istribution of the jam m ing time T_N of CIC samples of N = 1000 spins, against X_N de ned in (2.26). Histogram: numerical data (p = 1=2). Thick line: limit Gumbel law (2.27).

We have checked this prediction by a numerical simulation. Figure 2 shows a histogram of the observed jam ming time T_N for 10^6 samples of N=1000 spins, starting with a random initial conguration. The bin size is T=1=10. An excellent agreement is found with the limit law (2.27), with p=1=2, hence p=1=2

2.4 Spin correlations

The time-dependent spin correlation function reads

The one-cluster function is the probability that the sites 1; :::;n belong to a cluster of at least n consecutive down spins. It is therefore directly related to p_n (t) de ned in (2.15) by

This result can be alternatively recovered by deriving rate equations for the one-cluster function itself. As a consequence of (2.2), each variable $_2$;:::; $_n$ $_1$ entering the definition (2.29) can ip from 1 to 0 with rate c_n (t) per unit time, while the rate for the rst variable $_1$ is ac_n (t) + $(1 - a)c_{n+1}$ (t), and the rate for the last variable $_n$ is ac_{n+1} (t) + $(1 - a)c_n$ (t). Gathering all the contributions, we obtain the equation




Figure 3: Connected spin correlation function in the nal states of the CIC. Full (open) symbols show positive (negative) correlations. Circles and full line: logarithm of $(1)^n$ times the connected correlation $C_n^{conn}(1)$ (2.40) for p=1=2, against n. Squares and dashed line: prediction (2.11), (2.24) of the restricted a prioriensemble. Triangles and dashed line: prediction (2.12) of the full a prioriensemble.

The rst term in the above expressions is the leading one, in plying that the connected correlation function has a factorial asymptotic decay of the form $(p(1 e^t))^n = n!$, modulated by an oscillating sign, for any value of p and any time t. This super-exponential fall-o is a characteristic feature of irreversible processes such as RSA [27]. This behavior is entirely missed by the a priori approach (2.11), (2.12), where correlations fall o exponentially, as they generically do in equilibrium systems. Figure 3 shows a logarithm ic plot of $(1)^n C_n^{conn}(1)$ against n, for a random initial conguration (p = 1=2), together with both predictions of the apriori approach, i.e., the full ensemble (2.12), and the restricted ensemble (2.11) where the exact magnetization (2.24) is imposed. Both predictions appear as straight lines on the plot. The exact value of $C_1^{conn}(1)$ is correctly reproduced in the restricted a priori ensemble.

2.5 Distribution of nalmagnetization and dynamical entropy We nally determine the full distribution of the number of spin ips and of the nalmagnetization, for a given nite sample. This problem was tackled long ago by a some-

what sim ilar approach [32] in the case of dim er deposition, without consideration of the dynamical entropy, though.

Single active cluster

We consider st the case of a single active cluster of size '2, with free boundary conditions, with all spins being initially down. In the language of deposition, this corresponds to an initially empty cluster. We are interested in the distribution of the number of spin ips (i.e., deposited particles) during the history of this cluster, until it reaches a blocked con guration. The nalmagnetization M of the cluster is such that

Table 1 provides a comparison between exact dynamical results for a random initial state (p = 1=2) and prediction of the full a priori ensemble, concerning the main characteristics (mean value and scaled variance) of the nalenergy of the three models considered in this work.




Figure 4: Full line: plot of the dynamical entropy of the C IC, given by $_{1=2}$ (M) (2.56), against magnetization M. Dashed line: prediction (2.5), (2.9) of the a prioriapproach.

Figure 4 shows a plot of the dynam ical entropy, de ned as being the large-deviation function $_{\rm p}$ (M) of (2.56) for a random initial con guration, i.e., p = 1=2, against the magnetization M of the nal state. The endpoint values read $_{\rm 1=2}$ (0) = \ln (8=3)=2 = 0.490415 and $_{\rm 1=2}$ (1) = \ln 2 = 0.693147. The prediction (2.9) of the a priori approach is plotted for comparison. The functions $_{\rm 1=2}$ (M) and $_{\rm ap}$ (M) respectively vanish for M (1) (2.24) and M $^{\rm 2}$ (2.7). These numbers are listed in Table 1, together with the corresponding lim it scaled variances.

3 Constrained Glauber dynamics

3.1 De nition of the model

We now consider a ferrom agnetic Ising chain with G lauber dynamics (non-conserved order parameter) in the presence of kinetic constraints. The Ham iltonian of the chain, with unit exchange constant, reads

where we have introduced the energy (bond) variables $s_n = n_{n+1}$.

We consider single spin-ip (G lauber) dynamics, assuming that the ipping rate only depends on the energy dierence between the congurations after and before the proposed move, i.e.,

The rate W $_0$, corresponding to diusive rearrangements at constant energy, remains a free parameter. The zero-tem perature limits of the Metropolis and heat-bath rules respectively correspond to W $_0$ = 1 and W $_0$ = 1=2. Here we choose

Each move suppresses two consecutive unsatistical bonds: $s_{n-1} = s_n = 1$! $s_{n-1} = s_n = +1$. The system eventually reaches a blocked state, where there is no isolated spin. Equivalently, each unsatistical bond (or domain wall) is isolated. Our aim is again to provide a statistical description of the blocked states reached in this way.

We recast the problem in terms of deposition, where empty sites represent unsatised bonds, while occupied sites represent satised bonds:

The blocked states are the spin con gurations where unsatis ed bonds are isolated. These blocked con gurations are therefore form ally equivalent to those of the C IC of section 2, up to the replacement of the spins $_n$ by the energy variables s_n . The H am iltonians (2.1) and (3.1) are also equivalent, up to the replacement $_n$! s_n . As a consequence, the entropy S_{ap} (E) of the a priori ensemble at xed energy E is still given by (2.5), up to the replacement of M by E.

3.2 Dynamics of cluster densities and energy

We again consider an initial state similar to (2.13), with $_0$ (0) = $_1$ at random, while each energy variable is drawn from the binary distribution

The triangles show the full spin correlation function $C_n(1)$, measured in a numerical simulation. For each sample, starting in a random initial conguration, the constrained dynamics is run until a blocked state is reached. The correlation function $C_n(1)$ is found to be positive and to decay monotonically to zero as a function of the distance n. The data shown correspond to a total of 10^{10} blocked spins. Both correlations are observed to fallo as 1=(n+1)!.




Figure 5: Spin and energy correlation function in the blocked states of the ferrom agnetic chain with constrained G lauber dynamics. Full (open) symbols show positive (negative) correlations. Circles and full line: logarithm of (1)ⁿ times the connected energy correlation $_{n}^{\text{conn}}$ (1) (3.8) for p=1=2, against n. Triangles and full line: logarithm of the full spin correlation function C_{n} (1), against n, measured in a numerical simulation. Dashed line: logarithm of asymptotic behavior 1=(n+1)!, up to a multiplicative constant, meant as a guide to the eye.

We now investigate the distribution of the number of spin ips and of the nalenergy, using the method of section 2.5.




Figure 6: Full line: plot of the dynamical entropy of the ferrom agnetic chain with constrained G lauber dynamics, given by $_{1=2}$ (E) (3.10), against energy E. Dashed line: prediction (2.5), (2.9) of the a priori approach.

4 Constrained Kawasakidynamics

4.1 De nition of the model

We nally investigate a ferrom agnetic Ising chain with conserved dynamics at zero temperature, in the presence of kinetic constraints.

Consider the ferrom agnetic chain with Ham iltonian (3.1), but now with Kawasaki dynamics, where only pairs of opposite spins ($s_n = n_{n+1} = 1$) may be ipped, so that the magnetization is locally conserved. Considering unsatisted bonds as empty and satisted bonds as occupied, as in (3.4), the moves (4.1) read

4.2 A priori statistics

We consider the restricted a priori ensemble of blocked con gurations with energy E. The entropy S_{ap} (E) of this ensemble can again be evaluated by means of the transfermatrix formalism. The partition functions of a nite chain of N spins, now labeled by the prescribed values of its last two bonds (or), obey the recursion

4.4 Spin and energy correlations

The energy correlation function $_{\rm n}$ (1) can be evaluated analytically, similarly to sections 2.4 and 3.3. In the present situation nalresults are, however, less explicit.

We consider the one-cluster function c_n (t) and the two-cluster function $d_{m;k,n}$ (t), dened in (2.29), (2.30). The rate equations obeyed by these functions, and the way to solve them, are similar to (2.34), (2.35).

Besides the conventions of section 2.4, only some of the terms are present in the right-hand side for either m or n = 1 or 2, namely those for which the underlined index is greater than 2. Furthermore, for k = 1 the sum $d_{\underline{m+2};k-2;n}(t) + d_{m;k-2;\underline{m+2}}(t)$ is replaced by $C_{m+n+1}(t)$. As in previous cases, we look for a solution to (4.7) of the form

The function D (x;1) has a simple pole at x=1, with residue $q(1)^2$, where $c_1(1)$ has been evaluated in (4.6), so that the $d_{1;k;1}(1)$ converge to $c_1(1)^2$ as the distance k becomes in nitely large, as it should. The fall-o of the dierence $d_{1;k;1}(1) = q(1)^2$, and that of the connected correlation function $conn}(1)$, are related to the behavior of D (x;1) as jxj is large. The result (4.8) leads to the estimate




Figure 7: Spin (site) and energy (bond) correlation functions in the blocked states of the ferrom agnetic chain with constrained K awasaki dynamics, measured in a numerical simulation. Full (open) symbols show positive (negative) correlations. Circles and full line: logarithm of the absolute value of the connected energy correlation $\binom{\text{conn}}{n}(1)$. Triangles and full line: logarithm of the absolute value of the full spin correlation $C_n(1)$. Dashed line: logarithm of asymptotic behavior $1=(2^n (n=2)!)$ up to a multiplicative constant, meant as a guide to the eye.

The result (4.8) does not however lead to any useful expression for $_{\rm n}$, even for n = 1. Figure 7 shows a logarithm ic plot of the spin and energy correlation functions against n, as measured in a numerical simulation for a random initial condition (p = 1=2). The data shown correspond to a total of 5 $_{\rm n}^{10}$ spins. Both the full spin correlation $_{\rm n}^{\rm conn}$ (1) = $_{\rm n}$ (1) E (1) are found to agree with the asymptotic result (4.9). The absolute value of the data follows the predicted fall-o , shown as a dashed line, while the signs roughly follow the predicted pattern (+ +), up to more and more seldom mistakes.

4.5 Distribution of nalenergy and dynamical entropy

We end up with the distribution of the nalenergy of a nite sample. This analysis will follow the lines of section 2.5 and 3.4, the main dierence being that (4.10) will have to be solved numerically.

We consider st the case of a single cluster of size '2, whose initial con guration is only made of unsatised bonds. Let be the number of spin ips of this cluster. Equation (2.41) is replaced by

In contrast with (2.44) and (3.9), we have not been able to solve the Riccati equation (4.10) analytically.

We now consider the naltotal energy $N E_N$ of a nite chain of N spins, with the initial state (3.5). The tails of the distribution of E_N are again given by an estimate similar to (2.8),




Figure 8: Full line: plot of the dynam ical entropy of the ferrom agnetic chain with constrained K awasaki dynam ics, against energy E. Data are obtained by solving numerically (4.10), (4.11), and (4.12), for p=1=2. Dashed line: prediction (4.2) of the a priori approach.

Figure 8 shows a plot of the dynam ical entropy $_{1=2}$ (E) obtained by solving num erically (4.10), (4.11), (4.12). The prediction (4.2) of the a priori approach is shown for comparison. For p = 1=2, we have $_{1=2}$ (1) = $_{1=2}$ (1=3) = $\ln 2$ = 0:693147 and N VarE 0:459839.

5 Discussion

We have presented a parallel study of the zero-tem perature dynam ics of three onedim ensional Ising models with kinetic constraints, to which a number of previous studies have already been devoted: paramagnetic CIC models [14, 15, 16, 17] (section 2), ferrom agnetic chain with constrained G lauber dynamics [18, 19] (section 3), ferrom agnetic chain with constrained K awasaki dynamics [20, 21, 22] (section 4).

The common characteristic feature of these models is that their zero-tem perature dynamics is fully irreversible: each spin can ip at most once during its whole history. As shown in the present work, these stochastic dynamical systems can be mapped onto models of irreversible deposition [27]: CSA of monomers () for paramagnetic CIC models, RSA of dimers () for the ferromagnetic chain with constrained Glauber dynamics, RSA of hollow trimers () for the ferromagnetic chain with constrained Kawasaki dynamics. This exact mapping onto RSA or CSA models allows the analytical determination of many physical quantities. Assuming an uncorrelated initial state with prescribed energy (or magnetization), we have obtained exact results for the three models, and compared them to the predictions of the apriori approach, testing thus the so-called Edwards hypothesis in this particular zero-temperature framework.

We have rst shown that the jam m ing time grows logarithm ically with the system size, up to nite uctuations given by extrem e-value statistics. The result (2.26), (2.27), established for the CIC, also holds quantitatively for the ferrom agnetic chain with constrained G lauber and K awasaki dynamics, with respectively $= p^2 e^{-2p}$ and $= p^3 e^{-2p-p^2}$.

There is a complete lack of ergodicity in these irreversible models. The mean nal energy indeed bears a non-trivial dependence on the initial condition, as depicted in Figure 1. For a random initial con guration, the comparison of the exact dynamical results for the average and variance of the nal energy with the prediction of the a priori (Edwards) approach reveals systematic di erences, which have either sign, and an absolute value ranging up to some 20 percent (see Table 1).

The two-point spin (site) and energy (bond) correlation function in the nal states has also been evaluated, either by analytical means or by accurate numerical simulations. Connected correlations fall of actorially (see Figures 3, 5, 7), often with an oscillating sign. A super-exponential fall-of correlations is indeed known to be generically obeyed in RSA models. Such a feature cannot be reproduced by an a prioriensemble, where correlations generically decay exponentially, with a nite correlation length, related to the rst two eigenvalues of the transfer matrix.

We have also determined the distribution of the energy of the nal states beyond the

Gaussian approximation. Such a problem seems to have been tackled only once in the RSA literature [32]. We thus obtain large-deviation estimates for the exponentially small tails of the distribution. The corresponding dynamical entropy depends on the initial energy (or magnetization). The comparison of the result for a random initial conguration (p = 1=2) with the a prioriapproach again shows dierences at a quantitative level (see Figures 4, 6, 8).

The results obtained so far invalidate the Edwards hypothesis in the present situation of fully irreversible zero-tem perature dynamics. There are indeed systematic dierences between the exact dynamical expressions and the predictions of the a priori approach, and even qualitative discrepancies, such as the super-exponential fall-o of correlations.

The present work also questions the existence of any simple relationship between the landscape of metastable states and the slow dynamics just above the dynamical phase transition. Indeed, on the one hand, all the results on the zero-tem perature dynamics of the CIC are independent of the parameter a, which interpolates between the ACIC for a = 0 or a = 1 and the SCIC for a = 1=2. On the other hand, these limiting cases are known to have dierent kinds of slow dynamics in the presence of activated processes, at low temperature. For instance, the relaxation time to equilibrium diverges as $eq = \exp(2)$ for the SCIC [15], and as $eq = \exp(2 - \ln 2)$ for the ACIC [17].

In spite of its specialty, the present approach may also shed some new light on other quantities and/or other situations of interest. One example is the size distribution of ordered clusters, which has been recently shown to be a useful tool to test the Edwards hypothesis in spin models under tapping [25]. In the present context the exact determination of the density f(1) of clusters of 'occupied sites in the nal states would require a lengthy calculation. However its exponential fallo for a large cluster size is related to the ground-state dynamical entropy as $f(1) = \exp(-ip)$. We thus obtain the simple estimate f(1) = (1-p), both for CIC and constrained Kawasaki dynamics, expressing that the long ordered clusters in the nal state have to be already present in the initial state, while the result f(1) = 2p 'see (3.11) for constrained G lauber dynamics is non-trivial.

Finally, the present situation of a quench from a disordered initial con guration (innite initial temperature) can be viewed as the relaxation part of a cycle of random tapping with in nitely high intensity. It would also be desirable to extend at least some of our results to the more realistic situation of a nite tapping intensity.
