# V ortex-vortex interactions in toroidally trapped B ose E instein condensates

#### Abstract

W e analyze the vortex dynam ics and vortex \{vortex interactions in Bose E instein condensates conned in toroidal traps. W e show that th is particular geom etry strongly distorts the vortex dynam ics. T he num erically calculated vortex trajectories are well explained by an analytical calculation based on im age $m$ ethod and conform alm apping. $F$ inally, the dissipation e ects are discussed.


## Introduction

The realization of $B$ ose E instein C ondensation ( BEC )
 the possibility to explore fundam entale ects of low tem perature physics in a very controllable way. In this sense, several e ects related to super uidity $\left.\underline{l n}^{\prime \prime}\right]$ have been recently reported $\overline{[q]}, \overline{1}, \overline{1} 1$. A $m$ ong the phenom ena related to super uidity, the possibility of observing vortioes w ith quantized circulation [1]d has aroused a big interest. D ue to the dihuteness of the atom ic condensates, accurate theoretical predictions are possible. In addition, in these system s , the diam eter of the vortex core is typically three orders of $m$ agnitude larger than for superuid $H$ elium, allow ing for a m ore straightforw ard optical observation. N um erous theoretical schem es have been suggested for the generation of vortioes in BEC, see e.g. Refs. [1] 1 niques have successfully generated vortioes in condensates, nam ely the stirring of a condensate w ith a blue detuned laser $[\overline{[1]}, r 1]$ " $]$, and the phase im printing $m$ ethod achieved via the coherent interconversion betw een the two com ponents of a binary condensate [ $\left.{ }_{2}^{2} 0_{1}^{\prime}\right]$. In addition the creation of a vortex ring after the decay of a dark soliton has been recently reported [211]. The dynam ics and stability ofvortioes in trapped Bose\{E instein condensates has recently also been a sub ject of active investigation $[2,24,2$

In the $m$ ajority of current BEC experim ents, the condensate is created in a cylindrical trap, either pancake\{ shaped, or cigar\{shaped. H ow ever, in the recent years the possibility of creating a BEC in toroidal traps has aroused a grow ing interest. Toroidal traps have already been used in early Sodium BEC experim ents at M IT [2] and in recent experim ents on vortioes at JILA [2]. A lso, very recently the idea of creating a toroidalopticaldipole trap using Laguerre-G aussian beam s has been proposed [2-6]. The physics of condensates in toroidal traps have been extensively investigated during the last recent years, including the ground state properties and elem entary excitations $\left.[2]_{1}, 281\right]$, the possibility to obtain vortices which due to the toroidal topology could be m_etastable beyond
 and properties of solitons and the so called "svortioes" in this kind of traps [ $\left.3_{1}^{1} 1\right]$, and even the possibility to obtain a m ode\{locked atom laser w ith toroidal geom etry [32]. Very recently, we have proposed that a tim e\{
averaged potential produced by the shaking of an usual Gaussian trap also leads to the form ation of a double well or a toroidal condensate [33]]. A dditionally, if during the condensate shaking a proper phase is im printed, dark solitons and eventually vortices can be created in a controllable way within the torus. In Ref. [3]in], it was already reported, that the particular toroidal geom etry signi cantly $m$ odi es the vortex dynam ics, as well as the vortex \{vortex interaction. It is the aim of this paper to extend the analysis of Ref. [3]']. W e analyze in detail the e ects of the geom etry for toroidalbox potentials, as wellas those produced by the sm ooth transversalcon ne$m$ ent. Interestingly, we show that the vortex dynam ics obtained from direct num erical sim ulations can be analytically well described by $m$ eans of the so \{called im age m ethod, and conform alm apping techniques. Finally we analyze the vortex dynam ics in presence of dissipation.

The structure of the paper is as follow s. In Sec. I we describe the physical system, as well as the num erical techniques em ployed. In Sec. a toroidal box potential, and introduce the im age technique, as well as the corresponding conform alm apping, to analytically describe the vortex dynam ics, as well as the vortex interaction. T he case of a toroidal trap with harm onic transversal con nem ent is considered in Sec. 'III, where the e ects caused by the sm ooth trapping potential are considered. Sec. 'IV'l is devoted to a brief discussion of the dissipation e ects in the system. W e nalize $w$ th som e conclusions in Sec . V .

## I. $\mathrm{M} O \mathrm{DEL}$

At su ciently low tem peratures, the dynam ics of a condensate in an extemal potential V can be well described by the so\{called $G$ ross $\{\mathrm{P}$ itaevskii equation [34, 325

where $g=\frac{4 h^{2} a N}{m}$ denotes the coupling constant, $m$ refers to the atom ic m ass, a is the corresponding $\mathrm{s}\{$ wave scattering length, and $N$ is the num ber of condensed atom s . W e shall consider in the present paper trapping potentials in which the condensate is strongly con ned along one direction, so that the $m$ ean eld energy is sm aller than the excitation energy of the trap in
this direction. In this situation, the BEC can be considered as quasi\{ 2 D , and we can restrict ourselves to the analysis of the corresponding 2D GPE, w th a m odi ed coupling constant $g_{2 D}=g \mathrm{dzj}(z) \frac{J^{4}}{}$, where $(z)$ is the $w$ avefunction in the strongly con ned $z$-direction. B oth
 observed in experim ents. $T$ he potential $V$ in the rem aining tw o dim ensions has an annular shape, which we shall consider possessing rigid box boundaries in Sec. iII, or ham onic transversalcon nem ent in Sec.Int. W e restrict ourselves in the follow ing to the situations in which the $B E C$ can be considered in the $T$ hom as\{Ferm i regim $e$, i.e. the $m$ ean $\{$ eld energy is $m$ uch larger than the typical energy spacing of the annular trap. W e consider in the follow ing num erical sim ulations the case of $\mathrm{N}=10^{5}$ condensed Sodium atom s ( $a=2: 75 \mathrm{~nm}$ ).

W e perform the integration ofequation [ $\overline{I I}_{1}^{\prime}$ ) by an alternating direction im plicit (AD I) C rank-N icholson schem e [ 4011 ', using cylindrical coordinates, due to the particular sym $m$ etry of the trapping potential. In the present paper, we shall not consider the issue of the experim ental creation of the vortices, but rather we shall concentrate on the vortex dynam ics once created. In order to num erically create the vortioes, we em ploy the $C \operatorname{rank}\{$ N icholson procedure in im aginary tim $e$, while ensuring at each tim e step the proper phase pattem necessary to create the vortices ["41']. This leads to the creation of vortex states, which are free of any other kind of excitation, and, therefore, allow for a clear analysis of the vortex dynam ics. The proper phase pattem im printed during the im aginary tim e evolution has to be carefilly chosen. In particular, the boundary e ects have to be taken into account in the $m$ ethod, by adding the corresponding phase contribution of the im age vortioes (see next section). O nce the vortices are created we perform a realtim e evolution.

## II. BOX\{LIKE TOROIDALTRAP

In this section, we investigate the evolution of vortex states in an annular trap w ith rigid boundaries. In such a trap the condensate density in the bulk is constant and shrinks to zero at the condensate boundaries on pa length scale of the order of the healing length $=1=8 \mathrm{na}$, $w$ here $n$ is the condensate density. D ue to the absence of the potential in the interior of the torus and the hom ogeneity of the density inside the box, the vortex dynam ics is com pletely determ ined by the toroidal geom etry. In our num erical sim ulations we have considered a trap w ith inner rigid boundary at a radius $\mathrm{R}_{1}=12 \mathrm{~m}$, and an outer one at $R_{2}=18 \mathrm{~m} . W$ e shall not consider, neither in this section nor in the next one, dissipation e ects. These e ects $w$ ill be discussed in Sec. $\overline{\mathrm{T}}_{-}^{-1} \cdot$

## Single vortex dynam ics

W e consider rst the situation in which a single vortex is placed in a toroidal trapped condensate. D ue to the boundary e ects the vortex w ill not rem ain at rest, but on the contrary it willm ove at a xed radius around the torus, where the direction and the $m$ odulus of the vortex velocity depends on its circulation, and on the radial position at which it is created. In $F$ ig. ${ }_{1} 11$, we present the num erical results for the vortex velocity as a function of the radial vortex position.

Such dynam ics can be well understood by em ploying
 review this m ethod. In a hom ogeneous (untrapped) condensate the phase of a state containing a q tim es charged vortex is given by $e^{i q \prime}$, where $'$ is the polar angle centered at the position of the vortex [42]. Therefore, the super uid velocity becom es $\psi_{S F} \quad h^{2} \bar{S}=m=h q=m \quad \theta$, where $S$ is the condensate phase and is the distance from the vortex line. In the follow ing, we shall only discuss vortioesw ith one quantum ofcirculation since, in the cases considered, vortioesw ith $q>1$ willdecay into $q=1$ vortioes. For trapped condensates in the $T$ hom as $F e r m$ i regim $e$, the hydrodynam ic form of the $G$ ross $P$ itaevskiiequation allow s to approxim ately im pose for the superuid velocity eld the boundary condition of ordinary hydrodynam ics, nam ely the vanishing of the norm alcom ponent of the super uid velocity eld at the condensate boundary [ 43 jid]. This boundary condition and the specication of the positions and circulations of the vortioes, leads to the determ ination of the super uid velocity eld [231]. M oreover, the vortex dynam ics in the hom ogeneous, and also in the boxlike trapped quantum gas, reproduces the classical vortex dynam ics, which is govemed by the $K$ elvin theorem, i.e. a vortex $m$ oves $w$ ith the sam e veloc-五y than the super uid at its position [4]. T his velocity can be calculated by em ploying a welliknown m ethod in classical hydrodynam ics, nam ely the replacem ent of the boundaries by additional ctitious vortioes, so called im age vortioes. These vortices $m$ ust be placed at the appropriate positions $w$ th the appropriate circulations, such that the resulting velocity eld obeys the boundary conditions for the considered geom etry.

For the toroidal geom etry in question, we have to take into account two (in principle in nite) fam ilies of im age vortices. For the rst fam ily, an im age vortex is placed at $x_{i m 1}=\frac{\mathrm{R}_{1}^{2}}{\mathrm{r}} \frac{\stackrel{x}{r}}{r} \mathrm{w}$ th circulation and one m -
 $x$ denotes the position vector of the real vortex in a fram e centered at the origin of the torus [4]. The im age vortex at $x_{\mathrm{im}} 1$ induces a velocity com ponent normal on the outer circle, so in addition we need an im age vortex at $\Upsilon_{\text {im 2 }}=\frac{\mathrm{R}_{2}^{2}}{r_{\text {im } 1}} \frac{\mathscr{r}}{\mathrm{r}}=\frac{\mathrm{R}_{2}^{2}}{\mathrm{R}_{1}^{2}} \mathbb{x} \mathrm{w}$ th circulation. In tum this im age will induce som e norm al com ponent on the inner circle, so two $m$ ore im age vortioes are required: one at $\mathscr{x}_{\text {im }} 3=\frac{R_{1}^{2}}{r_{\text {im } 2}} \frac{\mathscr{x}}{r}=\frac{\mathrm{R}_{1}^{4}}{R_{2}^{2} r} \frac{\mathscr{F}}{r} \mathrm{w}$ th circulation the other one at the origin $w$ ith circulation and
so on and so forth. For the second fam ily, one considens an im age vortex at $x_{i m 1}^{0}=\frac{R_{2}^{2}}{r} \frac{x}{r} w$ ith circulation
. This im age vortex gives a norm al com ponent of the velocity on the inner circle so we need in addition one im age vortex at $x_{i m}^{0}=\frac{R_{1}^{2}}{r_{\text {im }}^{0}} \frac{x}{r}=\frac{R_{1}^{2}}{R_{2}^{2}} x \mathrm{w}$ ith circulation as well as one im age vortex at the origin w th circulation . For this we require another im age vortex at $x_{i m 3}^{0}=\frac{R_{2}^{2}}{r_{i m}^{0} 2} \frac{\varphi}{r}=\frac{R_{2}^{4}}{R_{1}^{2} r} \frac{\varphi}{r} w$ ith circulation and so on.

The total super uid velocity is $m$ ade up by the contributions of all vortices (both real and im age):

In absence offriction, the super uid velocity at the vortex position equals the velocity of the vortex line. T herefore we get for the vortex velocity:

$w$ here $R_{1} \$ R_{2}$ denotes the sam e term as the precedent one, but $w$ ith $R_{1}$ and $R_{2}$ interchanged. This velocity eld is in good agreem ent w ith that calculated from our num erical sim ulations.

Vortex\{vortex interaction

W e can at this point analyze the vortex \{vortex interaction $w$ thin an annular trap $w$ th rigid boundaries. In a hom ogeneous condensate the vortex \{vortex interaction depends on their relative circulation. In absence of dissipation, vortices $w$ th the same circulation orbit at a xed distance from the central point betw een them. On the other hand, vortioes $w$ ith opposite circulation $m$ ove parallel to each other form ing a so\{called vortex pair, which moves as a whole w th a velocity which depends on the separation betw een the vortices. T w o vortices in a toroidalbox exhibit a com pletely di erent behavior. W e shall consider in the follow ing several possible scenarios.

V ortioes w ith the sam e circulation created at di erent radiibut at the sam e polar angle show a dynam ics very sim ilar to that of the hom ogeneous case: they perform deform ed orbits around each otherbut $w$ ith an overalldrift around the torus (see. Fig. ${ }^{\prime 2}$ ). . On the contrary, vortioes w ith opposite circulation created on the sam e radial coordinate, but at opposite positions in the torus show an interesting evolution, as already discussed in Ref. [3]-3']. A s show $n$ in $F$ ig. $\overline{i n}$, the vortices $m$ ove tow ards each other keeping the radial coordinate constant. W hen approaching, they $m$ ove radially, and separate on a new constant radius, i.e. e ectively they repel each other. W hen they $m$ eet at the other side of the torus, they repeleach other again, and retum to the original radial coordinate, i.e. the overall trajectory for each vortex is closed. If the vortex \{anti vortex \{pair is created such that the vortices are close to each other at the sam e polar angle, one vortex $m$ oves very quickly (during a few ms ) tow ards the condensate boundary, where it is destroyed. T he other onem oves slightly, changes its initial radialposition, and later on $m$ oves on a xed radius ( F ig. ' $\mathrm{I}_{1}^{\prime \prime}$ ). This e ect explains the results of $R$ ef. $\left[\begin{array}{c}3 \\ \hline\end{array}\right.$ ated in a toroidalgeom etry seem ed to decay into just one vortex, apparently violating the conservation of the angular $m$ om entum. The dark \{soliton actually decays into tw o vortices, but one of them is rapidly destroyed at the condensate boundary, while the rem aining one is set into an orbit around the annulus.

Em ploying, as above, the im agem ethod technique, the

the com puted solutions of the coupled di erential equations

ulations. Deviations from the num erical solutions of the GPE are basically due to deform ations of the vortex core (see Sec. $\mathrm{V}_{\mathrm{L}} \mathrm{T}_{\mathbf{\prime}}$ ), since the im age $m$ ethod does not take into account the intemal structure of the vortex core.

A nalytical results. C on form alm apping.

In this section, we obtain the analytical expression of the vortex velocities explicitely, by em ploying a m ethod which combines the previously presented in age $m$ ethod and conform alm apping techniques [23].

## A nalyticalm ethod

We introduce a com plex velocity potential $p(z=x+$ $i y)=(x ; y)+i(x ; y)$, such that $d p=d z=u \quad i w$ is the velocity $\mathrm{v}=(\mathrm{u} ; \mathrm{w}) . \mathrm{p}(\mathrm{z})$ has to be analytic everyw here except for singularities, and therefore ( $x ; y$ ) and ( $x ; y$ ) are both solutions to the Laplace equation. O ne of them can be chosen to be the realvelocity potential : $r=w$. The curves $=$ constant and $=$ constant intersect in right angles and correspond to the equipotential and stream lines. It can be easily seen, that

In presence of rigid boundaries the velocity eld is constrained to have a vanishing norm al com ponent at the boundaries and, therefore, since the ow is alw ays in the direction of the stream lines, the boundaries correspond to curves of constant ( $x ; y$ ). O ne can always arrange $p(z)$ such that this constant is zero, so one has Im $[p(z)]=0$ for all $z$ at the boundary, where Im indicates im aginary part. T he potential $p(z)$ is constructed from the $G$ reen's function of the corresponding boundary value problem, by superposing the contribution of the N vortioes to the ow 45ㄴ․․

The term $f(z)$ allow s for somefirther ow due to $m$ oving boundaries. The function $g\left(z ; z_{j}\right)$ accounts for the constraints and it is sm ooth at the position of the vortioes. It can be thought of as the com plex potential induced by the im ages. Therefore, the velocity of the $j$-th vortex is given

which is an integralofm otion in the case of xed boundaries. N ote, that contrary to the situation considered in electrostatics, there is no contribution from fund $\left(z ; z_{j}\right)$ at the position of the vortex, since a vortex (possessing cylindrical sym $m$ etry) does not act on itself.

For com plicated geom etries the velocity potential and the K irchho R outh function are di cult to calculate. In order to sim plify one can $m$ ap the com plex plane which contains the complicated boundary value problem into another com plex plane where the boundary geom etry is sim pler. A $m$ apping $F(z)$, which carries the $z-p l a n e$ into the -plane, $=F(z=x+i y)=s(x ; y)+i t(x ; y)$, is called conform al if $F(z)$ is, apart from isolated points, an analytic function of $z$, the inverse $m$ apping $z=H()$ exists, and H ( ) is an analytic function of . A conform alm apping m aps continuous curves (in particular the boundaries) into continuous curves, and the solutions of the Laplace equation into solutions of the Laplace equation, i.e. if the boundary value problem in the original plane is ful lled, then it is also ful lled in the new plane $w$ ith the new boundaries beeing the $m$ appings of the original ones. The transform ation behaviour under the conform alm apping:

## O ne vortex in the torus

Let us rst calculate the velocity of one vortex in the torus. As already shown, the im age con guration is slightly com plicated. Let us now assum e that the torus is centered at the origin of the slitted com plex $z-p l a n e$ $w$ ith radii $R_{1}$ and $R_{2}$ respectively. $T$ he $m$ apping:

which $m$ aps the in nite strip to the upper halfplane and the boundaries of the in nite strip in the plane onto the real axis in the -plane. W e denote the position of the vortex in the plane as 1 and in the -plane as 1. In the -plane it is su cient to consider one im age vortex at position ${ }_{1}$ to ful 11 the boundary condition. The com plex velocity potential in the -plane is therefore given by

This analytical result is com pared in $F$ ig. ${ }^{-11} \mathbf{1}$ w th the results obtained from the direct sum $m$ ation provided by the im age $m$ ethod. The agreem ent is, as observed, excellent.

## Two vortices in the torus

Let us now consider two vortices in the tonus. We calculate rst the velocity of the $j$-th vortex in an in nite strip of $w$ idth $b$, containing tw o vortioes. A fter applying again the $m$ apping (1-5), and follow ing the sam e notation as in the previous section, the com plex potential in the new coordinates is $m$ ade up of the contributions of the tw o real vortices and tw o im age vortices:

ries as curves of constant $K$ irchho $R$ outh function (see Fig. . ${ }_{\underline{1}}^{1 / 2}$ ).


Since the $K$ irchho $R$ outh function is for $x e d$ boundaries a constant of $m$ otion, we obtain from this equation inform ation about the vortex trajectories by com puting the hyper surface on which the $K$ irchho function is conserved. In particular we investigate the case of the vortex-antivortex pair, where the vortices are in itially placed on the sam e radial coordinate. D ue to sym $m$ etry considerations it is clear, that the vortioes w ill alw ays stay on the same radial coordinates $r_{1}=r_{2}$ and $w$ ith this know ledge it is easy to com pute the vortex tra jecto-

$w$ ith $i ; j=1 ; 2$, where $i \notin j$. In this formula one has to take into account, that the azim utal seperation betw een the vortioes fullls $j_{i} \quad j j \quad . W$ e have num erically solved the rst\{orderdi erentialequations resulting from this velocity eld, and obtained the vortex trajectories, whose shapes are practically indistinguishable from the ones we obtain by num erically solving ( $\underline{L}_{1}^{\prime}$ ).

## III. HARMONIC TOROIDALTRAP

W e discuss now the dynam ics of vortioes in a toroidal geom etry w ith harm onic trapping in the radialdirection:

As before we consider a quasi\{2D condensate in the Thom as Ferm iRegime. In order to com pare with the previous calculation for a box $\{$ like annulus, the trapping frequencies are adjusted such that the Thom as\{Fem i radii correspond to an annular condensate $w$ ith inner radius of 12 m and outer radius of 18 m . The qualitative dynam ic of the vortices is unchanged from that in the box \{like case, but the tim e scales are di erent. D ue to the inhom ogeneity of the trapping potential a vortex w ill no longer only m ove with the super uid velocity. In addition it w ill have som e velocity w ith respect to the super uid, resulting from the sm all deviation from the cylindrical sym $m$ etric vortex state caused by the potential.

This velocity can be calculated by the $m$ ethod of m atched asym ptotic expansion $\left.[4] \bar{T}_{1}, 441\right]$, consisting in evaluating the form of the solution ofequation ( $\underline{1}_{1}^{1}$ ) in the vortex core and far aw ay from it. T he vortex velocity can be calculated by the requirem ent that the asym ptotic behavior of the tw o solutions has tw o coincide at a distance of the order of the healing length from the center of the vortex. T he calculation yields [4d]:

$w$ here $x_{0}$ denotes the position of the vortex and $T_{F}$ is the $T$ hom as\{Ferm i wave function. Since the deviation from the cylindrical symm etric vortex solution in the sm ooth potential is sm all, we neglect com pletely their $e$ ect on the velocity eld induced by the vortex. T herefore, we can em ploy again the im age $m$ ethod for determ ining the velocity eld ful lling the boundary conditions. Therefore, the total velocity eld results from adding to the eld calculated in the previous section that of ( $2 \underline{g}_{1}^{\prime}$ ). This produces a very good agreem ent w ith our num erical results, as observed in Fig.'IG.
$T$ he in uence of the potential on the vortex velocity gives the possibility to controland $m$ anipulate the vortex dynam ics by adiabatically changing the trapping potential. For instance, it is possible to revense the direction of

 sider the above investigated boxlike toroidal trap, where we create one vortex. If one im poses a slow ly increasing linear slope on the initially at ground of the box the contribution of $\left(2{ }_{2}^{2}\right)$ ) eventually becom es $m$ ore im portant then the boundary e ects, and the vortex tums backwards.

## IV. D ISSIPATION EFFECTS

In this section, we discuss how dissipation a ects the vortex dynam ics in a toroidalgeom etry. Follow ing a sim ilar analysis as in $R$ ef. [ functional

for a condensate containing a vortex-anti-vortex pair $w$ ith cylindrically sym $m$ etric vortex cores, for the vortex lines placed at the sam e radial coordinate $r$, but at di erent angles 1,2 (see Fig. , $_{1}^{1}$ ). Since the GPE describes a Ham iltonian evolution and it does not include any dissipation, the tra jectories of the vortices according to the GPE are curves of constant energy. H ow ever, if the vortices approach each other (or the boundaries) to a distance com parable to the healing lenghth, the vortex cores deform and the trajectories we obtain num erically slightly di er from these energy lines. T he total energy increases w ith increasing distance betw een the vortioes, or betw een a vortex and the torus boundaries, because the kinetic energy grow s rapidly in this case. T herefore, we expect that in presence of dissipation, the vortices w ill tend to m ove tow ards the trap w alls [241]. In addition, the vortices w illtend to reduce the distance betw een each other, and therefore, if the vortices do not collide w ith the walls, the apparent repulsion introduced by the toroidal geom etry will be eventually overcom e, and the vortices w ill eventually collide, and m utually annihilate, as in hom ogeneous condensates.

V. CONCLUSIONSAND OUTLOOK

In this paper, we have investigated the vortex dynam ics and vortex \{vortex interaction in an annular trapping
geom etry. The vortex tra jectories in the presence of rigid boundaries have been obtained num erically by direct nu$m$ erical com putation of the corresponding 2D GPE.W E have show $n$ that these tra jectories can be well described by closed analytical form ulas, obtained from the combination of the im age $m$ ethod and conform alm apping. A dditionally, we have considered the case of ham onic transversal con nem ent, and showed that the num erical results are in excellent agreem ent $w$ ith the analytical ones, once included the e ects of the inhom ogeneous trapping potential calculated from the corresponding $m$ atched asym ptotic expansion.

W e should note at this point, that the im age $m$ ethod is applicable, w hen the vortioes are spatially separated by a distance greater than their core size, which is of the order of the healing length. T he latter statem ent also concems the distance betw een the vortioes and the boundaries. If this is the case, no deform ation of the vortex core is produced. H ow ever, if the vortices approach to distances com parable to the core size, the in itially cylindrical sym $m$ etric vortex cores experience evident deform ations and therefore, the results provided by the im age $m$ ethod begin to depart from the num erically obtained ones. Sim ilarly, the dynam ics of vortioes in the quantum gas begin to di er signi cantly from the classical theory $\overline{4} \overline{4} \overline{4}^{\prime} \overline{4}_{2}^{9} 1$.

The analysis of the vortex dynam ics has been lim ited to the case of 2D traps. Low er dim ensional condensates are currently actively investigated, and very recently the experim ental observation of 2D (and even 1D) condensates have been reported $[\overline{3} \overline{1}, 1, \overline{3} \bar{q}, \quad, \overline{3}]$. H ow ever, the results of the present paper and Ref . $\left[3 \mathrm{~B}_{2}\right]$, open interesting questions conceming the behavior of vortioes in 3D toroidal condensates. P relim inar results conceming vortex lines parallel to the torus axis, con $m$ that in a 3D torus an essentially sim ilar picture as that discussed for 2D is obtained. H ow ever tiltings w ith respect to the torus axis, together w ith boundary e ects, could lead to a signi cant bending of the vortex lines. This e ect will affect the observability of the vortioes, since the density $m$ inim um will depart from the direction of experim ental observation. In addition, the bending will signi cantly distort the vortex dynam ics, introducing an additional radial velocity to the vortex line. The vortex \{vortex interaction is also expected to be signi cantly a ected in the presence of a signi cant bending. The analysis of these e ects, as well as those related w ith the propagation and interaction of vortex rings in toroidalgeom etries will be the sub ject of further investigation.
