Odd-even binding e ect from random two-body interactions

System atic odd-even binding energy di erences in nite m etallic particles are usually attributed to m ean- eld orbital energy e ects or to a coherent pairing interaction. We show analytically and num erically that a purely random two-body H am iltonian can also give rise to an odd-even staggering. We explore the characteristics of this chaotic mechanism and discuss distinguishing features with respect to the other causes of staggering. In particular, random ness-induced staggering is found to be a sm ooth function of particle num ber, and the mechanism is seen to be largely insensitive to the presence of a magnetic eld.

I. IN TRODUCTION

Interacting nite ferm ionic system s such as atom ic nuclei, metallic clusters [1], and small metallic grains [2] display an odd-even staggering in ground-state energies, ie, the binding energy of an even-number system is larger than the arithm etic m ean of its odd-num ber neighbors. There are two well-known mechanisms that can give rise to this staggering, namely the K ramers degeneracy in the mean-eld Ham iltonian and the BCS mechanism arising from an attractive e ective interaction. In nuclei, the BCS pairing mechanism resulting from a residual nucleon-nucleon interaction is dom inant [3], but the mean-eld or orbital energy e ect may also be significant in the lighter nuclei [4]. Surprisingly, many basic phenem on a norm ally associated with pairing can also arise from random interactions. The behavior of random interaction ensembles has mostly been studied in a nuclear physics context [5{11] but there has also been som e study of spectra in the context of sm all m etallic grains [12].

In the case of m etallic clusters of fewer than a hundred atom s, the orbital energy e ect is rather strong and staggering is seen for species that do not exhibit superconductivity. This e ect can be easily understood using a fellium modelor density functional theory [13]. On the other hand, the staggering e ect seen in R ef. [2] m ay have some contribution from the BCS pairing mechanism. A num ber of theoretical studies have been made [14] using techniques applicable to large nite systems [15]. Taking a uniform mean-eld spectrum and an attractive pairing interaction with constant coupling, one observes a smooth crossover from BCS superconductivity in the bulk to the few-electron regime. For small systems, the gap is of the size of the mean level spacing and thus ceases to be an indicator for pairing. Nevertheless, strong pairing correlations and odd-even staggering persist as the system size decreases.

In a grain with irregular boundaries, one expects that

the electron orbitals will have a chaotic character and therefore the interaction will have a random as well as a regular part. In this paper we will introduce such an interaction and study its typical e ects on the binding system atics. Our Ham iltonian thus includes attractive and repulsive pairing interactions as well as more general two-body interactions. The assumption of random ness is motivated as follows: For nuclei it is well known that the residual interaction leads to uctuation properties in wave functions and energy levels that are similar to those of random matrices taken from the Gaussian orthogonal ensemble [16]. In the case of small metallic grains or quantum dots, one may assume that their irregular shape leads to chaoticity in the single-particle wave functions [17]. This in turn causes random ness in those two-body matrix elements that link four di erent orbitals with each other. M atrix elements between pairs of orbitals that are related by tim e-reversal symmetry need not necessarily be random , and these determ ine the \coherent" term s of the interaction.

A realistic Ham iltonian for quantum dots or small m etallic grains would thus conserve total spin and include spin-independent one-body terms, random twobody interactions, and coherent interactions that are non-random but have attractive and repulsive components. The most general Ham iltonian to study generic properties when all these features are included may be written as

Here the coherent parts of the interaction are represented by the term s w ith coe cients u, w_s , and q. The

Sented by the terms with ODE Charles th, w_s , and g. The uctuating parts of the interaction are represented by the term s containing u^0 , w_s^0 , g^0 , and v_s . These uctuating parts are typically taken from ensembles with a G aussian distribution; they are thus characterized by the width of the G aussian. The single-particle term "i sets the energy scale and m ay offen be taken to give a uniform spacing of levels without loss of generality. This full H am iltonian is di cult to study due to its m any parameters. There have been m any studies in the limit in which uctuation effects are only included in the single-particle H am iltonian "i [18{21]. We consider a very di erent limit, neglecting the coherent terms in the interaction and assuming the v_s term to dom inate the uctuating parts. Properties of such random two-body interaction ensembles have been studied extensively in nuclear physics [22{25].

W hen the H am iltonian of the nuclear shell model was modeled in this way, it was found that the spectral properties were quite regular for the ground states. As examples we mention $J^P = 0^+$ ground-state dom inance in shell model calculations with random interactions [5{9], band structure in interacting boson models with random couplings [10], structure in ground-state wave functions of two-body random ensembles [26], and an odd-even binding e ect in lling a large shell [11]. In the context of quantum dots, the random two-body interactions were found strongly to favor singlet ground-state spins [12,27]. Recently, this structure has been investigated using the group symmetry of the random H am iltonians [28]. These

ndings suggest that the structure of interacting m anybody systems is to some extent already determ ined by the rank of the interaction alone, and one does not need all the details of the interaction. We will show that oddeven staggering also ts into this picture and is not solely a consequence of an attractive pairing force.

This paper is organized as follows. In Section II we introduce the H am iltonian and discuss the odd-even effects arising from the one-body part alone. Section III contains analytical results for the odd-even staggering due to a random two-body interaction (some technical details of this analytical analysis are included in an Appendix). The crossover between the mean- eki regime and the regime of strong interactions is numerically investigated in Section IV. The elects of breaking time-reversal symmetry are studied in Section V. Finally, we give a summary.

II. HAM ILTON IAN AND STAGGER ING INDICATOR

As discussed in the introduction, we will consider ensembles of H am iltonians including only a single-particle energy and a random two-body interaction. We write this in the form

The rst term represents the mean-eld contribution, where "i is the single-particle energy associated with orbital i, and $c_{i^{n}}$, $c_{i\#}$ are the one-particle annihilation operators for that orbital. As usual, we assume an ordering "i "i+1. The second and third terms represent the interaction for pairs having spin S equal to 0 and 1, respectively. The operators A in the second term are spin-singlet two-particle annihilation operators $A = (c_{i\#}c_{j^{m}} \quad q_{\mu}c_{j\#}) = 2(1 + i_{j})$ with standing for the set of orbital pairs ij. The A in the third line are similarly de ned for spin-triplet pairs.

The random ness assumption tells us that there is no preferred basis within either the S = 0 or S = 1 sector of two-body states. The couplings $v_s \rightarrow$ then should be taken from the Gaussian orthogonal random -m atrix ensemble (GOE).We x the variance of the y to be unity for o -diagonal elements. The GOE then satis es

where h i indicates an ensemble average and similarly for $v_1 \, \circ$. We are concentrating for now on the case of time-reversal symmetry, so the matrices v_0 and v_1 are real and symmetric. The case of broken time-reversal symmetry in the presence of a magnetic eld will be considered in Section V.

The prefactors C_0 and C_1 allow us to consider arbitrary strengths of the spin-0 and spin-1 couplings relative to each other and relative to the single-particle level spacing. As we will see below, several qualitatively di erent regimes for ground-state staggering are possible within this simple random model, depending on the values C_0 and C_1 as well as on particle density.

Let us denote the ground-state energy of the N -body system as E (N). A useful staggering indicator is the empirical pairing gap

This three-point observable is essentially the \curvature" or second derivative of the binding energy with respect to particle number N . Positive (negative) (N) indicates that the binding energy of the N-body system is larger (sm aller) than the arithmetic mean of the binding energies of its neighbors. We have an odd-even staggering whenever (N) staggers with N.

It is instructive to consider the trivial case where residual interactions are negligible, i.e., $C_0 = C_1 = 0$. Then the N particle ground-state energy is given by E(N) =

Thus, there is a trivial odd-even staggering due to the mean-eld alone. In what follows we will mainly be interested in the elds of interactions, and in the elds of adding a magnetic eld. For odd-number systems, a nonzero value of the empirical pairing gap must be due to interactions, and this allow sone easily to discriminate mean-eld elde ects from interactions. Such a discrimination is more di cult for even-number systems and has recently been studied in mean-eld plus pairing Ham iltonians [4,29,30]. We will see in Section IV how mean-

eld e ects can be distinguished from staggering caused by com plex (or random) interactions. Note that an electric charging energy $E_{charge} = cN$ (N 1) leads only to a N -independent constant shift (N)! (N) + c and can therefore be neglected.

III.EFFECTS FROM RANDOM TWO-BODY INTERACTIONS

W enow in agine the opposite situation from that of the previous section, i.e., we consider the regime $"_i = 0$ where m ean- eld e ects are negligibly weak compared with the random two-body interaction. In this limit one might assume that all odd-even e ects should disappear. Supprisingly, this turns out not to be the case. Instead, we

nd persistent odd-even staggering arising only from the random two-body interactions; stronger binding energies for even-N systems are typically obtained in num erical simulations.

To understand this result analytically, we rst note that the spectral density of a system with two-body interactions approaches a G aussian shape in the many-body lim it N ! 1 [31,32]. The ground-state energies for different particle number or spin sectors are then largely determined by the widths TrH² of the corresponding G aussians, scaling as

where it is assumed without loss of generality that TrH = 0. The prefactor b depends of course on the details of the deviations of the spectral shape from an exact G aussian form, since these deviations cut o the tails of the G aussian. Following an analysis along the lines of Ref. [31], where the spectral shape is expanded in terms of Herm ite polynomials, and then estimating the coe cients of these polynomials, one may conjecture that the prefactor b should scale as $\log N$ with the number of particles in the system. In any case, for our purposes it is succient that this prefactor varies smoothly with N without

signi cant staggering, which is con med by numerical simulations. Eq. (6) is known to provide a good qualitative explanation for some observed behavior of low-lying spectra, even for moderate numbers of particles where the G aussian approximation is far from valid. For exam – ple, a comparison of TrH² for di erent spin sectors helps to explain J = 0 total spin dom inance among the ground states of random interacting many-body systems [12,27].

A.D ilute lim it

Applying this approach to the present problem, we need then to understand how TrH² depends on the num – ber of particles and other parameters of the system. For simplicity, we consider rst the dilute limit N M with a pure S = 0 two-body coupling ($C_1 = 0$).

From previous work, it is known that for even N the ground state comes always from the sector of total spin J = 0. In the dilute limit, a typical basis state in this sector has the form

where the N orbitals i_z , j_z are all distinct. One easily checks that the number of S = 0 pairs in this state is (N² + 2N)=8, since the particles on orbitals i_z and j_z for a given z are in an S = 0 combination by construction, while the remaining (N² 2N)=2 pairs have a probability 1=4 of being in a singlet combination. Any of these S = 0 pairs, labeled by ⁰ in Eq. (2), may be annihilated by the C₀ term in the Ham iltonian. A nother S = 0 pair, n ust then be created; there are M²=2 choices for in the dilute lim it. Thus, sim ply by counting the number of terms in the C₀ part of the Ham iltonian in Eq. (2) that may act on a total spin J = 0 basis state we nd

Sim ilarly, for odd N the preferred m any-body ground state has total spin J = 1=2. The typical basis state has the form

where we take $J_z = +1=2$ without loss of generality, and the indices i_z , j_z , and k are all distinct. This state contains only (N² + 2N 3) singlet pairs, resulting in

The O $(1=N^2)$ di erence in the widths explains the oddeven staggering in ground-state energies. Intuitively, the result is easy to understand: the ground state of the odd-N system is forced to have a slightly higher total spin, resulting in a slightly smaller fraction of spin-O pairs and consequently a smaller e ect of the C_0 term in the H am iltonian. This in the end is what leads to weaker binding for the odd-N system.

The above analysis also gives a quantitative prediction for the size of the staggering e ect. A sum ing in accordance with Eq. (6) that the ratio of ground-state energies is proportional to the ratio of the widths, we nd

for large N in the dilute lim it and therefore

to leading order. We may compare this with the size of the pairing gap for the mean-eld dom inated system. In the previous section, we saw that (N) = =2 on average for N even, where is the mean level spacing of the single-particle spectrum. This can be norm alized, how - ever, in units of the binding energy. This binding energy, i.e., half the many-body spectral width, is $f \ge j$ M N =2 in the mean-eld case. So the average pairing gap has the size

for even N , which surprisingly is smaller than the pure interaction-induced pairing gap in the dilute lim it N M .

At nite particle density = 2N = M, mean-eldinduced and interaction-induced stagger are of com parable size, a characteristic di erence being the vanishing of the pairing gap (N) for odd N in the mean-eld case, Eq. (5), which is absent for the pure interacting theory. In addition, in the presence of uctuations in the single-particle spectrum, mean-eld induced (N) will itself uctuate between successive even values of N, while interaction-induced stagger is predicted to be smooth. These analytic predictions will be veried numerically in Sec. IV below.

B.G eneral results for nite density

The above derivation, though strictly valid only in the dilute limit, in fact provides a correct intuitive explanation of the stagger at any density for a pure S = 0 two-body interaction. Handling the S = 1 interaction requires more care, since the qualitative behavior will depend strongly on the density . We therefore need the exact expressions for TrH² in various particle number and spin sectors. These expressions m ay be straightforwardly, though perhaps rather tediously, obtained by applying the original Ham iltonian, Eq. (2), to various basis states and evaluating the norm.

The full results are presented in the Appendix. There we nd that for a pure singlet random interaction, the prediction of Eq. (12) for the size of the staggering, obtained above only in the dilute lim it, is in fact con meed as a lower bound for arbitrary densities in the many-body lim it N ! 1 :

The situation is more complex for a pure triplet coupling ($C_0 = 0$), since here the ground state m ay be a state of either m inimal or maximal spin. In this case we see using formulas given explicitly in the Appendix that a critical density crit exists below which there is no staggering, while above which interaction-induced staggering of order $\not \equiv (N) \not \ni N^2$ appears, just as in the singlet case. As the singlet coupling is turned on, crit decreases, reaching 0 at $C_0 = C_1$. Thus, odd-even staggering with stronger binding for even-N systems is predicted to be a very general consequence of random two-body interactions, present for pure-singlet and pure-triplet interactions as well as in the interm ediate case.

IV.CROSSOVER BETW EEN MEAN-FIELD REGIME AND STRONG TW O-BODY INTERACTIONS

The analytical results of the previous sections were obtained for pure one-body or pure two-body interactions. In this section we will study the odd-even staggering for the full H am iltonian (2) num erically. To this purpose we draw the random matrices v_0 and v_1 in Eq. (2) from the GOE and compute the ground-state energies of H am iltonian of Eq. (2) for several particle numbers N. This procedure is repeated m any times for each N to obtain ensemble-averaged values for the ground state energies E (N) and the empirical pairing gap de ned in Eq. (4). In what follows we set the number of single-particle orbitals to M = 10, and obtain ensemble averages from 200 runs. The largest matrices of the ensemble have dim ension 63504; their ground states are computed using the sparse matrix solver A rpack [33].




FIG.1. Empirical pairing gap as a function of particle number for parameter ' = 0 (full line), ' = =12 (dashed line), and ' = =2 (dotted line; graph scaled by a factor 1=2 for display purposes) shows the transition from the mean-eld regime to strong interactions in the spin-0 channel.

We have to assign values to the single-particle energies " $_{i}$ of the mean eld and to the coupling constants C₀ and C₁ of the two-body interactions. We assume a meanel spectrum with level spacings " $_{i+1}$ " $_{i}$ that are W ignerdistributed. This is consistent with the assumption that our quantum dot or metallic grain has irregular shape. To study the transition, we multiply the single-particle energies with a factor cos' and set the spin-0 coupling C₀(') = sin'. Here ' is in the range ' 2 [0; =2] and thus parameterizes the transition from the mean eld to the regime of strong interactions. The spin-1 coupling C₁ is set to zero. Figure 1 shows the empirical pairing gap (4) as a function of particle number N for parameter values = 0; =12; =2.

We see from Figure 1 that the odd-even staggering persists throughout this transition. In the absence of the mean eld (==2), the staggering decreases slow ly with increasing N and then increases again very close to the maximal lling, when the number of holes becomes approaches unity in Eq. (A4). Its envelope sm all and depends smoothly on N if only even or only odd values of N are considered. These qualitative results are fully consistent with the analytical predictions obtained in Sec. III and in the Appendix. The absence of such a smooth envelope thus indicates that the staggering is instead dom instead by mean-eld e ects, as in the ' = 0line in Figure 1. Sim ilar observations have been m ade for pairing-plus-quadrupole in Ref. [29]. Note that the random interactions drive the empirical pairing gap (N) to negative values for odd N; in this sense the staggering is more pronounced in the presence of interactions than in the mean-eld regime. Note also that the magnitude of the staggering itself contains only little information since the transition from the noninteracting to the interacting Ham iltonian does not correspond to a transition in a physical system .




FIG.2. Empirical pairing gap as a function of particle number for parameter ' = 0 (full line), ' = =12 (dashed line), and ' = =2 (dotted line; graph scaled by a factor 1=2 for display purposes) show s the transition from the mean-eld regime to strong interactions in the spin-1 channel.

W e repeat these calculations in Fig. 2 for the case of vanishing spin-0 coupling, $C_0 = 0$, and set the spin-1 coupling to $C_1(') = \sin'$. Again, odd-even staggering persists throughout the transition. In the regime of strong interactions the m agnitude of the empirical pairing gap increases with increasing N for even N. The situation is reversed for odd values of N. Leaving out very sm all systems (N = 3), the envelopes for even and odd N are still sm ooth enough to discriminate mean-eld e ects from interaction-induced pairing.




FIG.3. Empirical pairing gap as a function of particle number for parameter ' = 0 (full line), ' = =12 (dashed line), and ' = =2 (dotted line; graph scaled by a factor 1=2 for display purposes) shows the transition from the mean-eld regime to strong interactions.

Finally, we consider the case of equally strong spin-0 and spin-1 couplings and set $C_0(') = C_1(') = \sin'$. Figure 3 shows that this case is qualitatively similar to the case of pure spin-1 coupling, since triplet pairs outnum ber singlet pairs by a 3:1 ratio in the large-N lim it. Again, the interaction-induced staggering exhibits a sm ooth envelope and can therefore clearly be distinguished from mean- eld e ects.

V.MAGNETIC FIELD EFFECTS

BCS-like pairing results from strong correlations between ferm ions in time-reversed orbitals. Thus, these correlations can be destroyed by a su ciently strong breaking of tim e-reversal symmetry. Examples of this well-known phenomenon are the breakdown of electronic superconductivity in the presence of su ciently strong magnetic elds and the reduction of pairing correlations in rapidly rotating and deformed nuclei. In this section we want to study how breaking tim e-reversal symmetry a ects the odd-even staggering in systems with a random two-body interaction. Having metallic grains in mind we thus consider the e ect of a magnetic eld. To be de – nite, we take a uniform B – eld in the z-direction. This leads to Zeem an splitting and adds the following onebody term to the Ham iltonian

which also breaks rotational sym m etry, i.e., only the projection of the total spin $J_z\,$ rem ains conserved. Here, is an appropriate constant. A second e ect consists of the modi cation of the random two-body interaction. Provided the time-reversal sym m etry breaking induces splittings that are larger than the m ean level spacing, the random matrices $v_0 \, \circ \,$ and $v_1 \, \circ \,$ in the H am iltonian (2) have to be drawn from the Gaussian unitary ensemble (GUE). A ccordingly, Eq. (3) for the S = 0 m atrix $v_0 \, \circ \,$ and the corresponding form ula for the S = 1 m atrix $v_1 \, \circ \,$ have to be replaced by

This reduces the variance of the diagonalm atrix elements by a factor of two when compared to the GOE.Considering the random two-body interaction alone, this elect introduces only small corrections of order 1=N² to the results presented in the previous sections and in the Appendix.

Let us consider the trivial case where residual interactions can be neglected. The B -dependent pairing gap then becomes

The odd-even staggering thus decreases with increasing magnetic eld and disappears when the Zeeman splitting 2 B equals half the mean level spacing h''_{i+1} 'i. Note that Eq. (17) ceases to be applicable for stronger magnetic elds. In the limit of very large B - elds, the ground state becomes spin polarized (i.e., has maximal spin J = N = 2) and any odd-even staggering disappears. Note also that a breaking of time-reversal symmetry leads to a positive pairing gap at odd N and can thereby easily be distinguished from the elds explicitly be distinguished from the elds.

We now include again the random two-body interactions and compute the empirical pairing gap as the magnetic eld is switched on. The number of single-particle orbitals is M = 6. At vanishing magnetic eld we assume an equidistant mean- eld spectrum with unit spacing.




FIG. 4. Empirical pairing gap as a function of particle number for various strengths of the magnetic eld: 2 $B = h''_{i+1}$ "i = 0;1=4;1=2 (full line, dotted line, dashed line).

The two-body random interactions have xed couplings $C_0 = C_1 = 1=10$. We add the Zeem an Ham iltonian (15) to the system and increase the Zeeman splitting 2 B from zero to its maxim alvalue h"_{i+1} "i=2. Sim ultaneously, the variance of the im aginary part of the random matrix elements is increased from zero to one, being held proportional to the Zeem an splitting. Figure 4 shows that the odd-even staggering decreases with increasing Zeem an splitting. The remaining staggering is due to the interactions, which are relatively weak in this example; the transition from the GOE to the GUE in the random two-body matrix is very mild. For strong two-body interactions the odd-even staggering remains strong when tim e-reversal symmetry is broken. Thus, the breaking of time-reversal invariance has only mild e ects on the ground-state structure in strongly interacting systems. This nding is consistent with a recent study of timereversal symmetry breaking in the nuclear shell model with random two-body interactions [34].

VI.SUMMARY

W e have shown analytically and num erically that random two-body interactions cause an odd-even staggering in interacting few-ferm ion system s such as sm allm etallic grains or quantum dots. Interactions tend to sm ooth out the odd-N and even-N dependence of the pairing gaps and can thereby be discrim inated from the non-sm ooth m ean- eld staggering. As expected, the breaking of tim e reversal symm etry leads to a decrease of the odd-even staggering; this trend can how ever be countered by su ciently strong two-body interactions.

APPENDIX:

The derivation of interaction-induced staggering in Section III was obtained in the dilute limit N M. For general values of N and M and couplings C_0 and C_1 , a straightforward counting procedure results in the exact expressions

In each of the three above expressions form in in a land m axim al spin states, term s are ordered by their relative in portance in the many-body lim it at nite density, i.e., in the lim it N ! 1 with N=2M = const. The leading term is $O(N^4)$ in the many-body lim it, and this leading term is seen to be manifestly symmetric under particle-hole exchange N ! 2M N for the minimal-spin states (of course the maximal spin states J = N = 2 exist only for N M). At subleading order, the symmetry is broken due to anticom mutation relations between the creation and annihilation operators in Eq. (2). At both leading and rst subleading order, TrH^2 is clearly identical for the J = 0 and J = 1=2 states, indicating that the staggering can occur only at O (1=N²), entirely consistent with our dilute analysis in Section III. It is also at this second subleading order that we rst encounter the dimensionless quantity d, which we did not need to consider in the dilute approximation. d, taking values 0 d 1, represents the fraction of particles in the basis state that live on doubly occupied orbitals.

As discussed above, for a pure S = 0 coupling (C₁ vanishing), ground states com e always from the sector of m inim al spin, and thus we are led to consider the quantity

where terms of higher order in the 1=N expansion have been dropped, and the last inequality is easily checked for all possible values of lling fraction and double occupancy fraction d. Thus, our original estimate, Eq. (12), obtained using the dilute approximation, is con immed as a lower bound to the amount of predicted pairing gap,

The situation is more complex for a pure S = 1coupling ($C_0 = 0$), since here the ground state may be a state of either m inim alor m axim al spin, depending on the density . Comparing Eqs. (A1,A2) with Eq. (A3) at leading order in the many-body lim it, we see easily that J = N = 2 is preferred at very low density, < $_{crit}$ = (5 $2^{5}\overline{3}$)=13 0:118, but as density increases a transition should occur to ground states of m inim al spin. The preference for maxim al spin at low density is obvious, since high-spin states clearly maxim ize the fraction of particle pairs with aligned spins (S = 1instead of S = 0). On the other hand, the physical reason for the transition to m in im al-spin ground states even with a pure S = 1 coupling for > _{crit} is that at high enough density there are relatively few other high-spin states that a given high-spin state can couple to.

The relevant result for our purpose here is that at low densities there is no predicted stagger in the many-body limit, in accordance with Eq. (A3), but for $> _{\rm crit}$ minim al-spin states again become dominant. A calculation completely analogous to the one in Eq. (A4) tells us that once again the pairing gap is positive (negative) for even (odd) N and proportional to 1=N² times the magnitude of the binding energy. Thus,

The above analysis generalizes easily to the generic case where the two coe cients C_0 and C_1 are both nonzero. For $C_0 > C_1$, ground states are always expected to come from the minimal-spin sector, leading to positive pairing gap proportional to $1=N^2$ times the binding energy. For $C_1 > C_0$, on the other hand, there will be a transition between no pairing gap at low density to positive pairing gap at higher density, the critical density crit approaching 0:118 for C_1 C_0 and approaching 0 at $C_0 = C_1$.
