# Spin { rotation interaction in fullerite C $_{60}$

W e report on the  $^{13}C$  spin {lattice relaxation times in polycristalline fullerite  $C_{60}$  m easured over the temperature range 295 K to 1000 K. At temperatures above 470 K, spin {lattice relaxation is dominated by the spin {rotation interaction. From the analysis of temperature dependence of  $T_1$  ( $^{13}C$ ), the spin {rotation constant is determined using J- and M-m odels of rotational di usion:  $C_J$  ' 51 Hz,  $C_M$  ' 29 Hz.

IN T R O D U C T IO N

W hen a molecule rotates, the motion of its nuclear and electronic charges produces alternative magnetic elds. These elds may then interact with nuclear spins in the molecule. The resulting spin { rotation interaction is one of the possible competing contributions to the mechanisms of nuclear spin { lattice relaxation in the gas and condensed phases [1]. The extraction of the contribution due to the spin-rotation mechanism solely from the spinlattice relaxation is of interest in several ways. Firstly, it is especially useful to have a know ledge of the molecular reorientation correlation time and the angular momentum correlation time J in order to di erentiate between alternative models of molecular rotation, i.e., the rotational jum p m odel versus the rotational di usion one. W hile can be determined reliably by a variety of m ethods, J is far less available to precise m easurem ent. The fact that the interaction between nuclear spin and magnetic eld generated by molecular rotation is a dom inant mechanism for spin { lattice relaxation provides an excellent approach to the determ ination of . Secondly, the spin { rotation constants can be used to nd the param agnetic part of the shielding tensor, and vice versa.

Fullerite C<sub>60</sub> is the only known solid that consists of quasispherical hom onuclear m olecules. At am bient tem – peratures, these m olecules rotate quite fast, despite a very large m om ent of inertia, 10<sup>36</sup> g cm<sup>2</sup>. A lthough the spin {rotation constant in C<sub>60</sub> is relatively sm all (25.6 H z, as estim ated from chem ical shift), the spin {rotation interaction in this compound would be expected to signi – cantly contribute to spin {lattice relaxation even at tem – peratures about 400 K [2].

 $^{13}$ C NM R line shape and spin { lattice relaxation in fullerite C<sub>60</sub> have been studied in magnetic elds of 1.4 to 9.4 T at tem peratures ranging from 100 to 340 K [3, 4, 5, 6]. These experiments clearly demonstrate that the  $^{13}$ C NM R spectrum of fullerite C<sub>60</sub> in the range 100 {

Herein, we present the data in favor of this hypothesis. We report on the results of measuring spin{lattice relaxation time  $T_1$  ( $^{l3}C$ ) and  $^{13}C$  NMR chem ical shift in polycrystalline fullerite C  $_{60}$  at tem peratures ranging from 295 to 1000 K and on the experimental manifestation of spin{rotation interaction. From theoretical analysis of the tem perature behavior of  $T_1$  ( $^{l3}C$ ), we determ ined correlation times of the C  $_{60}$  rotation angularm om entum and the spin{rotation coupling constant of  $^{13}C$  nuclei in a fullerite C  $_{60}$  molecule.

#### EXPERIM ENTAL

A polycrystalline  $C_{60}$  sam ple was obtained by crystallization from a toluene solution, washed with hexane, and annealed in vacuum at 200 C. HPLC showed that the content of oxides and higher fullerenes was less than 0.02%. XRD con rm ed a high degree of crystallinity of the sam ple. The heat capacity of the sam e sam ple was m easured by DSC in the range 285{675 K [7]. The values obtained were consistent with available data.




FIG.1: Recovery of magnetization M (arb. units) of  $^{13}$ C spins in fullerite C<sub>60</sub> at 863 K after the action of a saturating pulse train. The solid curve is described by the equation M () = M<sub>1</sub> [L exp(=T<sub>1</sub>)] at T<sub>1</sub> = 59 5 s.

A C<sub>60</sub> powder (400 m g) was baded into a quartz NM R tube 5 m m in o.d. and 50 m m in length, evacuated to a residual pressure of 0.1 m m H g, and sealed. NM R m easurem ents were perform ed on a B ruker M SL-300 spectrom eter in a eld of 7.04 T (75.4 M H z); an original high-tem perature probe was used to cover the tem perature range 295{1000 K.A furnace 50 m m long with the m axim alouter diam eter of 20 m m was designed with the use of two coaxial quartz tubes. A noninductively wound

heating element was placed in between these tubes. An RF coilwas xed at a zircon tube 50 mm in length, 7 mm in od, and 5.8 mm in id. The tube with a sample was positioned in the zircon tube. For them al insulation of the furnace, quartz wool was used. At a sample tem perature of 1000 K, the tem perature of the probe cover was no more than 50 C. Forced cooling of the RF circuit was not used. Tem peratures were calibrated with the use of a Chrom el{A lum el therm occuple. The tem perature reproducibility with allow ance for the heat gradient was 20 C.NMR spectra were excited by a one-pulse sequence at a dead tim e of 4 m s and a pulse repetition tim e of 80 s; the num ber of scans, 100; scan w idth, 10 kH z; SI 16K and TD 16K.Chem ical shifts were measured from CHCL (77 ppm with respect to TMS) as the external reference. Spin { lattice relaxation tim es were m easured with the use of the saturation { recovery pulse sequence, 90, )<sub>n</sub>  $5T_1$ . The =2 pulse width (90<sub>x</sub> ţ 2 90, was 9 ms, n = 100, and time delays  $_2$  were from 1 to 500 s. Time  $t_1 = 100$  m s was optimized so that a signalupon saturation was absent. To construct the plots of signal amplitude versus delay time, 14 to 17  $_2$  values were used. The  $T_1$  values were obtained through processing the amplitude{ 2 plots with the SIM FIT program (ASPECT (3000 software) with allowance for oneexponential magnetization recovery. Figure 1 shows a representative plot of signal am plitude recovery. Before

each run, the sample was kept at a speci ed tem perature for no less than 60{100 m in. It took about 5 h to m easure  $T_1$  at one tem perature point. Before each run, the sample was allowed to cool to room tem perature. The error in m easurem ent of  $T_1$  was 7{10%.

## RESULTS




FIG.2:  $^{13}$ C NMR chem ical shift (ppm from TMS) in fullerite vs. tem perature. Regression line: = 141.8 + 4 10  $^{3}$  T.

The  $^{13}$ C NMR signal of the sam ple studied at 295 K had a slightly asymmetric contour with a chemical shift

of 143:6 0.2 ppm and the line width at half-maximum of 3.6 ppm, which is consistent with the known data [3, 4, 5, 6]. With an increase in temperature to 800 K, the chem ical shift linearly changes by only 2.5 ppm (Fig. 2) and the line width remains unaltered within the error of measurements and is presumably dominated by the eld  $B_0$  inhomogeneity. In contrast to the line width and




FIG. 3: Theoretical and experimental temperature dependence of spin{lattice relaxation time  $T_1$  ( $^{13}$ C) in fullerite C  $_{60}$  at 190{1000 K (B<sub>0</sub> = 7:04 T). Solid line: Calculated T<sub>1</sub>. D ashed line: Contribution chemical shift anisotropy to T<sub>1</sub>. D ot{dash line: Spin{rotation contribution. Symbols : experimental data of Tycko et al. [4] and Privalov et al. [6]; : present work. Jump of T<sub>1</sub> at 260 K corresponds to the

chem ical shift, the spin { lattice relaxation time  $T_1$  (<sup>13</sup>C) experiences noticeable changes in the tem perature range studied (Fig. 3). Increasing tem perature from 295 to

473 K is accompanied by an expected slight increase in  $T_1$  from 77 to 107 s [2]. A further increase in temperature results in a smooth decrease in  $T_1$  to 12 s at 823 K, being a strong evidence that the dom inating m echanism of  $^{13}$ C spin{lattice relaxation in fullerite changes with an increase in temperature from the m agnetic shielding anisotropy m echanism at am bient and low temperatures to the spin{rotation m echanism at high temperatures. To the best of our know ledge, this is the rst example of

realization of spin (rotation interaction in solid-state  $^{13}\text{C}$  NMR.At temperatures 830(900 K,  $T_1$  sharply increases to 100 s. In the range 900(1000 K,  $T_1$  is roughly temperature independent. The reasons behind this behavior of  $T_1$  ( $^{13}\text{C}$ ) at temperatures ranging from 830 to 1000 K are not clear. Note that the changes in  $T_1$  observed are reversible.

# DISCUSSION

#### Chem ical shift

The linear change in chemical shift observed with a change in temperature (Fig. 2) is caused by averaging  $^{13}\mathrm{C}$  m agnetic shielding over the rovibrational states of C  $_{60}$  m olecule

where  $_{\rm e}$  is the chem ical shift constant at equilibrium state, r = r  $r_{\rm e}$  is the change in double (d) and single (s) bond lengths in  $C_{60}$ ,  $_{\rm s}^{0} = (@ = @r_{\rm s})_{\rm e}$ ,  $_{\rm d}^{0} = (@ = @r_{\rm d})_{\rm e}$ , and h i denotes averaging over rovibrational states. In combination with the data on bond lengths in  $C_{60}$  at temperatures 4{295 K [8], Eq. (1) leads to the following relation:  $400 = 12.4_{\rm s}^{0} + 3.5_{\rm d}^{0}$ . If we suppose that  $_{\rm d}^{0}$  in  $C_{60}$  is close to the one in ethylene (Table I), then  $_{\rm s}^{0}$ ' 20 ppm A <sup>1</sup>, which is comparable with the magnitude of  $_{\rm s}^{0}$  in ethane.

## Spin { lattice relaxation tim e

The experimental temperature dependence of  $T_1$  can be adequately described in the model of molecular reorientations [2]. This model reproduces  $T_1$  (T) for both the low- and high-temperature phases up to 370 K, for which the experimental data are known. In the low tem perature simple cubic phase, C  $_{60}$  m olecules are assumed to jump between symmetry-equivalent positions about m olecular symmetry axes, while in the hightem perature f.c. phase, reorientations take place also about crystal symmetry axes.

For the jump m odel,  $T_1$  due to chem ical shift an isotropy is expressed in term s of correlation times for each type of reorientation axes [2]. W ith reasonable accuracy, this form ula can be approximated by the form ula for the diffusion rotation m odel with the elective correlation time :

$$(1=T_1)_{CS} = \frac{3}{10}!_0^2 + \frac{2}{3} + \frac{2}{3} + \frac{2}{1+!_0^2};$$

where =  $_{33}$  , =  $_{i \text{ iii}}^{P}$  = 3, = ( $_{11}$   $_{22}$ )= is the asymmetry parameter,  $_{ii}$  are the principal com – ponents of the shielding tensor, and ! $_0$  is the Larm or frequency. Values of these parameters for fullerite C  $_{60}$ were determined earlier [3, 4, 5, 6]: = 1:43 10<sup>4</sup> (from TM S), = 1:1 10<sup>4</sup>, = 0:24. Here, we use ! $_0$  = 2 75:4 M Hz.

The decrease in T<sub>1</sub> observed at 470{820 K can be assigned to the spin{rotation interaction, which becomes dominant in this temperature range. This relaxation mechanism is characterized by the angular momentum correlation time  $_J$  [9, 10, 11]. In terms of so-called J- and M-models for rotational di usion and in the limit  $_J$ ,  $_J$  and for a spherical top molecule are related to each other as  $_J = I=6kT$  and  $_J = I=2kT$  for J-and M-models, respectively (where I is the moment of inertia of the molecule). The spin{lattice relaxation rate due to spin{rotation interaction is given by

$$(1=T_1)_{SR} = \frac{8^2 kT}{2} IC^2 J;$$

where C is the spin { rotation constant.

The resulting relaxation rate is  $1=T_1 = (1=T_1)_{CS} +$  $(1=T_1)_{SR}$  . At tem peratures lower than 350 K , the relaxation rate is dom inated by the chem ical shift an isotropy. Fitting the model data to the experim ental data in this tem perature range gives the kinetic param eters of m olecular reorientations (Table II). These parameters are supposed to be also valid at higher tem peratures. It is easy to verify that, in this case,  $_{\rm J}$  < at tem peratures below 900 K and, hence, the relation between these two quantities holds. The constant C can be readily determ ined from the position of the maximum of  $T_1$  at 360 K, where  $(T_1)_{CS} = (T_1)_{SR}$ . Since  $I(C_{60}) = 10^{-36} \text{ g cm}^2$ , we have  $f_J j'$  51 Hz,  $f_M j'$  29 Hz for J-and M -m odels, respectively. The value of the spin { rotation constant obtained in the M model is in reasonable agreement with that derived from the chem ical shift, 25:6 Hz.

The model of molecular dynamics in fullerite C  $_{60}$  suggested adequately describes T $_1$ (T) in the range 190{ 830 K. However, the most intriguing is the reversible effect associated with a sharp increase in T $_1$  at 830{900 K,

followed by the constancy of  $T_1$  in the range 900{1000 K . O ne of the possible reasons can be a high-tem perature phase transition [12], although high-tem perature in situ studies of a C  $_{60}$  pow der by high-resolution X R D did not disclose a deviation from linearity for the volume expansion coe cient [13, 14]. This problem calls for further investigation. We hope to address this problem in the near future.
