## M elting behavior of ultrathin titanium nanow ires

The therm al stability and melting behavior of ultrathin titanium nanow ires with multi-shell cylindrical structures are studied using molecular dynamic simulation. The melting temperatures of titanium nanow ires show remarkable dependence on wire sizes and structures. For the nanow ire thinner than 1.2 nm, there is no clear characteristic of rst-order phase transition during the melting, im plying a coexistence of solid and liquid phases due to nite size e ect. An interesting structural transform ation from helical multi-shell cylindrical to bulk-like rectangular is observed in the melting process of a thicker hexagonal nanow ire with 1.7 nm diam eter.

M etalnanow ires are current focus of intensive research due to both the fundam ental interests of low -dim ensional physics and the potential applications in nanoscale materials and devices. Experimentally, stable ultrathin m etalnanow ires with diam eter down to severalnanom eters and su cient length have been fabricated by various methods<sup>1 {6</sup>. For example, Tinanowires of a few nm in width were produced by Ar<sup>+</sup> ions irradiation on Tithin layer by using carbon nanotube as a mask<sup>1</sup>. Takayanagi's group has successfully produced suspended stable gold wires<sup>2;3</sup>. Novel helical multi-shell structures were observed in those ultrathin gold nanowires<sup>3</sup>. As com pared with bulk materials and atom ic clusters, onedim ensional (1-D) m etalnanow ire have both the 1-D periodicity along wire axis similar to bulk solids and the larger surface to volum e ratio like clusters. Therefore, the metal nanow ires are expect to exhibit some unique features di erent from either bulk solids or nanoclusters.

On theoretical side, the structures and properties of free-standing ultrathin m etal nanow ires have been studied by several groups<sup>7{17</sup>. Based on genetic algorithm simulations with empirical potentials, we have system atically studied the helical multi-shell structures in Au<sup>14</sup>, Ti<sup>15</sup>, Zr<sup>16</sup> nanowires. The corresponding vibrational, electronic, and transport properties were also discussed. However, little is known about the therm al stability and melting behavior of the 1-D metal nanow ires, especially for those transition m etal nanow ires with novel cylindricalmulti-shell structures. Thus, it is important to clarify the relation between the melting behavior and the size or geometry of these ultrathin metal nanowires. The nite size e ects<sup>18</sup><sup>22</sup>, e.g., solid-liquid coexistence, on the phase transition of such quasi-1D systems are also interesting. For thicker crystalline lead nanow ires, surface melting phenomena associated with formation of a thin

skin ofhighly mobile surface atom swere observed<sup>7</sup>. More recently, the multi-shell gold nanow ires and their melting behaviors have been studied by MD simulations<sup>13</sup>. In our previous work, the atom is structures of titanium nanow ires with diameter from 0.7 to 1.7 nm have been optimized and helical multi-walled cylindrical structures have been obtained<sup>15</sup>. In this paper, we report molecular dynamic simulations on the therm odynam is properties of the titanium nanow ires. The end of nanow ire size and geometry on the melting behavior will be discussed.

In our simulations, Tinanowires of su cient length are modeled by supercell with 1-D periodical boundary condition along the wire axis direction. As a reasonable comprom ise between keeping the helicity in z axis direction and avoiding the nanow ire breaking into clusters upon relaxation, the length of the supercell is chosen to be 1,256 nm . The interaction between titanium atom s is described by a well-tted tight-binding many body potential<sup>23</sup>. To simulate the melting behavior of nanow ires, we employ the constant tem perature molecular dynamics (MD) method by  $Hoover^{24}$ , which have been extensively used in our previous works  $25 \{27\}$ . The MD time step is chosen as 2.15 fs. At each tem perature, the initial 10<sup>5</sup> MD steps are used to bring the system into equilibrium. Then we monitor the internal energy E, root-m ean-square (m s) uctuation of the interatom ic distances , and heat capacity  $C_{\nu}$  from the therm alstatistical averages in the equilibrium canonical ensemble. At each tem perature,  $10^6$  M D steps are perform ed to record the therm odynam ic average of these physical properties. The constant-tem perature M D simulations start from a low tem perature (400 K). The tem perature gradually increases towards high tem perature (1400 K) by 50 K per step.

We rst perform comprehensive genetic algorithm simulations<sup>14;15</sup> on the equilibrium structures of titanium nanowires. Several representative structures are presented in Fig.1. These stable multi-shell structures are composed by coaxial cylindrical shells, which have been theoretically predicted for Al, Pb, Zr, Cu, and Au nanow ires<sup>8;12 {14; $\overline{16}^-$ </sup> and experimentally observed in Au nanow ires<sup>3</sup>. We use index  $n-n^0-n^{00}-n^{003;14}$  to describe the nanow ire consisting of coaxial shells with n,  $n^0$ ,  $n^{00}$ ,  $n^{000}$ helical atom ic rows ( $n > n^0 > n^{00} > n^{00}$ ) each. Thus, the nanowire structures in Fig.1 can be de ned as 8-2, 9-3, 9-4, 5-1, 6-1, 12-6-1, and 17-12-6-1 respectively. The structure of the thinnest 5-1 wire is centered pentagonal, with the outer shell containing ve strands and the inner shellas a single atom ic row. The 6-1, 12-6-1, and 17-12-61 wires in F ig.1 constitute a hexagonal growth sequence containing two-shell, three-shell, and four-shell with a central single atom ic row. In stead of central atom ic row based structures, the 8-2, 9-3, 9-4 wires are com – posed of eight or nine strands in the outer shell and two to four strands in the inner shell. M oreover, multi-shell structures such as 13-8-2, 14-9-3, 15-9-4 are obtained in our simulation. Our system atical illustration of various multi-shellgrowth sequence of the m etalnanow ire can be found elsewhere<sup>16</sup>.

Starting from those optim ized structures at low tem perature, we simulate the melting behavior of the titanium nanow iresusing constant-tem perature M D m ethod. As representative examples, Fig 2 (a), (b), (c), (d), (e) present the tem perature dependence of the internal energy E, mean square bond length uctuation, and therm al capacity  $C_v$  for 5-1, 6-1, 9-4, 12-6-1, and 17-12-6-1 nanow ires respectively. From those curves, we can de ne the overall melting temperature  $T_m$  of the system as the tem perature at half of saturated in liquid states<sup>2</sup>. For the purpose of comparison, we have also simulated the melting of some titanium nanoclusters with equilibrium structures such as icosahedral T  $i_{55}^{27}$ . Table 1 sum m arizes the T<sub>m</sub> of various nanow ires with di erent multishell structural pattern from our simulations. In general, them elting tem peratures of titanium nanow ires are much lower than the bulk value (1943 K) and increase with the nanowire size. Because of the 1-D periodicity and the

well-reconstructed helical surface structures, the melting tem peratures of nanow ires are typically higher than those of clusters with comparable size (see Table I).

To explore the size dependence of nanow ire melting tem perature, we plot the overallm elting tem perature  $T_m$  versus wire diam eter (1/D) in Fig.3. It is found that the  $T_m\,$  for the 6–1, 12–6–1, 17–12–6–1 wires under the same hexagonal grow th sequence  $\,$  twellto a linear dependence as:

$$T_m = T_0 = D$$

where  $T_0 = 1542$  K is the extrapolated in nite limit, = 682 K nm describes the linear dependence of T with diameter D (in unit of nm). Such 1=D dependence ofm elting tem perature for nanow ire is sim ilar to the wellknown size relationship for metal nanoclusters28 (30. As compared with the linear dependence in the hexagonal wires (6-1, 12-6-1, 17-12-6-1), 8-2 and 13-8-2 wires almost belong to the same size relationship while the  $T_m$ of other nanow ires deviate from such linear t. These differences indicate that the atom ic structures of nanow ires play signi cant role in determ ining the melting behavior of nanow ires. Am ong those wires, the  $T_m$  of 5-1 wire is much higher than the 6-1 w ires with com parable size. On the other hand, the nanow ires with three or four atom ic strands in the internal shell like 9-3, 14-9-3, 9-4, 15-9-4, have lower melting temperature than the nanow ires with one atom ic strand in the center, e.g., 12-6-1. This e ect m ight be understood by the relatively looser internal structures of these 9-3 or 9-4 based nanowires (see Fig.1). Therefore, we suggest that the multi-shell m etal nanowires with tightly internal structures should have higher therm al stability.

W e now discuss the nanow ire melting behavior by examining the temperature dependent curve of internal energy E, bond uctuation () and thermal capacity  $(C_v)$  with di erent size and geometries. As shown in Fig.2 (a-e), the melting of 5-1, 6-1 and 9-4 wires all start from about 500 600 K. Their di erence in the internal structures are only rejected in the slightly di erent variations of rm s bond length uctuation with temperature. Sim - ilar e ect has been also found in other thinner nanow ires

like 8-2, 9-3. For all the thinner wires (e.g., 5-1, 6-1, 9-4 in Fig.(a-c)), we haven't seen clear peak in the  $C_v$ curve in Fig 2, which is a characteristic for the rstorder solid to liquid phase transition. A coordingly, the increase of internal energies is also relatively sm ooth in these sm all nanow ires. Only the dram atic jump in bond length uctuation with increasing tem perature dem onstrates the occurrence of melting. This behavior is similar to that in small clusters<sup>21</sup>. It can be understood by nitesize e ect in rst-order phase transition<sup>8;19</sup>, which leads to the coexistence of solid and liquid states in a rather broad tem perature region<sup>20 {22</sup>. On the other hand, the thicker wires, such as 12-6-1 and 17-12-6-1, show clear characteristics of the solid to liquid phase transition (see  $Fig_2(d_{re})$ . In particular, there are sharp peaks in the therm alcapacity curves at 1050 K and 1100 K for 12-6-1 and 17-12-6-1 wires respectively.

To further understand the melting process in the titanium nanow ires, we have traced the structural change of the 17-12-6-1 wire with the tem peratures in the melting region. Fig.4 gives the snapshot of the nanow ire at di erent tem peratures. One can see that the titanium atom s only weakly oscillate at their equilibrium positions before the overall melting (950 1000 K). A though there are sm all deform ation on the sharp of nanow ire and the di usion of interior atom s, the top view of the nanow ire cross-section still show shexagonal structure with distinct atom ic shells. It is interesting to nd a structural transform ation of the nanowire at 1050 K. In additional to the therm alenhanced 1-D di usion along wire axis, the atom ic arrangem ents of the nanow ire have transform ed from cylindrical helical to bulk-like rectangular. In the further melting process, the structures of nanow ire remains bulk-like. The structural transition from cylindricalhelical to bulk-like rectangular has also been observed in the size evolution of gold nanow ire optim ized structures in our previous simulation<sup>14</sup>.

From the above results and discussions, we make the following conclusions. (1) The therm all stability of titanium nanowires signi cantly dependent on the structures and sizes of the wire. (2) The melting temperature of titanium nanowire is lower than the bulk's, but higher than titanium cluster's with comparable size. Linear dependence of melting temperature upon inverse of nanow ire diameter (1=D) is obtained. (3) The coexistence mechanism of the solid state and the liquid state due to nite size e ect plays a signi cantrole in the melting process of the thinner nanow ires (D < 1.2nm). (4) For the thicker nanow ires, i.e., D 1:7 nm, we not the structural transformation from the helical multi-shell cylindrical to the bulk-like during the melting process.
