Density of States in a Mesoscopic SNS Junction

Sem iclassical theory of proximity e ect predicts a gap E_g ~D= L^2 in the excitation spectrum of a long di usive superconductor/normal{m etal/superconductor (SNS) junction. M esoscopic uctuations lead to anomalously localized states in the normal part of the junction. As a result, a non-zero, yet exponentially small, density of states (DOS) appears at energies below E_g . In the framework of the supermatrix nonlinear—model these prelocalized states are due to instanton congurations with broken supersymmetry. The exact result for the DOS near the semiclassical threshold is found provided the dimensionless conductance of the normal part G_N is large. The case of poorly transparent interfaces between the normal and superconductive regions is also considered. In this limit the total number of the subgap states may be large.

Introduction. It has recently been shown within several di erent although related contexts that the excitation energy spectrum of Superconductive { Normal (SN) chaotic hybrid structures [1, 2] and superconductors with magnetic impurities [3, 4] does not possess a hard gap as predicted by a number of papers [5, 6, 7, 8] using the sem iclassical theory of superconductivity [9, 10, 11]. With mesoscopic uctuations taken into account, the phenomenon of soft gap appears: the density of states is nonzero at all energies, but it decreases exponentially fast below the sem iclassical threshold E_a ~= c, with c being the characteristic dwell time in the N region. In particular, for di usive system sperfectly connected to a superconductor, E_{α} has the order of the Thouless energy E_{Th} in the N region [5, 6].

The rst result in this direction was obtained in Ref. [1], where the subgap DOS in a quantum dot was studied by employing the universality hypothesis and the predictions [12] of the random matrix theory (RMT) [13]. Later on, the tail states in a superconductor with magnetic impurities were analysed in Refs. [3, 4] on the basis of the supersymmetric nonlinear—modelmethod [14] extended to include superconductive paring [15].

Fully m icroscopic approach to the problem of the subgap states in di usive NS systems was developed in Ref. [2] in the fram ework of the supersymmetric—model similar to that employed in Refs. [3, 4]. Physically, the low—lying excitations in SN structures are due to anomalously localized eigenstates [16] in the N region. From the mathematical side, nonzero DOS at E < E $_g$ comes about when nontrivial eld con qurations { instantons

{ are taken into account in the $\neg m$ odel functional integral. As shown in [2], at E E_g there are two dierent types of instantons, their actions being dierent by the factor 2. The main contribution to the exponentially small subgap DOS is determined by the Gaussian integral near the least-action instanton.

For a planar (quasi-1D) SNS junction with ideally transparent SN interfaces it is given by (provided $G_N^{2=3}$ " 1)

where " = (E_g E)=E_g, $G_N = 4$ D $L_y L_z = L_x$ 1 is the dimensionless conductance (in units of $e^2 = 2$ ~) of the normal part connecting two superconductors, $E_g = 3.12E_{Th}$, $E_{Th} = D = L_x^2$ is the Thouless energy, and = (V)¹ is the mean level spacing. Here L_x is the thickness of the N region, assumed to be larger than the superconductive coherence length. It is also assumed that the lateral dimensions L_y ; L_z are not much larger than L_x (otherwise, the instanton solution acquires additional dimension(s) and the exponent 3=2 changes, cf. [2] for details). The corresponding meaned (MF) expression above the gap reads [6]

Generally, the functional form of Eqs. (1), (2) is retained, whereas the coe-cients are geometry-dependent and can be found from the solution of the standard Usadel equation [11] for the speci-c sample geometry. In any case, the total number of states with energies below E $_{\rm g}$ is of the order of one.

In the present Letter we extend our previous results [2] in two dierent directions. Firstly, we derive exact expression for the DOS in the energy region J^{\dagger} j 1,

 $G_N^{2=3}$. The without using anymore the inequality " obtained result interpolates smoothly between the sem iclassical square-root edge (2) and exponential tail (1). Secondly, we consider the same SNS system allowing for non-ideal transparencies at the SN interfaces. The result depends upon the relation between dimensionless interface conductance G $_{\mathrm{T}}$ and norm al conductance $G_{N}^{1=4}$, all qualitative features G_N . As long as G_T of the previous solution are retained, but the value of the sem iclassical threshold E $_{\rm g}$ and num erical coe $\,$ cients in the expression like (1) become dependent upon the $G_T = G_N$. However, at further decrease $G_N^{1=4}$, the DOS beof interface transparency, $G_{\,\mathrm{T}}$ haviour changes dram atically: in the sem iclassical region E > E $_{\rm q}$ it acquires the inverse-square-root singu- $(")^{1=2}$. At sm allest J jth is singularity larity, h i_{m F} sm oothens out and crosses over to an exponentially decaying tail of low-energy states. Distinctive feature of this tail, as opposed to the situations discussed previously, is that the total number of subgap states becomes large and grow sasG $_{\rm T}$ $^{1=2}$ G $_{\rm N}$ 1. We coined this situation as \strong tail", and nd exponential asymptotics of the DOS in the strong tail region.

2.0 utline of the m ethod. We treat the problem within the supersymmetric formalism. The derivation of the -m odel functional-integral representation can be found in Refs. [14, 15, 17]. The DOS is given by the integral over the supermatrix Q:

Q is an 8 8 m atrix operating in N am bu, time-reversal and Bose { Ferm i (supersym m etry) spaces. Pauli m atrices operating in N am bu and TR spaces are denoted i and i. The matrix k is the third Pauli matrix in FB space. $= z_z$. Integration in (3) runs over the manifold Q² = 1 with the additional constraint

This manifold is parameterized by 8 commuting and 8 anticommuting variables. It turns out how ever that only 4 commuting and 4 anticommuting modes are relevant in the vicinity of the quasiclassical gap while contributions from all other modes to the DOS cancel. The detailed discussion of this fact will be published else-

where [17]. The reduced parameterization for the commuting part of Q in terms of the 4 variables reads [2]:

Variation of this action yields the identical U sadelequations for $_{\rm F}$, , and :

with the boundary conditions ($I_x=2$) = =2. Eq. (9) generally possesses two different solutions $_{1;2}$ = =2 + i $_{1;2}$ which coincide ($_{1;2}$ (r) = $_{0}$ (r)) just at the threshold energy E_g , and are close to each other in the range J''j 1 we are interested in. Thus there are 8 possible saddle points for the action (7) corresponding to two solutions of the U sadel equation for each variable $_{F}$; . Rotation over the angle $_{B}$ 2 [0;2) connects some of them and produces the whole degenerate family of saddle points (see Refs. [2,17] for details). In the following, we will need the function f_0 (r) which is the normalized difference $_{2}$ (r) $_{1}$ (r) at E ! $_{g}$; it obeys the linear equation

3. Exact result for the transparent interface. For energies close to E_g we substitute = $=2+i_0+igf_0$ into (8), expand it in powers of g and " and integrate over space using (10):

where we have introduced the constants $c_n=R^n$ (dr=V) $f_0^{2n-1}\cosh_0$. For the quasi-1D geometry, $c_1=1.15$ and $c_2=0.88$. To describe deviation of the angles , , $_F$ from =2 + i $_0$ we introduce, analogously to g, three parameters u, v,

w, respectively. Grassmann variables are introduced as Q = $e^{iW_c=2}e^{iW_a=2}e^{iW_a=2}e^{iW_c=2}$ where Q_C = $e^{iW_c=2}e^{iW_c=2}$ is specified in Eqs. (6) and

Expanding the action in u, v, w and G rassm ann variables leads to

For calculating the DOS we also need an expansion of the pre-exponential factor in (3) as well as the Jacobian J for the param eterization of the Q-m atrix:

Integrating over G rassmann variables and the cyclic angle $_{\rm B}$, performing a rescaling (u;v;w)! (2G) $^{1=3}$ (u;v;w) which excludes G from the integrand, and changing the variables to 1=(u+v)=2, $m=(u-v)^2=2$, we arrive at the following expression for the integral D O S:

where we introduced the notation = $(2\mathfrak{T})^{2=3} \mathfrak{n}$:

At this stage we have to choose the contours of integration over w and 1. The usual convergence requirements for the nonexpanded action (7) enforce the contour for w (1) go along the imaginary (real) axis at large values of w (1). However since the main contribution to the DOS comes from the expression (13) determined




Fig. 1. Possible contours for integration over w and 1. The proper choice is C_1 for w and C_3 for l.

by smallw and 1, these contours should be properly deformed to achieve convergence of (13). The integral (13) converges if the contour for 1 runs to in nity in the dark regions in Fig. 1 and otherwise for w. Therefore, we should choose the contour C_1 for w (see Fig. 1), whereas for 1 there are two possibilities: C_2 and C_3 . The correct choice is dictated by positivity of the DOS, which imply the contour C_3 for 1. Integration in (13) is straightforward although rather cum bersom e and leads to the nal expression for the DOS:




Fig. 2. Exact dependence (14) of the DOS on the dimensionless energy (solid line). Single-instanton approximation (1) (dotted line). Sem iclassical result (2) for the DOS (dashed line).

where Ai() is the Airy function. A symptotic behaviour of the calculated DOS at 1 coincides with the result (1) of the single-instanton approximation [2], see Fig. 2.

The functional dependence (14) coincides with the RMT prediction for the spectrum edge in the orthogonal ensemble [12]. It is not surprising because the random matrix theory is known to be equivalent to the 0D - model [14]. In our case the problem became electively 0D when we seed the coordinate dependence $f_{\theta}\left(r\right)$ for the parameters of Q near E $_{\sigma}$.

B reaking the time-reversal symmetry drives the system to the unitary universality class. The corresponding RMT result [12] can be obtained from Eq. (14) by dropping the last integral term. This result can be easily derived by the -m odel analysis in the following way. Strong magneticeld imposes an additional constraint on the Q-matrix. As a result the mode associated with the variable macquires a mass, so, instead of integrating over it we set m=0.0 ne of the G rassman modes is

also frozen out giving the pre-exponent $(w + 1)^2$ in the integral (13). Finally, the expression for DoS coincides with Eq. (14) but without the last term.

4. Finite transparency of the NS interface. Now we turn to the analysis of the sub-gap structure of a quasi-1D SNS contact with nite conductance G_T of the NS boundary. The role of the interface is described by the dimensionless parameter $t=G_T=G_N$. For t=1, the interface is transparent and the result (14) apply. In what follows we will consider the case t=1. The effect of nite transparency is described by the additional boundary term [14] in the action

where Q L,R are the Q $^{-m}$ atrices at both sides of the interface. Eq. (15) is the the $^{-m}$ rst term in the expansion of the general boundary action [14, 4, 18] in the small transparency 1 of conductive channel and leads to the K upriyanov { Lukichev [19] boundary conditions. In the di usive regime (1 $^{-m}$ L_x) at t 1, we have

The maximum of the RHS achieved at $P_0=(48\pm t)^{1=3}$ determines the position of the mean-eld gap: $\S_g=t+0$ ($t^{5=3}$) and hence $E_g=G_T=4$. Depending on the deviation from the threshold, "= ($E_g=E$)= $E_g=(s_g=s)$ = S_g , there are two regimes for Eq. (18).

Weak tail. If j''j t^{2-3} the two solutions of (18) are close to each other and can be seek in the form $P = P_0 + P$. Expanding the action in powers of P we get

This equation closely resembles its counterpart (11) for the transparent interface. As mentioned in Ref. [4], this form of the expansion of the action over small deviations near the threshold solution inevitably leads to the instanton action scaling as " $^{3=2}$. In fact, there is full equivalence [17] between the DOS for the transparent NS interface given by Eq. (14) and the DOS in the lim it J"j t^{2=3} 1. The latter can be obtained from the form er by rede nition of the constants $\mathfrak{q}_{;2}$. For a 1D planar contact they appear to be $\mathfrak{c}_1=\mathfrak{P}_0=2$, $\mathfrak{c}_2=6=\mathfrak{P}_0$, $\mathfrak{E}_g=\mathfrak{E}_{Th}=\mathfrak{t}.$

Strong tail. In the opposite \lim it, t^{2-3} f''j 1, the di erence between the two solutions for Eq. (18) is large but expansion (17) is still valid (gradients of $_{1;2}$ are small provided " 1). The roots $P_{1;2}$ can be found neglecting either the second or the third term

Below E_g one obtains for the instanton action $S=S_0(P_2)=(3=4)G_N^{-1/2}$ which determines the one-instanton asymptotics of the subgap DOS. The pre-exponent can be calculated by generalizing the method of Ref. [2]. Introducing the deviation parameter qaccording to $= -2 + i\log P_2 + iq = 2$ and expanding the action in powers of q and the corresponding G rassmann pair we obtain for the action and the pre-exponential factor in Eq. (3):

5. D iscussion. We have considered the integral density of states in a coherent di usive SNS junction with arbitrary transparency of the SN interface. For the ideal interface ($G_T = G_N$) we managed to go beyond the single-instanton analysis [2] and derived the exact result (14) valid as long as $E_g = E_g = E_g$. This expression uniquely describes the semiclassical squareroot DOS (2) above the Thouless gap E_g , the far subgap tail (1), and the crossover region " $G_N^{2=3}$ between the two asymptotics. The functional form of this result coincides with the prediction of the RMT.

As the SN interface become less transparent, G $_{\rm T}$ G $_{\rm N}$, the situation changes. At G $_{\rm T}$ G $_{\rm N}^{1=4}$ these changes are only quantitative: the position of the quasiclassical gap is shifted to E $_{\rm g}$ = (G $_{\rm T}$ = G $_{\rm N}$)E $_{\rm Th}$, but the D O S both above [E q. (20)] and below [E q. (21)] the gap has the same dependence on the deviation "from E $_{\rm g}$, with the coeccients becoming dependent on G $_{\rm T}$. In this limit, the very far part of the tail [at " (G $_{\rm T}$ = G $_{\rm N}$) $^{2=3}$] exhibits another "-dependence (23), but the corresponding D O S is exponentially small. Therefore, in the limit G $_{\rm T}$ G $_{\rm N}^{1=4}$ the total number of the subgap states is of the order of 1 and is independent on G $_{\rm T}$. We refer to this case as weak tail.

As the interface becomes less transparent, the region of applicability of the weak tail shrinks and nally dis- $G_N^{1=4}$. For even lower G_T $G_N^{1=4}$, appears at G $_{
m T}$ the di erence between the case of the transparent interface becomes qualitative: the DOS above E_{α} acquires an inverse square-root dependence (22), while the subgap DOS follows (23). In this regime the total number of the subgap states is proportional to $G_T^{1=2}G_N^{1=8}$ and grows with decreasing G_T in contrast to all previous cases when this number is of the order of 1. This $G_N^{1=4}$ the universality class of the indicates that at G $_{
m T}$ problem is changed. At G_T $G_N^{1=4}$ it is no longer equivalent to the spectral edge of the Wigner-Dyson random m atrix ensembles.

The asym ptotic results for the D O S above and below the gap, as well as the width of the uctuation region near E $_{\rm g}$ are sum marized in Table I for the three regions considered.
