A nom alous Quantum Di usion at the Super uid-Insulator Transition

We consider the problem of the superconductor-insulator transition in the presence of disorder, assuming that the fermionic degrees of freedom can be ignored so that the problem reduces to one of Cooper pair localization. Weak disorder drives the critical behavior away from the pure critical point, initially towards a di usive xed point. We consider the elects of Coulom b interactions and quantum interference at this di usive xed point. Coulom b interactions enhance the conductivity, in contrast to the situation for fermions, essentially because the exchange interaction is opposite in sign. The interaction-driven enhancement of the conductivity is larger than the weak-localization suppression, so the system scales to a perfect conductor. Thus, it is a consistent possibility for the critical resistivity at the superconductor-insulator transition to be zero, but this value is only approached logarithm ically. We determ ine the values of the critical exponents ;z; and comment on possible im plications for the interpretation of experiments.

In a perfectly clean system at T = 0, the free Ferm igas is perched precariously at a critical point. An arbitrarily weak interaction will drive the system superconducting (by the Kohn-Luttinger e ect if the interaction is repulsive). In the presence of disorder, how ever, the di usive Ferm i liquid is a stable phase for a nite range of interaction and disorder strengths in dimensions d > 2. In d = 2, it remains an open problem whether or not ferm ions have a stable di usive metallic phase. Such a phase, if it exists, could not be adiabatically connected to the Ferm i liquid¹ since the non-interacting Ferm i gas is always insulating in the presence of disorder in d = 2. In the lim it of weak disorder, this can be understood as a quantum interference e ect which is singular as a result of the di usive nature of electron propagation in a disordered system : di usion at interm ediate length scales (longer than the elastic m ean-free path) thw arts di usion at long scales (longer than the localization length) 2 . The interacting-electron problem remains unresolved because interactions in the spin-triplet channel are also singular as a result of the languid pace of di usive motion^{3,4,5,6}. The upshot of the interplay between these di erent sinqularities is unknown (see, how ever, ref. 7,8).

Consider the critical point separating the insulating and super uid phases of a perfectly clean system of bosons at T = 0 in 2D. We would like to draw an analogy between it and the free Ferm i gas. In the bosonic case, there is a particular value of the chem ical potential for which the system has gapless criticalm odes, bosely analogous to the excitations of the free Ferm i gas. For any other value of the chem ical potential, the bosons are either in a super uid state { a superconducting state, if we assume that the bosons are C ooperpairs { or in a gapped insulating state. Suppose we now add disorder to this system . W hat is the fate of this critical point? On general grounds, we believe that it is unlikely to broaden into a stable di usive m etallic phase, and that the only stable phases are insulating (M ott insulator or Bose glass⁹) or superconducting. Instead, we expect a di usive m etallic critical point with a universal conductivity separating the insulating and superconducting phases. The analogy between Ferm i and Bose system s is in precise, but it em phasizes the important point that in both cases there is a ballistic critical point in the clean system which must be usuped by a di usive xed point in the disordered one.

Such a xed point should be amenable to analysis by methods similar to those used for the di usive Fermiliquid. Conversely, expansion about the pure critical point { which is ballistic, not di usive { should fail. In considering such a perspective, one is faced with the following question: why do quantum interference e ects, which appear to be such an inevitable consequence of di usive motion, not preclude a nite conductivity at the super uidinsulator transition? The answer must lie in the e ects of interactions, which one m ight hope to tam e since spinless bosons, such as singlet C ooper pairs, do not have a triplet channel { the troublesom e, singular one { through which to interact.

In this paper, we present the results of such an analysis. We nd that there are two competing e ects at a putative 2D di usive Bose liquid critical point: one resulting from interactions between the bosons; the other, from quantum interference, i.e. weak localization. In the ferm ionic case, it is advisable to consider quantum interference and interactions on the same footing since they lead to sim ilar logarithm ic corrections at the perturbative level. In the bosonic case, one must perforce do so, since quantum interference leads to the existence of localized states even in the weak disorder lim it, and bosons would congregate in the lowest energy localized state in the absence of interactions. We nd that the effect of interactions is stronger than quantum interference and drives the system to a perfect conductor, thereby explaining how di usion can remain in pervious to local-

ization. This result is congenial to one's intuition that repulsive interactions should disfavor localization. Potential wells due to im purities dim in ish in attractiveness when they are occupied and, as a result, the random potential is e ectively screened. This e ect is present for both short-ranged interactions as well as long-ranged Coulomb interactions, but is stronger in the latter case. The same phenomenon occurs in fermionic systems as well, but it competes with the exchange part of the interaction, which is opposite in sign due to Ferm i statistics. If the interaction is short-ranged, it is irrelevant for spinless ferm ions, so it has no e ect on the conductivity in the infrared limit. (This is clear in the -function limit, where the direct and exchange interactions cancel.) In the case of C oulom b interactions, the exchange interaction between spinless ferm ions dom inates and suppresses the conductivity. In the case of spin-1=2 ferm ions, the runaway ow of the triplet interaction amplitude indicates that the Hartree interaction begins to prevail over the exchange interaction at longer length scales, thereby leading to an enhanced conductivity. However, the interaction strength diverges before a metallic xed point is reached, and no conclusion can be drawn about the existence of a m etallic state at zero-tem perature. These di culties do not arise in the bosonic case. The exchange interaction has the sam e sign as the direct one, and both enhance the conductivity.

O ur result is valid for large conductivities in units of $e^2=h$. Hence, if the bare conductivity is large { as it can be if the bosons have an anisotropic mass tensor { then the renormalized conductivity is in nite. If the bare conductivity is small, then there are two possibilities. If the conductivity initially ows to su ciently large values that we can apply our calculation, then it will continue to ow to in nity. However, it is also possible that the system will ow in this case to a di erent xed point at which the conductivity if nite. In such a scenario, there would be two di erent possible universality classes of superconductor-insulator transitions. In either case, we conclude that it is a consistent possibility for the critical point between the super uid and insulating states of a disordered Bose liquid to be a perfect conductor.

We derive these results in a non-linear -model (NLM) formulation of the problem of di using, interacting bosons. Our NL M is very similar to Finkelstein's model for fermions³. However, the NL M plays a very di erent role in this problem than in the ferm ionic problem . There, the NL M describes the entire m etallic phase. In 2+ dimensions, the metal-insulator transition occurs near the m etallic xed point, so the NL M excom passes it as well. In the bosonic problem which models the superconductor-insulator transition, our NL M describes the critical point. The antiferrom agnetic Heisenberg model in d > 2 provides an enlightening analogy. For isotropic exchange coupling $J_z = J_{x,y}$, the model is ordered and is described by a NL M. In the ordered phase, continuous symmetries are broken so there are Goldstone modes; this is the analog of our critical point.

For $J_z > J_{x,y}$, the model develops Ising order with a gap; this is analogous to our insulating phase. For $J_z < J_{x,y}$, the model develops X Y order, which is analogous to our superconducting phase.

II. D IRTY BOSONS

Following 9, we will treat the C ooper pairs in a dirty superconductor as bosons moving in a random potential. We will assume that all ferm ionic degrees of freedom are gapped or localized and are therefore unimportant. This assumption has been called into question recently^{10,11}. If ferm ionic degrees of freedom prove to play an important role at the superconductor-insulator transition, then our analysis will need to be modiled to include them, but our description of dirty bosons will remain an important component of a richer description of the superconductor-insulator transition.

Note that we are studying here the generic transition⁹ between the Bose G lass and super uid phases which occurs at an incommmenusurate boson density. In the special case in which there are an integer number of bosons per lattice site, there may be a direct transition between M ott Insulating and super uid phases which is tuned by varying the ratio of the hopping and interaction parameters¹².

We begin with a system of interacting bosons moving in a random potential in two dimensions. The derivation which follows goes through in arbitrary dimension with minor changes, but d = 2 is the most interesting case. The imaginary-time action is:

 $u(x \quad x^0)$ is the interaction between bosons; we will consider the cases of both short-ranged interactions and C oulom b interactions. V (x) is the random potential; we use the replica trick to average over it, thereby obtaining the action:

a = 1;2;:::;N is a replica index. We have assumed that the potential has the G aussian white-noise distribution $V(x)V(x^0) = v_0 (x x^0)$.

This action is problem atic because it is not positive de nite as a result of the second term. To cure this, we will rotate the integration contour in the functional integral, as one does in the non-interacting case. This can be done m ore conveniently if we work in the M atsubara frequency representation and separate the real and im aginary parts of the M atsubara elds $_{na} = _{na1} + i_{na2}$, where $_n = 2$ n=. In the absence of disorder, repulsive interactions are marginally irrelevant, and the critical behavior of (3) is controlled by the Gaussian xed point. Now consider a perturbative treatment of the disorder. In the selfconsistent B or approximation, we nd a self-energy due to disorder of the form:

The random potential shifts the chemical potential and also gives the bosons a nite lifetime . As a result of the lifetime , single-boson excitations are no longer long-lived degrees of freedom . How ever, particle-hole pairs are long-lived, as may be seen from the conductivity which, at this level of approximation, is $=\frac{1}{2^{-3}}$.

This does not preclude critical behavior in the singleparticle properties, as has already been seen in the context of interacting ferm ions³ and of quasiparticles in a disordered d-wave superconductor where there are density-of-states corrections and also in the context of non-interacting electrons with an extra sublattice sym – m etry, where the single-particle G reen function itself is critical¹⁶.

The conductivity is sm all because there are no particlehole pairs for = 1 (since the transition occurs at the bottom of a quadratic band). A nite lifetime leads to a small density of states 1= for particlehole pairs, which cancels the factor of the lifetime to which is custom arily proportional, thereby leading to a conductivity which is O (1). How ever, we note that a param etrically large conductivity can be obtained in a slight generalization to a model of two species of bosons with anisotropic masses and that mix upon scattering. Suppose that one of them has $m_x = m_1, m_y = m_2$, while the other has masses reversed. An RG analysis of the dirty boson problem yields the following RG equation in an -expansion about $d = 4^{\circ}$:

with 4 spatial dimensions and time dimensions (the interesting case d = 2 occurs at = = 1). B > 0, so there is no xed point at weak coupling; instead, there is a runaway ow to strong disorder. We interpret this as an instability of the pure critical point, at which the criticalm odes are ballistic, to the di usive xed point. To access the latter xed point, we will construct a non-linear

m odel which is appropriate for physics at length scales longer than the m ean-free path. In this regime, transport is di usive, and we may neglect degrees of freedom, such as the elds, which are short-lived.

III. SADDLE-POINTS FOR DIRTY BOSONS

In the absence of the i_n term, the non-interacting part of the action (3) has an O ((k + 1)N; kN) symmetry, where k is a cuto on the M atsubara frequencies. The key assumption of F inkelstein's theory³ for fermions is that the elevation of the energies of the di usion m odes by the i_n term and the interactions can be neglected compared to the gaps associated with other degrees of freedom; when this condition is satisfied, it is valid to retain only interacting di usion m odes and ignore all other degrees of freedom. We make the same assumption here in our description of the critical point. In the super uid state, this is clearly not su cient, and we will have to retain an extra degree of freedom. It may also be necessary to include extra degrees of freedom to properly describe the Bose glass insulating state.

O ur treatm ent of the critical saddle-point and nonlinear -m odel (NL M) for interacting bosons follows that of F inkelstein for the ferm ionic case and also that of the bosonic representation of the non-interacting problem. Hence, we will merely give an outline in this section and the next, em phasizing the important di erences. D etails are presented in appendix A. We begin by using the H ubbard-Stratonovich transform mation to decouple the v_0 term with a matrix $Q_{ab;AB}^{mn}$. We then decouple the interaction in two dimensional event ways with X, which decouples the direct and exchange channels according to X, and X, which decouples the Cooper channel according to X, Finally, we decouple the chemical potential term with In this way, we have a system of non-interacting bosons at zero chemical potential { their critical point { moving in the background elds X, X_c, and Integrating out the olds we obtain the continue action (movement of the theorem is a system).

The G reen function \hat{G} of the $_A$ s is written as a 2 2 matrix in the nal line to emphasize the particle-hole structure. It is the operator inverse of the expression inside the logarithm. For 0, it is not even necessary to introduce ; we can simply drop the last line of (9) and insert inside the logarithm.

Let us now consider the saddle-points of this e ective action. For > 0, there is a saddle-point with h i \leq 0. (W hen we include uctuations, will be renormalized, so the critical value will not be zero.) W hen develops an expectation value, Q, X_c, and X are forced to follow since they are coupled directly to bilinears in . This is the super uid phase.

Let us absorb the realpart of the saddle-point value of Q into a renorm alized $_{\rm R}$ and focus on the in aginary part.

This is the di usive saddle-point for self-consistent B om scattering of critical bosons by in purities. It corresponds to a nite density of states for the bosons at this level of approximation. Notice that this saddle-point solution is taken to be replica symmetric.

Now, for $_{\rm R}$ < 0, there is another translationallyinvariant saddle-point with Q = 0. For this solution, a

non-zero density-of-states in not generated in the insulating state at this level of approxim ation; it rem ains a M ott insulator. We would like to point out two possible mechanism s to generate the nite density of states that occurs in the Bose-glass phase. One is that the correct saddle points are replica sym m etry broken m ixtures of the Q = 0and Eq. 11 solutions. A possible self-consistent solution is one still diagonal in replicas but with zero matrix elements for preplicas and unit matrix elements for n р replicas. A nother possibility is that there are non-trivial instanton saddle-points which generate a nite densityof-states¹³. In the absence of interactions, the bosons will condense into these localized states, so we must consider the corresponding instantons with ; $_{c} \in 0$. At present, we do not have a description of the Bose glass insulator, but this does not a ect our ability to describe the critical point between it and a superconductor.

It is useful, in thinking about this theory, to in agine lowering the temperature of a system of dirty bosons. At nite temperature, there will be a nite wedge in the phase diagram { the quantum critical region^{14,15} { where the bosons will be e ectively critical. In this regime, we may begin by considering non-interacting bosons which are sem iclassically scattered by in purities. As we decrease the temperature, we must begin to include the e ects of interactions and of quantum interference processes. If we stray too far from the critical as we lower the temperature, thereby leaving the quantum critical region, then we cannot include these e ects perturbatively. It is clear that they completely destabilize the di usive saddle point, so they must be included right from the start (e.g. by starting from new saddle-points, as we have sketched above) in order to describe the super uid or insulating phases correctly. However, so long as we remain at criticality, we can hope to account for these e ects perturbatively. To such an analysis we turn in the next section.

IV. -MODEL FOR INTERACTING BOSONS

To go beyond a non-interacting, sem iclassical analysis and include the e ects of interactions and quantum inter-

where $J_{AB} = \frac{p_{\overline{2}}}{2} (AB = \frac{2}{AB})$ and $S_{AB} = \frac{3}{AB}$ i_{AB} express the particle-hole matrix structure for the densitydensity and Cooper channels, respectively. The parameter Z is 1 in the bare action above; how ever, this quantity is renorm alized, so we have introduced it explicitly here. We have absorbed the density-of-states into the di usion constant D (and also the coe cients of the other term s); the resulting quantity is just the bare conductivity and is given by $D = 1=2^{3}$ in the above model. How ever, as we noted earlier by considering a model with anisotropic masses, and a su ciently large or small ratio $m_1 = m_2$, the bare conductivity will be large. The resistivity q = 1 = (2 D) is the expansion parameter used in our RG equations, so this observation gives us a lim it in which they can be applied without apology.

It may strike the reader as strange that we are using a NL M to describe a critical point; usually NL M s are used to describe stable phases because they are so highly constrained by symmetry. However, the NL M of eq. 12 is not, in fact, so rigidly constrained at all. The interaction terms and the tr (^Q) term explicitly breaks the O ((k + 1)N; kN) symmetry' of the model. The latter breaks it in such a way as to push the theory into a diffusive m etallic state. However, this symmetry-breaking ' eld' is sm all in the low -energy lim it, so other sym m etrybreaking elds (or anisotropies) can intervene instead. orders in eq. 9, Q is forced away from the dif-W hen fusive direction' in its saddle point manifold, and into the super uid plane', where Q has non-vanishing com ponents which are o -diagonal in particle-hole indices. Thus, we can understand the perturbations which lower the symmetry of the saddle-point manifold as perturbations which drive the system away from criticality. There

are a variety of ways in which one can imagine driving the system into an insulating phase. In the absence of a better understanding of the Bose glass phase, we consider the simplest which is just a mass' term of the form tr (M Q), with M a constant matrix say in replica space, which breaks the symmetry of the saddle-point manifold and leads to an insulating state. Such a perturbation di ers only in index strucure with the one imposed by a

nite . Such a term is also generated by shifting out of the trln[:] term when considering replica symmetry broken saddles. Note that none of these possibilities can occur in the non-interacting problem, where the symmetry of the saddle-point manifold is a genuine symmetry.

W e parametrize Q about the non-interacting saddle point as

where the block structure is in frequency space, i.e., the matrix q_{nm} is such that n = 0 and m < 0.

The resulting action is very similar to the O (N) sigm a model which is appropriate for a system of fermions with spin-orbit scattering. Indeed, one can be transformed into the other by rede ning q ! q, \vec{q} ! \vec{q} , and D ! D. The interaction term s look somewhat strange at rst glance, but the extra i's in (13) are precisely compensated by the explicit factors of e $i_{\vec{q}}n_i$ in Eq. (12) (see appendix C).

V. RG EQUATIONS

Taking advantage of the observation at the end of the previous section, we can obtain the RG equations for our

-model by ipping g ! g in the equations for the corresponding ferm ionic model. Some factors of 2 w ill be di erent because our bosons are spinless. More details may be found in appendix C.

The RG equation for $\frac{2}{c}$ is:

Observe that $_{\rm c}$ ows to zero, even if g = 0. Hence, we set $_{\rm c}$ to its xed point value of zero and consider the RG equations for g, and Z in its absence. To order g^2 and allorders in (although, of course, we cannot access non-perturbative e ects associated with saddle-points which are far from the non-interacting di usive one), the RG equations are:

The physics of these equations is clear from the discussion in the introduction. Interactions always enhance the conductivity to order g^2 because the exchange term has the same sign as the direct term (they are folded into a single in the bosonic NL M (12)). The gist of the effect can be seen from the Hartree and Fock diagrams for the boson self-energy displayed in g. 1. In the Hartree




FIG. 1: The Hartree and Fock diagrams for the boson selfenergy

diagram, the boson line is repelled by the boson bubble which is a measure of the ground state density. (In a pure system, this is uniform and cancelled by the neutralizing background.) In a ferm ionic system, the Fock diagram comes with the opposite sign, so it is an elective attraction. In a bosonic system, how ever, both diagram s come with the same sign and lead to a repulsion of particles from regions of high density { which, of course, are precisely the regions where there are deep wells in the random potential. The interaction strength, , grows in importance at low energies because it plays a role som ew hat analogous to the Pauli exclusion principle: in its absence, all of the bosons would sit in the low est m in im um of the random potential. Z must follow in order to maintain a nite com pressibility.

Notice from Eqs. (16,17) that Z remains invariant under the RG ow, as a result of W and identities that originate from charge conservation. It is very useful to introduce the coupling constant = = Z, which allows us to rewrite the RG equations in a simpler way:

For g > 0, it follows from Eq. The while the = 1 one is stable. Consider the RG equation for g. The rst term on the right-hand-side is the weak-localization correction, while the second term is the interaction correction. Although the entire surface g = 0 with arbitrary is left invariant under the RG ow, any system with bare g; \notin 0 will necessarily ow into the g = 0; = 1 xed point. This is the case for short-range interactions, where the ow starts with a value < 1. Note that if the bare interaction is weak, 1, then the resistivity will initially increase before eventually decreasing to zero.

Now, consider the case of dynamically-screened C oulom b interactions. As in the ferm ionic case, the W and identity for charge conservation requires the density-density correlation function to vanish at q = 0. This, in turn, requires the q-dependent interaction (q), which generalizes to the case of C oulom b interactions, to satisfy the identity^{3,4,5}:

Taking the q! 0 lim it of (20), we obtain Z = . Substituting this identity into (15), we see that the second term inside the square bracket in (15) vanishes. Thus, the RG equation for g is dg=d' = $3g^2=2$, and the resistivity

ows logarithm ically to zero. The system is controlled by the same in nite-conductivity xed point as in the short-ranged case.

Before concluding this section, let us write down the asymptotic behavior near the xed point g = 0; = 1, which we will need later to obtain the critical exponents: g 2=3`and 1 exp(d`g) `²⁼³.




FIG.2: RG ow for the resistivity g and interaction parameter = =Z

VI. CRITICAL BEHAVIOR

The most striking conclusion about the critical behavior of this system is that the critical resistivity is zero! In other words, the 2D superconductor-insulator transition is broadly similar to the 3D one. This is som ewhat unexpected. In models such as the Bose-Hubbard model, which describes a super uid insulator transition in a clean system, or the 2 + 1-dimensional X Y model, one nds = ce²=h, with c a nite universal num ber. At our xed point, c = 1. A nother odd feature is the logarithm ic approach to the critical resistivity which we nd; this logarithm is rather di erent from the type which are encountered in the lower critical dimension of a phase transition (which happens to be d = 1 for the super uid-insulator transition). Since a logarithm ic ow is rather slow, it may not be possible to observe c = 1. Instead, the critical conductivity at a given tem perature m ay actually appear to be a non-universal num ber which depends on the bare conductivity.

Let us also consider the single-boson density of states, N (!). This may be studied by introducing a source term for tr(Q) into the elective action and computing its renormalization. In a system with short-ranged interactions, we nd:

the scaling relation for N (!) in plies that the critical exponent = 0 with logarithm ic corrections. However, in the presence of dynam ically-screened C oulom b interactions, there is a more severe divergence, and we nd:

C onsequently, the single-boson density of states diverges at the transition with the power-law N (!) ! $^{2=3}$. This im plies that the critical exponents and z satisfy =z =

2=3. Note that we have calculated the density-of-states at a metallic critical point. Thus, we should not expect C oulom b gap physics to suppress it and give > 0. In the ferm ionic case, the suppression of the density-of-states is due to the dom inance of the exchange interaction.

O urNL M does not explicitly include single-boson operators. We assume that their properties can be deduced from the the density-of-states. It is certainly possible for single-particle operators to be critical even in a theory in which only collective m odes are retained; this is the idea behind bosonization. It is conceivable, how ever, that our NL M is incom plete, as regards single-boson properties. This could occur if the critical exponent controlling the correlation function h ${}^y(x;0)$ (x;0)i were unrelated to that controlling h ${}^y(0;)$ (0;0)i.

Since Z diverges only logarithm ically, the dynam ical exponent, z = 2, as in a non-interacting system . However, in the case of dynam ically-screened C oulom b interactions, there are actually two di erent diverging time scales. One, with exponent z, is the scale associated with Z; it controls the scaling of the speci c heat and energy di usion. There is a second exponent, z_e , asso-, which controls charge di usion. By ciated with Z the same argument as in a fermionic system 5 , eq. 20 implies at small q that Z q, from which we con-¹, i.e. $z_c = 1$. This result was clude that Z obtained for the superconductor-insulator transition by a closely-related argum ent in ref. 9. C om bining this with our density-of-states calculation, we have = 2=3 for Coulomb interactions. Notice that = 2=3 < 0 sat-< 2 d of Ref. 9 for d = 2.is es the lower bound The density-of states and the dynamical exponent, $z_{c,i}$ are the only quantities which distinguish short-ranged and dynamically-screened Coulomb interactions in the infrared lim it.

As we discussed in section IV, the leading perturbation of our model is a tr (M Q) term, where M is a constant matrix say in replica space, which breaks the replica symmetry of the di usive saddle-point manifold possibly in the direction of the Bose-glass phase. This is (21) a dimension 2 operator at tree level. (If the matrix M is proportional to the identity in replica space, this operator is instead just a constant at the di usive saddle-point.) Since the coupling constant g ows to zero, we expect a critical exponent = 1=2, up to logarithm ic corrections. This value of { the mean-eld value { violates the bound 2=d of ref. 17. How ever, such violation has been seen in other system s as well, and it has been argued 18 that the exponent bounded by the theorem of ref. 17 is, in fact, a nite-size scaling exponent which can be di erent from $% A^{2}$.

VII. DISCUSSION

D i usion in two dimensions is marginal, and small corrections (in the lim it of large conductivity) such as that due to quantum interference or interactions can tip the balance one way or the other. Contrary to conventional wisdom, it is hardly a foregone conclusion which e ect willw in. A fler all, weak localization is weak. Interactions can easily overpower it, leading to metallic behavior. A c-cording to our analysis, this is precisely what occurs at the superconductor-insulator transition. The e ect of interactions is so dom inant that the universal value of the conductivity at the transition is in nity. Such a diverging conductivity has been found in models with interaction and dissipation, but without disorder¹⁹.

The possibility of a metallic phase within the Bose glass phase has been studied recently^{20,21}. We focus on the di usive properties at the critical point, and do not investigate whether saddle-point solutions whithin the Bose glass could lead to non-zero conductivities. How – ever, it is noteworthy that an in nite critical conductivity is consistent with a Bose metal with a diverging conductivity at the transition²¹.

We derive these results in a NL M approach, in which we discard those criticalm odes of the clean system which are extraneous and retain only the particle di usion m odes of the disordered system. The resulting NL M leads to a number of non-trivial predictions: (1) the critical conductivity is in nite; (2) there are two diverging times scales if the interaction is C oulom bic, one associated with charge di usion, which has exponent z = 1, the other associated with energy di usion, which has exponent z = 2; (3) the single-boson density of states diverges as ! 2^{-3} , which in plies a critical exponent = 2-3 in the case of C oulom b interactions; for short-range interactions, it diverges logarthm ically; (4) the correlationlength exponent takes the mean-eld value = 1=2.

If boson-vortex duality were to hold exactly, then one would expect g = 1 (in units of $(2e)^2 = h$). Our result ap-

pears to imply that duality is violated logarithm ically: bosons are more mobile than vortices in the infrared lim it. However, it is hard to see how the physics of vortices enters at all into our calculation, so it is possible that we have m issed in portant non-perturbative e ects. Our results do not agree with the num erical study of W allin, et al.²². How ever, the ow to our xed point is logarithm ic, and this m ay be too slow for a num erical study on a nite-sized system. A Iternatively, they may simply be accessing a di erent xed point which attracts system s with small bare conductivities. And nally, since their starting point studies phase but no amplitude uctuations, the two models may simply be in di erent universality classes. Our results also di er quantitatively from those of Herbut, which are based on an expansion about $d = 1^{23}$

The measured critical exponents for the zero-eld superconductor-insulator transition, which is accessed by varying the thickness of a thin $m^{24,25}$, are those of classical percolation. This does not agree with our theory, but it also suggests that the experiments are not quite in the asymptotic quantum critical regime, but rather in som e higher-tem perature classical regim e. There is disagreem ent about the values of the critical exponents at the magnetic- eld-tuned superconductor-insulator transition. One experiment²⁶ nds percolation-like exponents, while another²⁵ nds = 0.7 0.2, which includes our theoretical prediction at the edge of its error bar. (All of these experiments nd z 1, as expected on general grounds^{5,9}, and in our theory.) The applicability of our strategy to a magnetic- eld-tuned superconductorinsulator transition is a question for future study.

It is trivial to show by integration by parts (splitting the integrands into $f(y) = y = (y^2 + 1)^3$ and g(y) = y) that the integral in Eq. (B11) scales as ($y^{l=2}$ ⁴. Thus the cut-o can be safely taken to in nite for d < 8, and Im D = 0.

Notice the di erence between the fermionic and bosonic cases. In the fermionic case one can also interchange momentum p integrals for energy integrals, using the density of states at the FermilevelE_F. The integrals are cut-o by the bottom of the band, E_F away from the zero energy states. In the bosonic case, one starts from the bottom of the band, and needs to include an energy dependent density of states (); the cut-o is introduced only for convergence, and ! 1 is possible for d < 8. In contrast to the fermionic case, where E_F is nite, in the bosonic case for a perfect parabolic spectrum ! 1. The sm all parameter for the Fermi case is (E_F)¹, whereas for the Bose case it is ()¹!

APPENDIX C:PARAMETERIZATION OF THE SADDLE AND RELATION TO THE FERMIONIC -MODEL

As we previously mentioned, we can easily obtain the RG equations for the conductance and interaction couplings by determining a correspondence with the fermionic model. Here we show how this is achieved.

Let us rst look at the F inkelstein type term s in the effective action for the Q elds. The Q m atrices are param – eterized as in in Eq.(13), repeated here for convenience.

These factors will cancel each other in the expansion of the quadratic in Q di usive term, and hence can be dropped, and once again the ferm ionic saddle expansion can be used. The overall factor of i has the e ect of changing D ! D.

In sum m ary, all the RG equations for the dirty interacting boson problem can obtained from those of the (interacting) ferm ionic orthogonal ensemble upon replacing g ! g (or D ! D).
