X -ray spectra of 3d m etals of H eusler alloys and La_{1 x}Sm _xM n₂S i₂ com pounds

The M n x-ray emission spectra and x-ray photoemission spectra of M n-based Heusler alloys Co_2M nAl, Co_2M nSb and $La_1 \ _xSm _xM n_2Si_2$ compounds (x=0, 0.8) have been measured and discussed in connection with a value local magnetic moment at M n site. The spectra peculiarities re ect also the localization degree of 3d valence electrons of 3d m etals in considered compounds.

I. IN TRODUCTION

M agnetic properties of localized and delocalized m agnetics are usually bound with the peculiarities of their electronic structure and found to be explained within the fram ework of these terms. Here x-ray emission (XE) and x-ray photoem ission (XP) spectroscopy is used to bring light on the di erences in 3d m etal spectra of close to half-m etallic [1]M n based H eusler alloys and rare-earth M n containing com pounds both within general problem of strong m agnetism of the 3d m etal alloys and com pounds. U sing the sam ples well studied experimentally before by di erent techniques we will discuss the di erence at x-ray spectra of 3d m etals in connection with the value of the local m agnetic m om ent and di erent spin polarization of the value celectrons using the x-ray spectroscopy. The selection of the sam ples will be explained below. First let us pay attention to the techniques being used.

The x-ray spectroscopy is a well-known to be an element-selective probe of electronic structure. That opens the principal ability to provide inform ation about the relation between a magnetic properties and x-ray spectra, because it deals with a short-lived states, so it is complementary with data obtained from static magnetic measurements. The emission process accrues in a mst coordination sphere, therefore it is good to use that to investigate the formation of localm agnetic moment of 3d m etal. General techniques being used are the x-ray emission, x-ray photoemission and x-ray absorption spectroscopy using the circularly polarized energy-variable excitation source, that allows to study a ne structure of electronic states and their spin con guration. That could be combined with a tradition techniques using non-polarized excitation with a metals by processing of x-ray spectra of 3d m etals in dimensity becalized and itinerant magnetics containing 3d transition metals by processing of x-ray spectra of 3d m etals in dimensity polarized structure of Heusler A lloys (HA) (C o₂M nA l, C o₂M nSb) and La_{1 x} Sm xM n₂Siz com pounds (x= 0, 0.8).

First attention to Heusler alloys has been paid in 1903 when Heusler [2] discovered ferrom agnetic behavior in com pounds of nonmagnetic elements. Such ternary alloys are determined by the generic formulas X_2YZ or XYZ[3, 4, 5] For the Y-elem ent Heusler alloys usually contain Mn, the X element, for example, can be X: Fe, Co, Ni, Cu, Pd, or Rh. For the Z element it is considered Al, Ga, Si, Sn, Sb, or In. Crystallizing in the space groups L21, Mn-based HAs have been found at most in a ferrom agnetic ground state. They o er the unique possibility to study m anganese com pounds where the M n atom has only other transition X m etals as nearest neighbors and non-transition Z elements of group III V in the second coordination sphere. Webster et al. and later on Robinson et al. [6, 7] have investigated the crystal structure of these alloys in detail. Furtherm ore, it has been shown that som e disorder is offen appearing in M n-based HAs and that in total up to 10% of the M n atom s change places with elements from a dierent sublattice. The neighborhood of M n atom s is mainly built by X and Z elements. M n-based Heusler alloys have an e ective magnetic moment of about $_{Mn}$ = 3.0 4.0 $_{B}$ localized at the Mn site. Traditionally they are considered as ideal system s with localm agneticm om ents. First principle band structure calculations [8] for these alloys have show n that in the electron system with spins directed along the magnetization axis (") the M n-3d states are occupied and hybridized with the 3d states of the X atom s. In the electron system with spins directed against the magnetization (#) local, not hybridized empty M n-d states have been observed, located at 1.0 1.5 eV above the Ferm i level [8, 9, 10, 11] Z atom s supply sp electrons, which take part in an indirect M n-M n exchange and therefore determ ine the degree of occupation of hybridized pd orbitals. Further investigations on Mn-based HAs Refs. [1, 12, 13] predict the existence of a half-m etallic ferrom agnetic (HMF) state, for example, in NMnSb, PtMnSb, PdMnSb, and PtMnSb. This means that an energy gap at the Ferm i level exists for one spin orientation and a m etallic behavior has been obtained for the other spin direction. O ther band structure calculations reveal that a HMF ground state m ay also exist for C o2M nZ albys [14]. Both neutron scattering m easurem ents [15, 16, 17] and theoretical predictions [18] show well de ned local m om ents $_{\rm Mn}$ (see Table I). The local magnetic m om ent at Co atom s is much smaller then at Mn (less then 0.5 $_{\rm B}$,

[6, 19]. The remarkable feature of M n 3d valence band for alloys being considered is a theoretically predicted pseudo gap for m inority spin electrons, that m akes alloys to be close to class of half-m etallic ferrom agnets.

The RM n_2S_2 compounds (R is rare-earth metal) crystallize in the tetragonal ThC r_2S_2 structure, where separate layers are stacking along c-axis in the M n X R X M n sequence. The compounds are assumed to exhibit an unusual strong dependence of M n-M n exchange interaction from the distance between M n atom s in a single layer [20, 21]. The relation of such unusual M n behaviour in RM n_2X_2 and peculiarities of their electronic structure is suggested to be dependent of the $d_{M n M n}$ in the neartest neighborhood. In case of $d_{M n M n} \ll d_c$ where $d_c=2.85-2.87$ A is the critical distance for the space localization of M n 3d electrons, magnetic moments are aligned primarily along the c-axis that leads to antiferrom agnetic order. In case of $d_M n M n$ ferrom agnetic order is appeared. The distance between R (001) and M n (100) planes is about c=2 = 52A, that exceeds the one between R atom s ($d_{R R} = a 4.2A$) and M n atom s ($d_{M n M n} = \frac{a}{P_2} 2.3A$). Last value is close to the critical $d_c v 2.84$ for space localization-delocalization of M n 3d electrons in the crystal space according to predicted [22]. The doping of the second rare-earth m etal in RM n_2S_2 com poundes allow s to gradually change M n-M n distance from $d_{M n M n} > d_c$ for LaM n_2S_2 to $d_{M n M n} < d_c$ for Sm M n_2S_2 [23]

The system has an elective magnetic moment about $_{eff} = 3.5 \quad 3.8 \, _{B}$, that is similar to Heusler alloys, although the value of $_{M n}$ is smaller and found to be in range 2.3 $2.5 \, _{B}$. The value of local magnetic moment $_{M n}$ changes from 0 to 1.45 $_{B}$ with x changing from 1 to 0. The relation of such unusual M n behavior in RM n_2X_2 and peculiarities of their electronic structure is suggested to be depended of the $d_{M n M n}$ in the nearest neighborhood. In case of $d_{M n M n}$ d_c , where $d_c = 2.85 \quad 2.87 \, A$ is the critical distance for space localization of M n 3d electrons, magnetic moments align primarily along the c-axis that leads to antiferrom agnetic order, and in case of $d_{M n M n} > d_c$ the ferrom agnetic ordering appears. Note that in set RM $_2X_2$ doping by di erent 3d transition m etals M = Fe_cC o_cN i_dM n, only m anganese contains the non-zero local magnetic moment. C alculations [24] show the non-strongly spin-polarized M n D O S, unlike in Heusler alloys. It was suggested that M n 3d states of RM n_2X_2 have been hybridized with X-p states, in our case-with Sip states due to close positions in a single layer. The direct M n-M n exchange interaction prevails in a single layer of M n atom s. The one between the nearest single layers is realized by the La-f and Sm -f electrons hybridized with M n 3d and also Sip electrons.

Finally we concentrates on the question of the in uence of localization degree of 3d electrons, the values of the local magnetic moments of 3d metals at x-ray spectra. The M n-M n distance in Heusler alloys exceeds the value for RM n_2Si_2 in factor two. In other hand, the magnetic ordering is formed by indirect intralayer exchange, that is opposite to direct exchange mechanism in RM n_2Si_2 . Calculations also predict the localization di erence in k-space [24]. These factors de ned the choice of selected materials. The principal opportunity of using the spectroscopy to detect the in uence of an atom magnetic moment to X-ray spectra spectra had been shown by van A cker et al. [25]. The corresponding experimental data have been obtained for a series of alloys and compounds containing Fe. The energy splitting of the Fe-3s band is essentially di erent for each material, but without strong correlation e ects. From more recent experiments, in which polarized radiation has been used it is evident that the dispersion as well as the energetic position of the Fe-3s band varies as a function of the electron spin [26].

II. EXPERIMENTALDETAILS

The specim enswere prepared from a melt in an atmosphere of puri ed argon, annealed at 720 C during 24 h for Heusler alloys and at the tem perature T = 900 C for La_{1 x} Sm x M n₂Si₂ in argon and quenched in water. A coording to X-ray di raction patterns (Cu K) sam ples were in single phase.

X-ray photoelectron spectra (XPS) were measured using a PHI 5600ci spectrom eter with an energy resolution of 0.35 eV with monocromatized AlK radiation. The compounds were crushed in situ in vacuum $1 \quad 10^7$ Torr. The surface cleanlyness was tested by monitoring the C-ls and O-ls peaks. During the measurements in vacuum $1 \quad 10^9$ Torr no signi cant increase in the contam ination was observed.

X-ray emission spectra were obtained using an x-ray spectrom eter of the type RSM -500. The measurements have been carried out at a voltage of U = 4.5 kV, an anode current of about 0.3-0.4 mA and $1 \quad 10^7 \text{ Torr vacuum}$. The energy resolution in the XE spectra resulted in 0.7 eV. Last but not least the rest contamination with oxygen has been estimated during the heating procedure. This has been done by controlling the intensity ratio of the lines 0 K and M n L₁ in the corresponding XE spectra.

III. D ISC U SSIO N

The M n 3s photoem ission spectra of compounds and pure manganize are shown at Fig.1. The multiplet splitting is observed in form of two peaks at the binding energies $E_B = 83$ and $E_B = 87.5$ eV for pure M n and RM n_2 Si2. No clear

dependence of the spectra shape and the local magnetic moment at M n site is observed for whole series of com pounds, but roughly it is possible to distinguish only small splitting of M n 3s core level due to interaction between 3d valence electrons and 3s core hole created and the binding energy shift of M n 3s XPS about 0.6 eV toward high energy side.

Brie y, such e ect is explained by the di erence in the energy for $M n 3_3^{13}3d^5S$ nalstate, that comes to be result of the strong exchange interaction between $M n 3s_j$ hole and strongly spin-polarized M n 3d electrons in case of $Co_2M nSb$. At Fig. 2 the M n 2p XPS have been show n.

The spin-orbit splitting at the M n $2p_{1=2}$ peak with the binding energy $E_B = 649:7$ eV and at the M n $2p_{3=2}$ peak with $E_B = 638.5$ eV are observed clearly. Opposite to M n 3s photoem ission spectrum at Fig.1, M n 2p spectrum di ers from pure M n for both series of com pounds. The M n $2p_{3=2}$ peak splits at two, each position of is marked as A and B. The energy position of peak A is the same for all M n 2p spectra. The energy position of the peak B is moving toward high binding energies and the intensity is rising in line $La_{02}Sm_{08}Mn_2Si_2$, LaM n_2Si_2 , Co₂M nA l, Co₂M nSb. For RM n_2Si_2 com pounds the value of splitting is 0.7-0.8 eV and for Heusler alloys it is approximately 1 eV. No energy shifts of M n 2p XPS have been observed com paring to pure m etal spectrum. Peak of very weak intensity at the $E_B = 641$ eV appears at the edge of M n $2p_{3=2}$ spectra due small am ount of oxygen at the surface.

The M n $2p_{3=2}$ energy splitting is connected to the strong 2p 3d exchange interaction [27] that correlates with M_n . Such qualitative dependence is observed between RM n₂Si₂ with $M_n = 2.3$ 2.8 and H eusler alloys with M_n see TableI. The absence of satellite peaks and energy shifts at whole M n 2p XPS allows to expect that e ects being observed for M n 3s XPS are due to localm agneticm on ent at M n site, like in cases [25, 26]. That also is in agreem ent with C o 2p and La 3d photoelectron spectra at Fig.3 and Fig.4 displaying no signi cant changes.

The M n L_2 , L_3 X -ray em ission spectra corresponds to em ission transition of M n 3d valence electron to $2p_{1=2}$ and $2p_{3=2}$ core hole respectively. C om paring spectra between each other (Fig.5) one nds two remarkable features. The height of I (L_2)=I (L_3) intensity ratio correlates with M_n . The L_3 peak consist of two peaks A⁰ and B⁰, that is observed in case of H eusler alloys and again is due to high localization of strongly spin-polarized M n 3d electrons [28].

In x-ray em ission spectra of 3d m etals such a peak B⁰ located toward high photon energies is explained by the in uence of inner C oster-K ronig transition [29, 30, 31], but that is opposite to the high intensity ratio observed. B oth the presence of the peak B' with energy exceeding the M n $2p_{3=2}$ core level binding energy and the I (L₂)=I (L₃) high intensity ratio are indicating the existence of pseudo gap for one of M n 3d spin-projection at valence band. That is characteristic for the case of the strong localization of 3d electrons [28, 32, 33].

The Co XPS spectra of Heusler alloys and La, Sm spectra of core levels are shown at Fig 3, Fig.4. There is no di erence between the pure metal spectra and one in compounds. Co L_2 , L_3 emission spectra resemble with one of pure Co, that correlates with a small value (less then 0.5 $_B$), thought [33]) of atom magnetic moment in compounds. It is also con med by Co L_2 , L_3 spectra exhibiting no changes in comparison to the pure Co L_2 , L_3 spectra (see Fig.6).

IV. CONCLUSION

The presented analysis gives an opportunity to discuss the degree of valence electron localization for di erent com pound with a metallic type of conductivity. For example, analyzing the same of spectra of metal oxides, x-ray spectra contains not only C oloumb exchange interaction appears in x-ray spectra, but also charge-transfer e ects. Latter factor makes complicated the interpretation of x-ray spectra. Both the degree of localization of 3d valence electrons and type of chemical bonding is to be relected in x-ray spectra, that is observed at the example of M n spectra in compounds even using non-polarized and non-resonant energy excitation source.
