Spin Fluctuation Induced Superconductivity Controlled by Orbital Fluctuation

A m icroscopic H am iltonian re ecting the correct sym m etry of f-orbitals is proposed to discuss superconductivity in heavy ferm ion system s. In the orbitally degenerate region in which not only spin uctuations but also orbital uctuations develop considerably, cancellation between spin and orbital uctuations destabilizes $d_{x^2 \ y^2}$ -wave superconductivity. Entering the non-degenerate region by increasing the crystalline electric eld, $d_{x^2 \ y^2}$ -wave superconductivity mediated by antiferrom agnetic spin uctuations emerges out of the suppression of orbital uctuations. We argue that the present scenario can be applied to recently discovered superconductors C eT In₅ (T = Ir, R h, and Co).

U nonventional superconductivity has been one of central issues in the research eld of strongly correlated electron system s. Especially since the discovery of high tem – perature superconductivity in cuprates, much e ort has been focussed on elucidating the mechanism of unconventional superconductivity, clarifying that a crucial role is played by antiferrom agnetic (AF) \spin uctuations" (SF) [1]. The importance of AFSF is widely recognized, for instance, in 4f-and 5f-electron superconducting materials such as $C \in Cu_2 Si_2$ [2] and $UPd_2A \downarrow_3$ [3] as well as in organic superconductors such as -(BEDT-TTF) [4]. Thus, it is widely believed that a broad class of unconventional superconductors originates from SF.

In d- and f-electron systems, however, the potential importance of orbital degrees of freedom has recently been discussed intensively. In fact, \orbital ordering" is found to be a key issue for understanding m icroscopic aspects of the charge-ordered phase in colossalm agnetoresistive m anganites [5]. This orbital ordering is prim arily relevant to the insulating phase, while \orbital uctuations" (OF) should be signi cant in the m etallic phase. R ecently, the e ects of OF have attracted attention, since it is hoped to provide a new scenario for superconductivity [6]. Especially from a conceptual view point, it is in portant to clarify how superconductivity em erges when both SF and OF play active roles.

As a typicalm aterial for investigating superconductivity in a system with both SF and OF, let us introduce the recently discovered heavy-ferm ion superconductors CeT In₅ (T = Ir, Rh, and Co) [7] with the HoCoG a_5 -type tetragonal crystal structure. Due to this structure and to strong correlation e ects, the sim ilarity with cuprates has been emphasized. In particular, AFSF also plays an essential role in the C e-115 system , since it exhibits quasi two-dimensionalFermisurfaces [8] and the AF phase exists next to the superconducting state in the phase diagram of $C \in Rh_1$, $Ir_x In_5$ [9]. In fact, a line node in the gap function has been observed in CeT In₅ by various experim ental techniques [10]. It may be true that superconductivity itself is due to AFSF, but an important role for the OF has been overlooked in spite of the fact that both SF and OF are originally included in the ground-state

multiplet of Ce^{3+} ion. In actual materials, superconductivity occurs in a situation where OF is suppressed, since orbital degeneracy is lifted by the e ect of the crystalline electric eld (CEF). Thus, we envision a scenario where OF controls the stability of the superconductivity even though it originates from AFSF.

In this Letter, we investigate superconductivity based on the orbitally degenerate Hubbard model constructed by the tight-binding m ethod [11]. Solving the gap equation with the pairing interaction evaluated using the random phase approximation (RPA), we obtain several superconducting phases around the spin and orbital ordered phases. In the orbitally degenerate region where both SF and OF are developed, it is found that singlet superconductivity is suppressed due to the competition between them, while triplet superconductivity is favored since they are cooperative in this case. W hen a level splitting is included to lift the orbital degeneracy, d_{x^2} v^2 -wave superconductivity due to AFSF is stabilized in the vicinity of the AF phase. Thus, we claim that AFSF-induced supercondutivity in Ce-115 systems is substantiated in consequence of the suppression of 0 F.

In order to construct the microscopic model for felectron systems, let us start our discussion from a local basis of the C e³⁺ ion. Among the 14-fold degenerate 4f-electron states, due to the e ect of strong spinorbit coupling, only the j= 5/2 sextuplet e ectively contributes to the low-energy excitations (j is total angular momentum). This sextuplet is further split into a 7 doublet and a 8 quadruplet due to the e ect <u>pf cubic</u> CEF, where the eigen states are given by j 7 i= 1=6j 5=2i 5=6j 3=2i, $j_8^{(1)}i=$ p 5=6j 5=2i+ 1=6j 3=2i, and $j_8^{(2)}i=$ j 1=2i. Here + and in the subscripts denote \pseudo-spin" up and down, respectively, within each K ram ers doublet.

Now we discuss the relative positions of the energy levels of $_7$ and $_8^{()}$ while taking account of certain features of C eT In₅. Since C eT In₅ has a tetragonal crystal structure and a quasi two-dim ensional Ferm i surface [8], it is natural to consider a two-dim ensional square lattice com – posed of C e ions. D ue to the e ect of an ions surrounding

the Ce ion, it is deduced that the energy level of $_7$ becomes higher than those of $_8$'s. Thus, in the following, the $_7$ orbital is neglected for simplicity. Note also that we need to include the e ect of the tetragonal CEF, which lifts the degeneracy of the $_8^{(1)}$. A lthough a mixing between $_7$ and $_8^{(1)}$ generally occurs under a tetragonal CEF, such a mixing is expected to be small since the

7 orbital has higher energy. Thus, in this situation, the e ect of a tetragonal CEF can be included in terms of a level splitting " between the $\binom{(1)}{8}$ and $\binom{(2)}{8}$ orbitals. In order to explain the magnetic anisotropy observed in experiments, $\begin{bmatrix} (1) \\ 8 \end{bmatrix}$ must be lower than $\begin{bmatrix} (2) \\ 8 \end{bmatrix}$, i.e., "> 0 in CeT In_5 . The magnitude of "for each CeT In_5 compound will be discussed later. It should be noted that the above level scheme is consistent with the following two facts: (i) Experimental results for CeT In₅ exhibit a larger uniform susceptibility form agnetic eld perpendicular to the $CeIn_3$ plane than for the parallel case [7,12]. This significant anisotropy is well explained under the assumption that $_7$ is not the lowest-energy state and " is positive. (ii) The band-structure calculation results suggest that the alm ost at band corresponding to 7 appears above the Ferm i level [11].

In order to include the itinerant features of the 4felectrons, a simple way is to include nearest-neighbor hopping for the f-electrons by the tight-binding m ethod [11,13]. A lthough the hybridization with the In 5p electronic states may be important, here such an e ect is considered as renorm alization of the e ective hopping amplitude of f-quasiparticles. Further, by adding the on-site C oulom b interaction term s am ong the f-electons, the H am iltonian becom es

where f_i is the annihilation operator for an f-electron in the orbital $\binom{()}{8}$ at site i, a with pseudo-spin is the vector connecting nearest-neighbor sites, and $n_i = f_i^{y} f_i$. The rst term represents the nearestneighbor hopping of f-electrons with the amplitude $t^a\,_{\scriptscriptstyle 0}$ between $\overset{()}{=}$ and $\overset{()}{=}$ along the a-direction, given by $\overset{()}{t_{12}} = \overset{()}{3} \overset{()}{t_{12}} = \overset{()}{3} \overset{()}{t_{21}} = 3 \overset{()}{t_{22}} = 1$ for a= x and $\overset{()}{t_{11}} = \overset{()}{3} \overset{()}{t_{12}} =$ $y_{21} = 3t_{22}^{y} = 1$ for a=y, respectively, in energy units 3t where $t_{11}^x = 1$. Note the positive sign of the rst term in H, since the M-point, not the -point, is at the bottom of the bands form ing the Ferm isurfaces [11]. Note also that the present t^a_{0} is just the same as that of the e_q electrons [5], but this point will be discussed elsew here. The second term denotes the tetragonalCEF. In the third and fourth term s, U and U⁰ are the intra-and inter-orbitalC oulom b interations, respectively. In reality, $U = U^0$, since they originate from the same Coulomb interactions among forbitals in the j=5/2 multiplet, but in this paper, we also treat the case where $U \in U^0$ in order to analyze the roles of SF and OF. Since we consider quarter-lling (one felectron per site), the model in the limit of "= 1 reduce to the half-lled, single-orbitalHubbard model.

Now, in order to investigate superconductivity around the spin and/or orbital ordered phases, we calculate spin and orbital susceptibilities, s (q) and o (q), respectively. W ithin the RPA, these are given in a matrix form as

where labels of row and column in the matrix appear in the order 11, 22, 12, and 21, these being pairs of orbital indices 1 and 2. Note that 1 is the 4 4 unit matrix. \hat{U}^{s} is given by $U_{11;11}^{s} = U_{22;22}^{s} = U$, $U_{12;12}^{s} = U_{21;21}^{s} = U^{0}$, otherwise zero, while \hat{U}^{o} is expressed as $U_{11;11}^{o} = U_{22;22}^{o} = U$, $U_{11;22}^{o} = U_{22;11}^{o} = 2U^{0}$, $U_{12;12}^{o} = U_{22;11}^{o} = U^{0}$, otherwise zero. The matrix elements of ^(q) are de ned by ; (q)= $T^{P}_{k;n} G^{(0)} (k+q;i!_{n})G^{(0)} (k;i!_{n})$, where T is temper-

ature, G⁽⁰⁾ (k;i!_n) is the non-interacting G reen's function for f-electrons with momentum k propagating between - and -orbitals, and !_n = T (2n+1) with integer n. The instabilities for the spin- and orbitalordered phases are determined by the conditions of det[\hat{l} $\hat{U}^{s}(q) \models 0$ and det[$\hat{l} + \hat{U}^{\circ}(q) \models 0$, respectively.

where $(k) = [1, 1, k), 22, k, 12, k, 21, k]^{t}$ is the gap function in the vector representation for a singlet (= S) or triplet (= T) pairing state, and the matrix elements of the singlet-and triplet-pairing potentials, respectively, are given by

Here, the spin and orbital susceptibilities are included as $\hat{W}^{s}(q) = \hat{U}^{s} + \hat{U}^{s} \wedge s^{s}(q) \hat{U}^{s}$ and $\hat{W}^{o}(q) = \hat{U}^{o} + \hat{U}^{o} \wedge o(q) \hat{U}^{o}$. The elements of the pair correlation function $\hat{}(k)$ are given by ; $(k) = T_{n}^{P} G^{(0)}(k; i!_{n})G^{(0)}(k; i!_{n})$. The superconducting transition is obtained for each respective irreducible representation by solving Eq. (4), where the maximum eigenvalue becomes unity.

Here we mention the essential symmetries of the Cooperpairs in multi-orbital system s. The pairing states are classi ed into four types owing to spin SU (2) symmetry and space inversion symmetry; (1) spin-singlet and orbital-symmetric with even-parity, (2) spin-triplet and orbital-symmetric with odd-parity, (3) spin-singlet and orbital-antisymmetric with odd-parity, and (4) spin-triplet and orbital-antisymmetric with even-parity. Note that SU (2) symmetry does not exist in orbital space,

since the lattice and the local wavefunctions rotate simultaneously. For (1) and (2), f-electrons in the same band form the Cooper pair, while for (3) and (4), such a pair is form ed only between di erent bands. Except for the special case in which two Ferm i surfaces connect with each other, orbital-antisym metric pairing is unstable due to depairing e ects destroy inter-band pairs. In fact, even after careful calculations, we do not nd any region for (3) and (4) in the parameter space considered here. Thus, in the follow ing, we discuss only the orbital-sym metric pair.




FIG.1. (a) Spin and (b) orbital susceptibilities in q space for "= 0 and $U = U^0 = 0.9U_m$. (c) and (d) are for "= 4. Insets indicate the Ferm i-surface lines.

Let us discuss st the e ect of " on the correlation between SF and OF. Since we are considering a realistic situation corresponding to $C \in I = I_{15}$, we restrict ourselves to the case of $U = U^0$ for a while. In Fig. 1, the principal components of s (q) and o (q) are shown in q space for $U = U^{0} = 0.9U_{m}$, where U_{m} denotes spin instability determ ined from det $[\hat{1} \quad \hat{U}^{s}(q)] = 0$. In the orbital-degenerate case with "= 0, as shown in Figs. 1(a) and (b), the overall m agnitude of OF is com parable with that of SF.As for the q dependence, common structures are found in $^{\rm s}$ (q) and $^{\circ}$ (q). Namely, there are two peaks around (=2;=2) and (=2;0) owing to the nesting properties of the Ferm i surface (see the inset). Thus, the orbitaldegenerate region is characterzied by competition between SF and OF.W ith increasing ", the Ferm i surface approaches a shape having the nesting vector (;) (see the inset). For "= 4, as shown in Fig. 1 (c) and (d), OF is alm ost completely suppressed, and SF around (;) becom e dom inant. Note here that the increase of " m akes the lower energy state favorable and suppresses excitations to the upper energy state, indicating the suppression of 0 F. Thus, even at this stage, it is understood that the suppression of OF leads to the developm ent of SF for the param agnetic system which is wavering between spinand orbital-ordering.




FIG.2. (a) Maximum eigenvalue vs. " for the respective inreducible representation at $U = U^0 = 2.5$. (b) Schematic plot c=a vs. " to illustrate a comparison between our theory and actual C eT In₅ compounds.

Next, we consider how a superconducting phase em erges when " is increased. In Fig. 2 (a), the maximum eigenvalues for several irreducible representations are depicted as a function of " for $U = U^0 = 2.5$. The calculations are carried out for a xed T = 0.02, and the rst B rillouin zone is divided into 128 128 meshes. In the orbitaldegenerate region, several eigenvalues are very close to each other owing to multi-peak structures in $^{s}(q)$ and $^{\circ}$ (q). W ith increasing ", as is easily understood from the growth of AFSF mentioned above, the eigenvalue for B_{1q} sym m etry becom es dom inant and nally at " 3, the B_{1g} superconducting phase is stabilized. On further increasing ", the AF instability eventually occurs, since the system asymptotically approaches the half-led singleorbital Hubbard model. We emphasize that the increase of "brings transitions successively in the order of PM, B_{1q} superconducting, and AF phases.

Based on the above calculated results, let us try to explain the dierences among three Ce-115 com pounds, $C \in RhIn_5$ (N celtern perature $T_N = 3.8K$), $C \in IrIn_5$ (superconducting transition tem perature $T_c = 0.4K$), and $CeCoIn_5$ (T_c=2.3K) [7]. One property which distinguishes these compounds is two-dimensionality, as expressed by the ratio c=a between lattice constants. It is naturally expected that two-dimensionality becomes stronger in the order of $CeIrIn_5$, $CeRhIn_5$, and $CeCoIn_5$ [7]. Since the magnetic state should be stabilized with increasing three-dimensionality, CeIrIn₅ should be most favorable for the occurence of antiferrom agnetism am ong three compounds, but this is obviously inconsistent with experimental results. This inconsistency is resolved by introducing another important ingredient ". One can show that the increase of magnetic anisotropy just corresponds to the increase of ". A nalysis of experim ental results for the anisotropy of magnetic susceptibilities [7,12] leads to the conclusion that " becom es larger in the order of $C \in C \circ In_5$, $C \in IrIn_5$, and $C \in RhIn_5$. Taking into account the e ect of " in addition to dimensionality, we arrive at the picture schematically shown in Fig. 2(b). Due to the enhancement of AFSF induced by increasing ", as shown in Fig. 1, it may be understood that $CeRhIn_5$

rather than CeIrIn₅ is more favorable to antiferrom agnetism . Namely, it is considered that CeRhIn₅ with the largest " is antiferrom agnet, while CeCoIn₅ and CeIrIn₅ with smaller " than CeRhIn₅ exhibit superconductivity. The di erence in T_c between CeCoIn₅ and CeIrIn₅ may be attributed to the extent of two-dimensionality. Concerning the superconductivity and antiferrom agnetism of CeIrIn₅ compounds, the combination of two dimensionality and the crystalline eld splitting is necessary to reach a consistent picture.




FIG. 3. Phase diagram (a) in the U-U⁰ plane for "=0 and (b) in the U-" plane for U=U⁰. Meanings of abbreviations used here are as follows: SC() denotes superconducting phase with -symmetry, ICSO(q) indicates incommensurate spin ordered phase with wave vector q, ICOO(q) is incommensurate orbital ordered phase with wave vector q, and AFSO(Q) denotes antiferrom agnetic spin ordered phase. Several wave vectors are dened as $q_1 = (0.56; 0.56)$, $q_2 = (0.53; 0)$, $q_3 = (; 0)$, $q_x = (q_x; 0)$, $q_v = (; q_v)$, and Q = (;). Solid curves are the phase boundaries determined by actual calculations, while dotted lines are schem atic phase boundary guides for the eye.

The orbitally degenerate model, Eq. (1), shows new, rich superconducting properties both for singlet and triplet pairings. In Fig. 3 (a) and (b), we show the phase diagram s in the U-U $^{\rm 0}$ plane for "= 0 and U-" plane for $U = U^0$, respectively. In these gures, four characteristic superconducting phases are observed: (1) a SFm ediated spin-singlet superconducting phase with B_{1g}symmetry in the vicinity of a spin-ordered phase; (2) a g-wave superconducting phase with A_{2g} -symmetry; (3) a spin-triplet superconducting phase with E_u-symmetry due to the cooperation between SF and OF around $U = U^{0}$ and "= 0 and (4) an 0 F-m ediated spin-singlet superconducting phase with A_{1q} -symmetry for U U⁰ around an orbital-ordered phase. W ith respect to (1), it is thought that B_{1g}-superconductivity is induced by SF around q=Q=(;). Concerning the triplet superconductivity (3), note that for this region all superconducting instabilities are quite close to each other because of the multipeak structures in $^{s}(q)$ and $^{o}(q)$ as shown in Fig. 1. W e also note that the factors in front of the SF term in $\hat{W}^{s}(q)$ are 3=2 for singlet and +1=2 for triplet pairing, while the factor for the OF term in $\hat{W} \circ (q)$ is +1=2 for both pairings. Namely, OF is cooperative with SF for

spin-triplet pairing, while SF and OF compete with each other for spin-singlet pairing [6]. Thus, the spin-triplet pairing phase appears in the region for " 0 and U U^9 . The mechanism of the OF-mediated singlet supercondutivity (4) is interesting. In this state, two quasi-particles with di erent pseudo-spin form an on-site intra-orbital singlet pair since U⁰ U, leading to A_{1g} superconductivity. In short, singlet superconductivity with B_{1g}-or A_{1g}-symmetry is stabilized when either SF or OF is dom inant, while triplet superconductivity is favored when there is cooperation between SF and OF.

In sum m ary, we have studied superconductivity in the Ce-115 system s based on the orbitally degenerate Hubbard m odel, and found that with increasing the tetragonalCEF splitting $d_{x^2} = y^2$ -wave superconductivity due to AFSF emerges out of the suppression of OF in the vicinity of the AF phase. The concept of AFSF-induced superconductivity controlled by OF qualitatively explains the di erence am ong Ce-115 m aterials.
