DYNAM IC ENTROPIES, LONG {RANGE CORRELATIONS AND FLUCTUATIONS IN COMPLEX LINEAR STRUCTURES

W e investigate symbolic sequences and in particular information carriers as e.g. books and DNA (strings. First the higher order Shannon entropies are calculated, a characteristic root law is detected. Then the algorithm ic entropy is estimated by using Lem pel(Z iv com pression algorithm s. In the third section the correlation function for distant letters, the low frequency Fourier spectrum and the characteristic scaling exponents are calculated. We show that all these measures are able to detect long(range correlations. However, as demonstrated by shu ing experiments, di erent measures operate on di erent length scales. The longest correlations found in our analysis com prise a few hundreds or thousands of letters and m ay be understood as long(wave uctuations of the com position.

1 Introduction

The purpose of this paper is to compare di erent correlation m easures based on m ethods of statistical physics. We aim to analyse correlations and uctuations comprising at least several hundreds of letters. The characteristic quantities which m easure long correlations are dynam ic entropies^{1;2;3}, correlations functions and m ean square deviations, 1=f noise^{4;5}, scaling exponents^{6;7}, higher order cum ulants⁸ and, m utual inform ation^{9;10}. Our working hypothesis which we form ulated in earlier papers^{1;5}, is that texts and DNA show some e structural analogies to strings generated by nonlinear processes at bifurcation points. This is demonstrated here rst by the analysis of the behaviour of the higher order entropies. Further analysis is based on the m apping of the text to random walk m odels as well as on the spectral analysis. The random walk m ethod which was proposed by Peng et al.⁶, found several applications to DNA sequences^{11;9} and to hum an writings^{8;12}. In order to nd out the origin of the long{range correlations we studied the e ects of shu ing of long texts on di erent levels (letters, words, sentences, pages, chapters etc.). The shu ed sequences were always com pared with the original one (without any shu ing). We note that all our les have the same letter distribution. How ever only the correlations on scales below the shu ing levelare conserved. The correlations (uctuations) on higher levels which are based on the large{scale structure of texts as well as on sem antic relations are conserved only in the original le. The objects of our investigation were the book \M oby D ick" by M elville (L 1;170;000 letters) and the DNA {sequence of the lam bda{virus (L 50;000 letters).

2 Entropy { like M easures of Sequence Structure

Let $A_1A_2:::A_n$ be the letters of a given substring of length n \quad L. Let further $p^{(n)}$ (A_1:::A_n) be the probability to \quad nd in a string a block with the letters A_1:::A_n. Then we may introduce the entropy per block of length n:

O ur m ethods for the analysis of the entropy of sequences were in detail explained elsewhere¹³. We have shown that at least in a reasonable approximation the scaling of the entropy against the word length is for large n given by root laws of the type

In our earlier work on M oby D ick ³ we assumed $c_2 = 0$ and obtained for our empirical data in the range n = 10 26 the constants g = 1.7, $c_1 = 0.9$. As shown already in 1951 by Shannon and a few years later by Burton and Licklider, the limit of the uncertainty h_n for large n which is given here by c_2 should be nite. W ith the estimate $c_2 = 0.05$ we have repeated our t including data for M oby D ick obtained with a new method ¹³. The parameters obtained by the new t are $c_0 = 1.7$, $c_1 = 0.5$, $c_2 = 0.05$. The dominating contribution ist given by the root term, an observation rst m ade by H ilberg. In this way the decay of uncertainties h_n follows a scaling according to a power law.

W e consider now a di erent approach to the entropy analysis which goes back to the work of Kolm ogorov, Chaitin, Lempel and Ziv. The algorithm ic entropy according to Lempel and Ziv is introduced as the relation of the length of the compressed sequence (with respect to a Lem $pel{Ziv}$ compression algorithm) to the original length.

The results obtained for the Lem pel{Ziv com plexities (entropies) of M oby D ick and of the lambda virus DNA are shown in Fig. 1. We see, that the Lem pel{Ziv entropy of M oby D ick having a value of about 0.56 is m uch higher than than the Shannon entropies derived above. This clearly shows that the com pression algorithm s based on the Lem pel-Ziv m ethod are by far not optim al. As show our shu ing experiments represented in Fig. 1, com pression algorithm s of Lem pel-Ziv type are mainly based on rules below the page level.

3 Correlation Functions, Power Spectra, R andom W alk Exponents

In this part we closely follow the method proposed by Peng et al. $^{6;7}$ and the invariant representation proposed Voss⁴. Instead of the original string consisting of dienent symbols we generate strings on the binary alphabet (0,1) (= 32 for texts). In the rst string we place a \1" on all positions where there is an \a" in the original string and a \0" on all other positions. The same procedure is carried also out for the remaining symbols. Then we generate random processes corresponding to these strings moving one step upwards for any \1" and remaining on the same elevel for any \0". The resulting m ove over a distance l is called y (k; 1) where k denotes the symbol. Then by de ning a {dimensional vector space considering y(k; 1) as the component k of the state vector at the (discrete) \time" l we can map the text to a trajectory. The corresponding procedure is carried out for the DNA {sequences

which are mapped to a random walk on a = 4{dimensional discrete space. The power spectrum is de ned as the Fourier transform of the correlation function C (k;n) which measures the correlation of the letters of type k in a distance n⁵. The results of spectra calculations for the original le of the B ible, for M oby D ick and for the same less hu ed on the word level or on the letter level correspondingly were presented in a foregoing work⁸. As a new result we present here the power spectrum of M oby D ick shu ed on the chapter and on the page level (Fig. 2).



Figure 2: Double{logarithm ic plot of the power spectrum for Moby Dick. The full line corresponds to the original text, the dashed line corresponds to the text shu ed on the chapter level and the dotted line to the text shu ed on the page level. Shu ing on a level below pages destroys the low frequency branch.

We see that the spectra of the original texts have a characteristic shape with a well{expressed low frequency part. This shows the existence of long{ range correlations in M oby D ick. An estimate for the exponent is 0.8. How - ever it is di cult to extract a precise value for the exponent corresponding to a power law. One should better look at the shape of the whole curve which reminds a piecew ise linear behaviour which is characteristic for multifractal structures. This point certainly needs further investigations. How ever we believe, there is no reason to expect that a long text as M oby D ick is a multifractal in a quantitative sense. On the other hand the hierarchical character of the structure of texts is beyond any doubt and we think that spectral curves m ay be characterised as a quantitative measure of this hierarchy. Fig. 2 shows that shu ing on the page level already destroys the low {frequency branch of the

spectrum. This clearly proves that the origin of the 1=f (uctuations is on a scale which exceeds the page level. The contribution of high frequencies corresponds to the structure on the word and sentence level. Let us study now the anom alous di usion coe cients which allow a higher accuracy of the analysis ⁷. The mean square displacement for sym bolk is determined as

where the brackets < > m ean the averaging over all initial positions. The behaviour of F (k; 1) for 1 is the focus of interest. It is expected that F (k; 1) follows a power law ⁷.

where (k) is the di usion exponent for symbol k. We note that the di usion exponent is related to the exponent of the power spectrum ⁷. The case

(k) = 0.5 corresponds to the norm ald i usion or to the absence of long{range correlations. If (k) > 0.5 we have an anom alous di usion which rejects the existence of long{range correlations. B eside the individual di usion exponents for the letters we get also an averaged di usion exponent for the state space. The data are summarised in Fig. 1.

In the same way we can obtain other important statistical quantities: higher order m om ents and cum ulants of $y(k; l)^8$ By calculations of the H older exponents D_q up to q = 6 we have show n, that the higher order m om ents show (in the limits of accuracy) the same scaling behaviour as the second m om ent. We repeated the procedure described above for the shu ed les. A graphical representation of the results for M oby D ick and D NA are given in Figs. 1.

We see from Figs 1{2 that the original sequences show strong long{range correlations, i.e. the coe cients of anom alous di usion are clearly di erent from 1=2 and there exists 1=f {noise. A fler the shu ing below the page level the sequences become practically B emoullian in comparison with the original ones since the di usion coe cients decrease to a value of about 1=2 and there is no m ore 1=f {noise. The decrease occurs in the shu ing regime between the page level and the chapter level. For DNA {sequences the characteristic level of shu ing where the di usion coe cient goes to 1/2 is about 500{1000.0 ur result dem onstrates that shu ing on the level of sym bols, words, sentences or pages, or segments of length 500{1000 in the DNA {case destroys the long range correlations which are felt by the m ean square deviations.

4 Conclusions

Our results show that the dynamic entropies, the low frequency spectra and the scaling of the mean square deviations, are appropriate measures for the

long (range correlations in symbolic sequences. How ever, as dem onstrated by shu ing experiments, di erent measures operate on di erent length scales. The longest correlations found in our analysis comprise a few hundreds or thousands of letters and m ay be understood as long { wave uctuations of the com position. These correlations (uctuations) give rise to the anom alous di usion and to long { range 1=f { uctuations. These uctuations com prise several hundreds or thousands of letters. There is some evidence that these correlations are based on the hierarchical organisation of the sequences and on the structural relations between the levels. In other words these correlations are connected with the grouping of the sentences into hierarchical structures as the paragraphs, the pages, the chapters etc. U sually inside certain substructure the text shows a greater uniform ity on the letter level. In order to dem onstrate this we have shown in earlier work⁸ the (averaged over windows of length 4000) local frequency of the blanks (and other letters) in the text M oby D ick in dependence on the position along the text. The original text shows a large { scale structure extending over m any windows. This re ects the fact that in some part of the texts we have many short words, e.g. in conversations (yielding the peaks of the space frequency), and in others we have more long words, e.g. in descriptions and in philosophical considerations (yielding the minim a of the space frequency). The shu ed text shows a much weaker non {uniform ity of the text, the lower the shu ing level, the larger is the uniform ity. M ore uniform ity means less uctuations and more similarity to a Bernoulli sequence. For the case of DNA { sequences no analogies of pages, chapters etc. are known. Nevertheless the reaction on shu ing is similar to those of texts. Possibly a m ore careful com parison of the correlations in texts and in DNA sequences m ay contribute to a better understanding of the inform ational structure of DNA.
